DESCRIPTION

FIG. 1 is a top front right perspective view of the coffeemaker showing the new design;

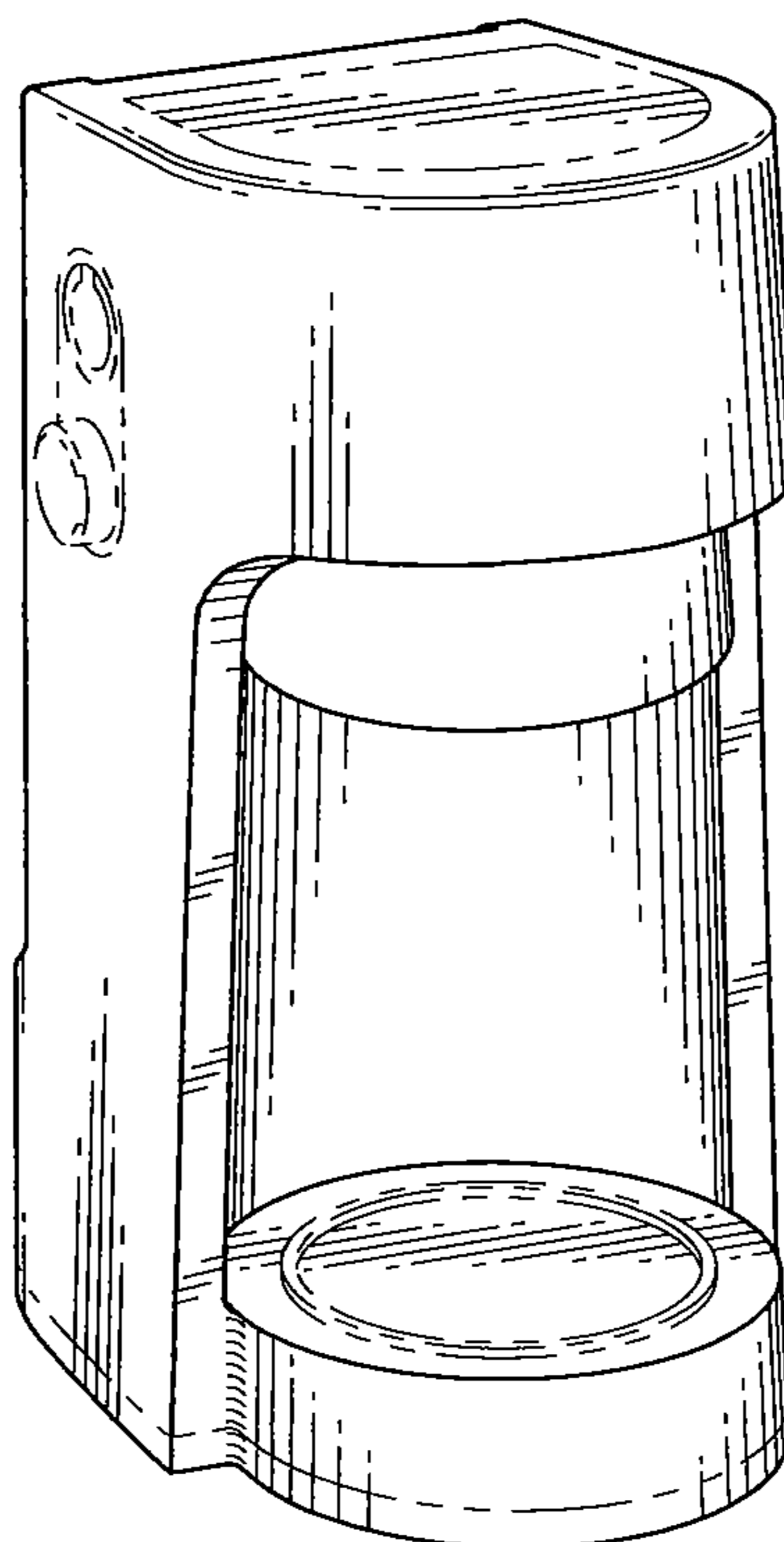

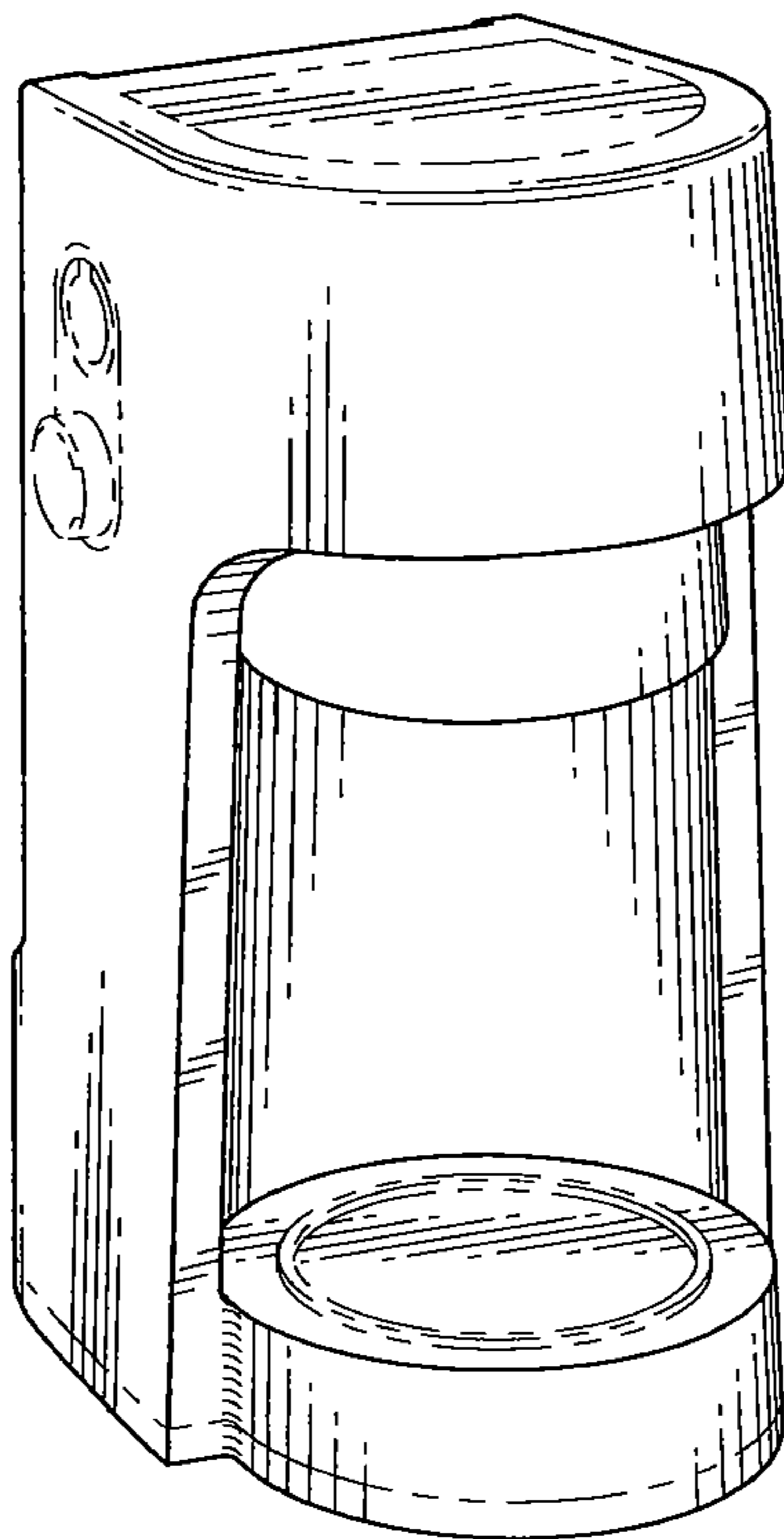

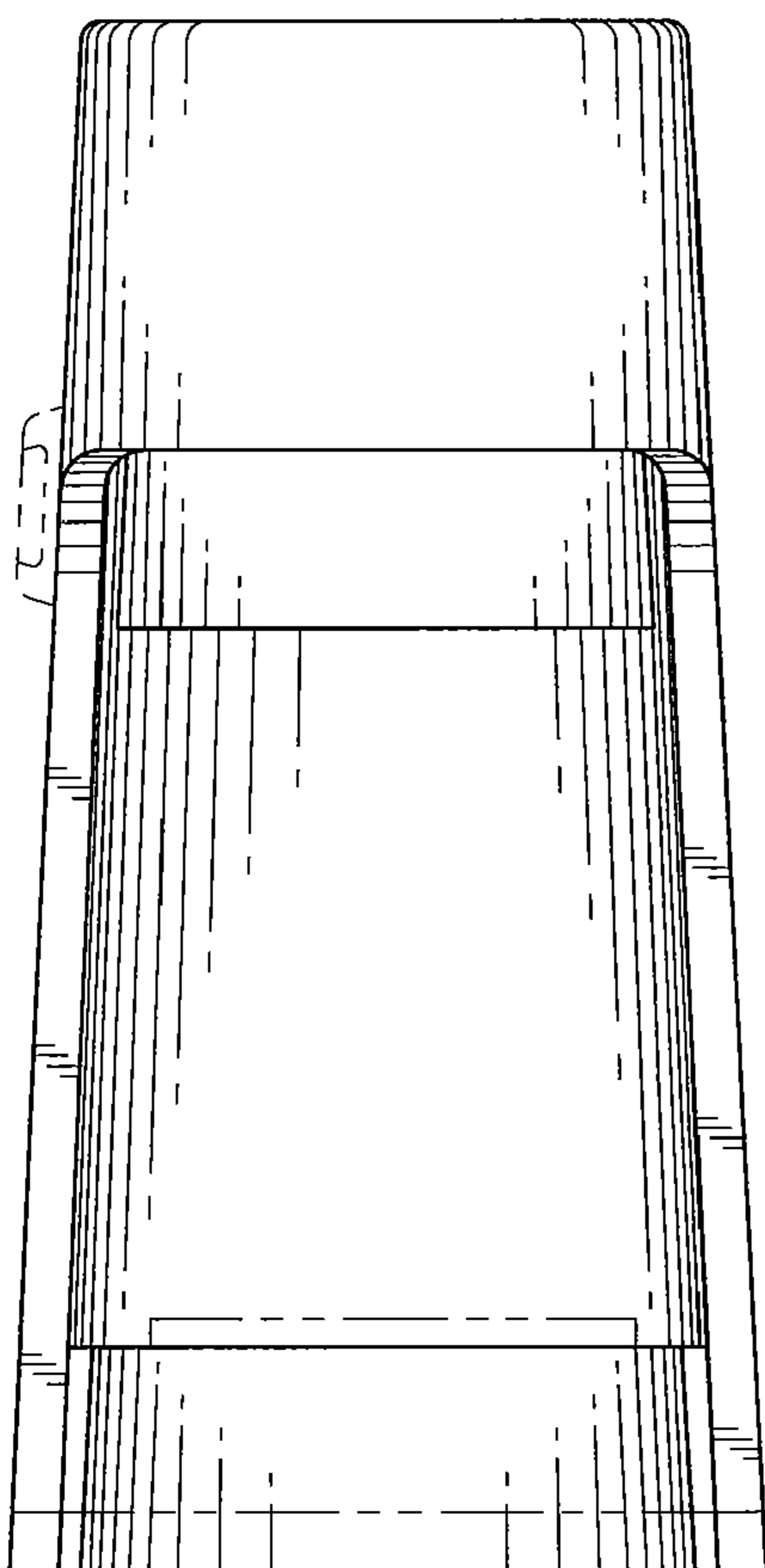

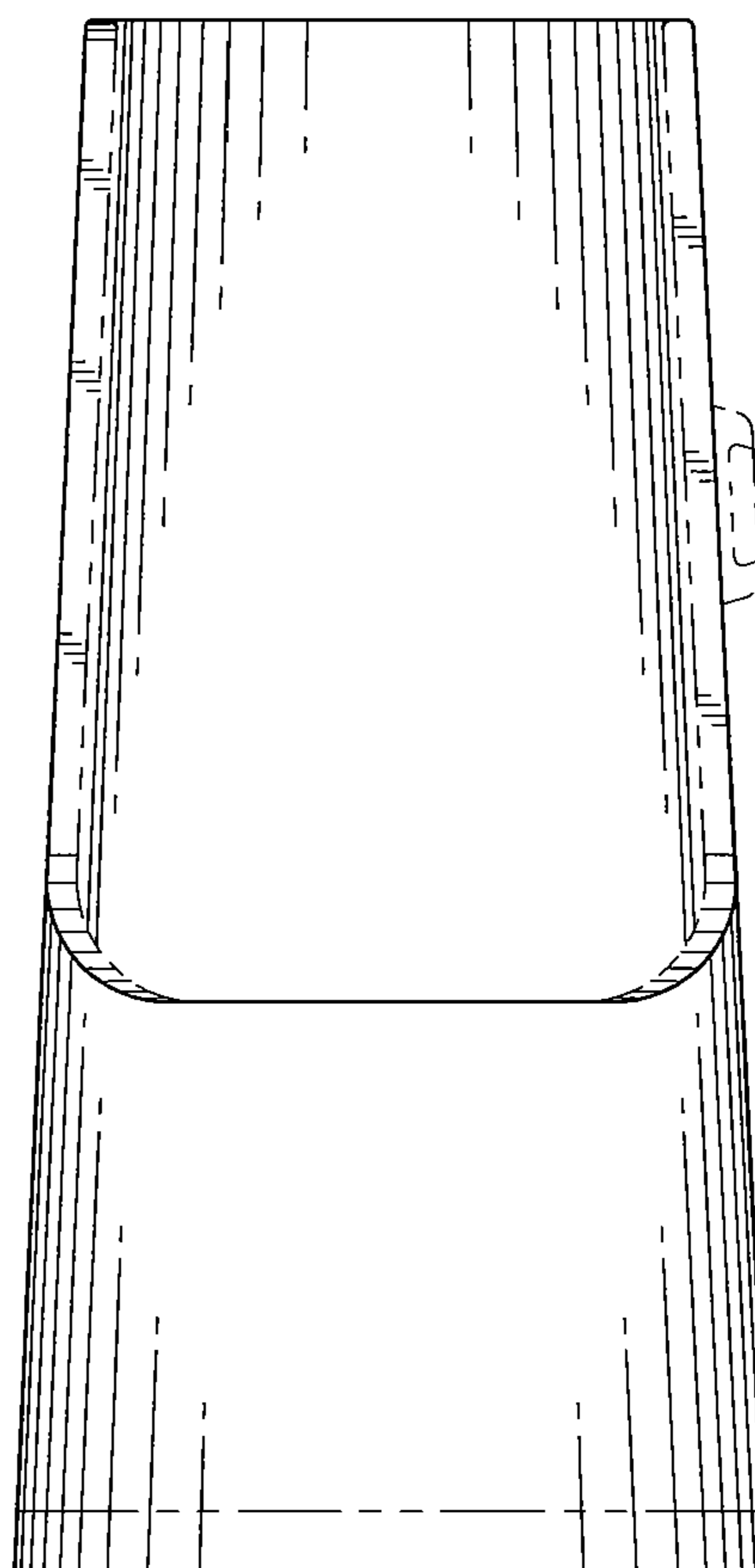

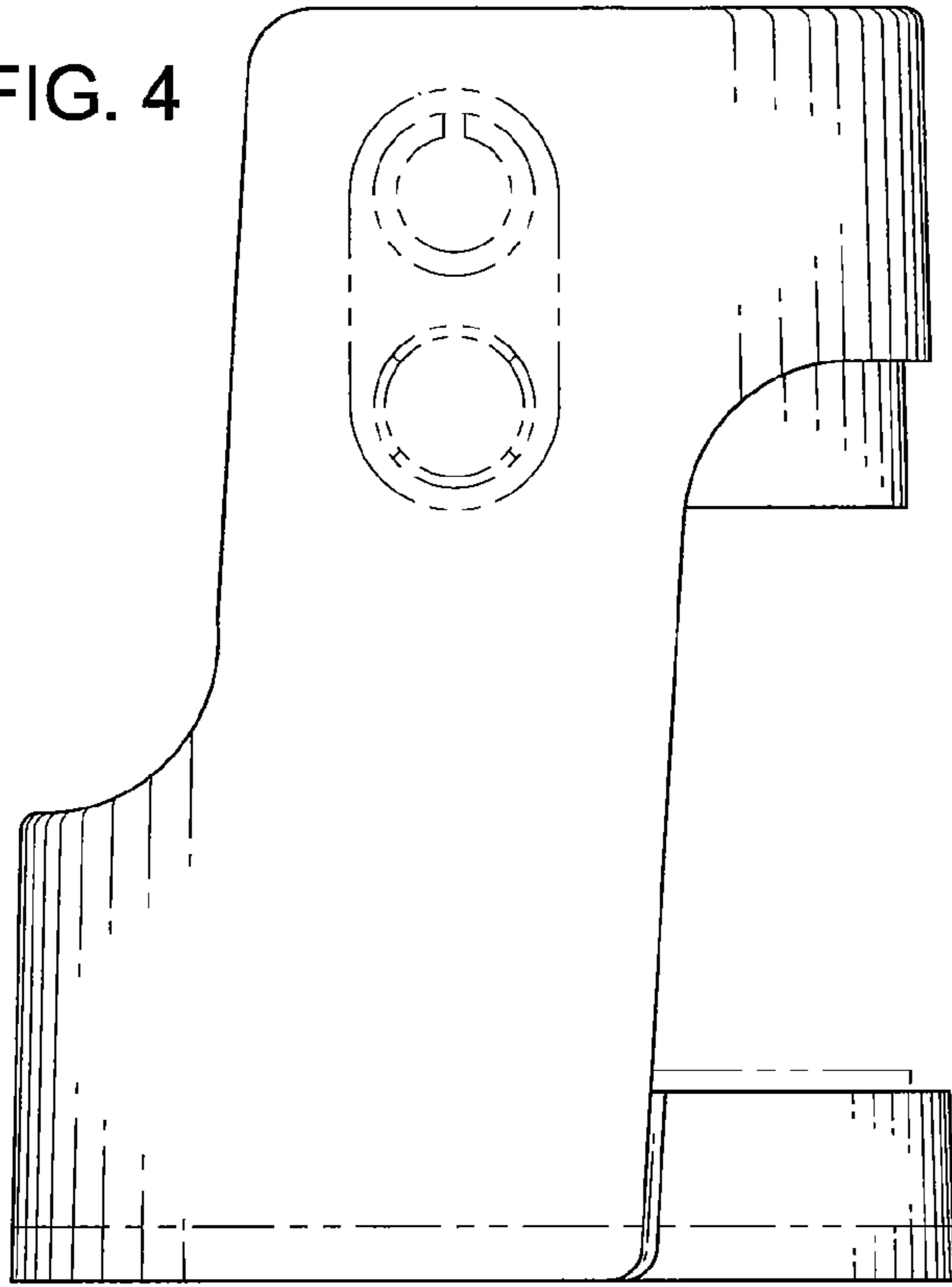

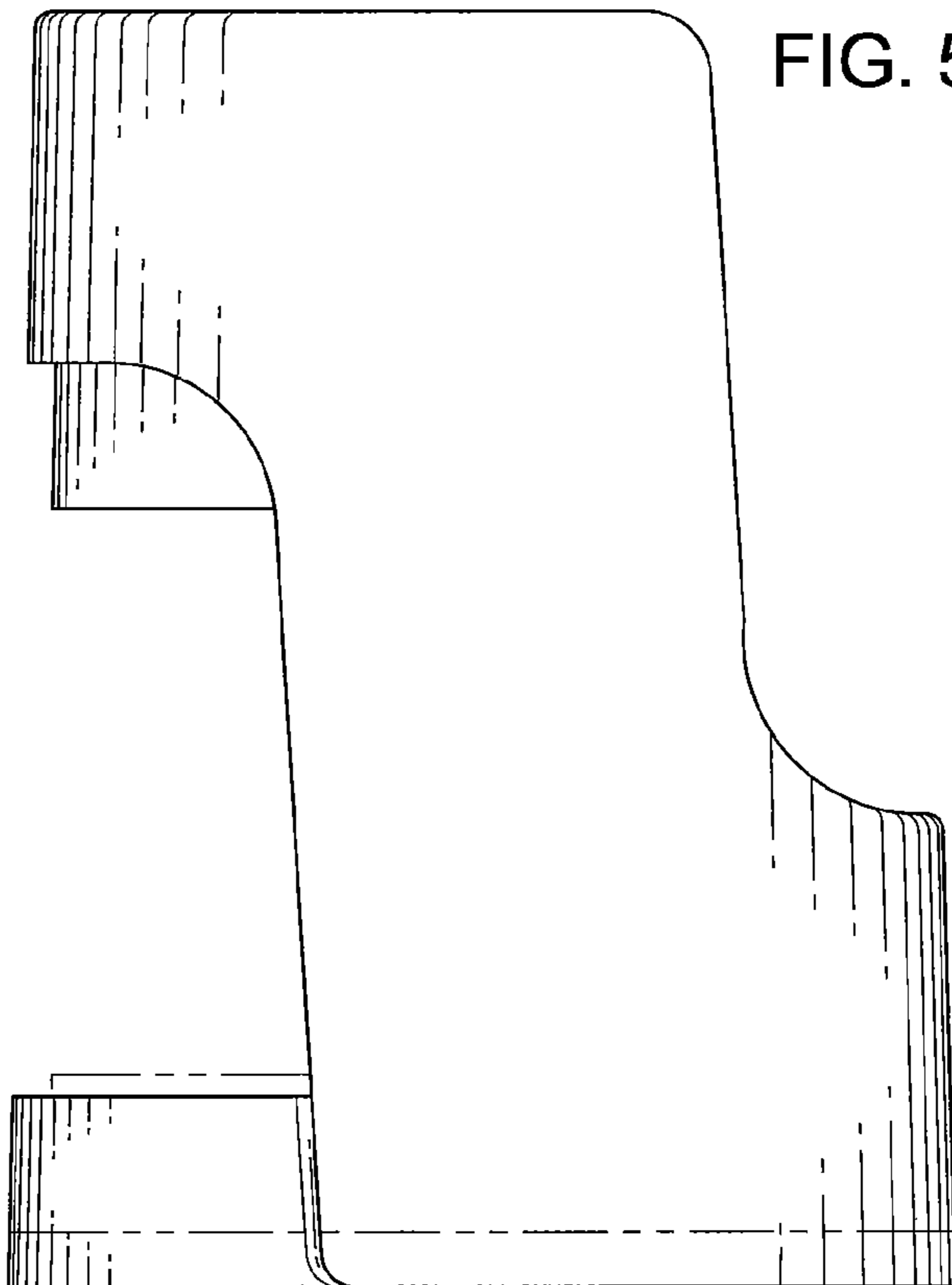

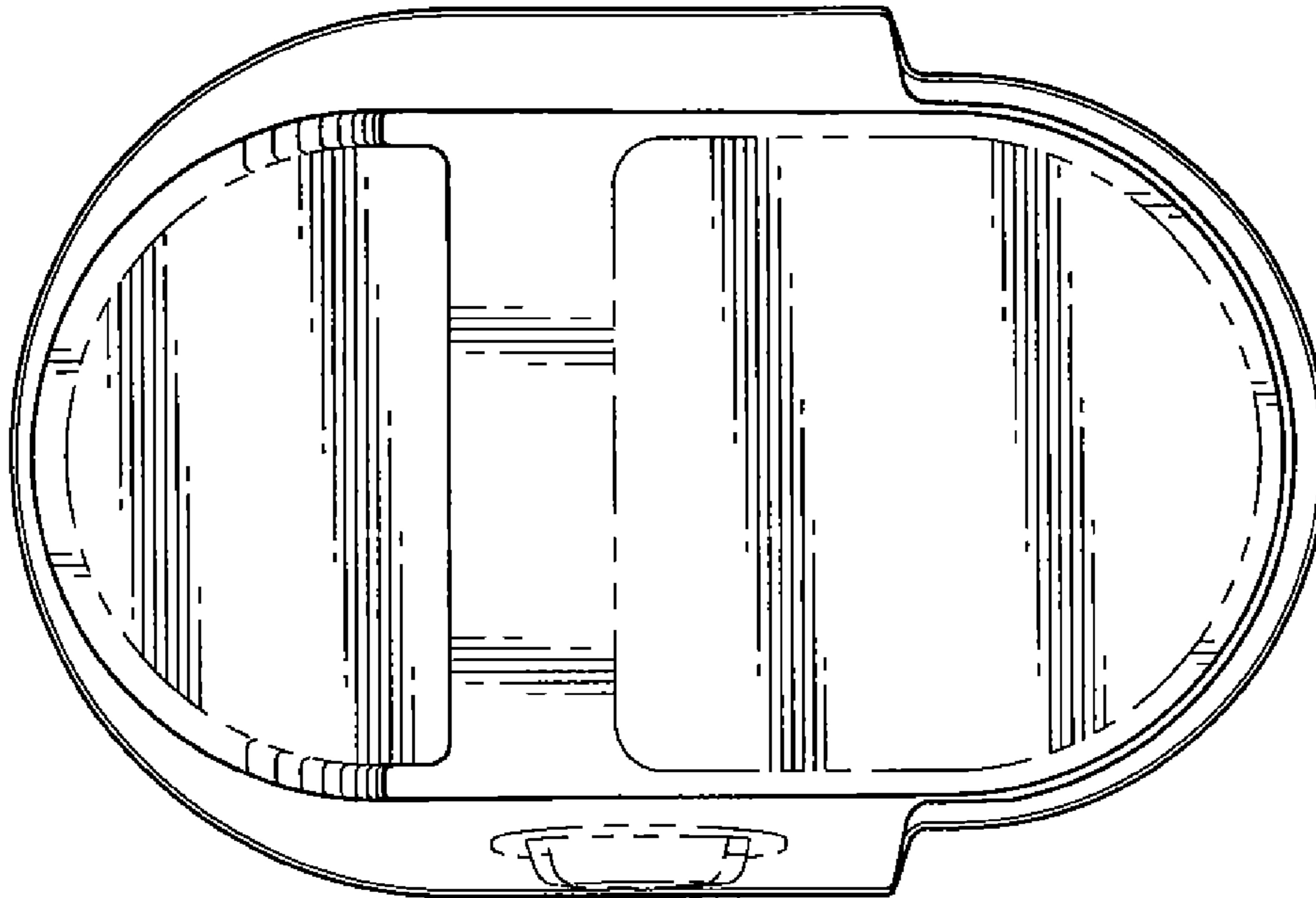
