FIG. 3 is a bottom plan view thereof;

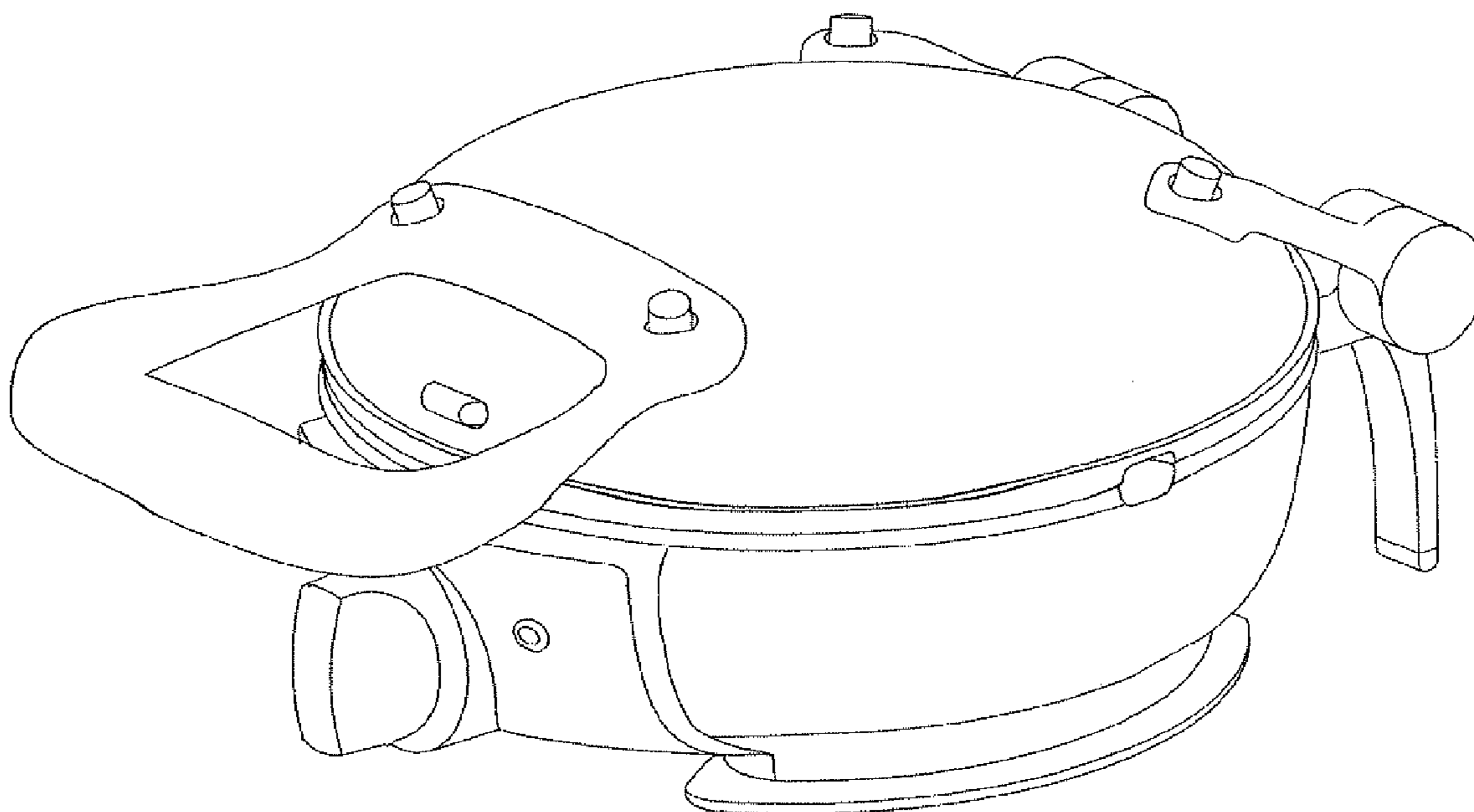
FIG. 4 is a side elevational view thereof from the left of FIG. 1;

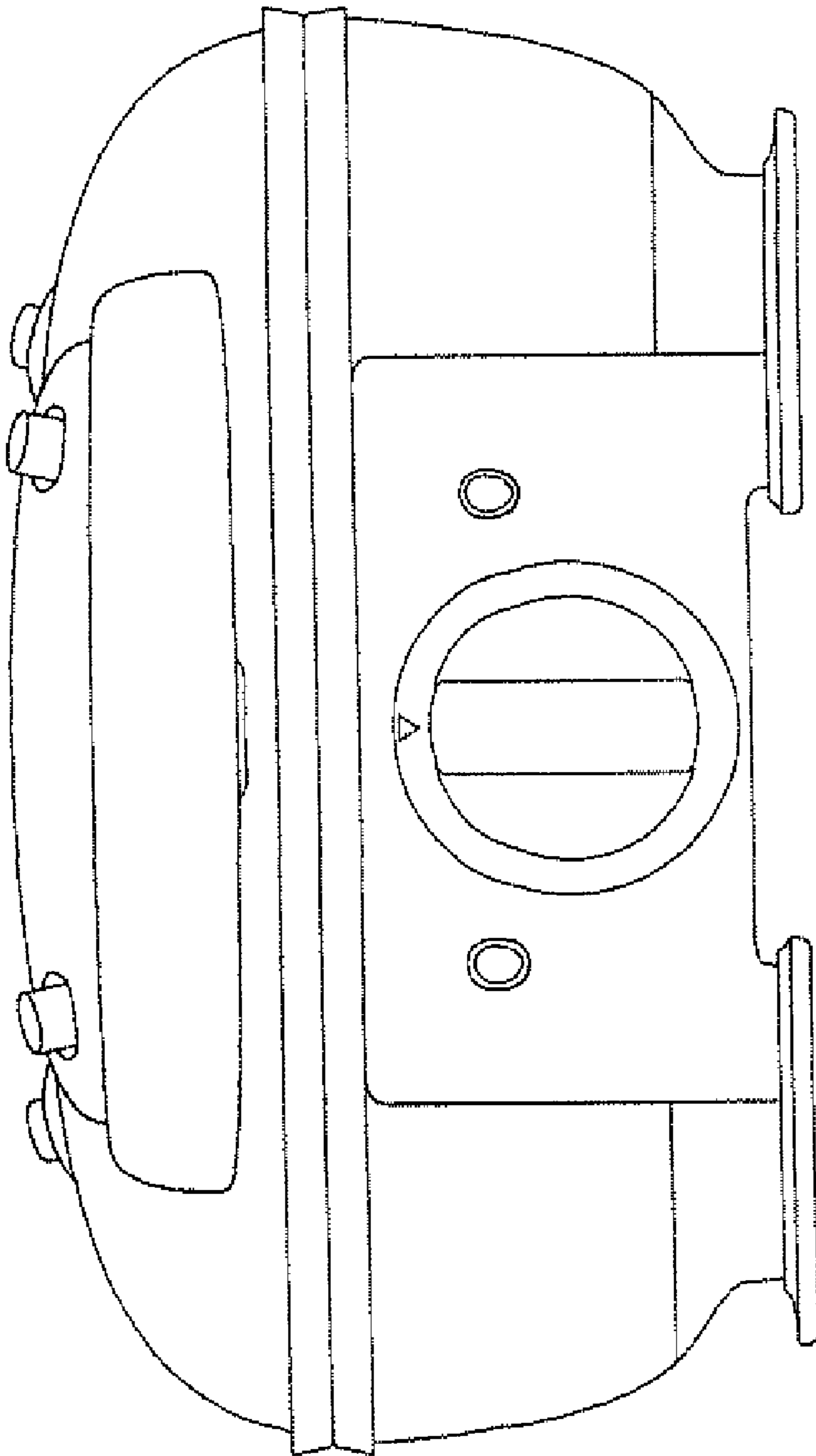

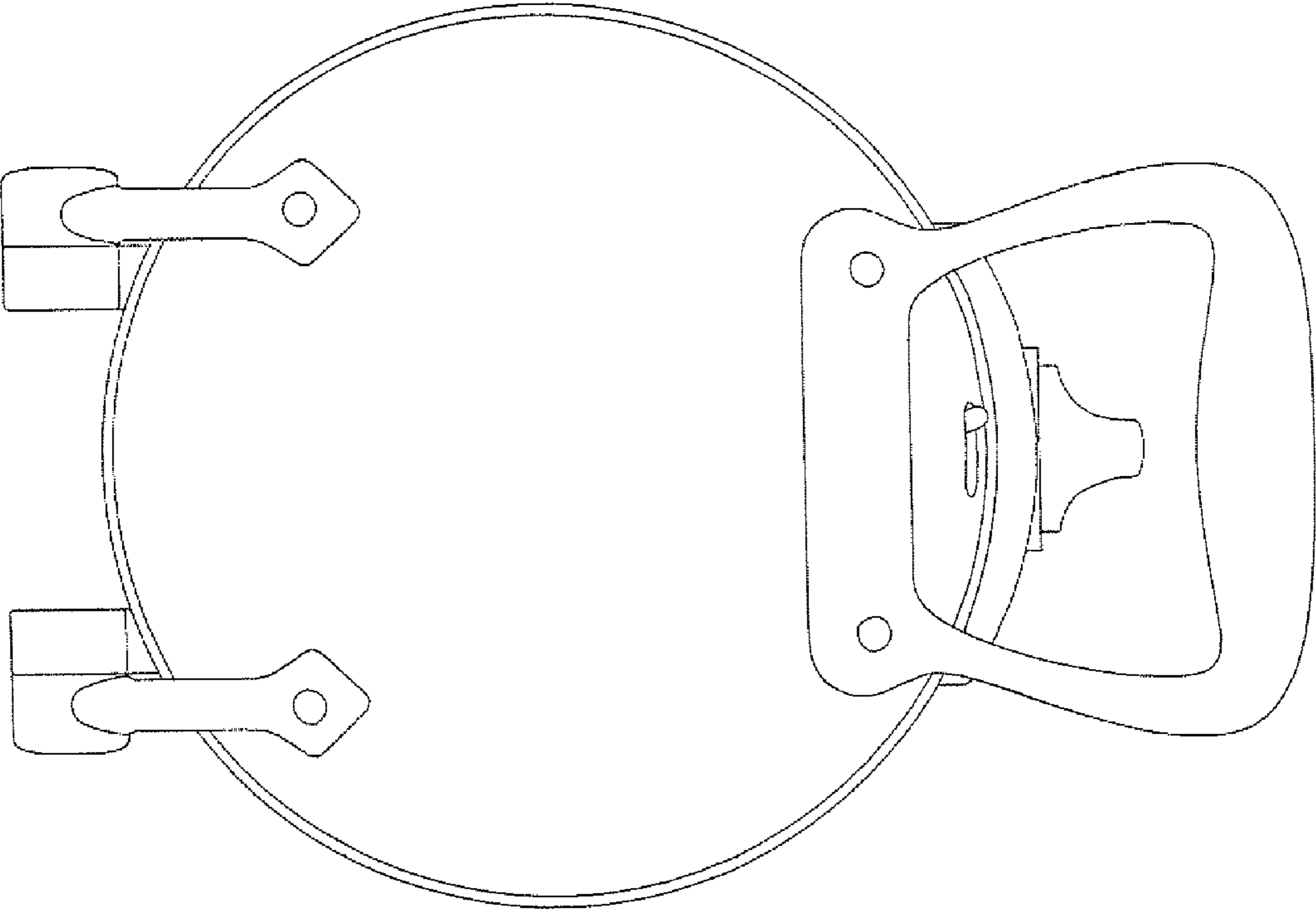

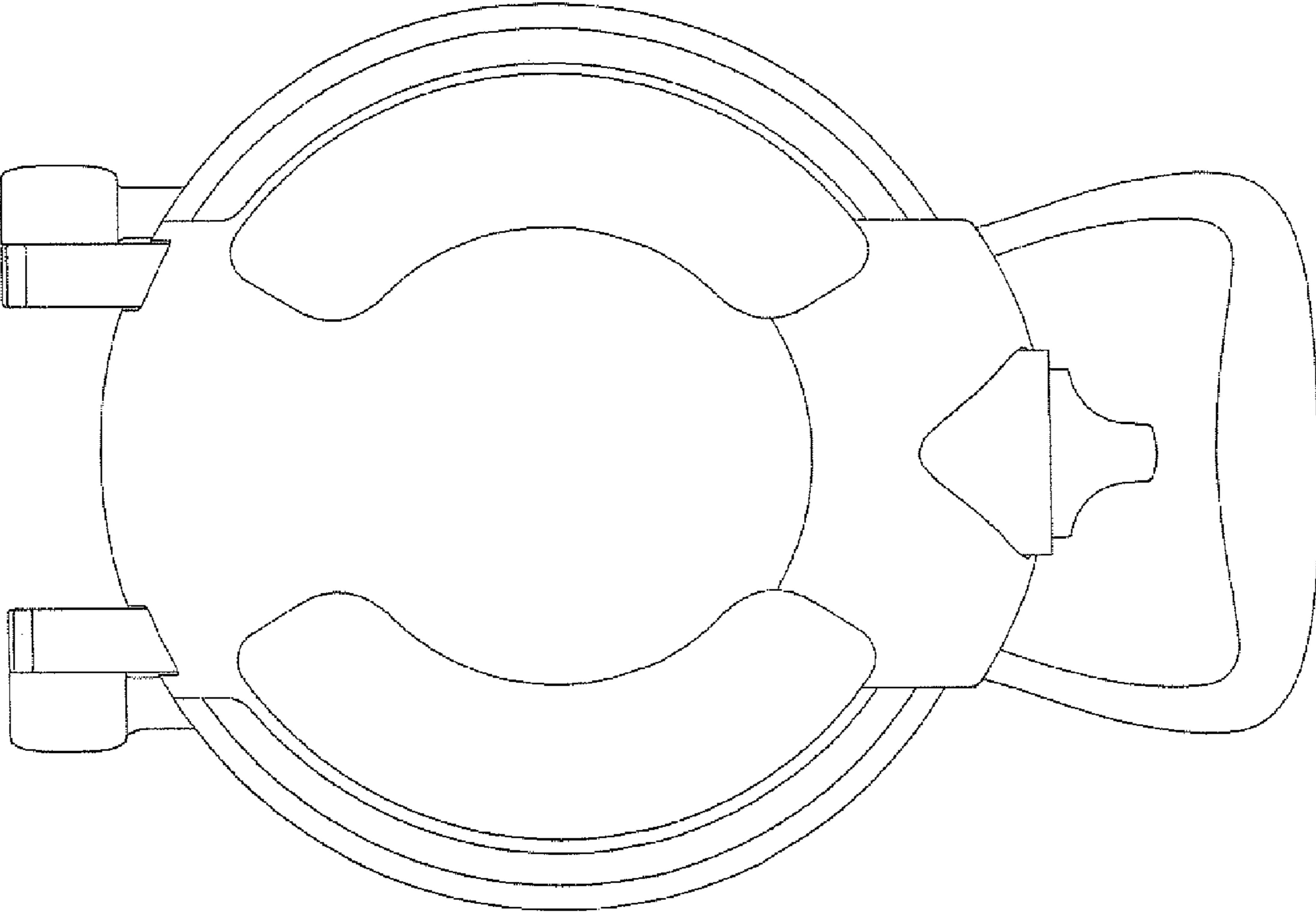

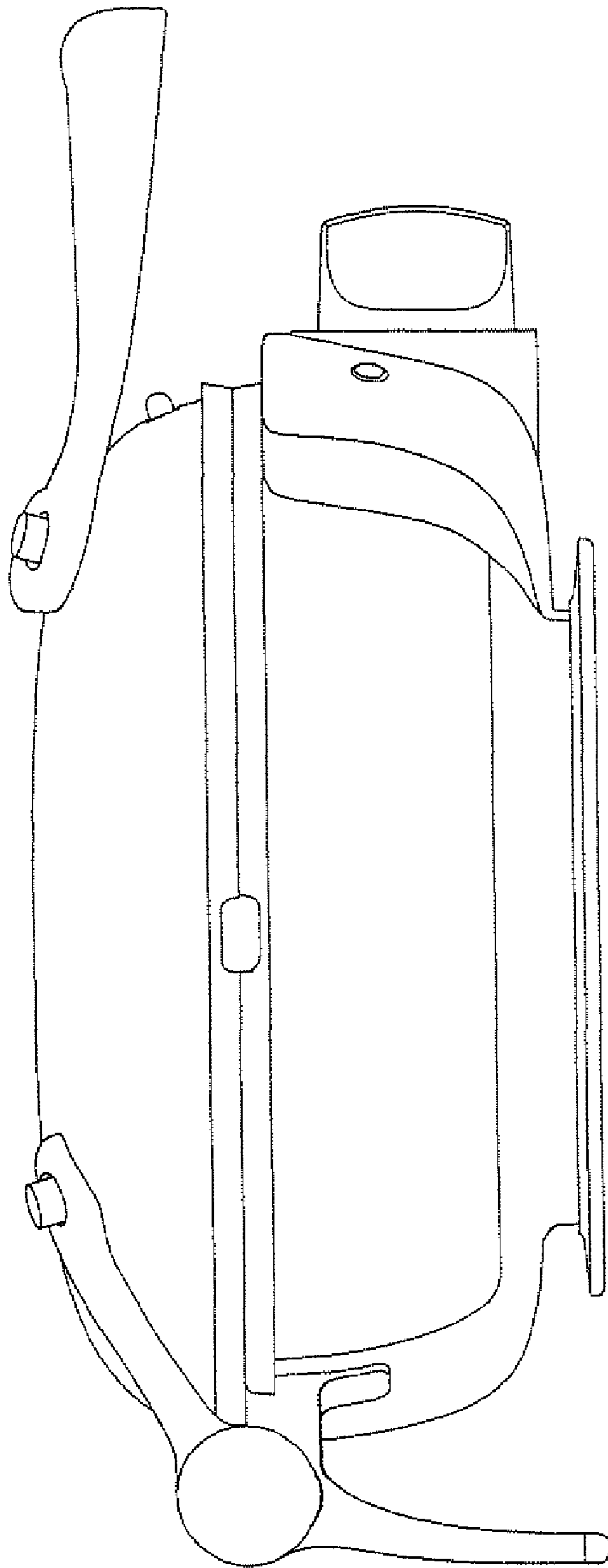

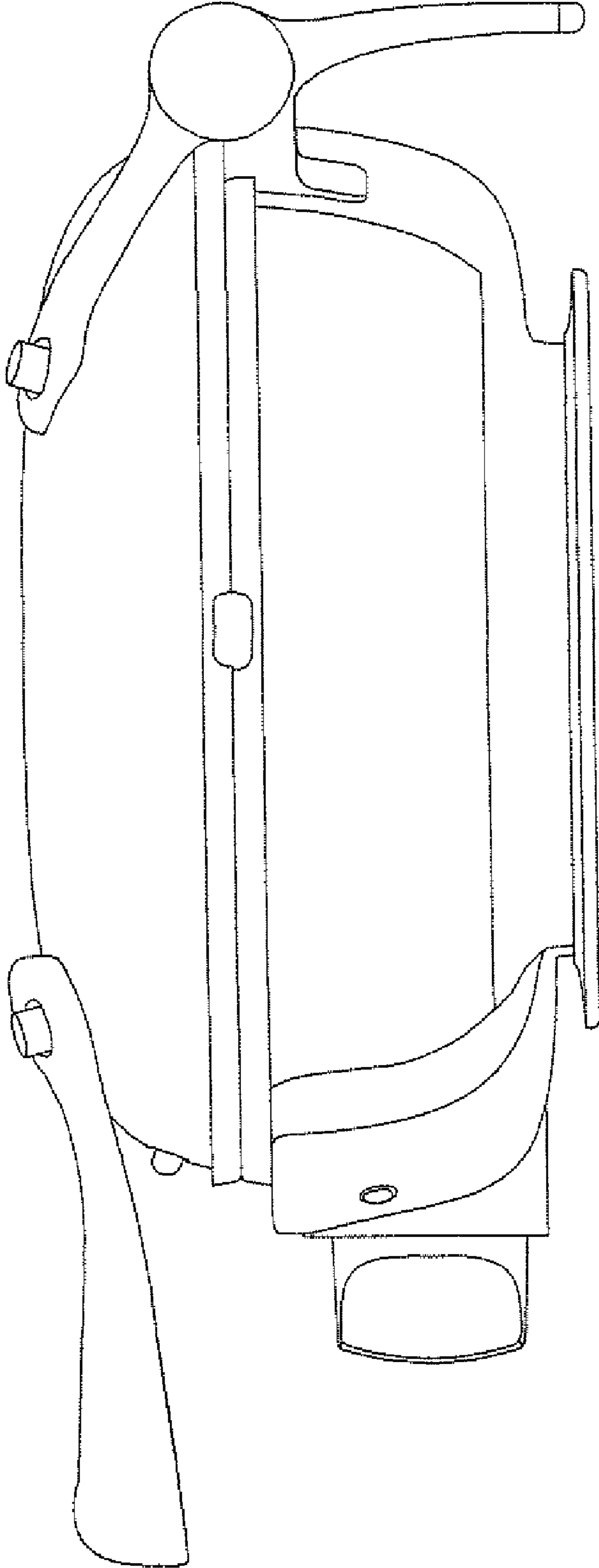

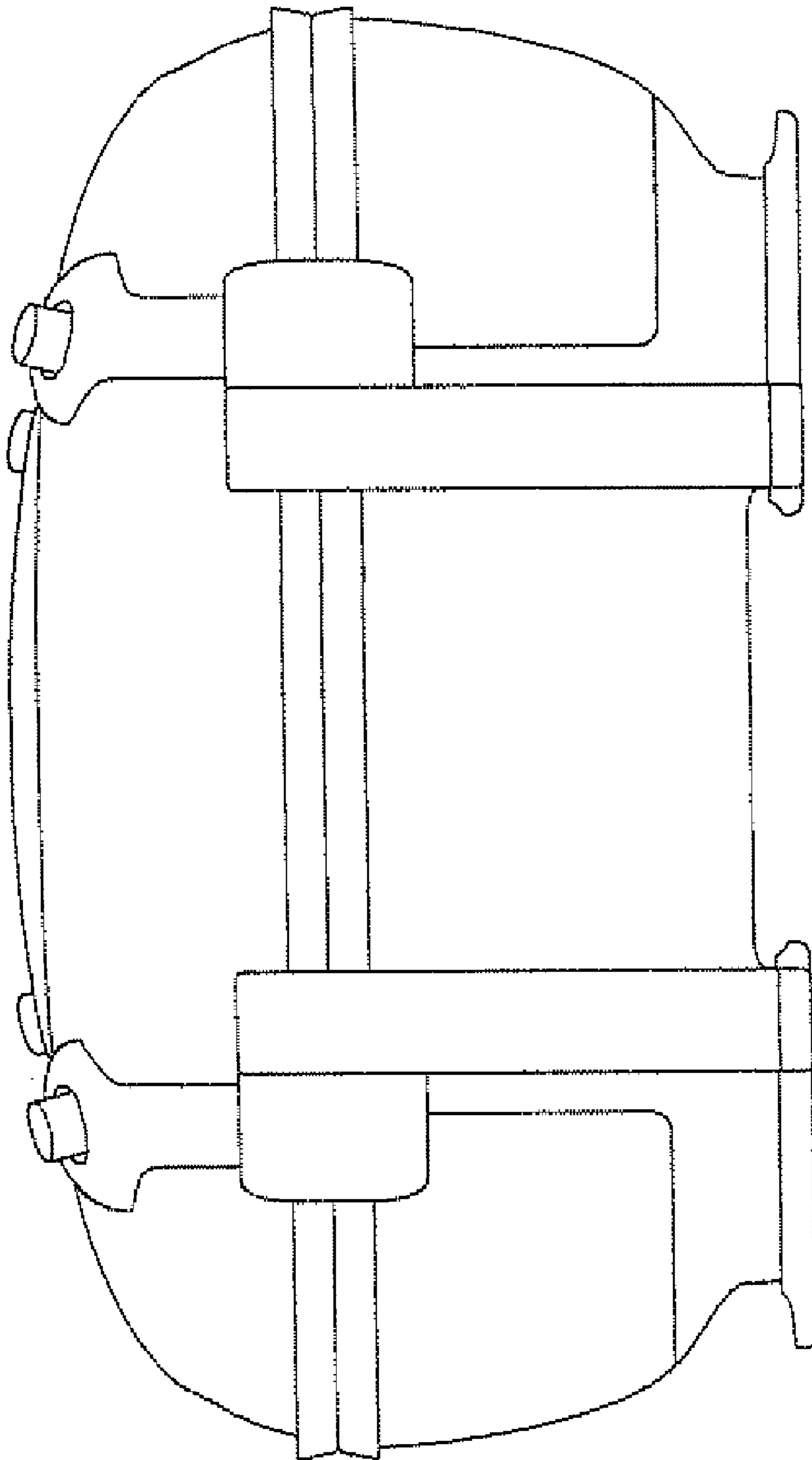

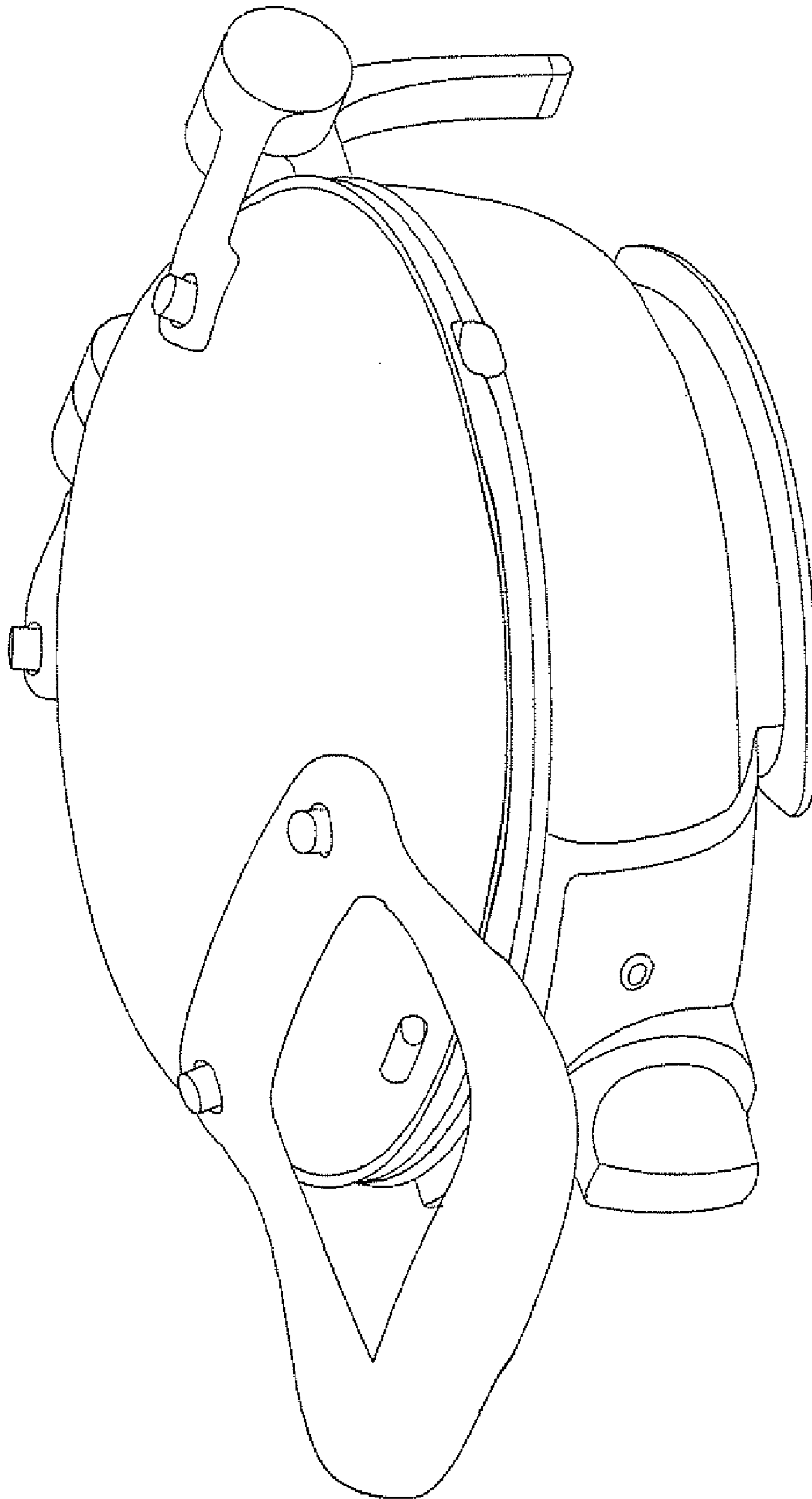
