FIG. 8 is a top plan view of the second embodiment;

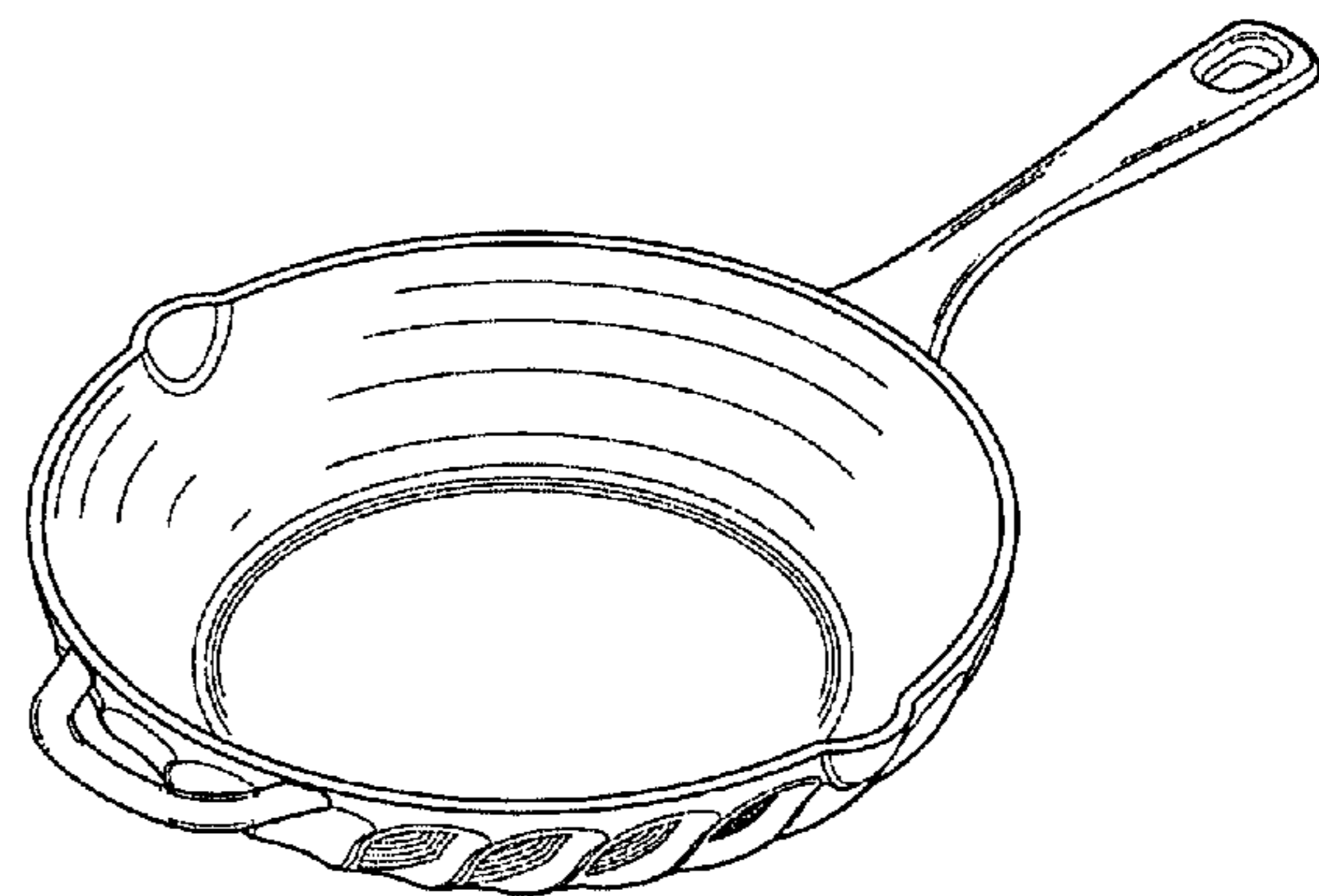
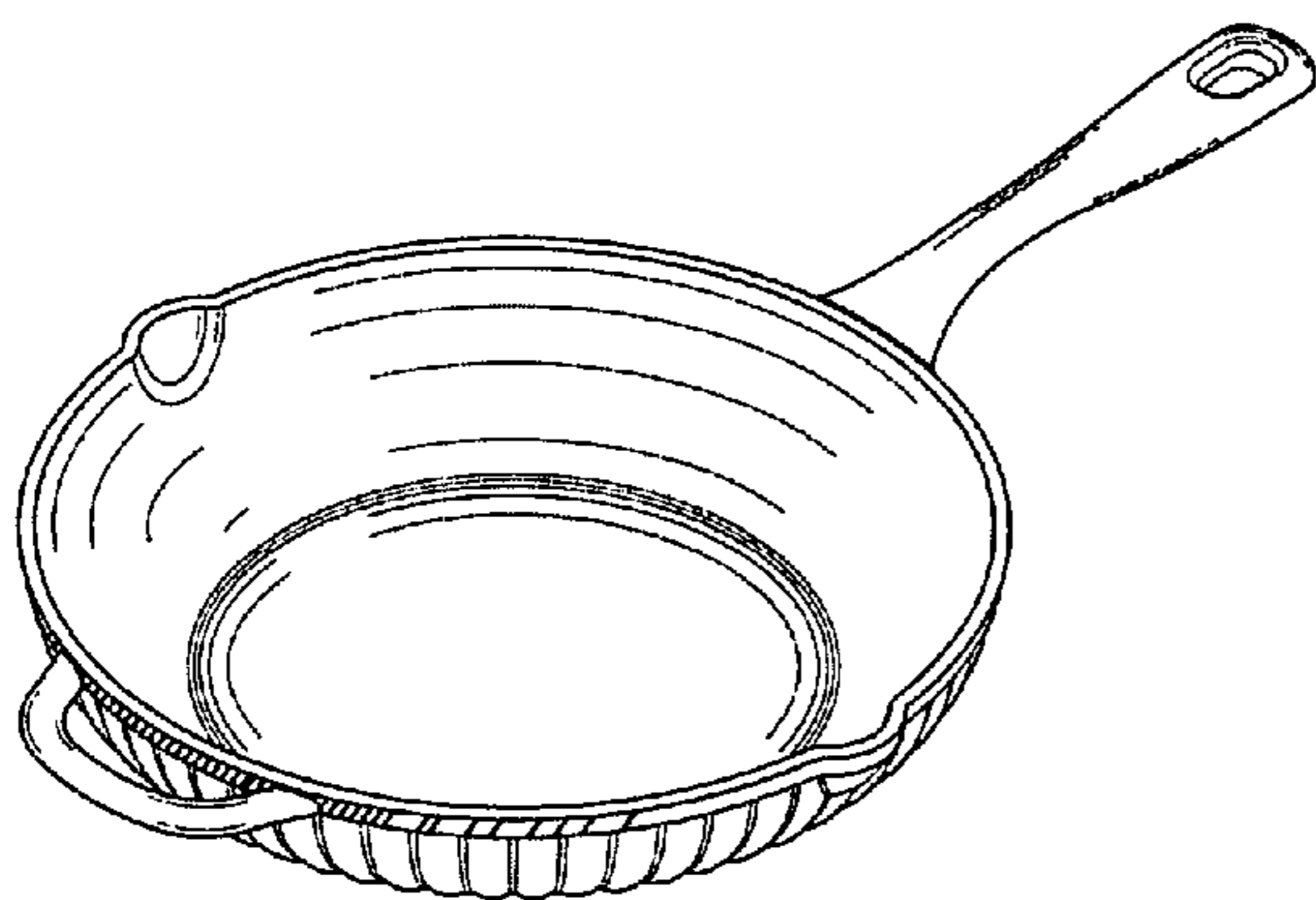
FIG. 9 is a front elevation view of the second embodiment;

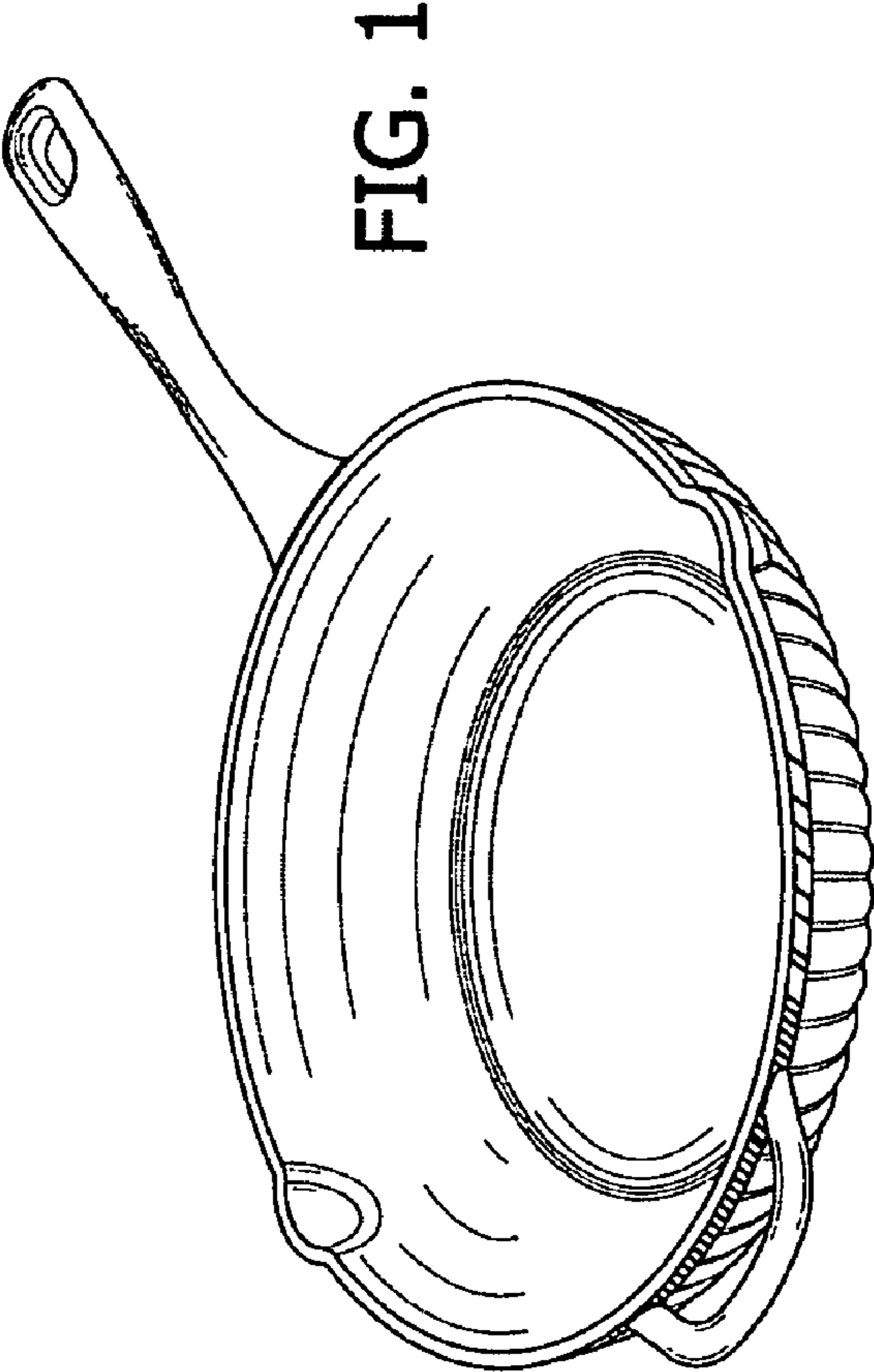

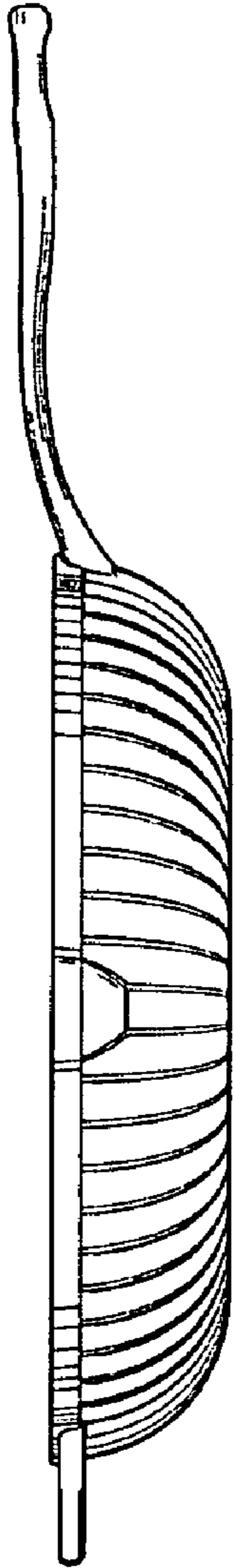

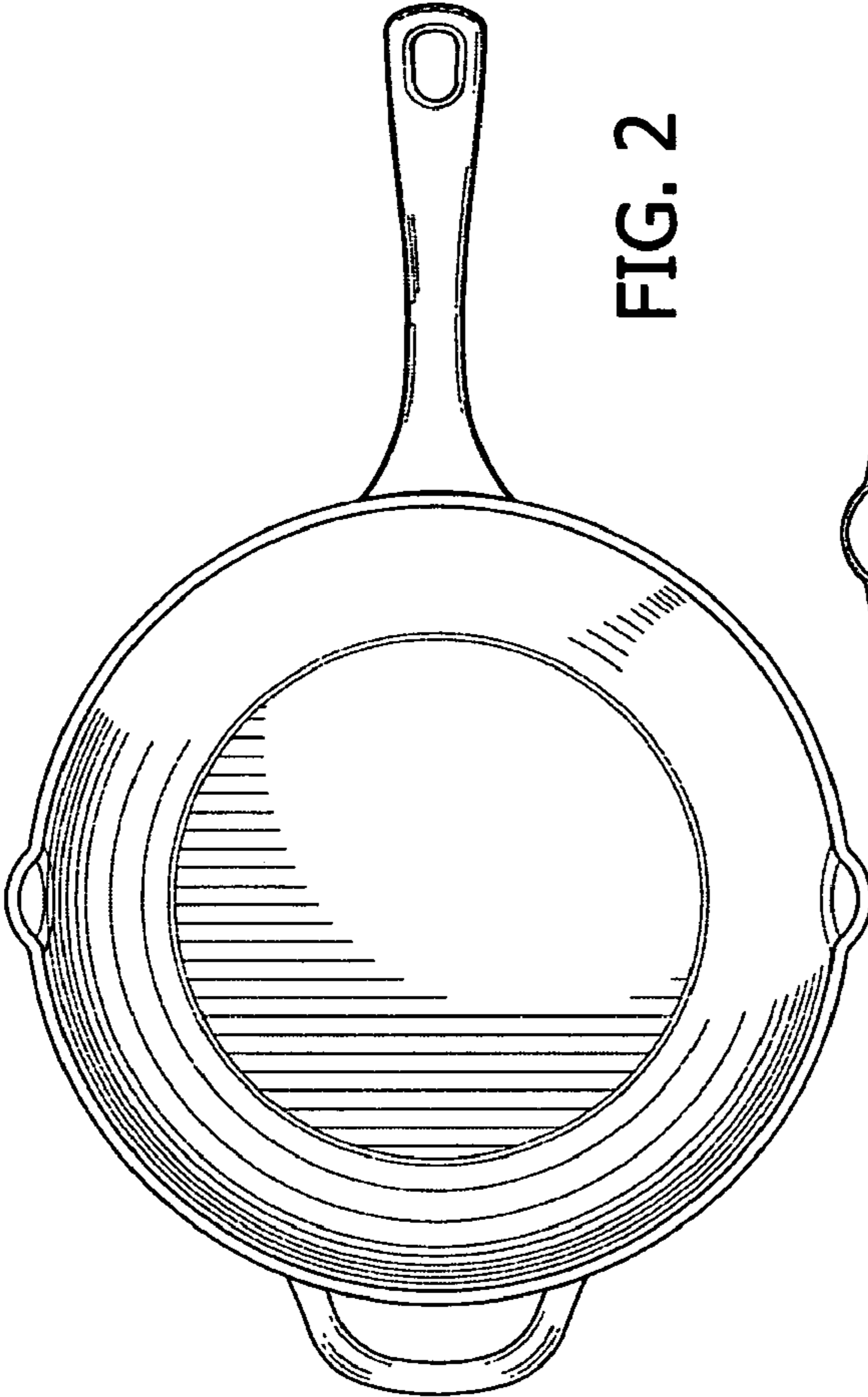

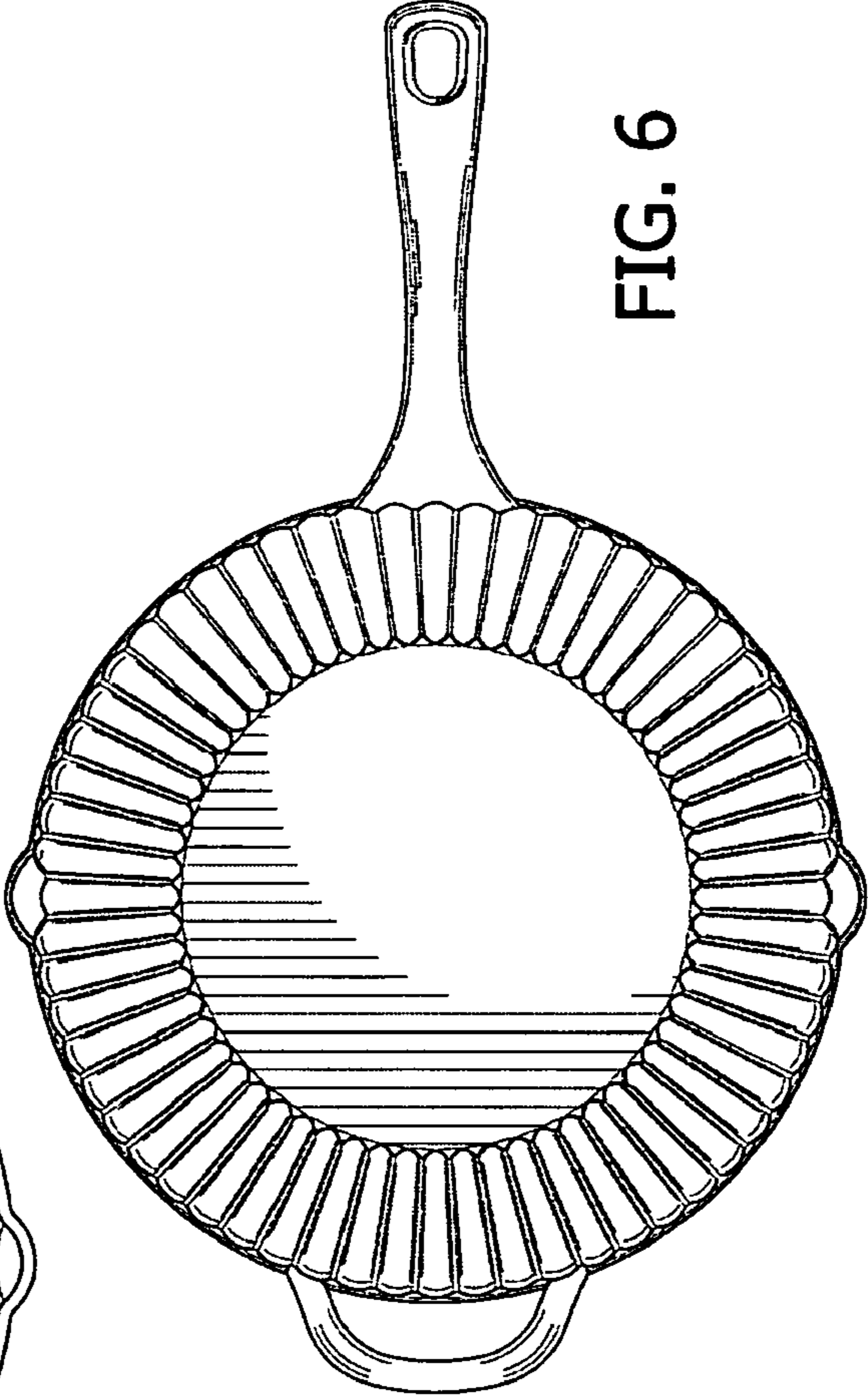

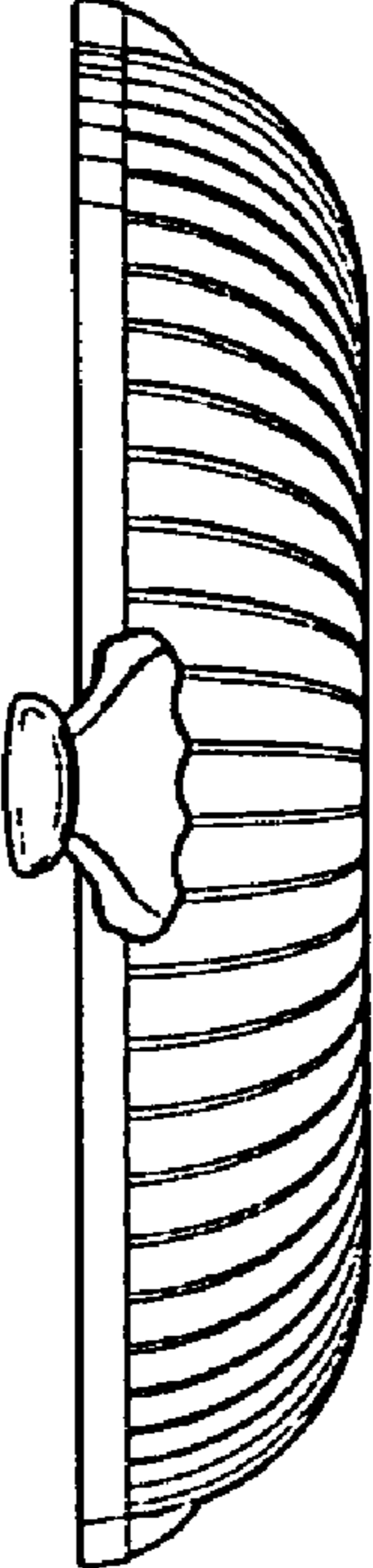

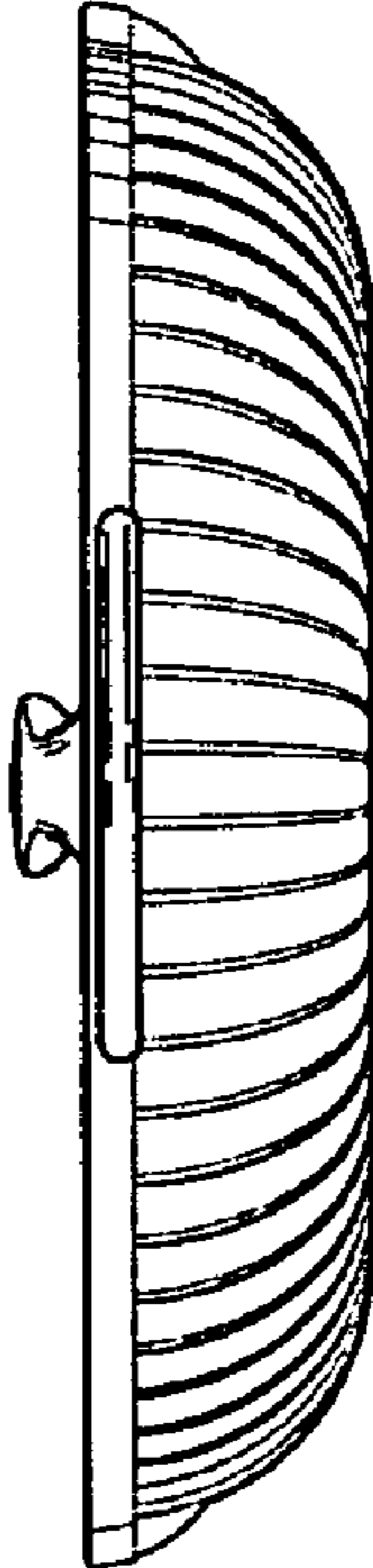

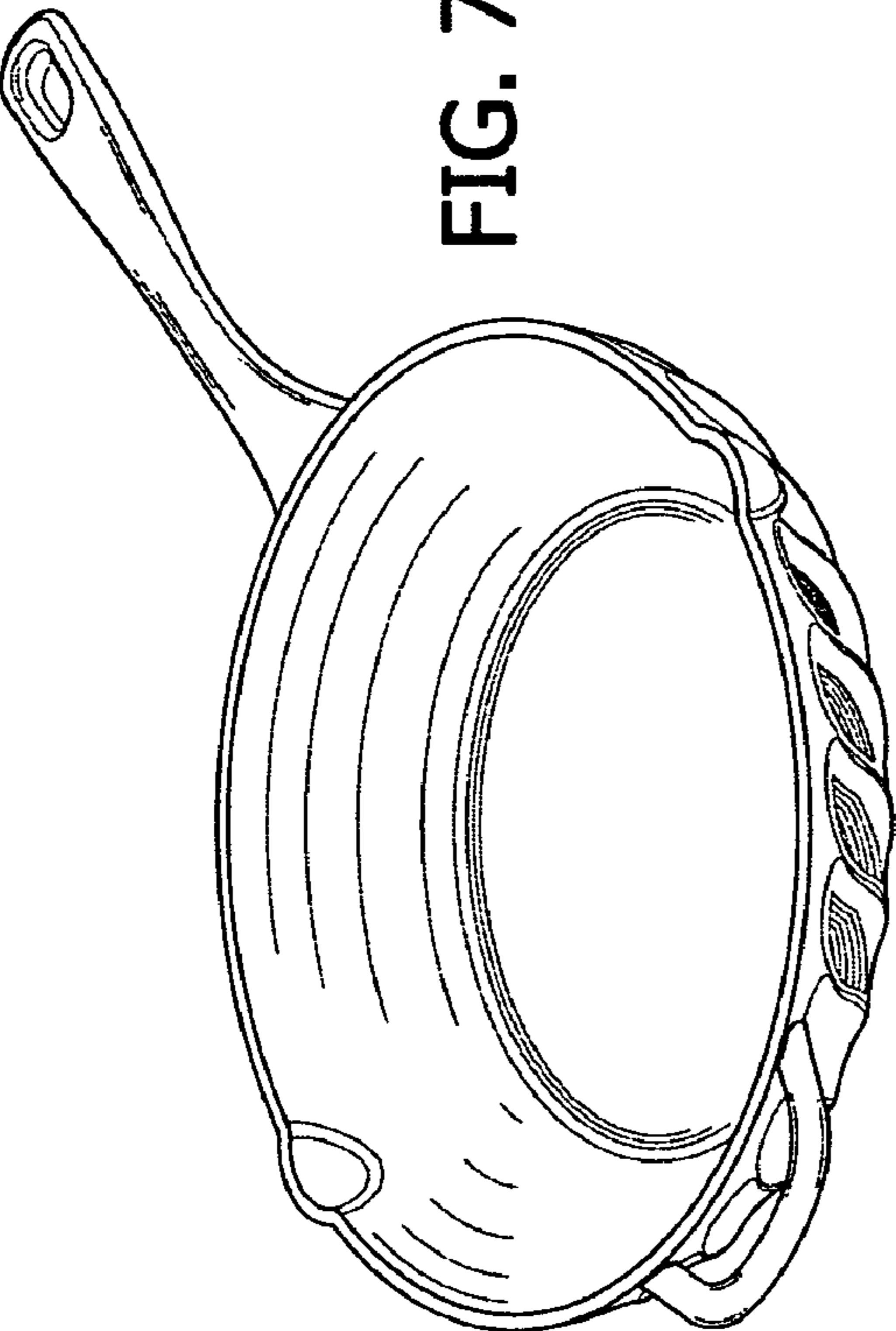

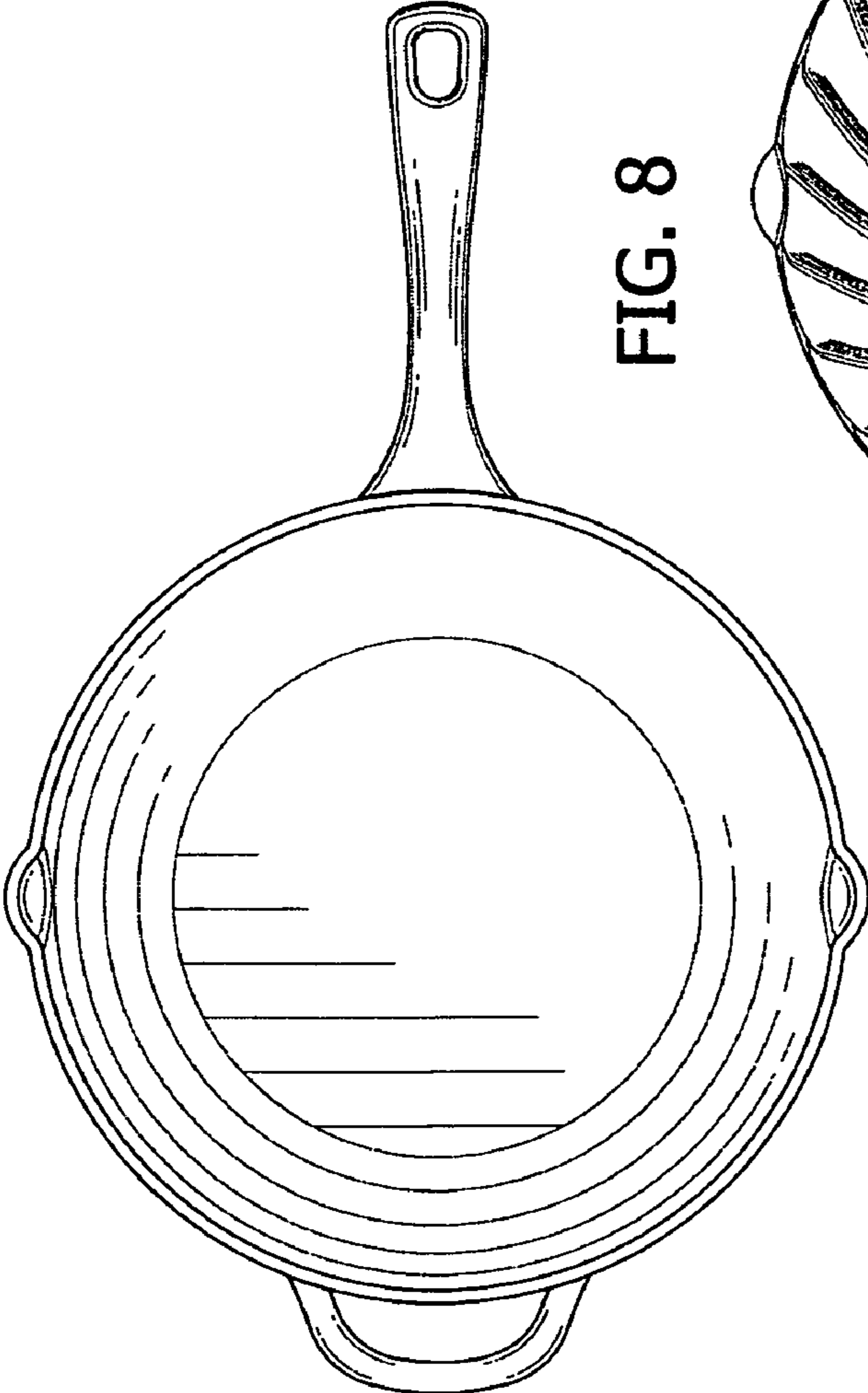

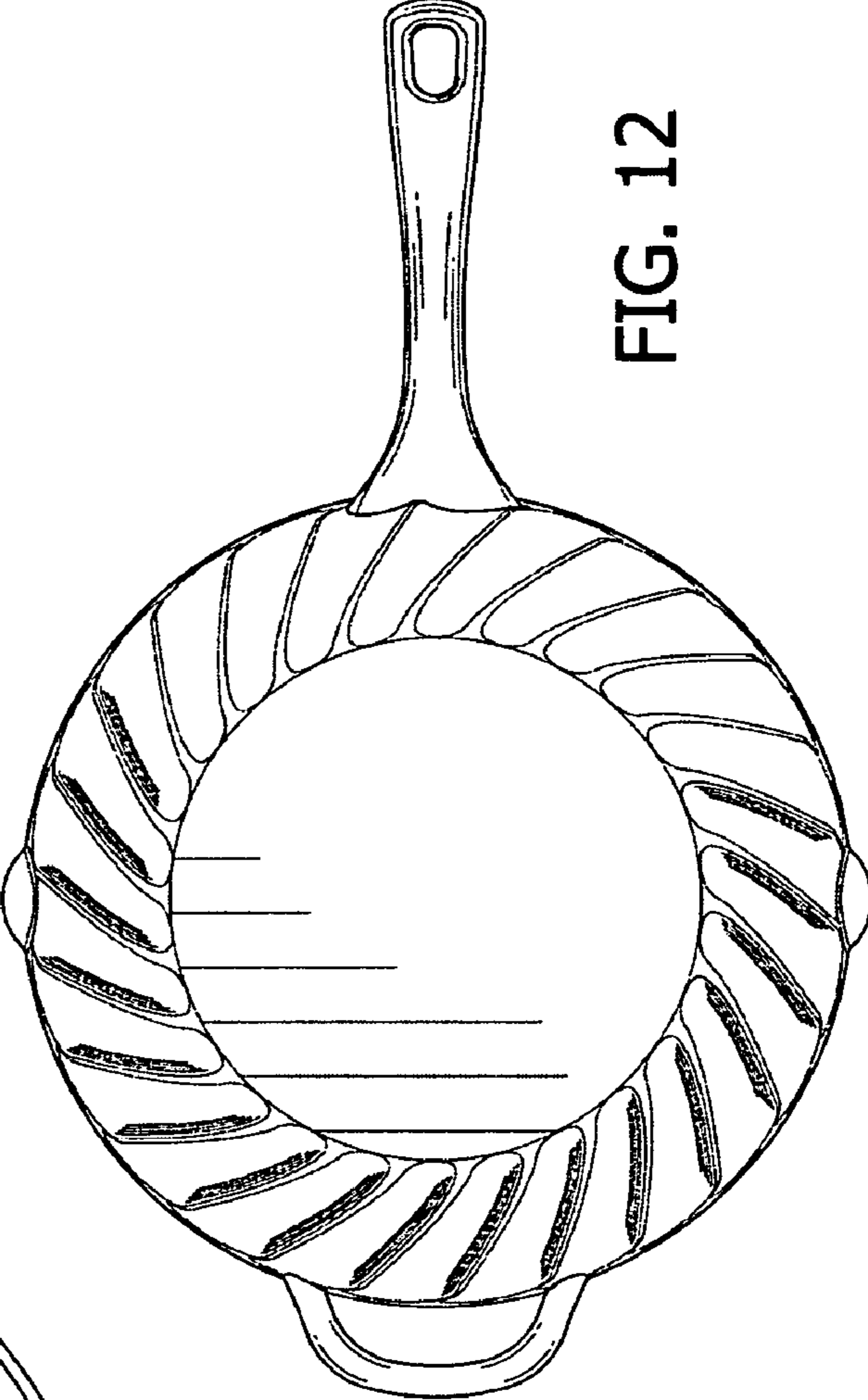

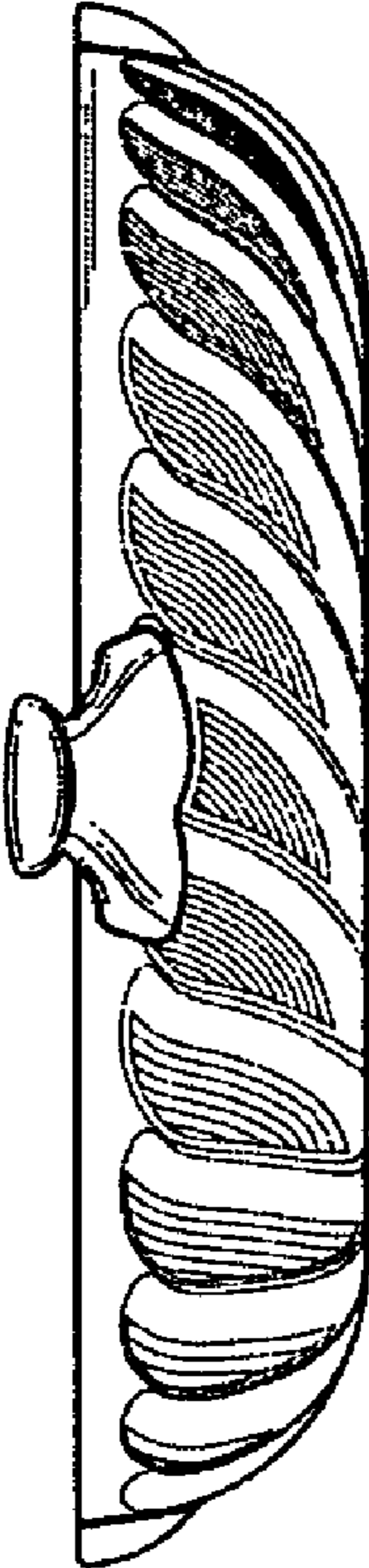

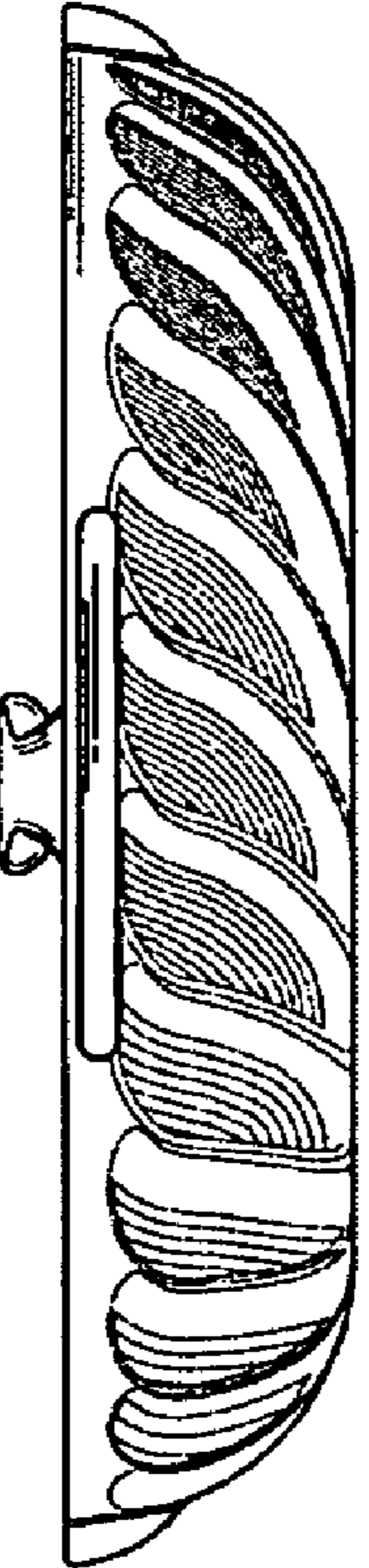
