DESCRIPTION

FIG. 1 is a top, front, and right side perspective view showing my new design for a container lid.

FIG. 2 is a top view of the container lid shown in FIG. 1.

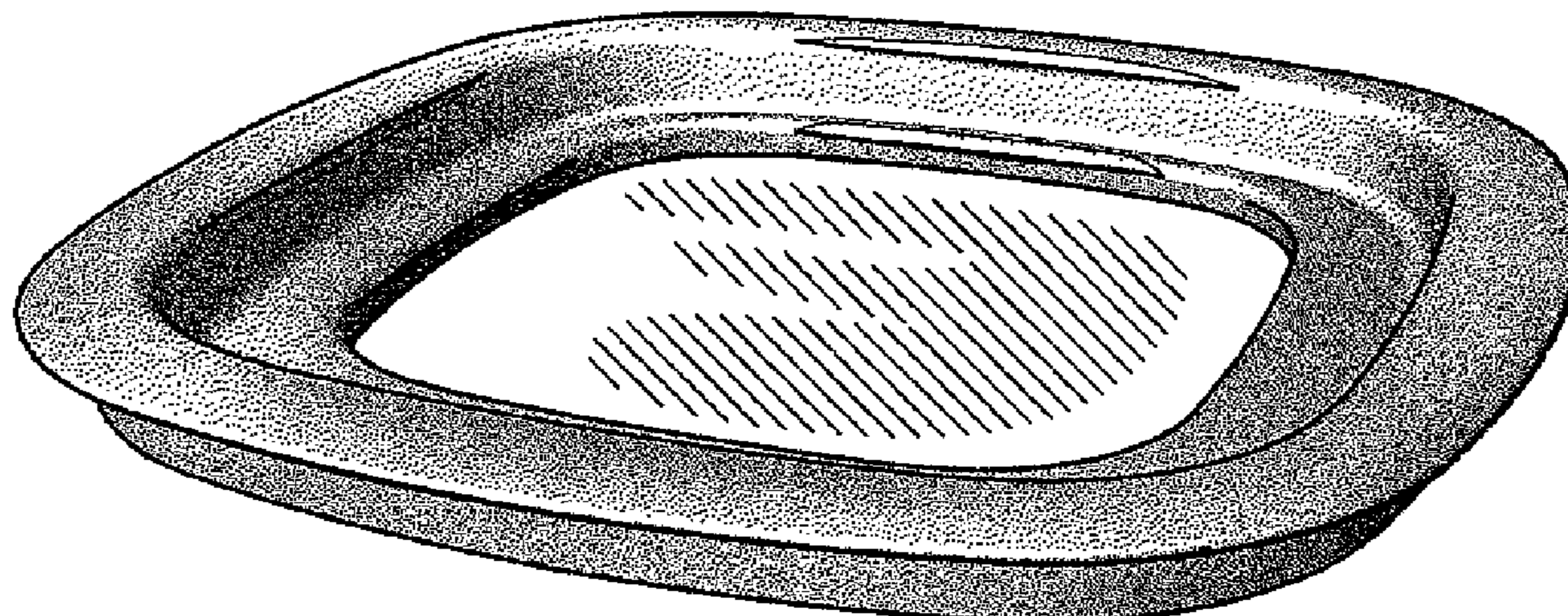
FIG. 3 is a front view of the container lid shown in FIG. 1, the rear view being a mirror image thereof.

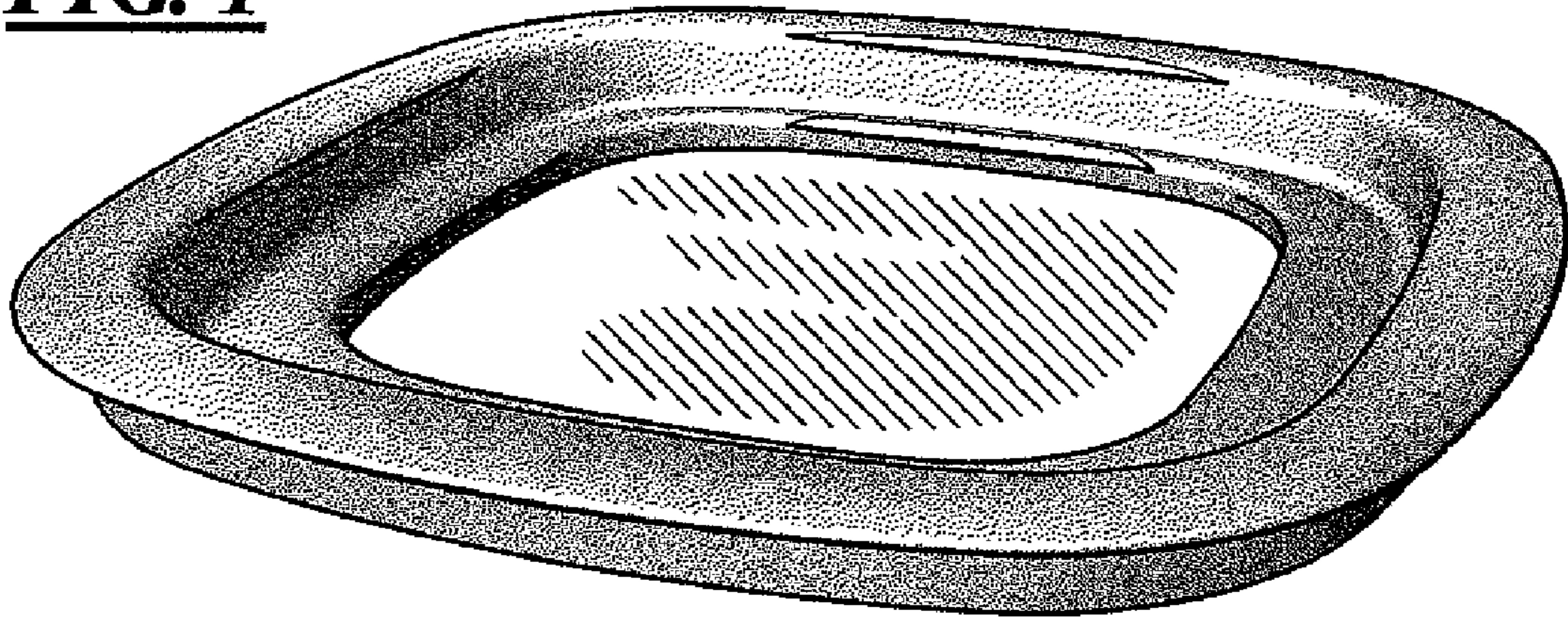

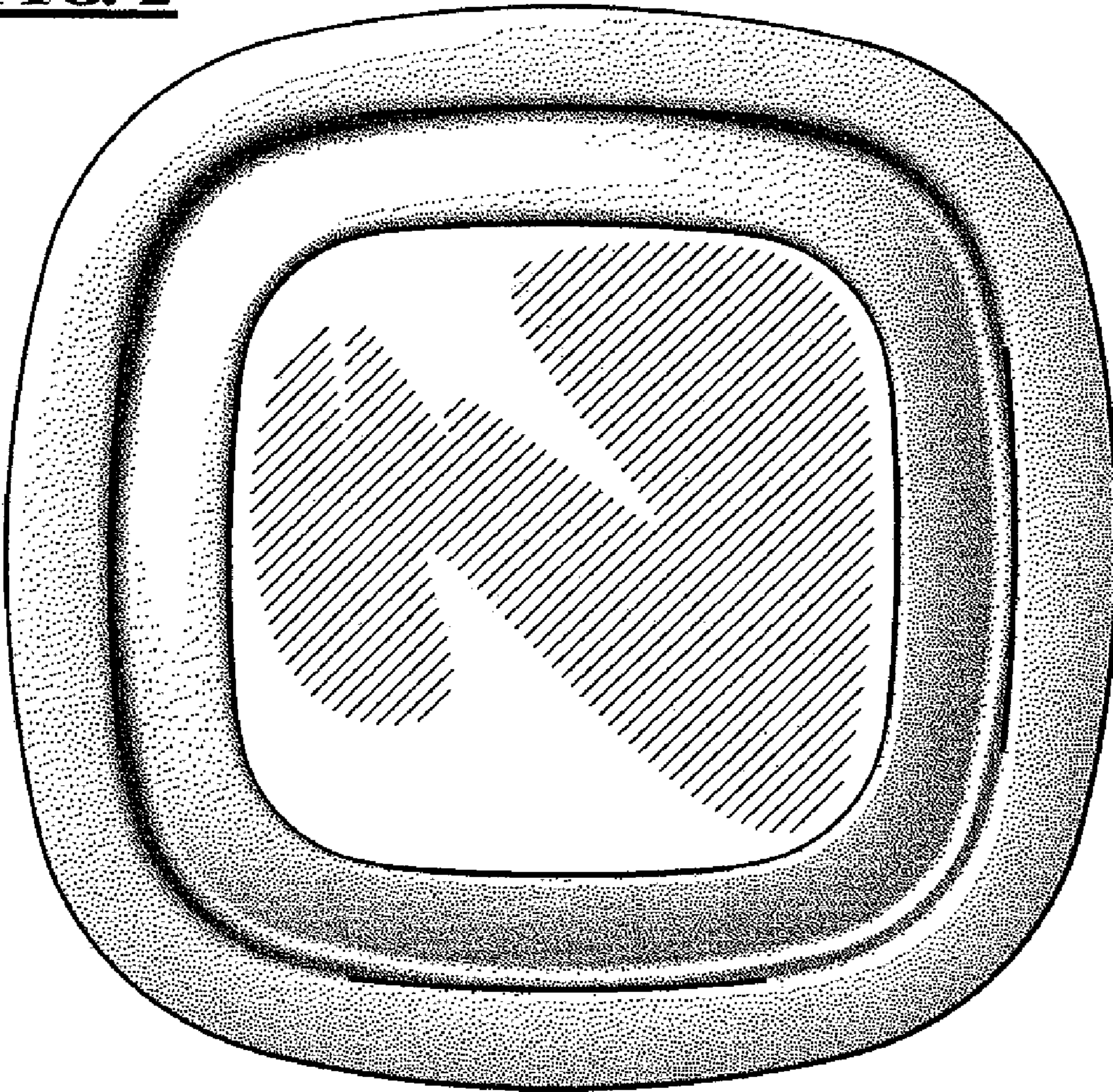

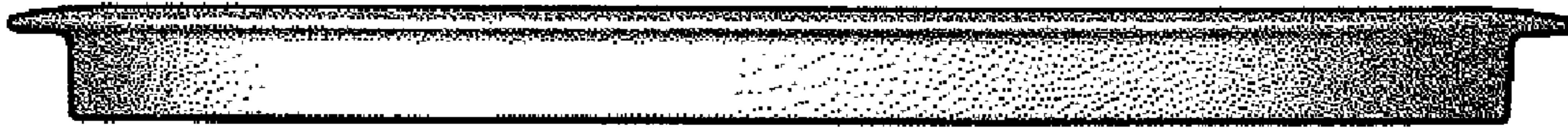
