The ornamental design for a container body portion, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-right perspective view of a container body portion of the present invention;

FIG. 2 is a top-rear-right perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side elevational view being mirror image of the left side elevational view;

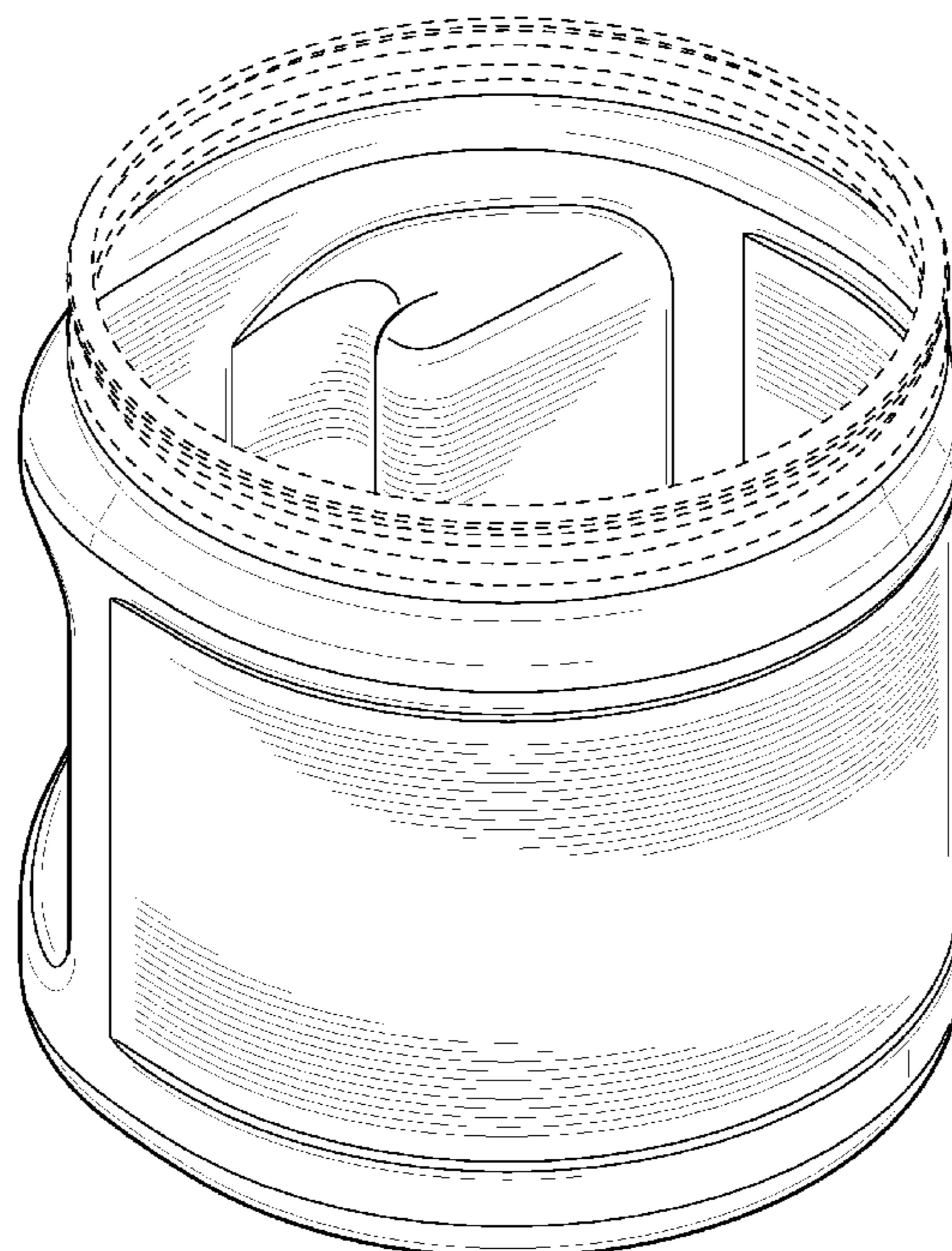
FIG. 5 is a rear elevational view thereof;

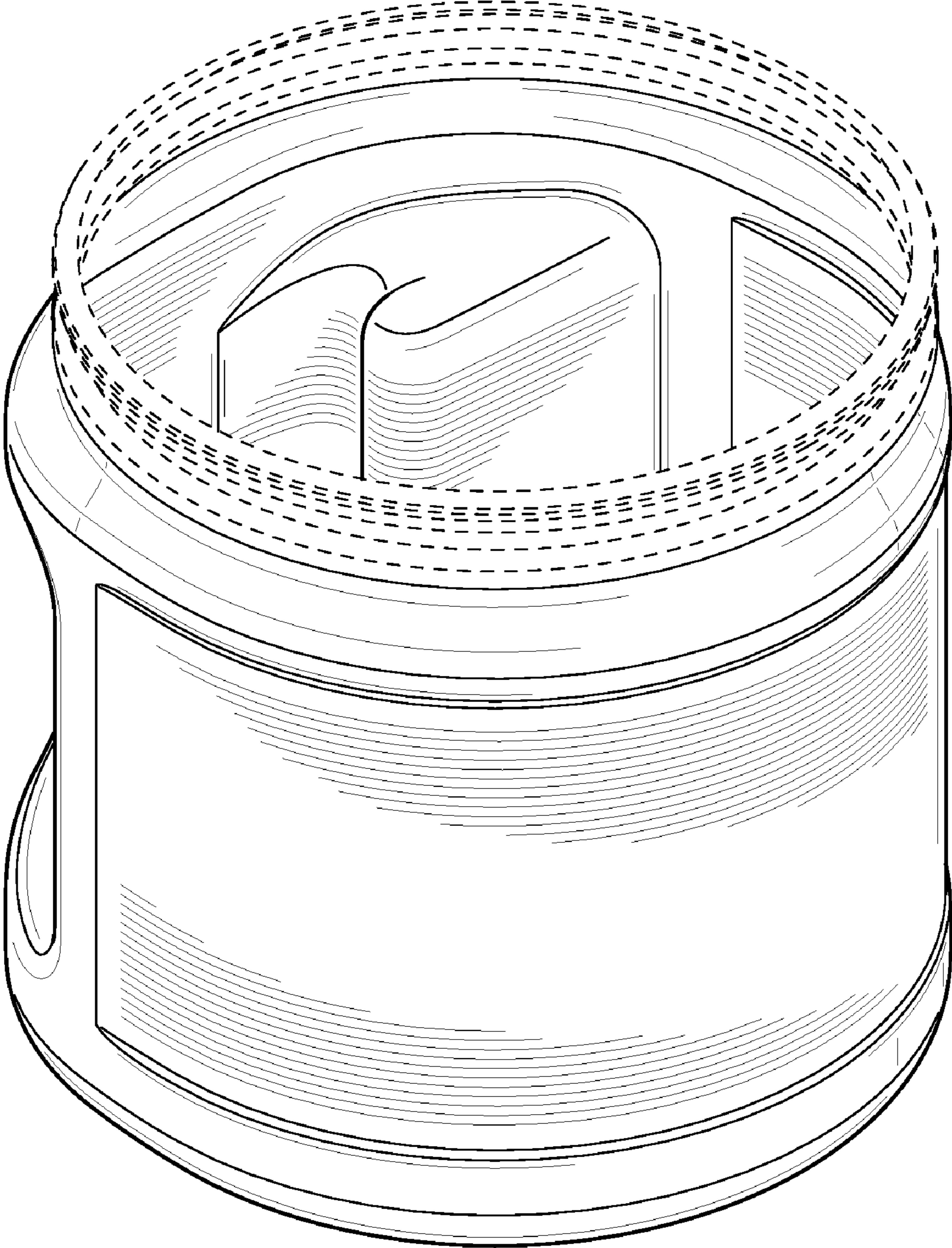

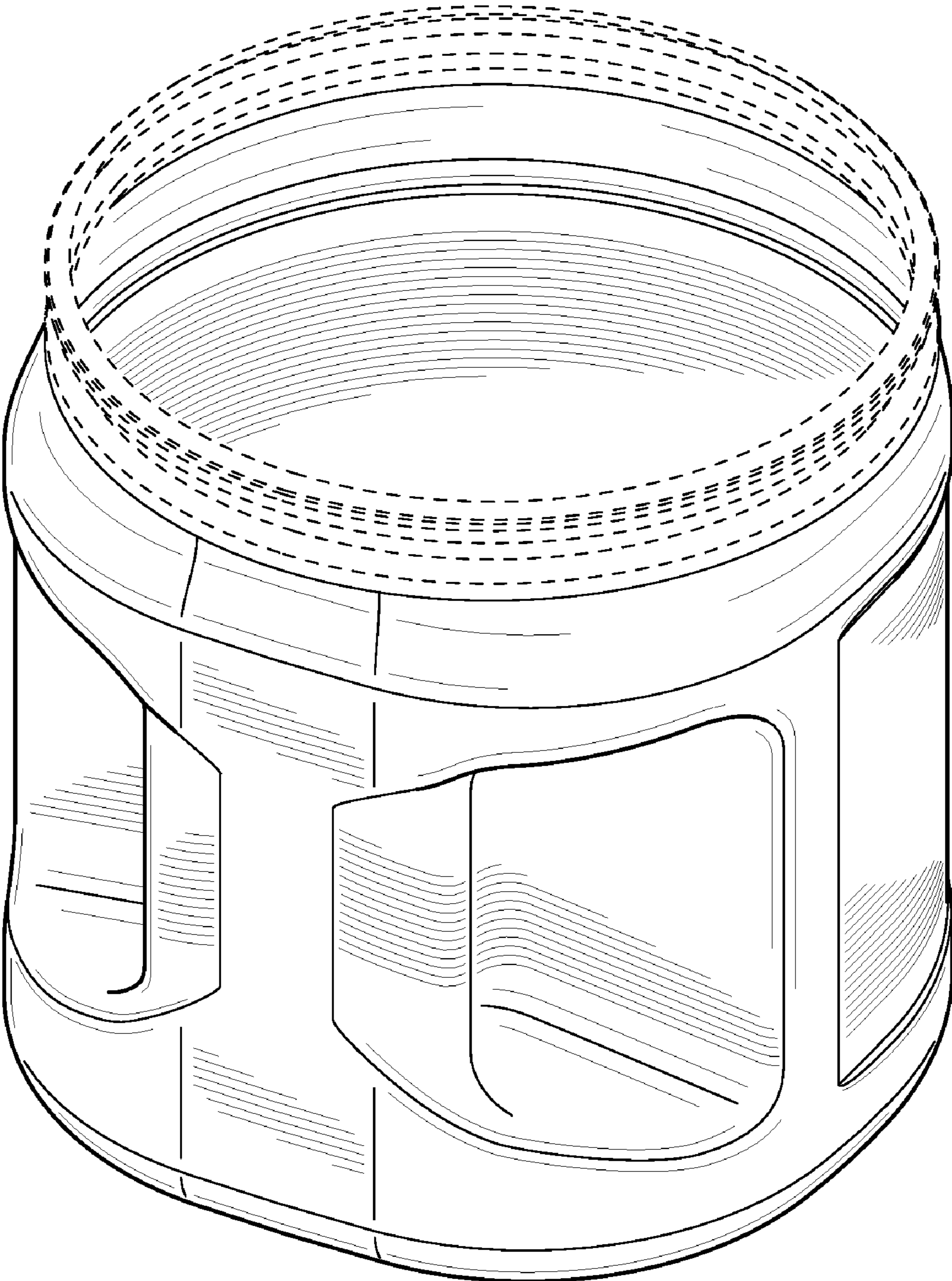

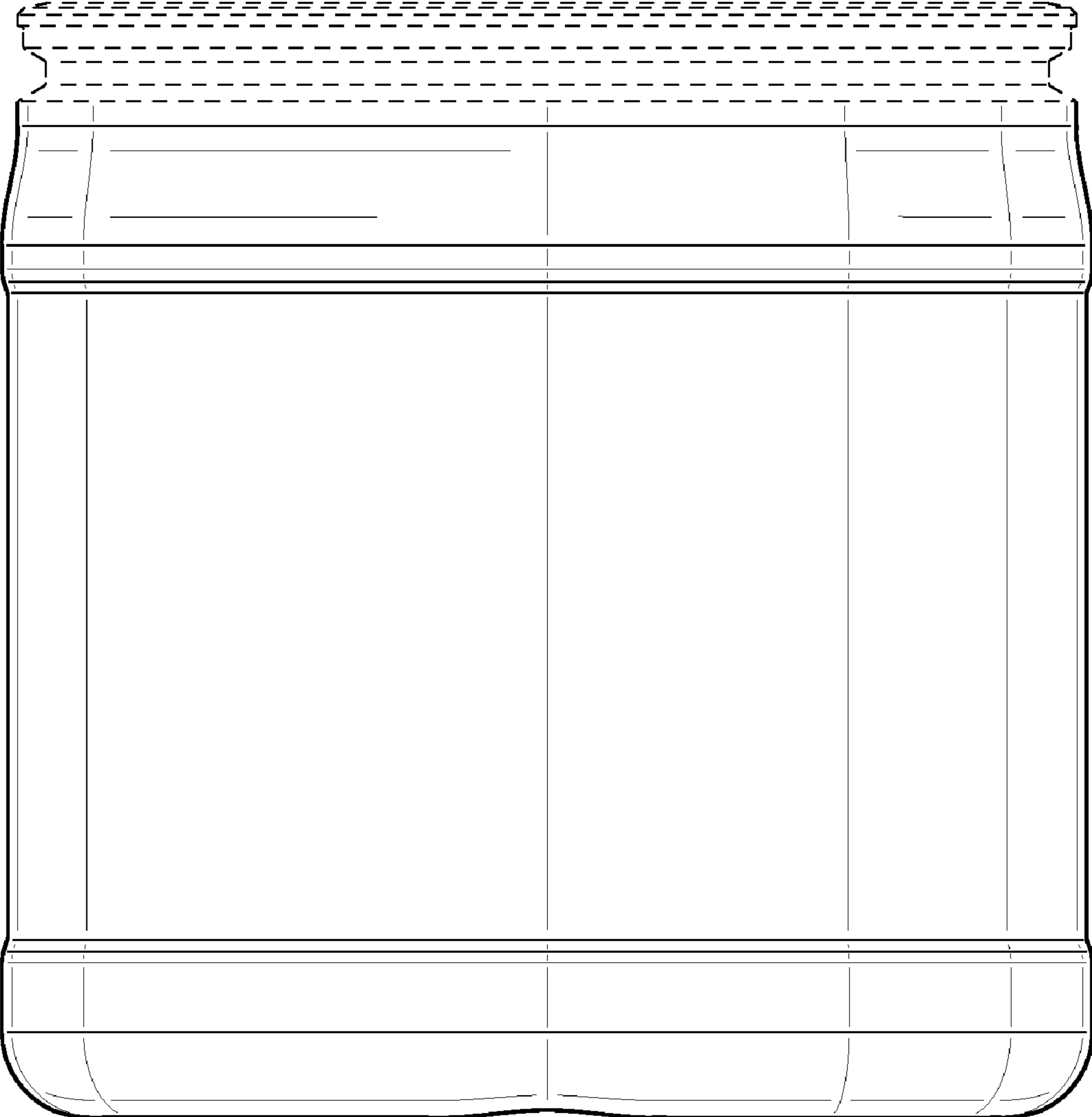

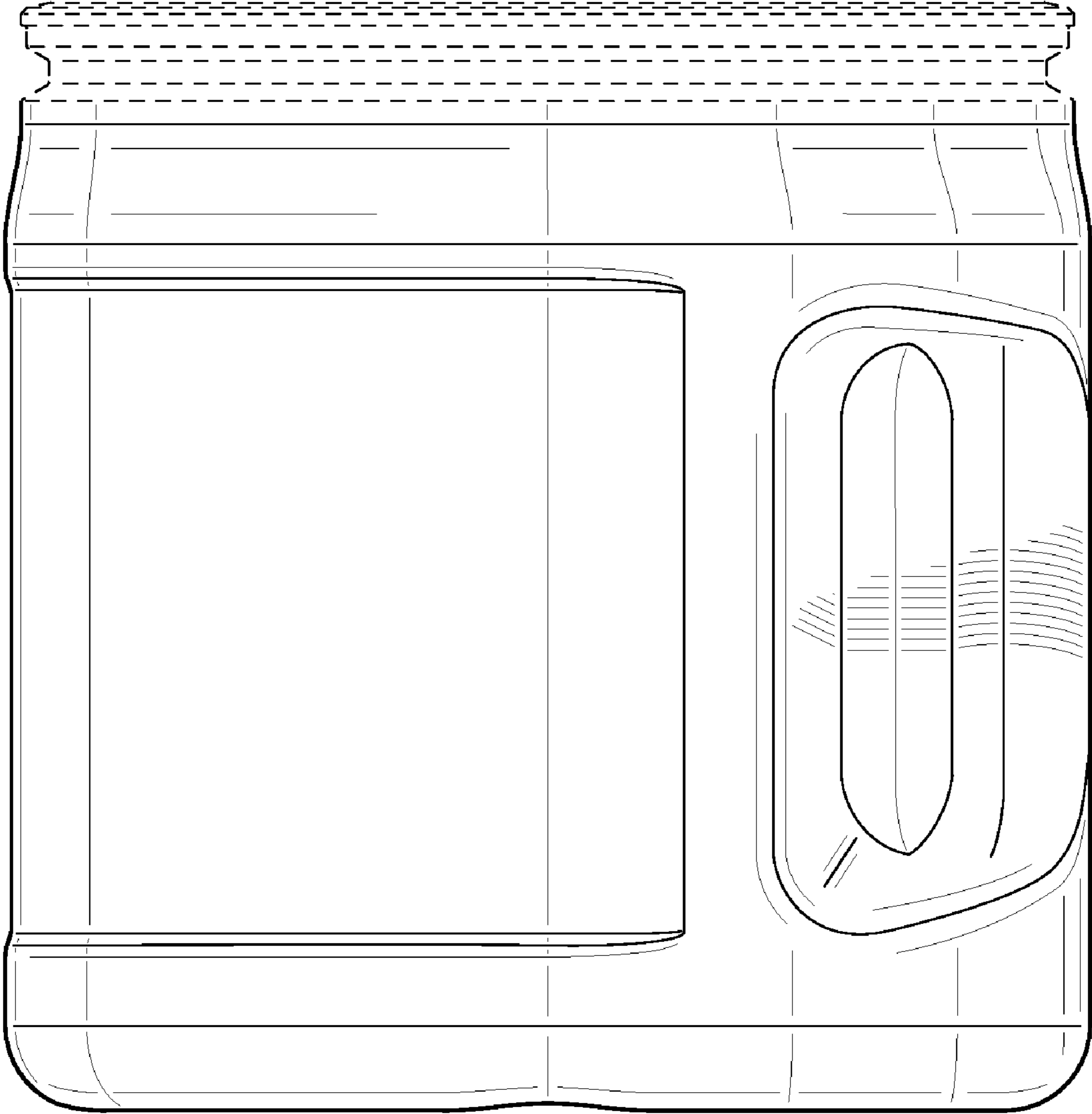

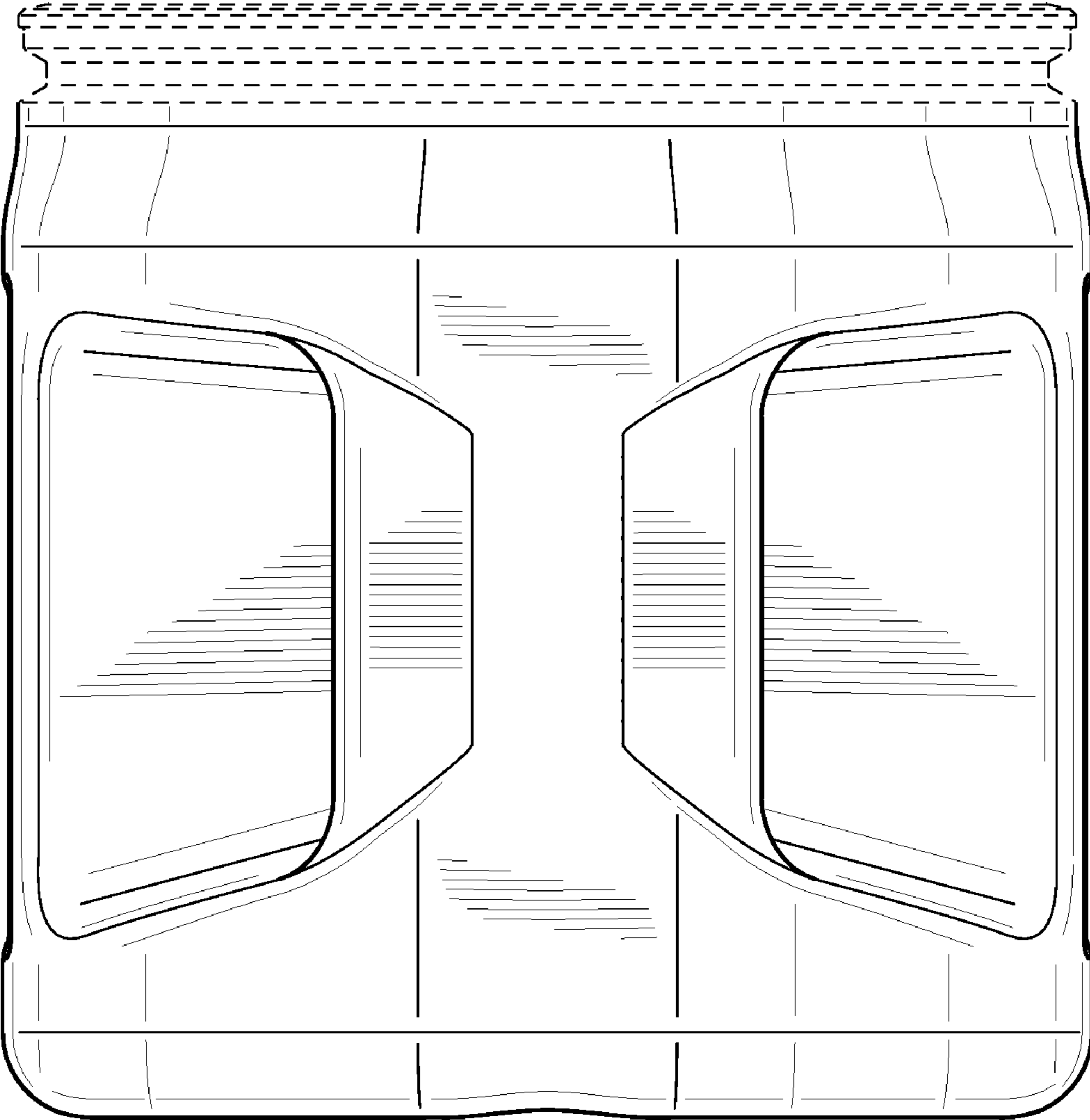

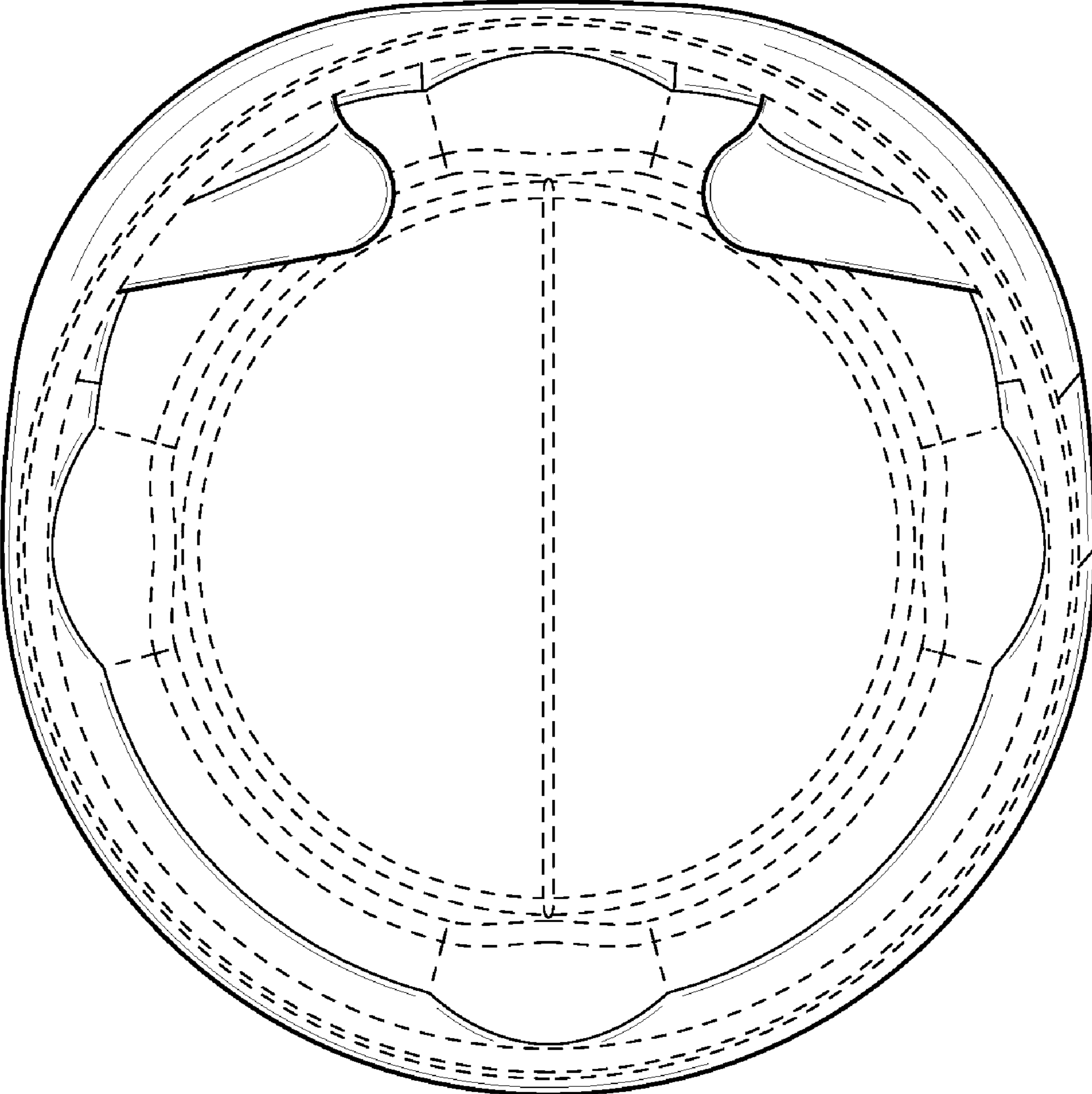

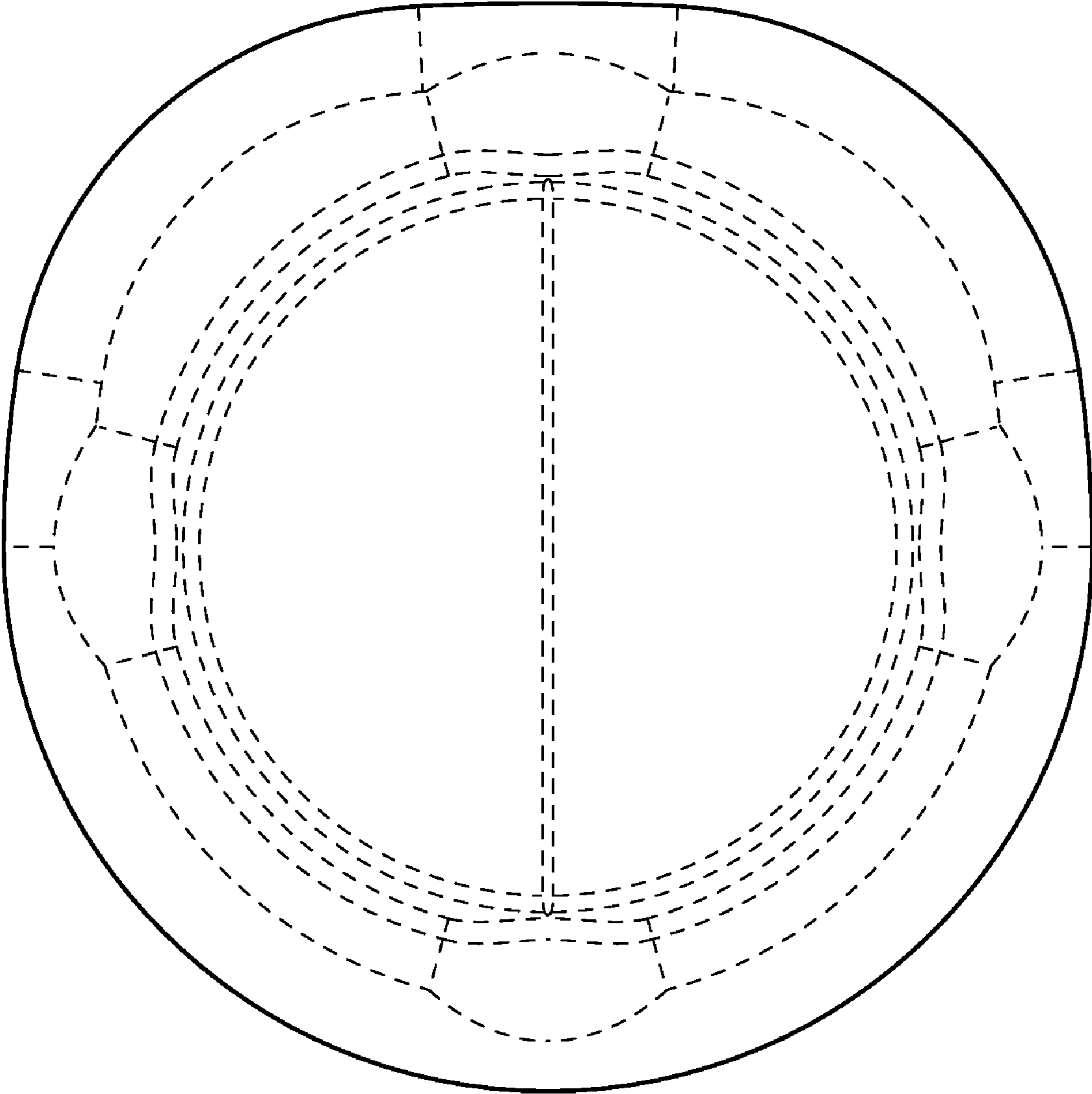
