(57) **CLAIM**

The ornamental design for a group of gilt-edge sheets, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a group of gilt-edge sheets, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

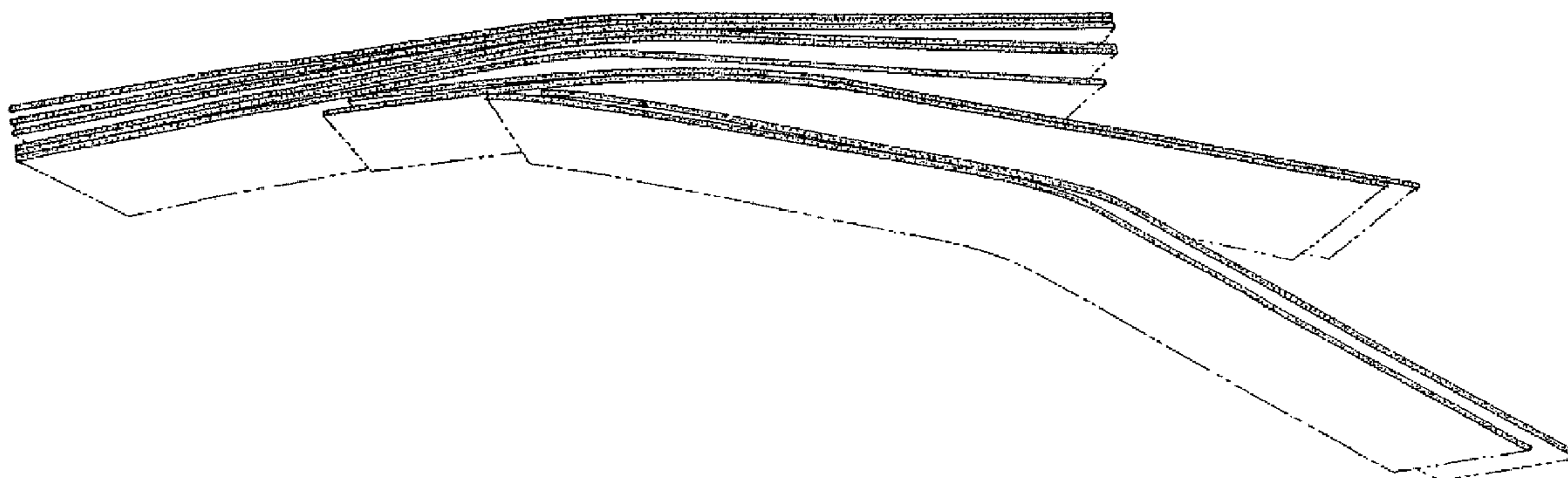
FIG. 6 is an end elevational view thereof from the right of FIG. 2; and,

FIG. 7 is an end elevational view thereof from the left of FIG. 2.

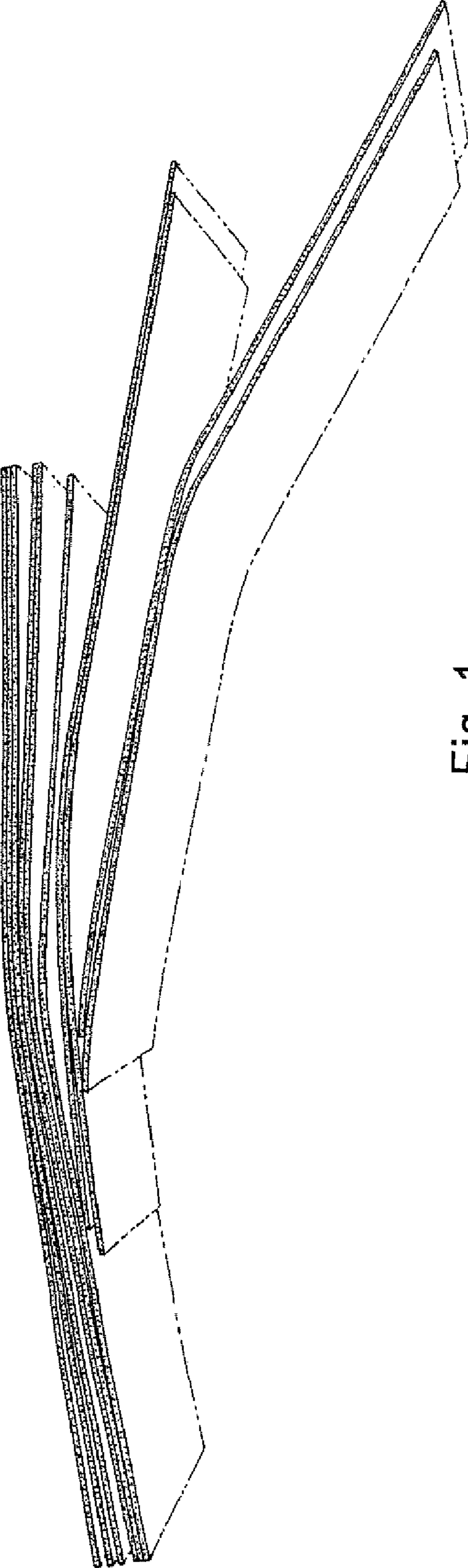

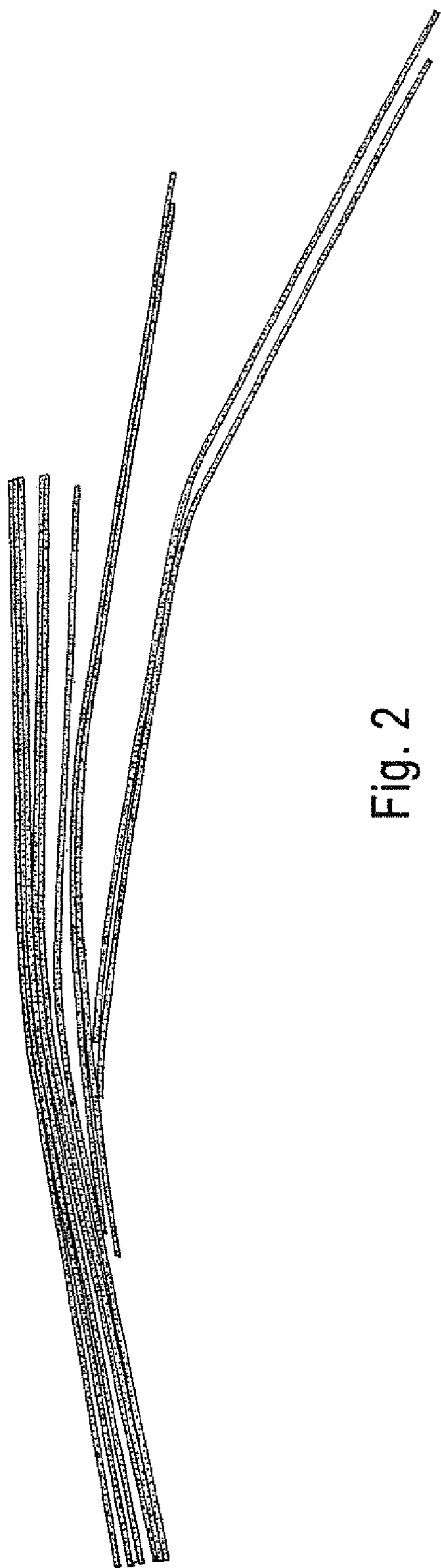

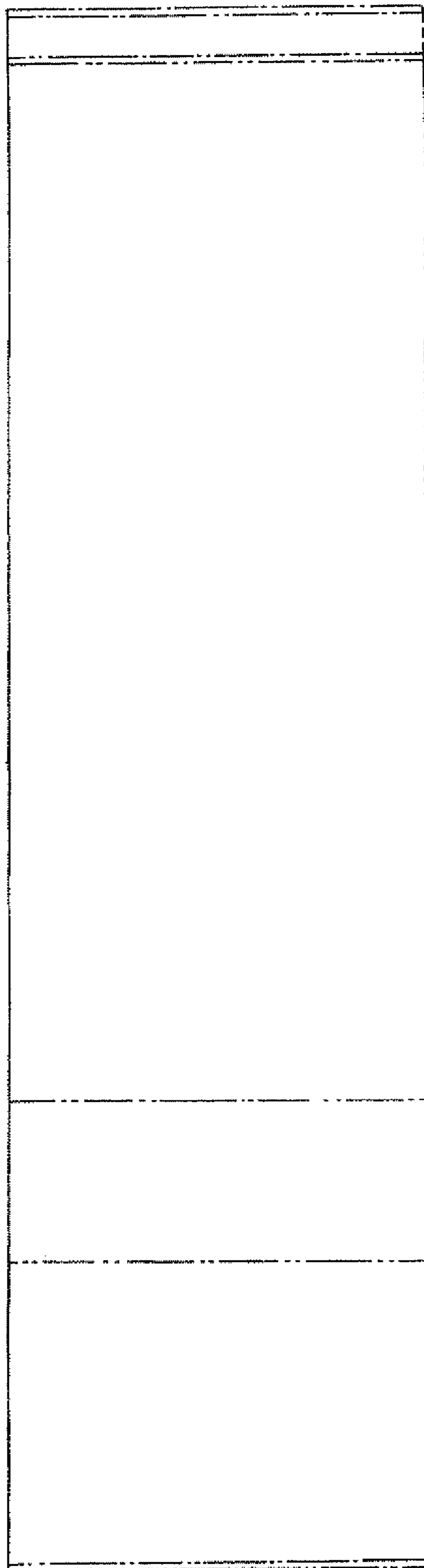

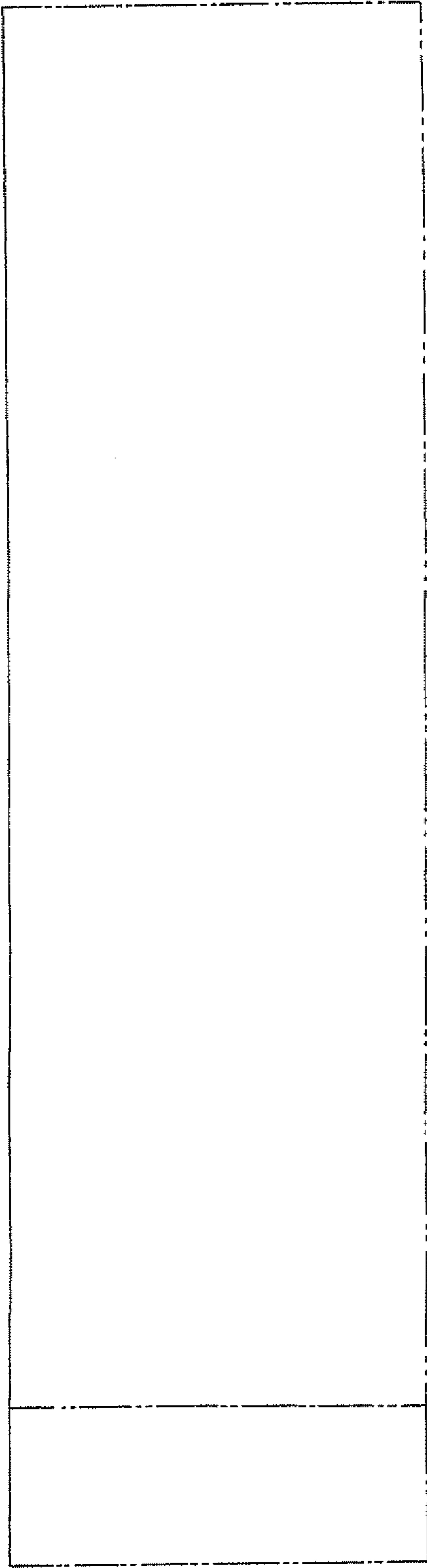

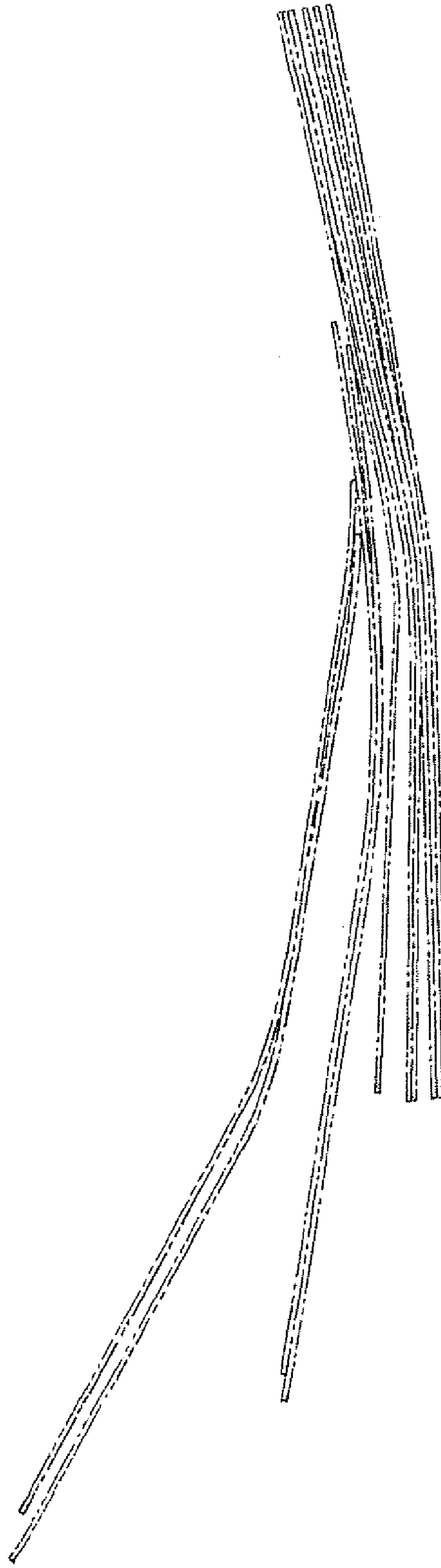

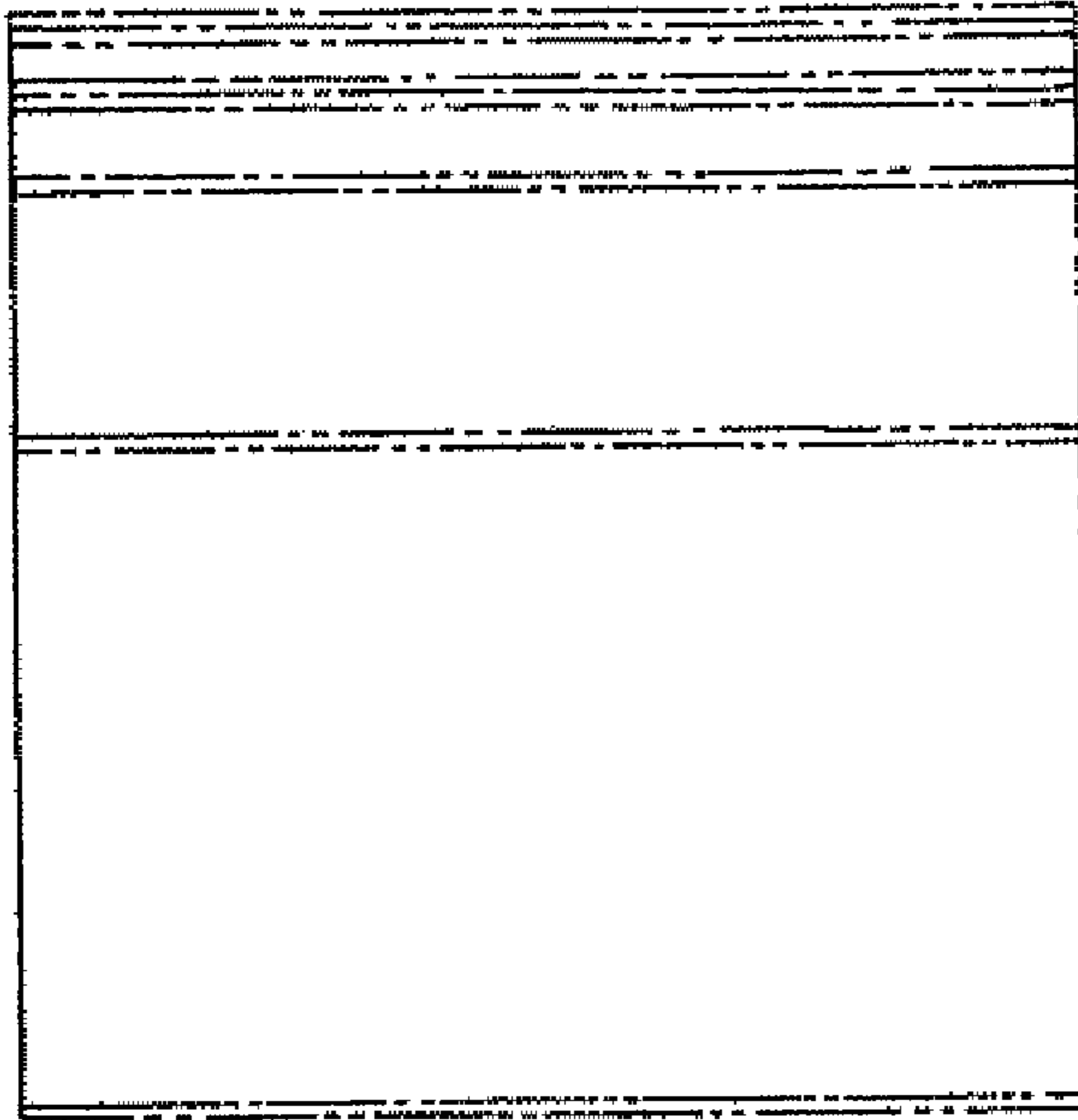

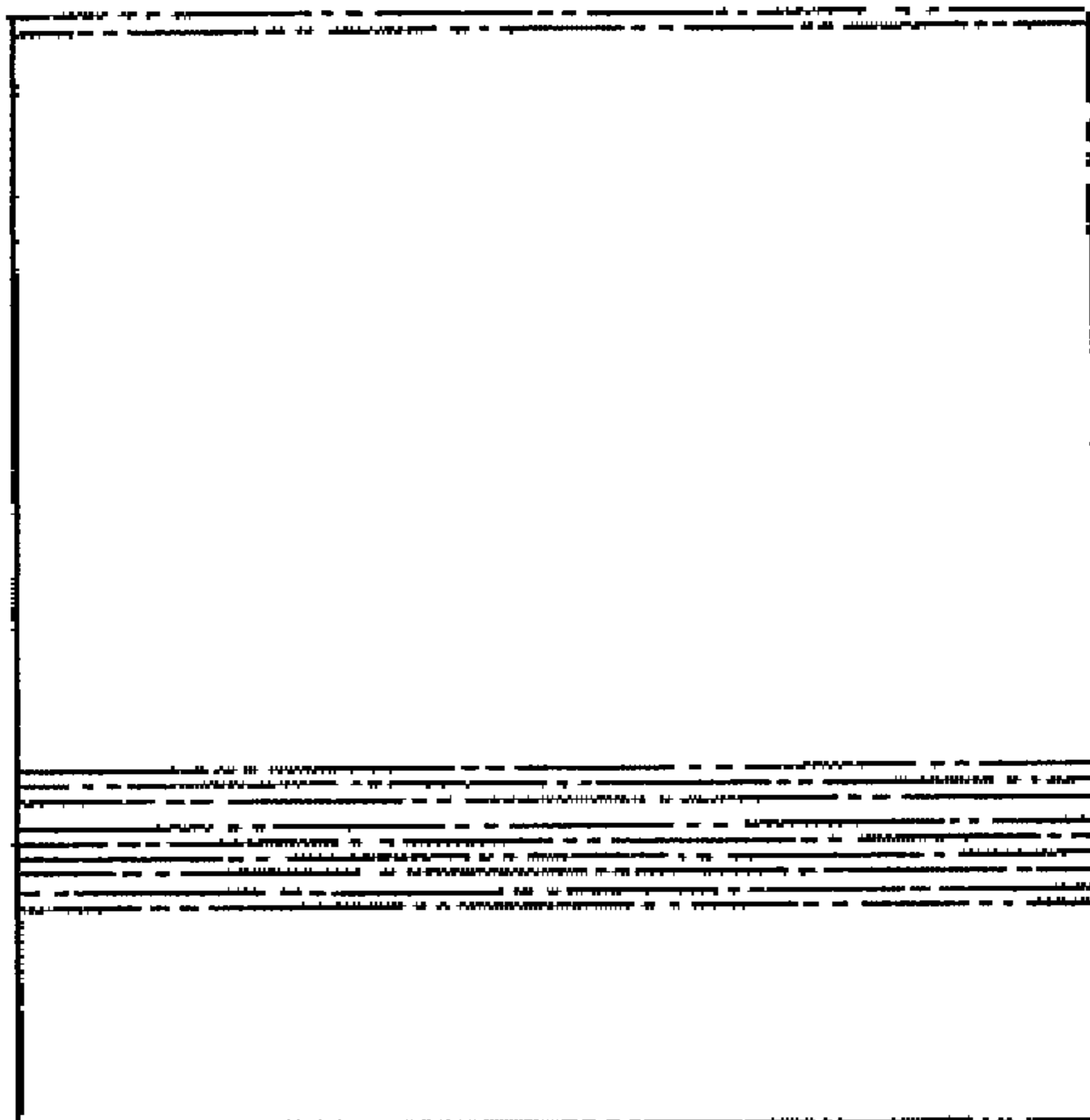
