**DESCRIPTION**

FIG. 1 is a side perspective view of the off-road vehicle frame; FIG. 2 is another side perspective view of the off-road vehicle frame;

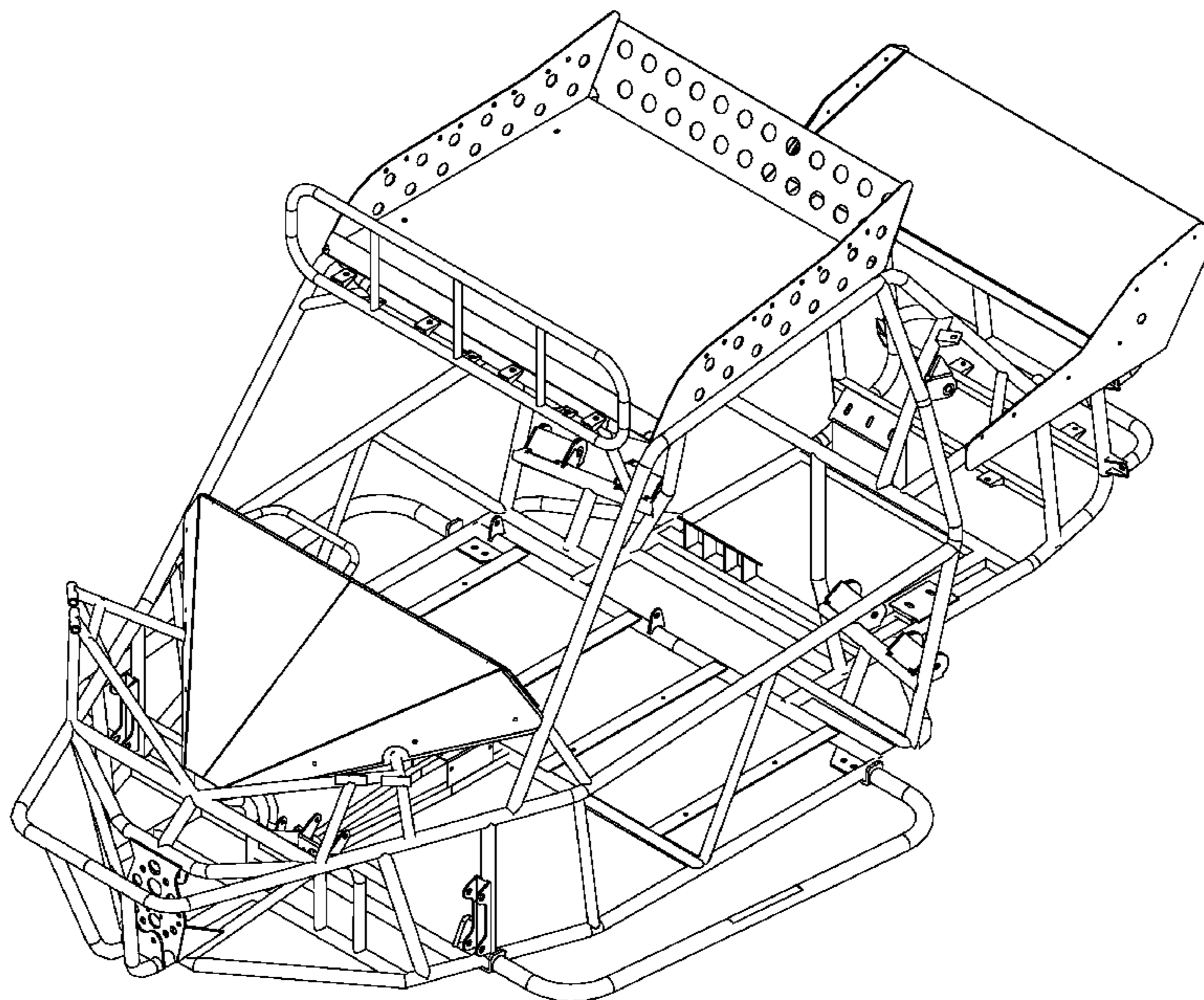
FIG. 3 is a front side elevation of the off-road vehicle frame; FIG. 4 is a driver's side elevation of the off-road vehicle frame;

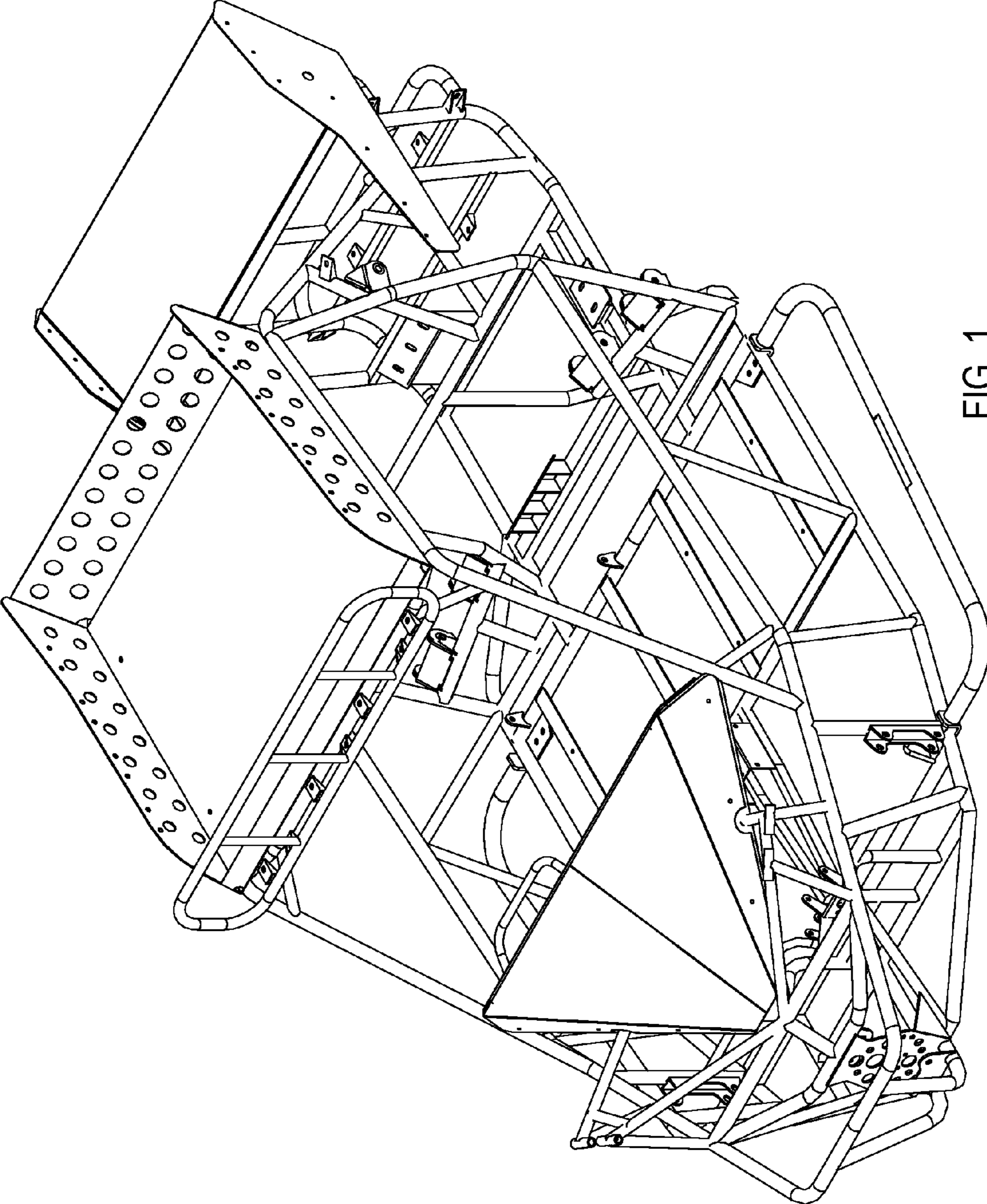

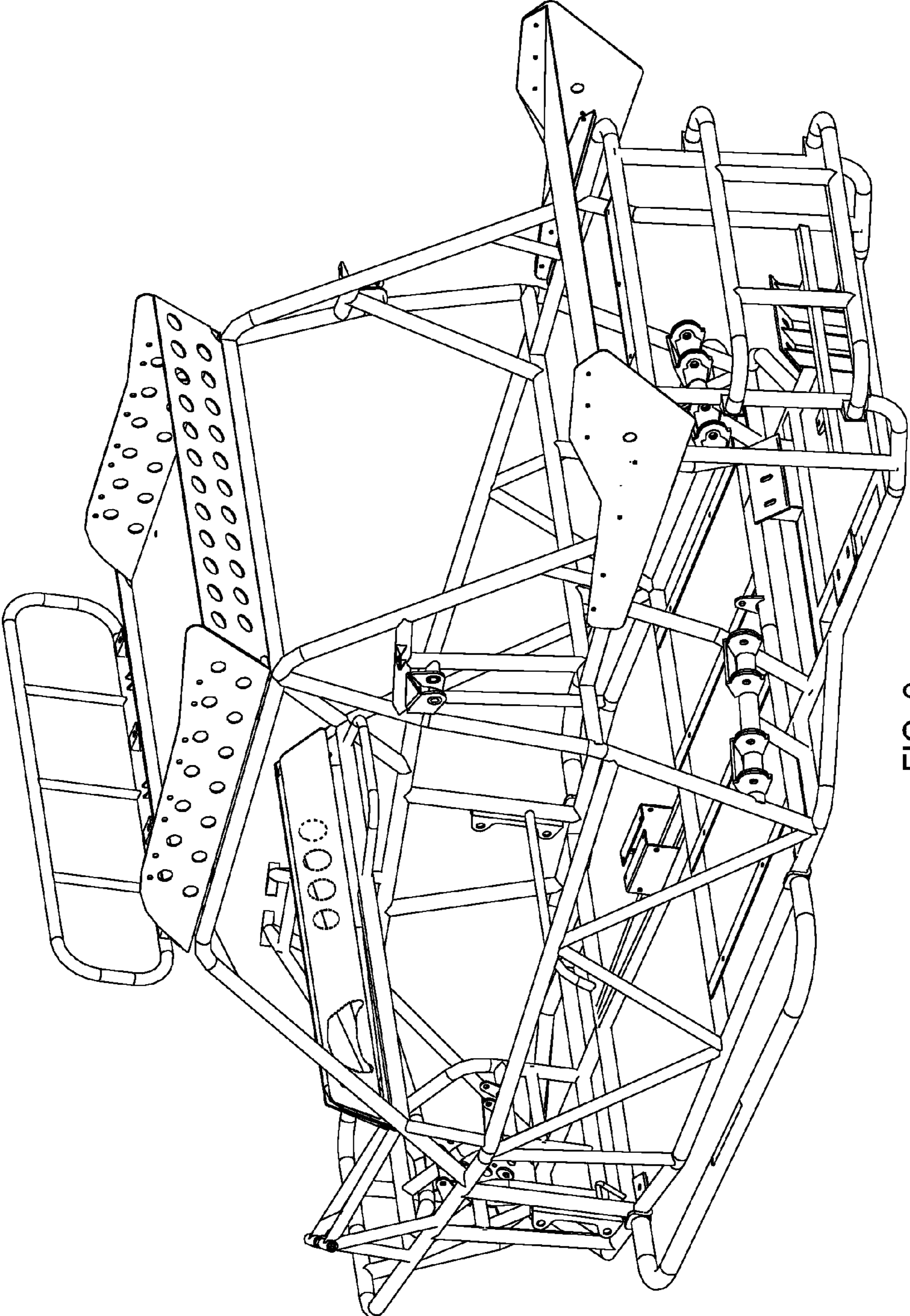

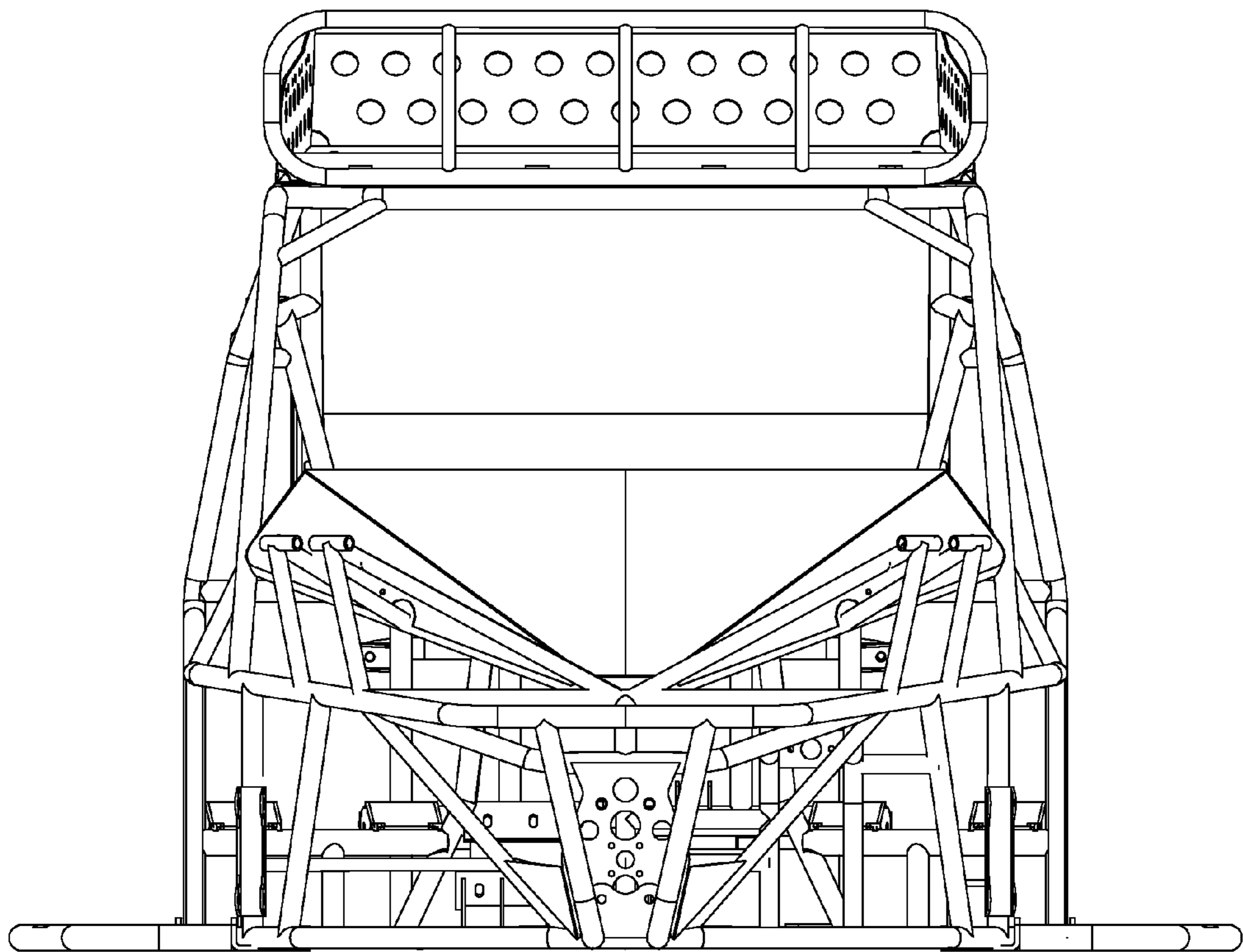

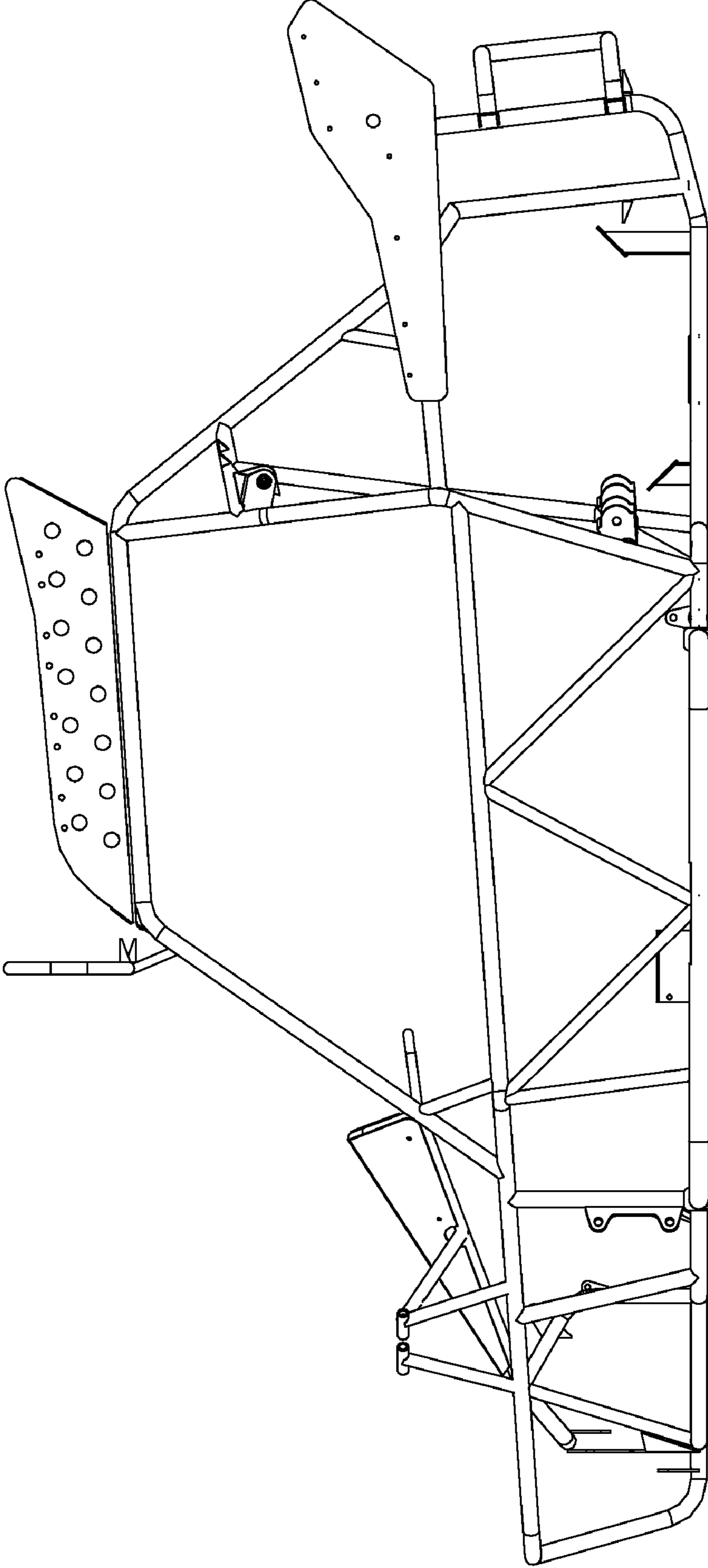

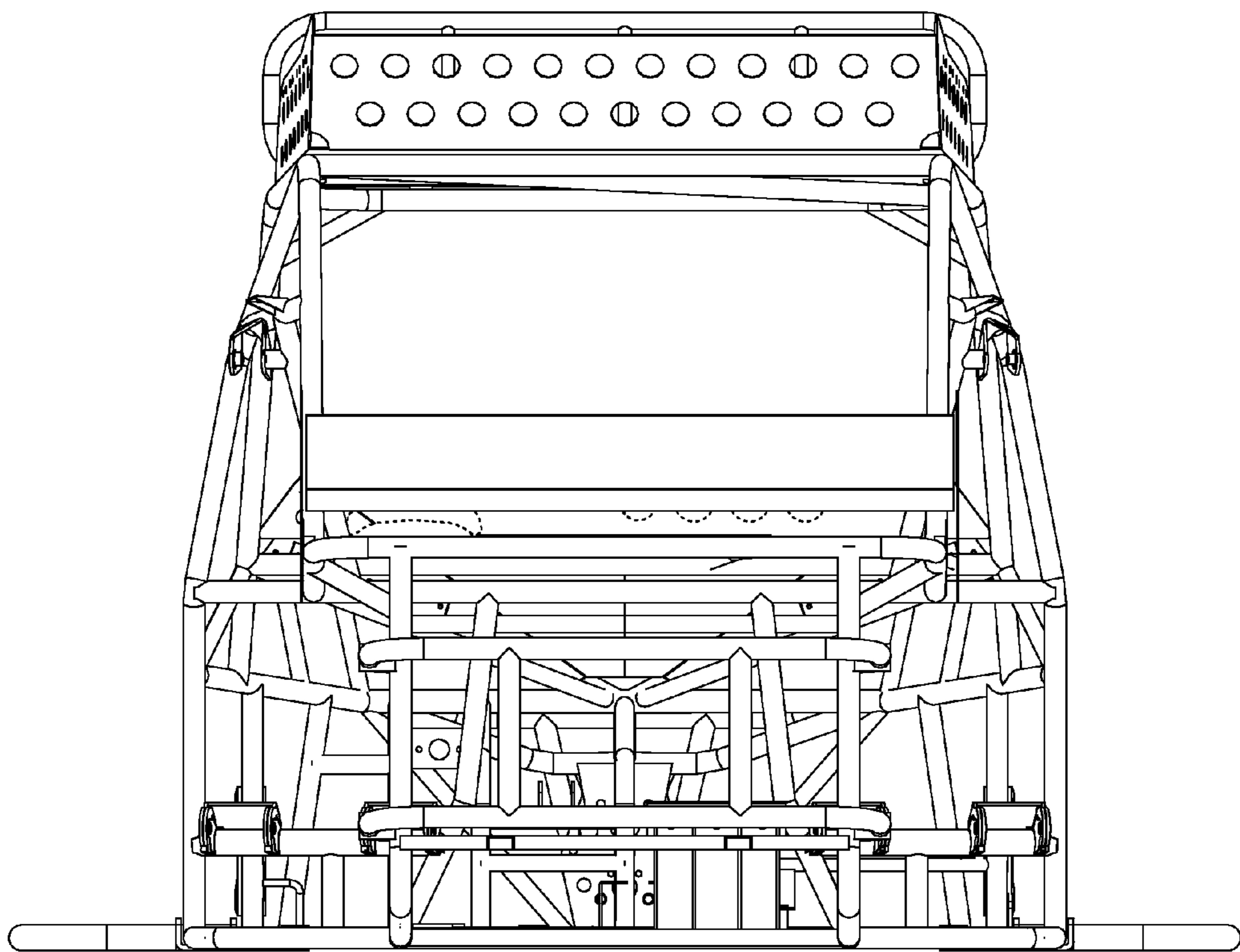

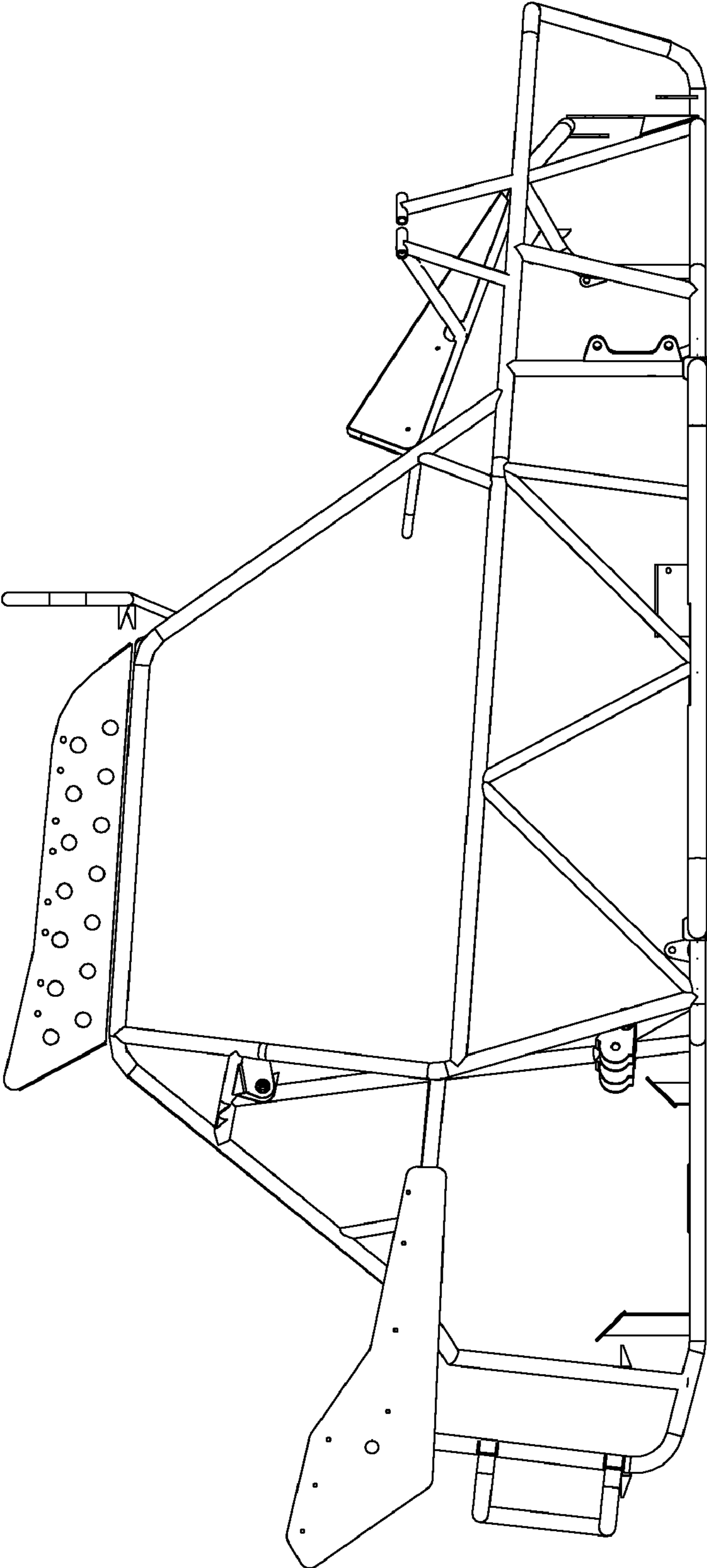

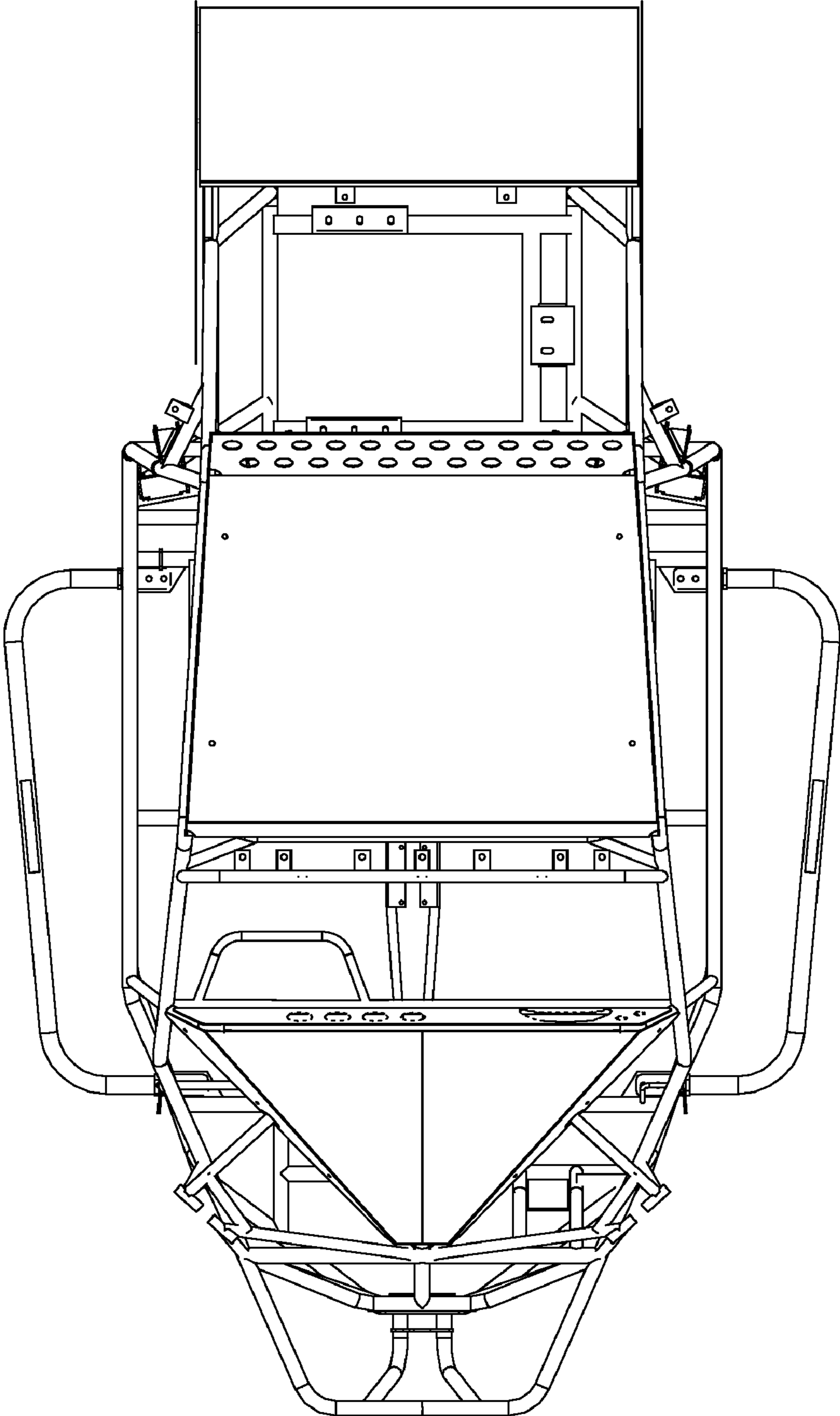

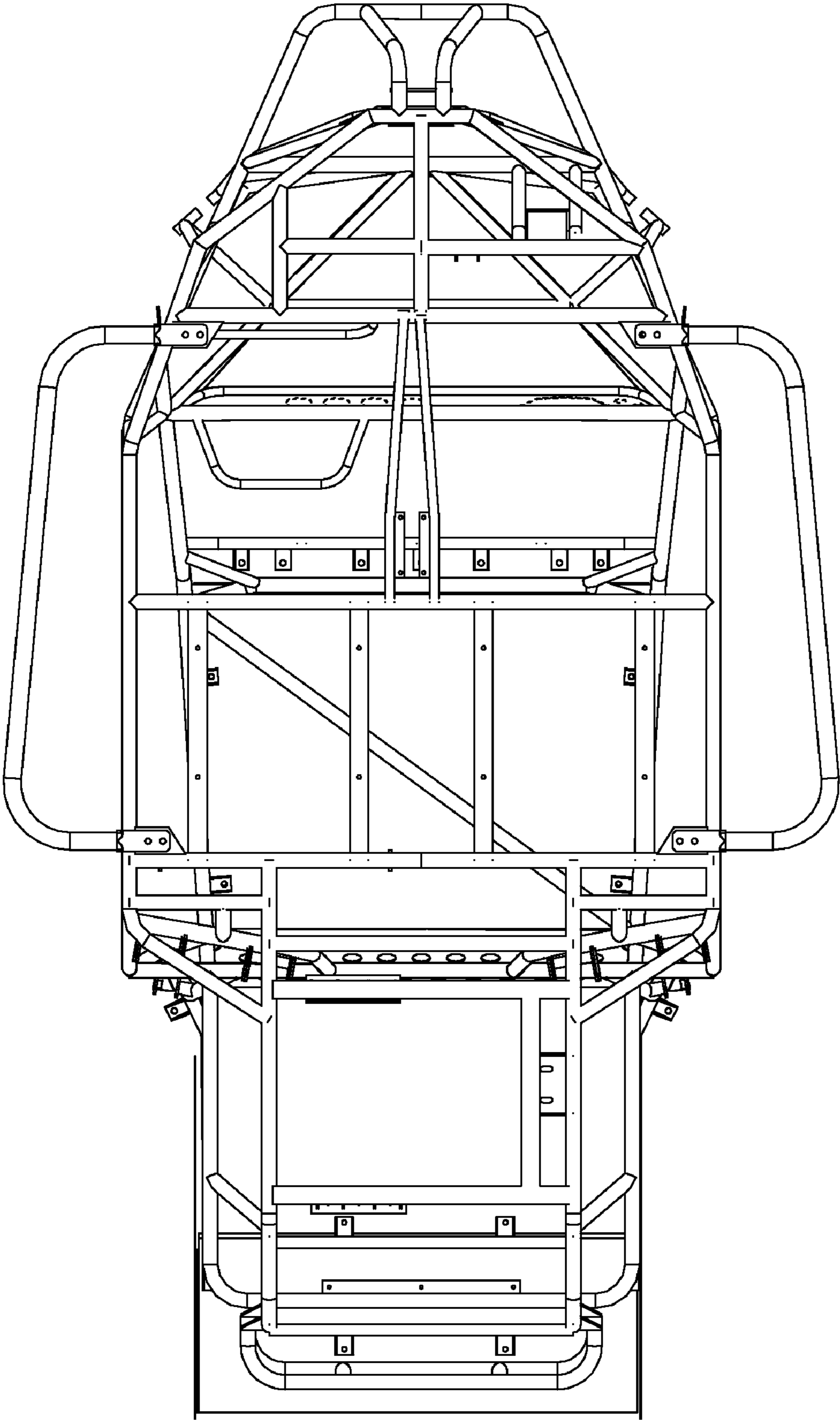

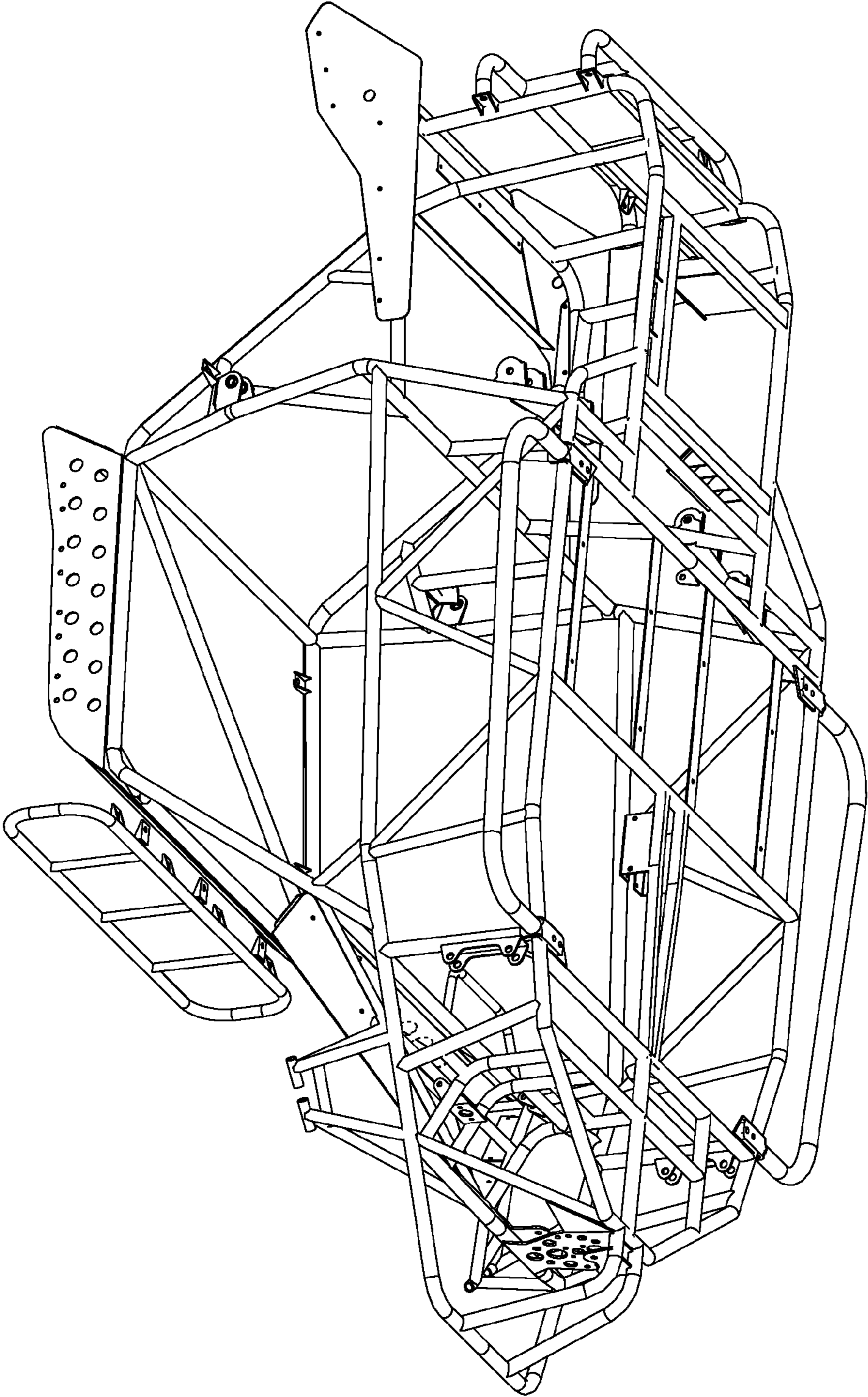

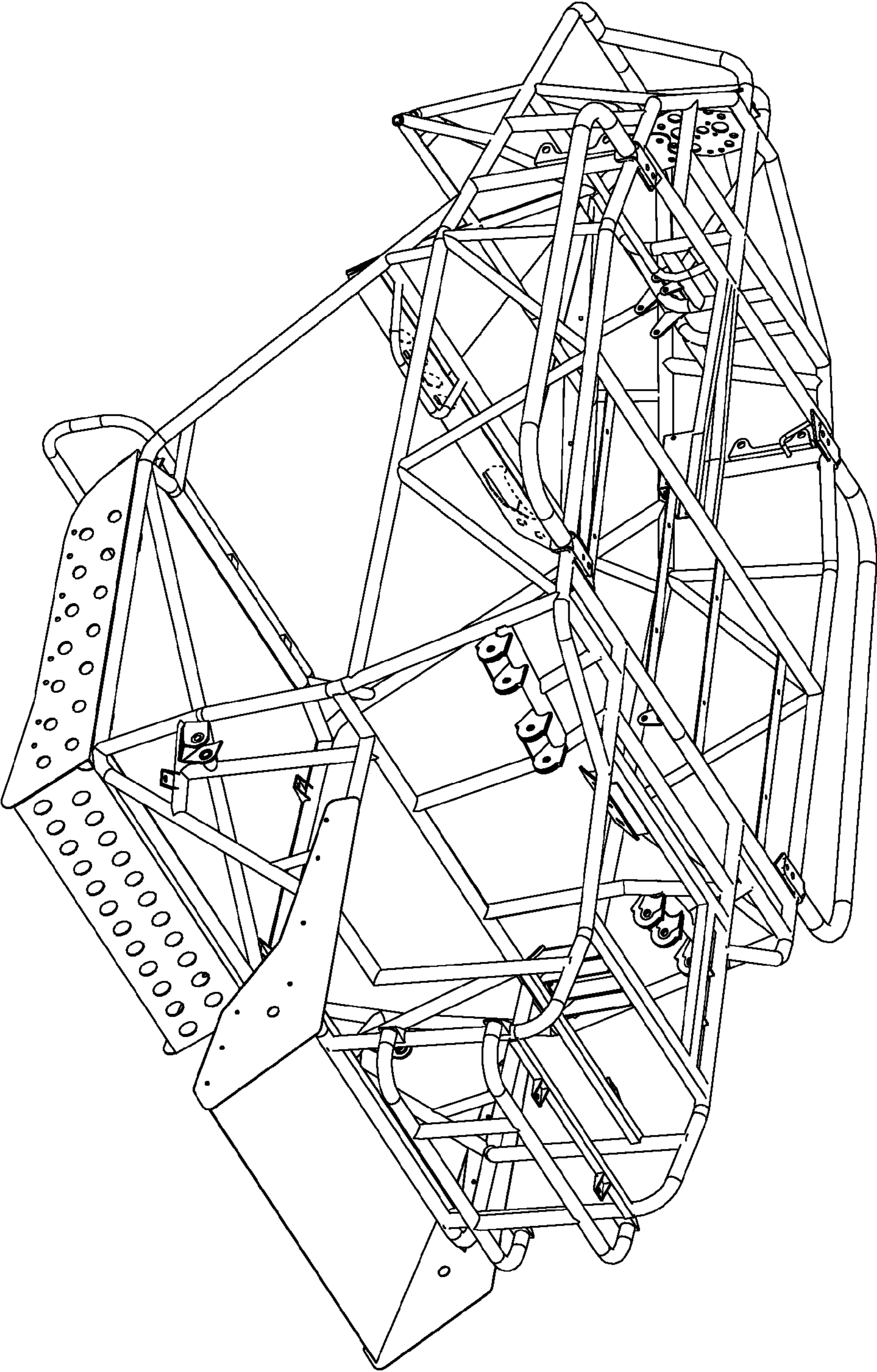
