(57) **CLAIM**

The ornamental design for a chrome cover for engine head of a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view, with the rear view being a mirror image, of a chrome cover for engine head of a motorcycle showing my new design;

FIG. 2 is a left side elevational view thereof;

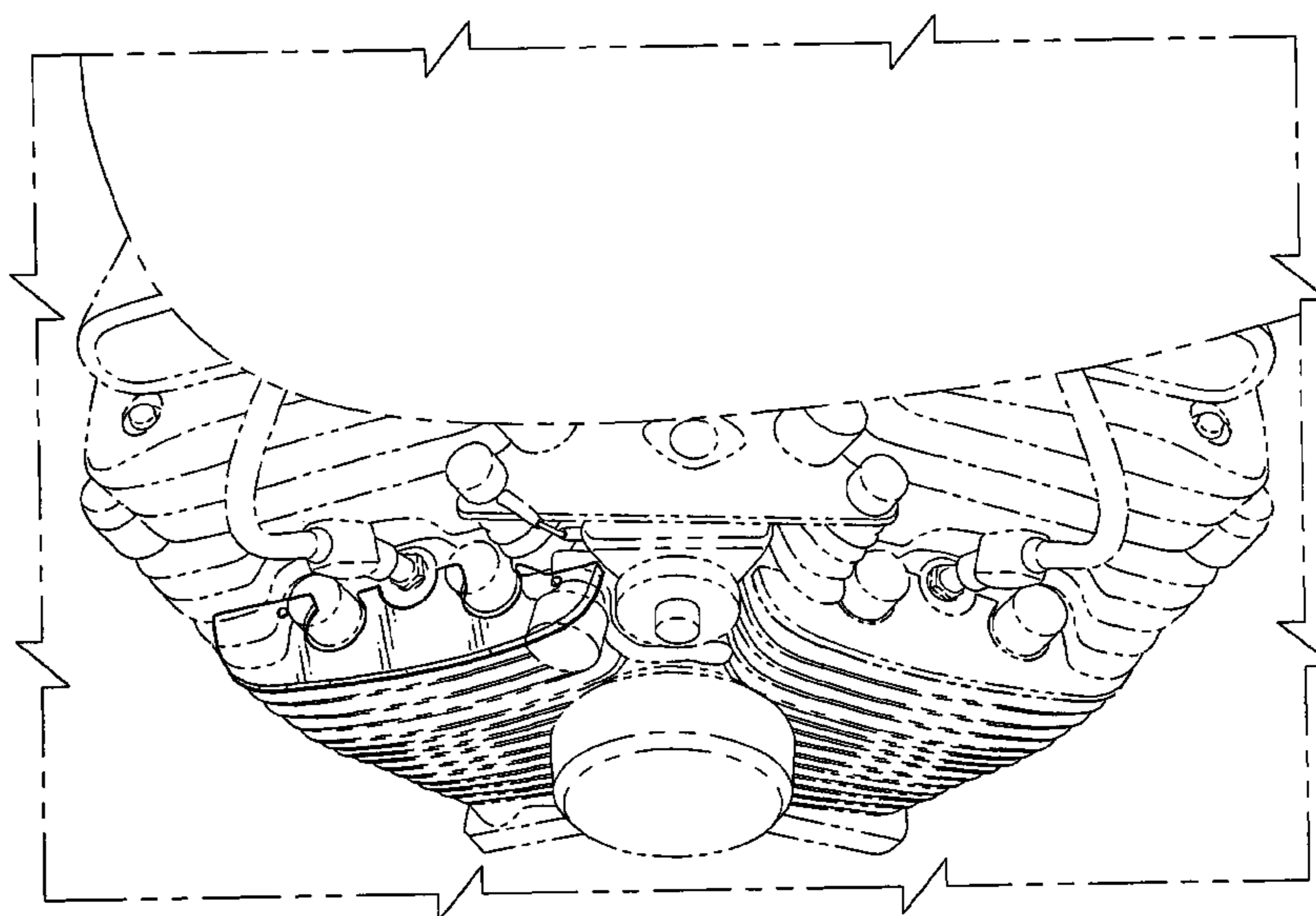
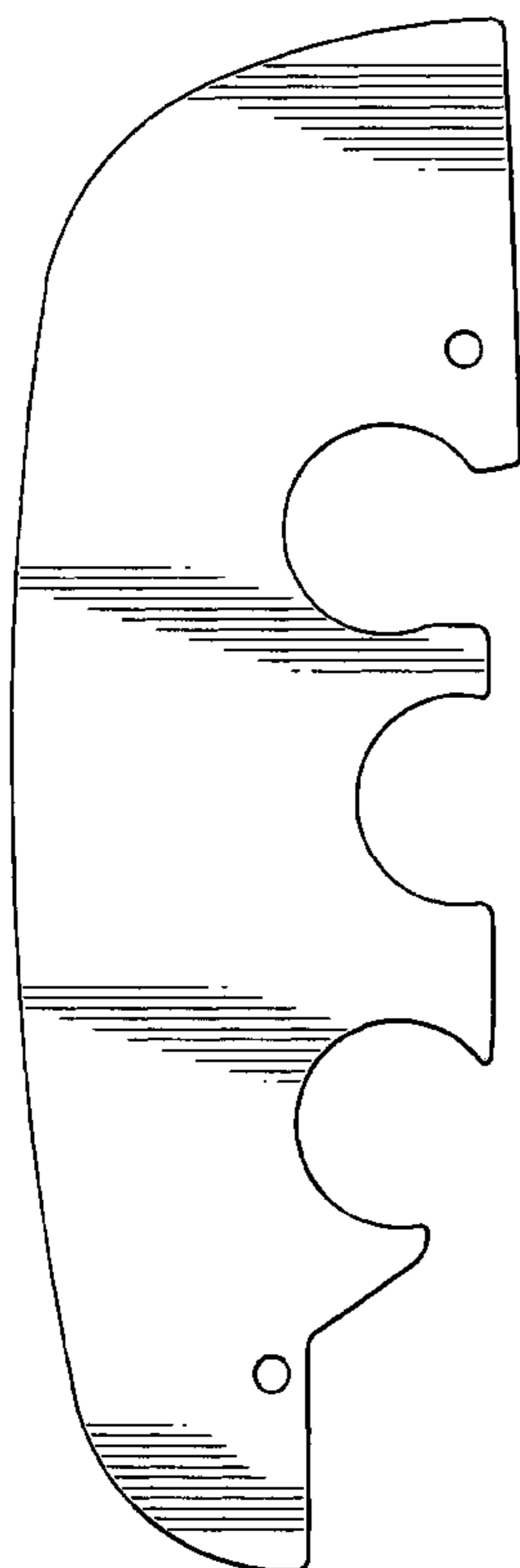
FIG. 3 is a right side elevational view thereof;

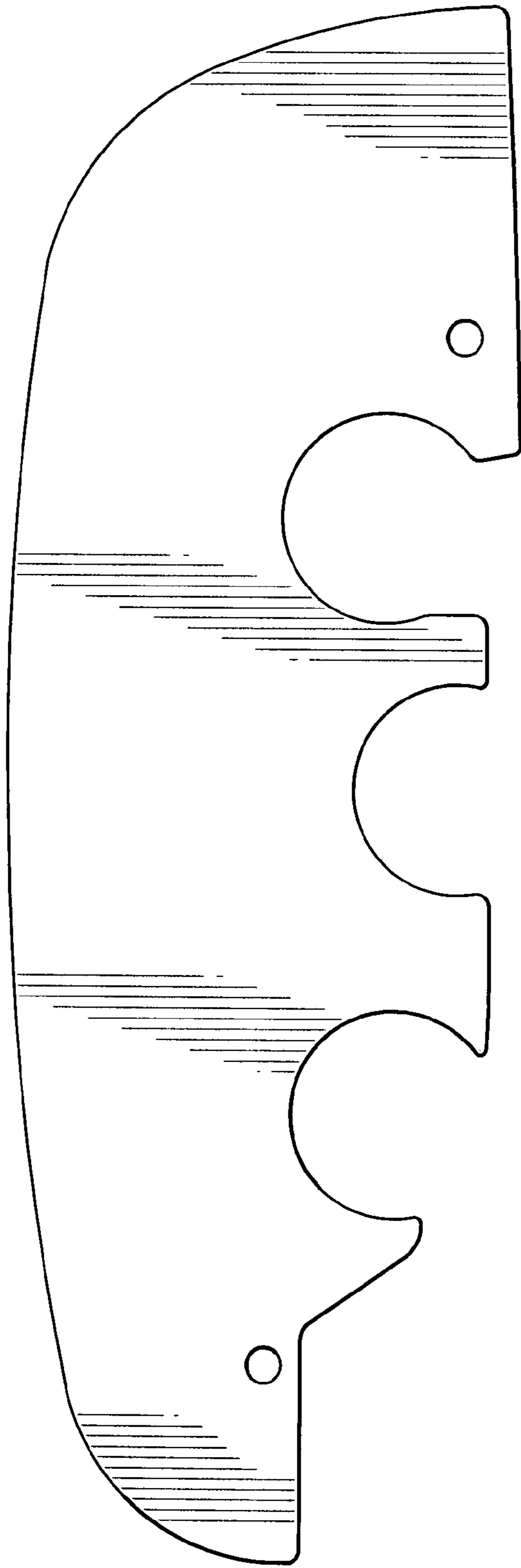

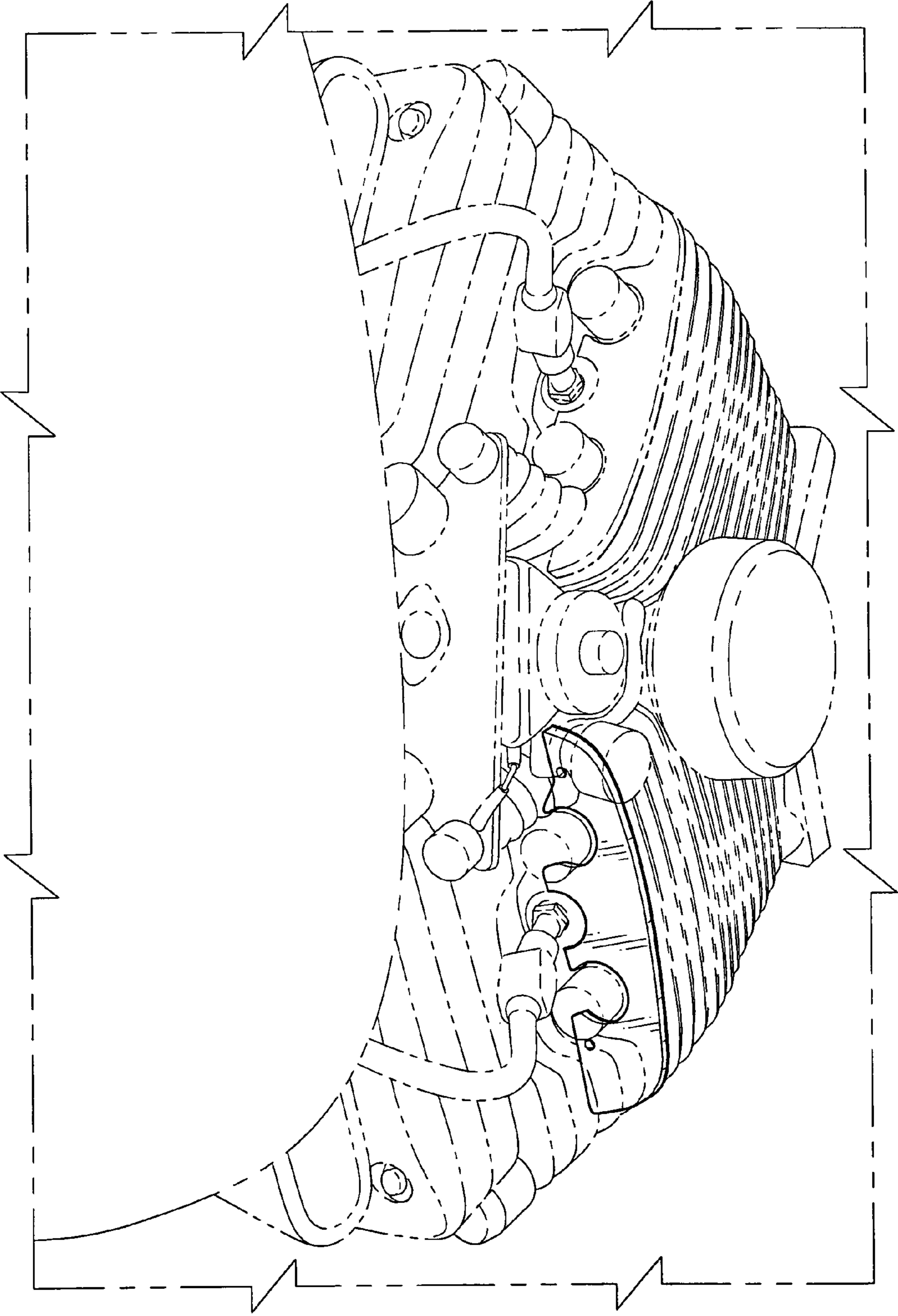
