The ornamental design for a set of key buttons for a handset, as shown and described.

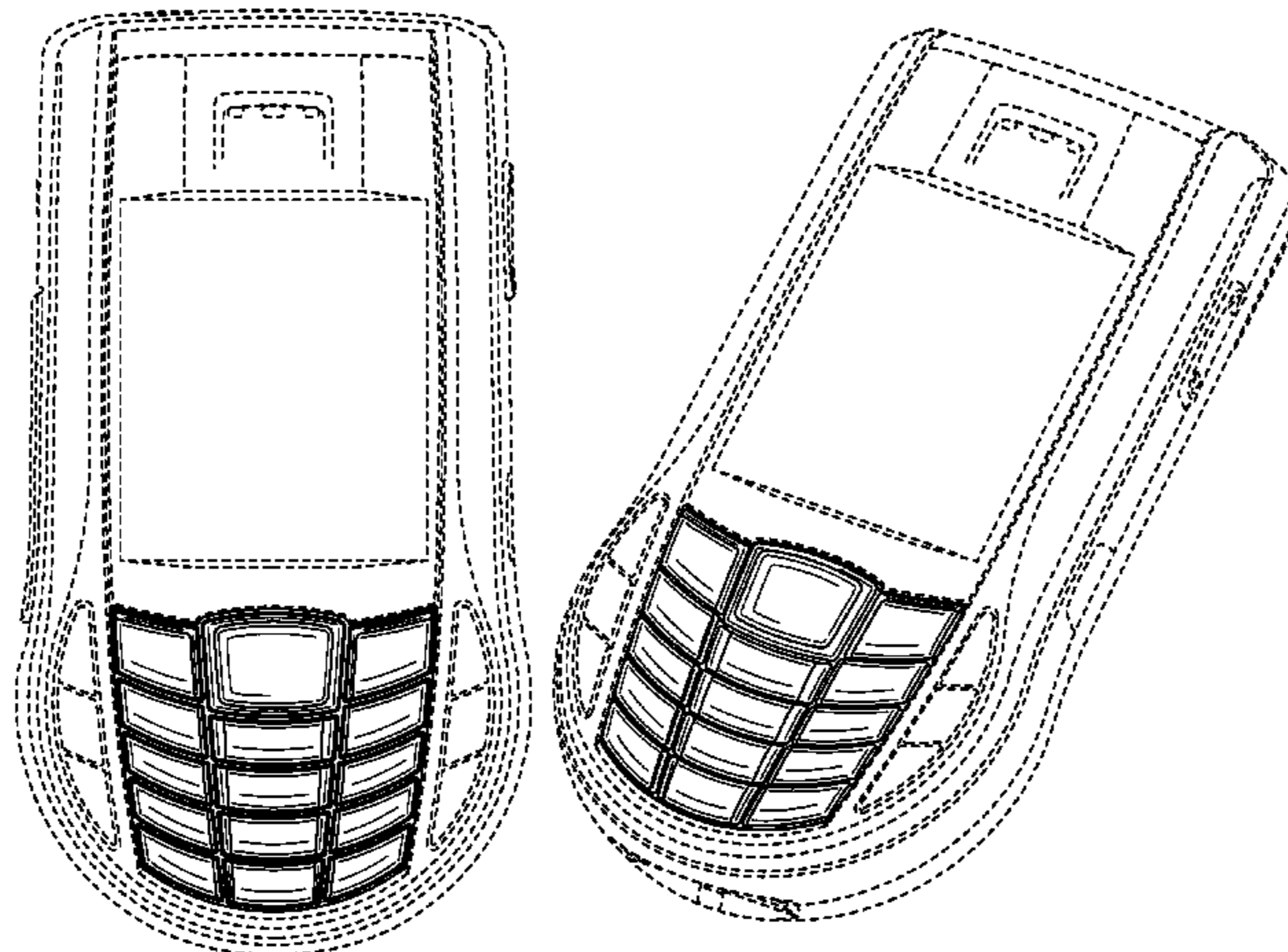
**DESCRIPTION**

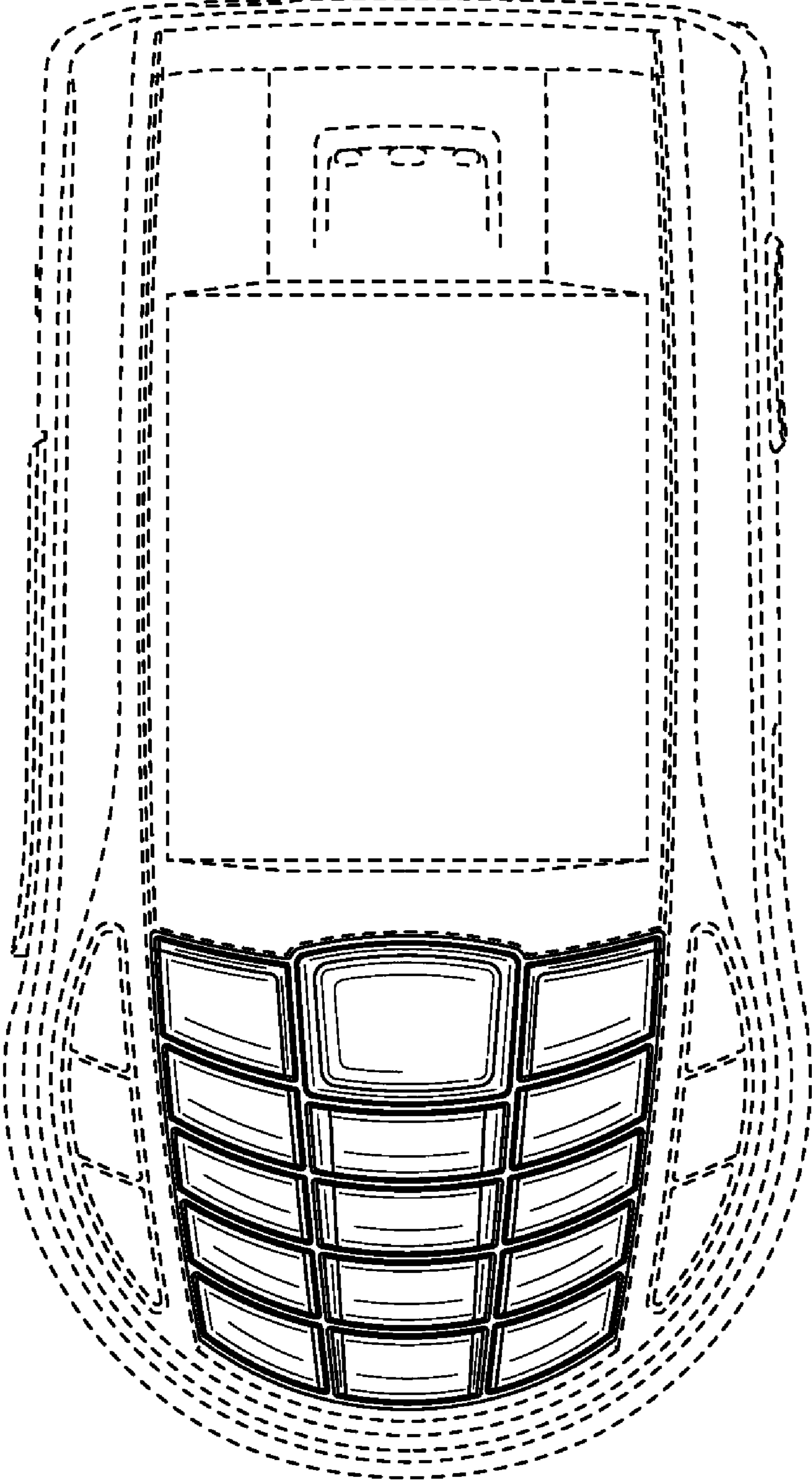

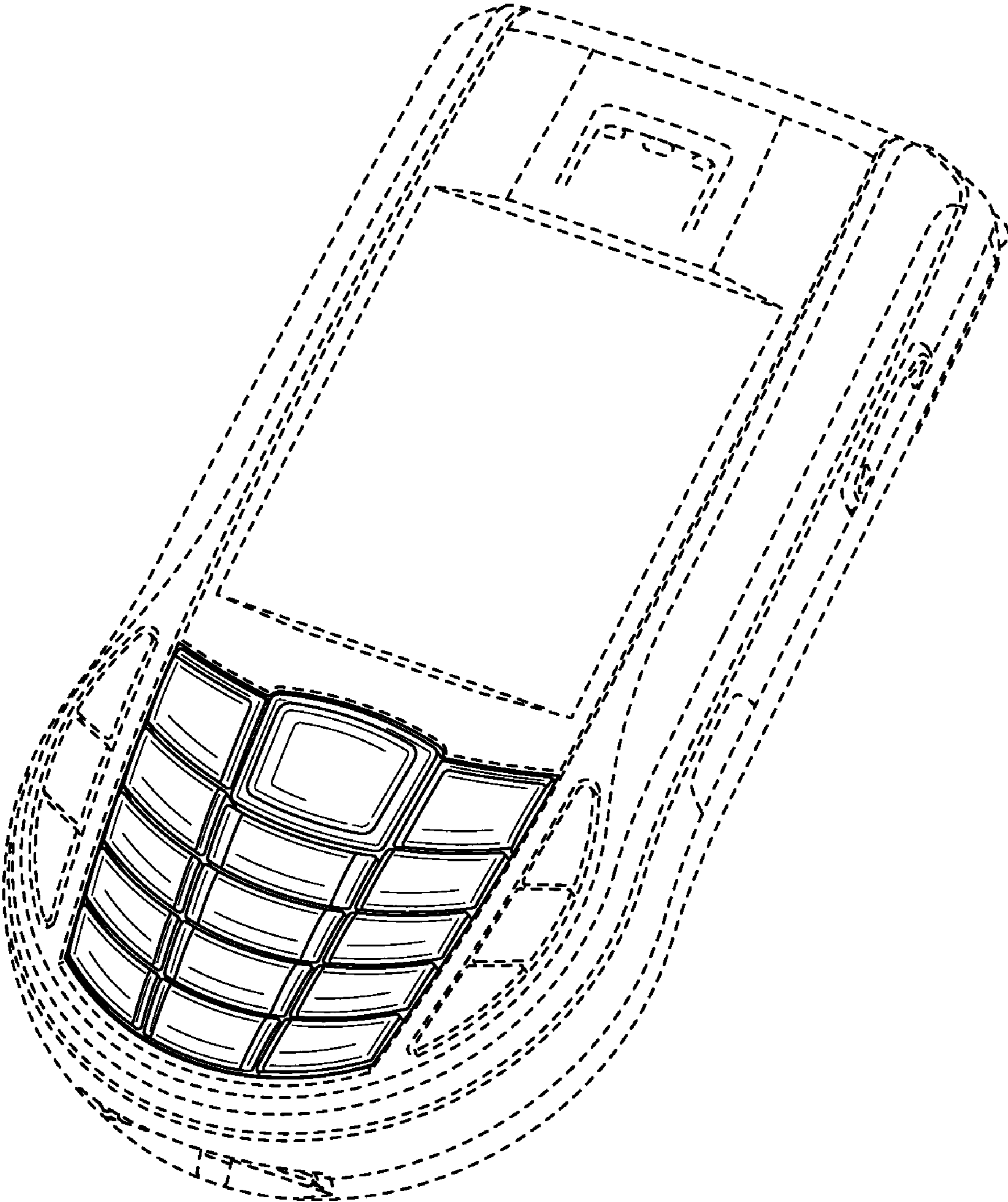
