**DESCRIPTION**

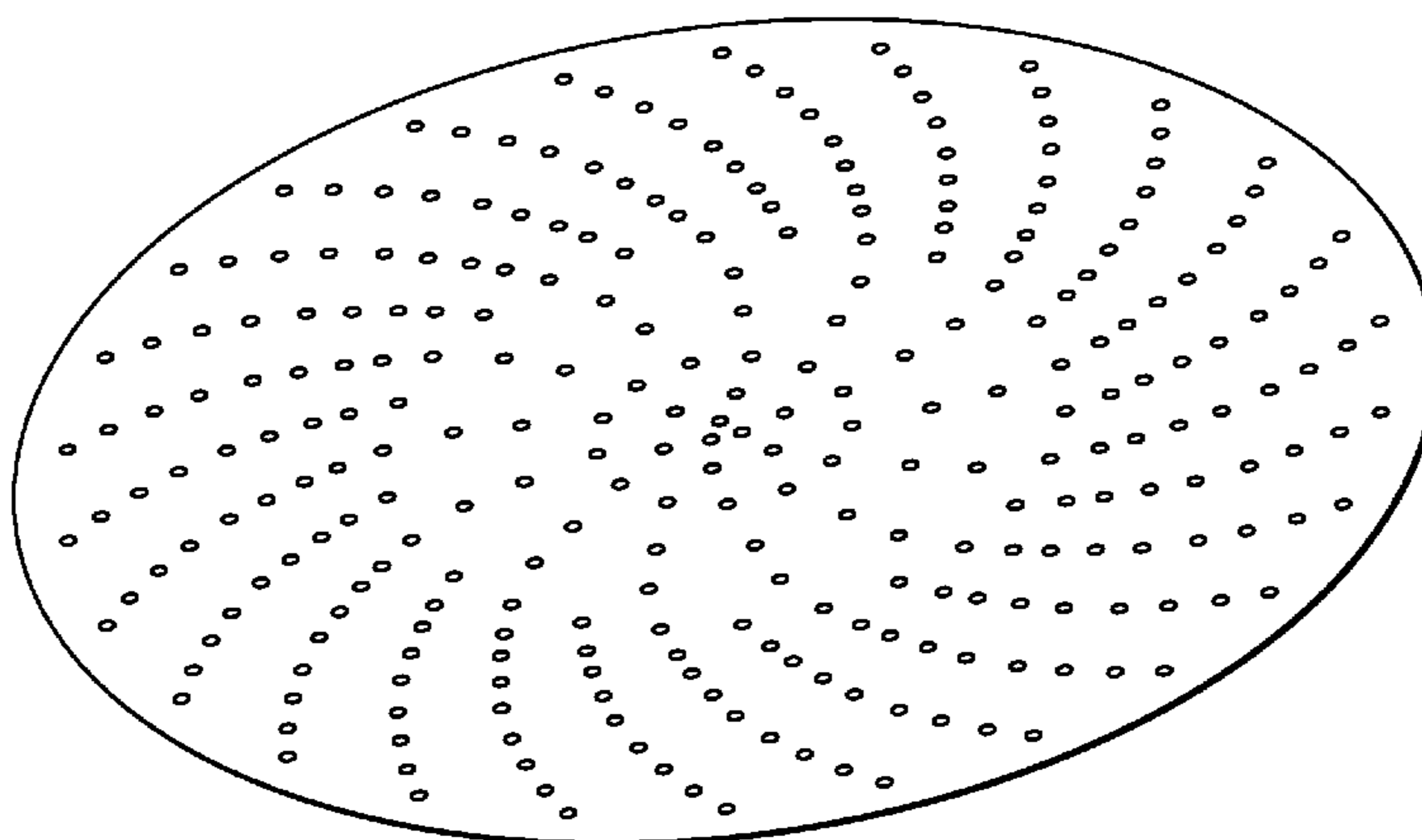
FIG. 1 is a perspective view of an abrasive disk showing the new design for a random hole abrasive disc;

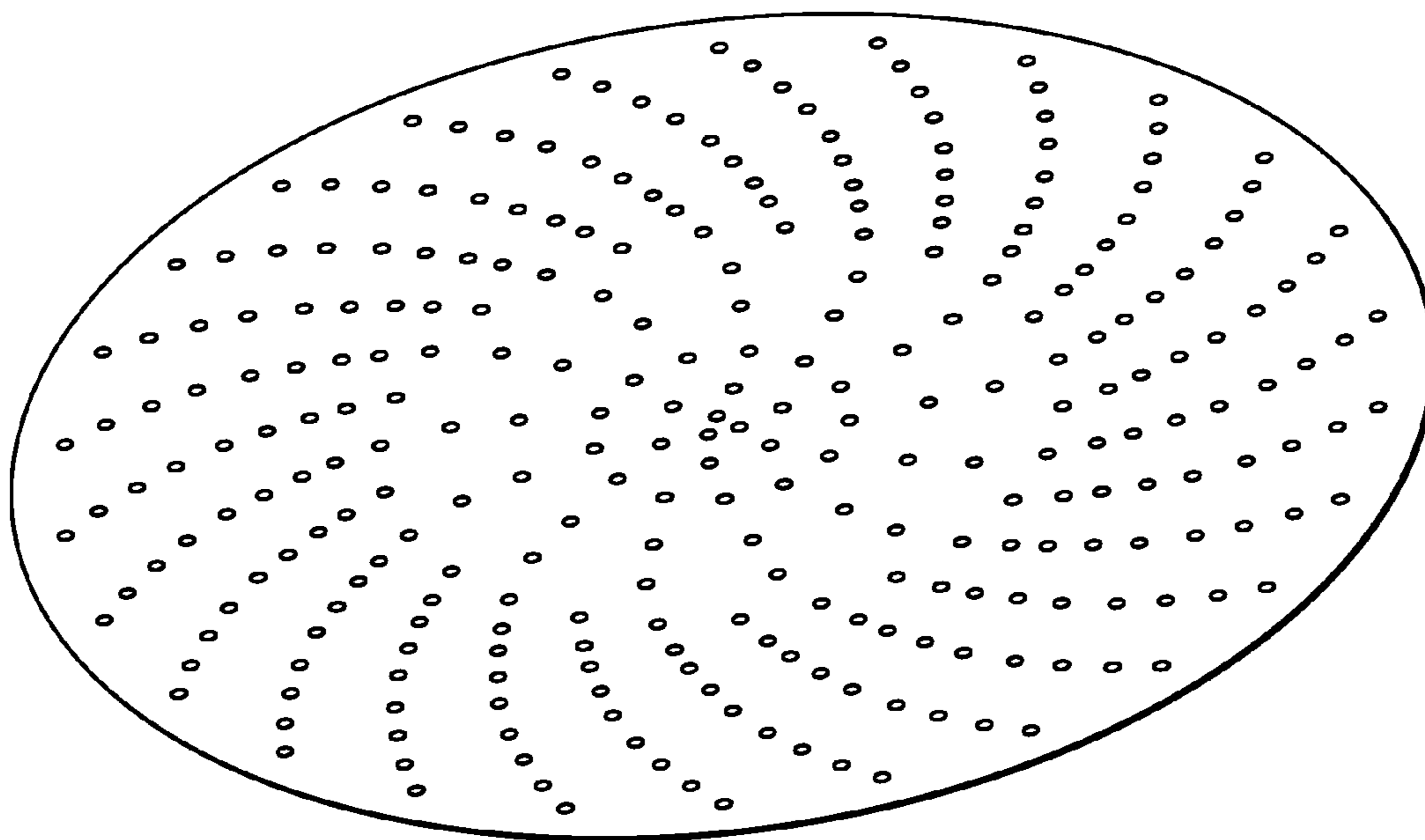

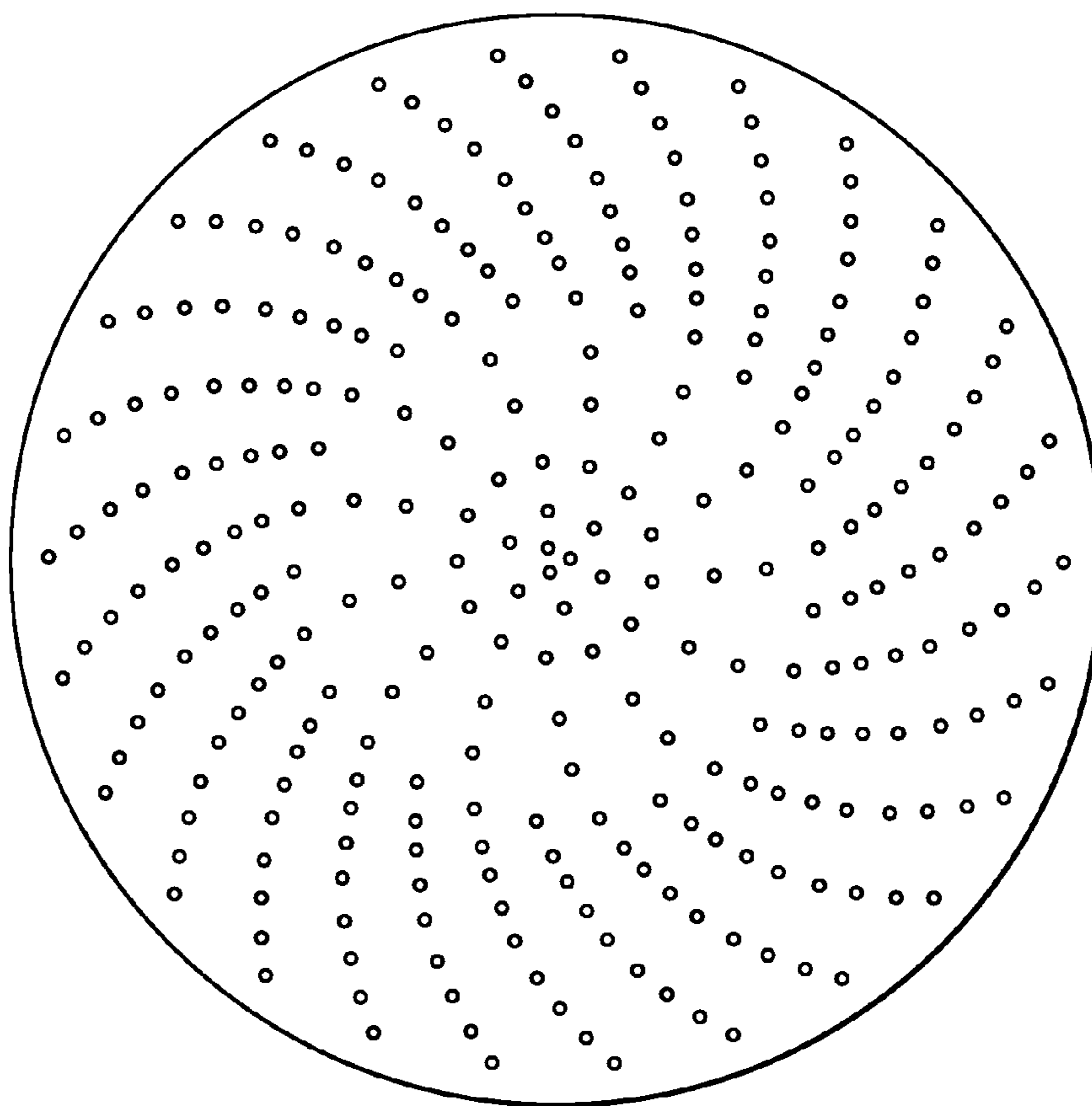

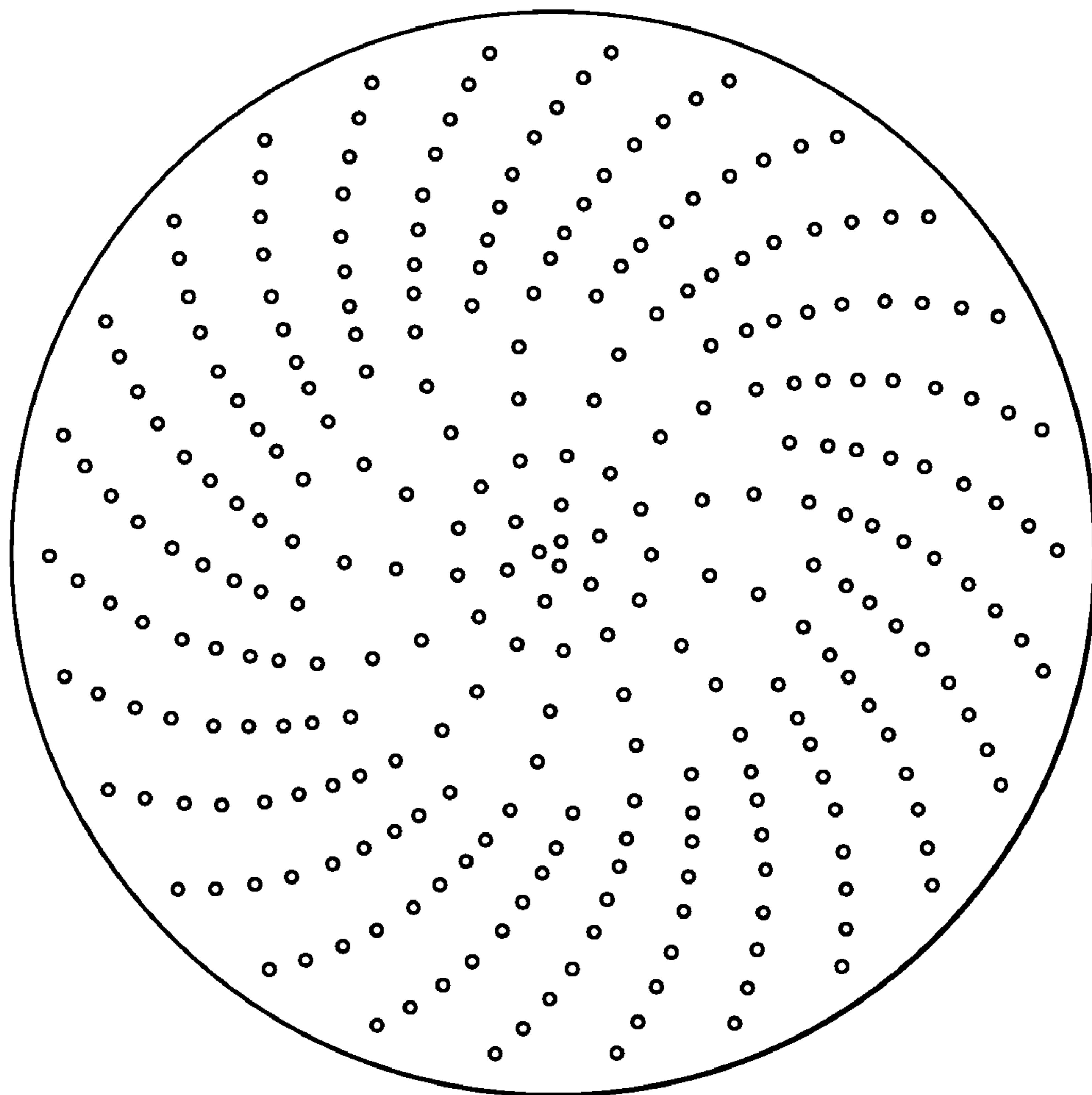
