The ornamental design for a pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pen showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof; the left side elevational view is a mirror image of the right side;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

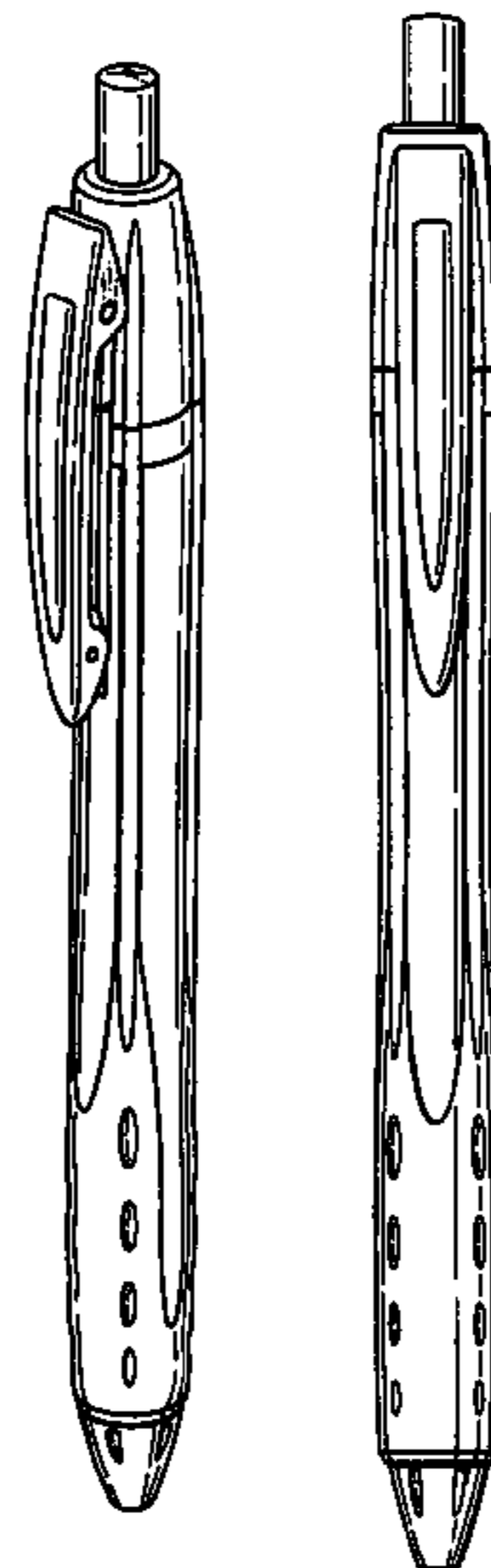

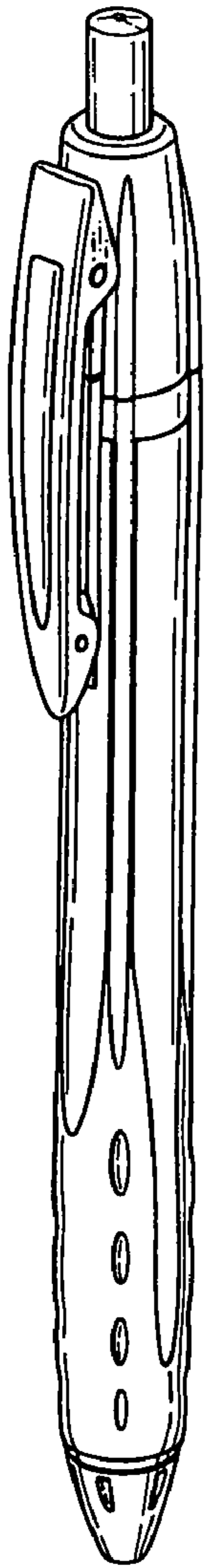

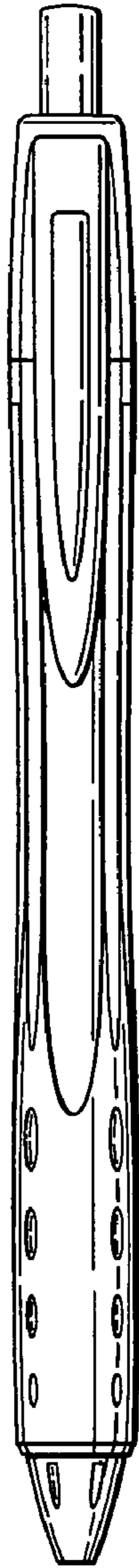

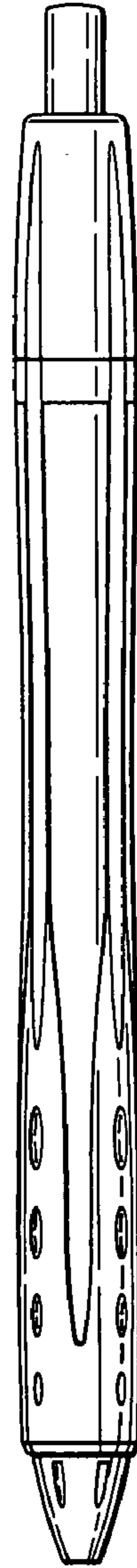
