The ornamental design for a pen clip, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a pen clip showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side view thereof, the left side view being a mirror image of the right side;

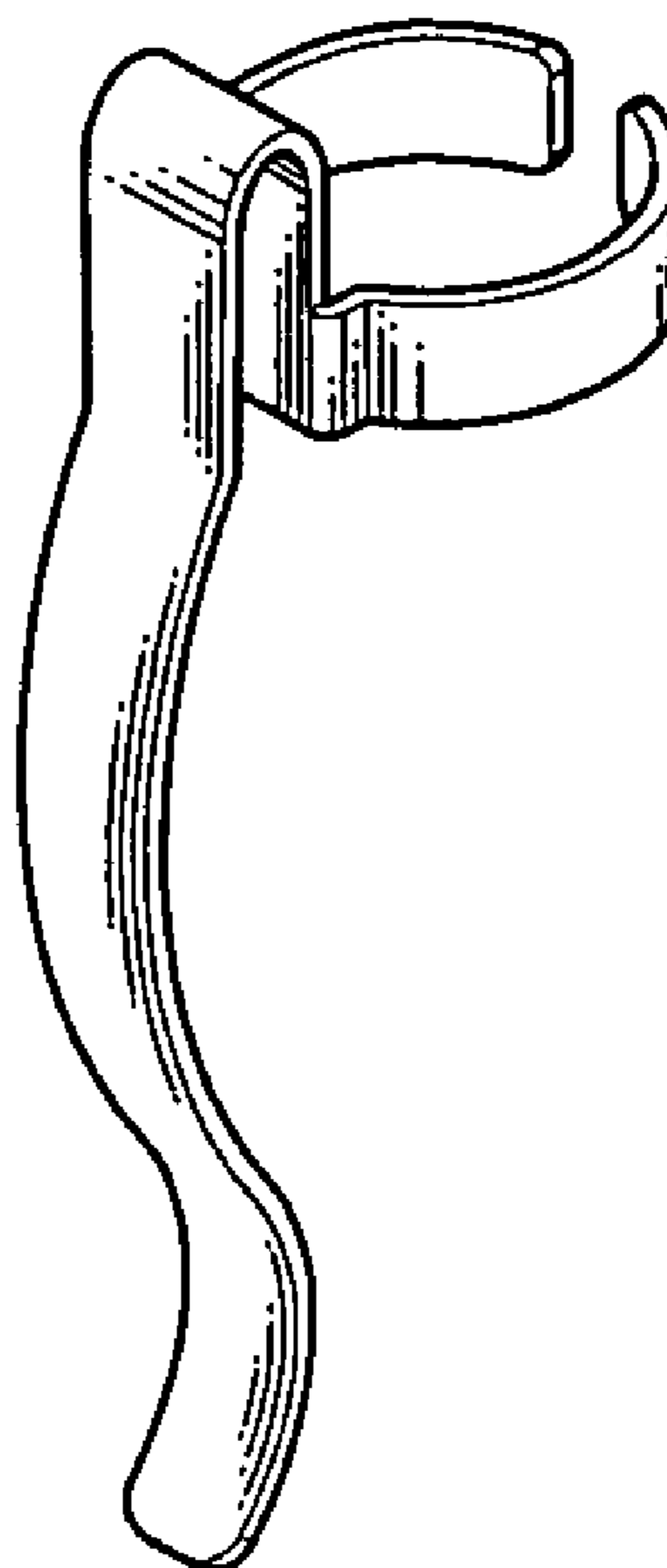
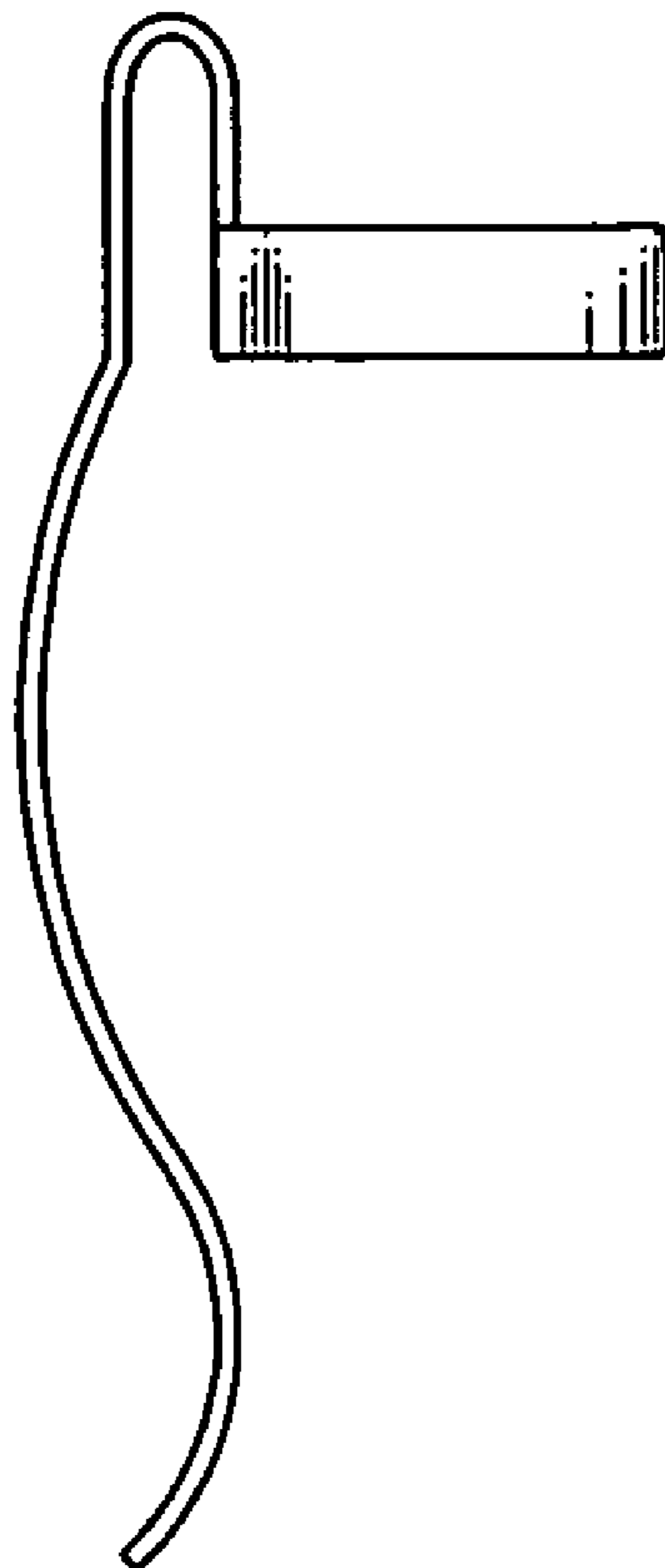
FIG. 5 is a rear view thereof;

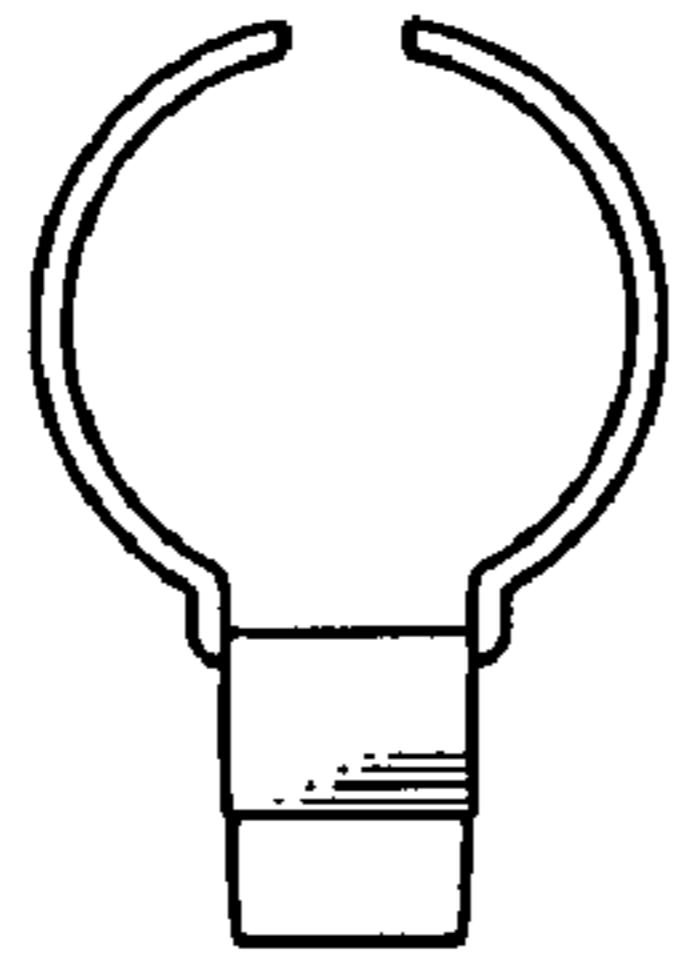

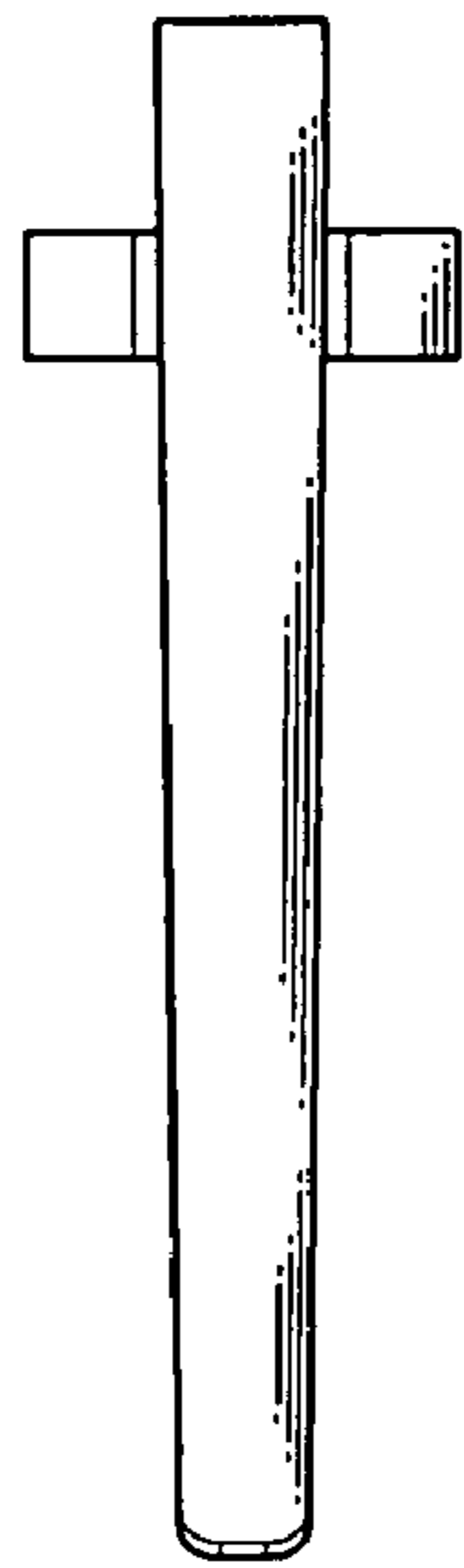

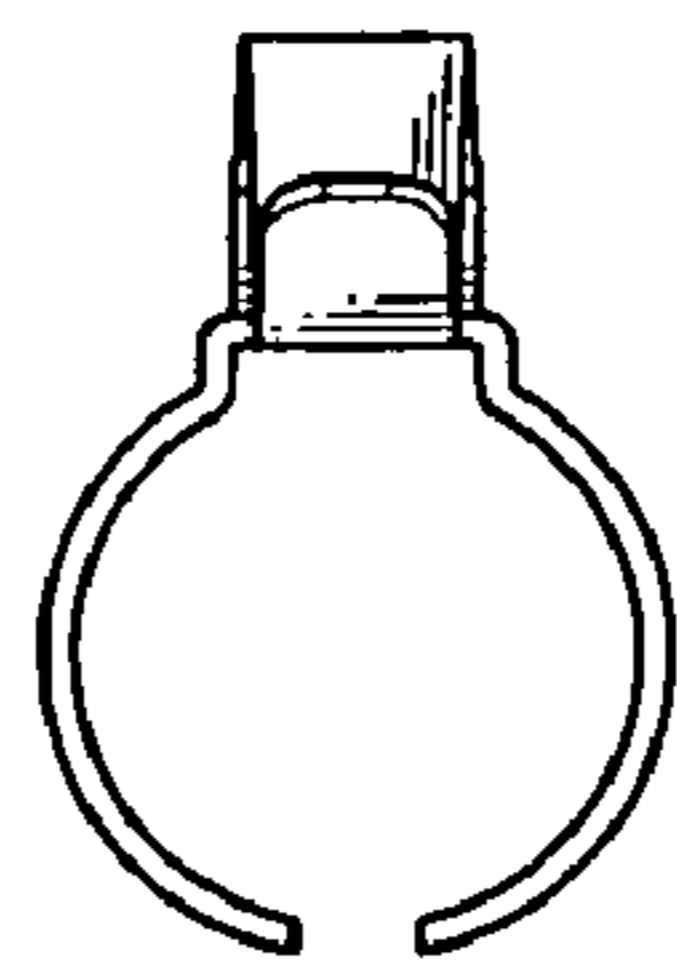

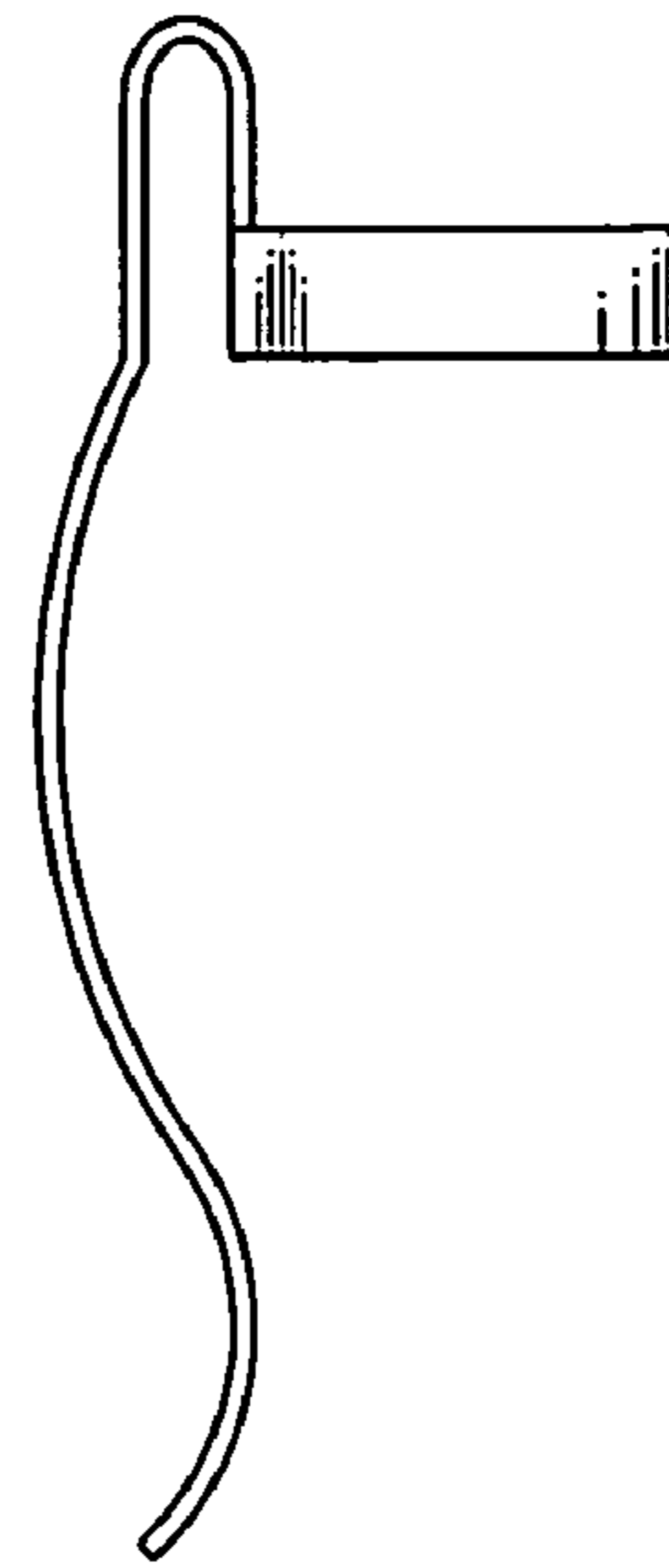

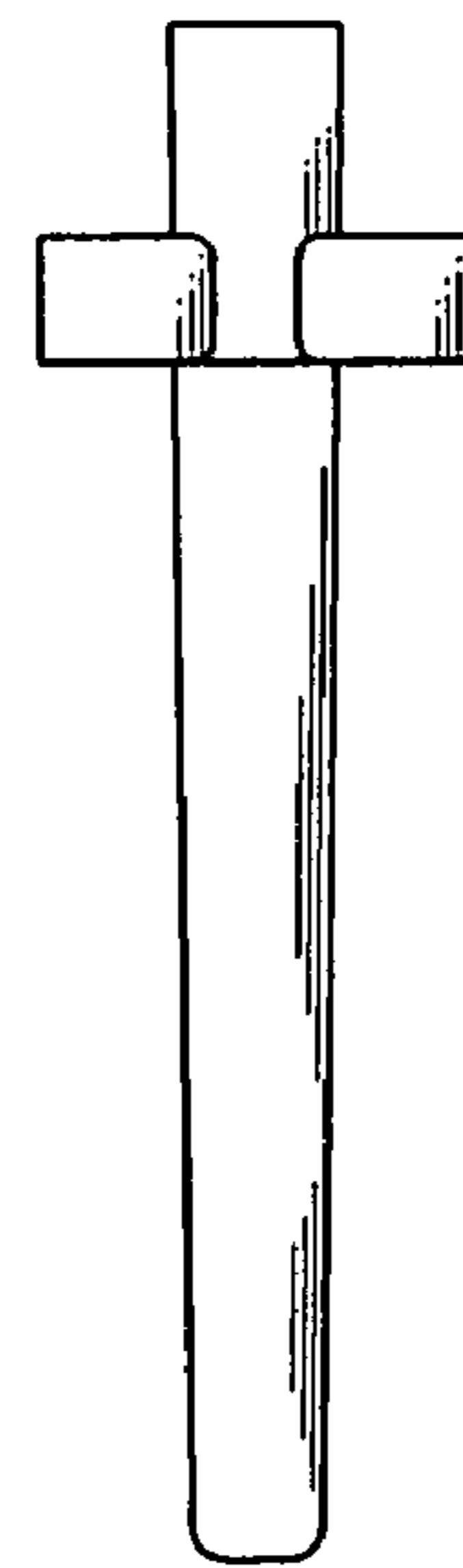

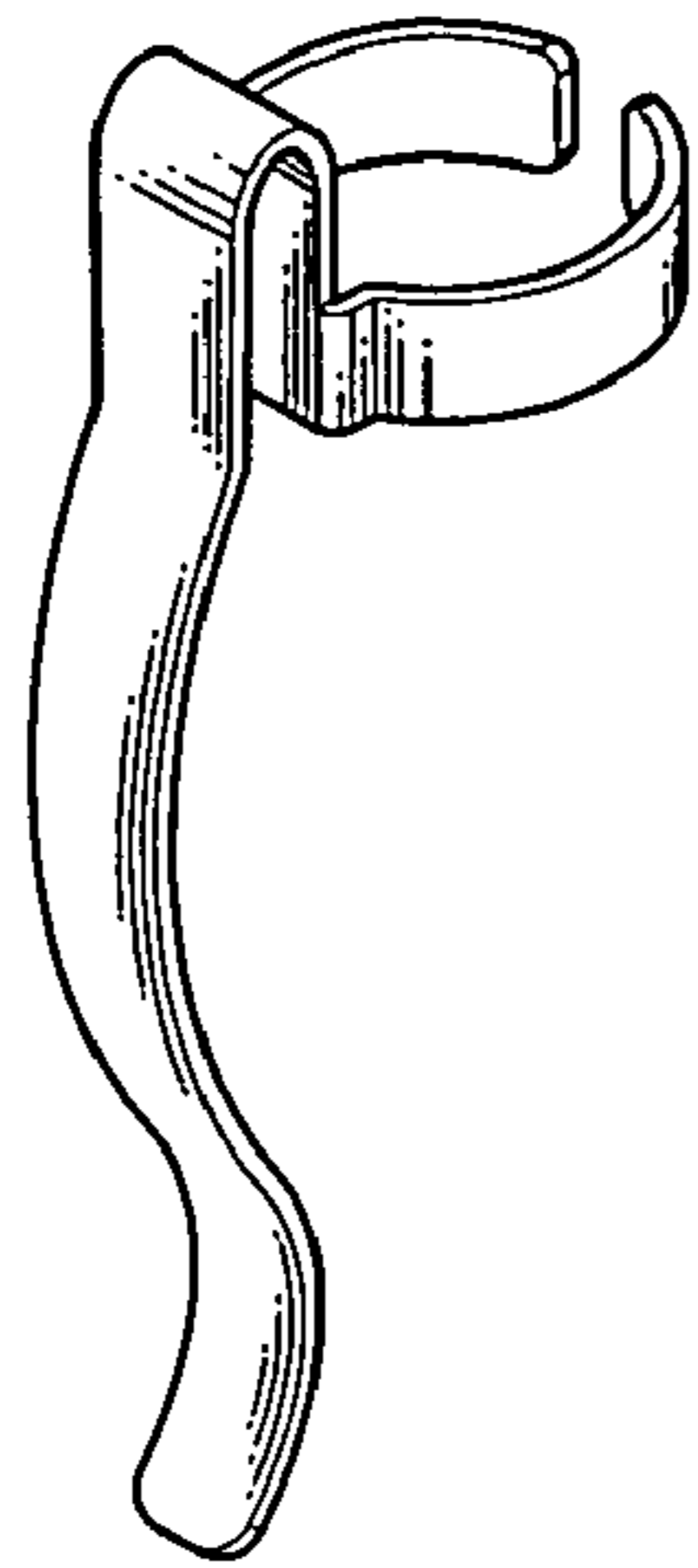

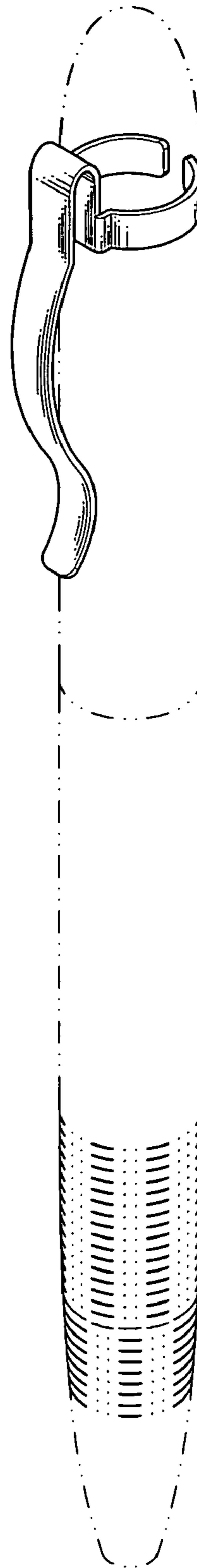
