FIG. 3 is a back view;

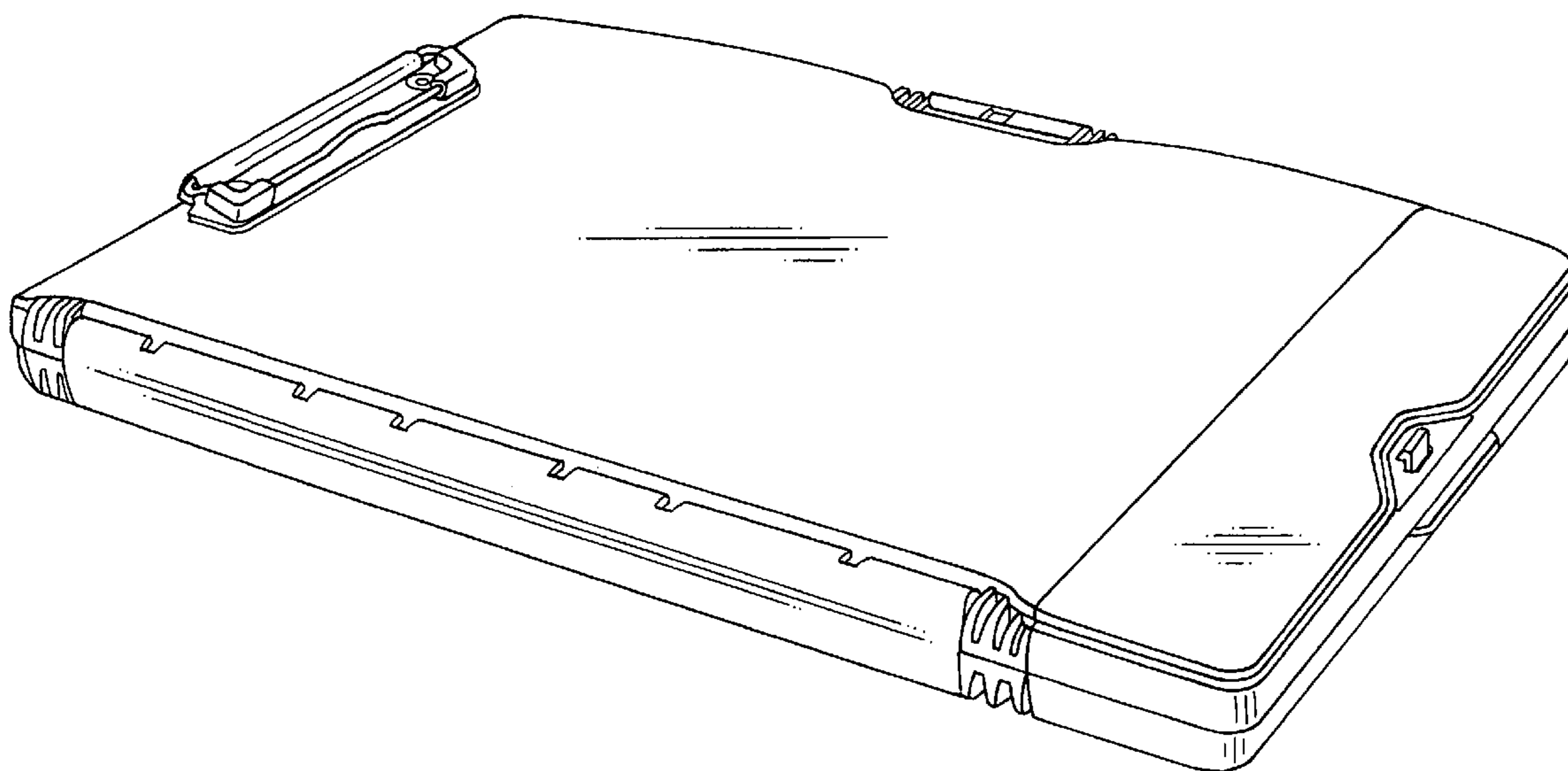
FIG. 4 is a side view;

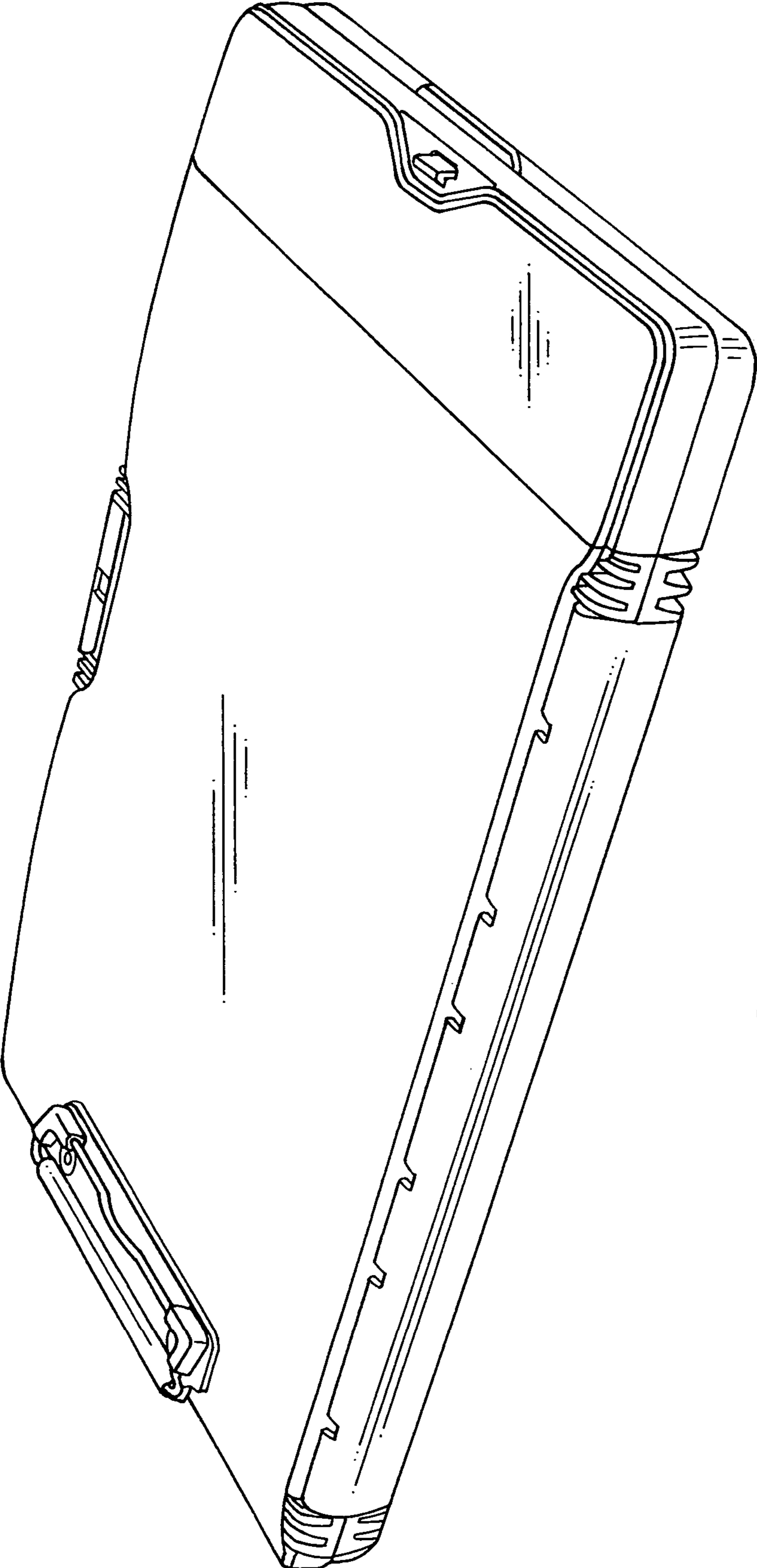

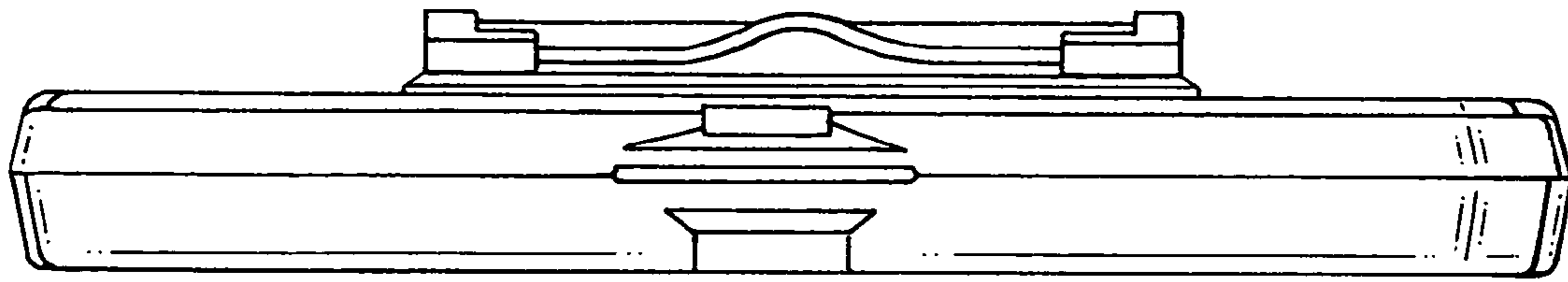

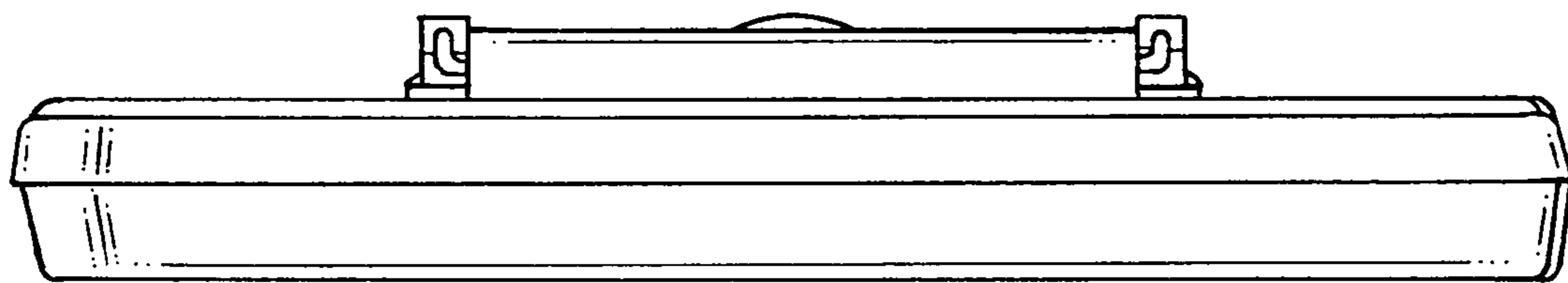

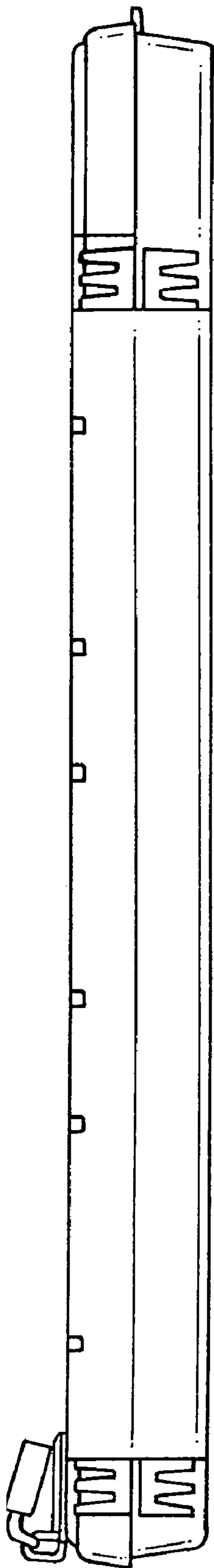

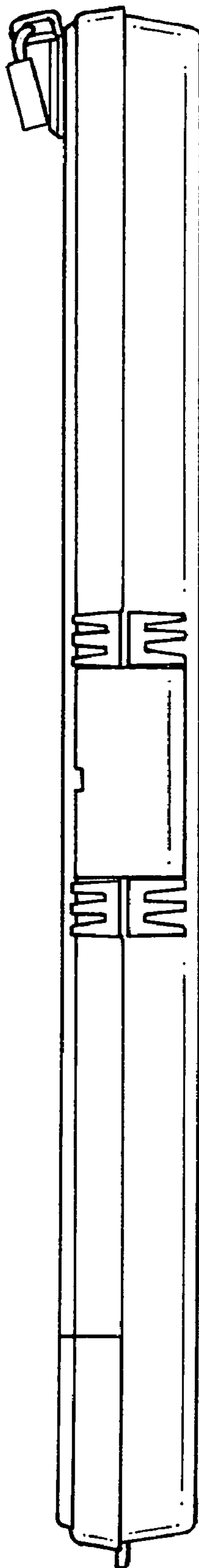

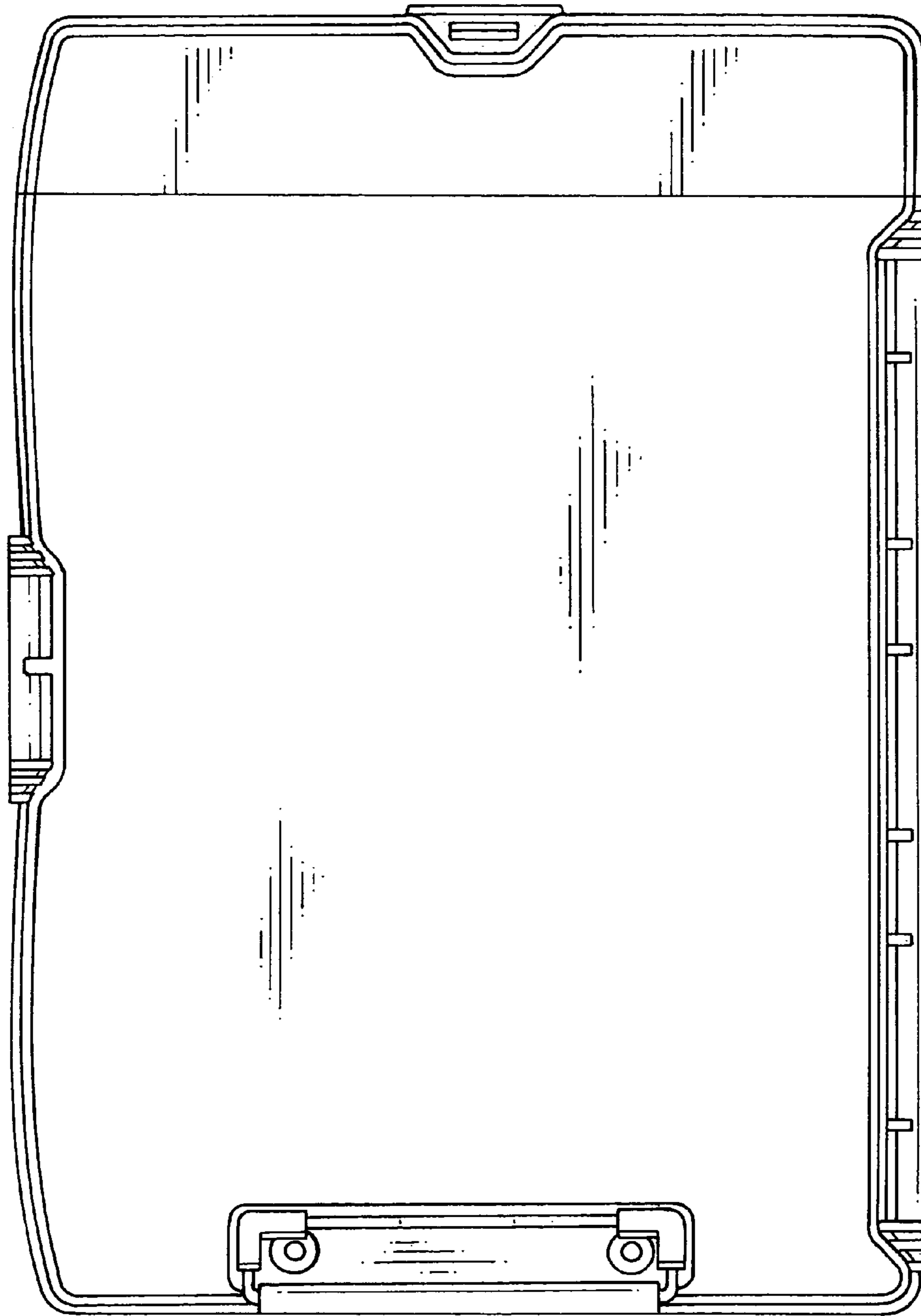

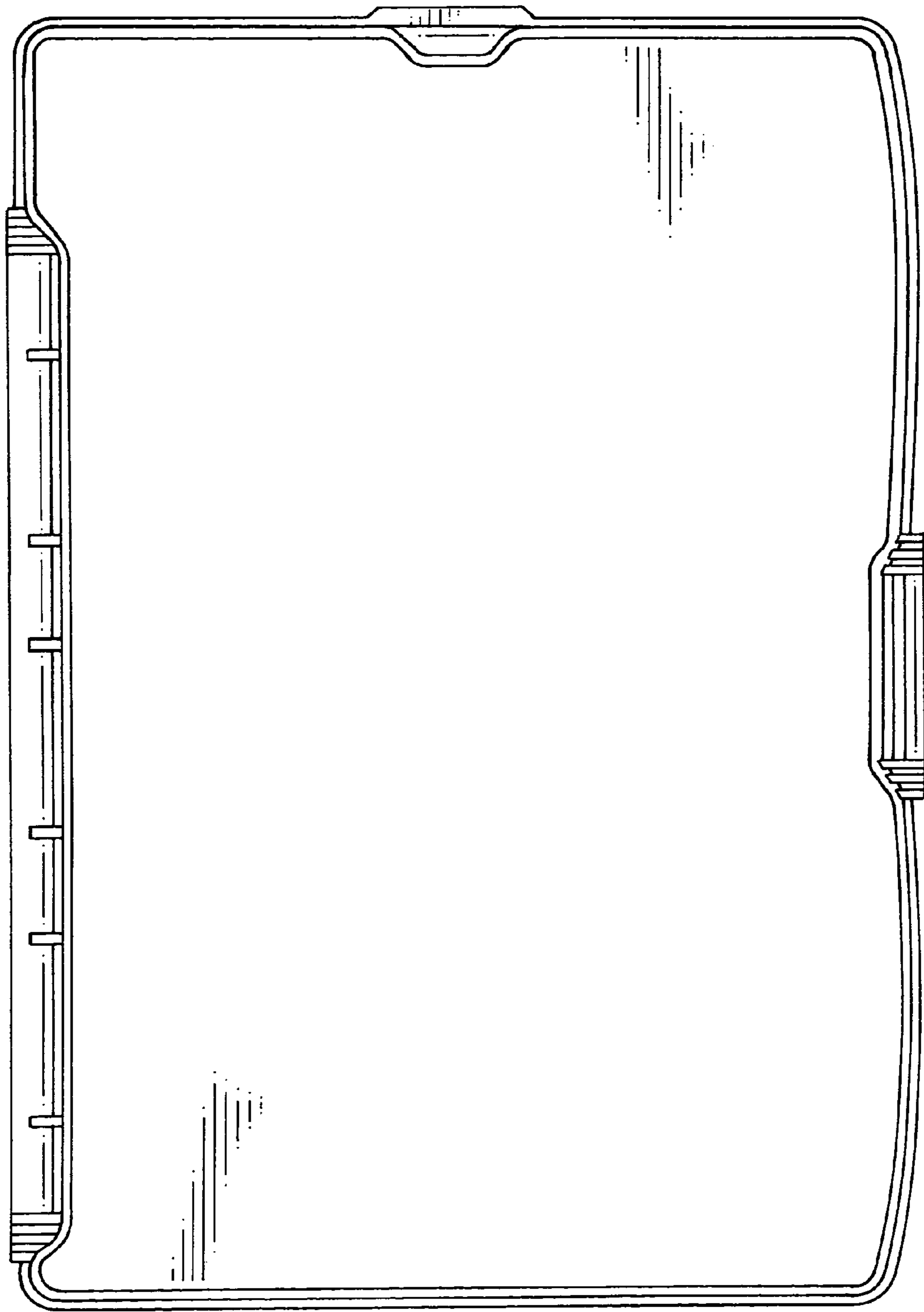
