FIG. 4 is a top plan view according to the invention;

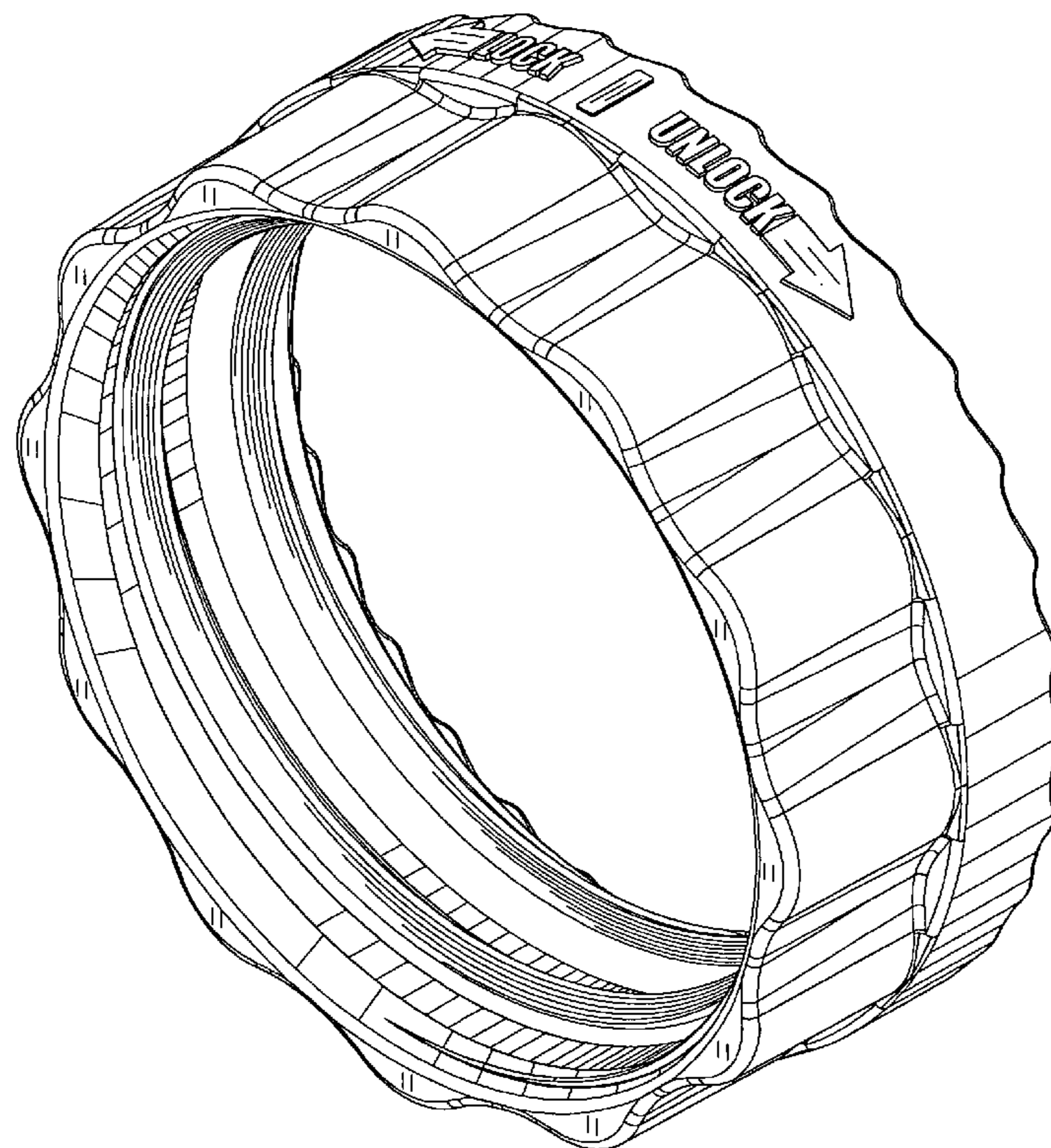
FIG. 5 is a bottom plan view according to the invention;

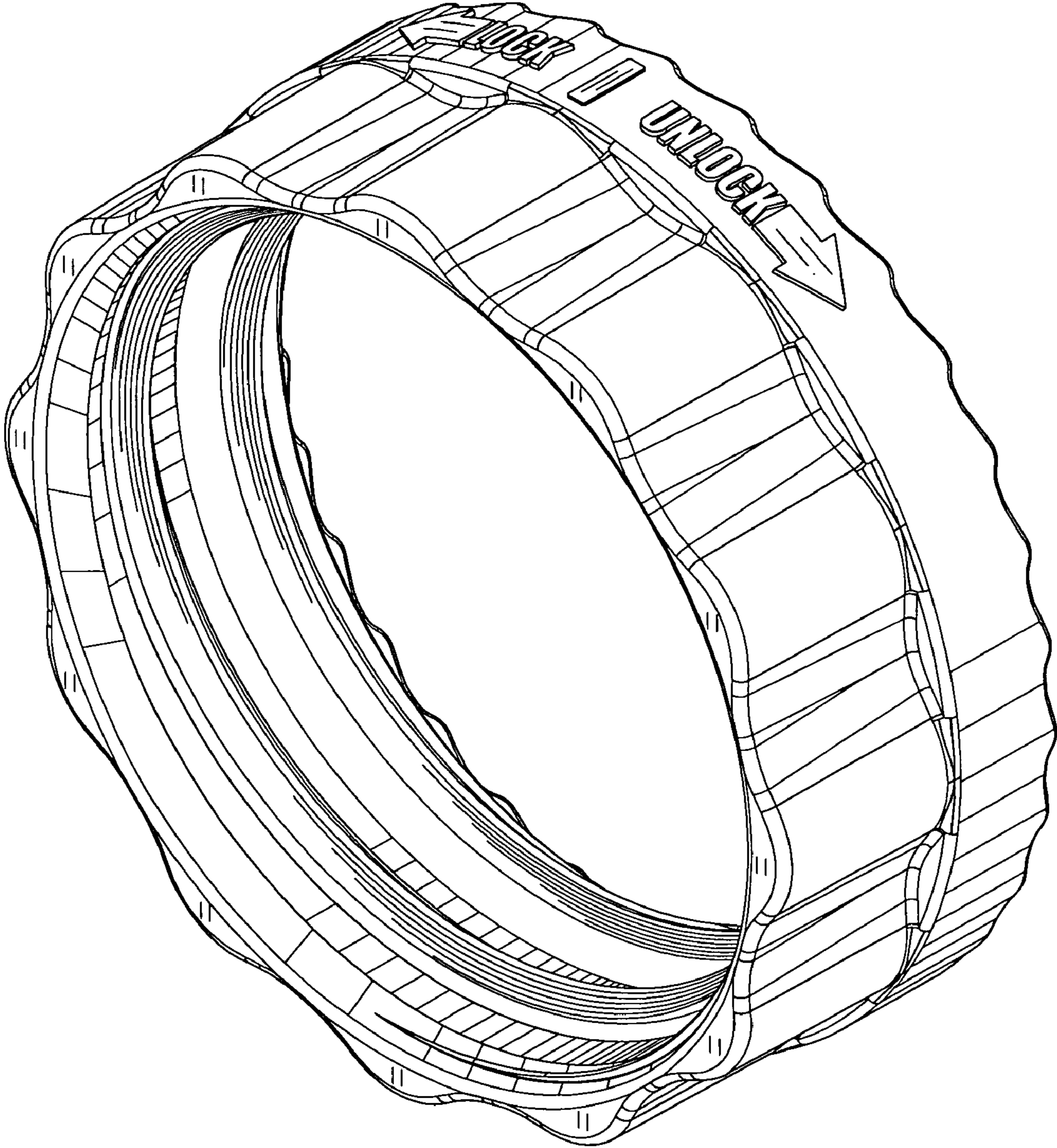

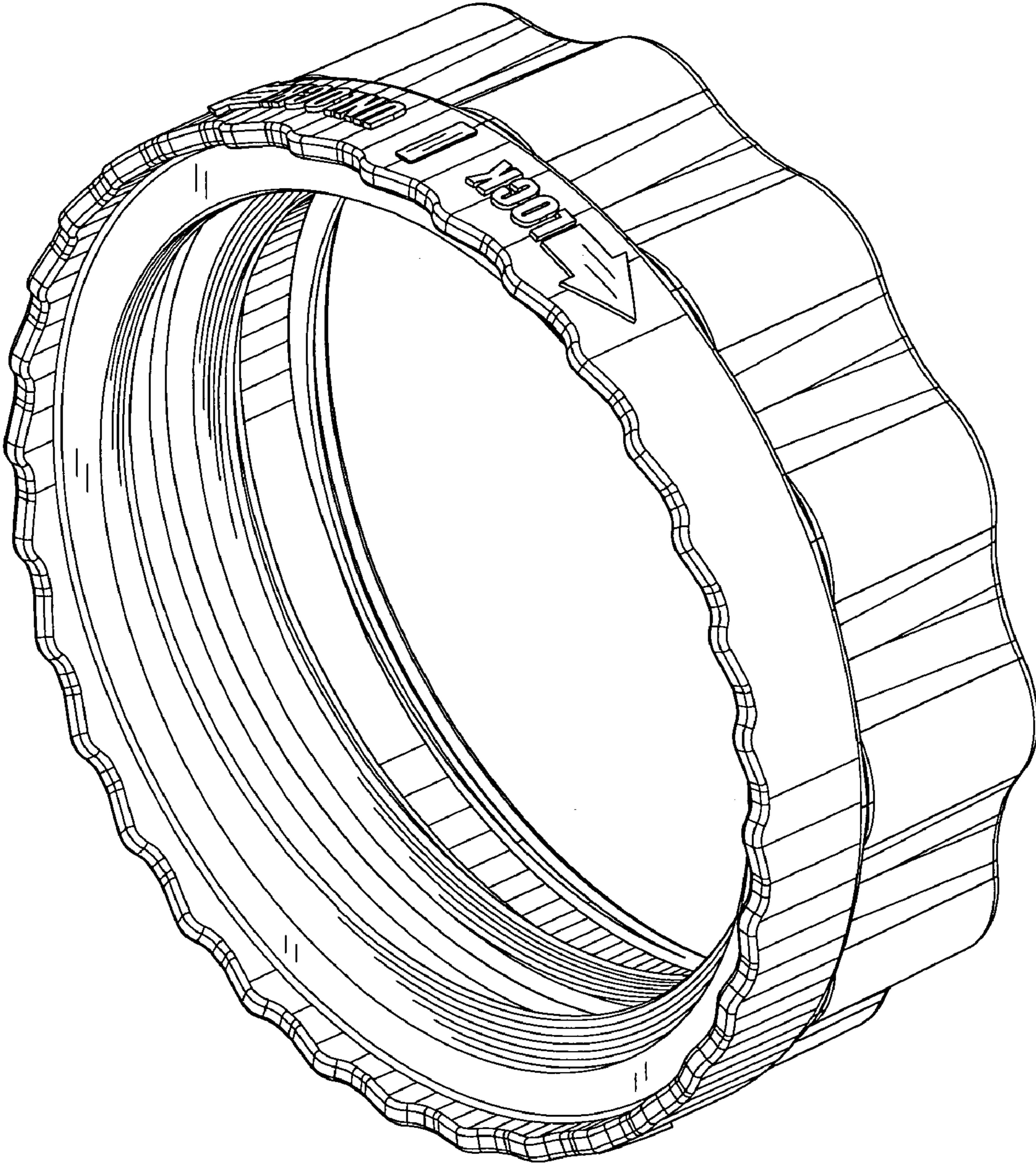

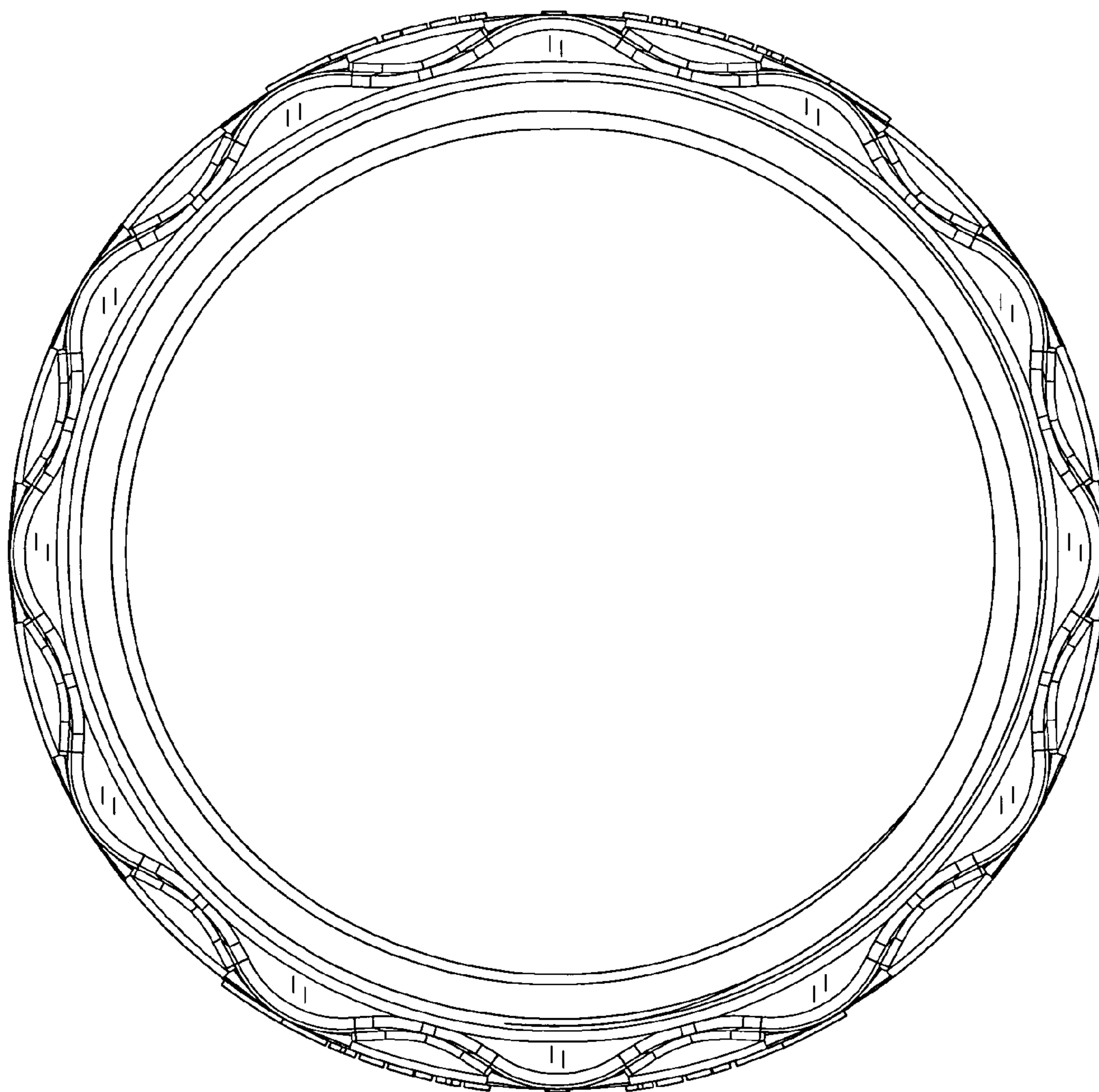

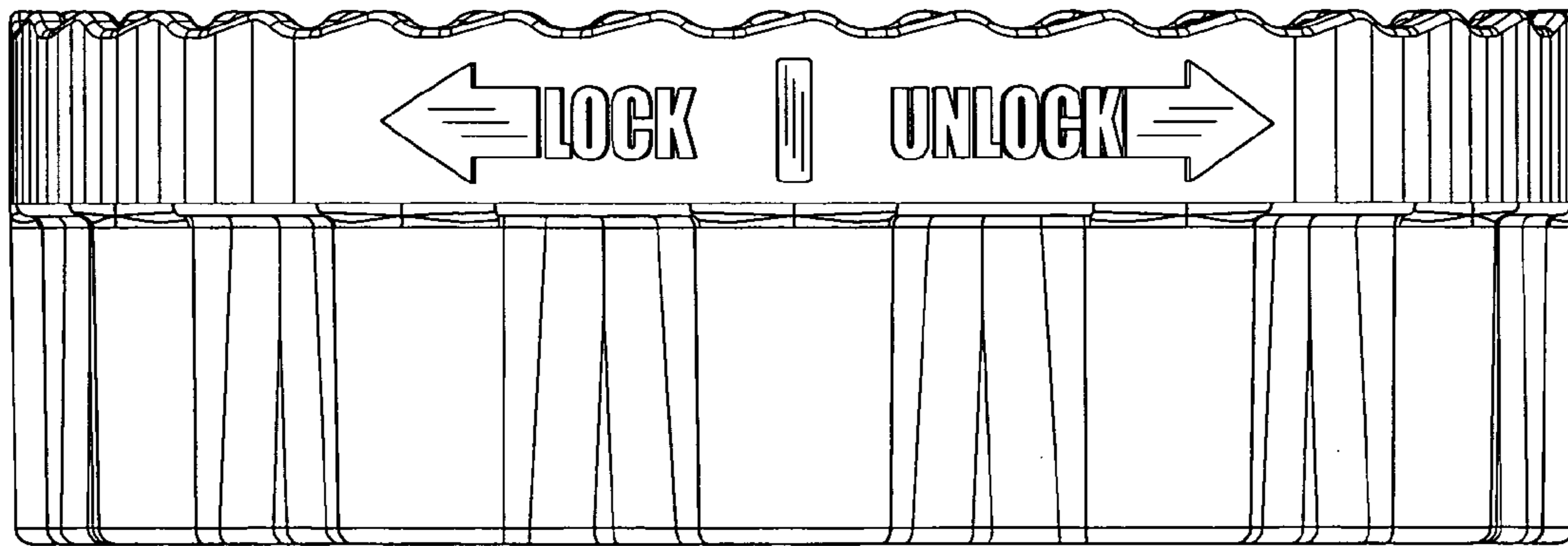

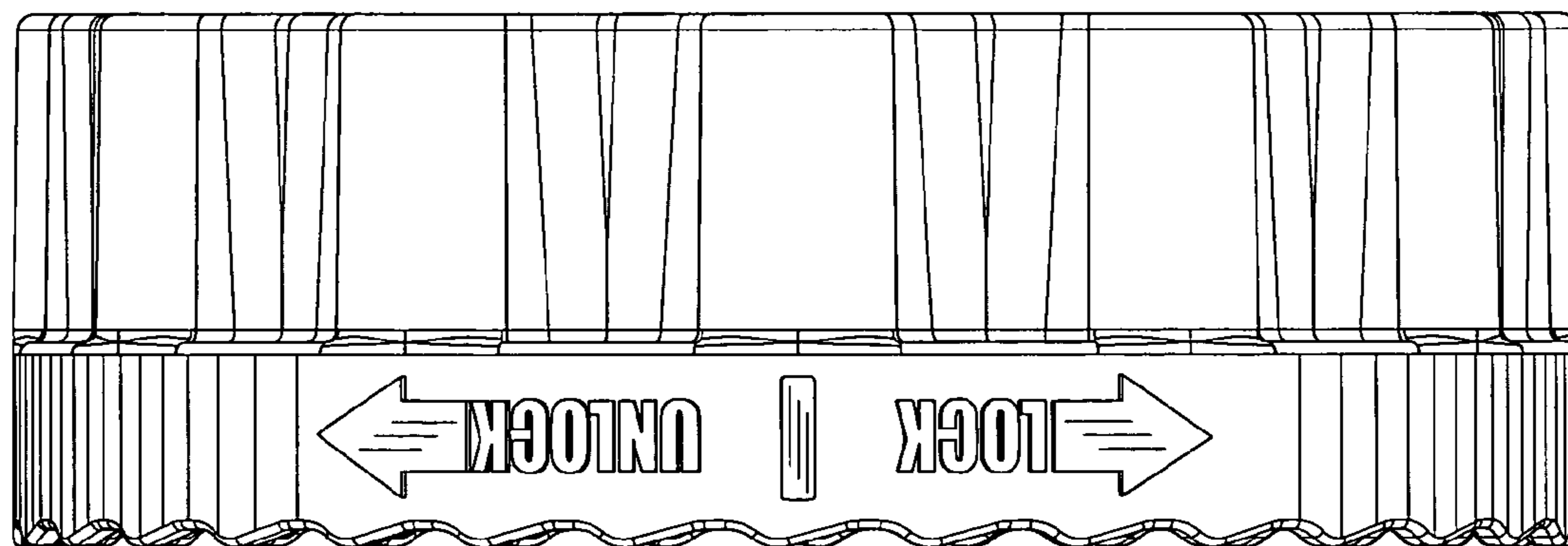

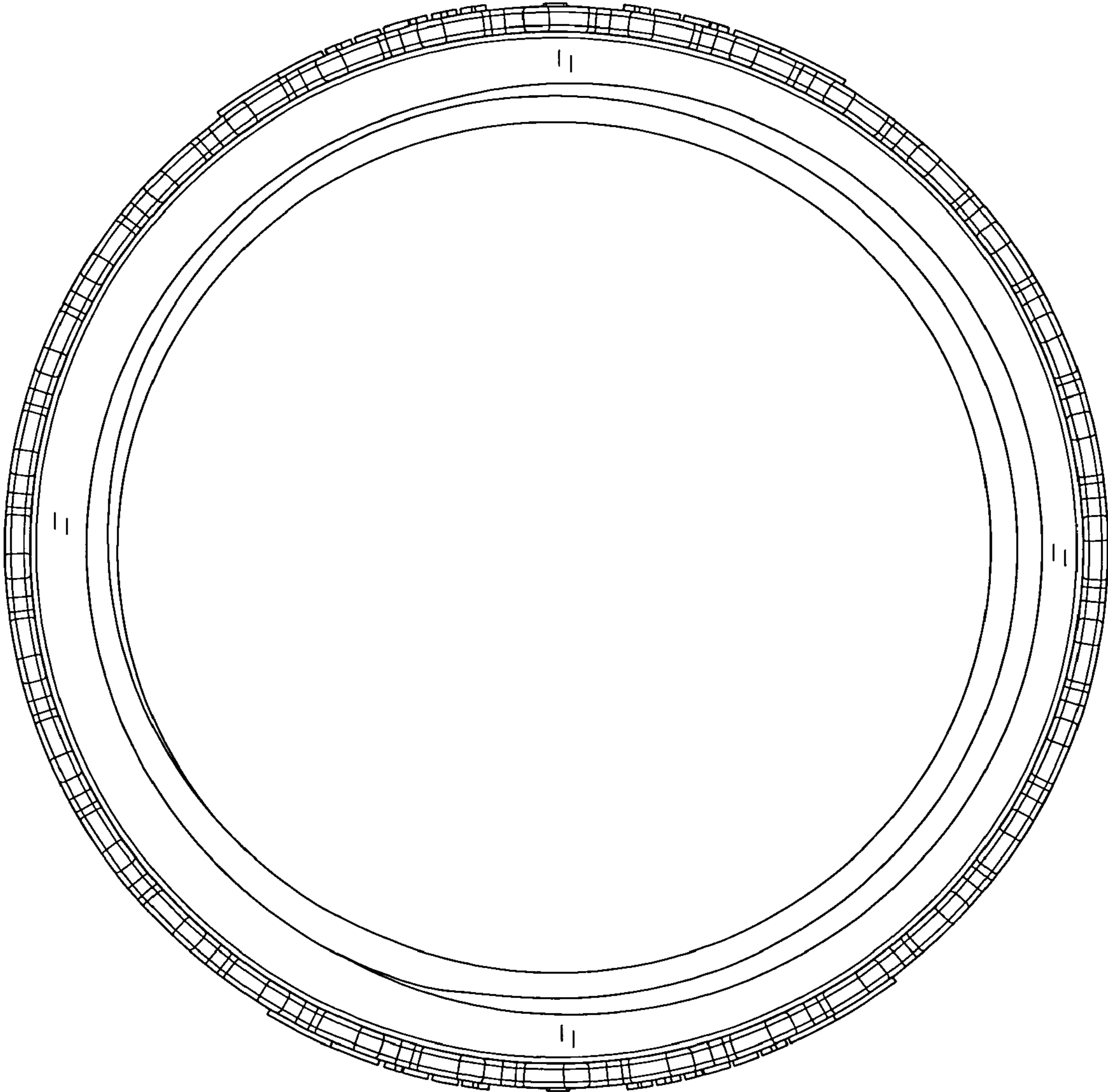

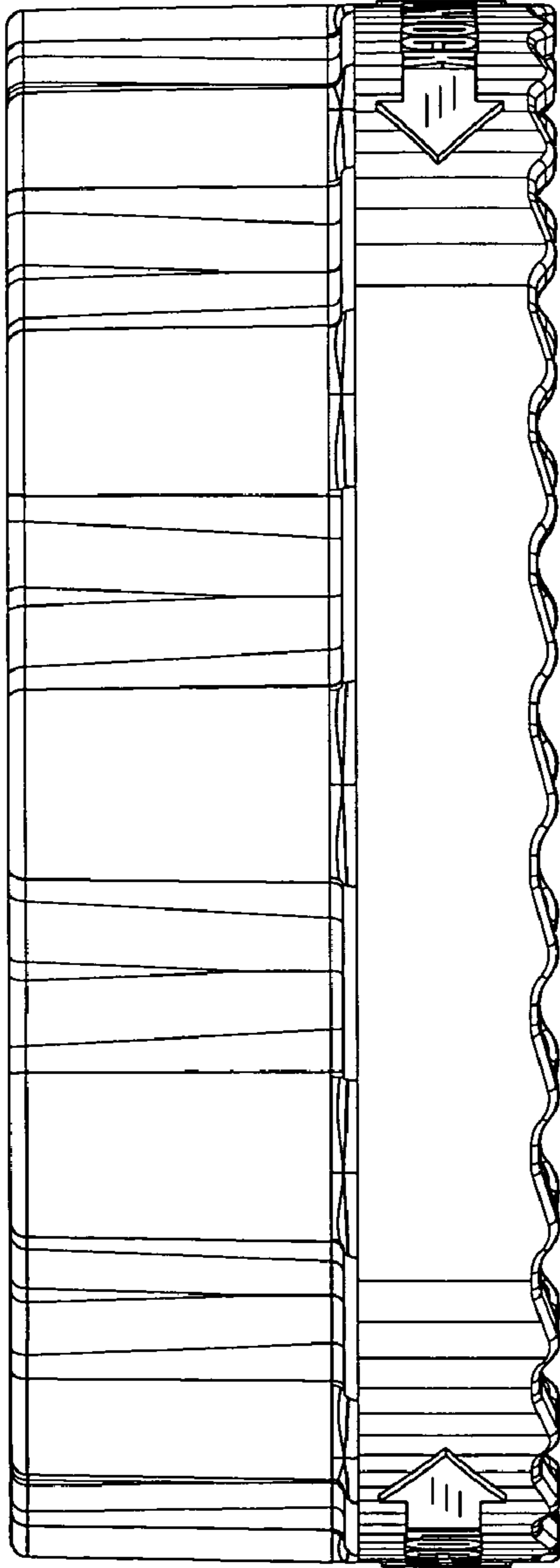

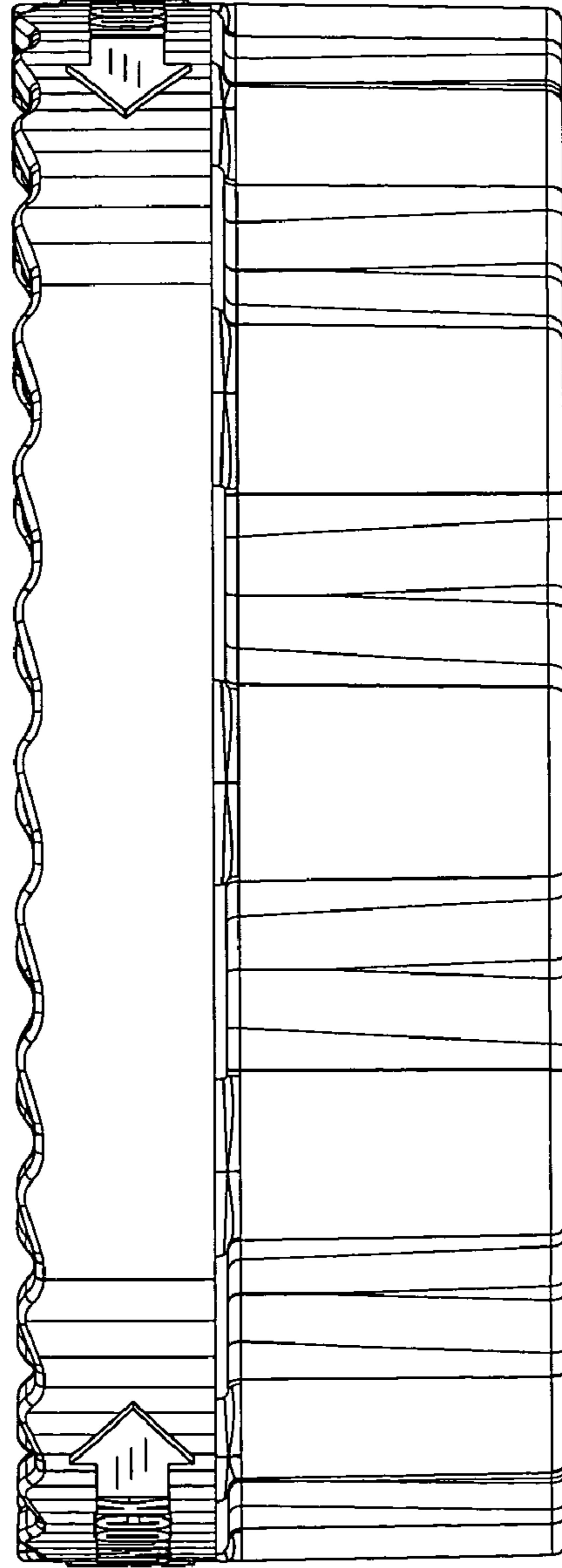
