(57) **CLAIM**

The ornamental design for a fold down worksurface module, as shown and described.

DESCRIPTION

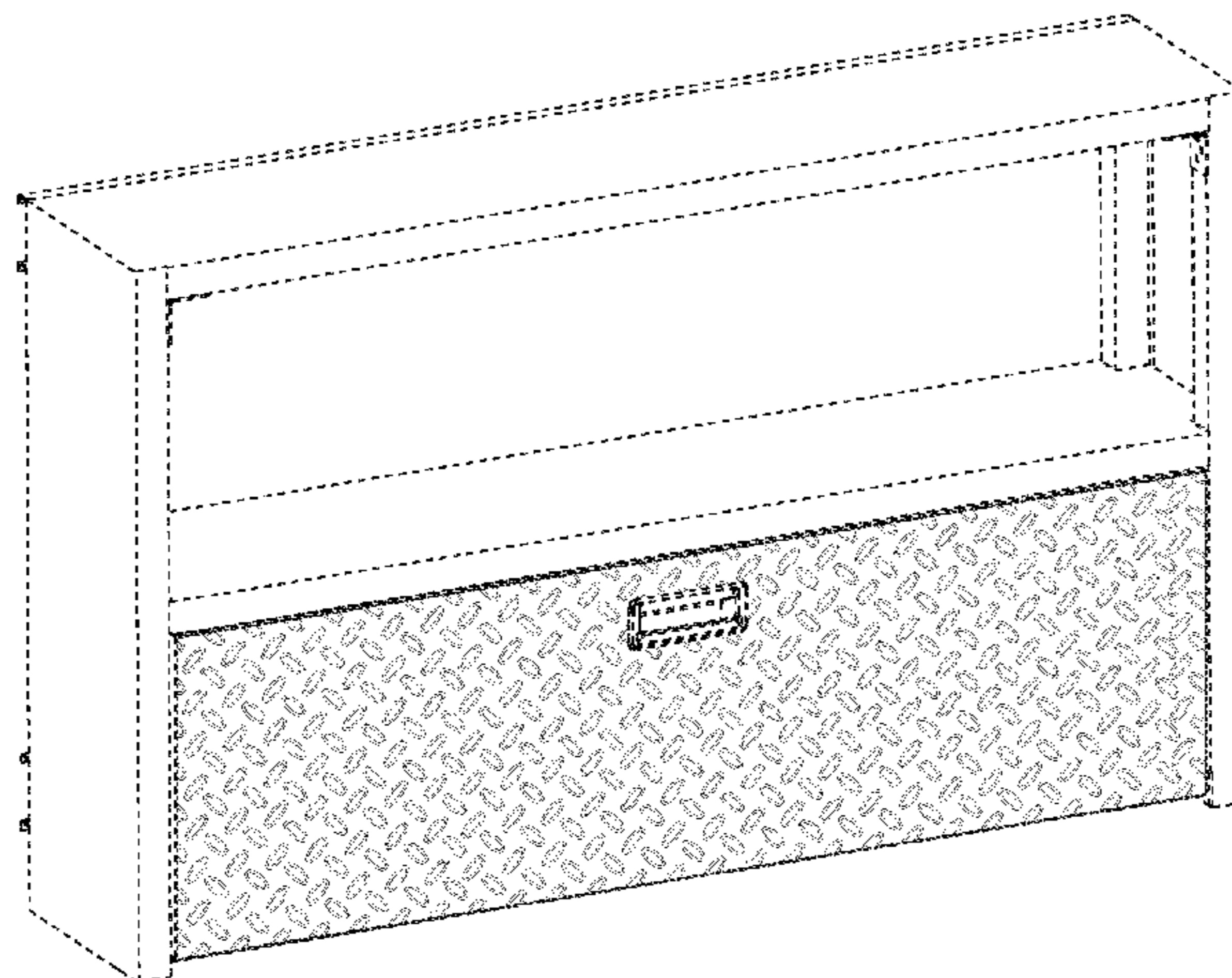
FIG. 1 is a left front perspective view of the design of the fold down worksurface module;

FIG. 2 is a front elevational view thereof; and,

FIG. 3 is an enlarged view of the pattern on the fold down worksurface module.

The ornamental design resides in a pattern on a fold down worksurface module. The pattern is not visible when the worksurface is folded down to an open position, not shown. The broken lines shown are for illustrative purposes only and form no part of the design claimed.

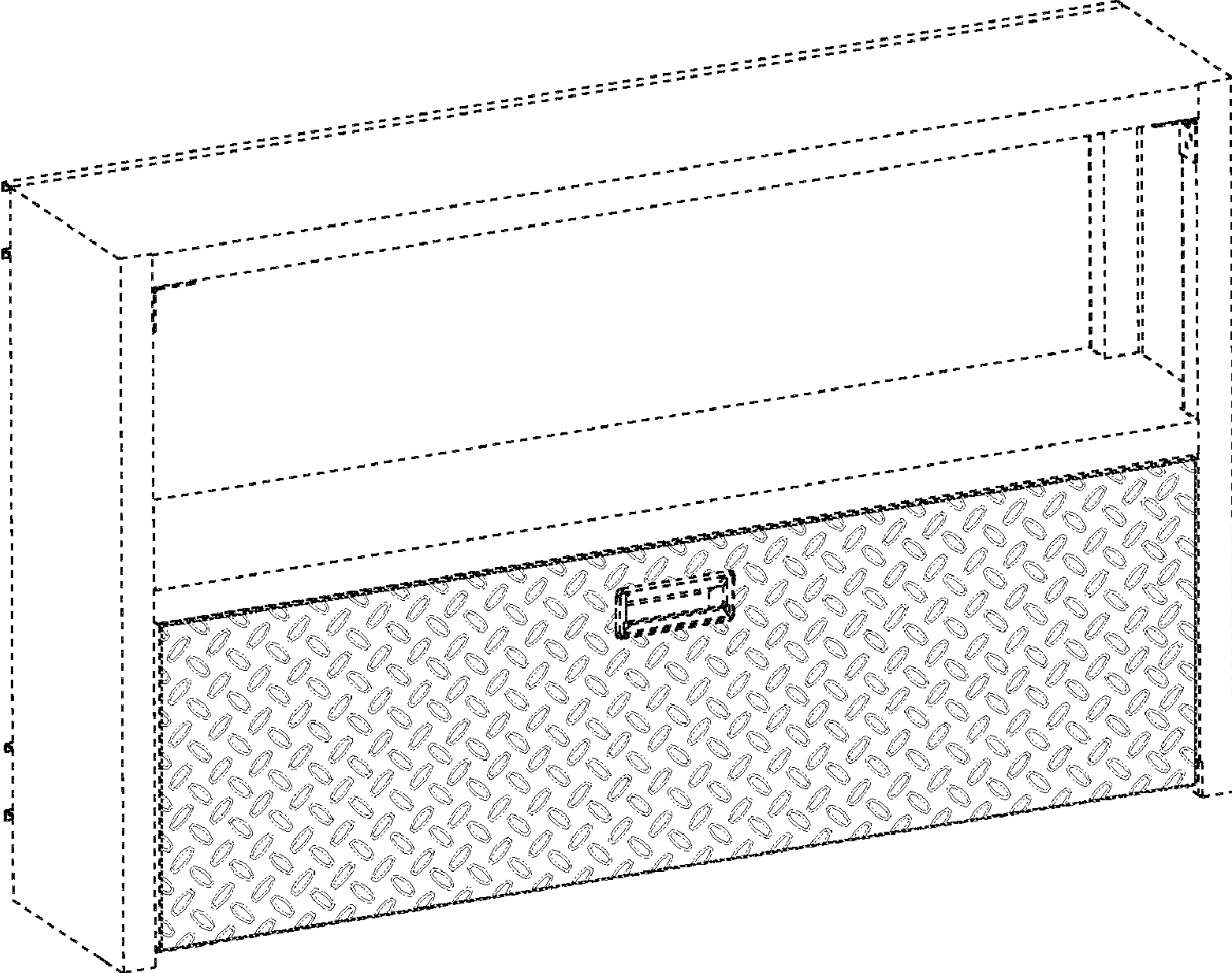

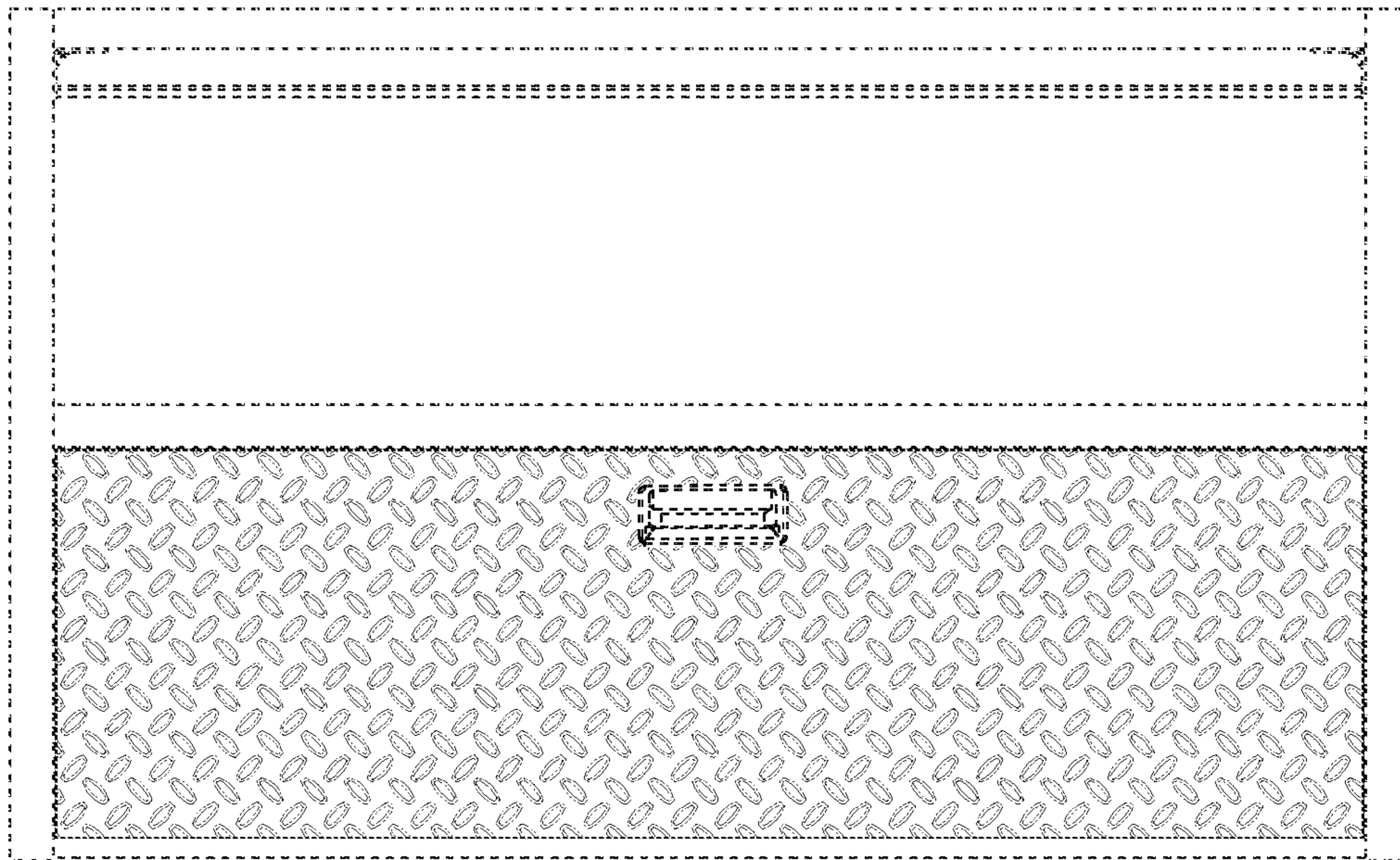

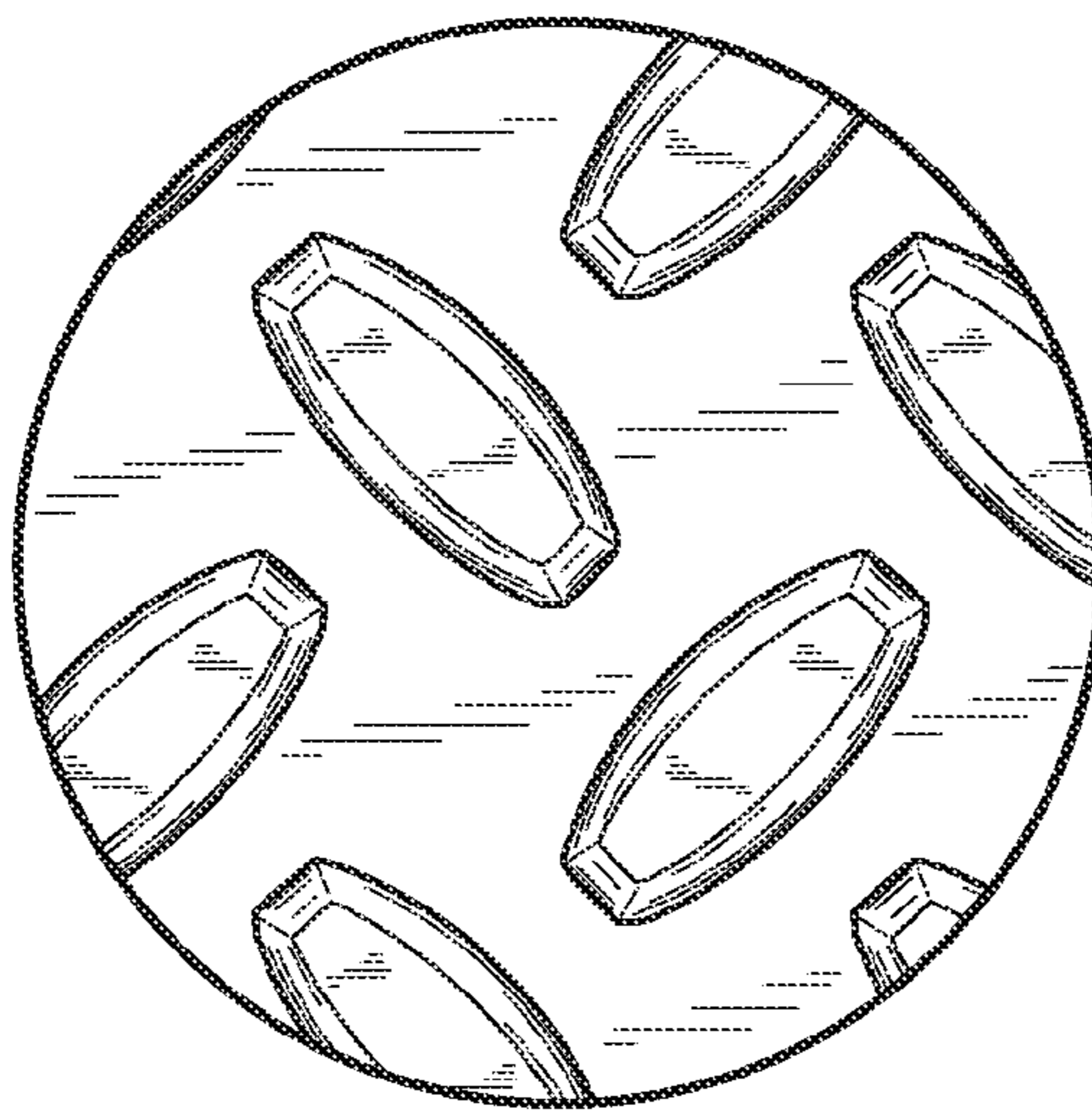
