DESCRIPTION

FIG. 1 is a top view of a louver assembly. The bottom view of the louver assembly forms no part of the claimed design and is not shown.

FIG. 2 is a front view of a louver assembly.

FIG. 3 is a left end view of the louver assembly.

FIG. 4 is a right end view of the louver assembly.

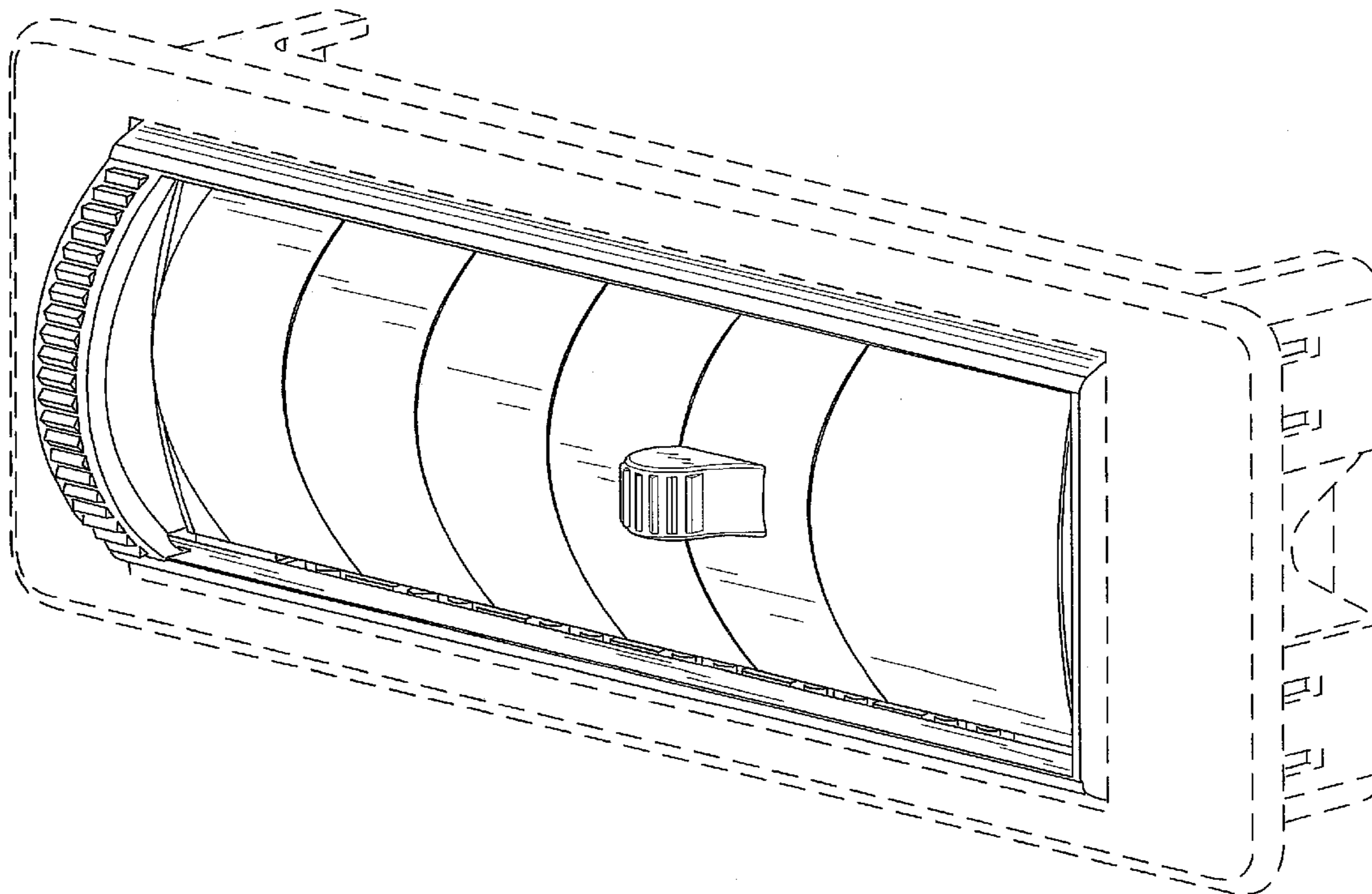
FIG. 5 is a perspective view of the louver assembly, where the perspective view emphasized the left and top of the louver assembly.

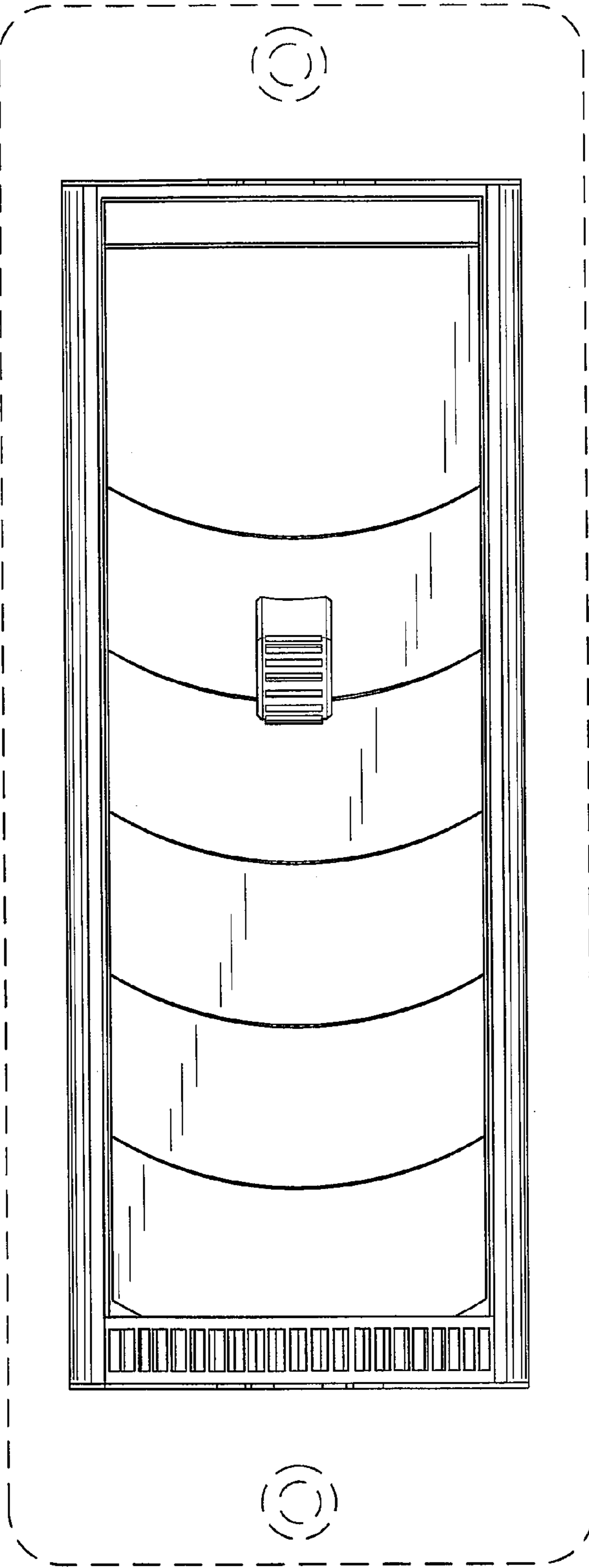

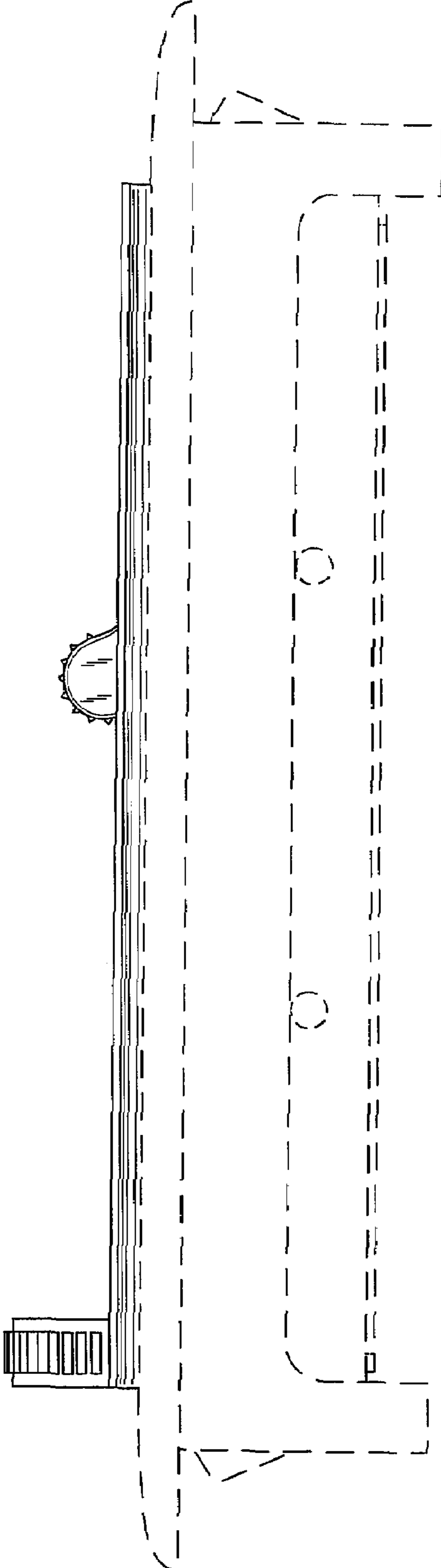

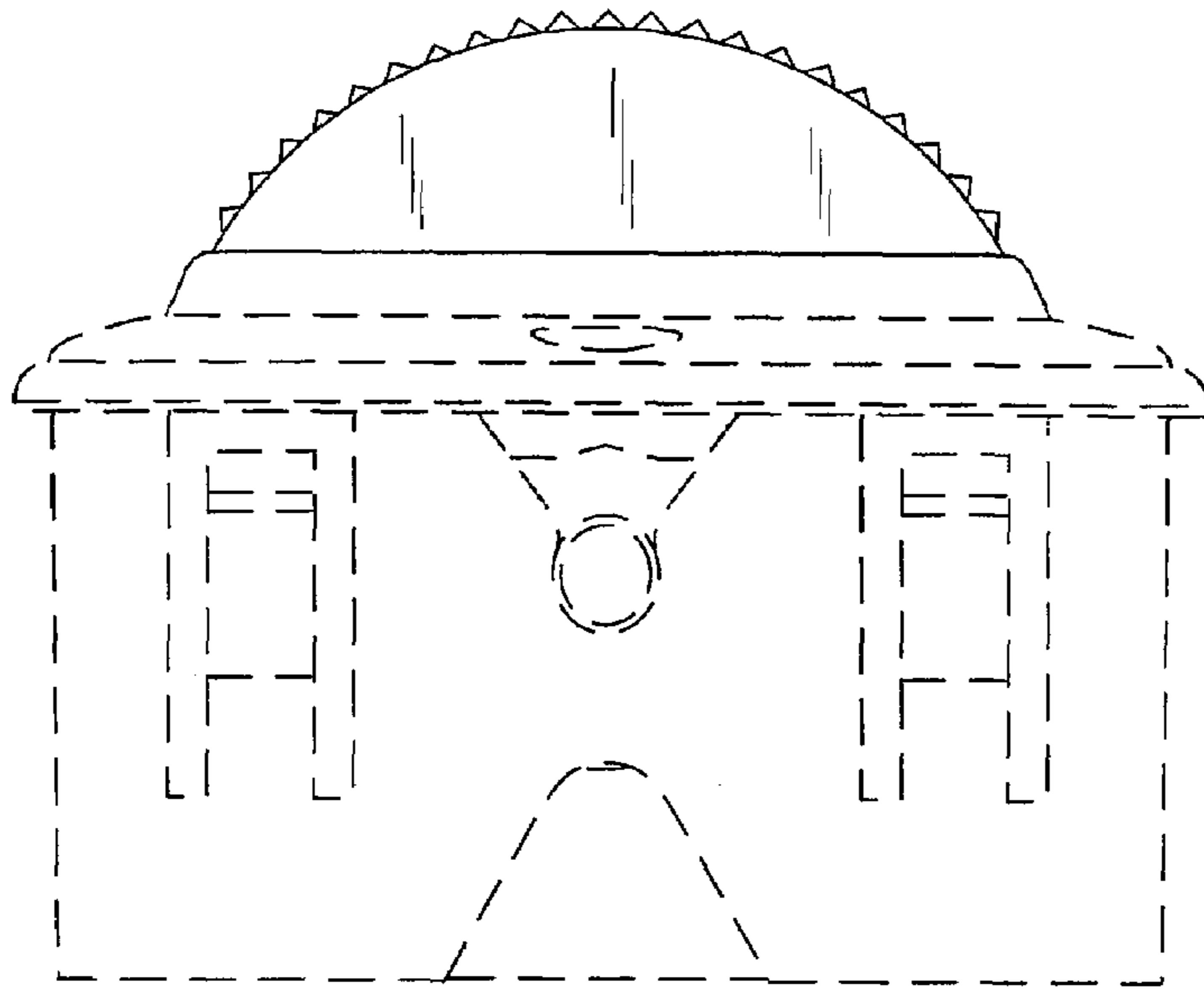

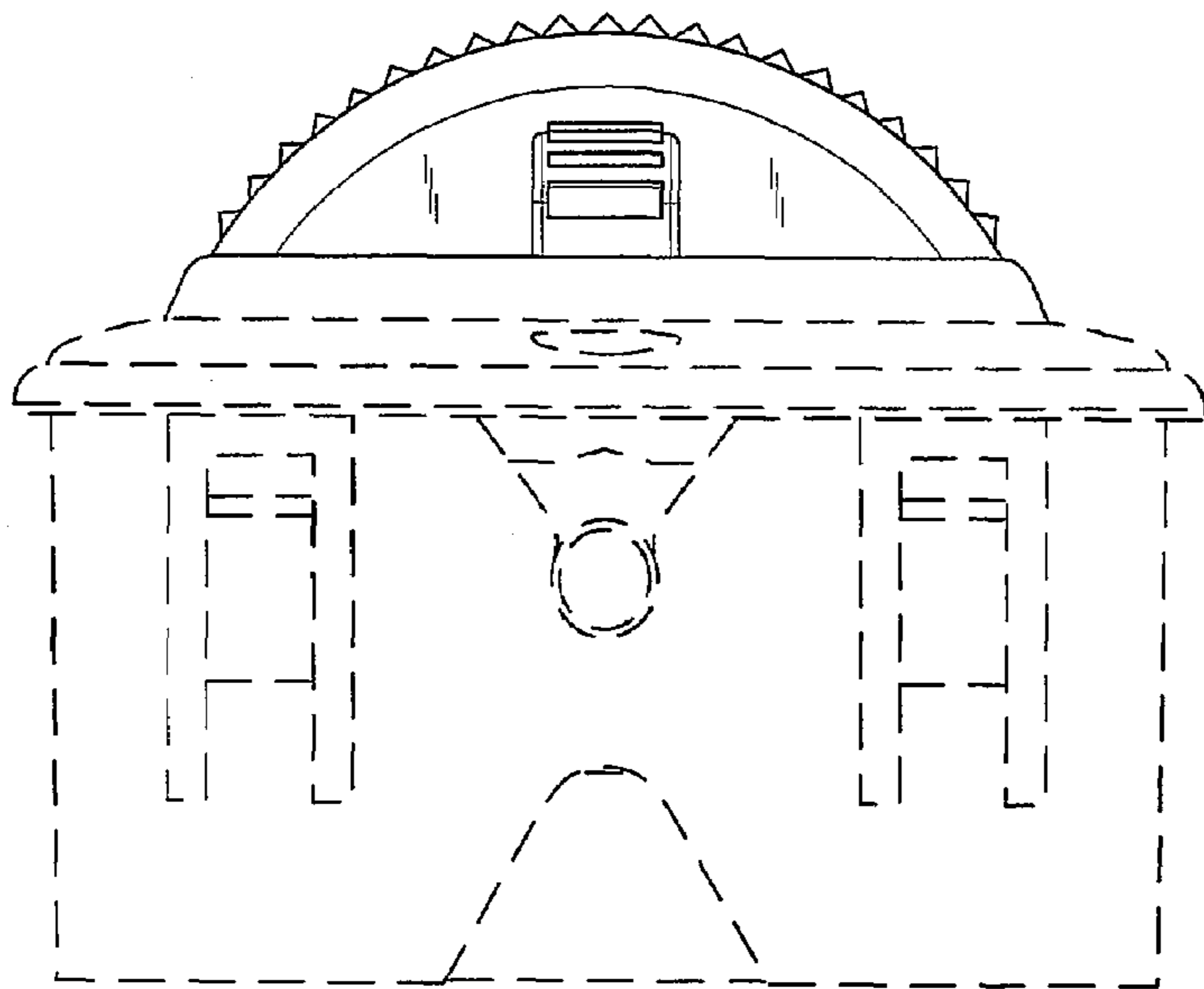

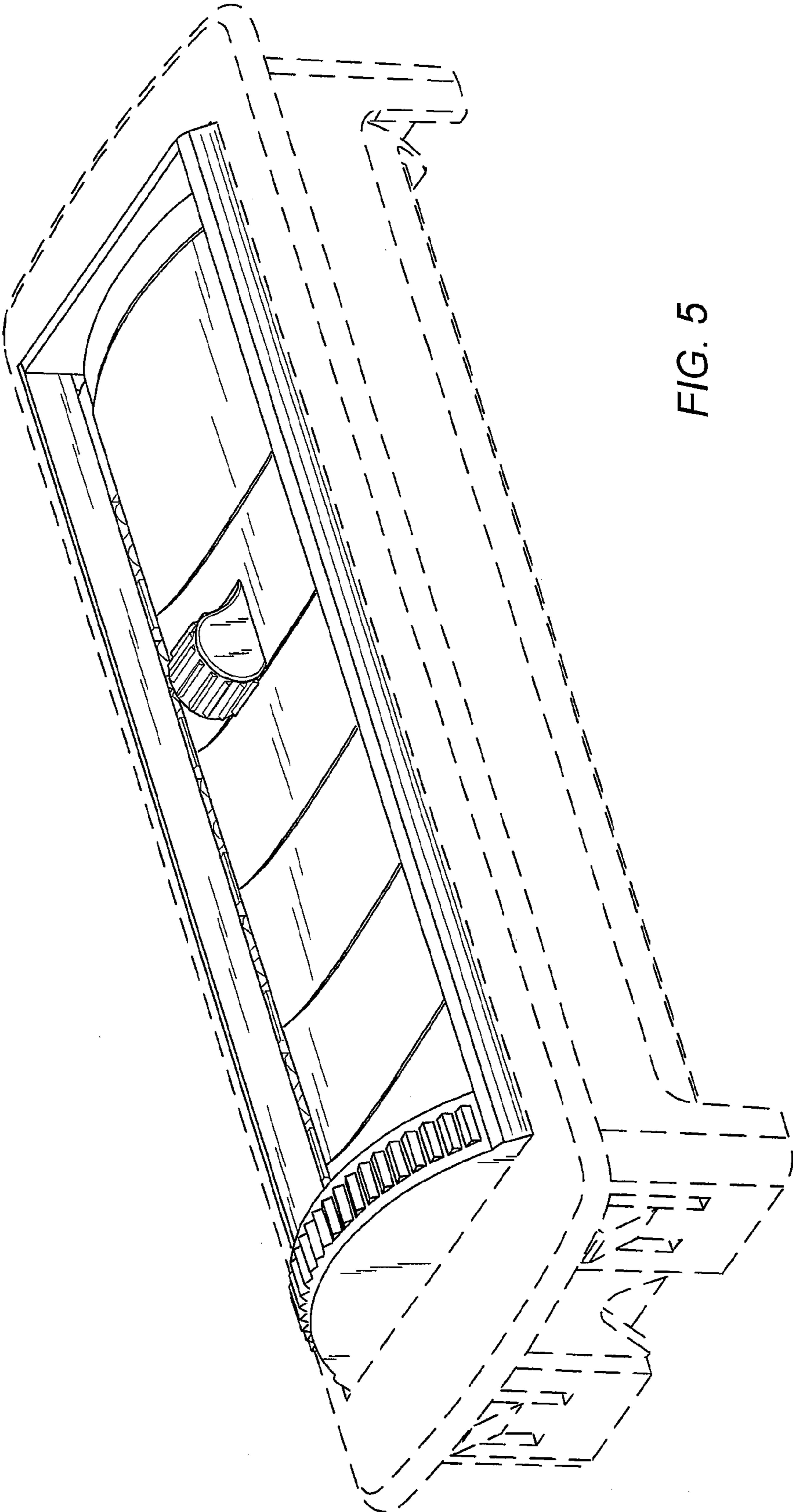

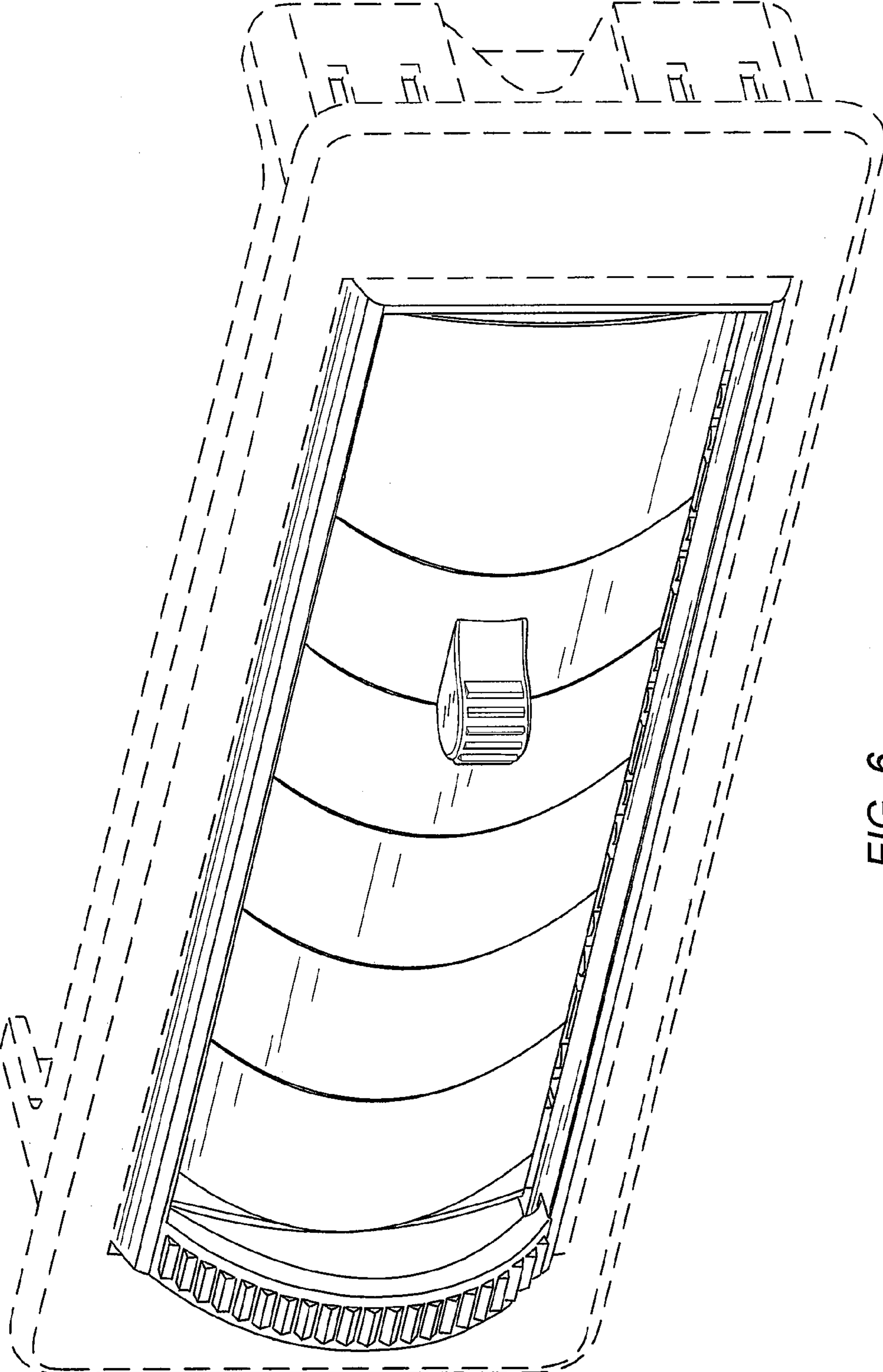

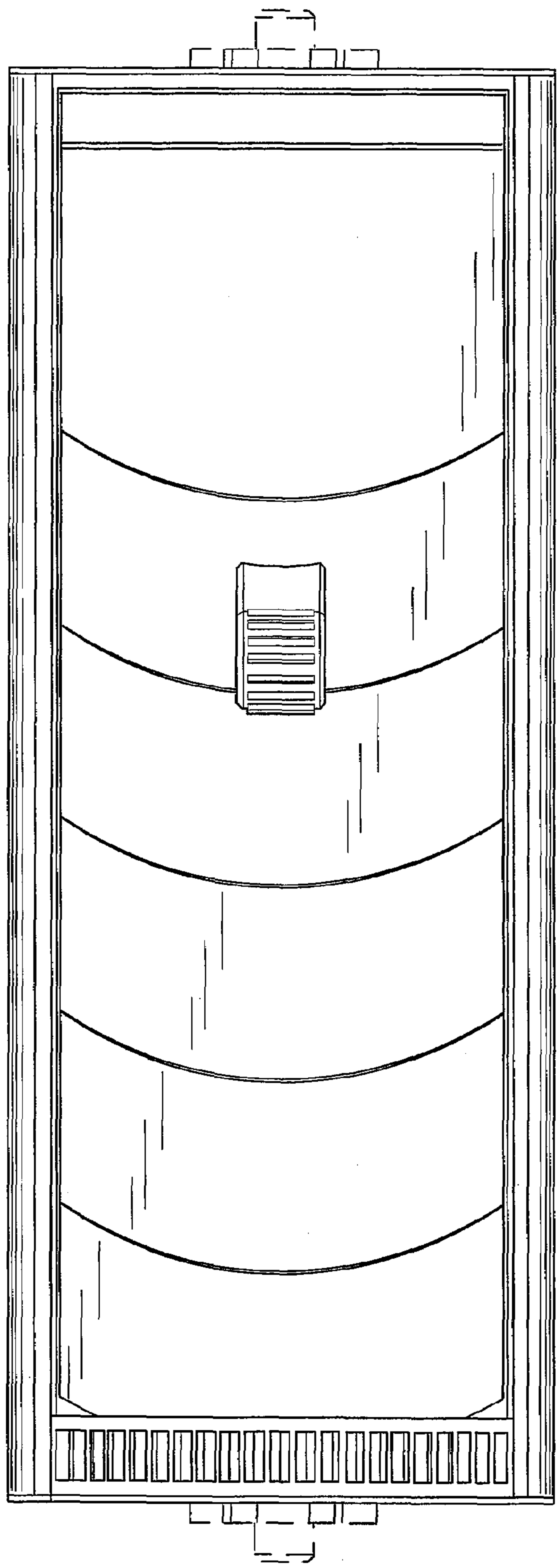
