**DESCRIPTION**

FIG. 1 is a front elevation view of a sawtooth embodying our new design;

FIG. 2 is a back elevation view of the sawtooth shown in FIG. 1;

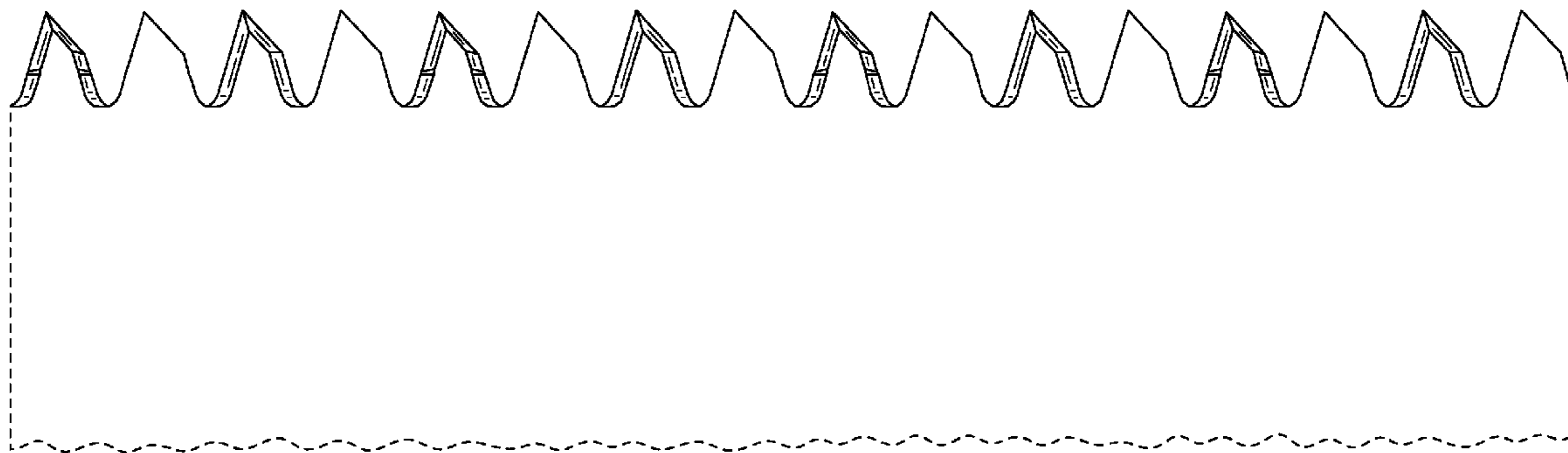
FIG. 3 is a left side elevation view of the sawtooth shown in FIG. 1;

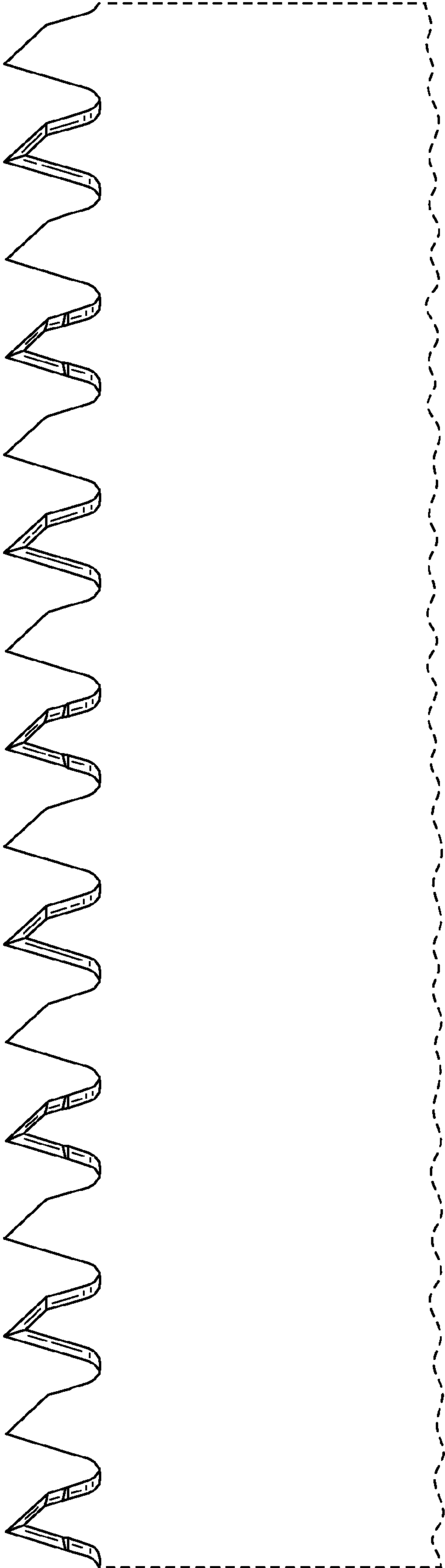

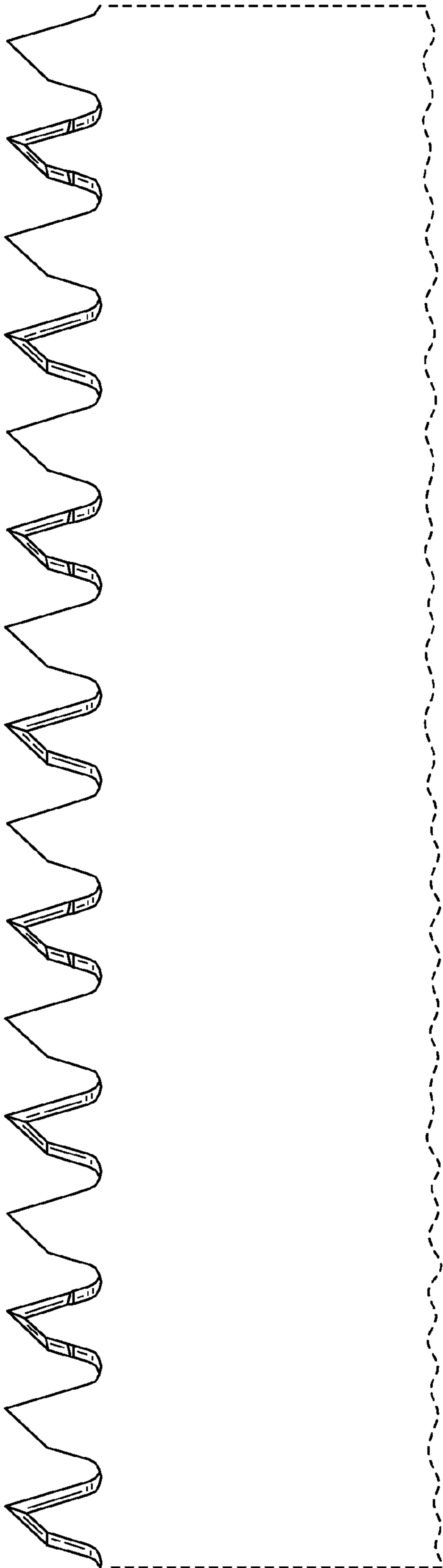

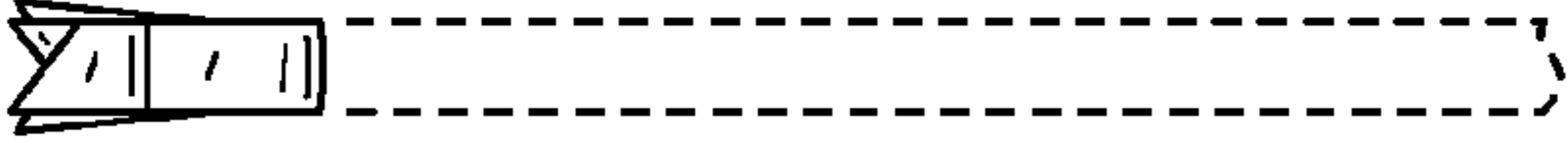

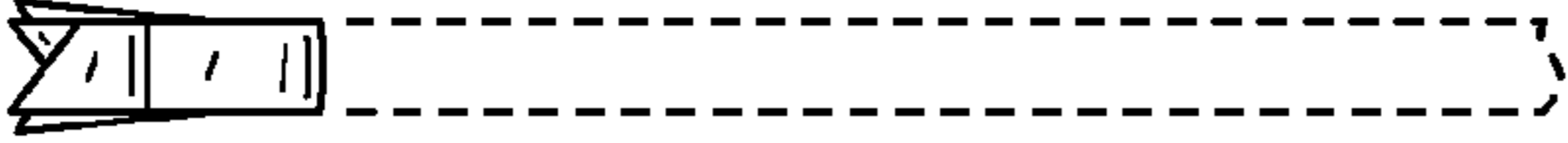
