(57) **CLAIM**

The ornamental design for a cord stopper, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a cord stopper of the claimed design.

FIG. 2 is a rear view of the cord stopper of FIG. 1.

FIG. 3 is a plan view of the cord stopper of FIG. 1.

FIG. 4 is a base view of the cord stopper of FIG. 1.

FIG. 5 is a right side view of the cord stopper of FIG. 1, the left side view being identical with the right side view; and,

FIG. 6 is a perspective view of the cord stopper of FIG. 1.

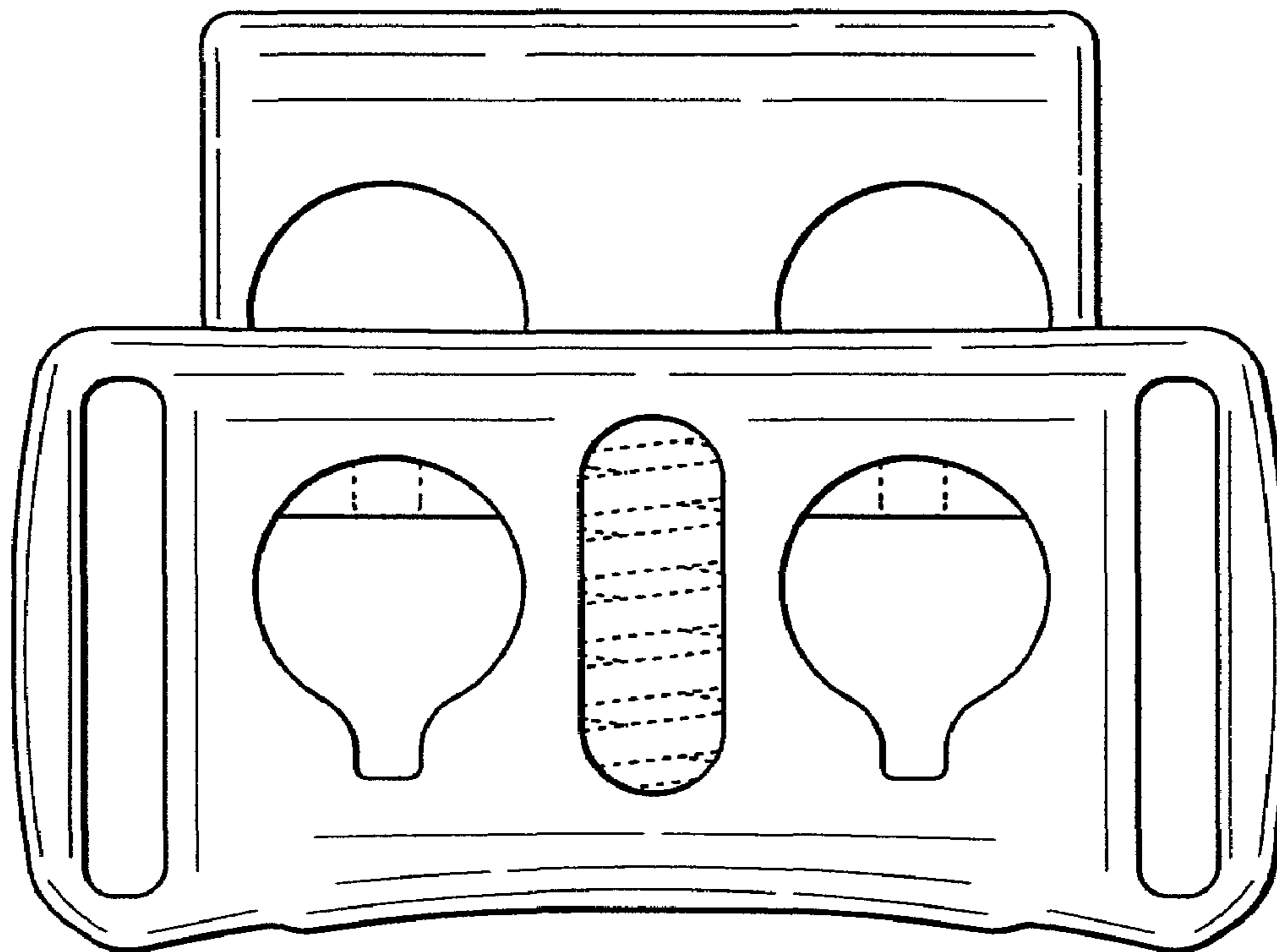

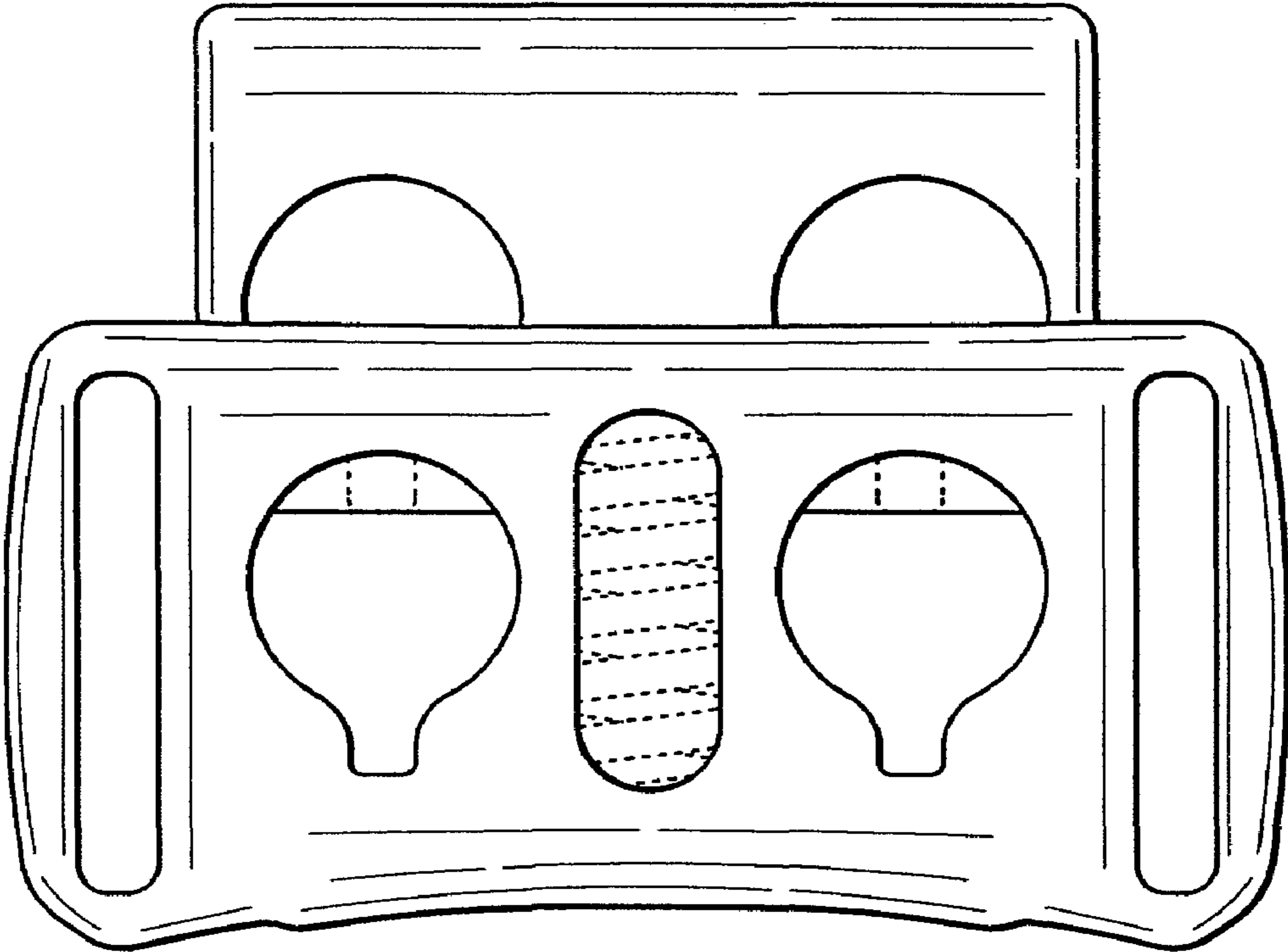

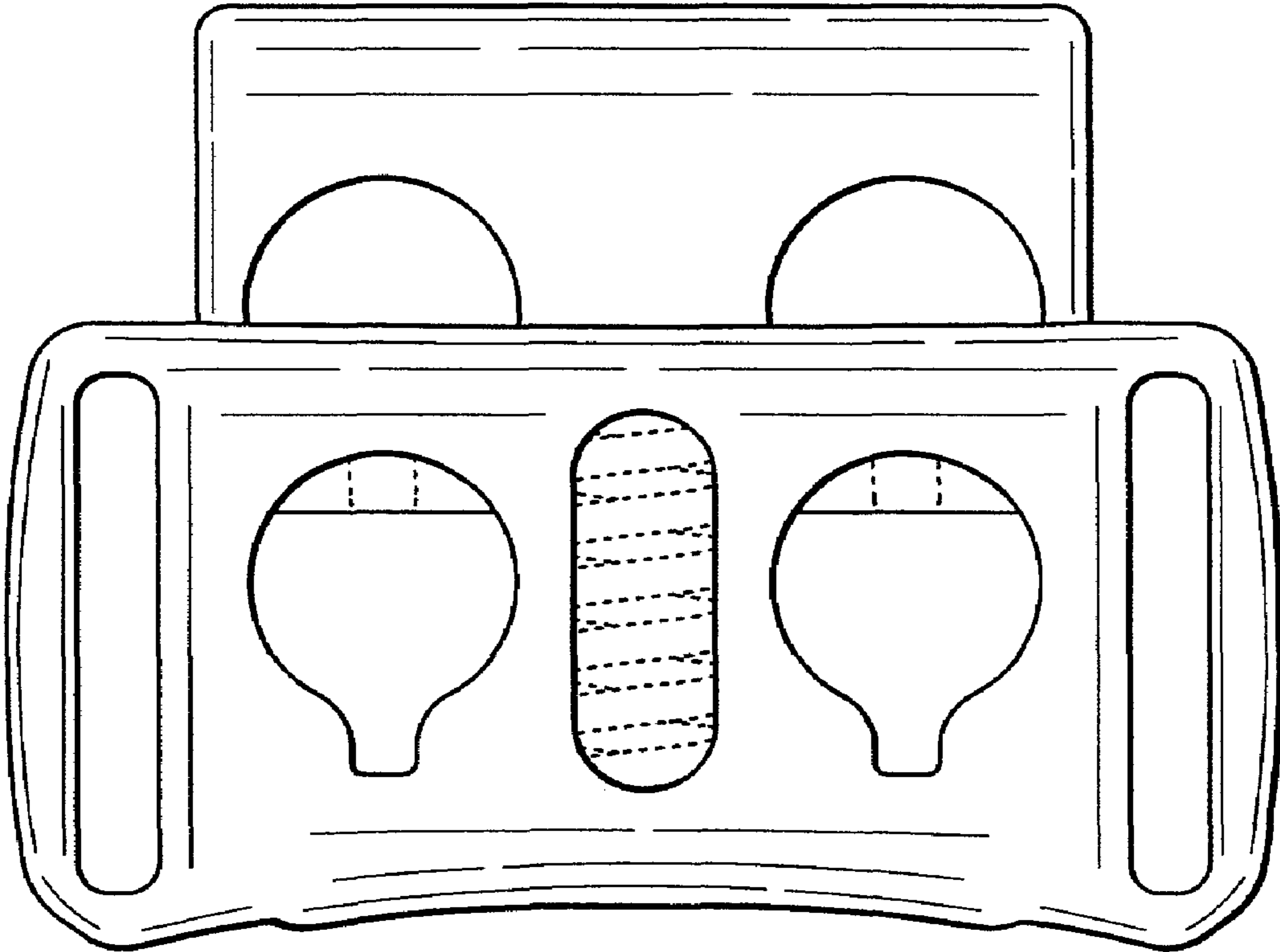

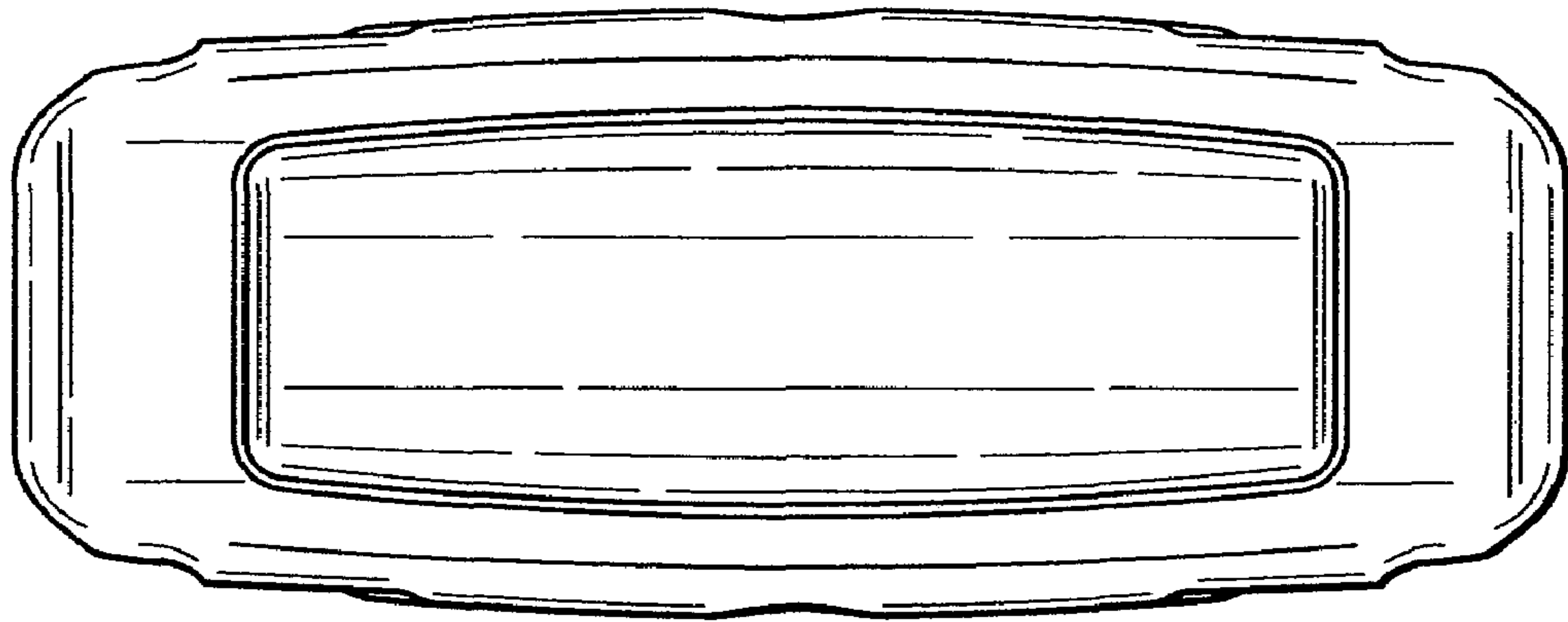

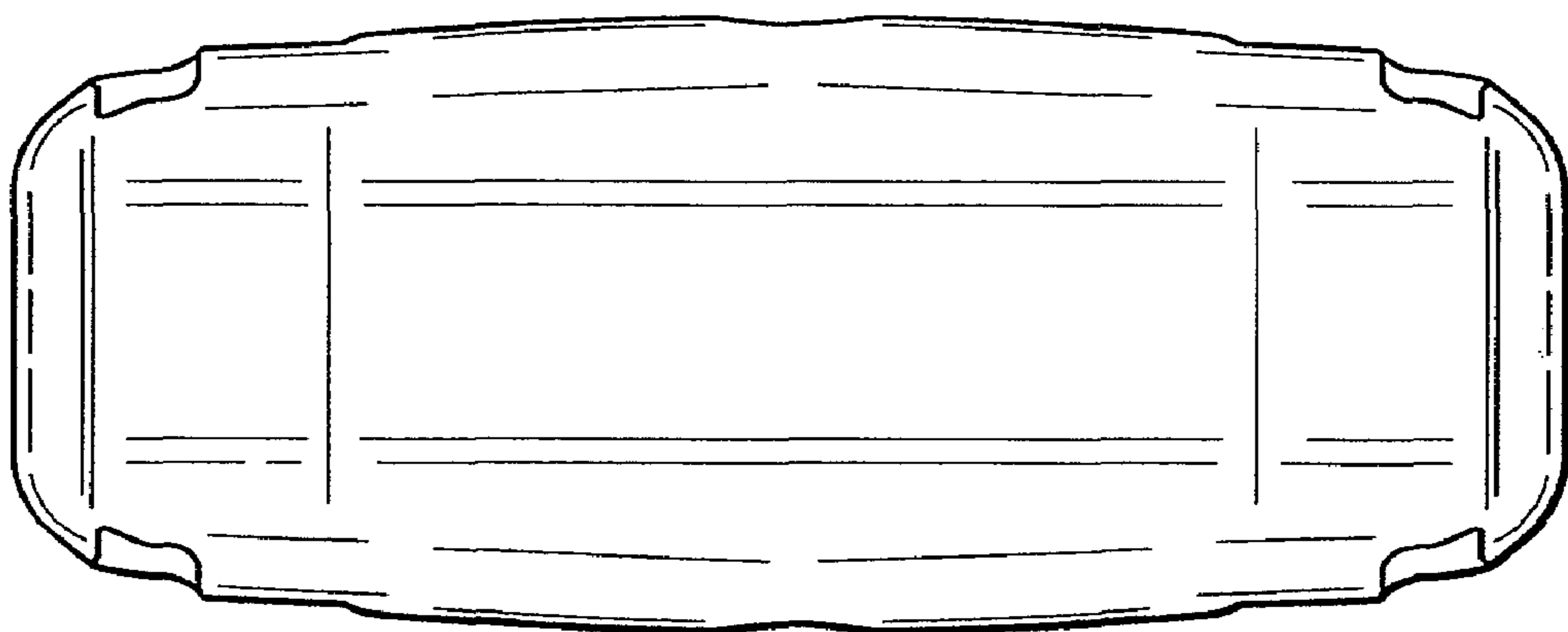

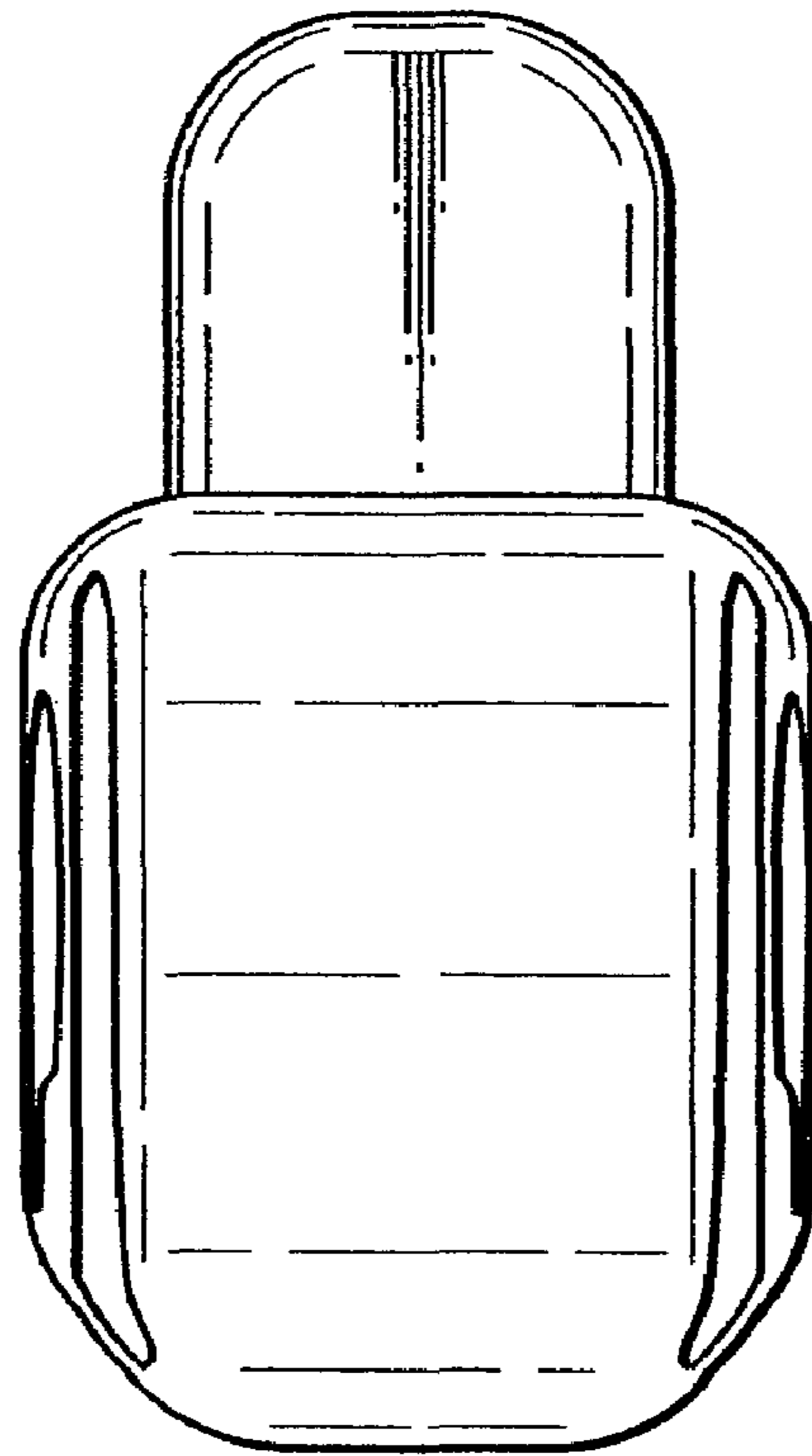
