(57) **CLAIM**

The ornamental design for a bottle, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the bottle, showing our new design;

FIG. 2 is a front elevational view, the rear elevational view being a mirror image thereof;

FIG. 3 is a right side elevational view, the left side elevational view being a mirror image thereof; and,

FIG. 4 is a top plan view thereof.

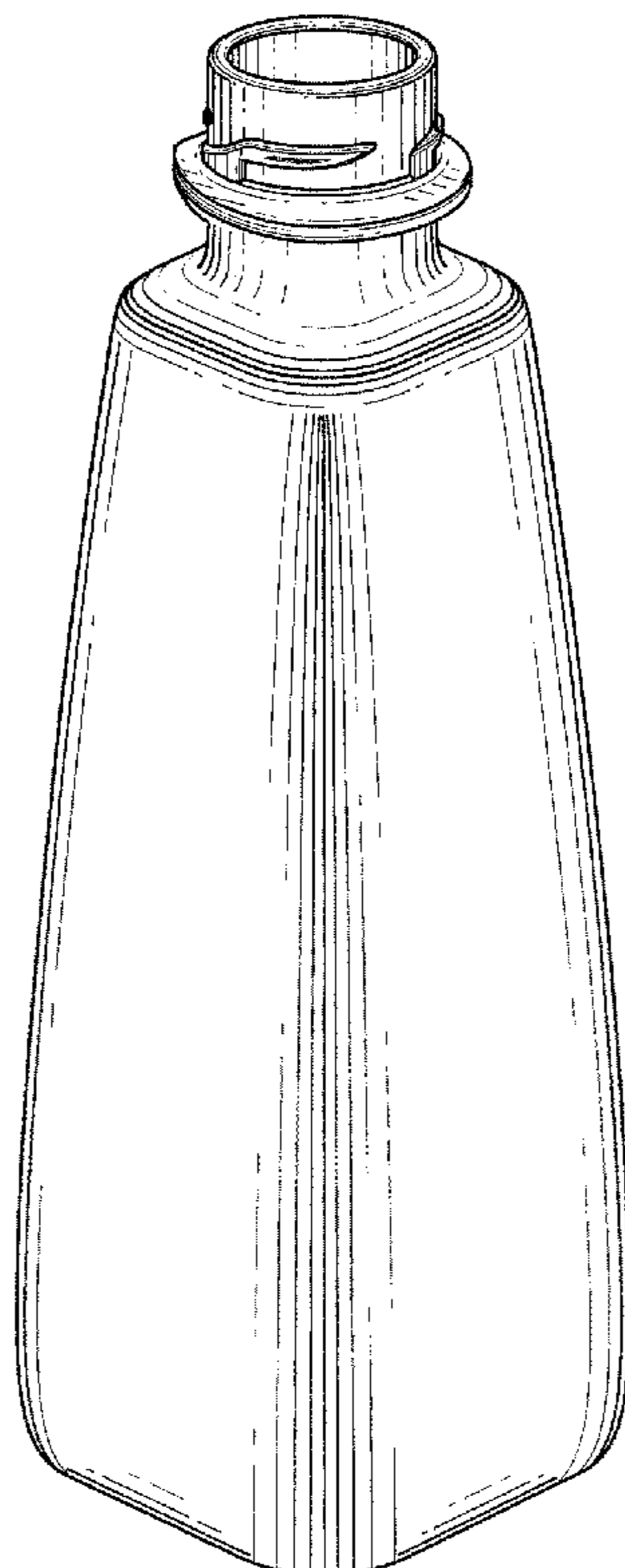

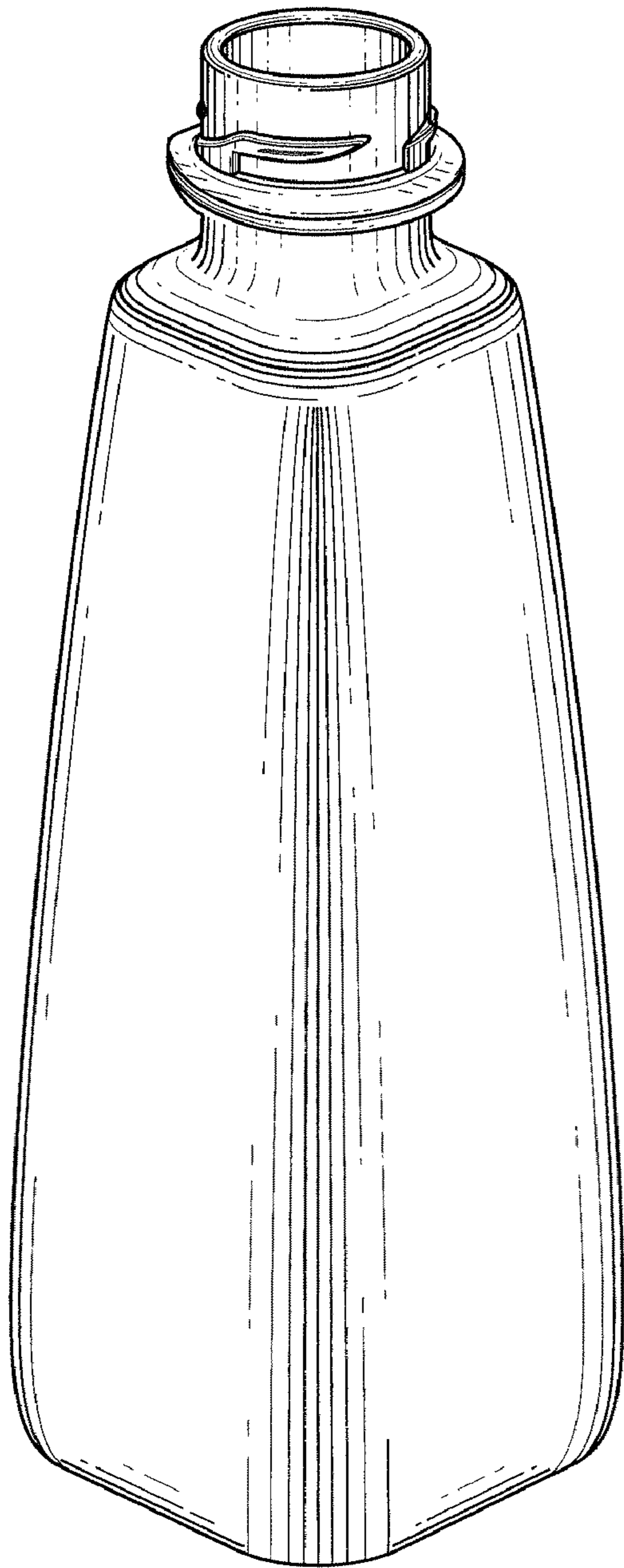

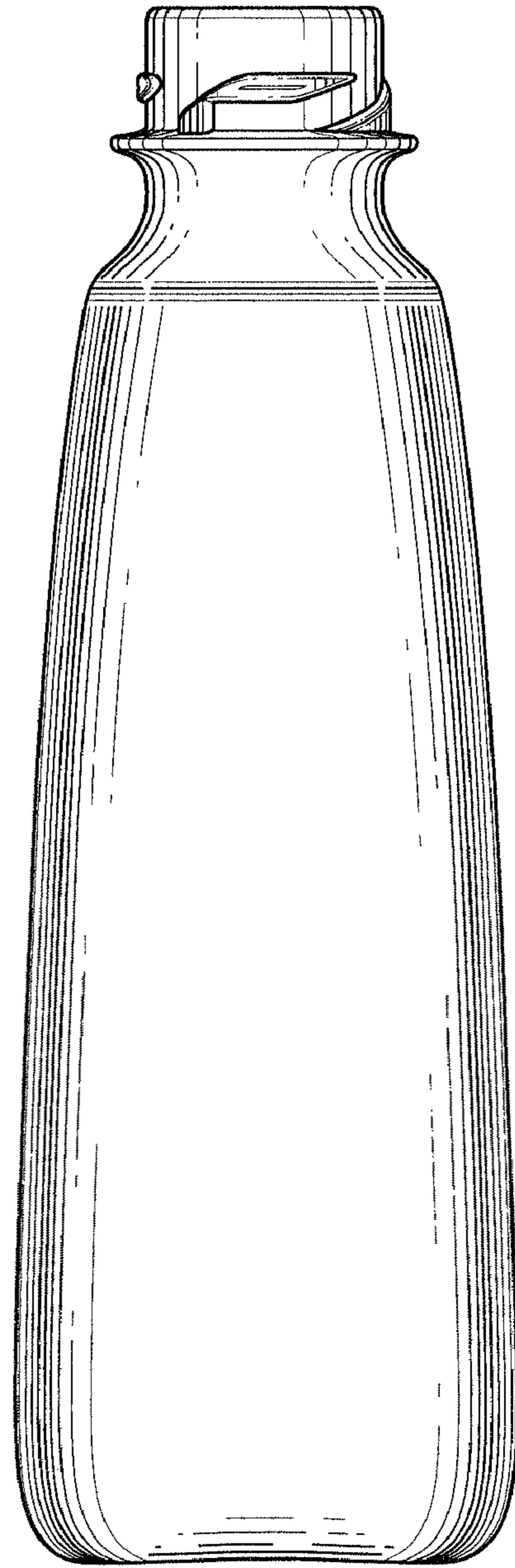

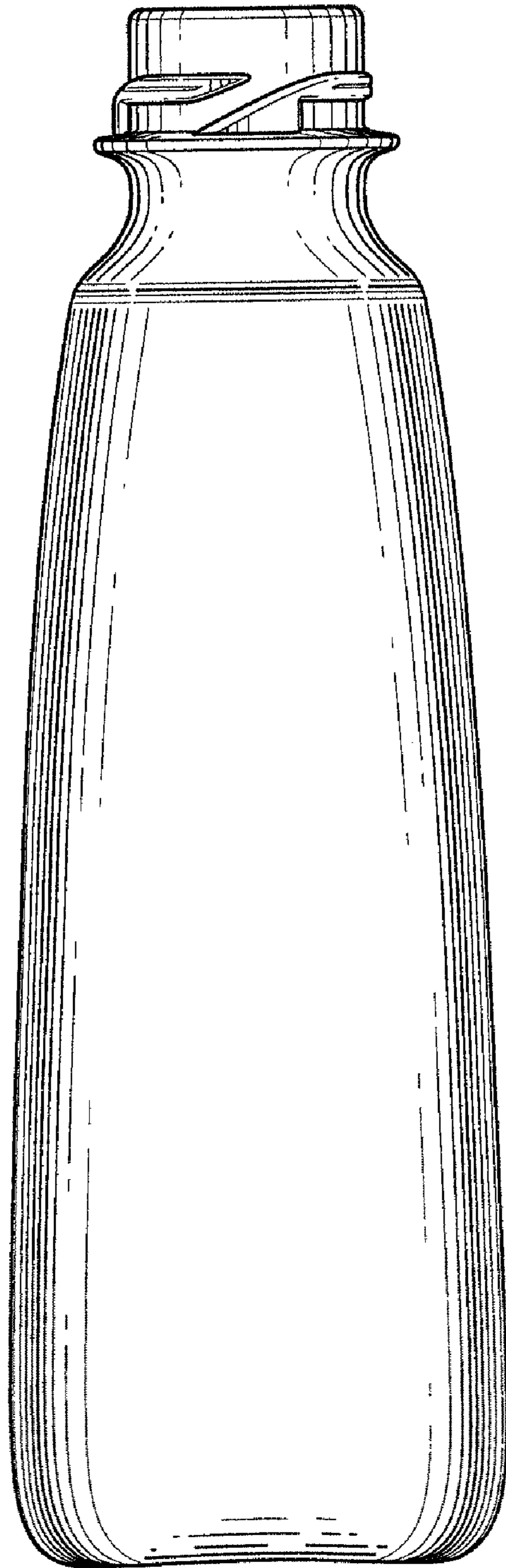
