FIG. 3 is a top view of a bunting according to the present invention;

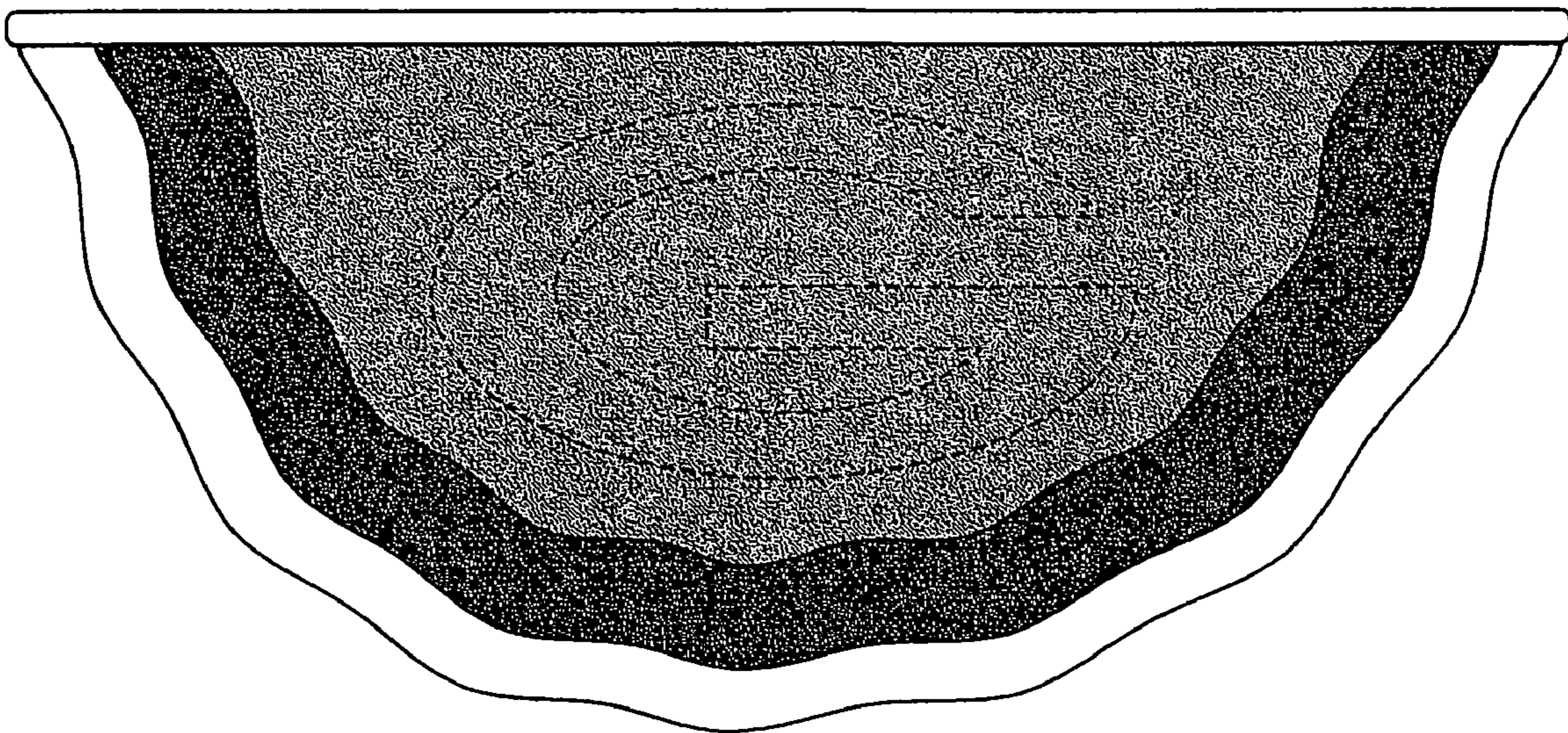
FIG. 4 is a bottom view of a bunting according to the present invention;

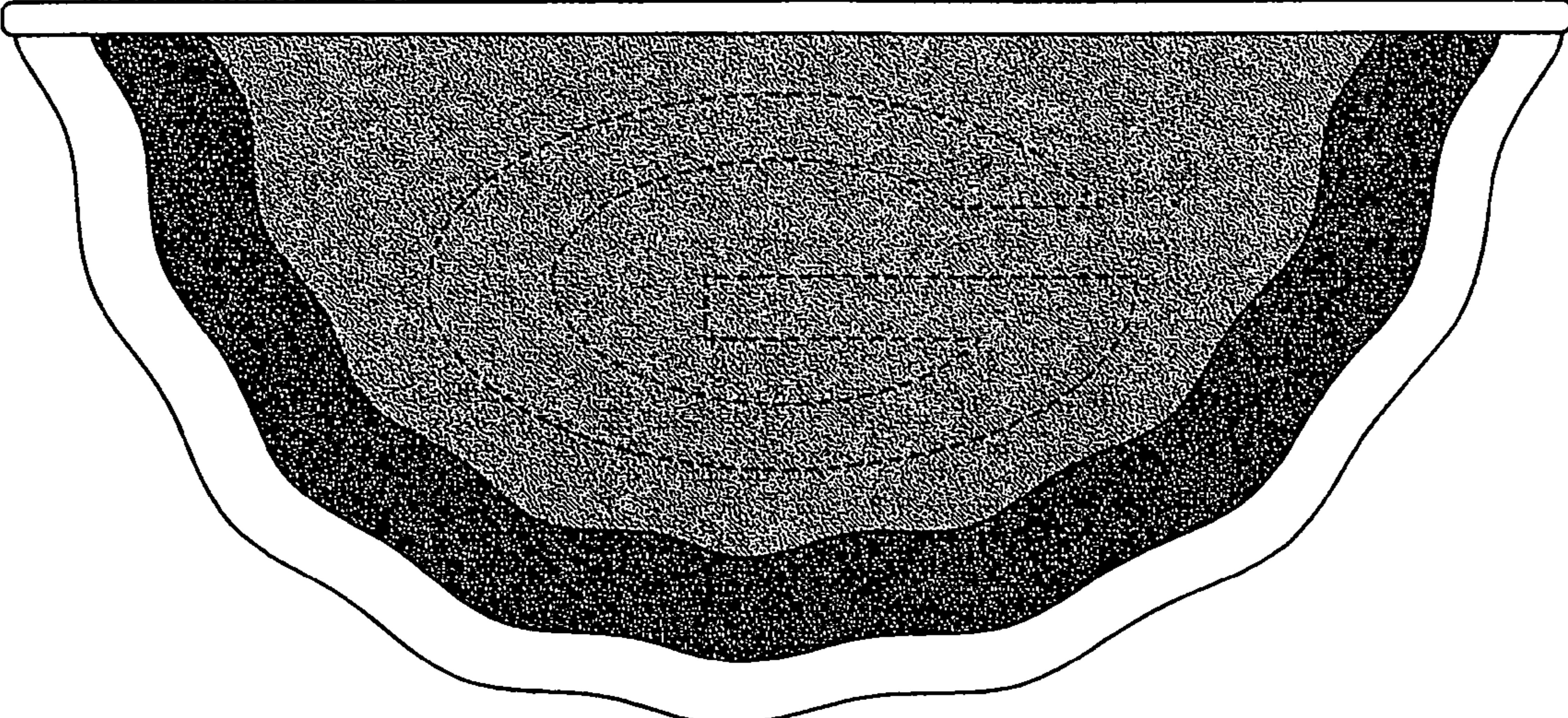

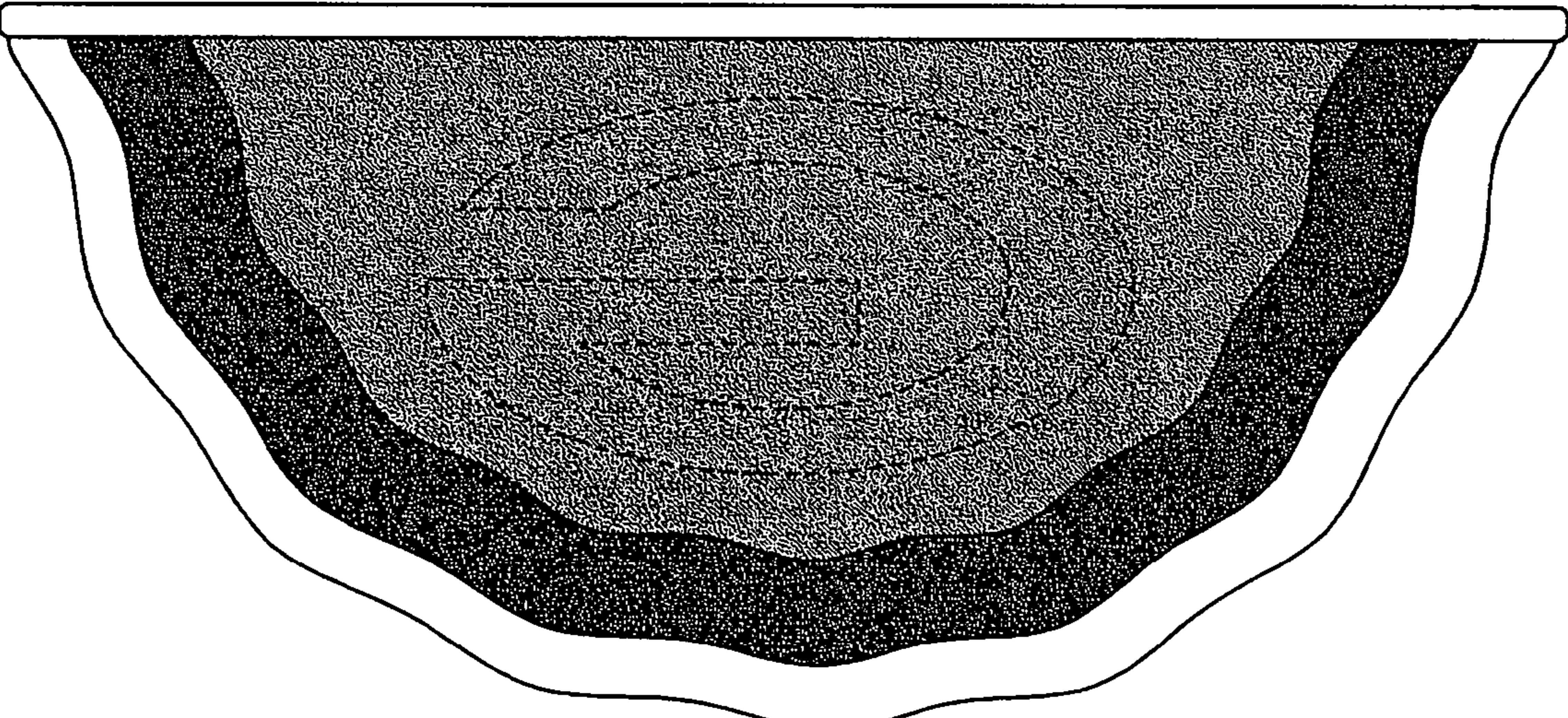

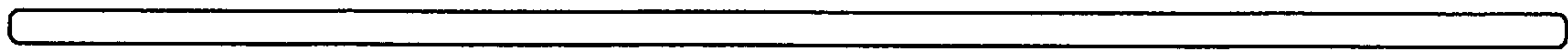

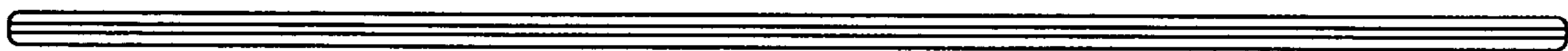
