FIG. 3 is a front view of the electronic instrument support structure shown in FIG. 1,

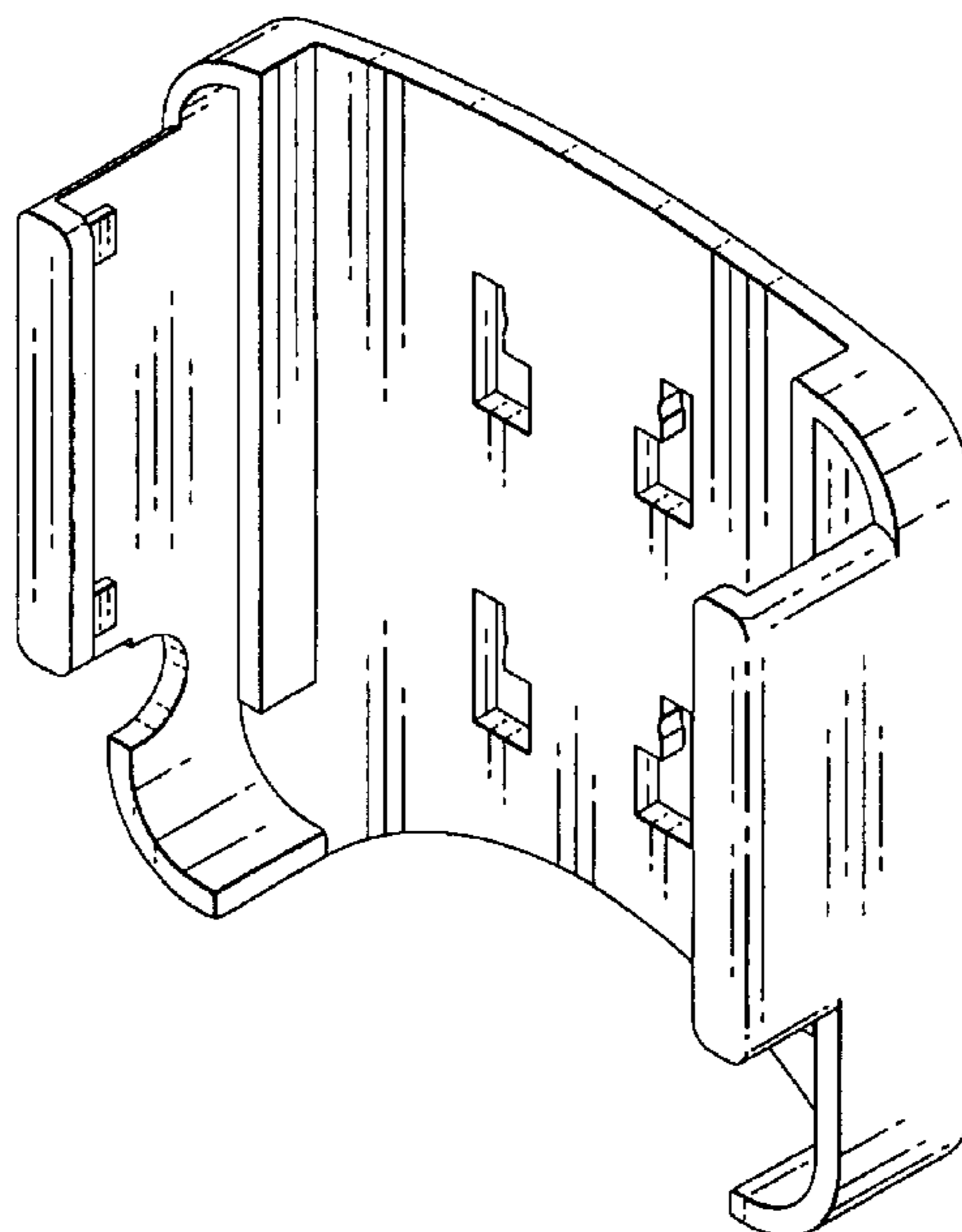
FIG. 4 is a top view of the electronic instrument support structure shown in FIG. 1,

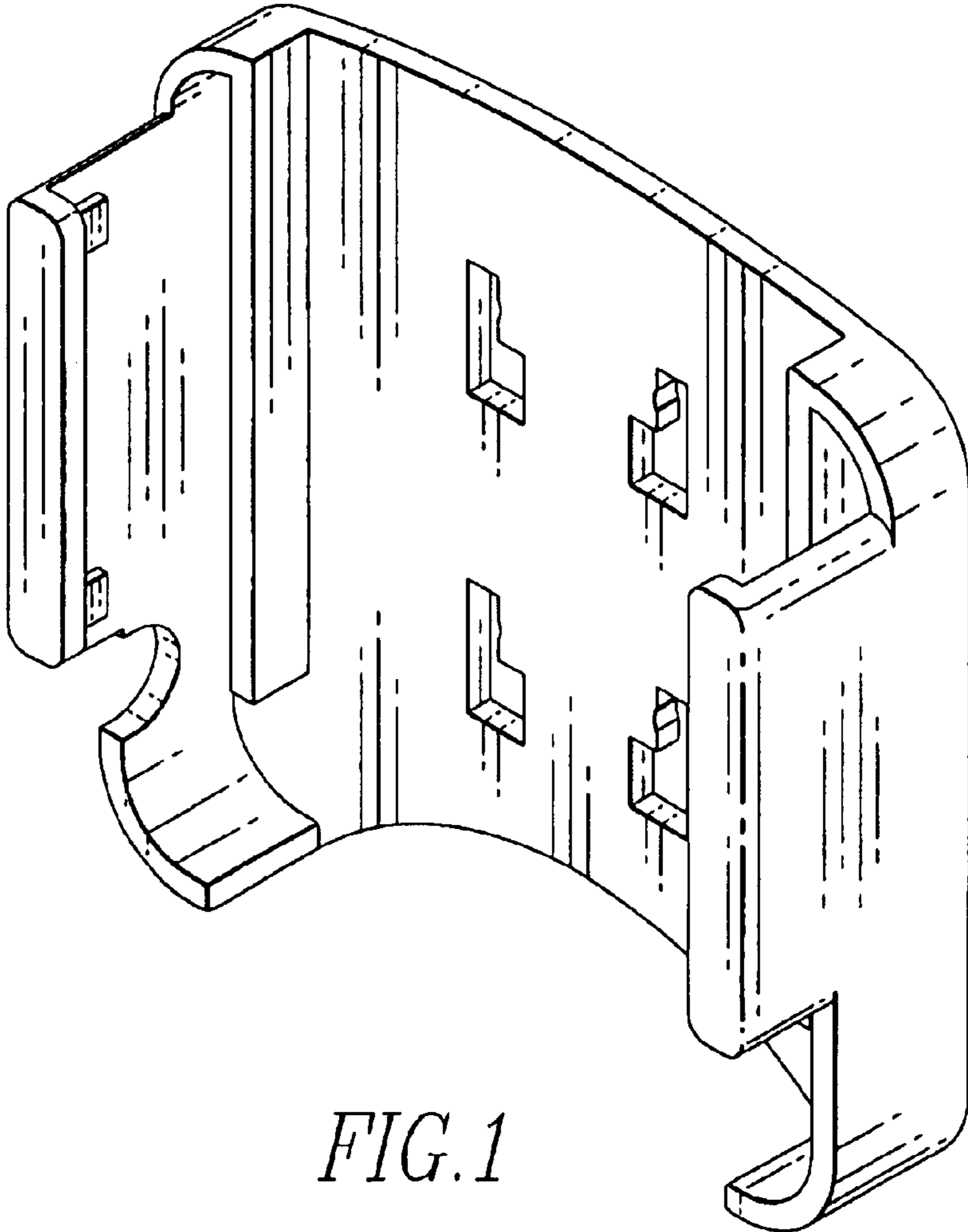
FIG. 5 is a bottom view of the electronic instrument support structure shown in FIG. 1,

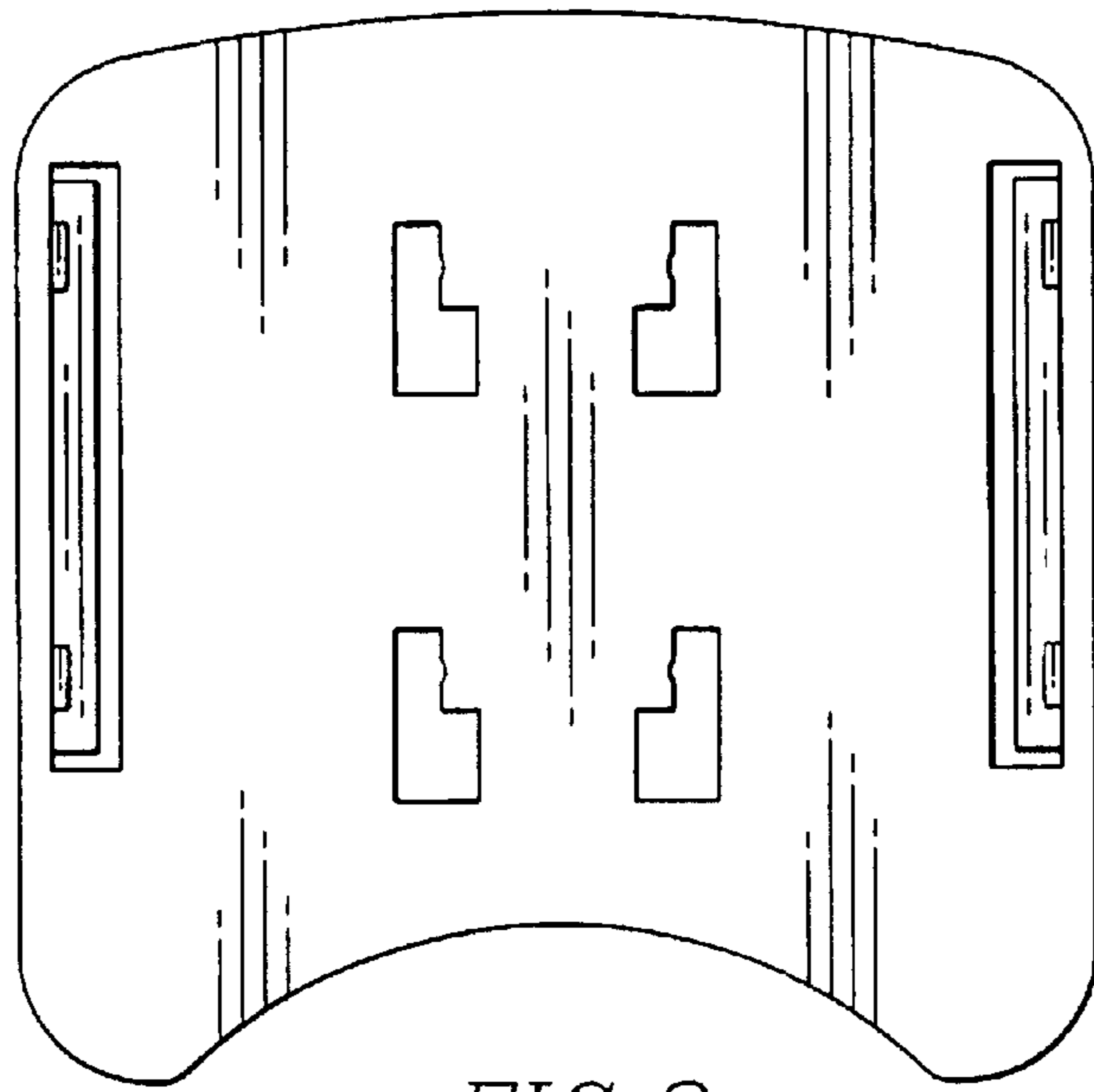

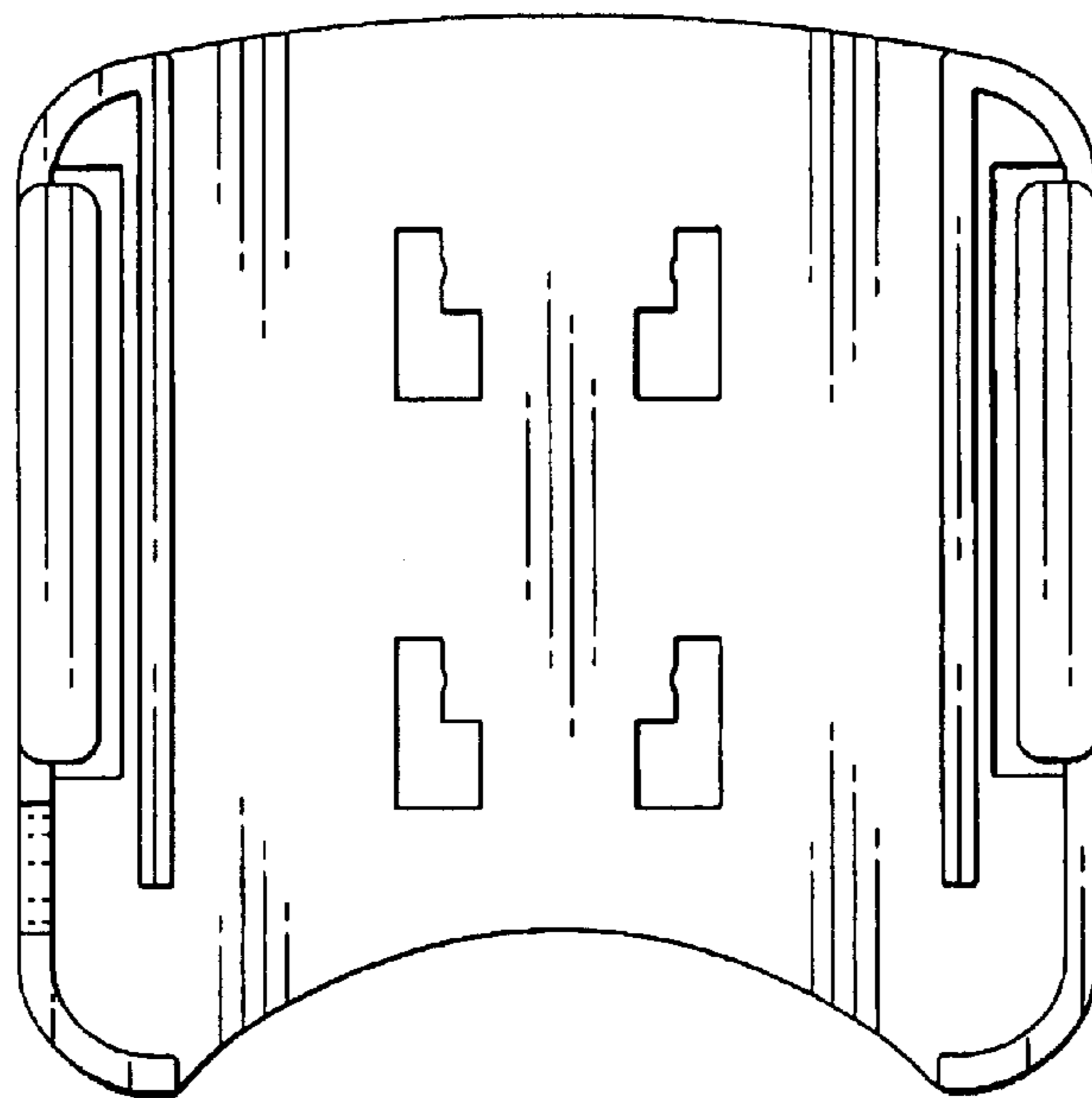

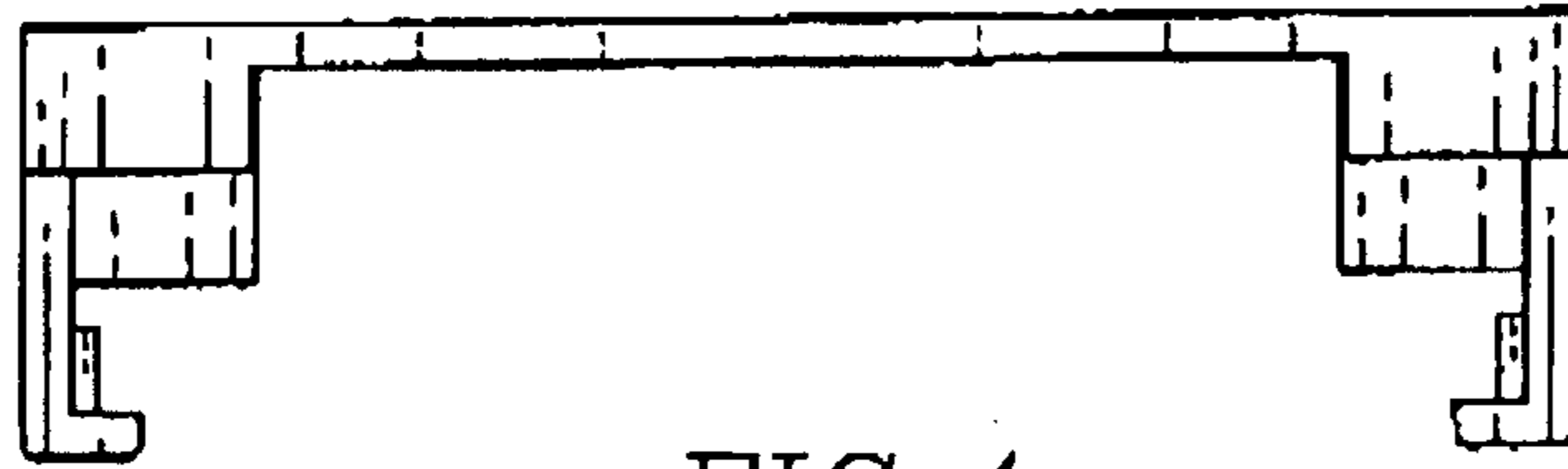

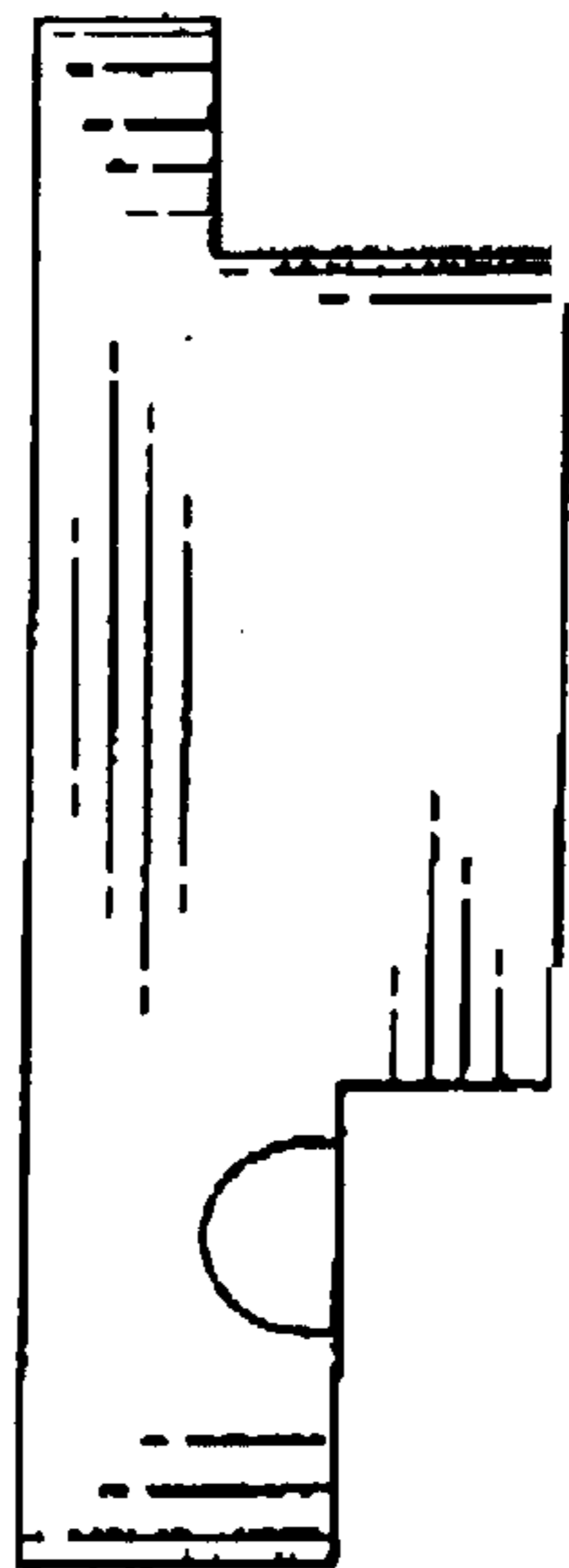

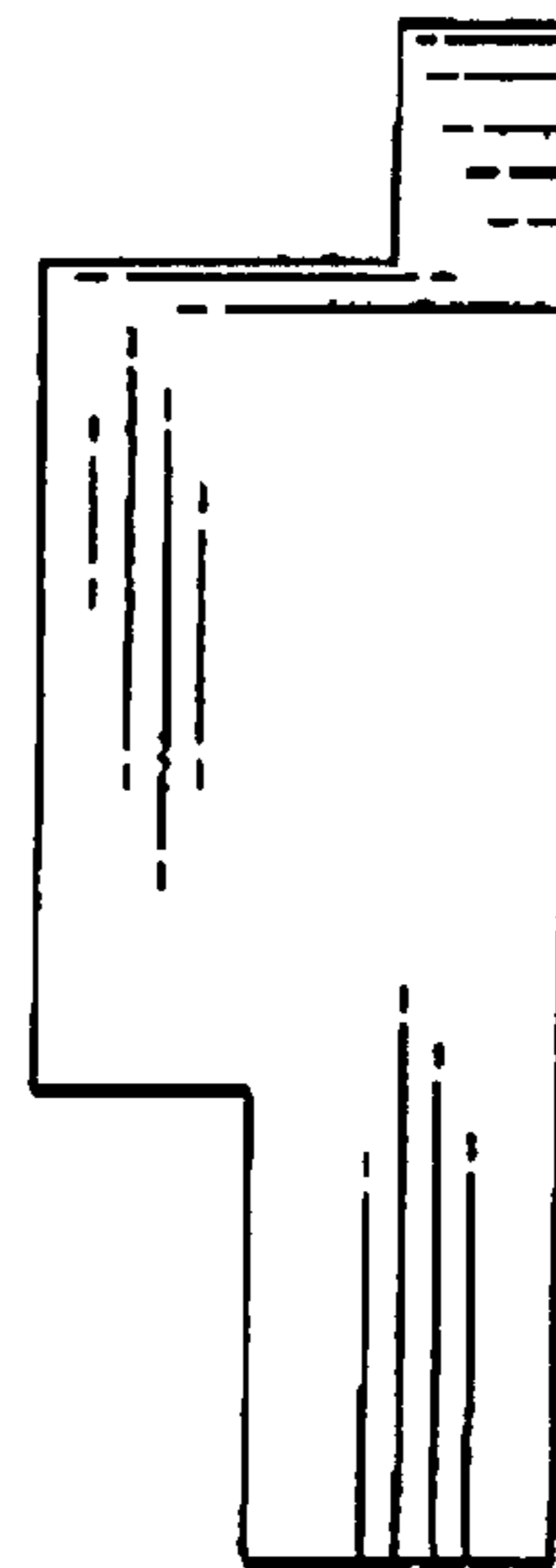
