**DESCRIPTION**

FIG. 7 is a bottom plan view thereof;

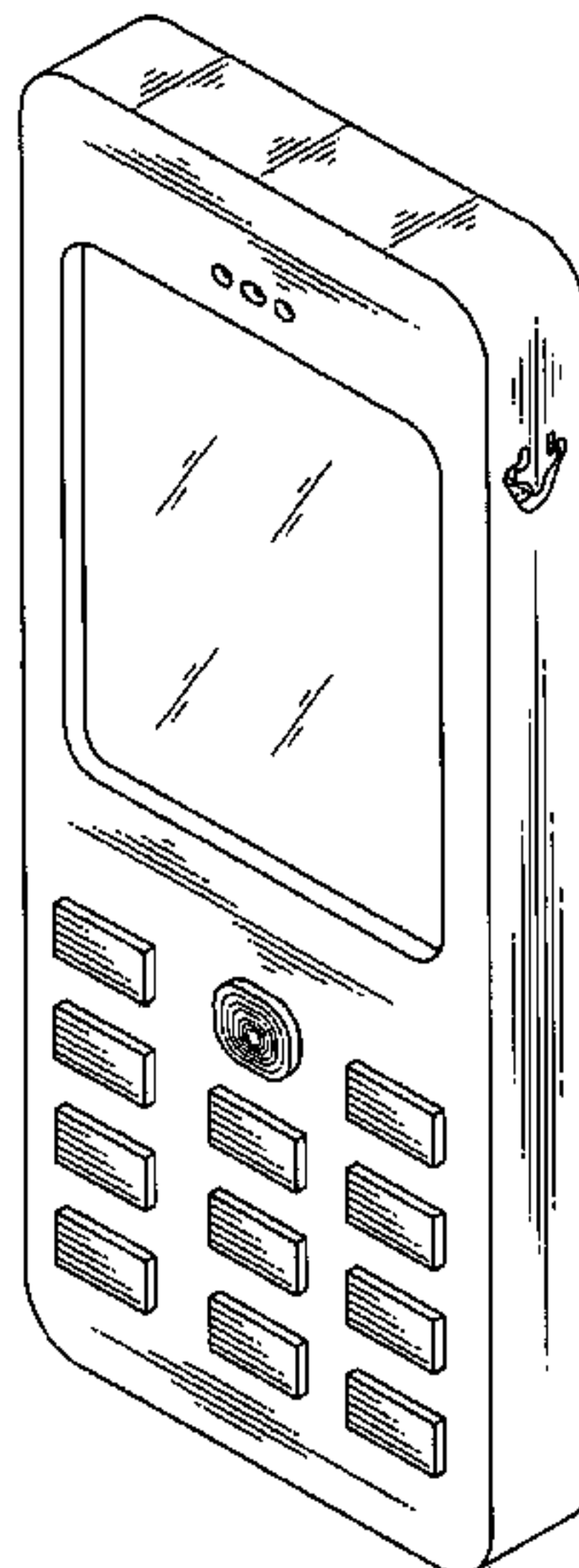
FIG. 8 is another perspective view of the portable electronic device in use;

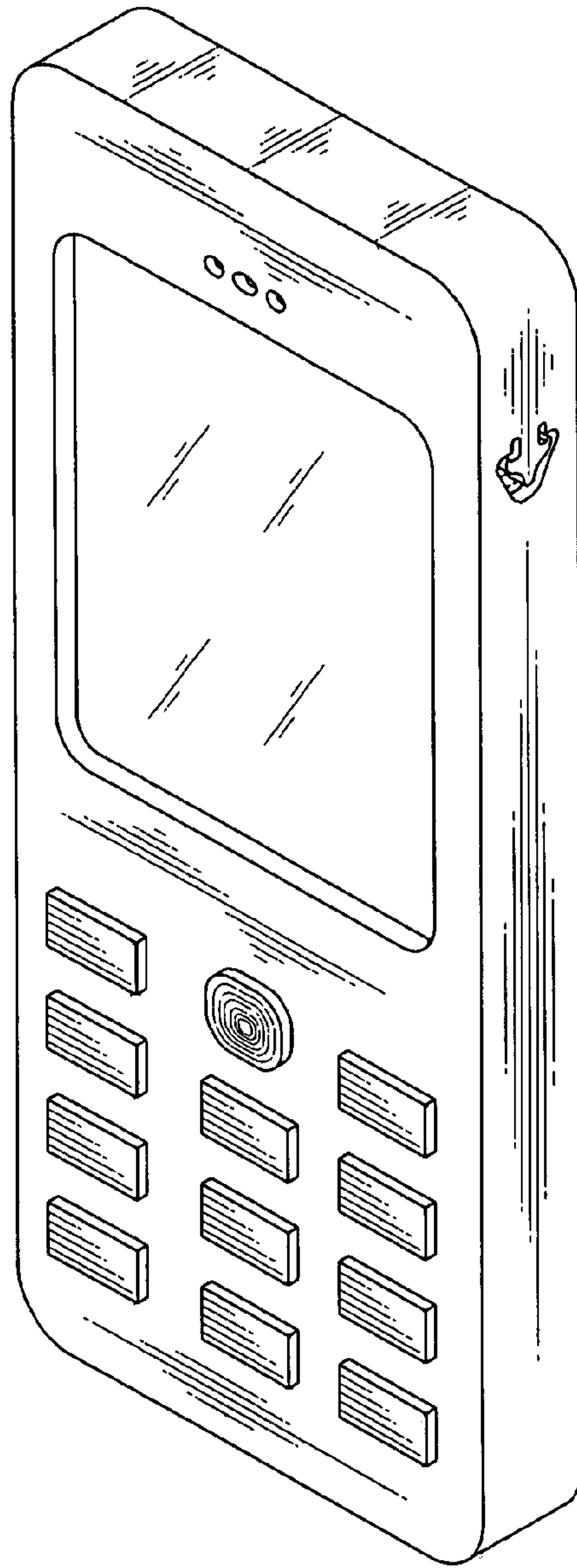

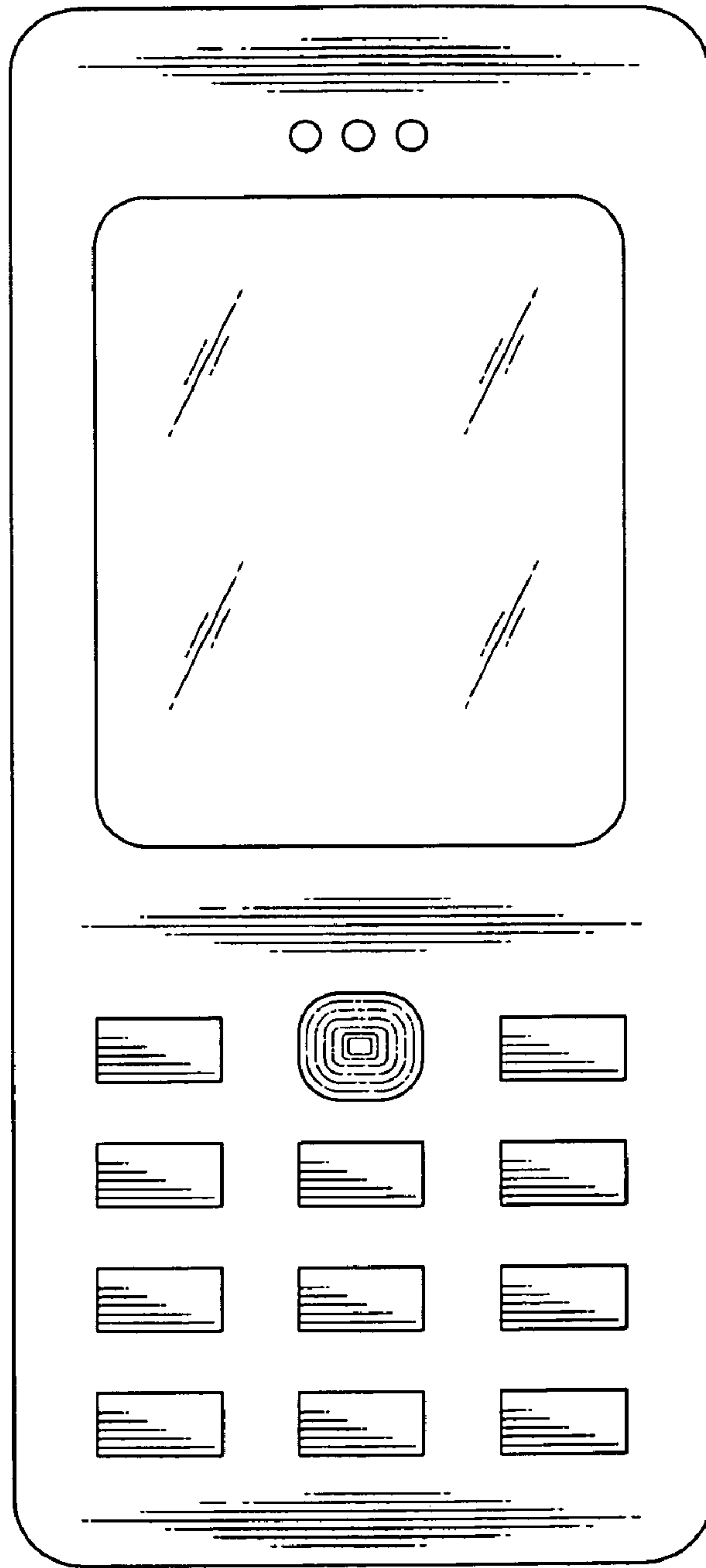

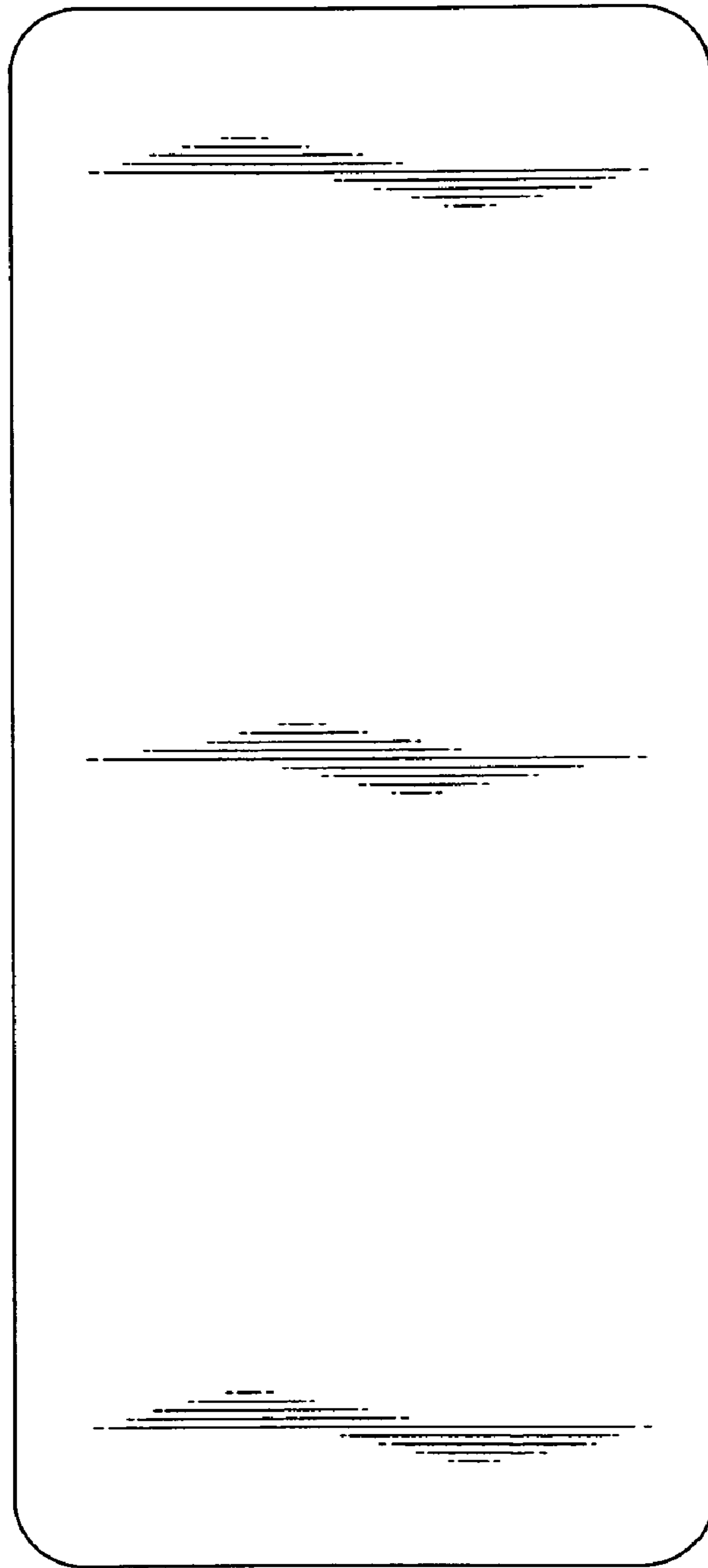

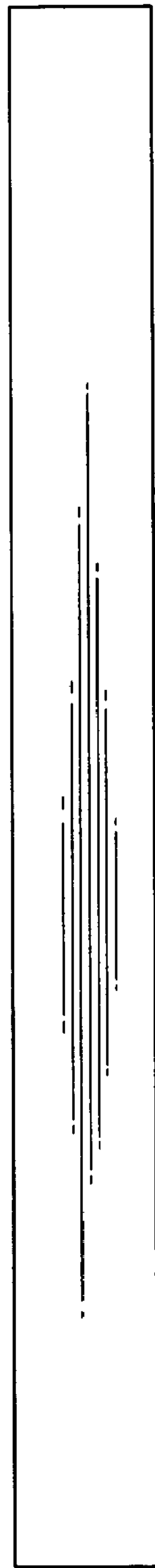

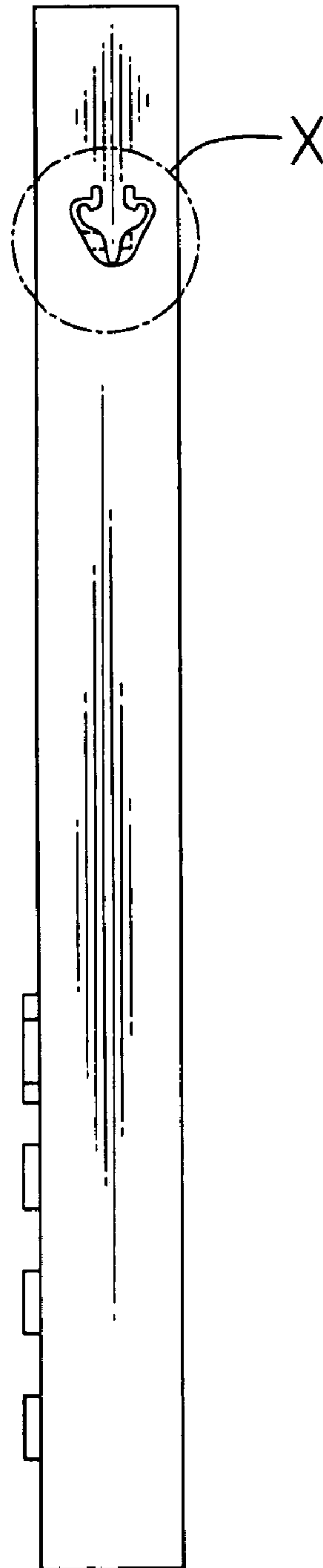

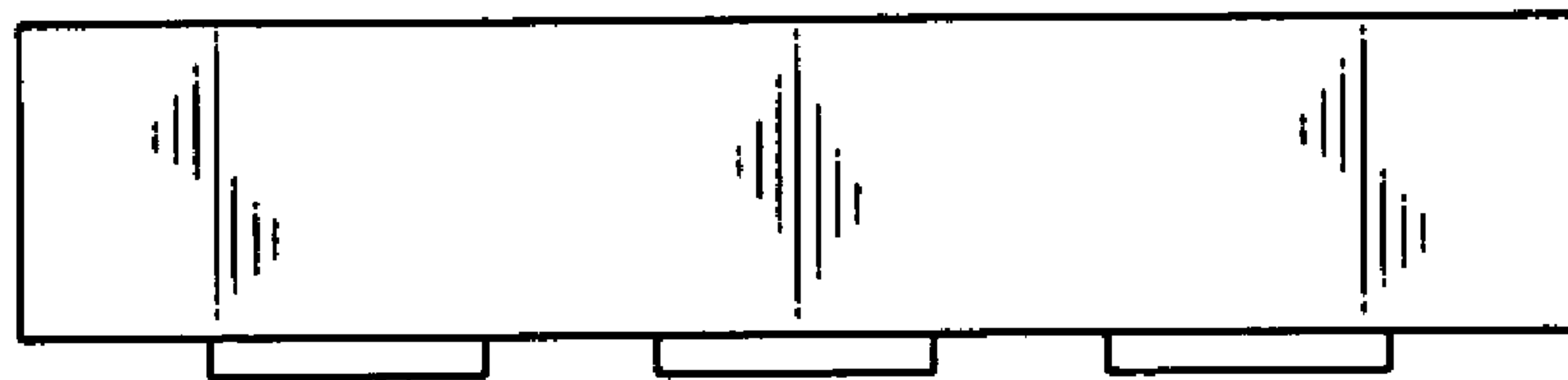

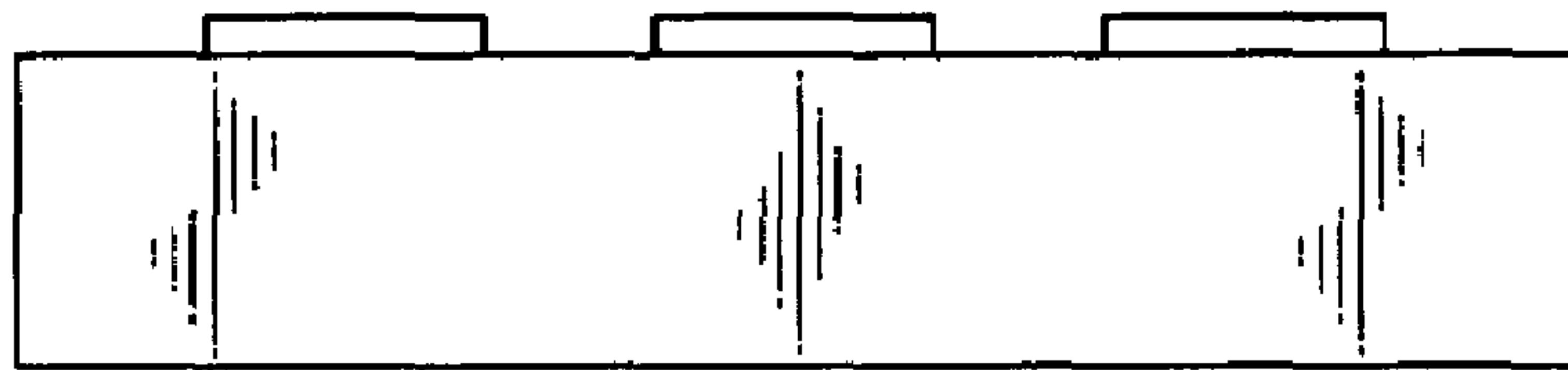

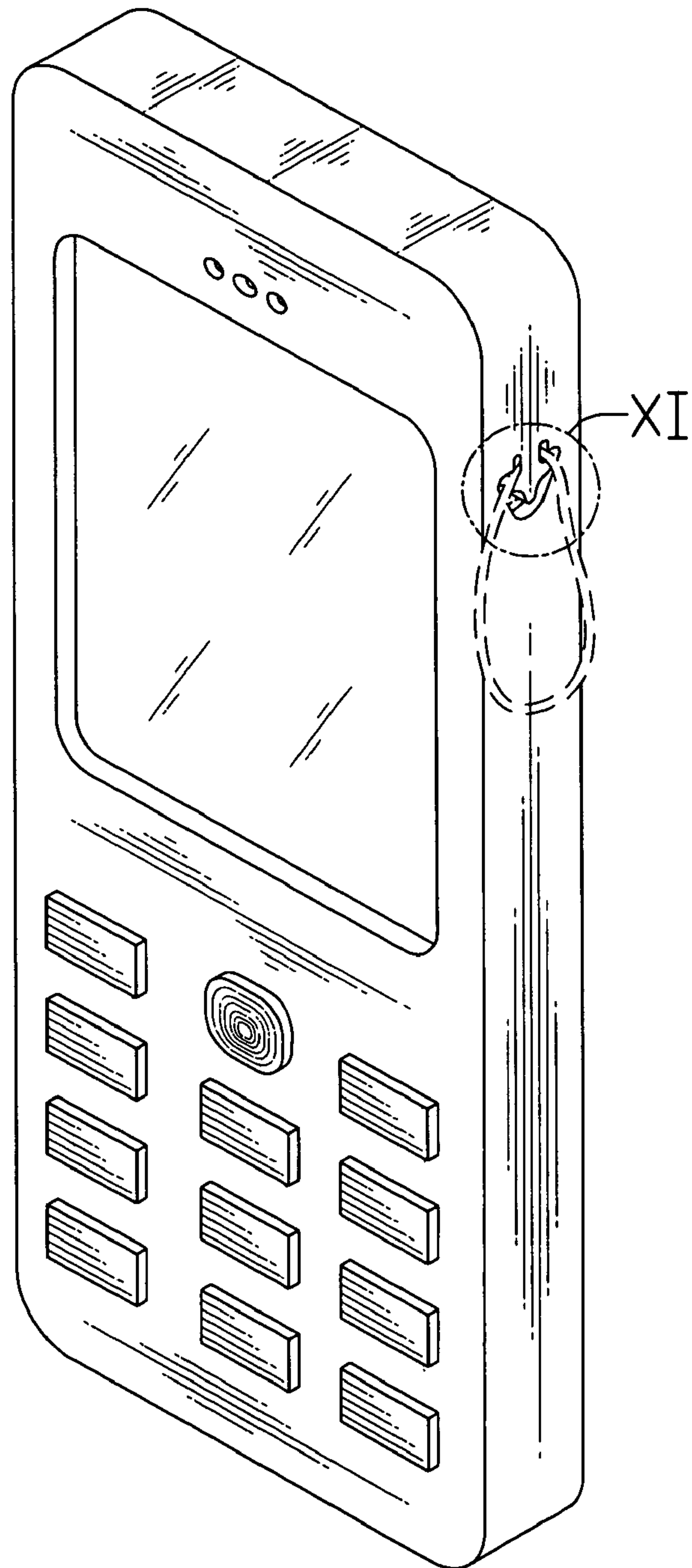

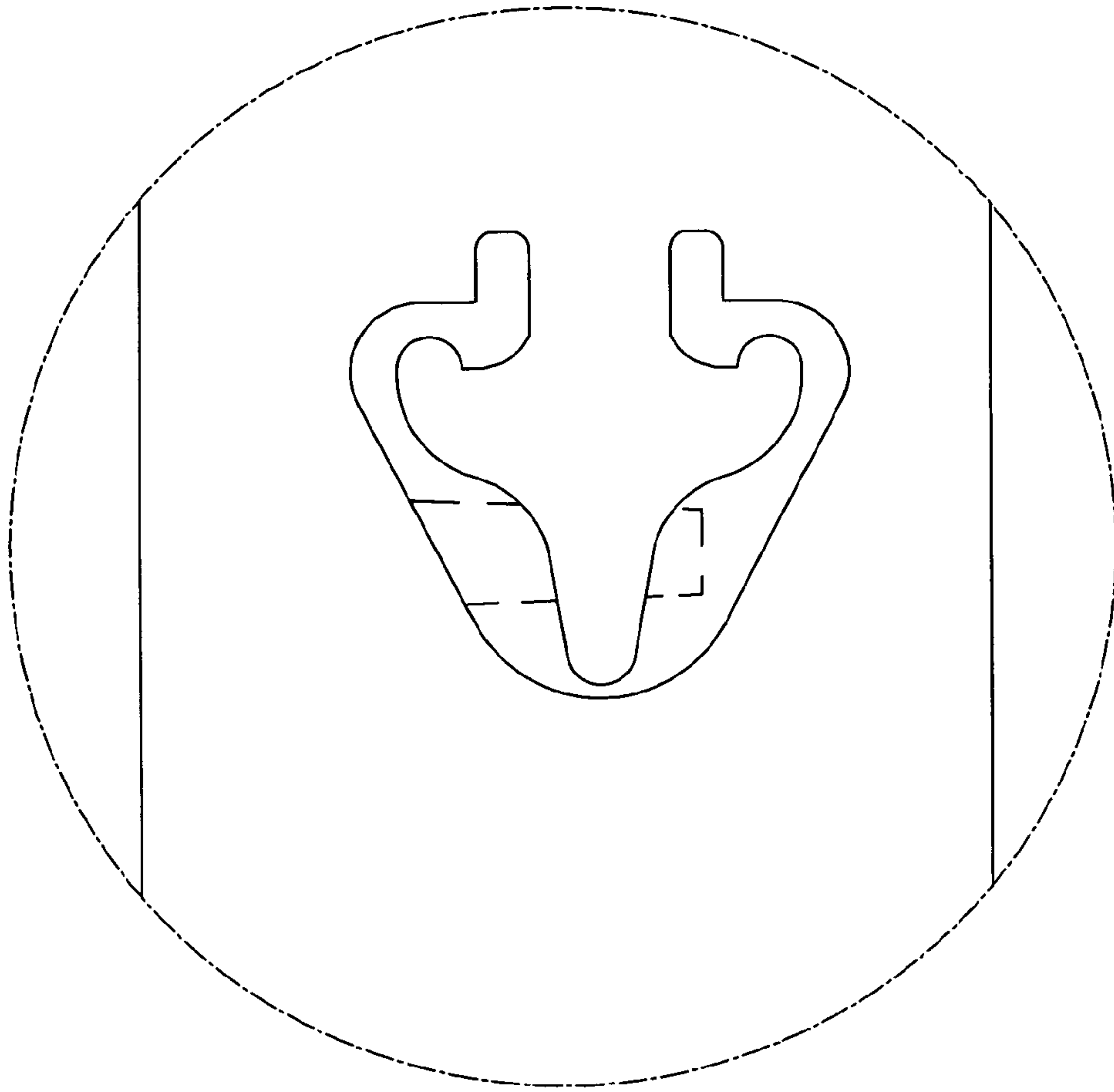

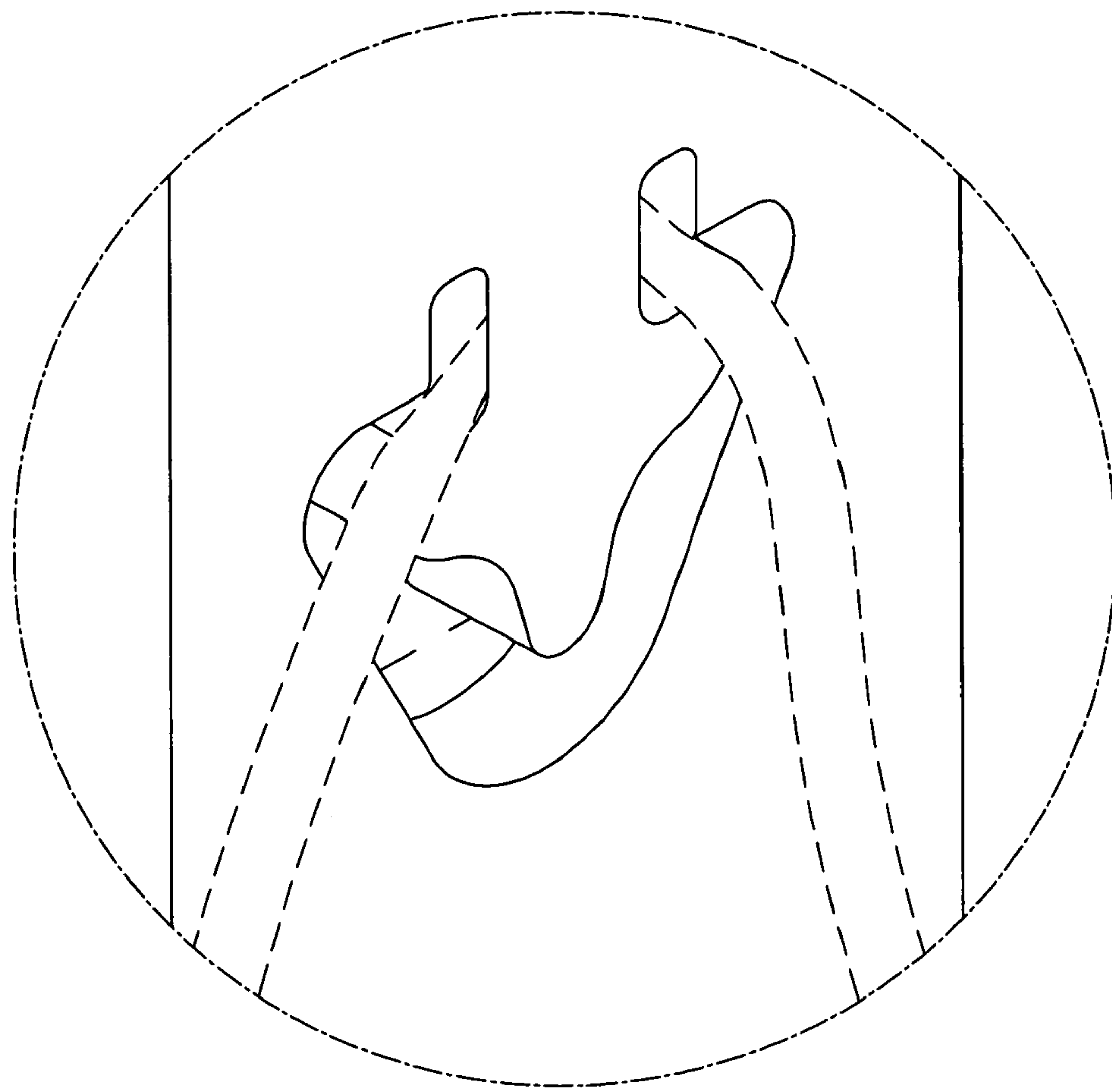
