(57) **CLAIM**

The ornamental design for a combination magnetic stripe and contactless card reader, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combination magnetic stripe and contactless card reader;

FIG. 2 is a front view of the combination magnetic stripe and contactless card reader;

FIG. 3 is a rear view of the combination magnetic stripe and contactless card reader;

FIG. 4 is a left side view of the combination magnetic stripe and contactless card reader;

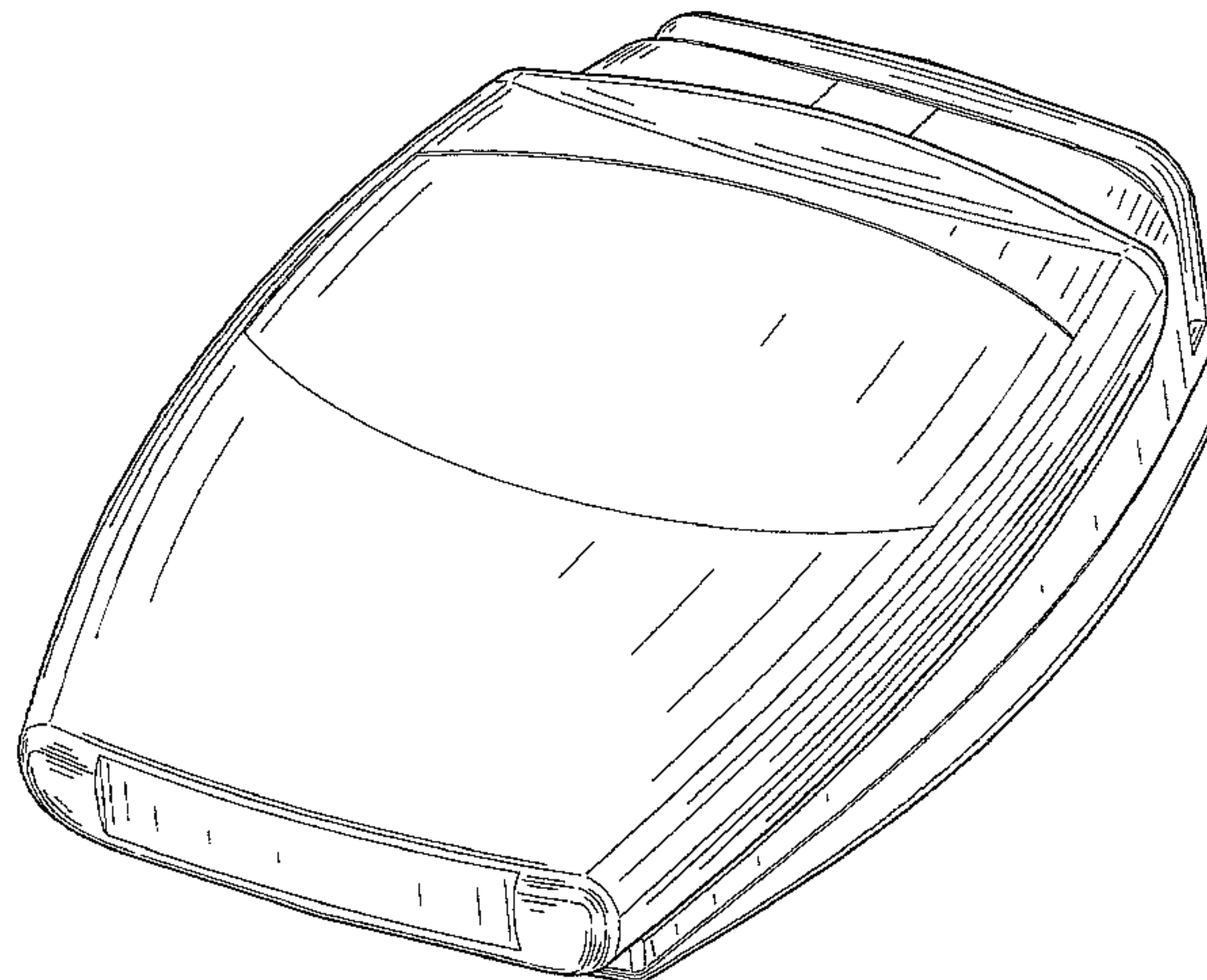
FIG. 5 is a right side view of the combination magnetic stripe and contactless card reader;

FIG. 6 is a top view of the combination magnetic stripe and contactless card reader; and,

FIG. 7 is a bottom view of the combination magnetic stripe and contactless card reader.

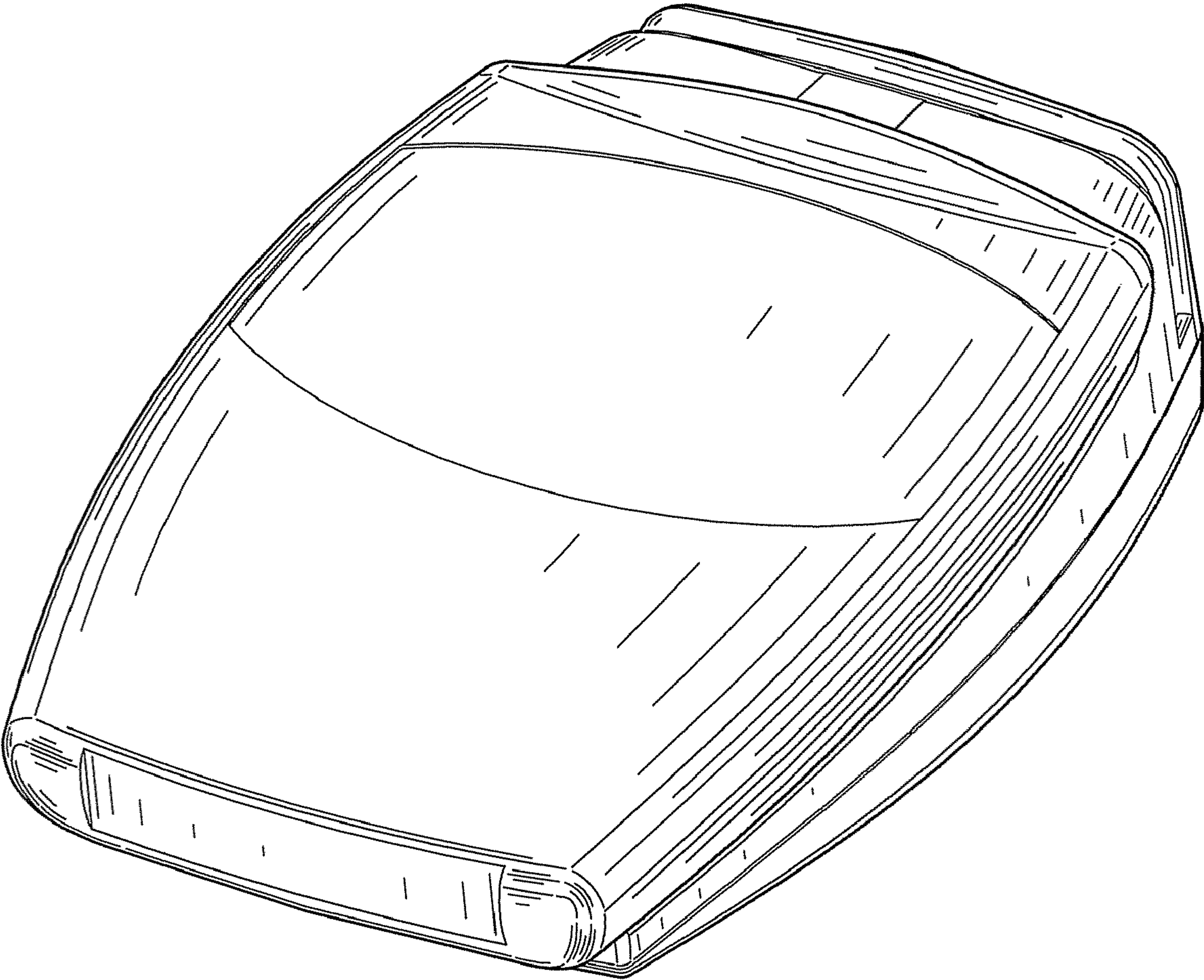

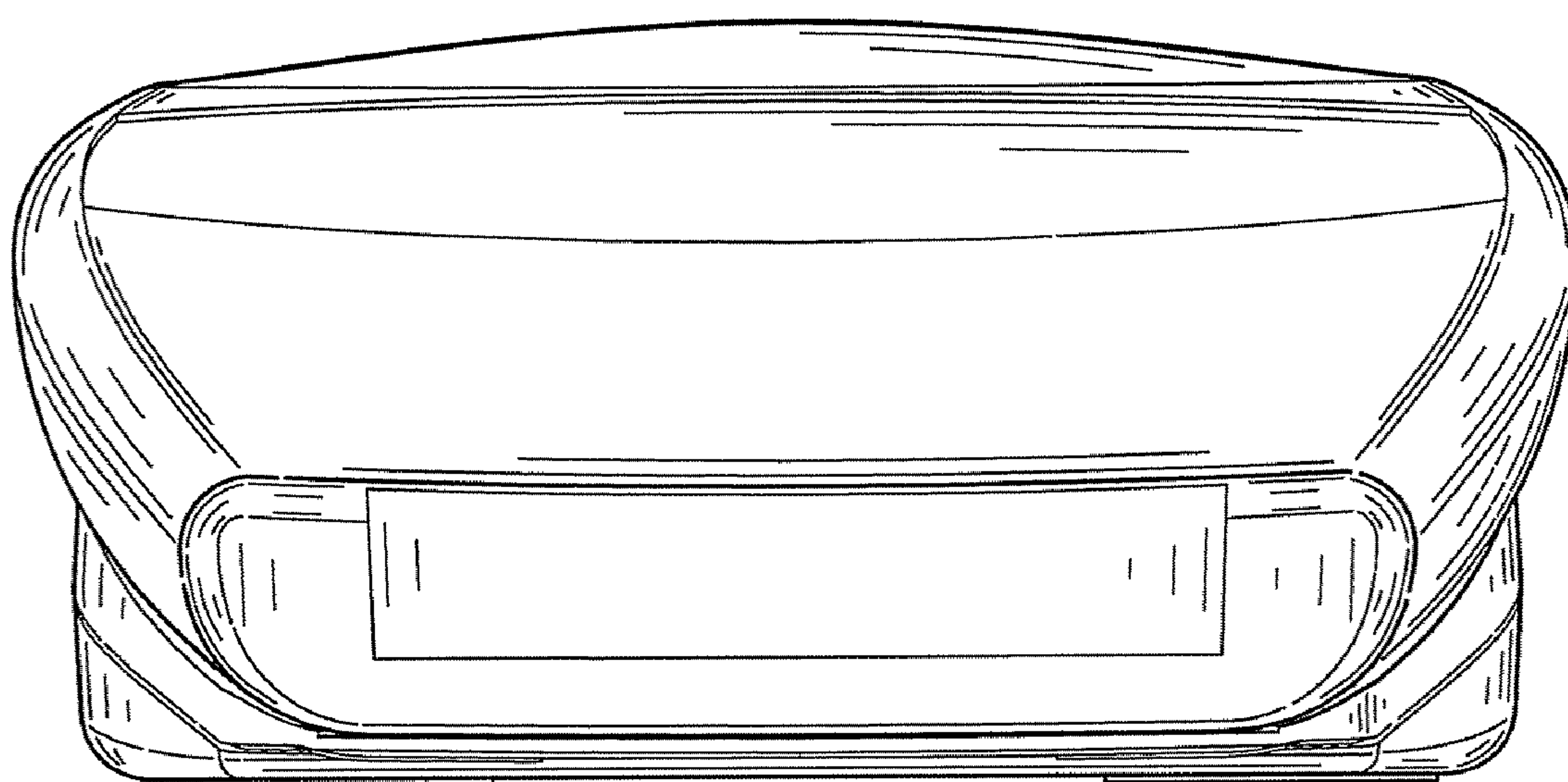

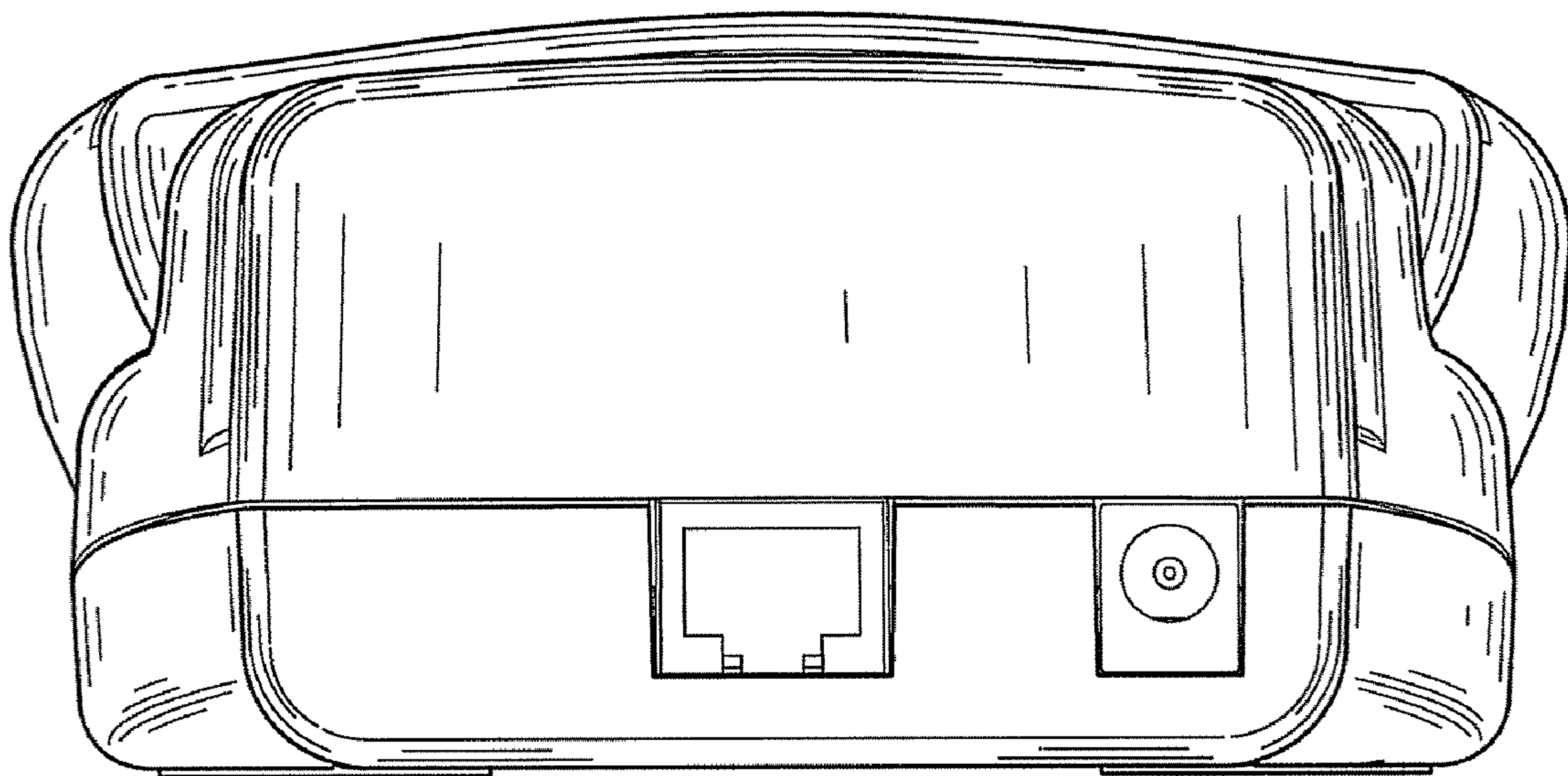

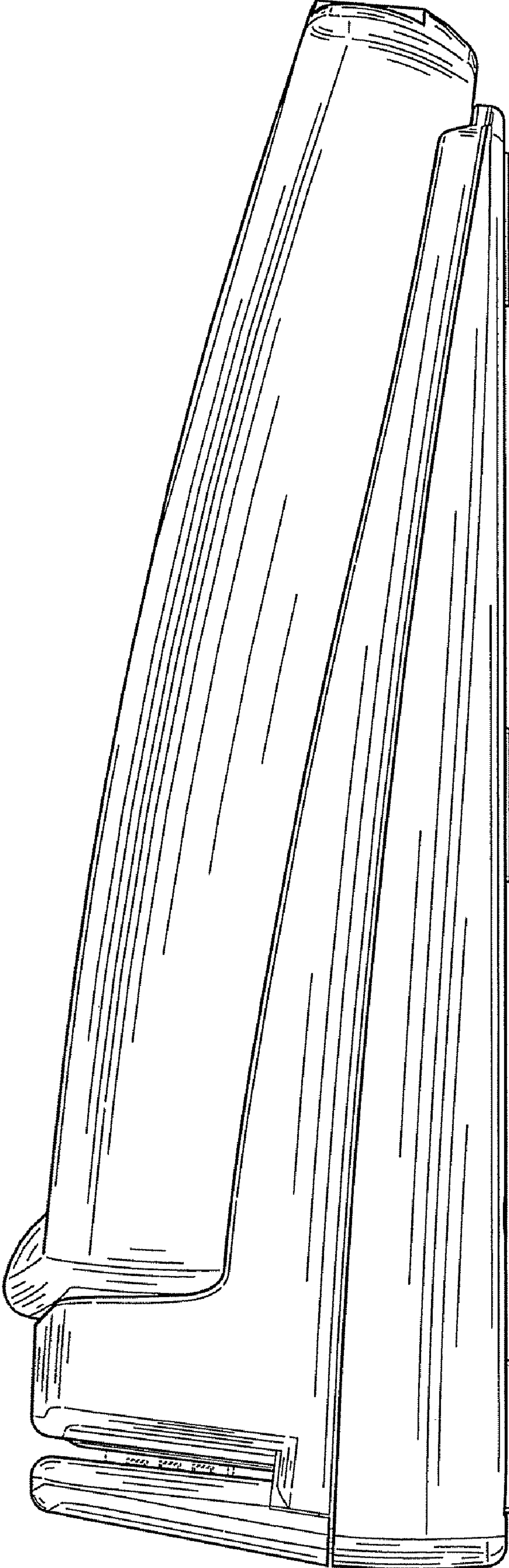

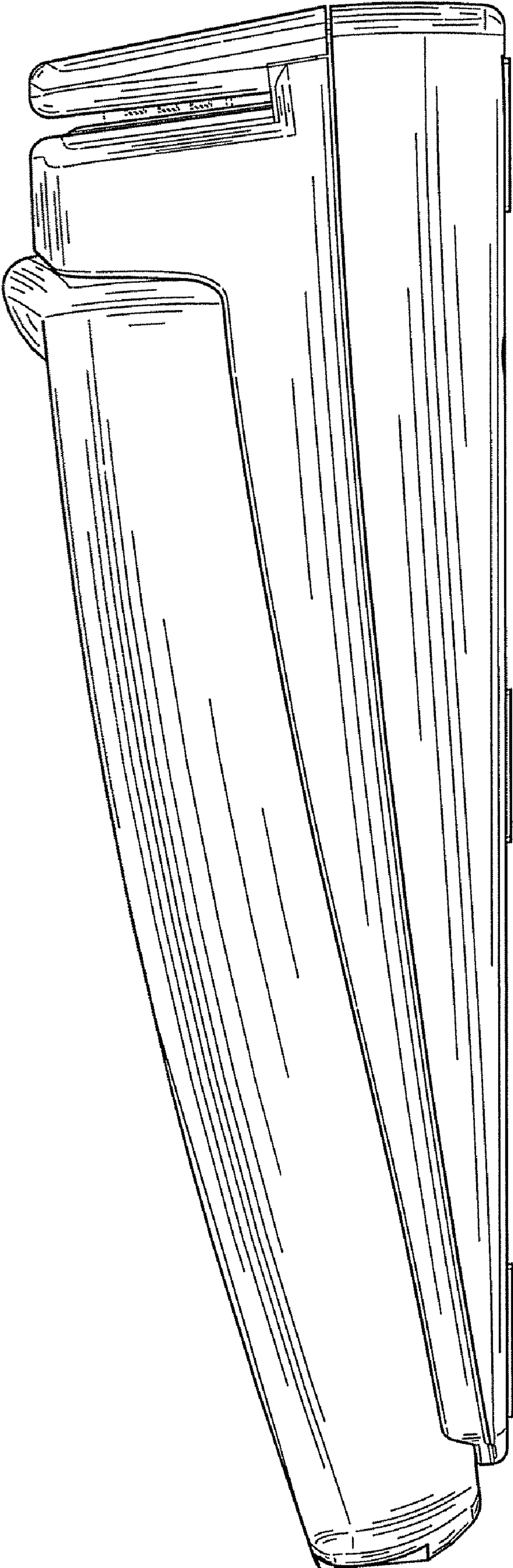

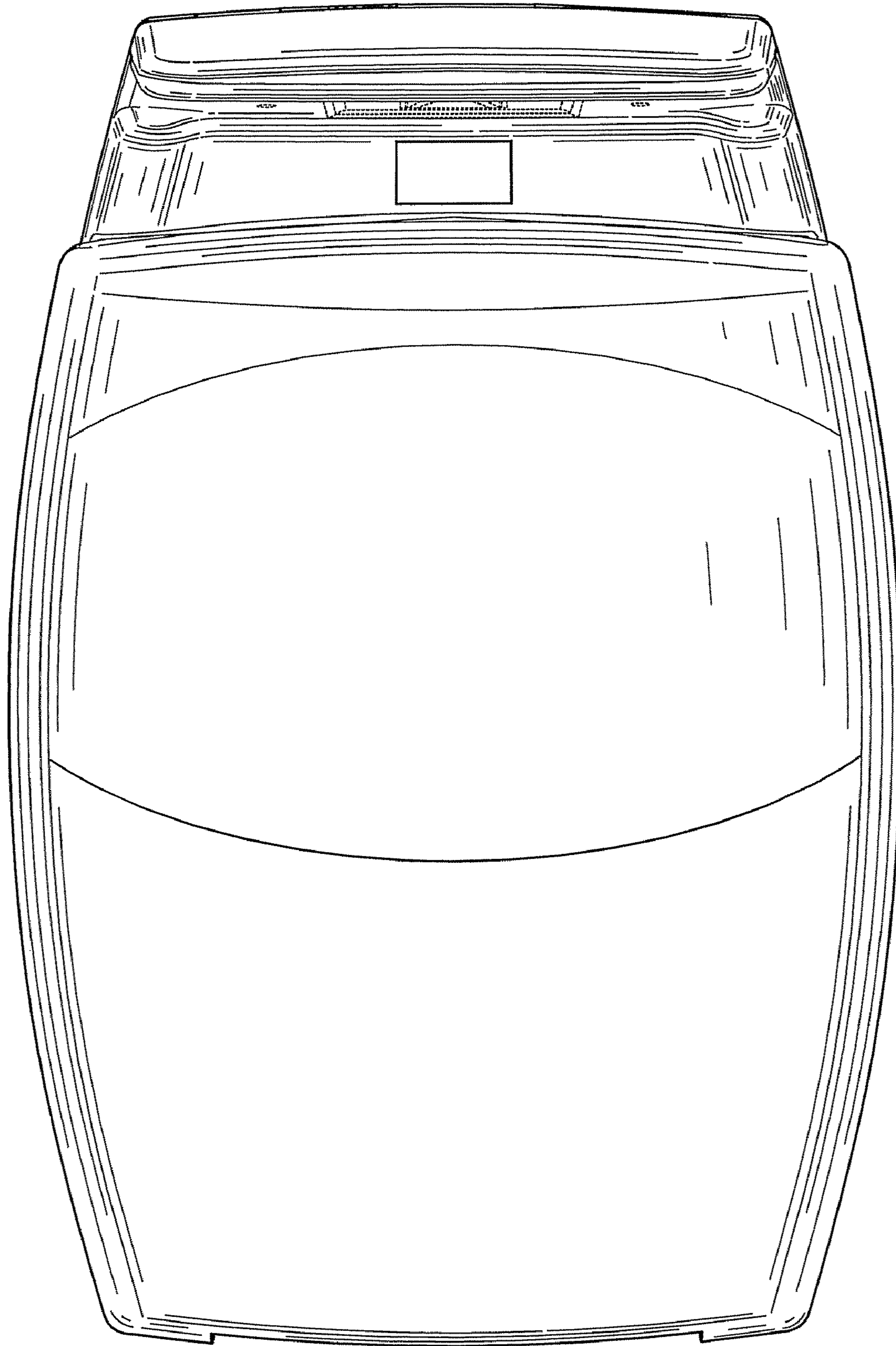

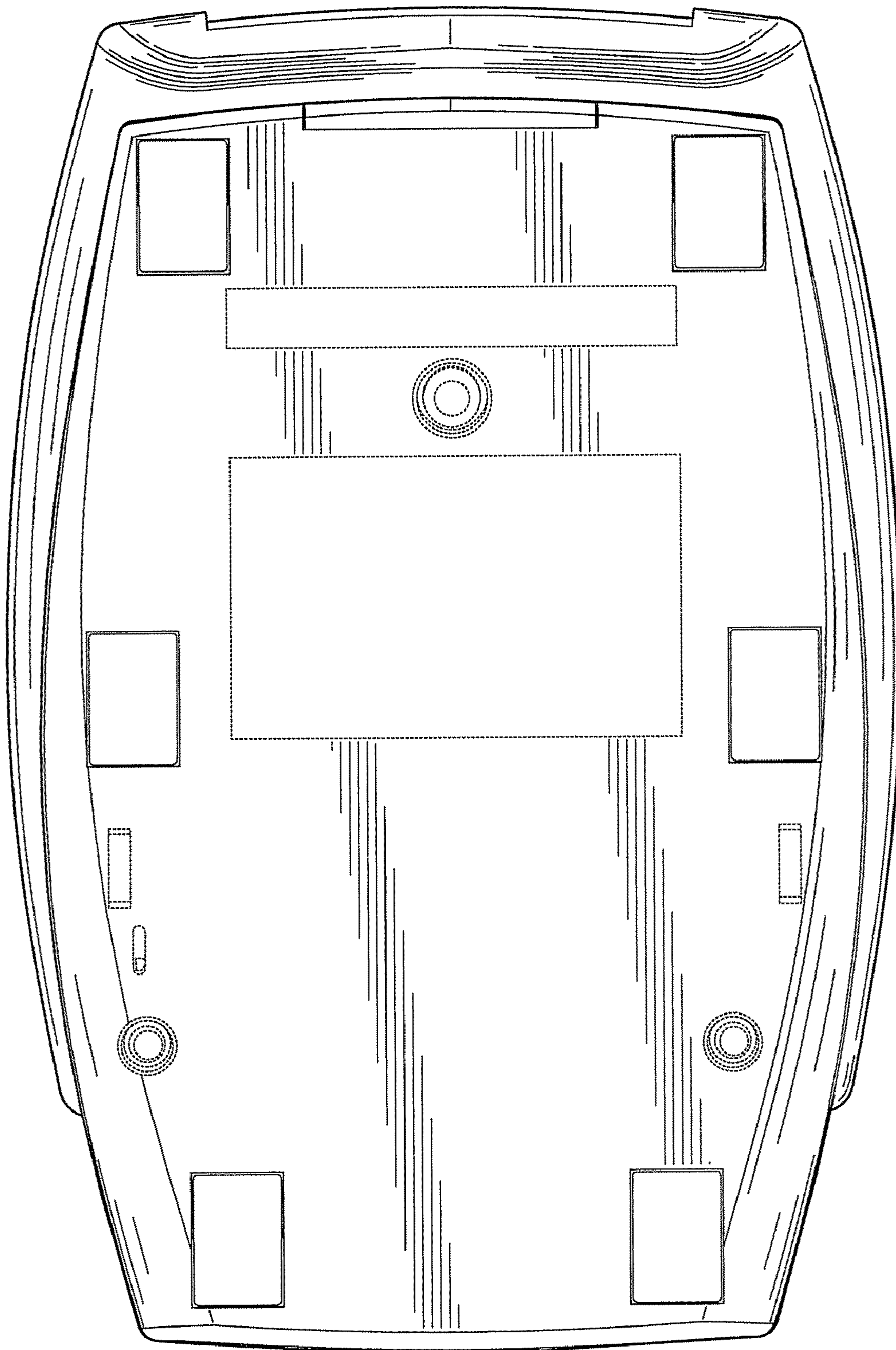
