(57) **CLAIM**

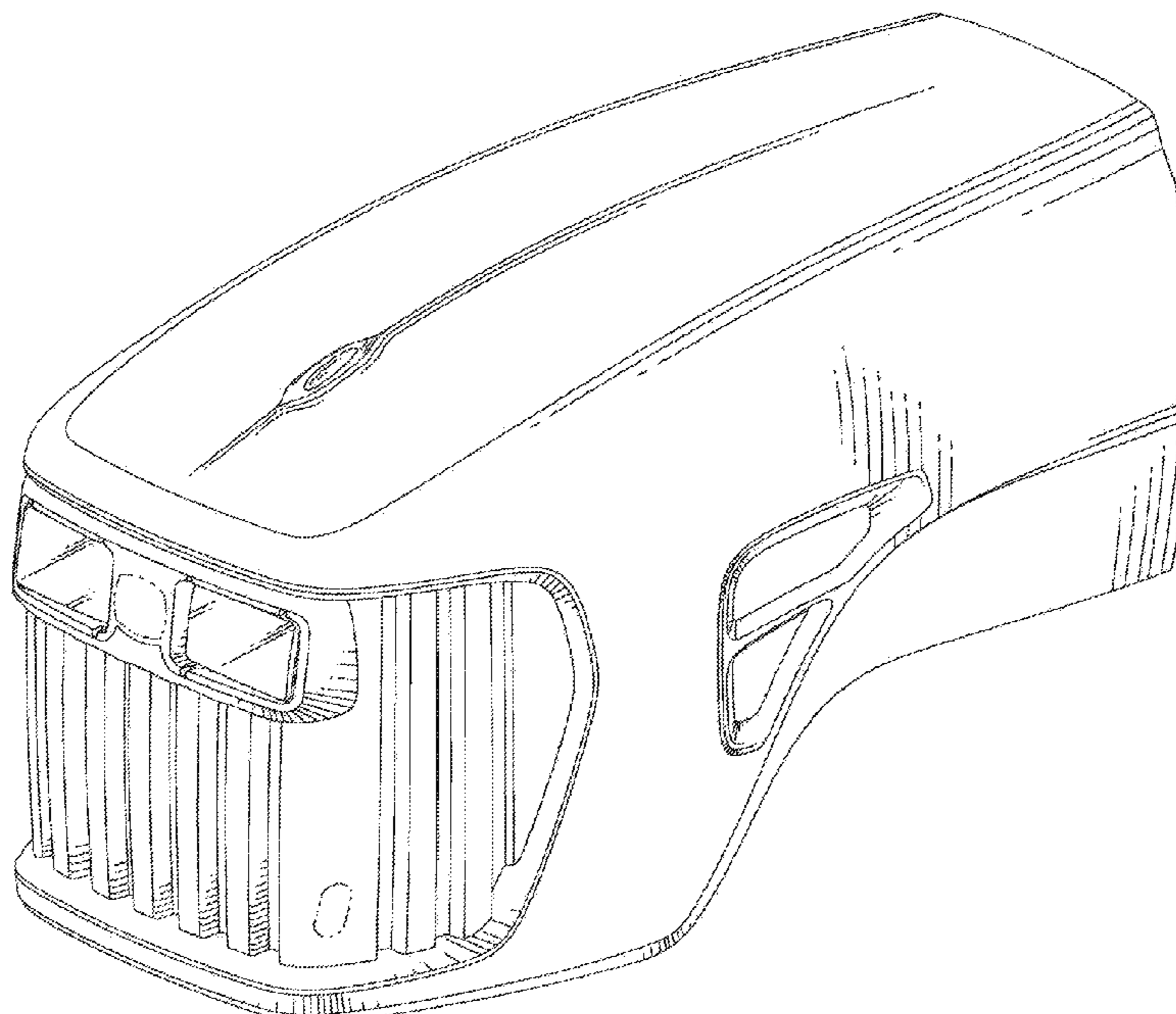
The ornamental design for a tractor engine enclosure, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the tractor engine enclosure showing our new design;  
 FIG. 2 is a side view thereof;  
 FIG. 3 is an opposite side view thereof;  
 FIG. 4 is a front view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a top view thereof; and,  
 FIG. 7 is a bottom view thereof.

The broken line showing in FIG. 5 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

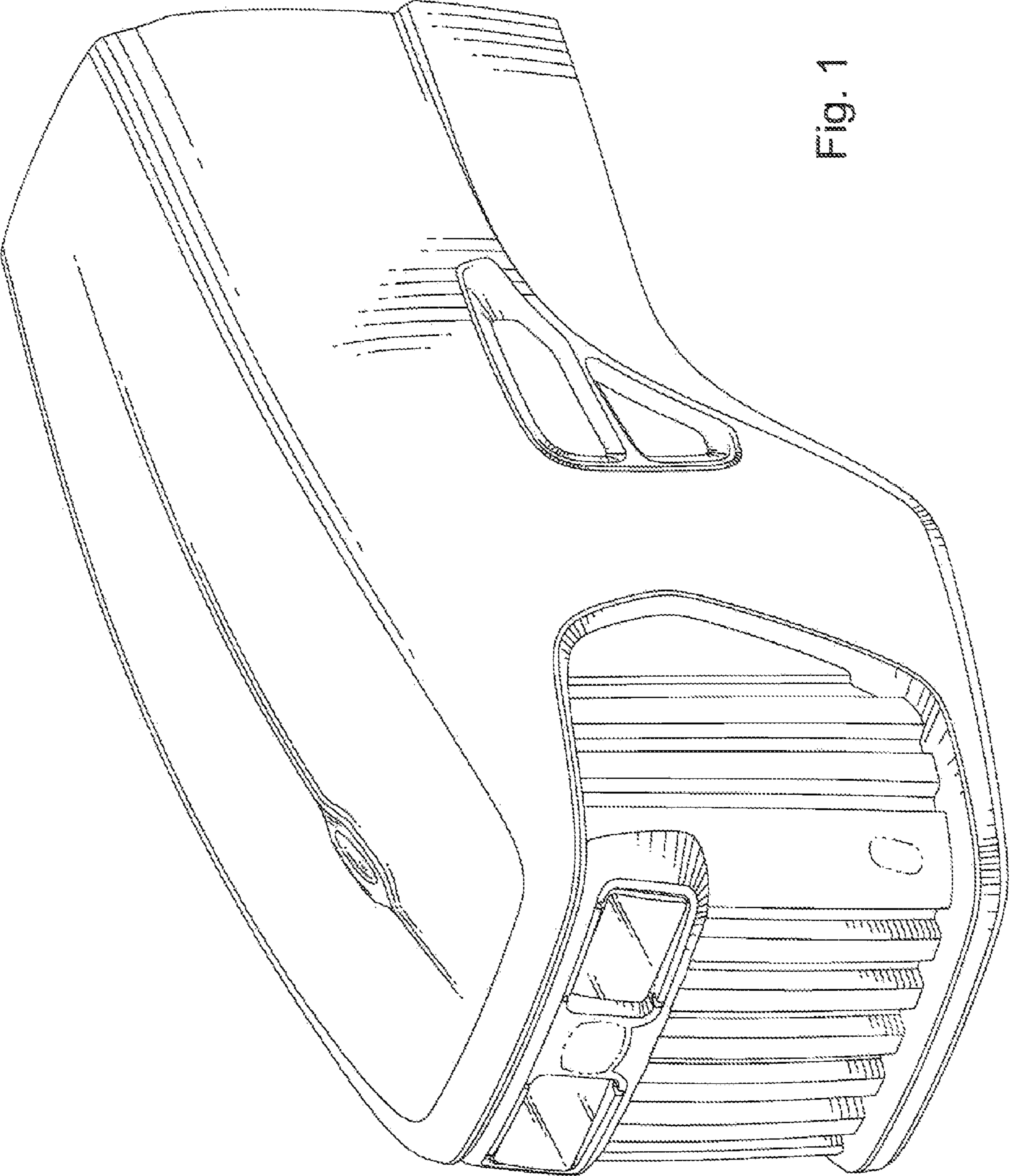

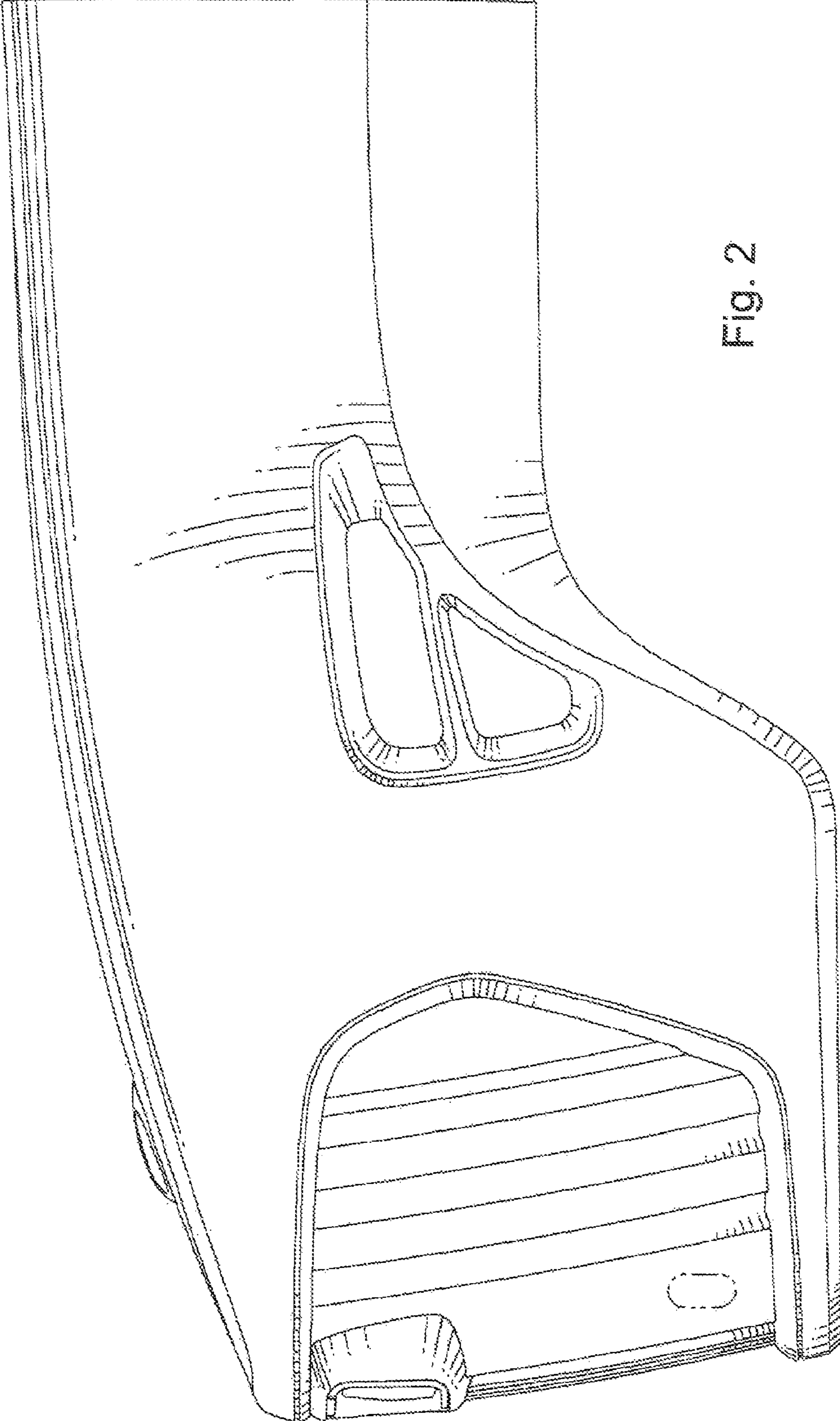

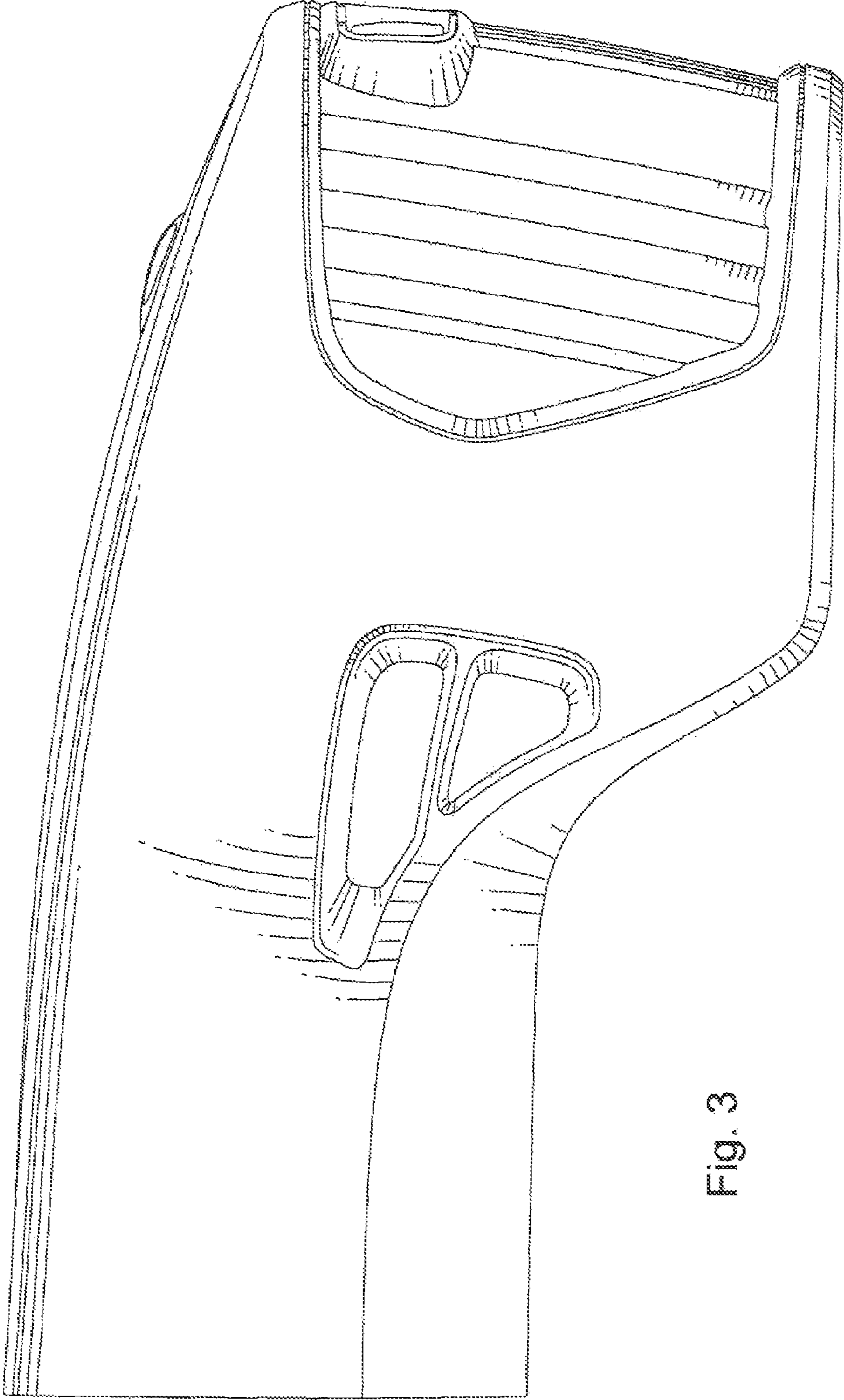

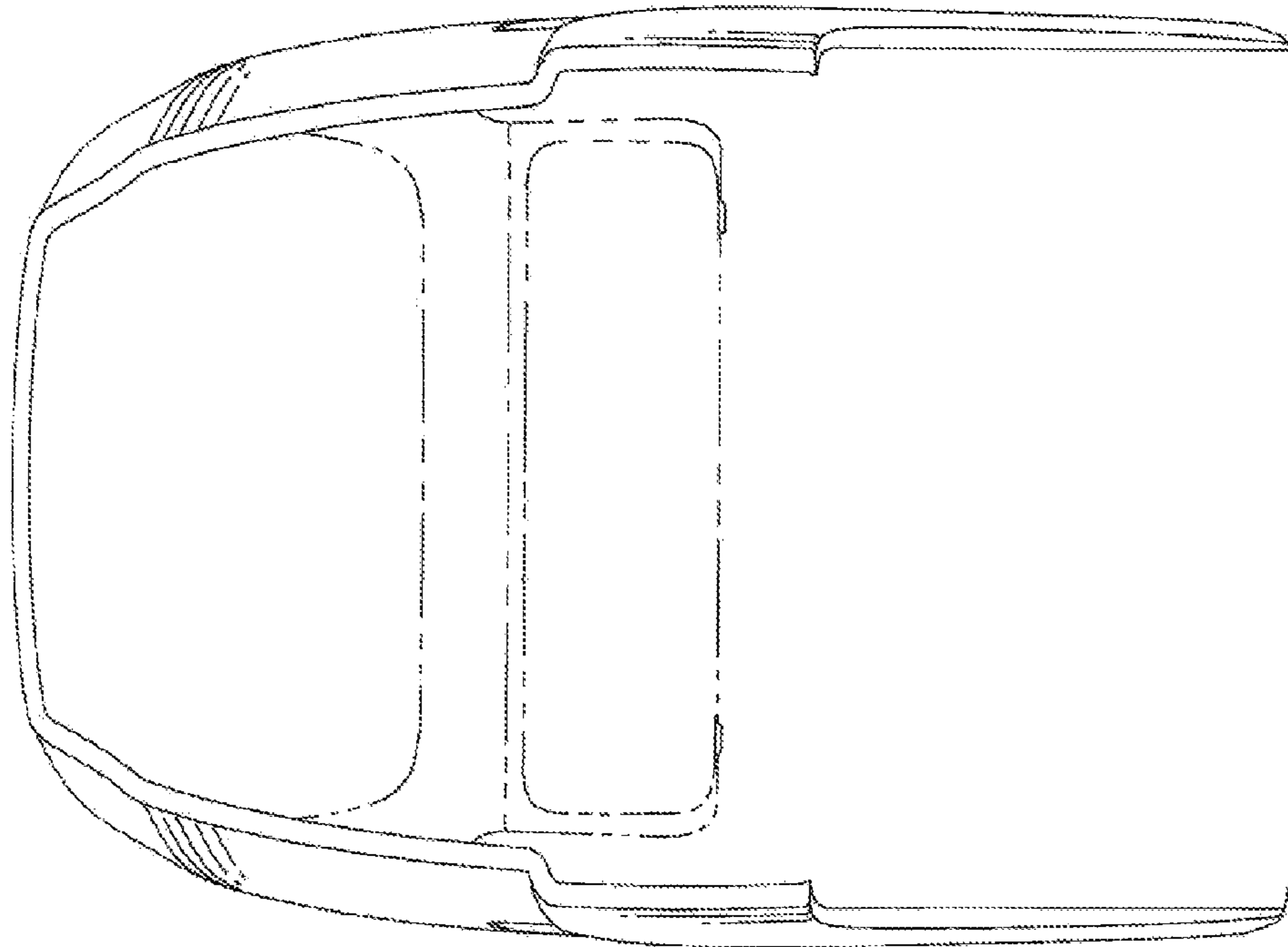

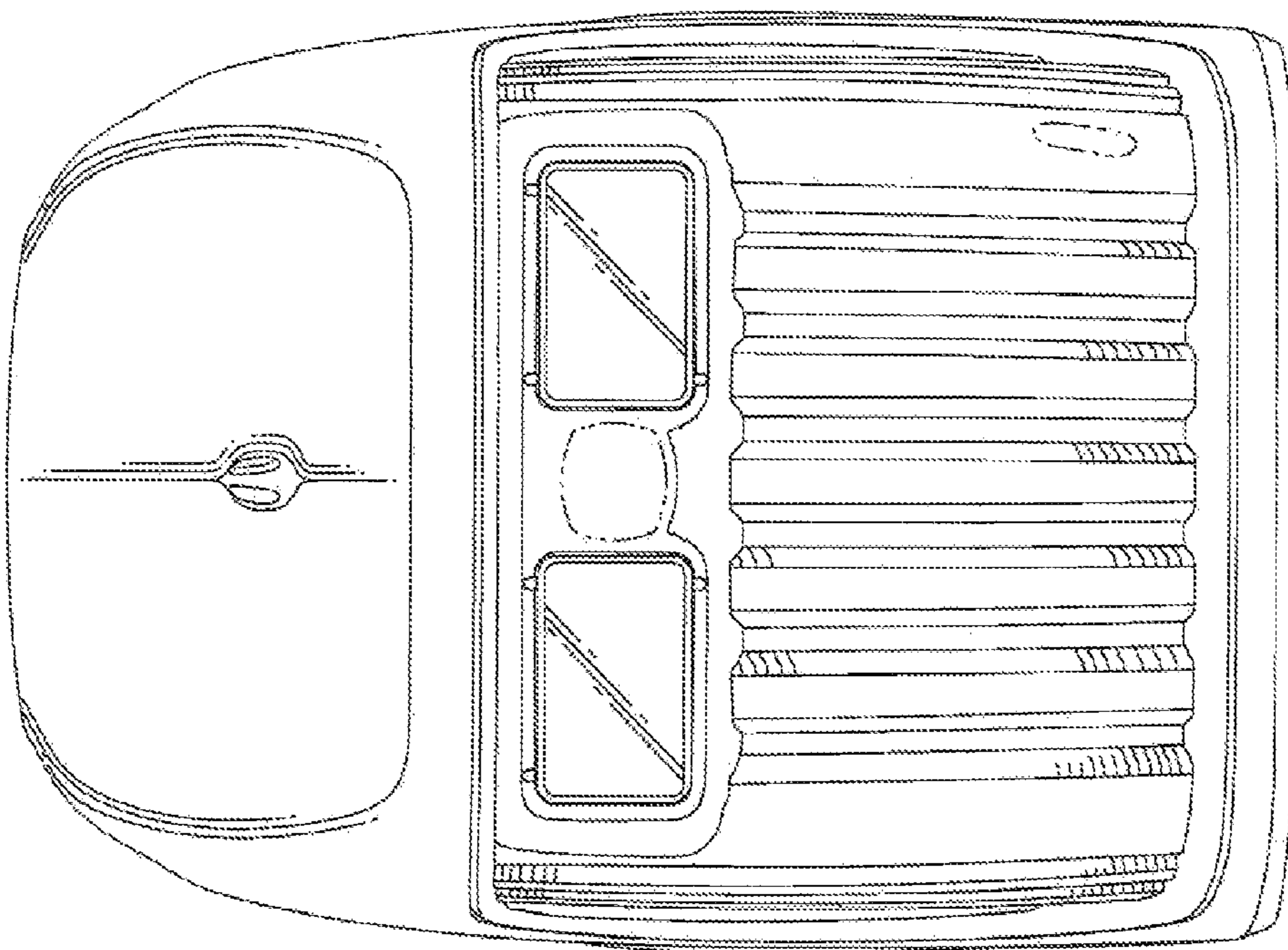

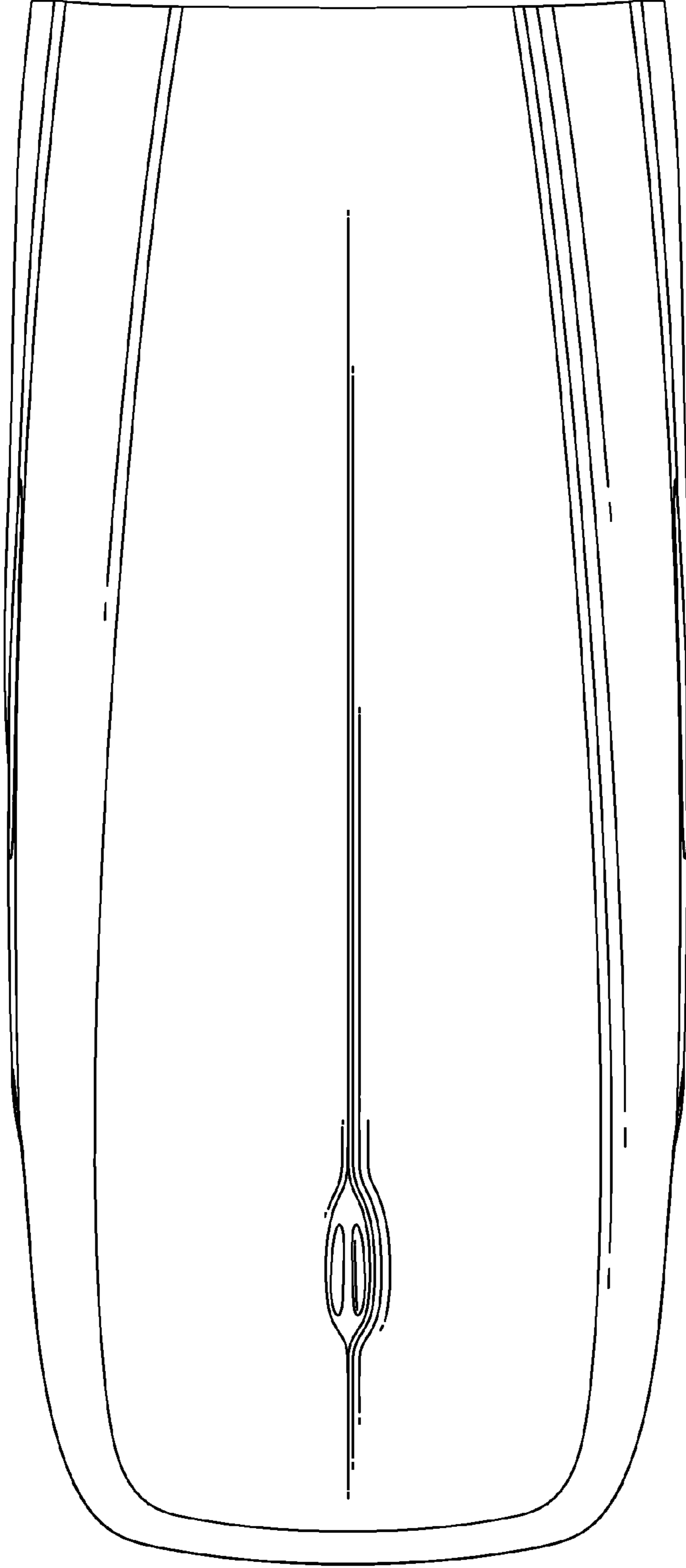

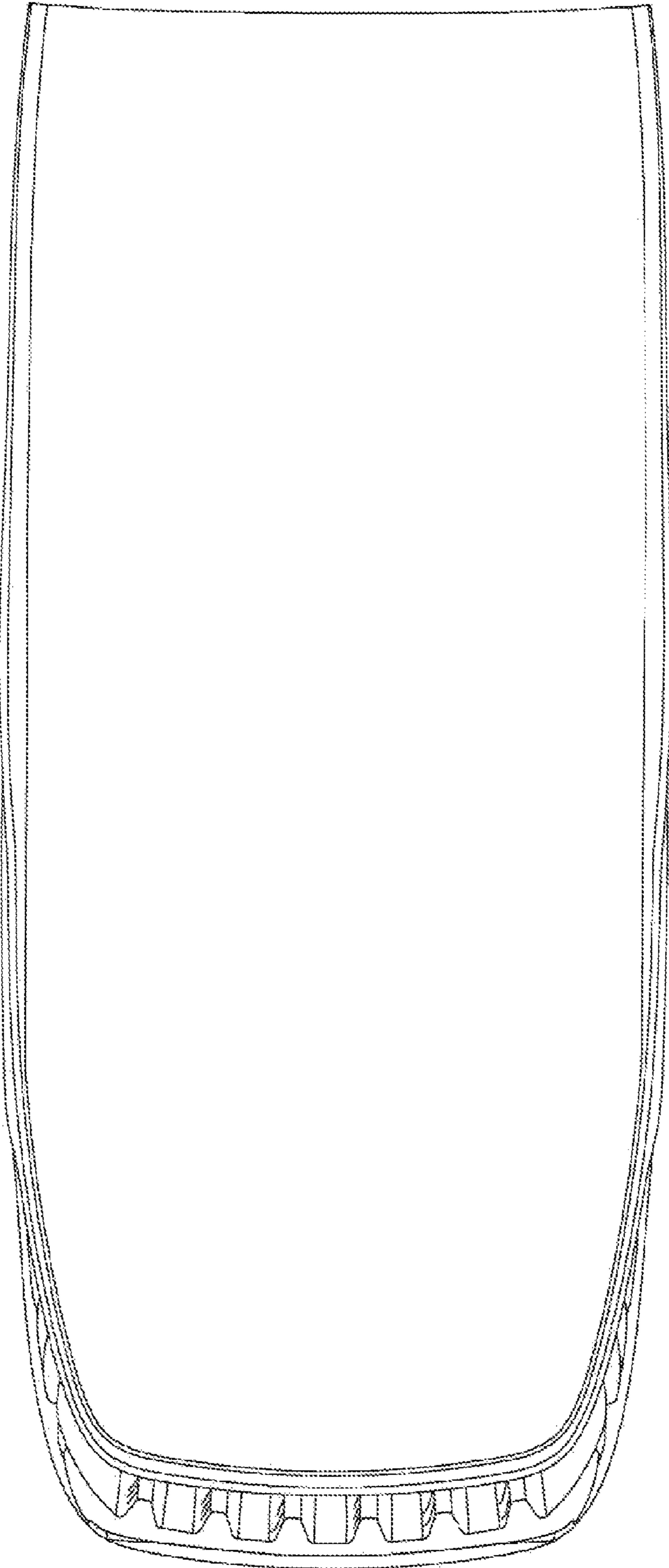
