The ornamental design for chair for rollercoaster, as shown and described.


**DESCRIPTION**

FIG. 1 is a perspective view of the embodiment of the chair for rollercoaster design of the present invention;


FIG. 2 is a front view of the embodiment of the chair for rollercoaster design of the present invention;

FIG. 3 is a side view of the embodiment of the chair for rollercoaster design of the present invention; and,


FIG. 4 is a top plan view of the embodiment of the chair for rollercoaster design of the present invention.




