FIG. 4 is a bottom plan view of the dispenser of FIG. 1.

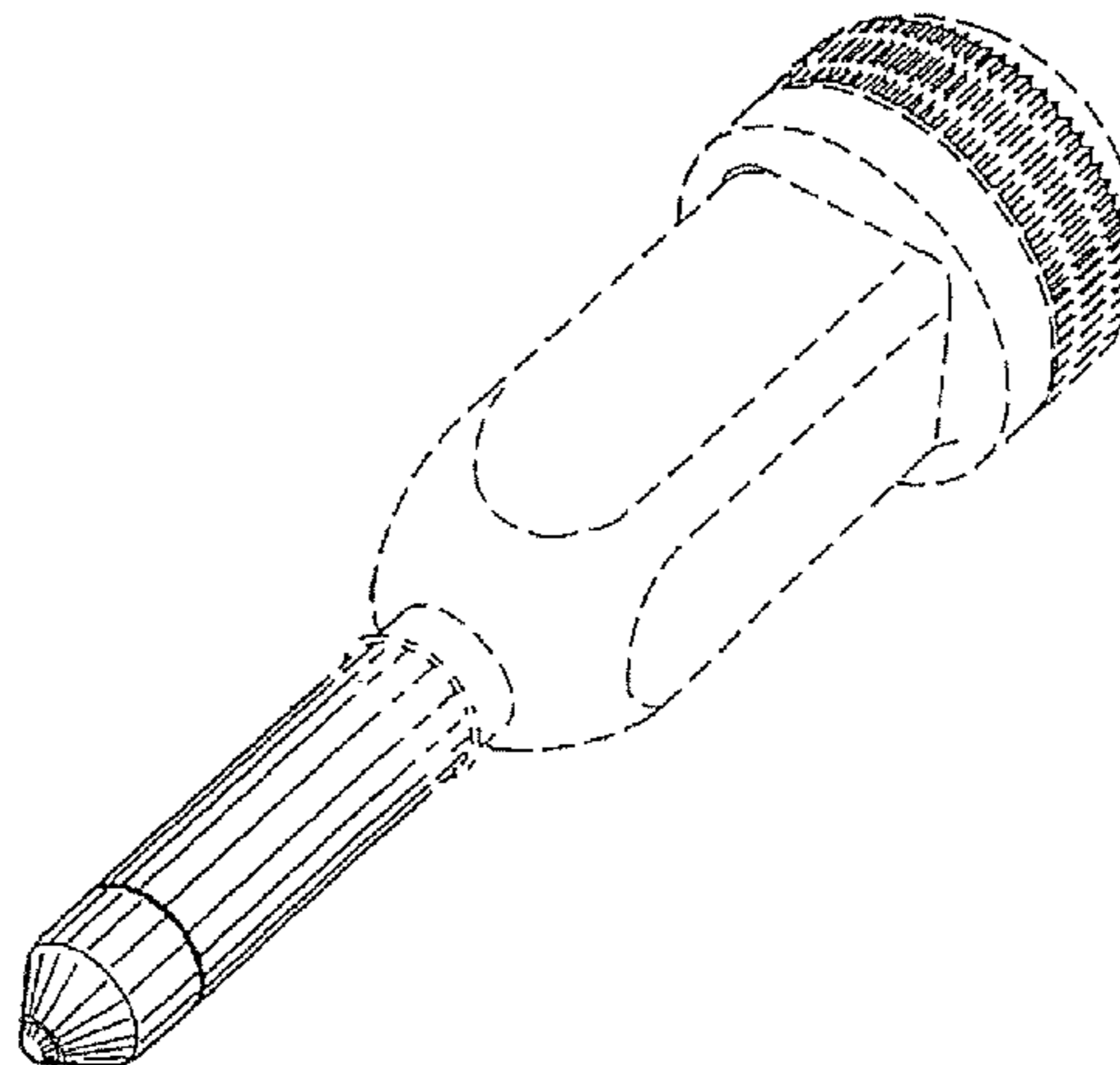

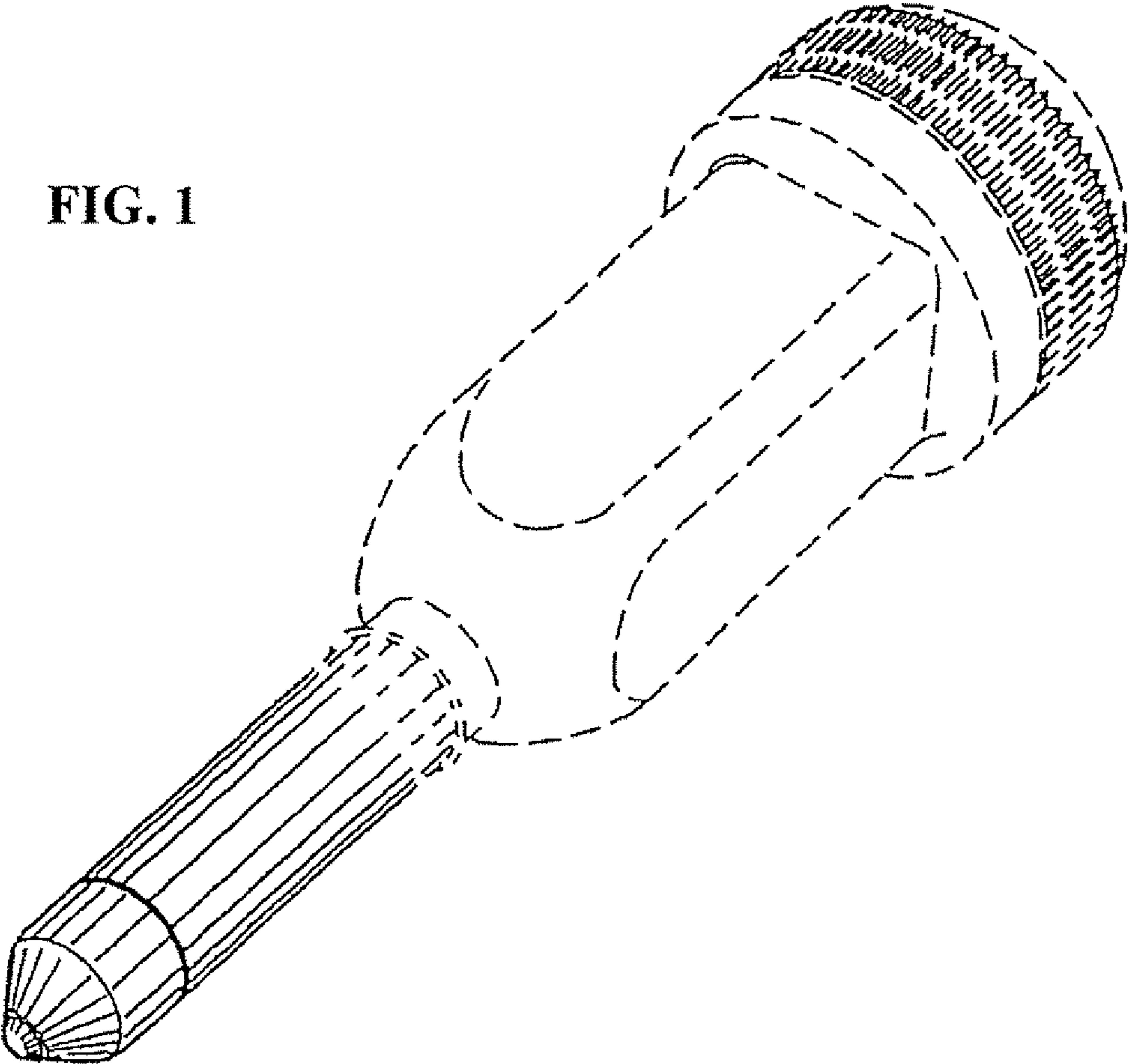

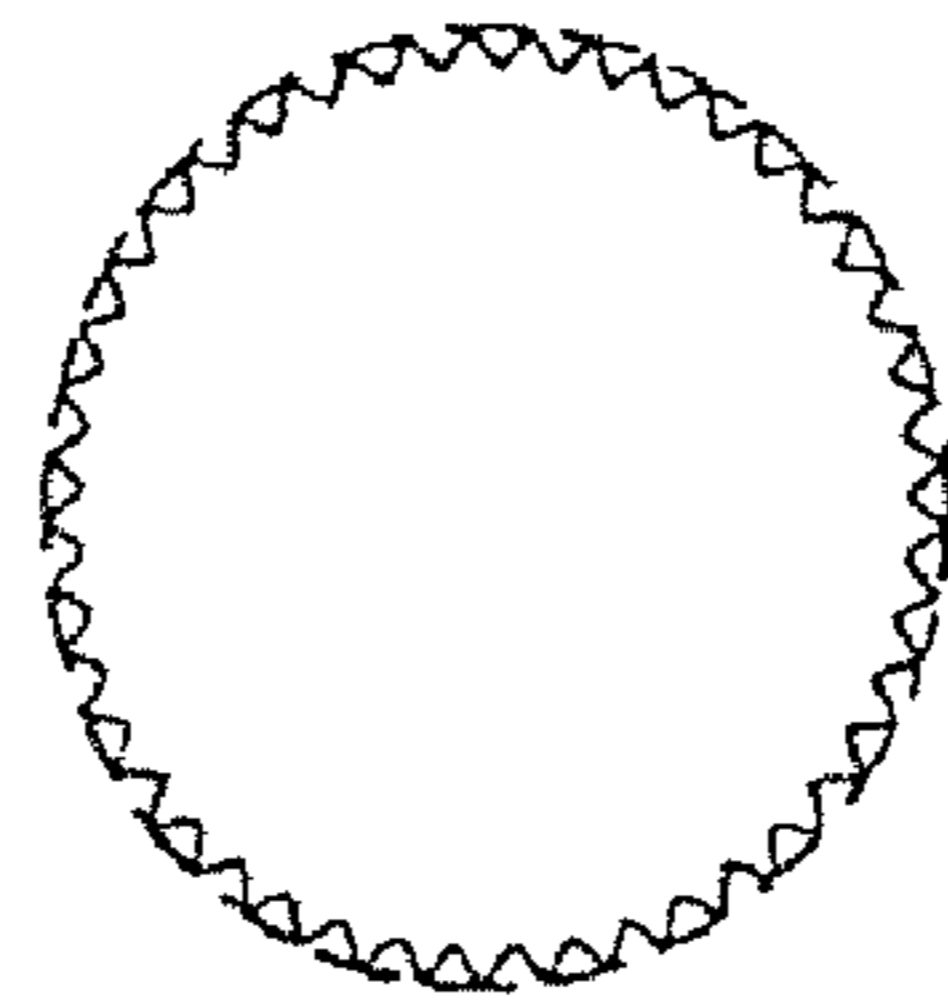

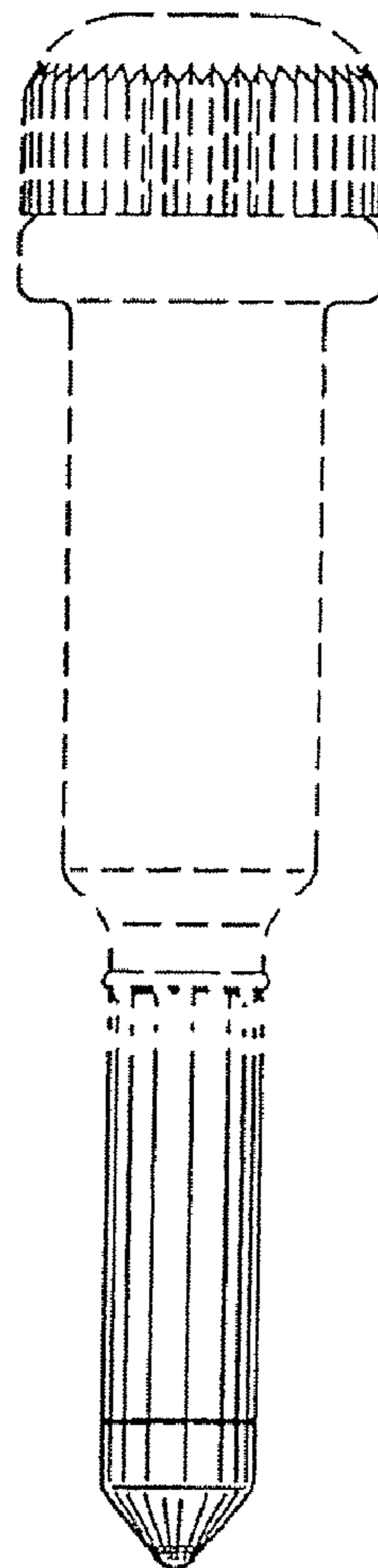
