(57) **CLAIM**

The ornamental design for a landscape stone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a landscape stone showing my new design.

FIG. 2 is a top plan view thereof.

FIG. 3 is a bottom plan view thereof.

FIG. 4 is a front side elevational view thereof.

FIG. 5 is a back side elevational view thereof.

FIG. 6 is a left end elevational view thereof.

FIG. 7 is right end elevational view thereof.

FIG. 8 is a plan view of an example condition of use of the landscape stone illustrated in FIGS. 1–7 in combination with other landscape stones of the same design forming an edger row. The features shown in FIG. 8 in dashed lines form no part of the claimed design.

FIG. 9 is a perspective view of a landscape stone showing a second embodiment of my new design.

FIG. 10 is a top plan view of the second embodiment of the design.

FIG. 11 is a bottom plan view of the second embodiment of the design.

FIG. 12 is a front side elevational view of the second embodiment of the design.

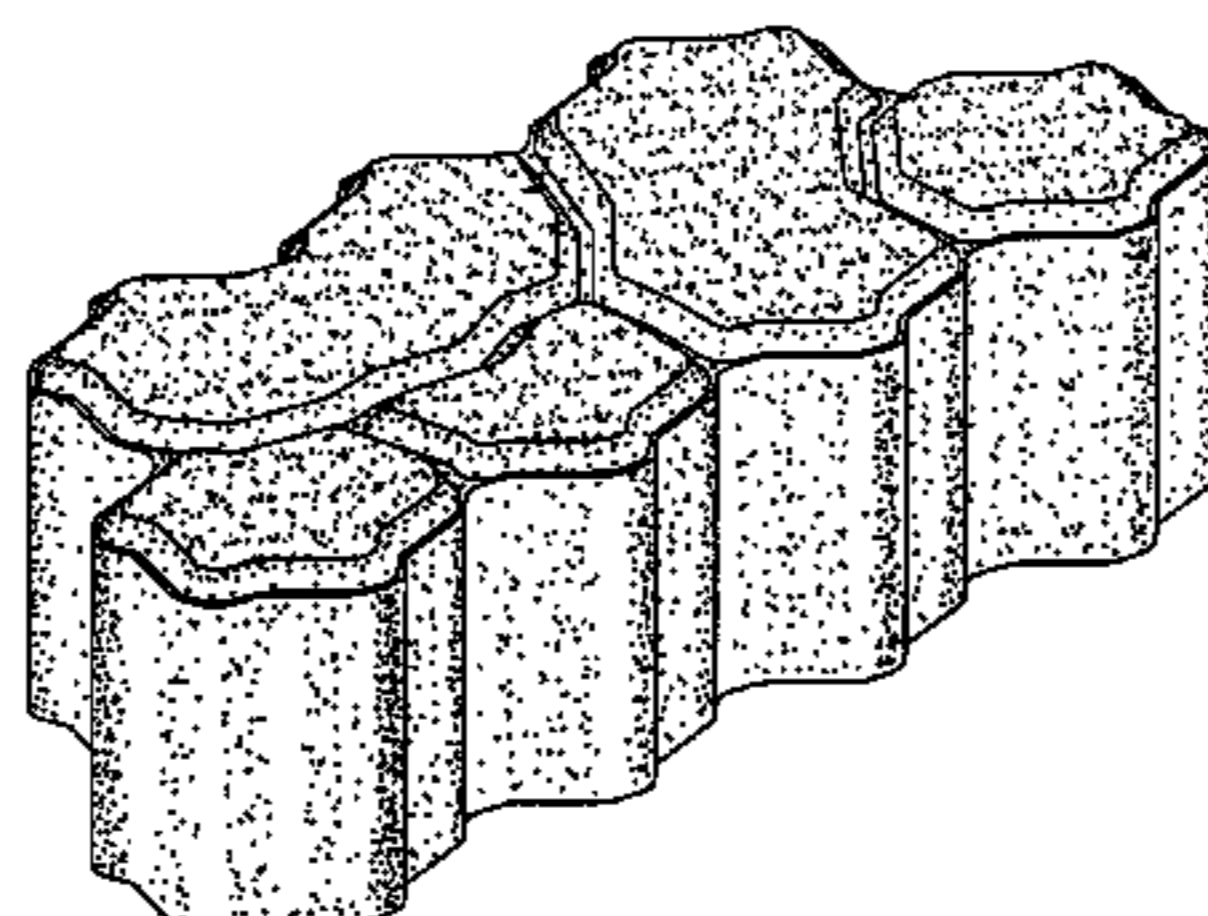
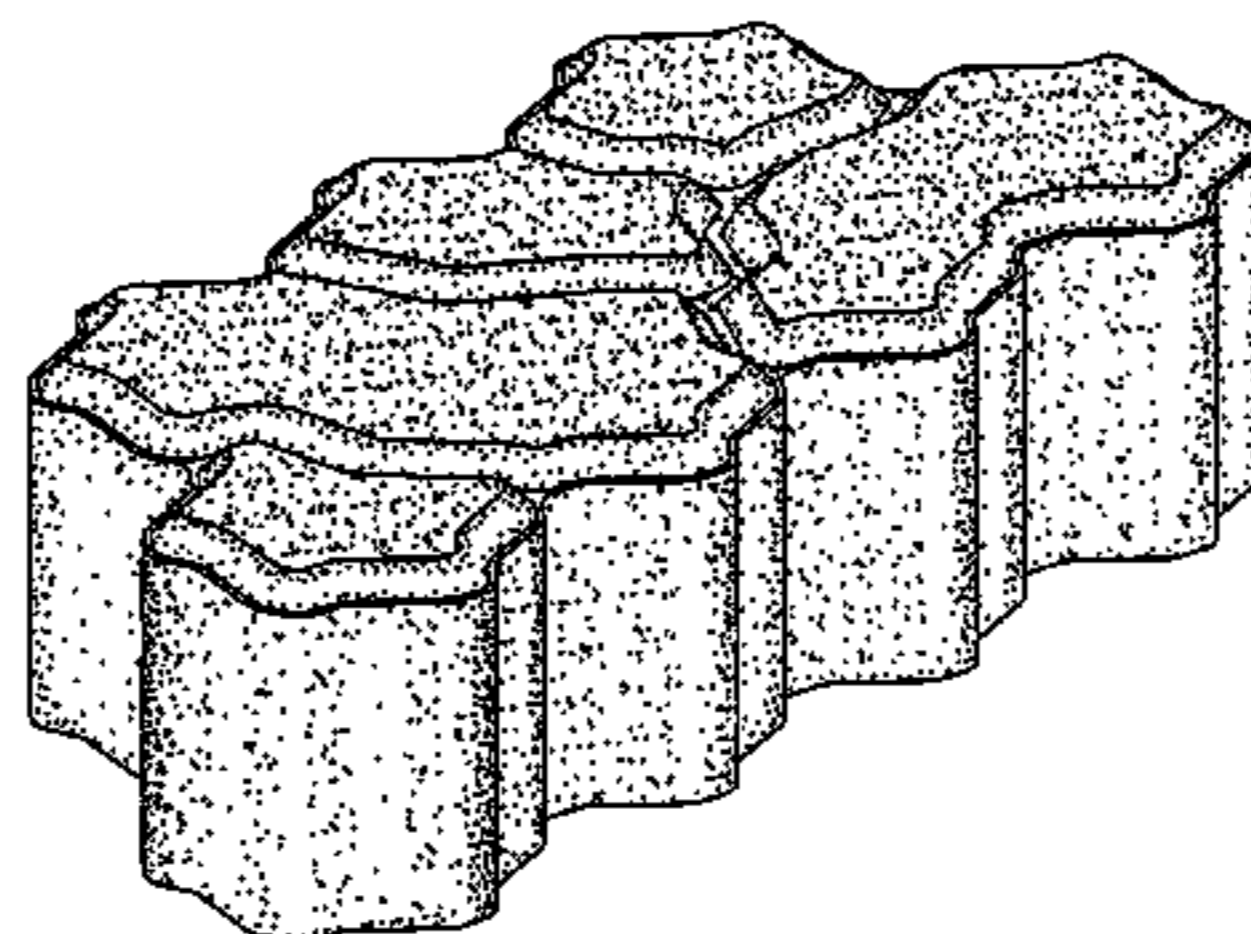
FIG. 13 is a back side elevational view of the second embodiment of the design.

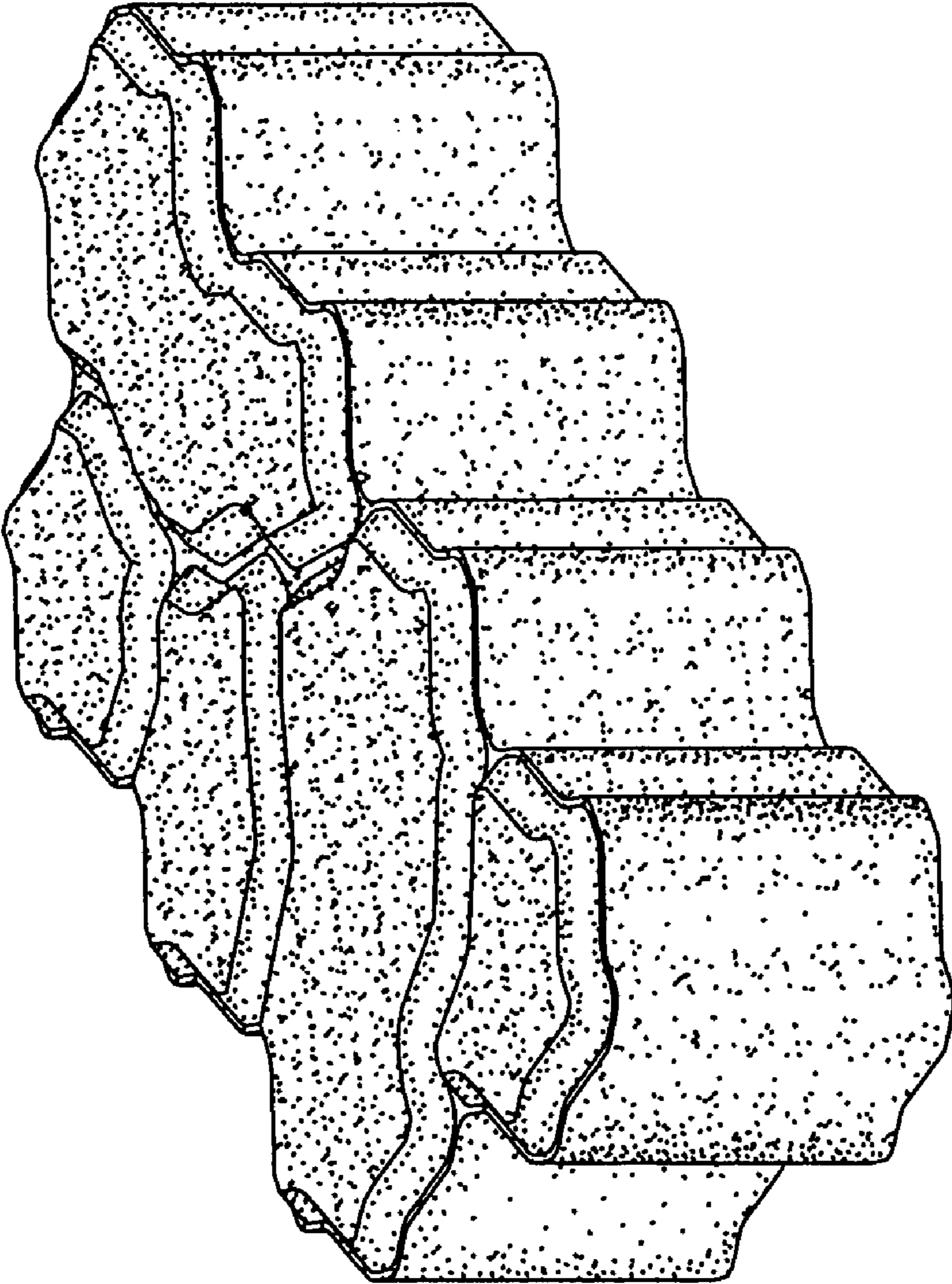

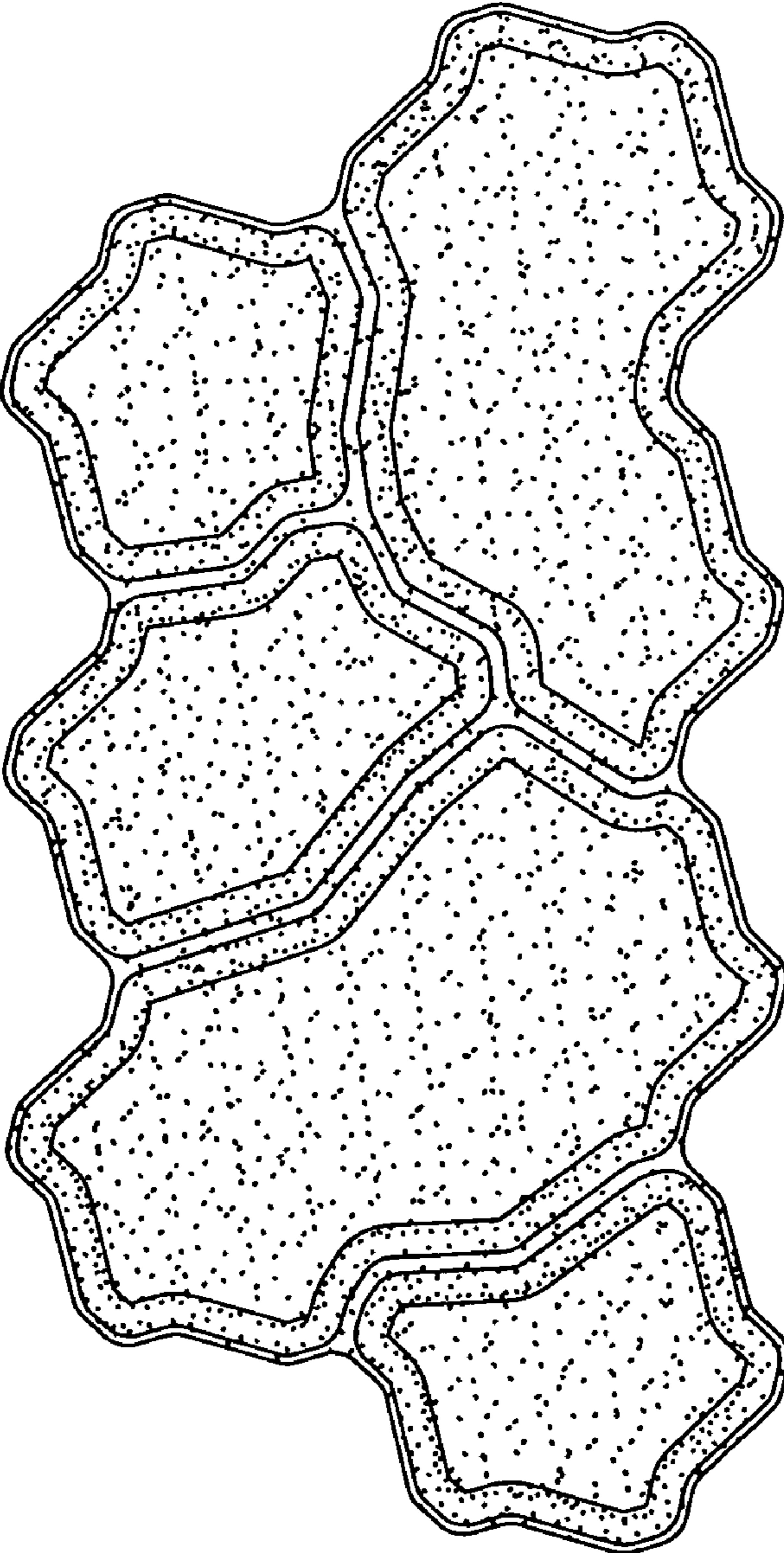

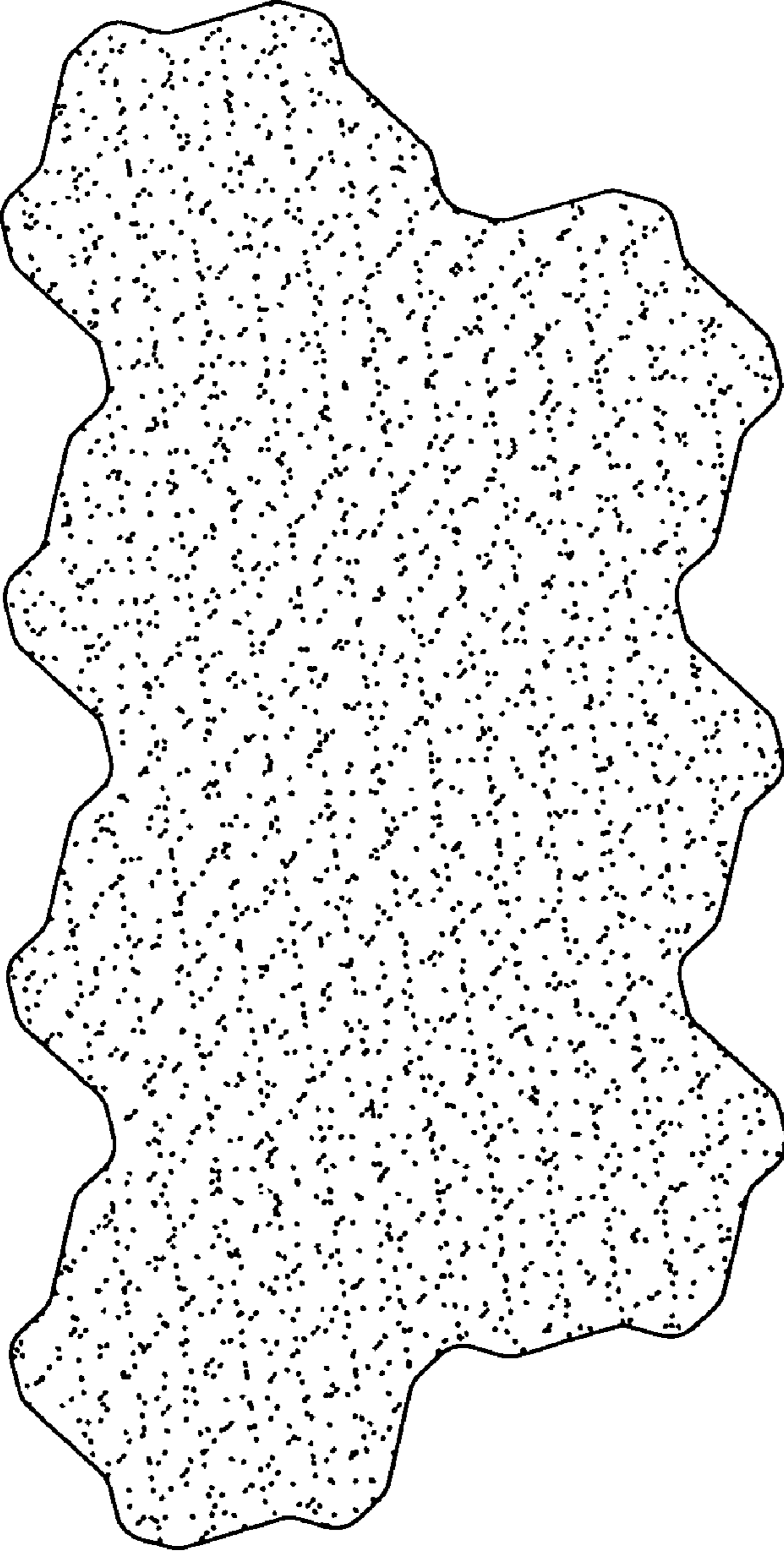

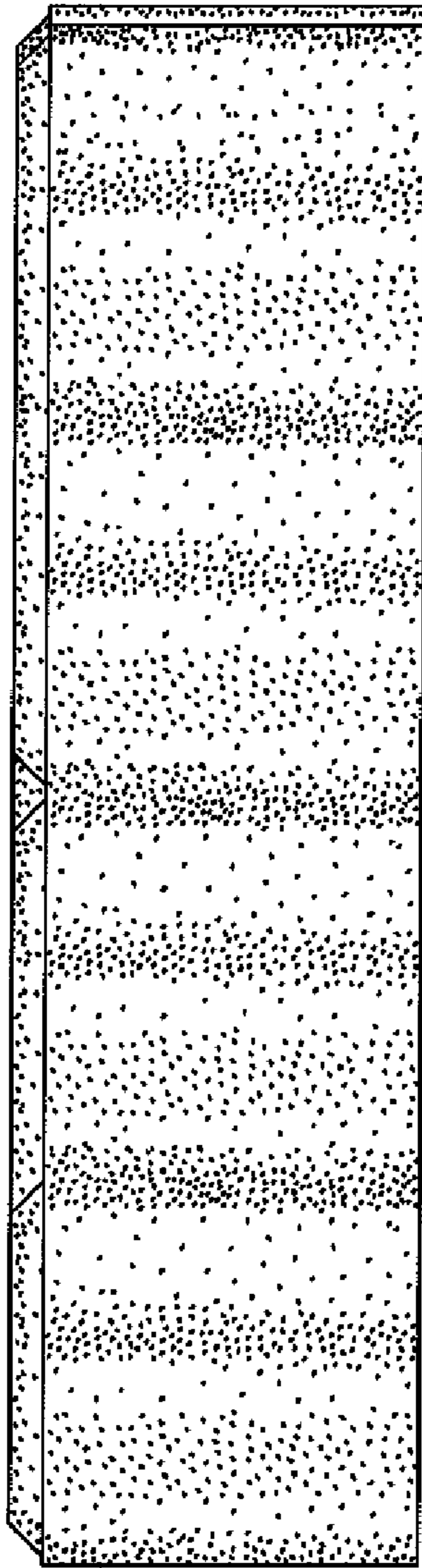

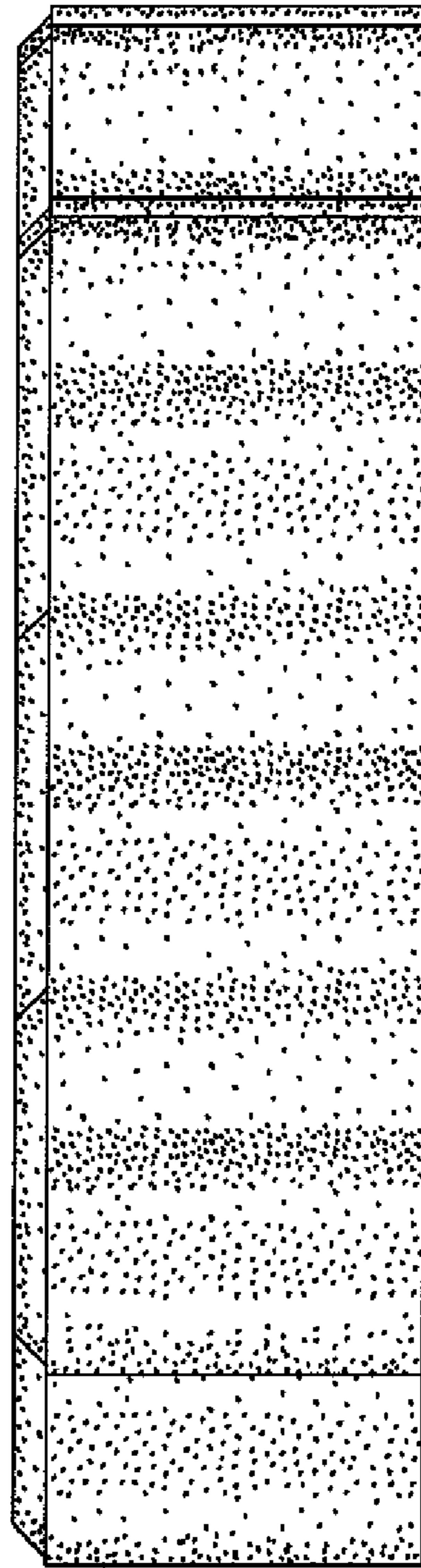

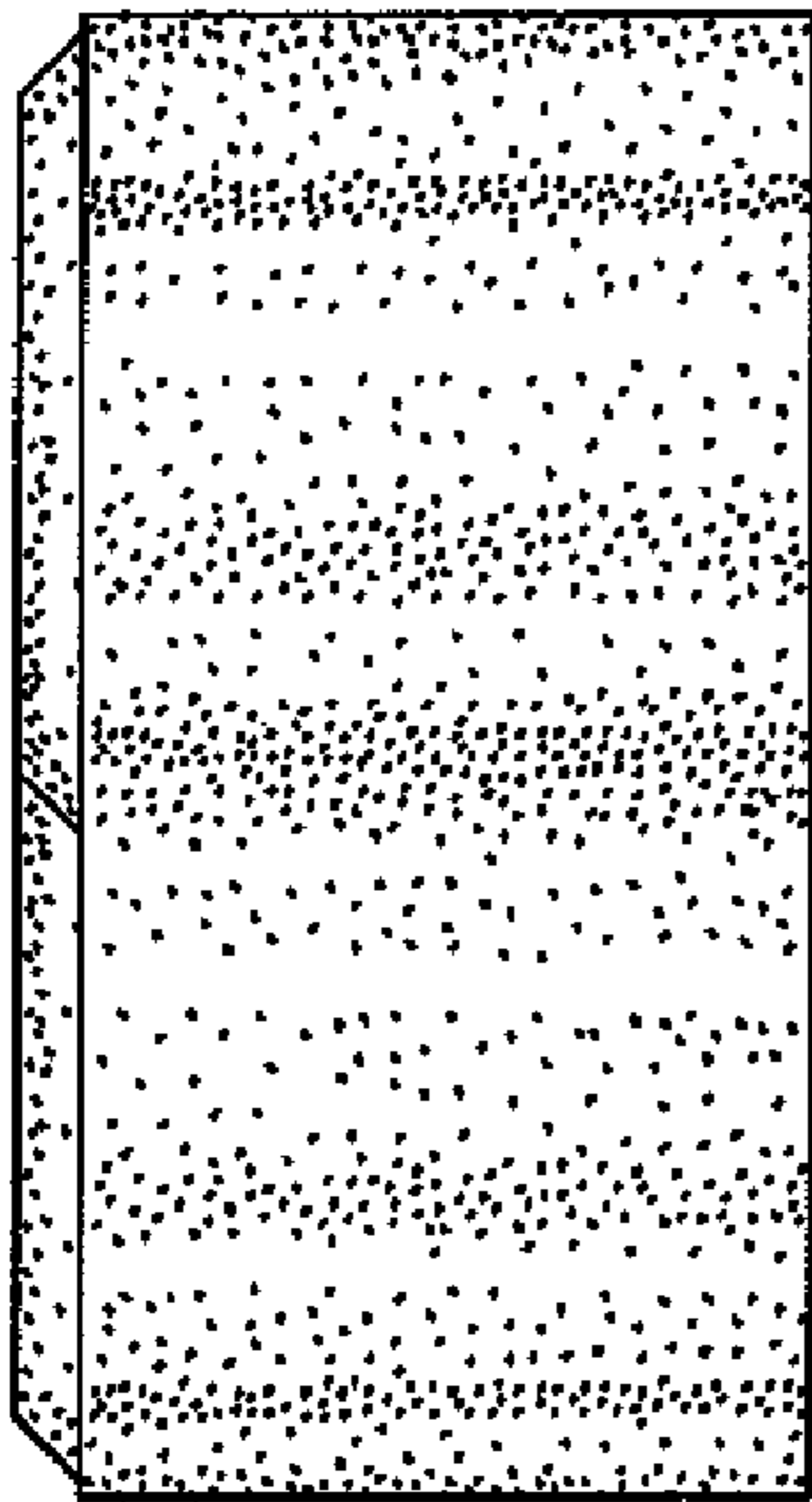

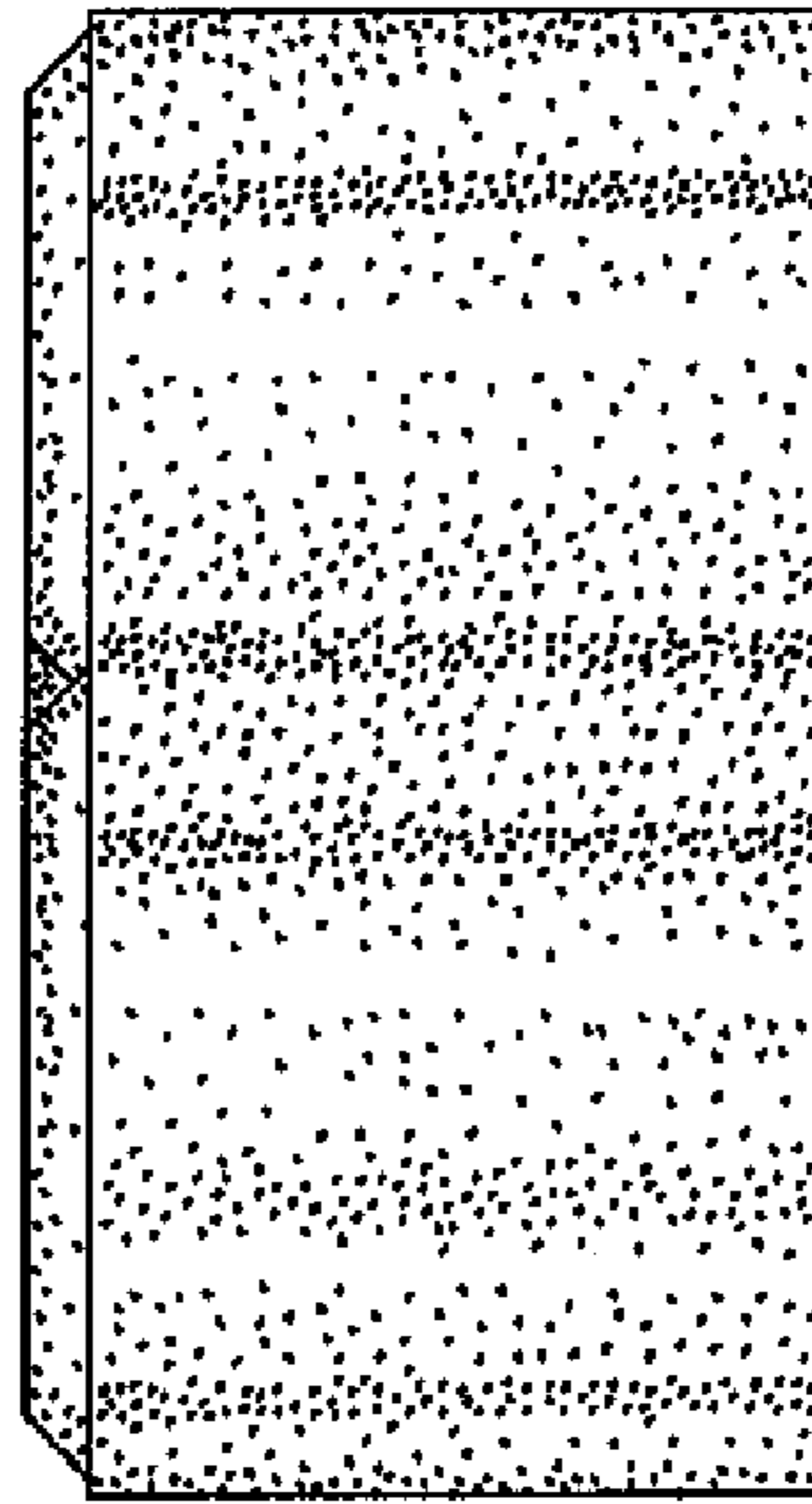

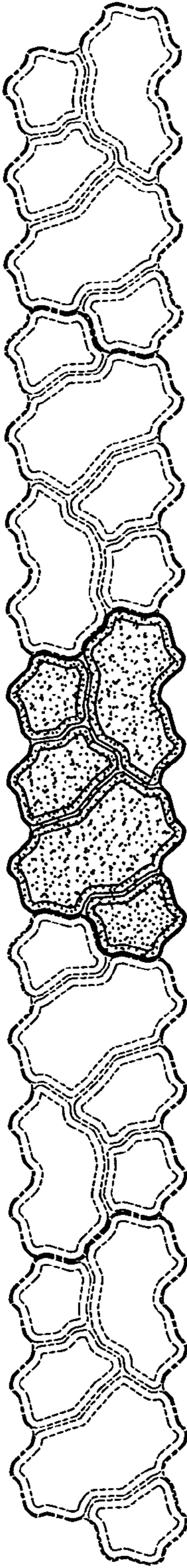

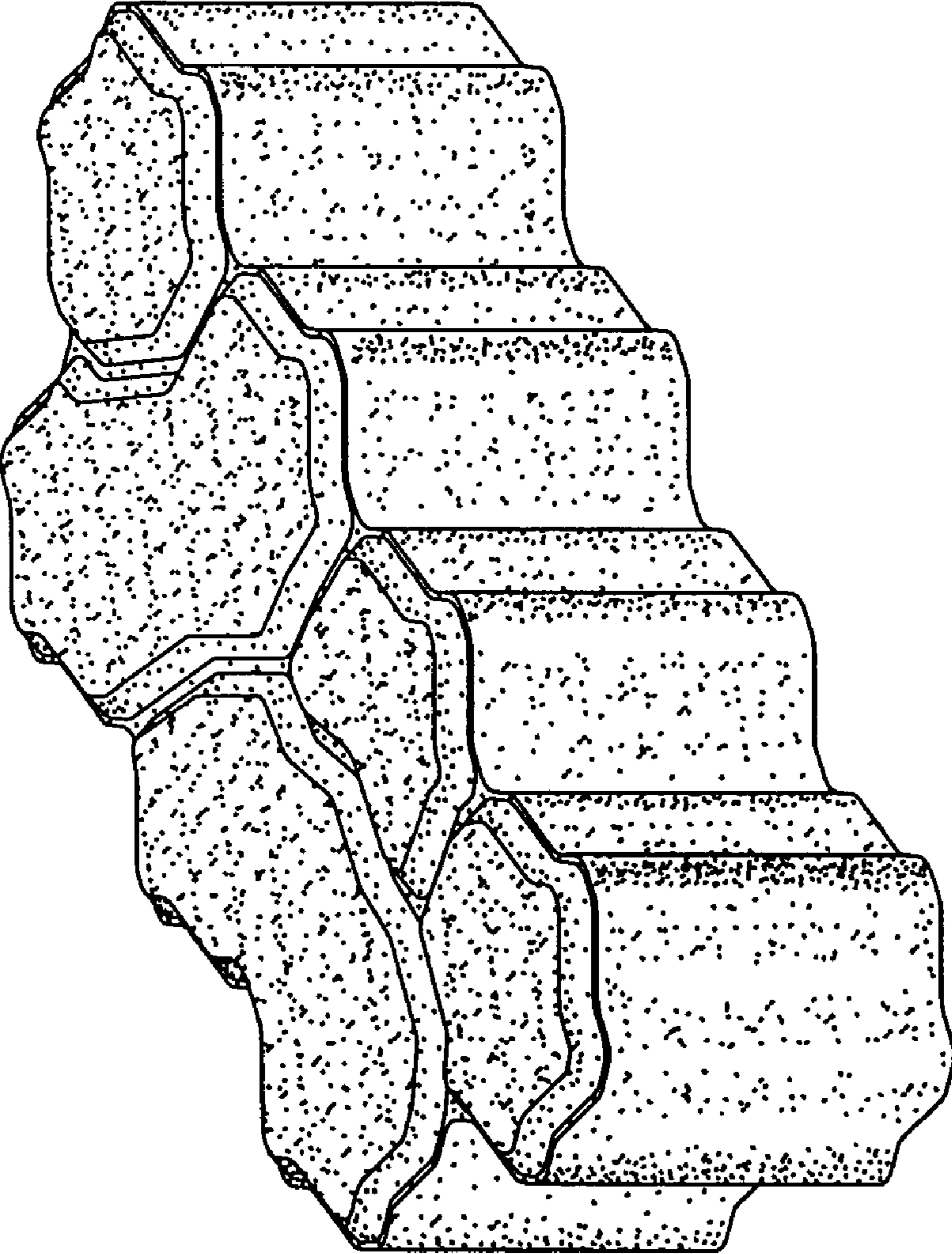

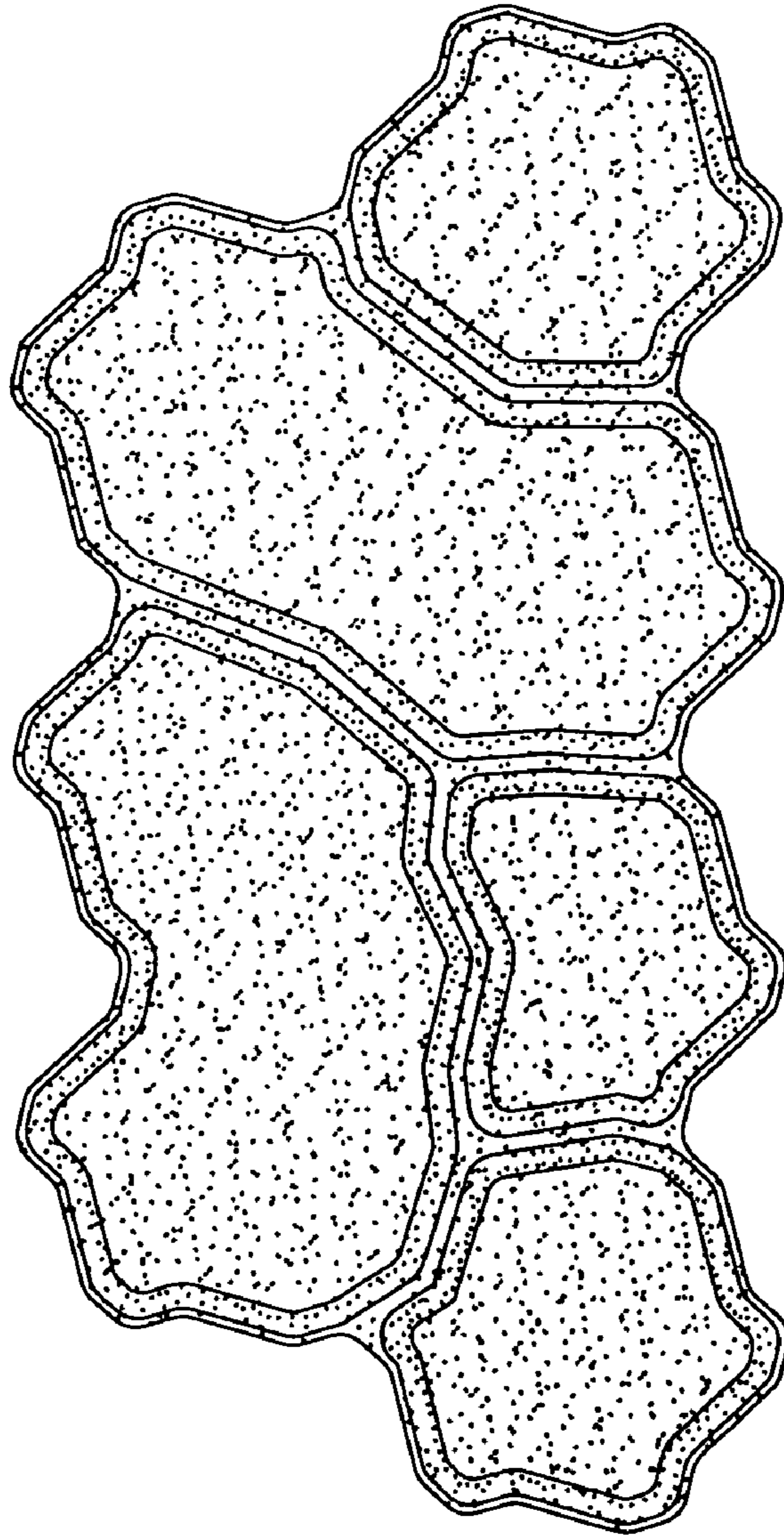

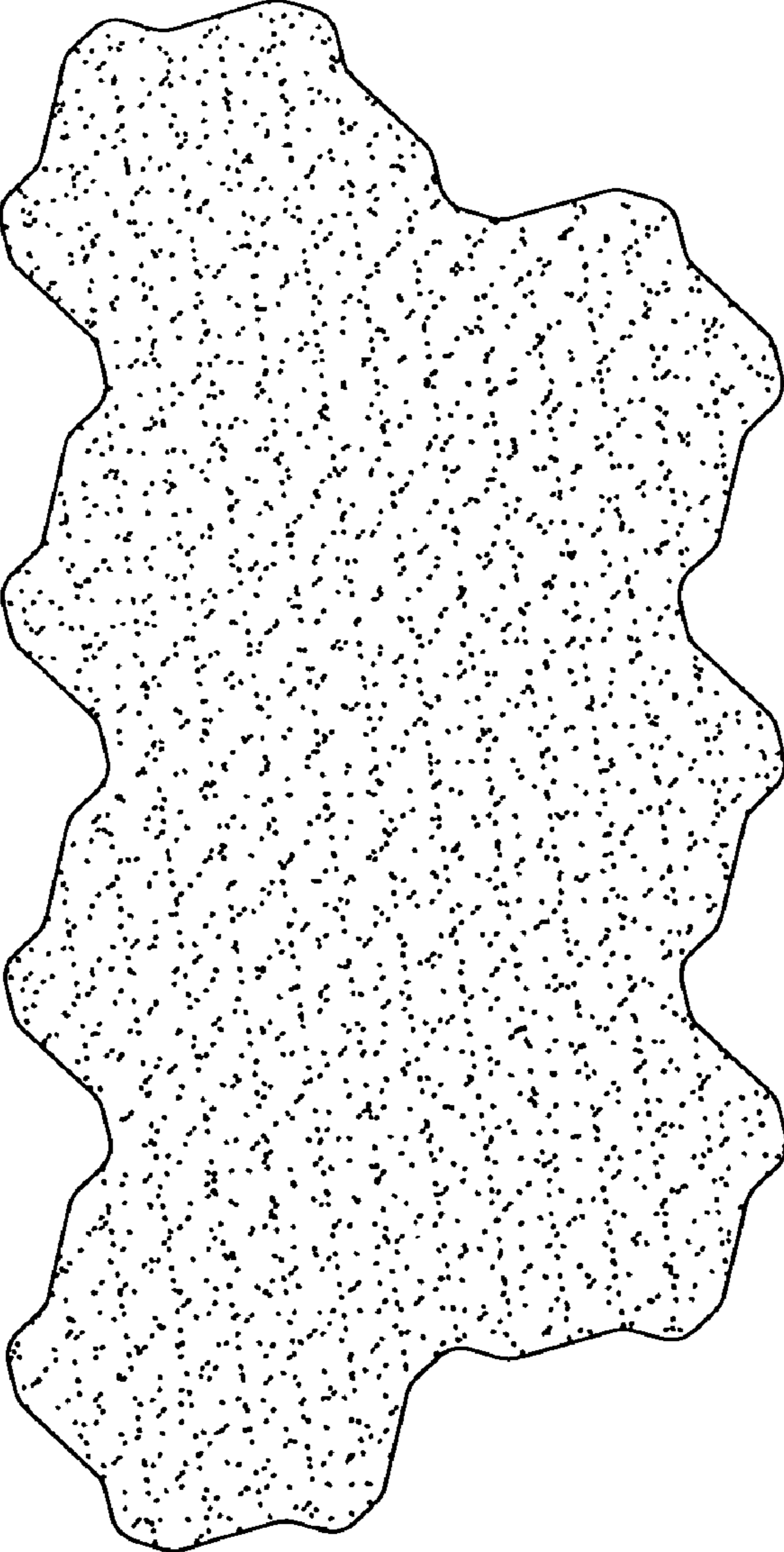

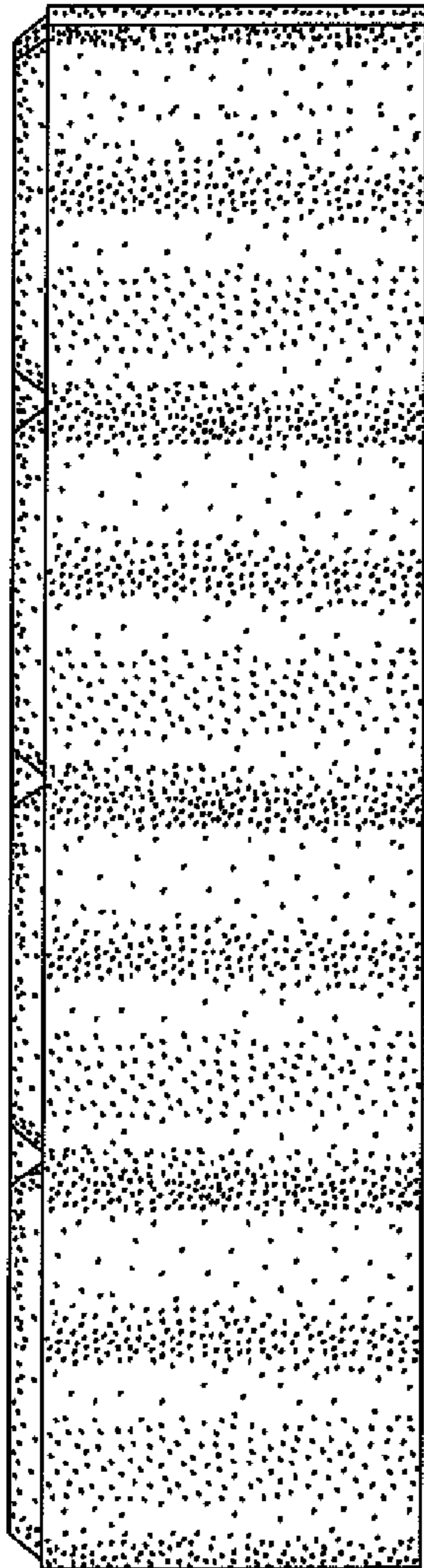

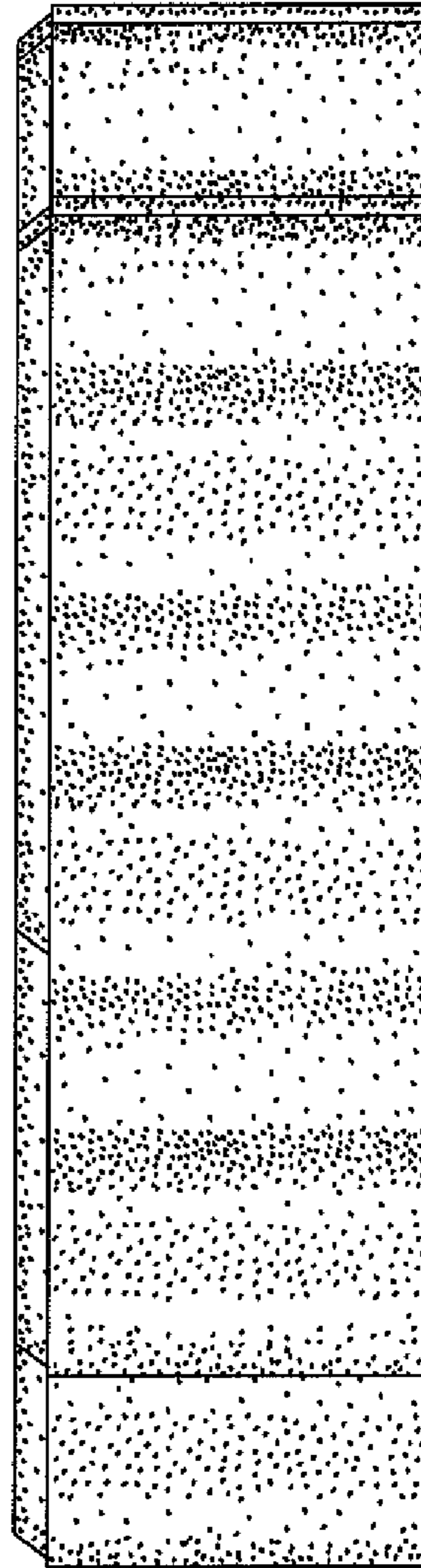

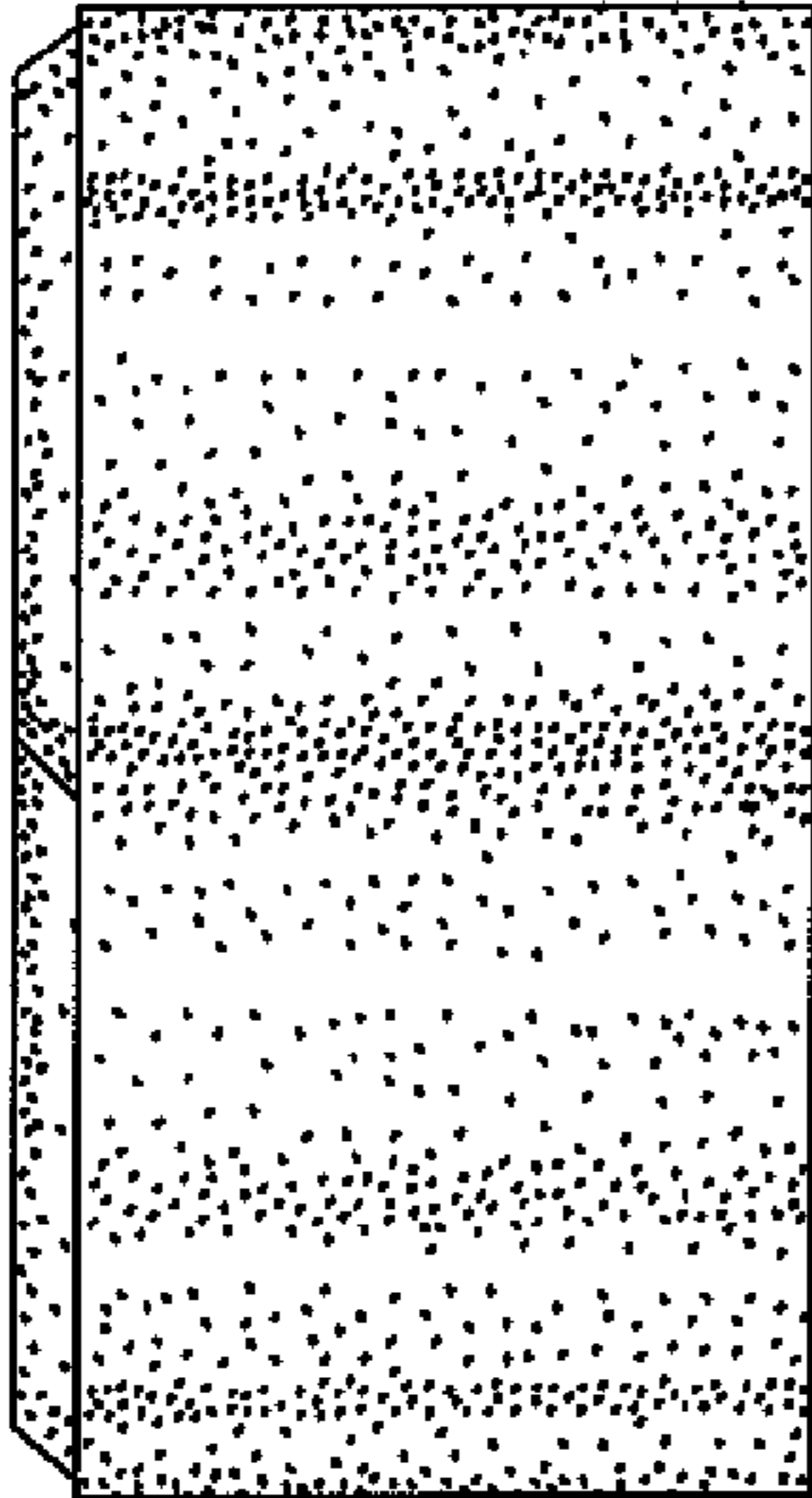

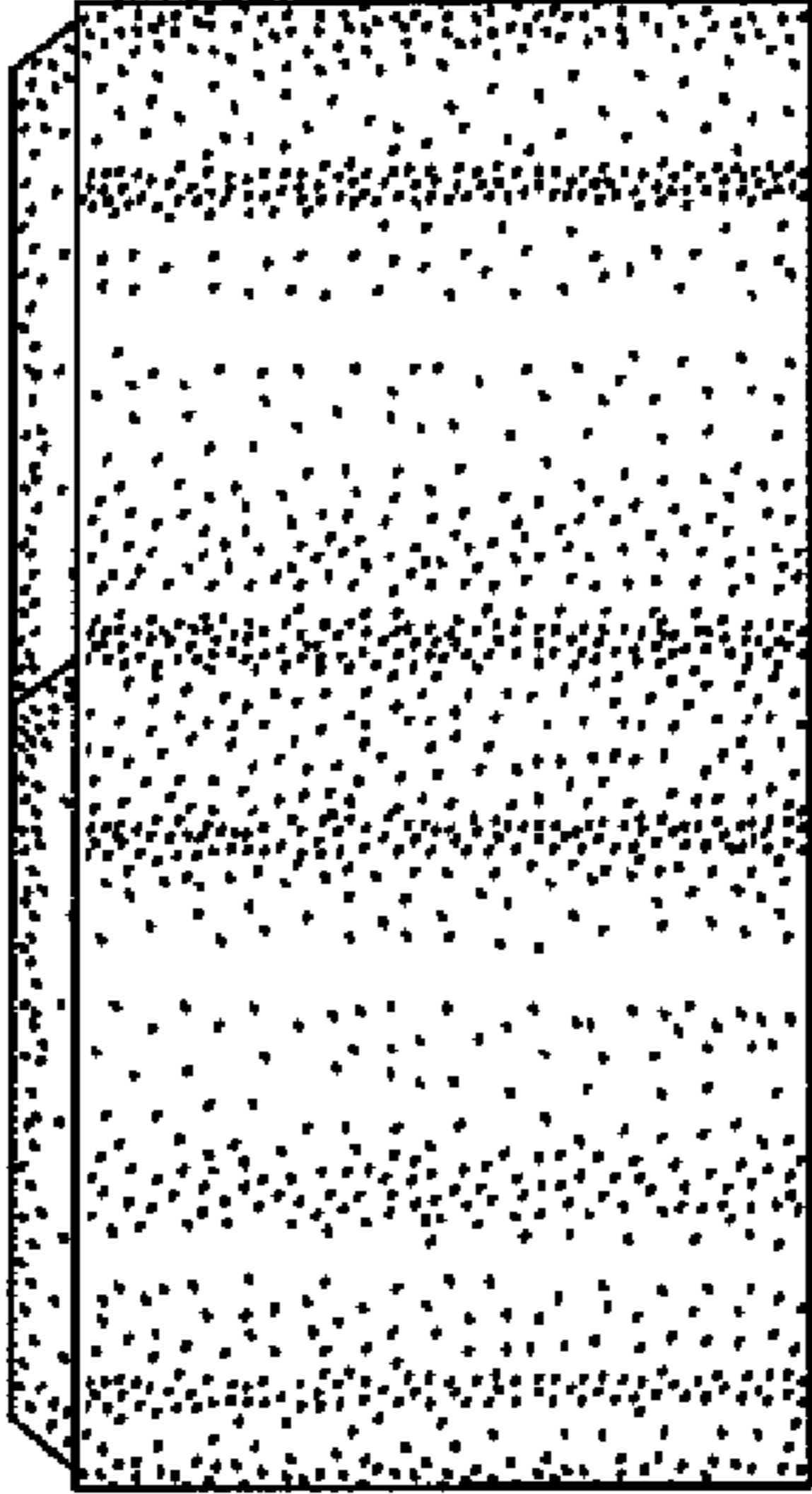

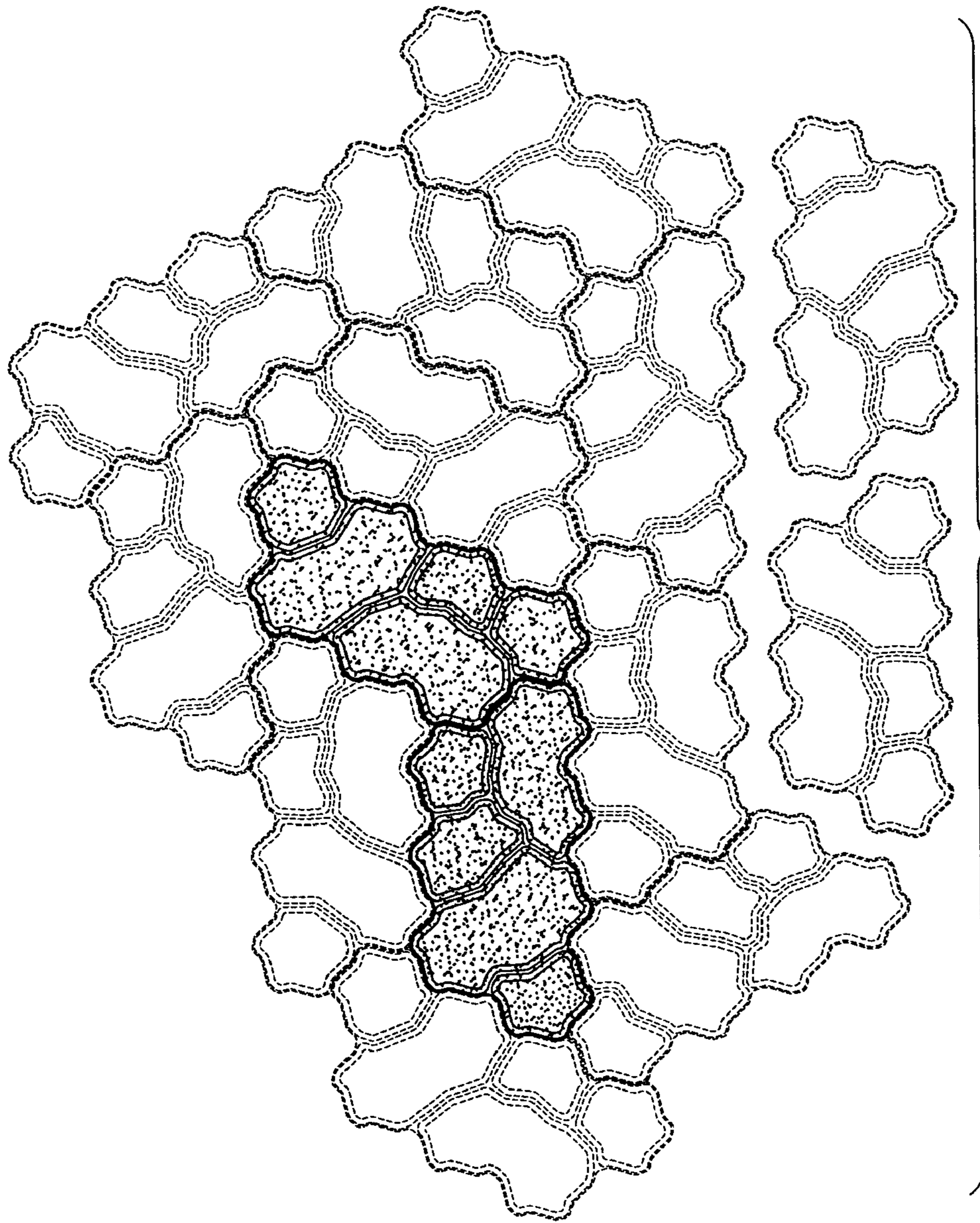
