(57) **CLAIM**

The ornamental design for a louver assembly, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a louver assembly of the present invention shown mounted to a light fixture housing;

FIG. 2 is a bottom perspective view of the louver assembly of the present invention;

FIG. 3 top elevational view of the louver assembly of FIG. 2;

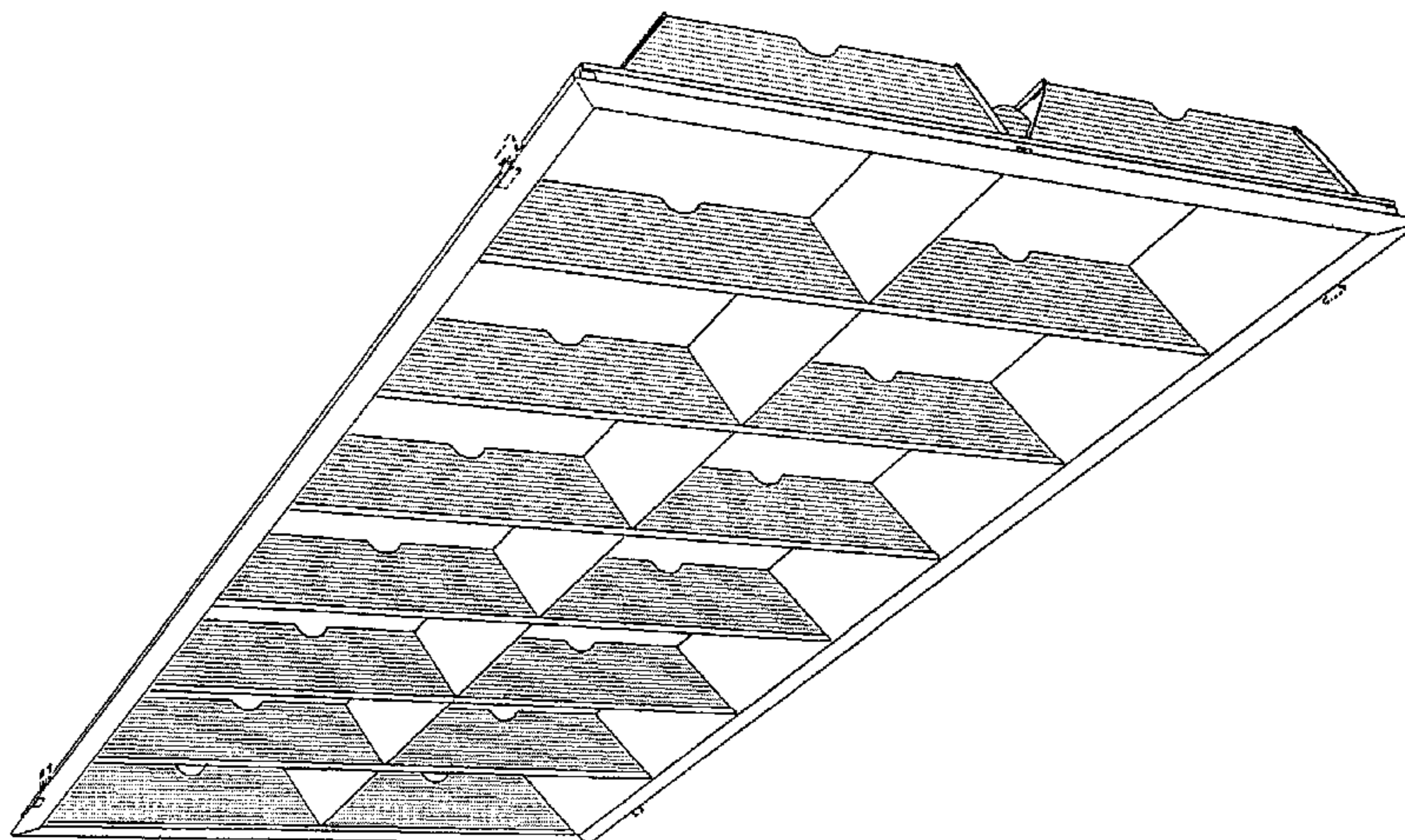
FIG. 4 is a left side elevational view of the louver assembly of FIG. 2, the right, opposite, side of which is a mirror image thereof;

FIG. 5 is a bottom elevational view of the louver assembly of FIG. 2; and,

FIG. 6 is a top perspective view of the louver assembly of FIG. 2.

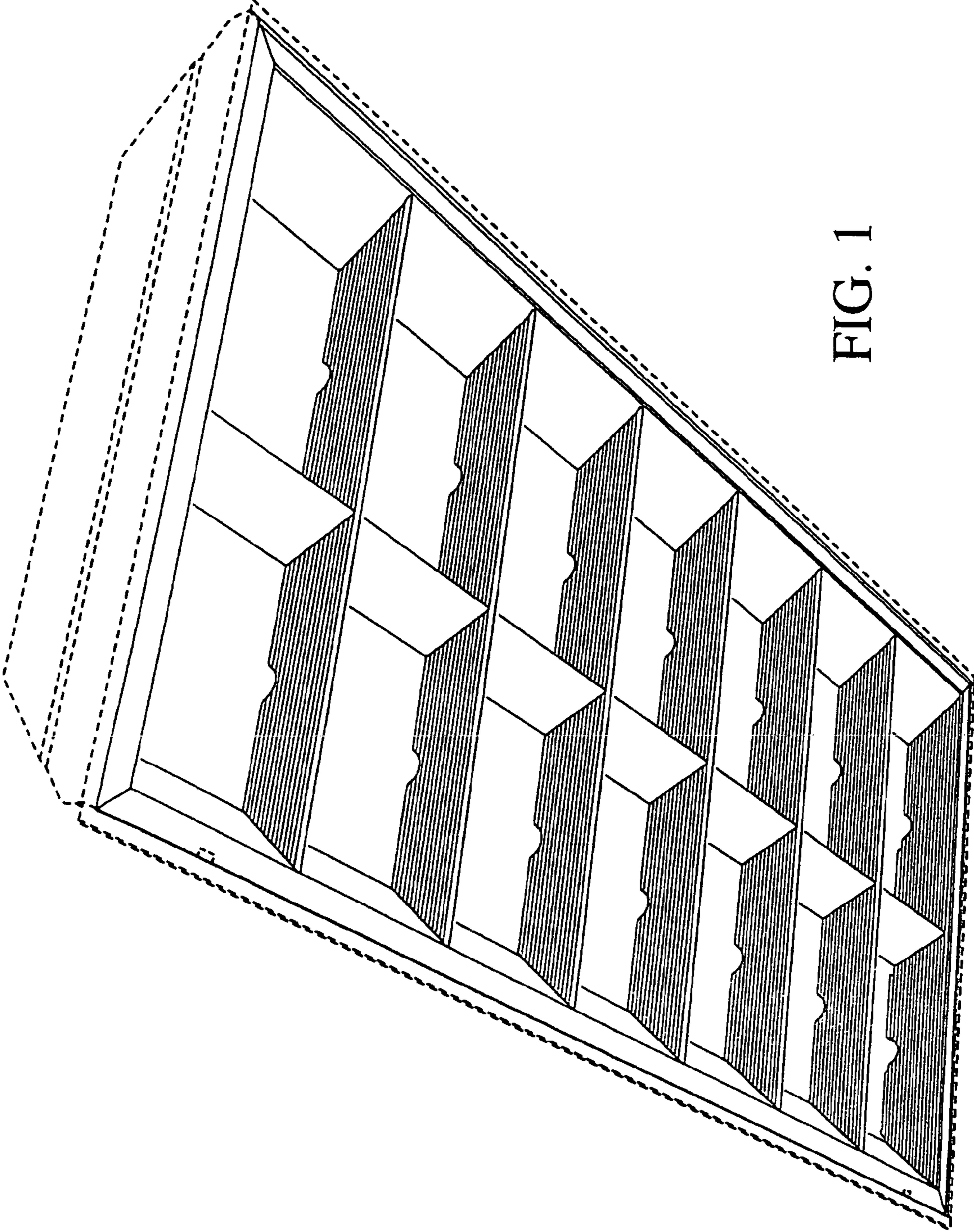

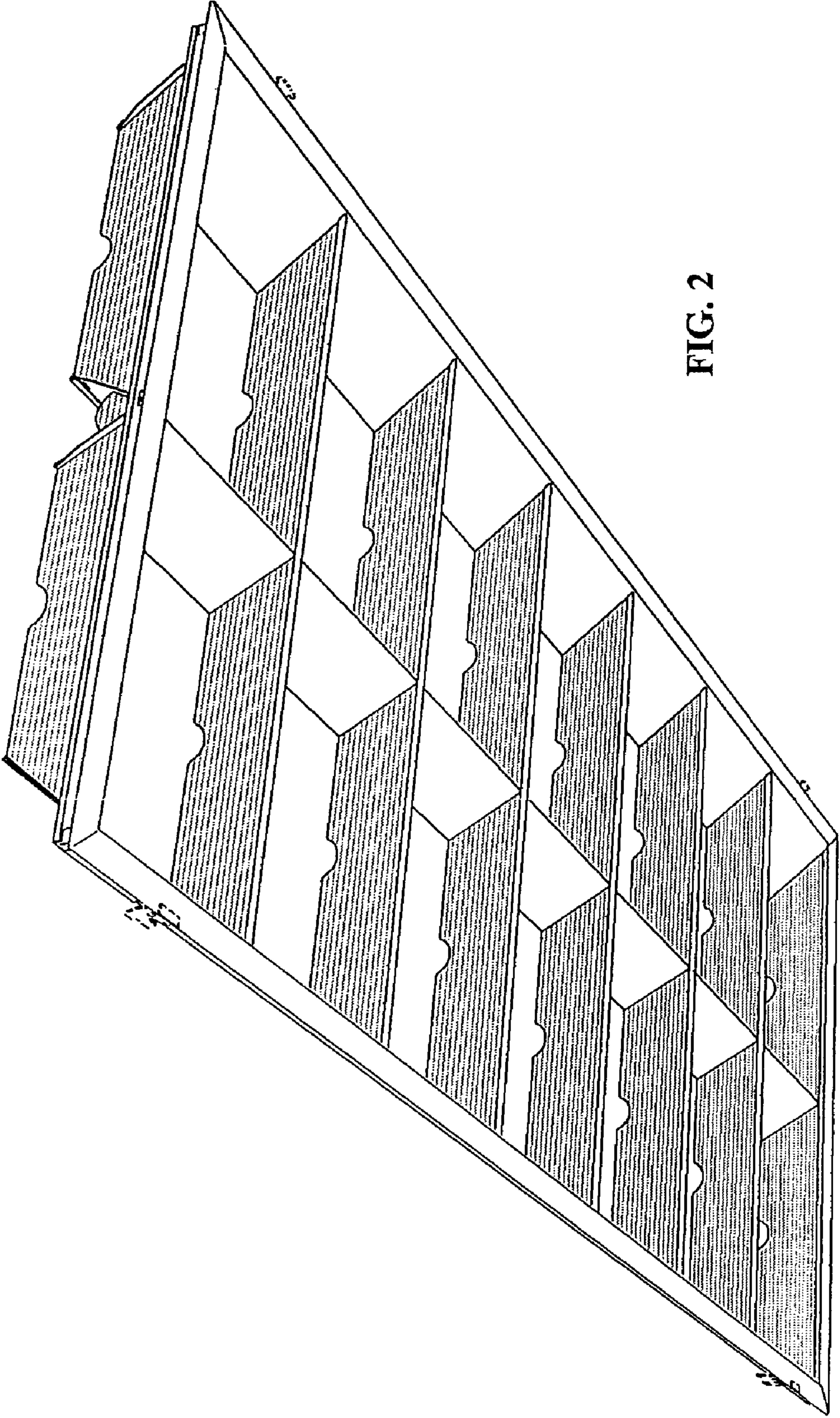

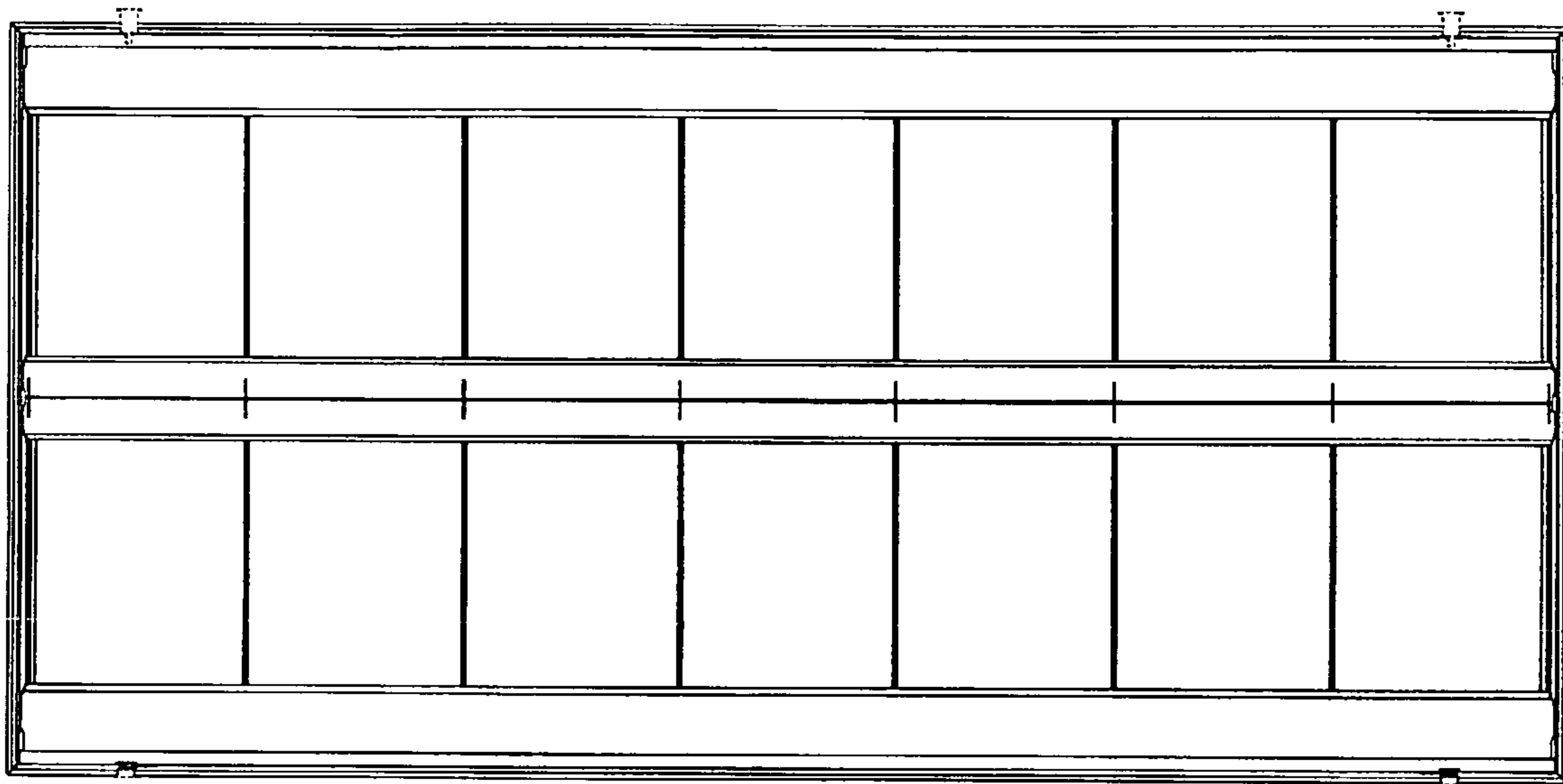

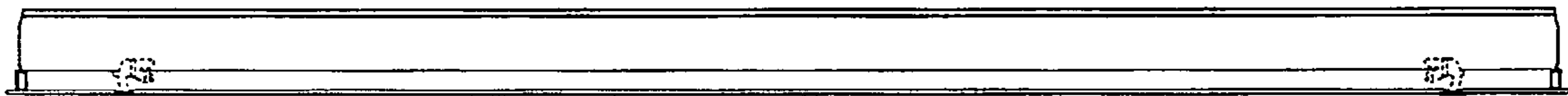

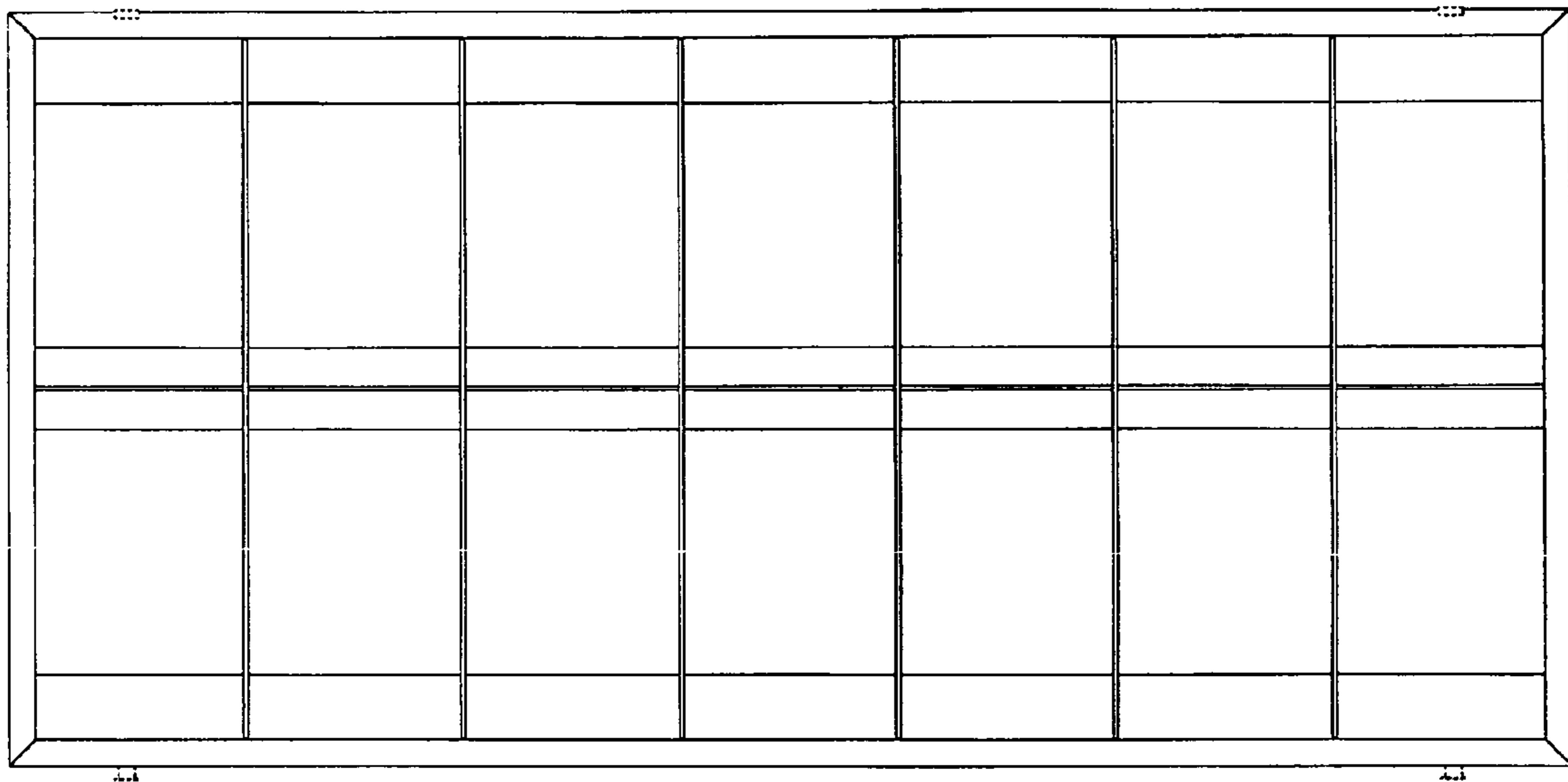
