(57) **CLAIM**

The ornamental design for a combined cigarette holder and snuffer, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of the combined cigarette holder and snuffer;

FIG. 2 is a side elevation view of the combined cigarette holder and snuffer that is 90° counterclockwise from FIG. 1;

FIG. 3 is a side elevation view of the combined cigarette holder and snuffer that is 90° counterclockwise from FIG. 2;

FIG. 4 is a side elevation view of the combined cigarette holder and snuffer that is 90° counterclockwise from FIG. 3;

FIG. 5 is a top plan view of the combined cigarette holder and snuffer; and,

FIG. 6 is a bottom plan view of the combined cigarette holder and snuffer.

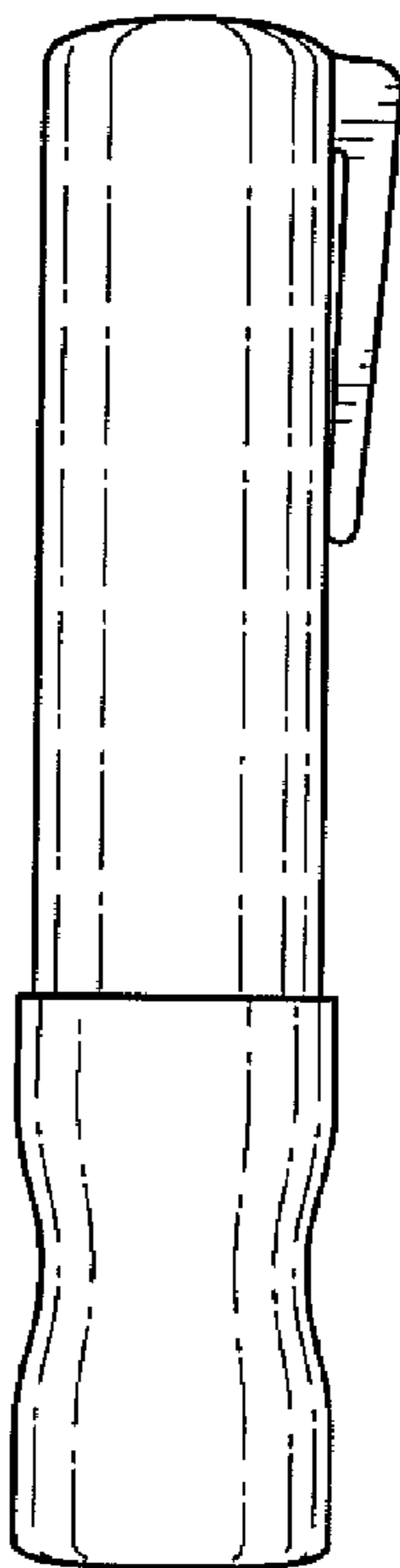

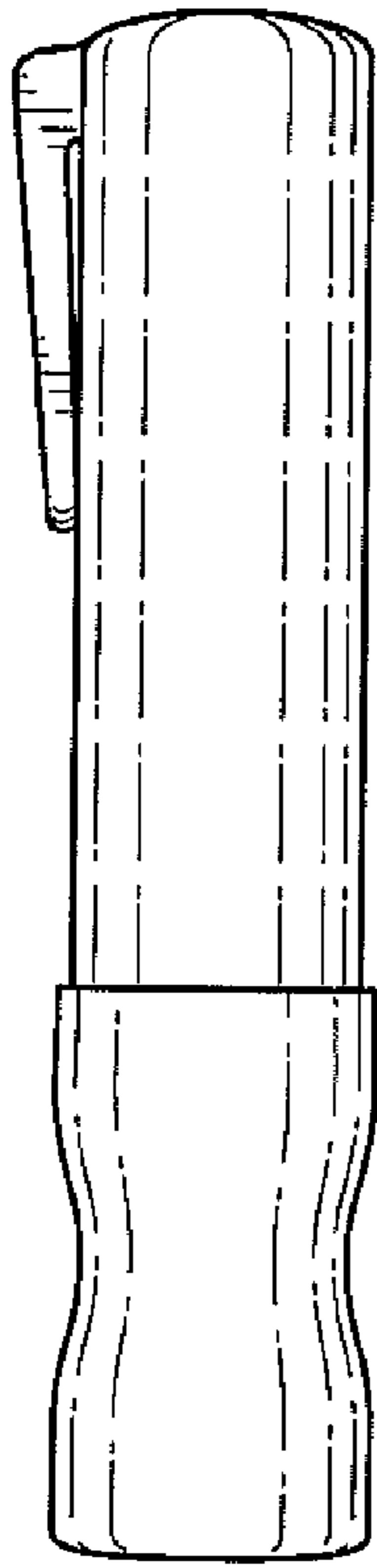

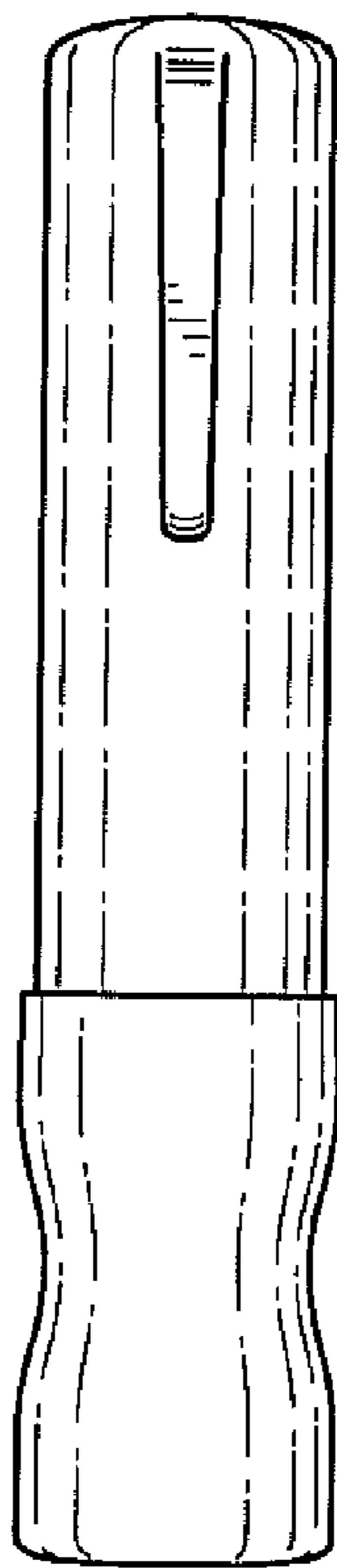

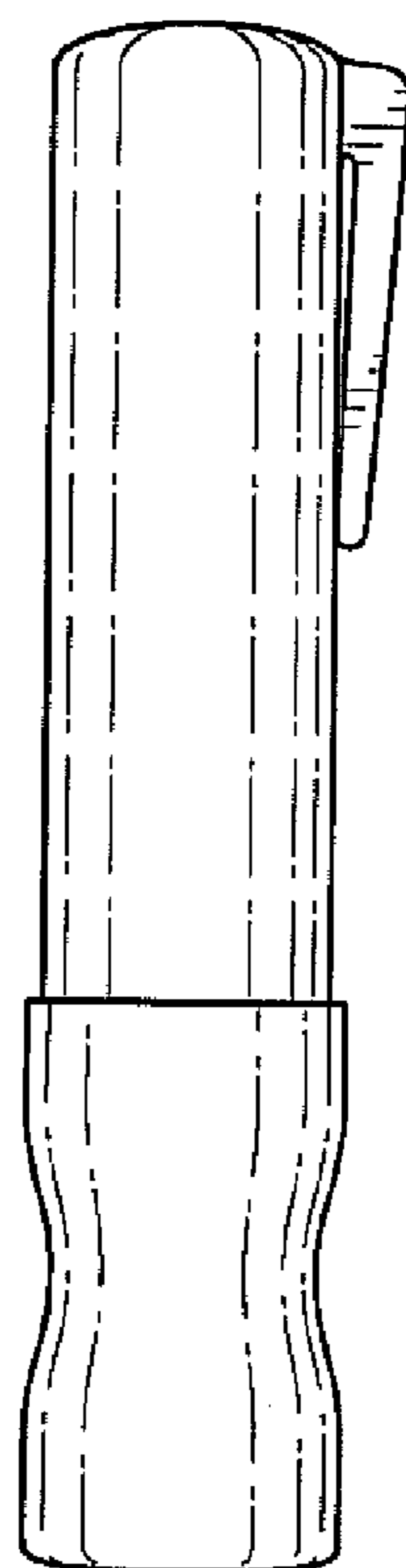

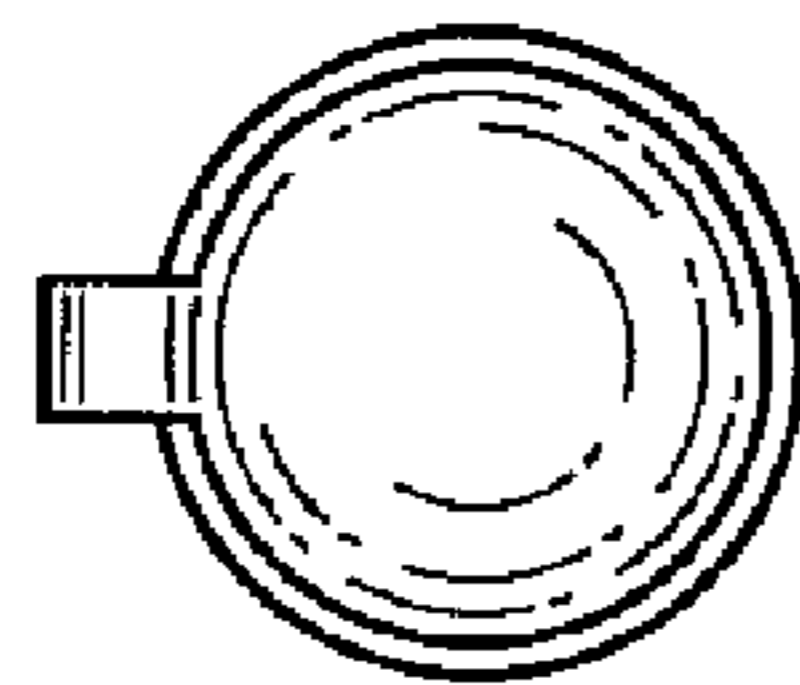

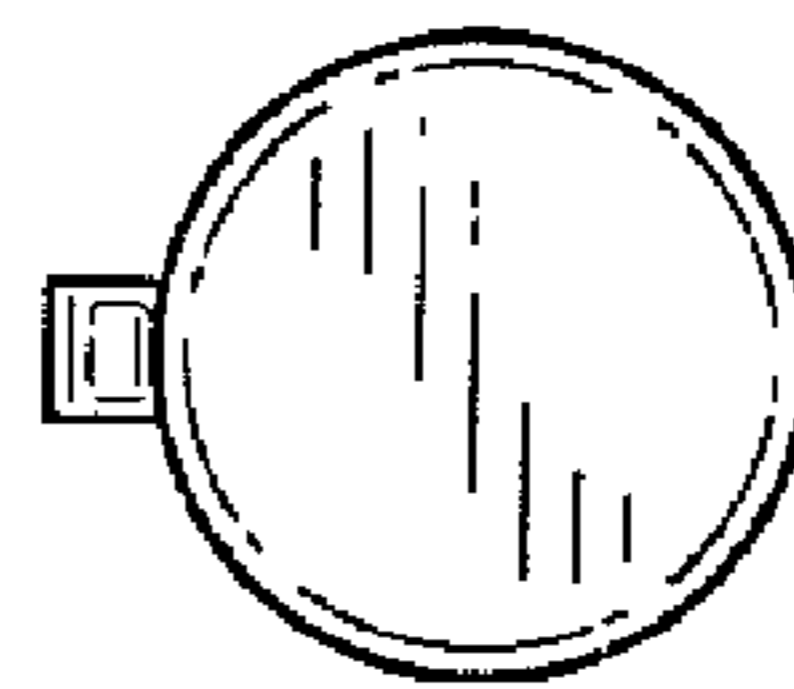
