and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a pair of women's shoes,  
showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevational view thereof, the left side  
view of the right shoe being a mirror image;

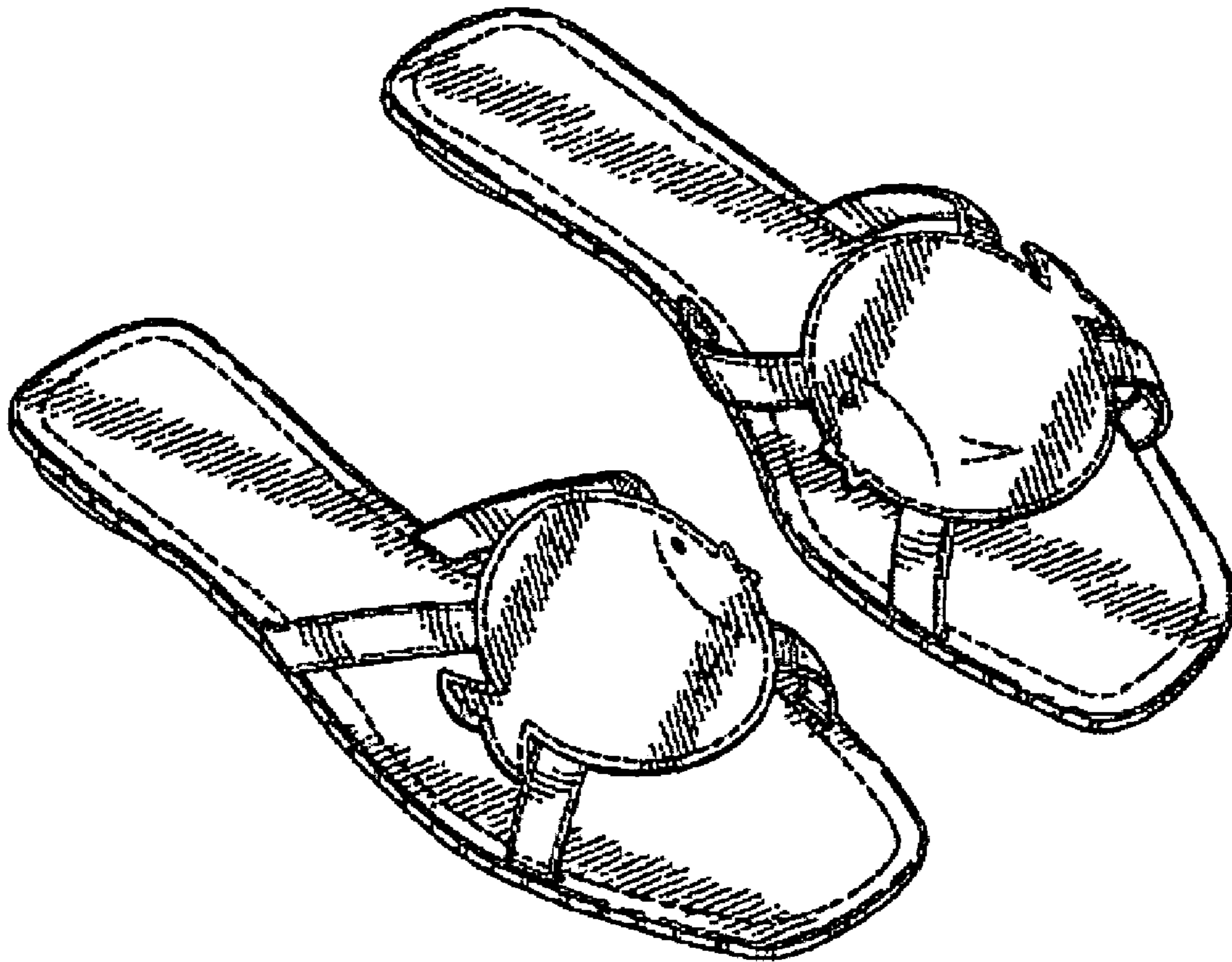
FIG. 5 is a left side elevational view thereof, the right side

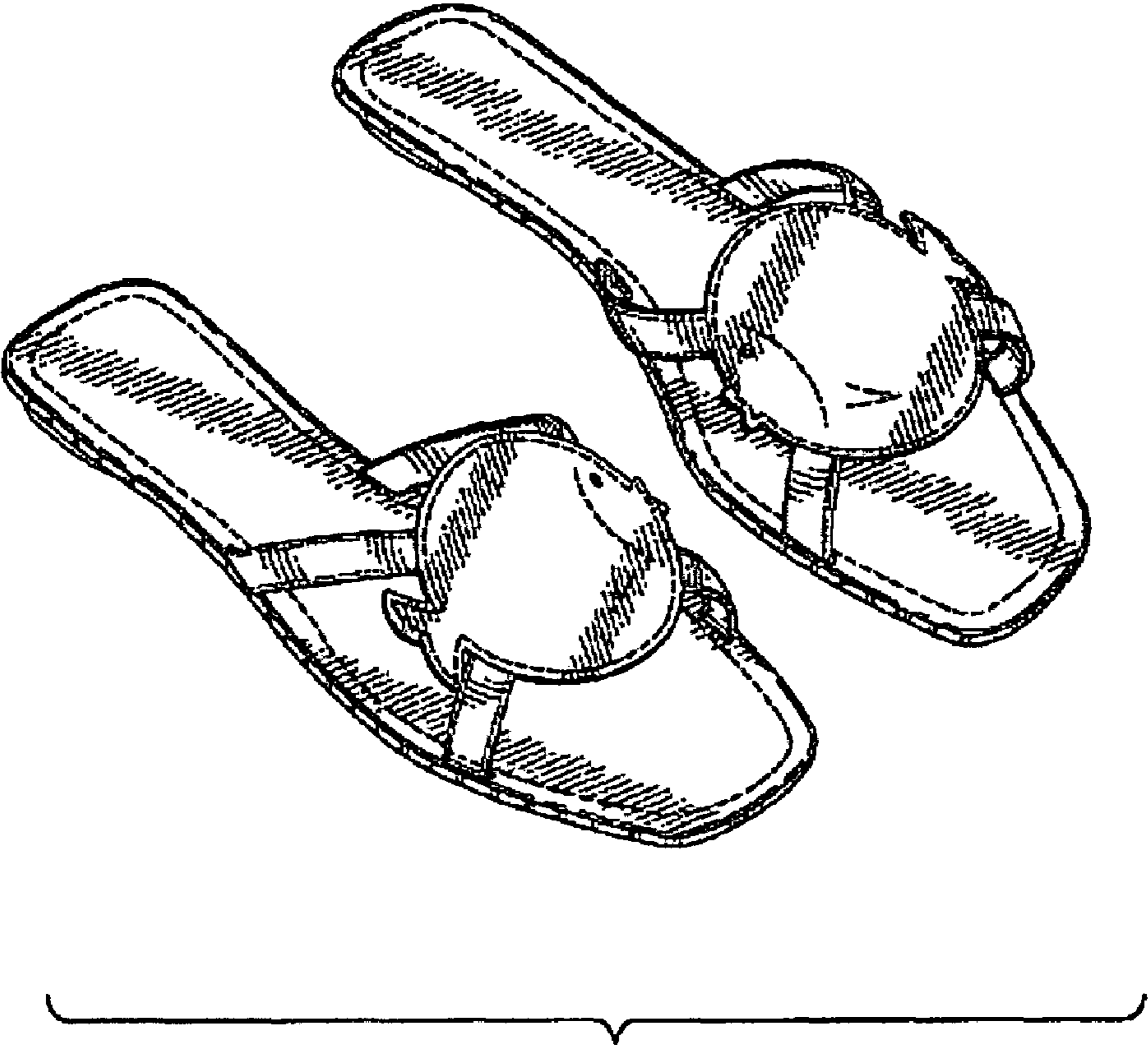

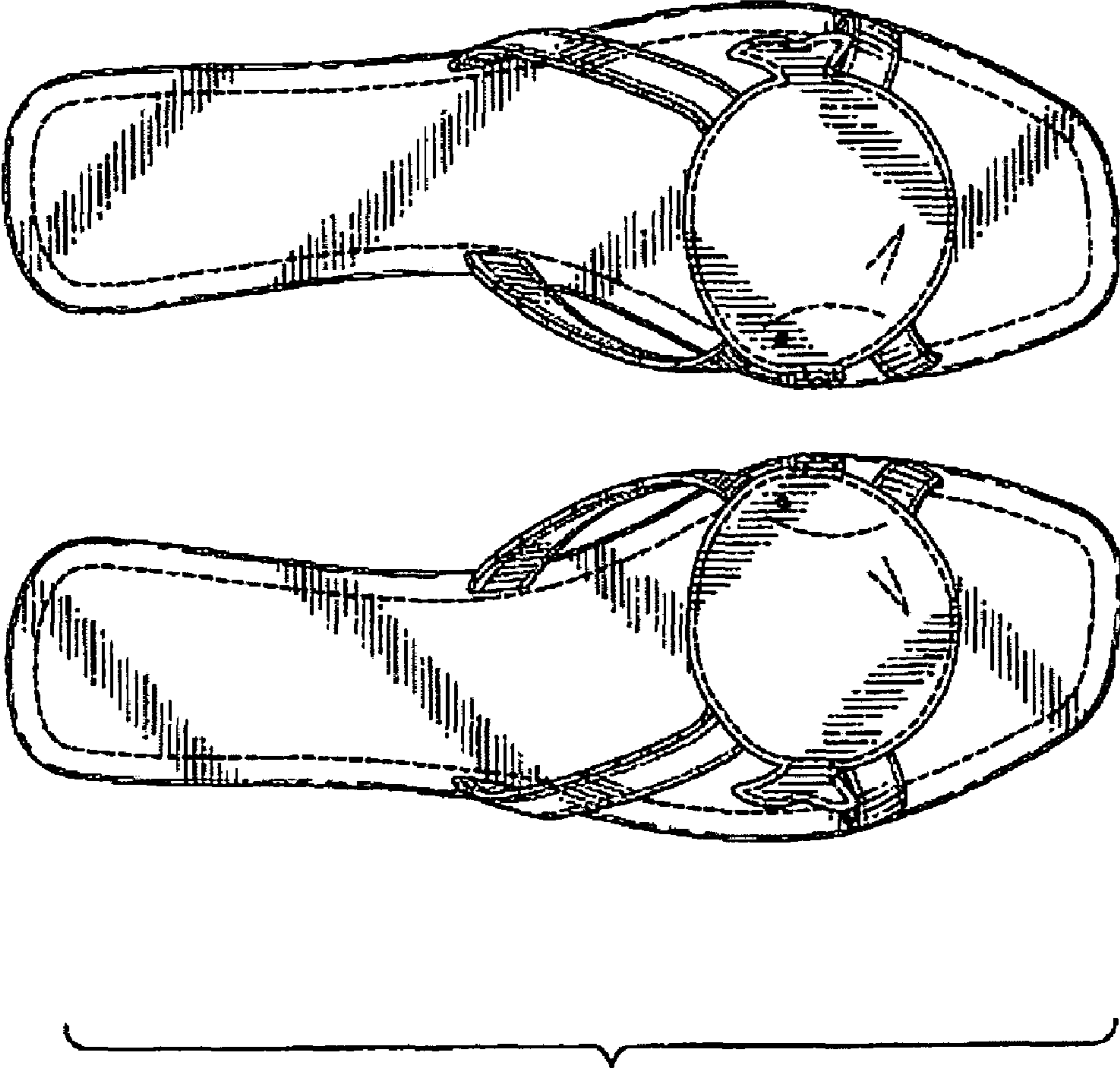

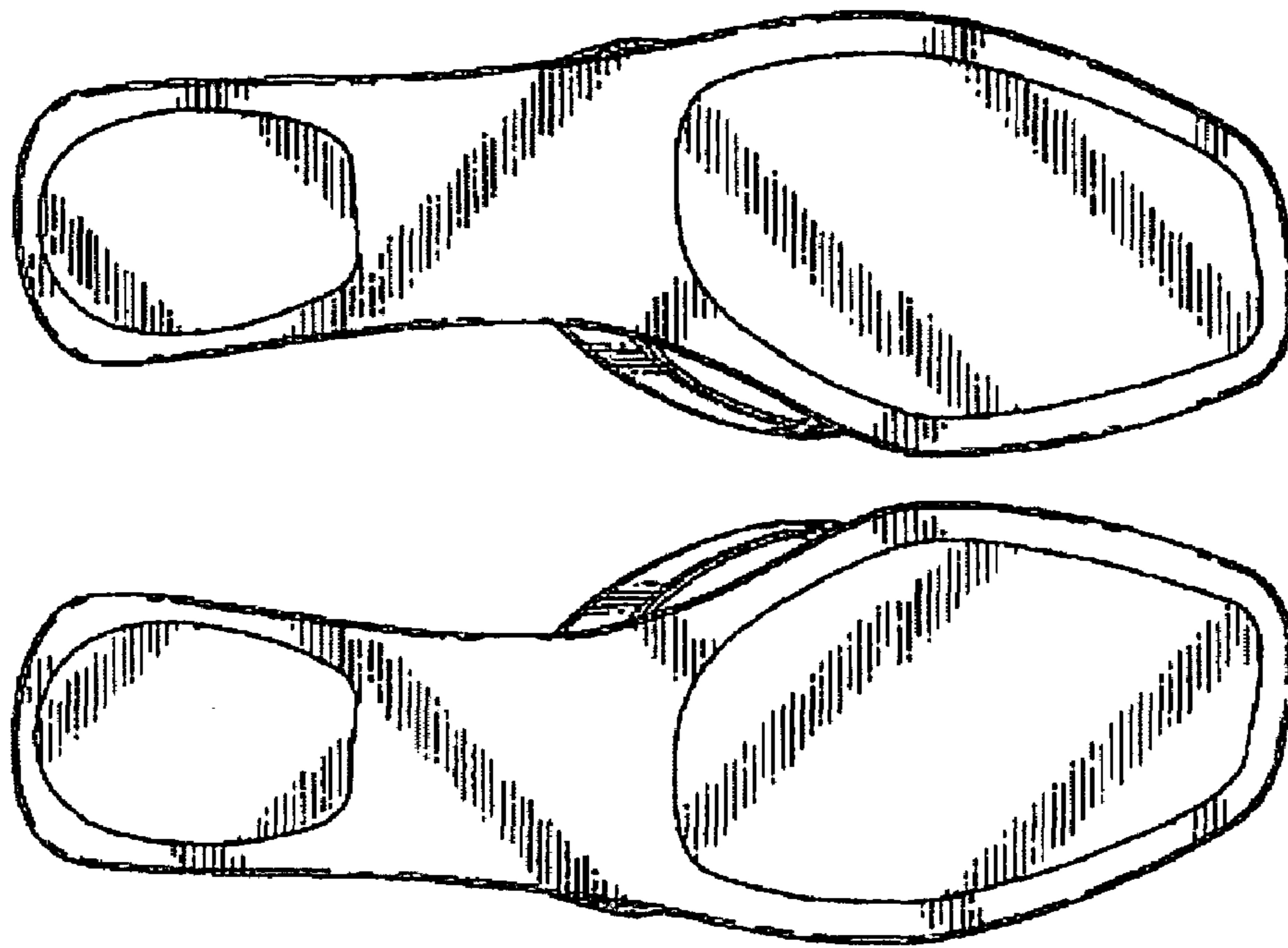

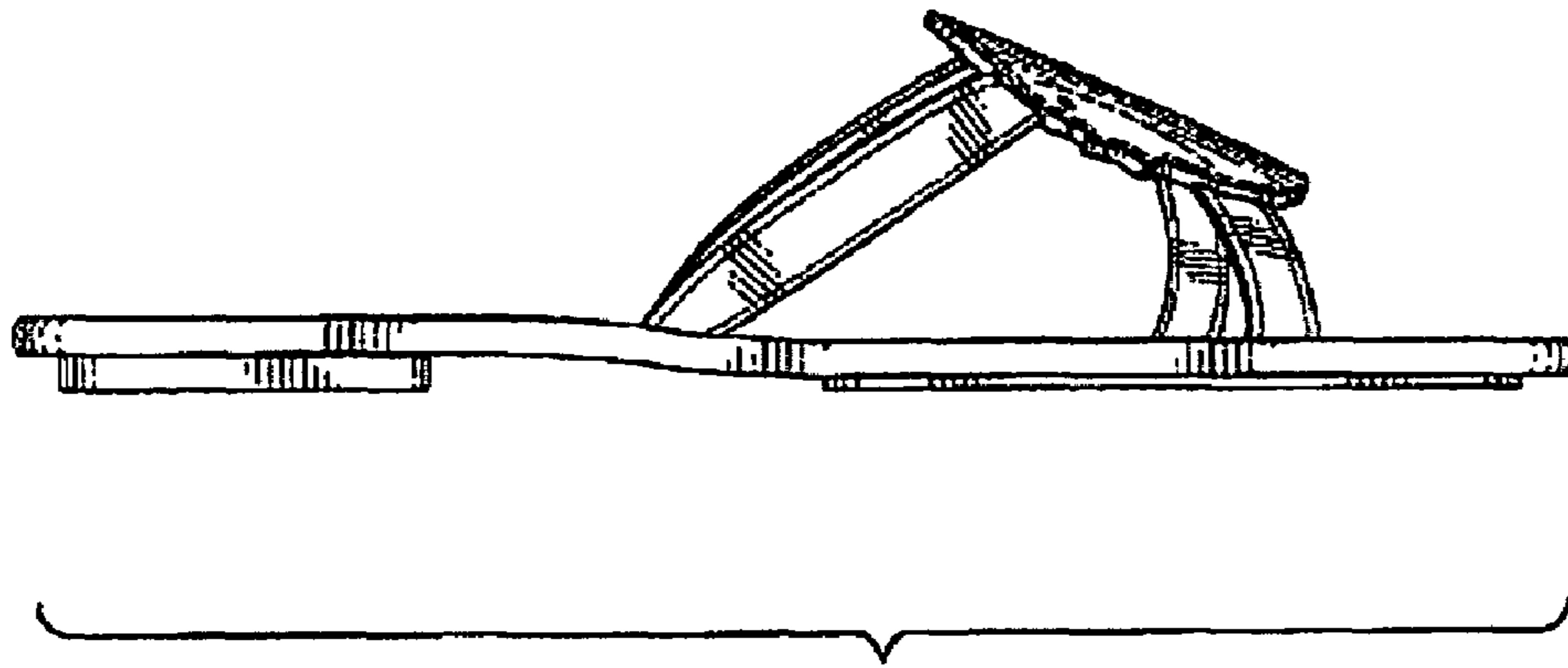

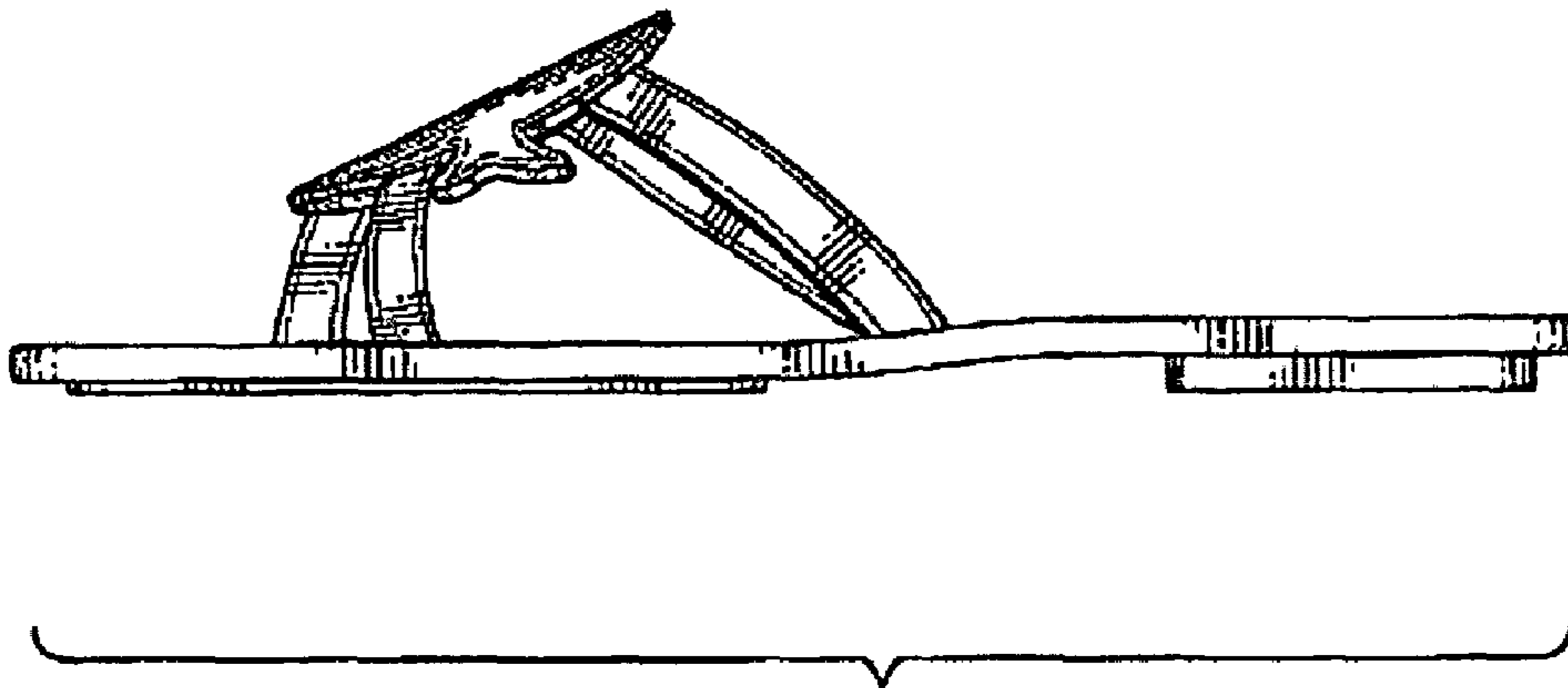

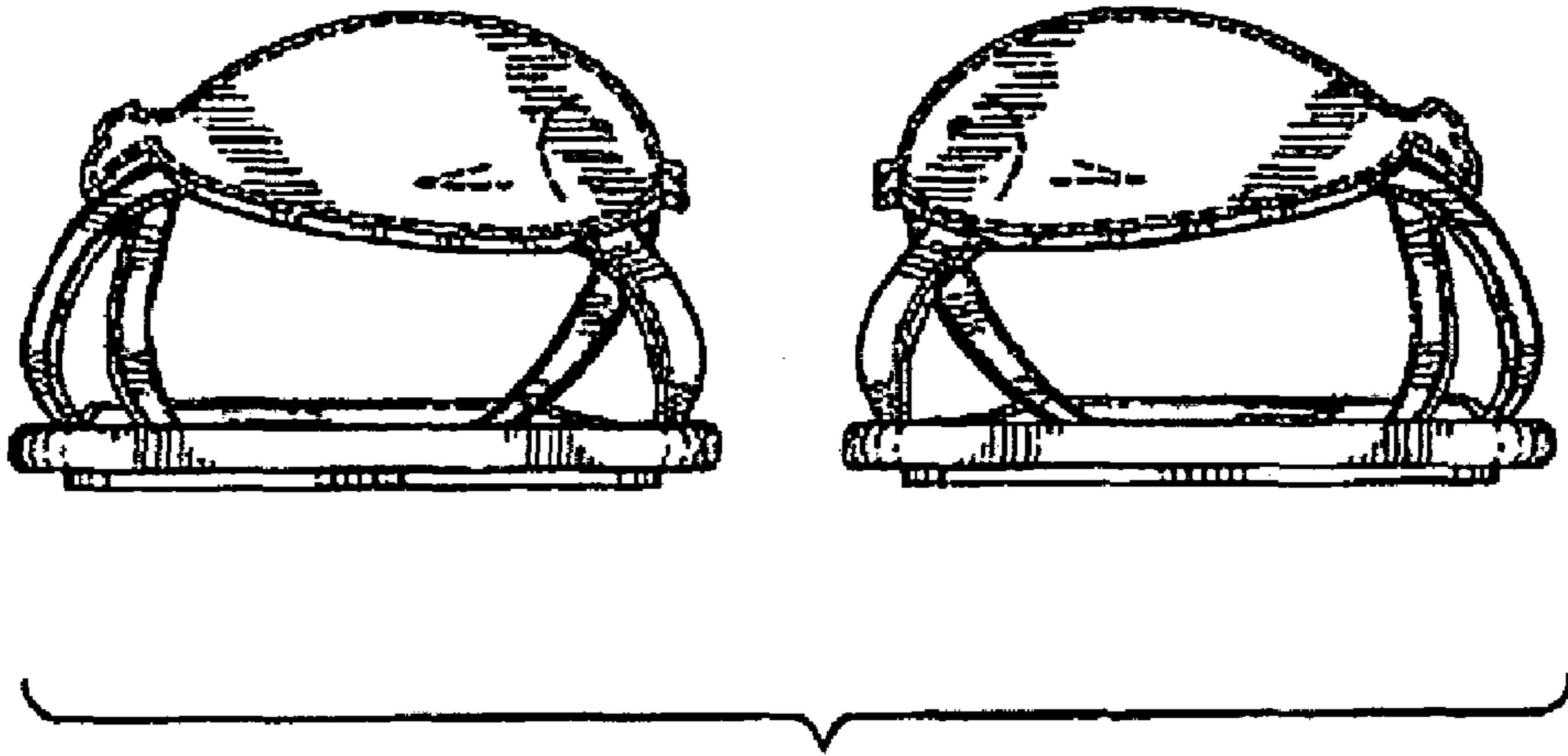

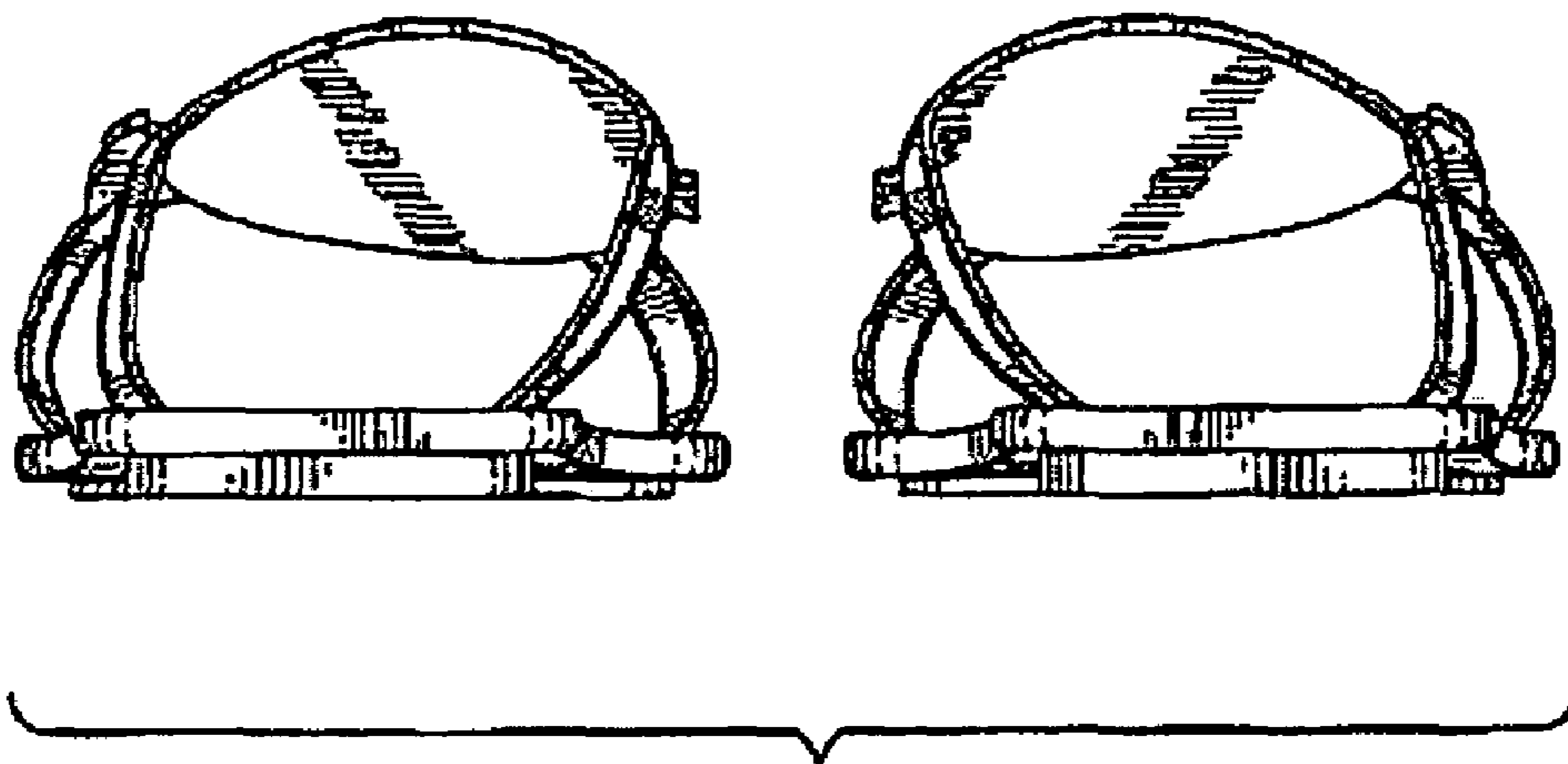
