FIG. 7 is the front view of the double handcuff case with phantom lines indicating sets of handcuffs within the double handcuff case for reference only, the handcuffs not being included as part of the disclosed invention,

FIG. 8 is a front view of the double handcuff case in an alternative position,

FIG. 9 is a right side view of the double handcuff case in an alternative position with phantom lines indicating sets of handcuffs within the double handcuff case for reference only, the handcuffs not being included as part of the disclosed invention; and,

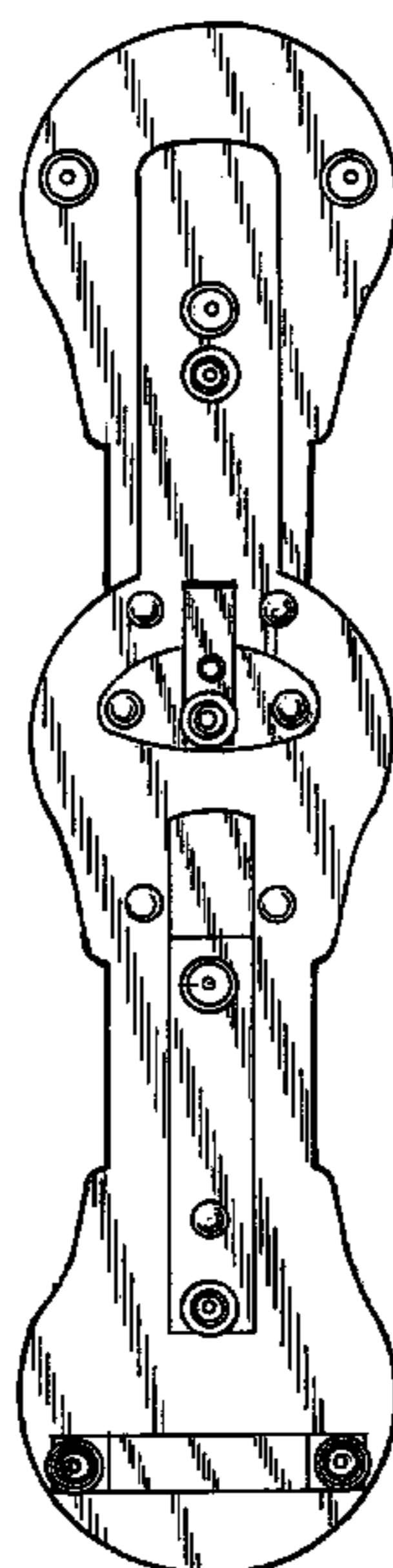

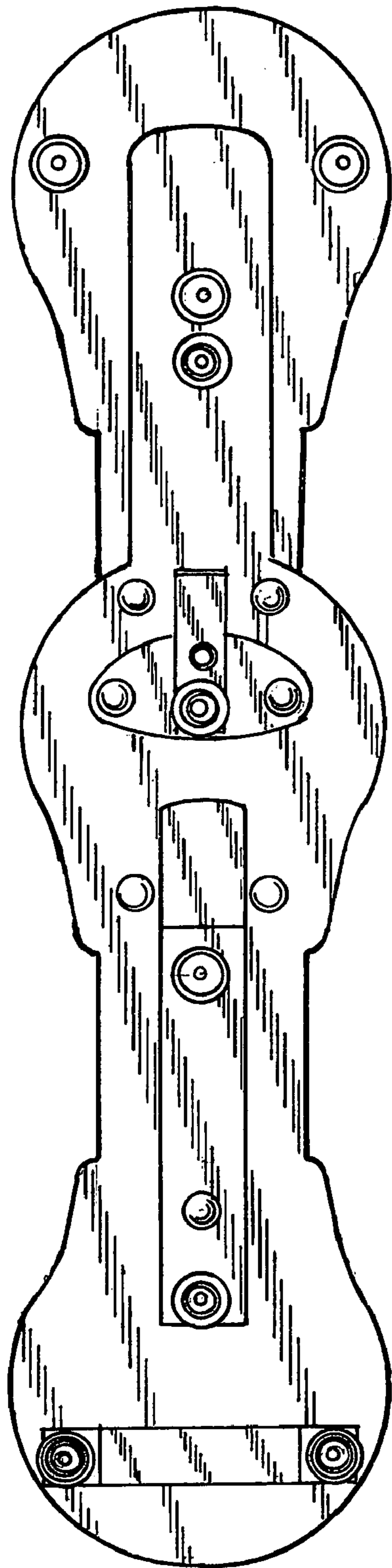

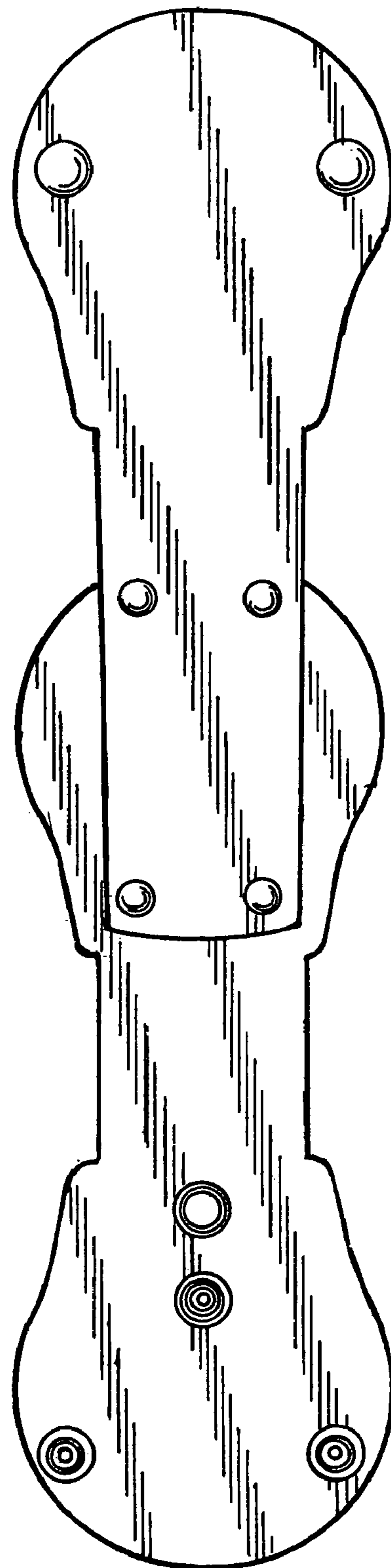

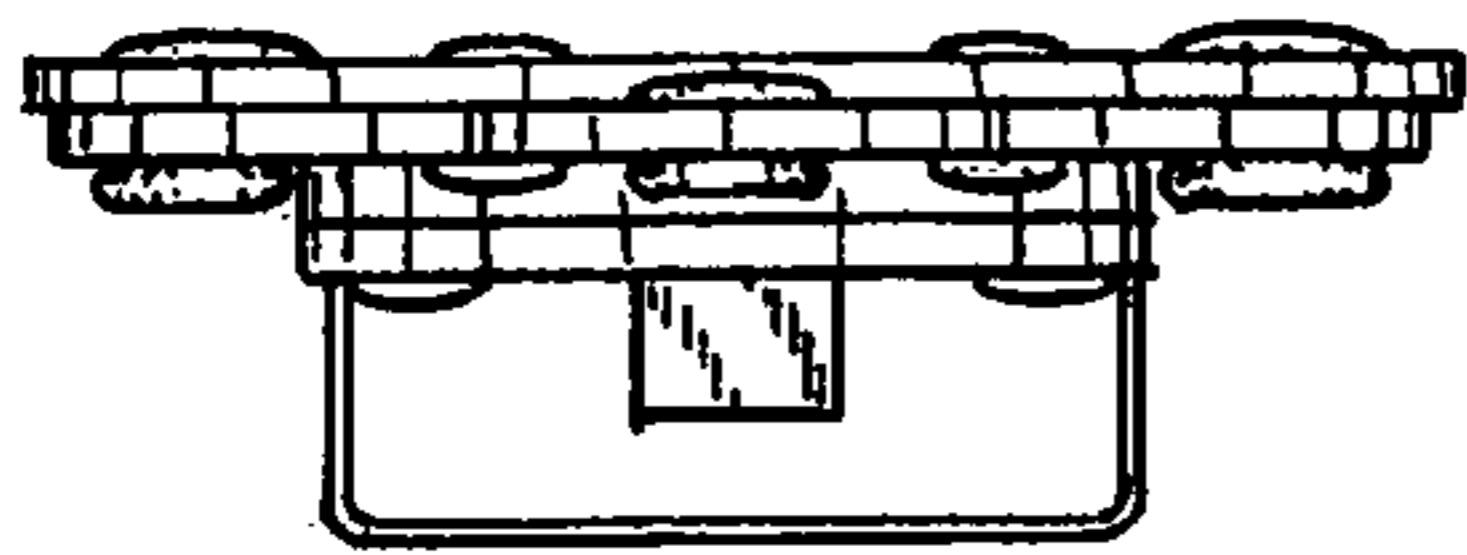

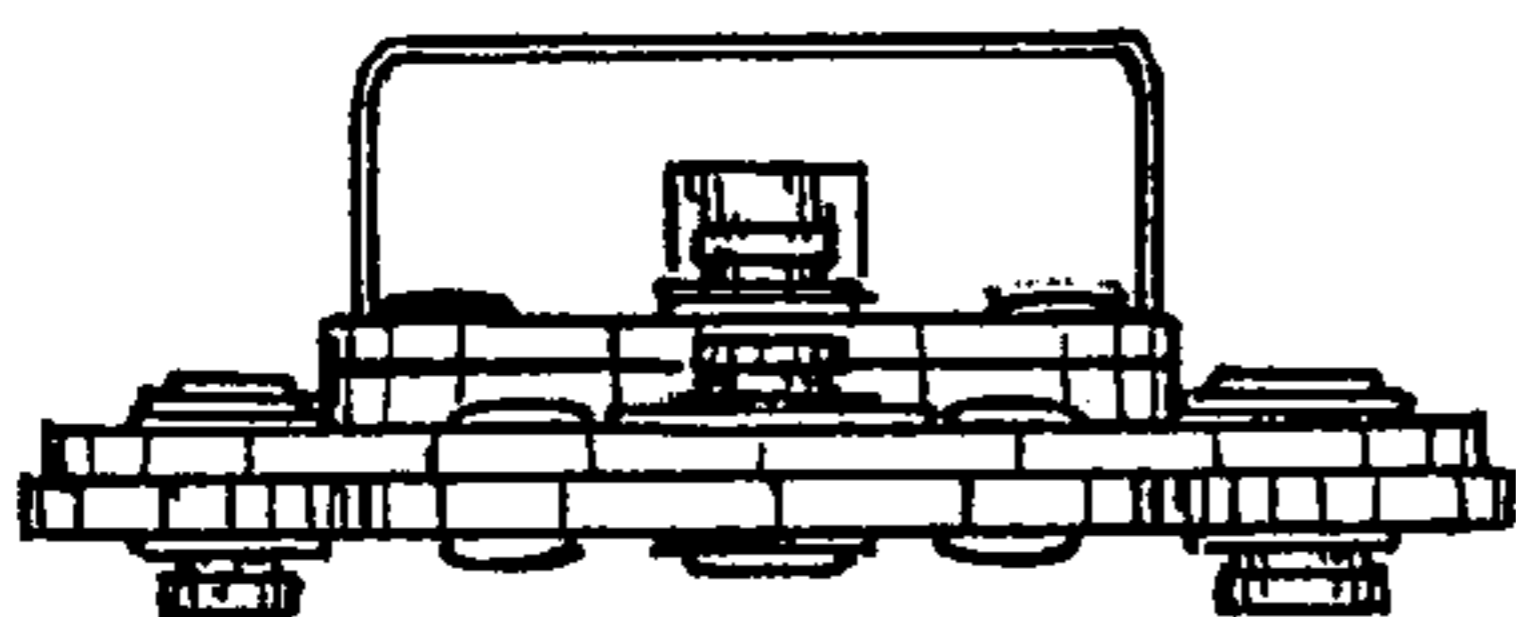

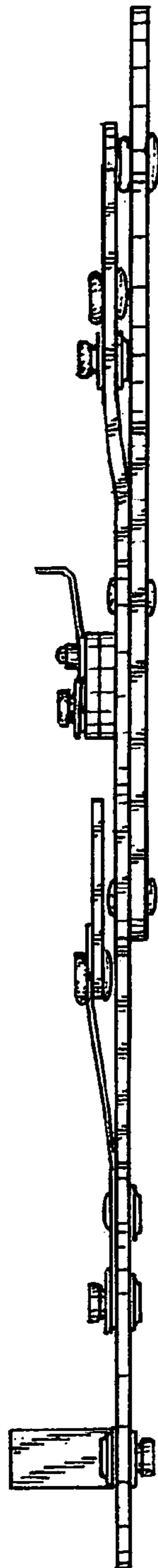

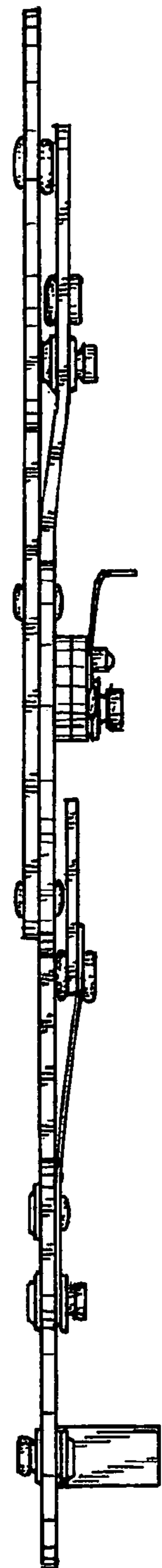

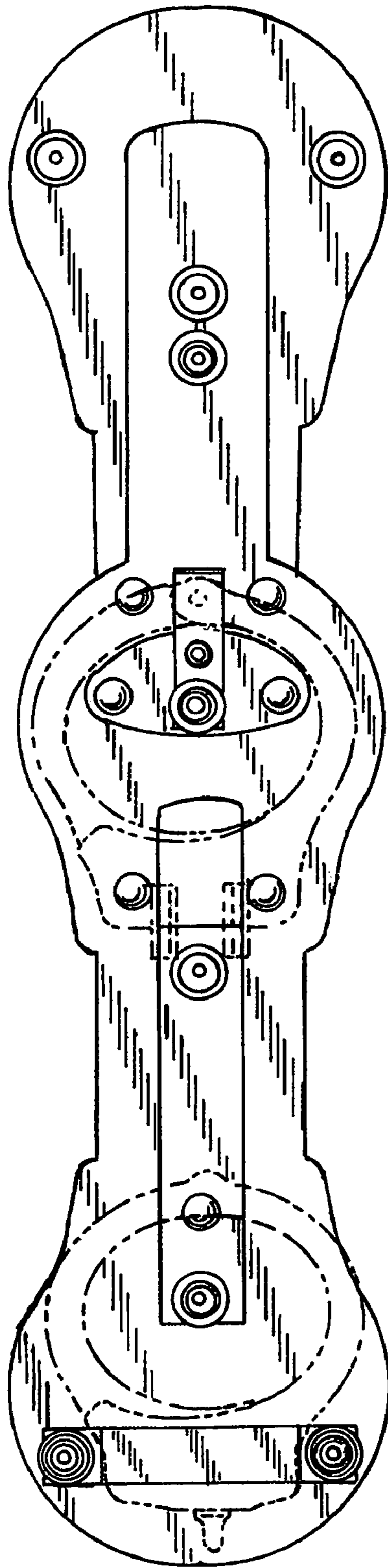

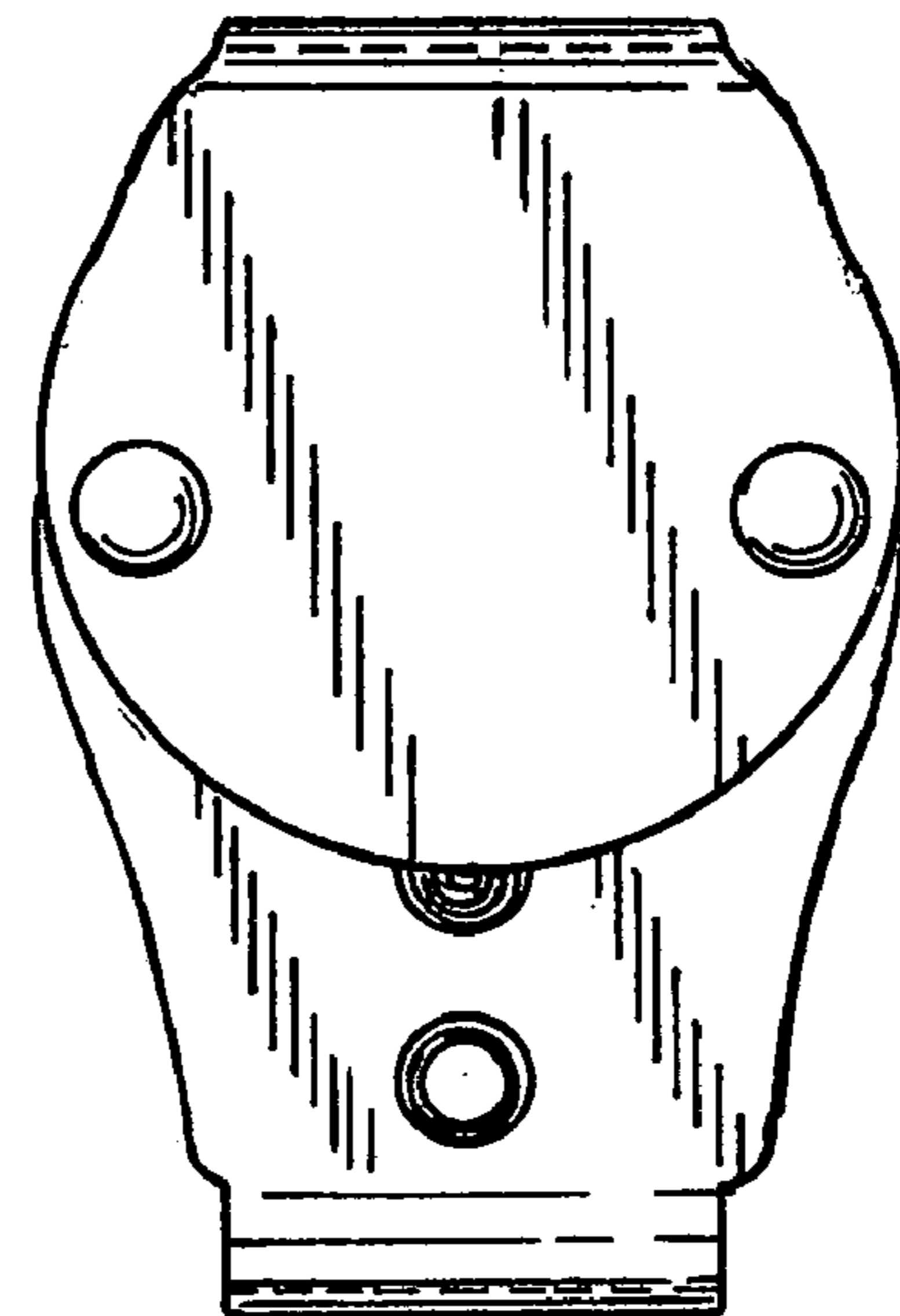

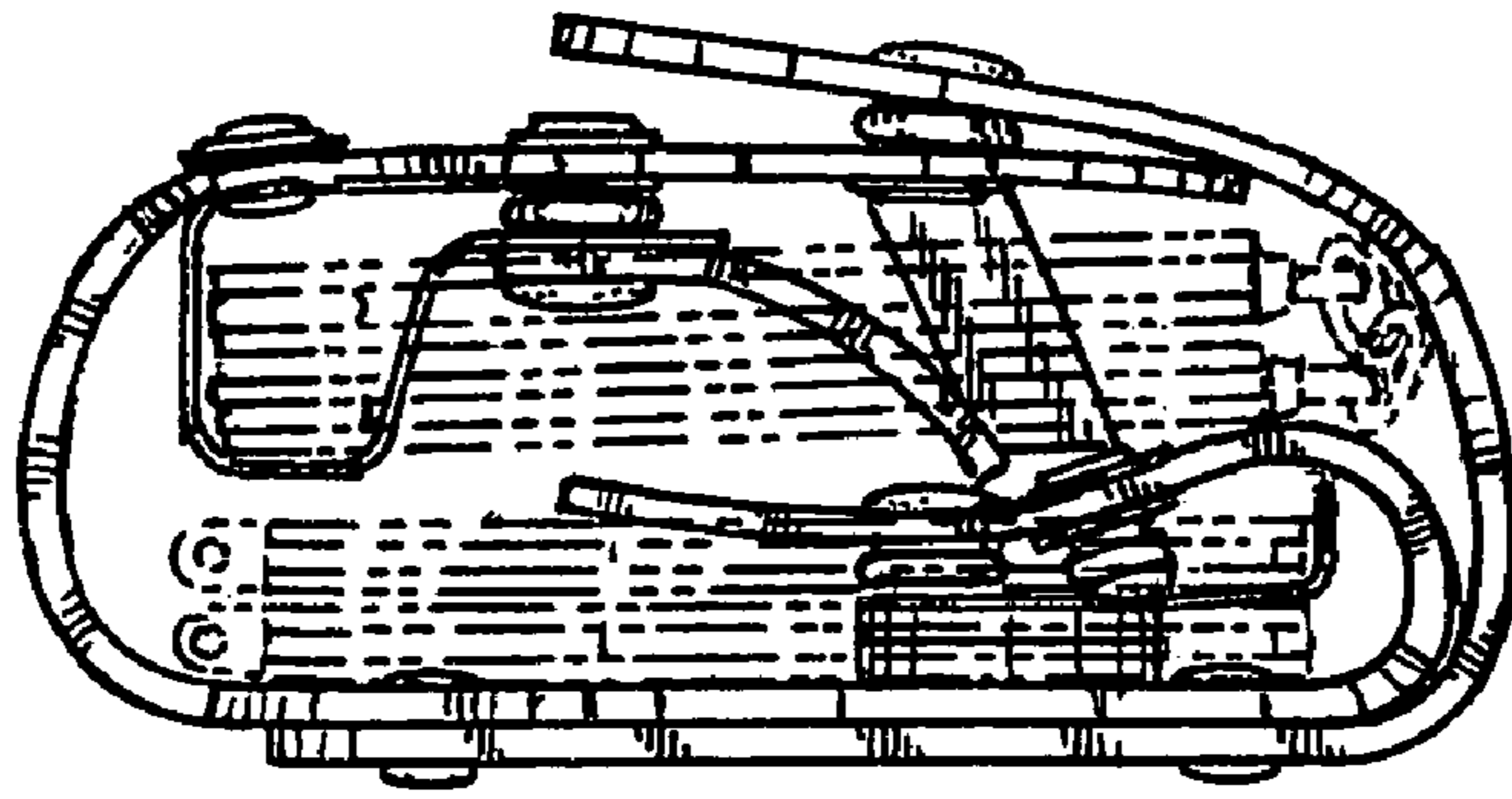

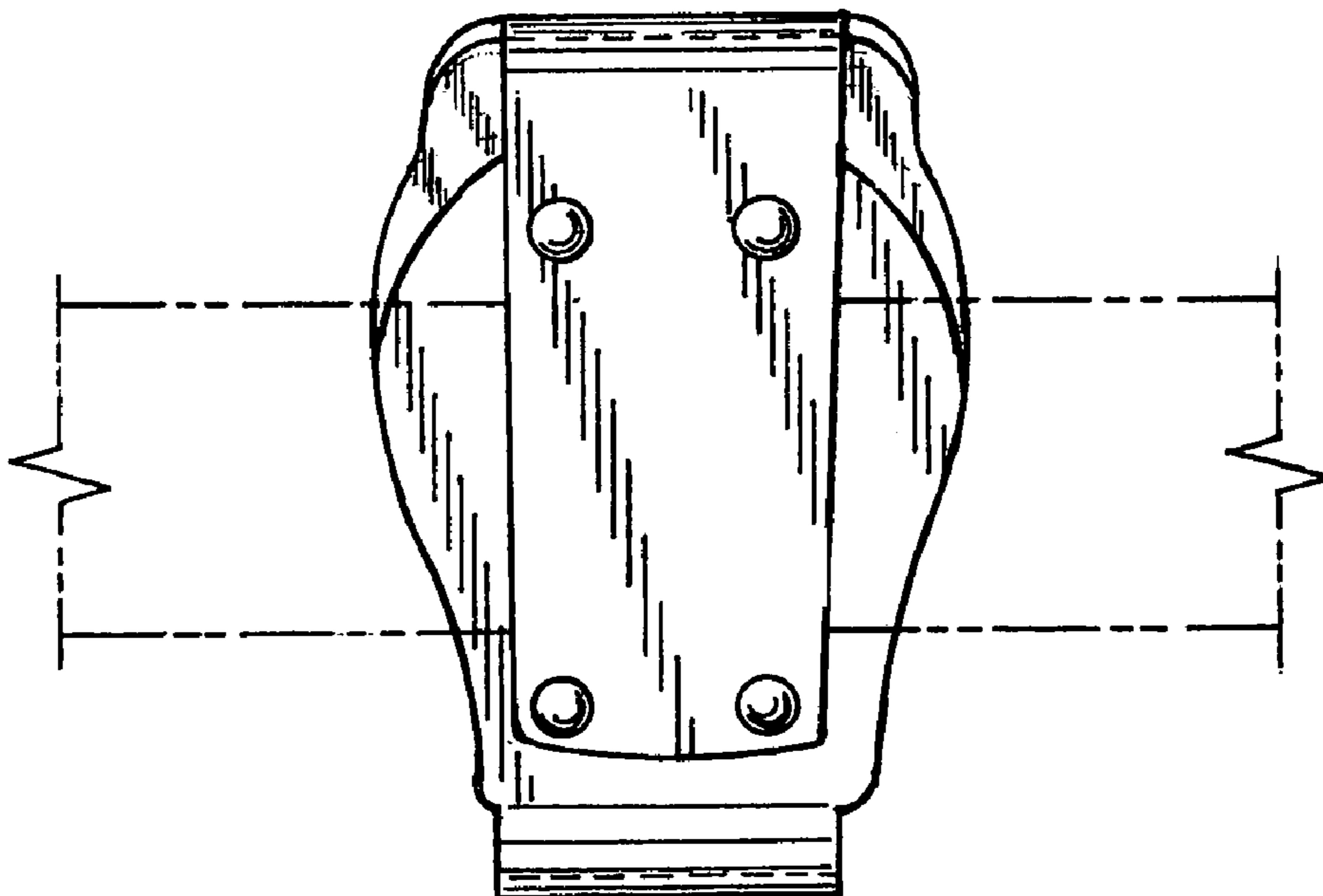
