side view being a mirror image;

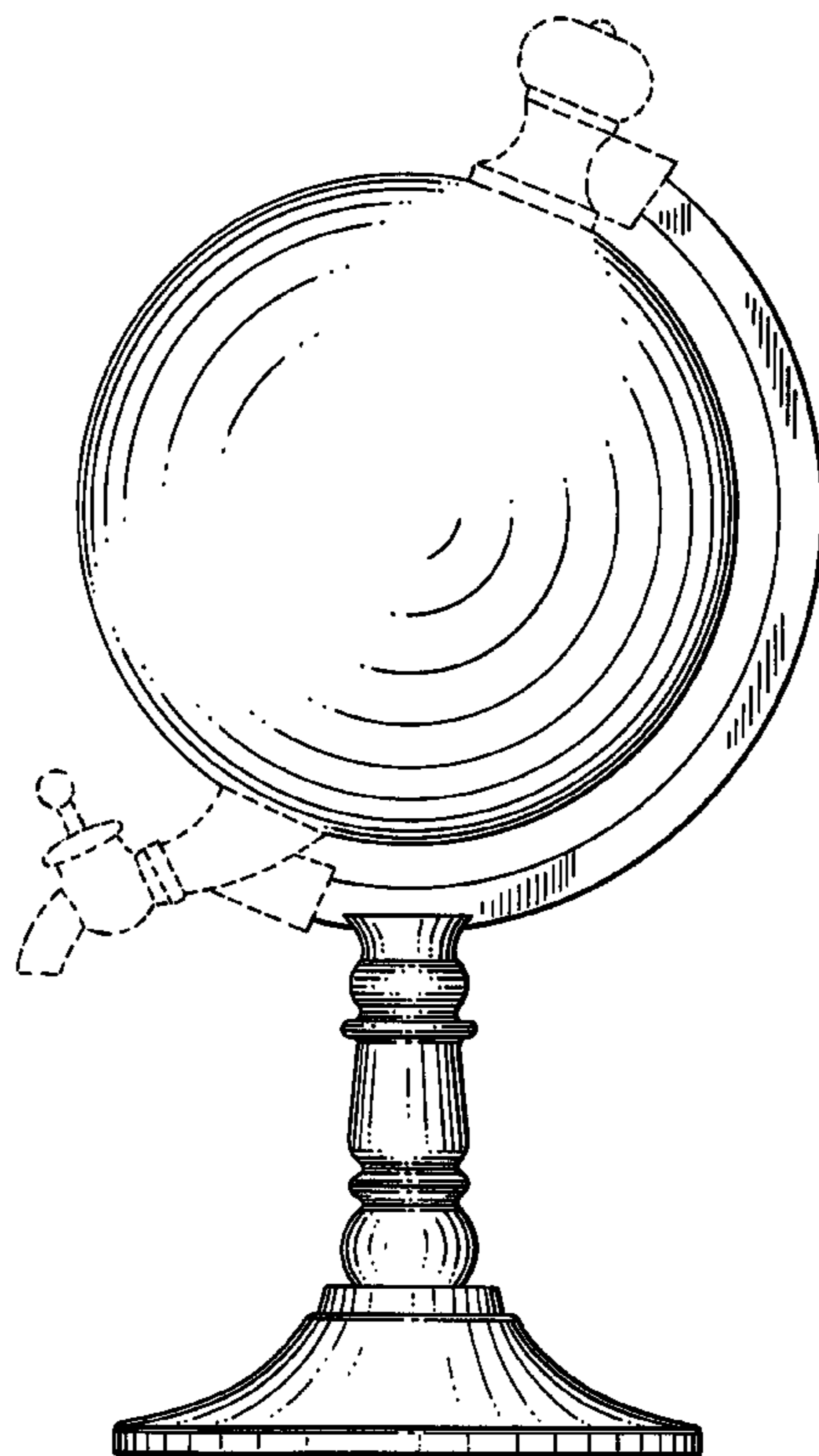
FIG. 2 is a top view thereof;

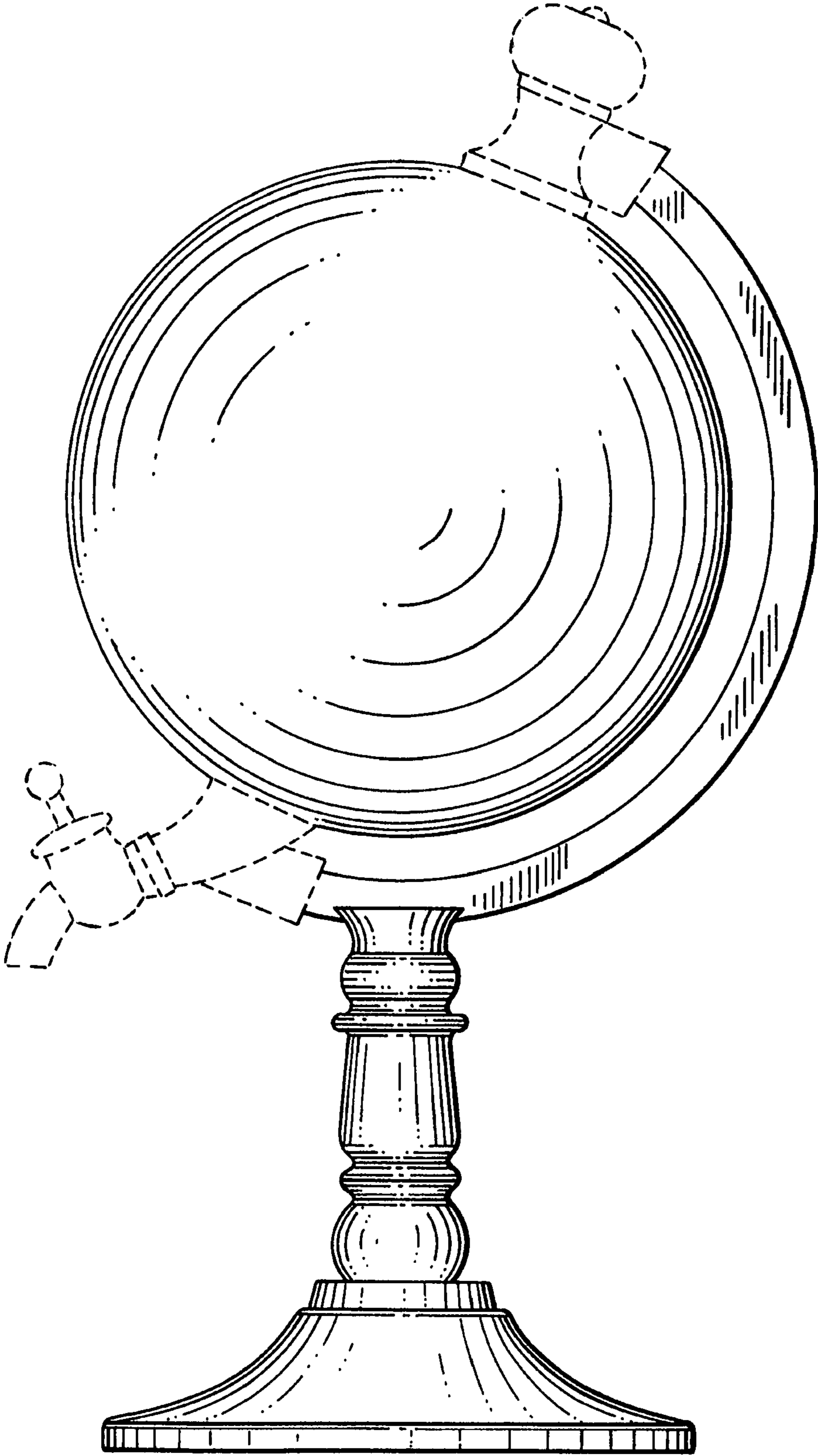

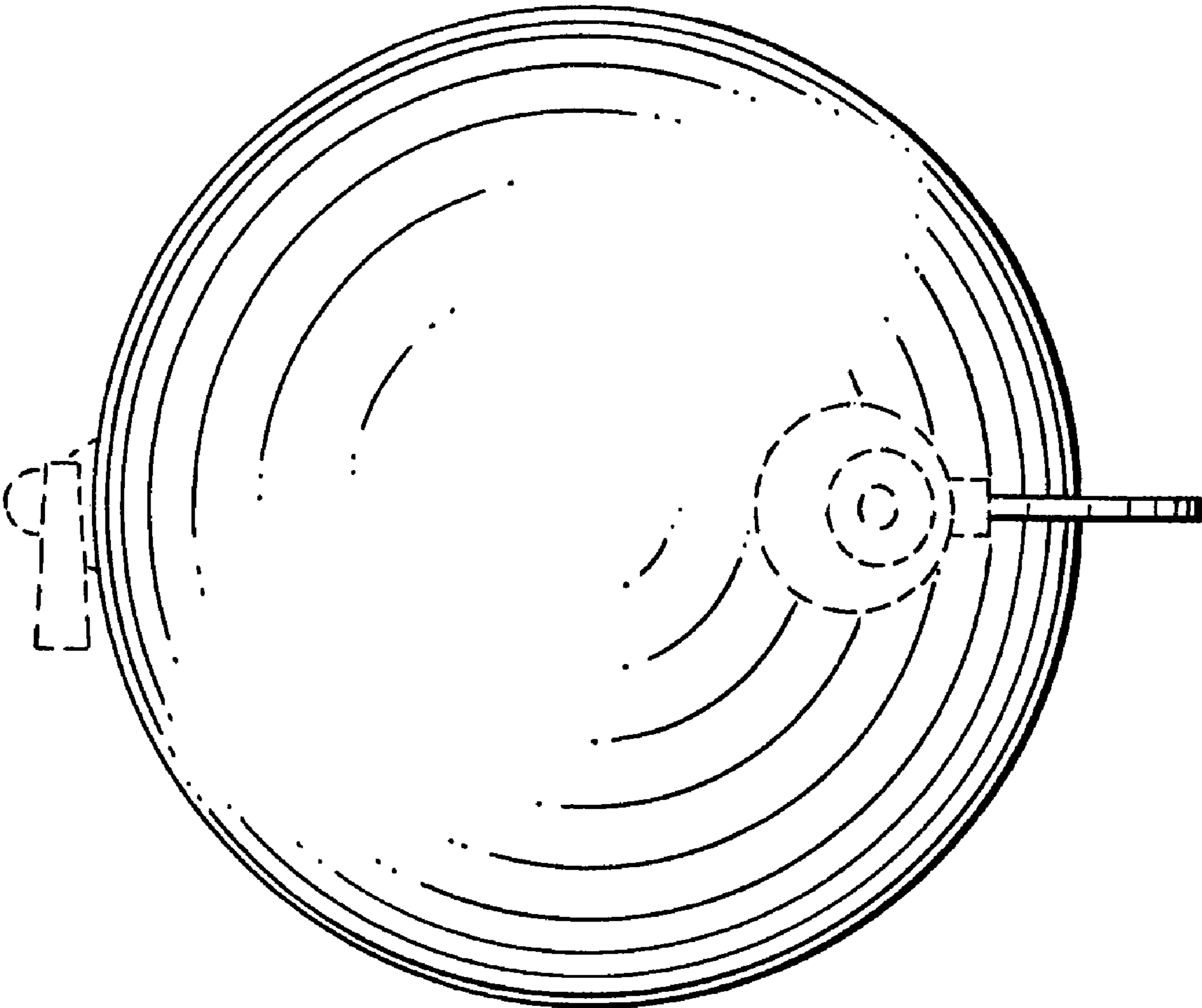

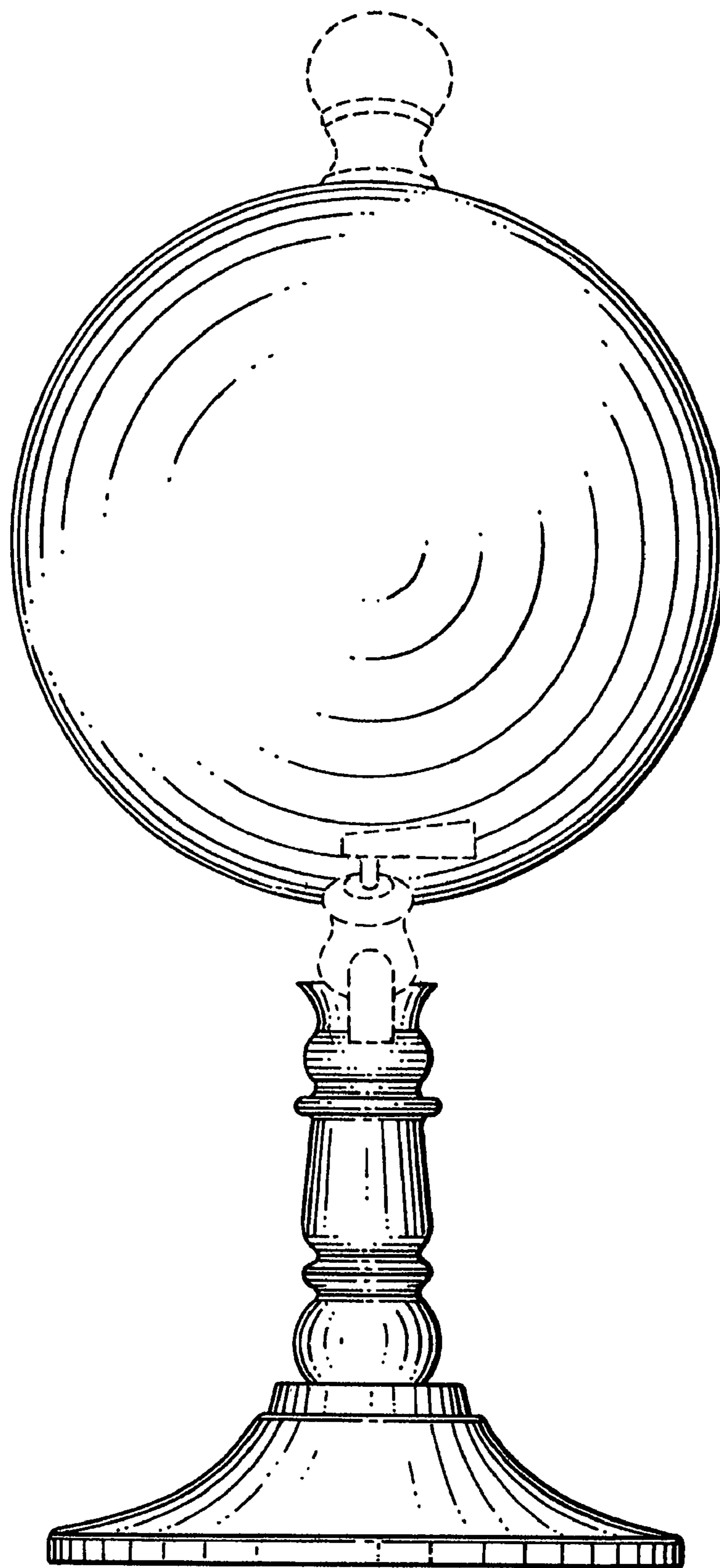

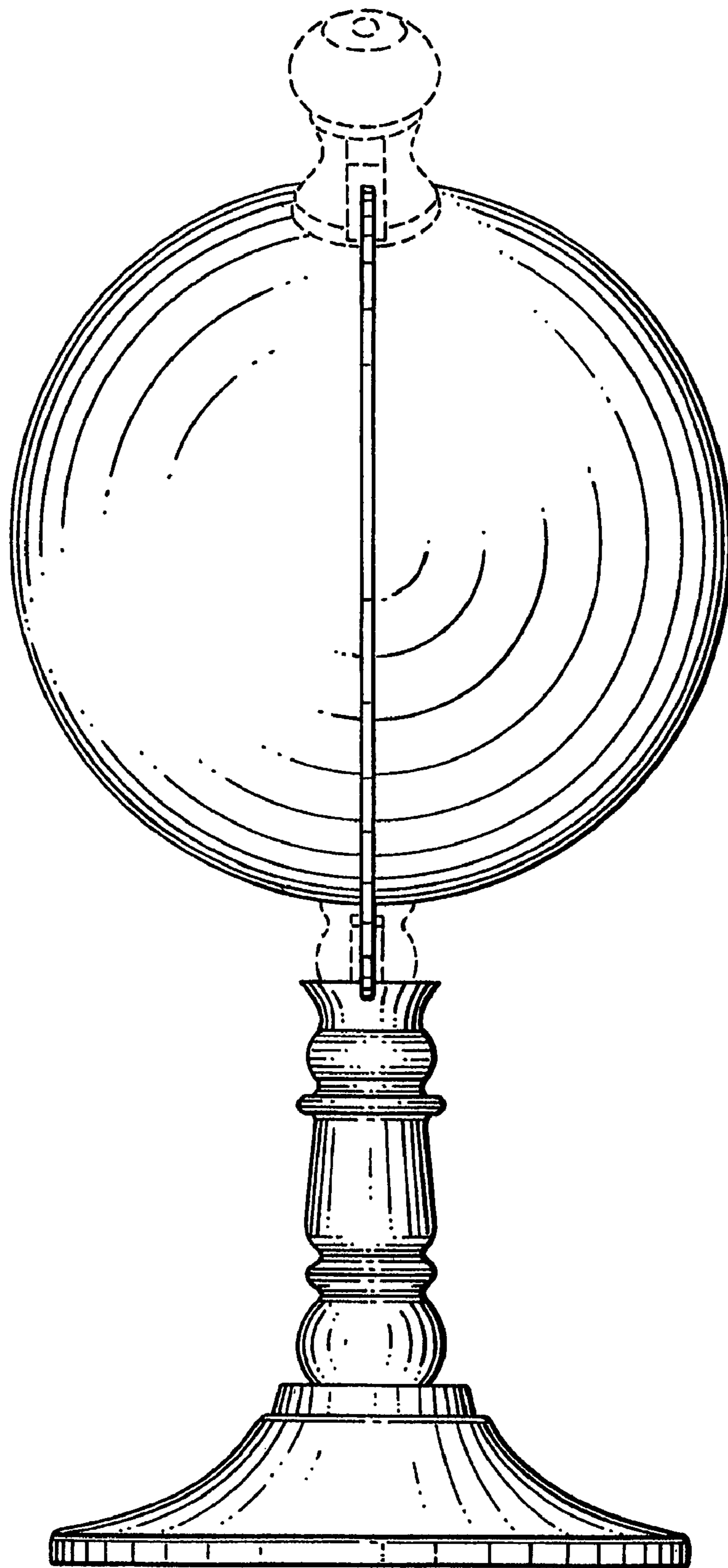

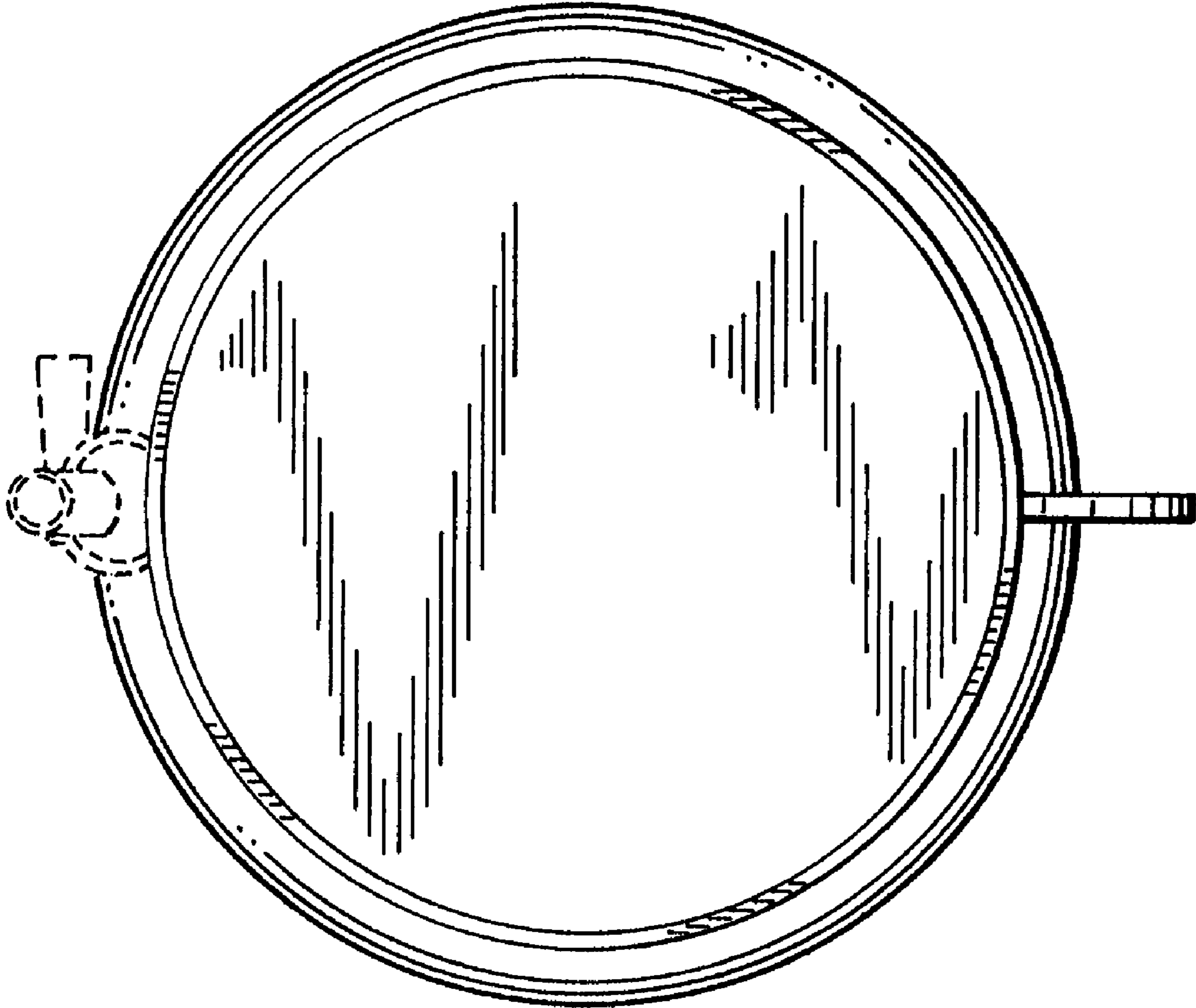
