DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a drink dispenser showing our new design;

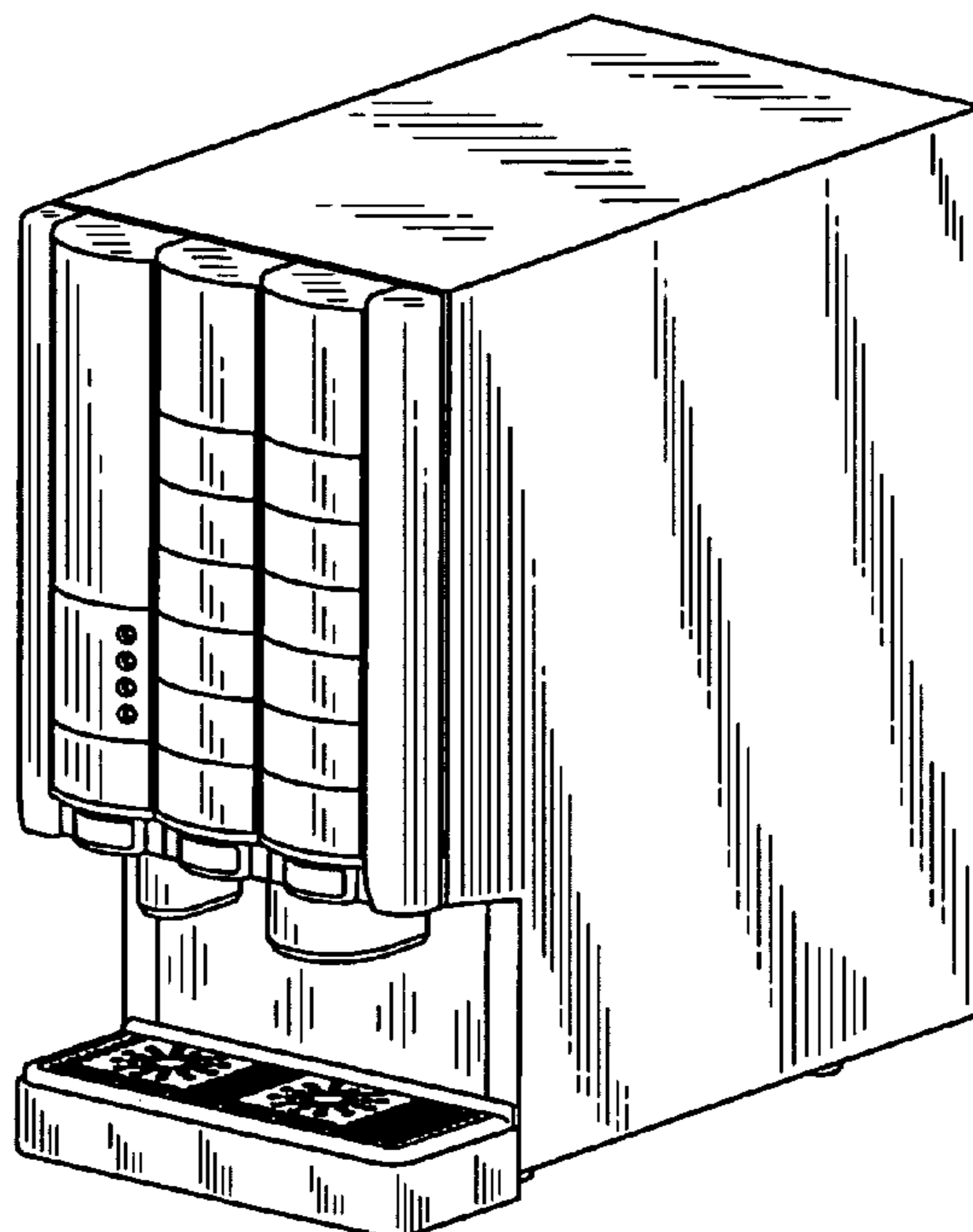

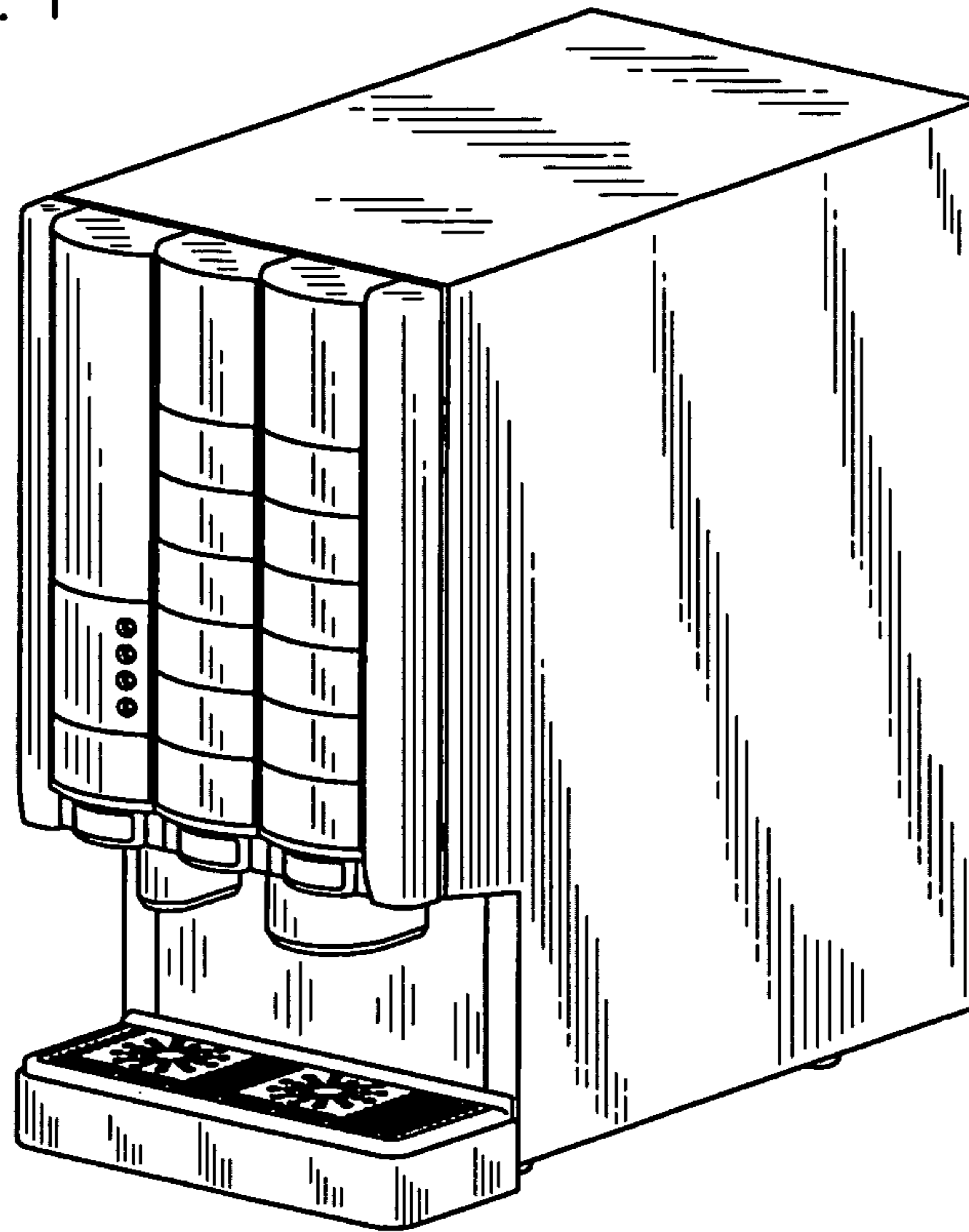

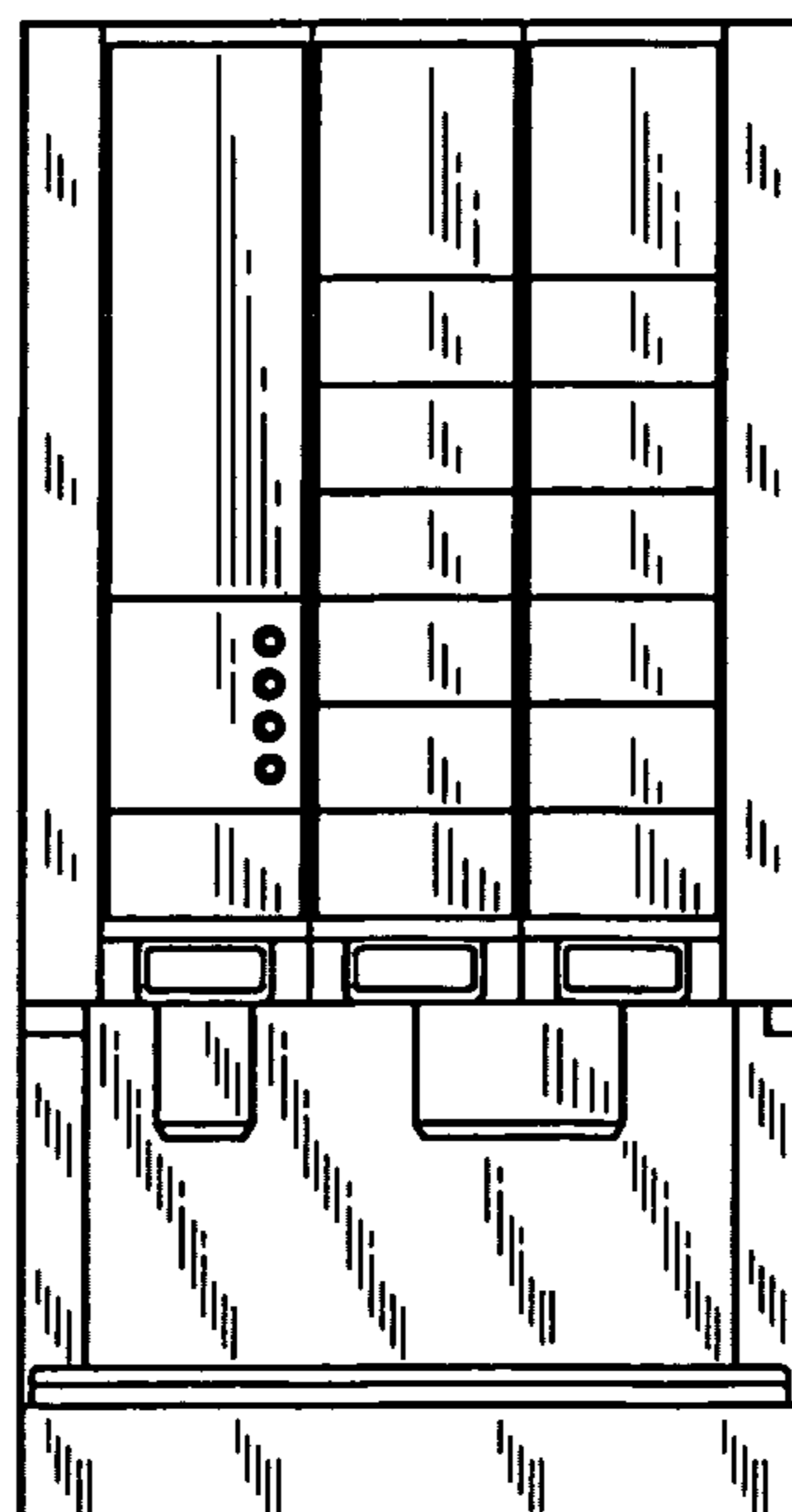

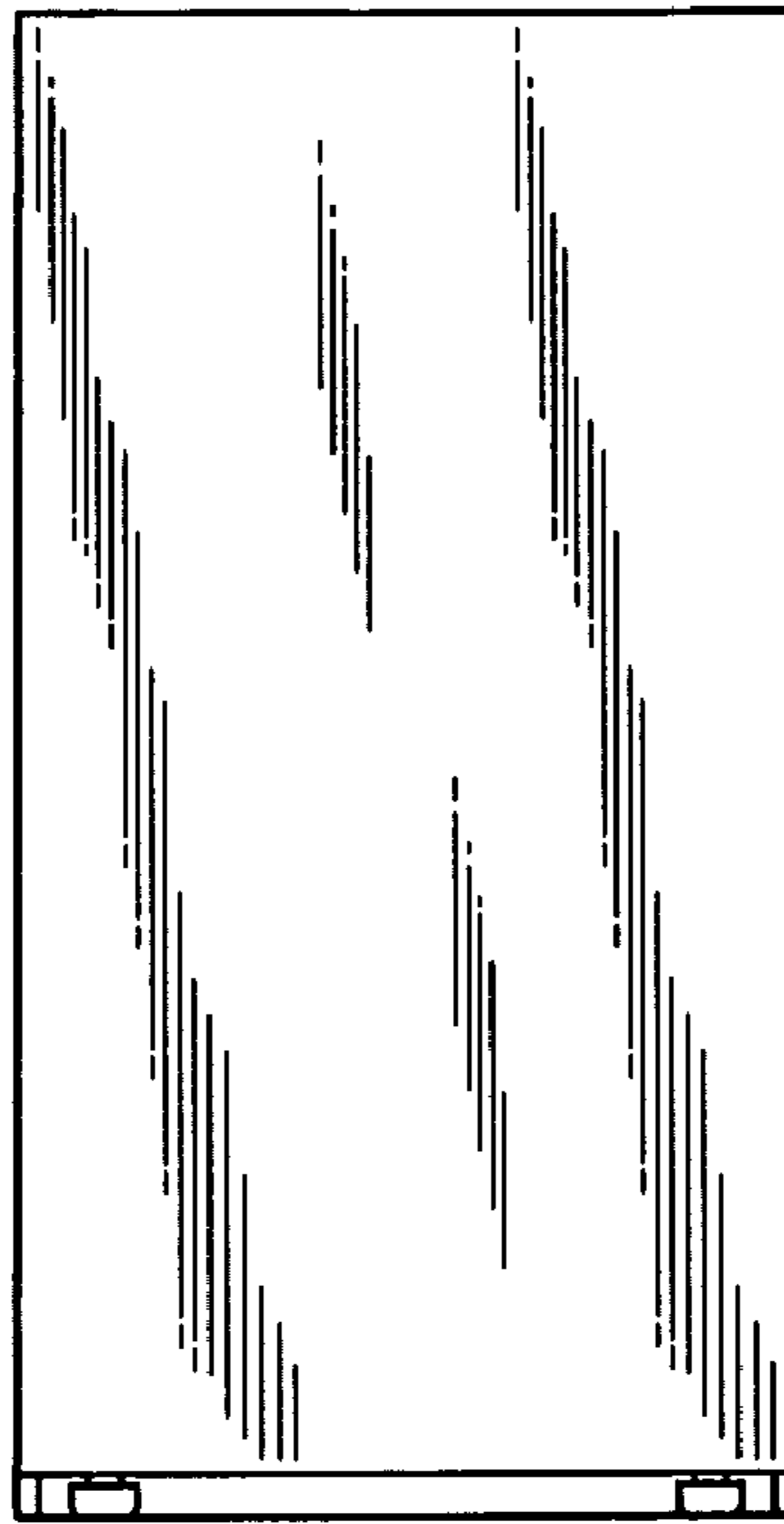

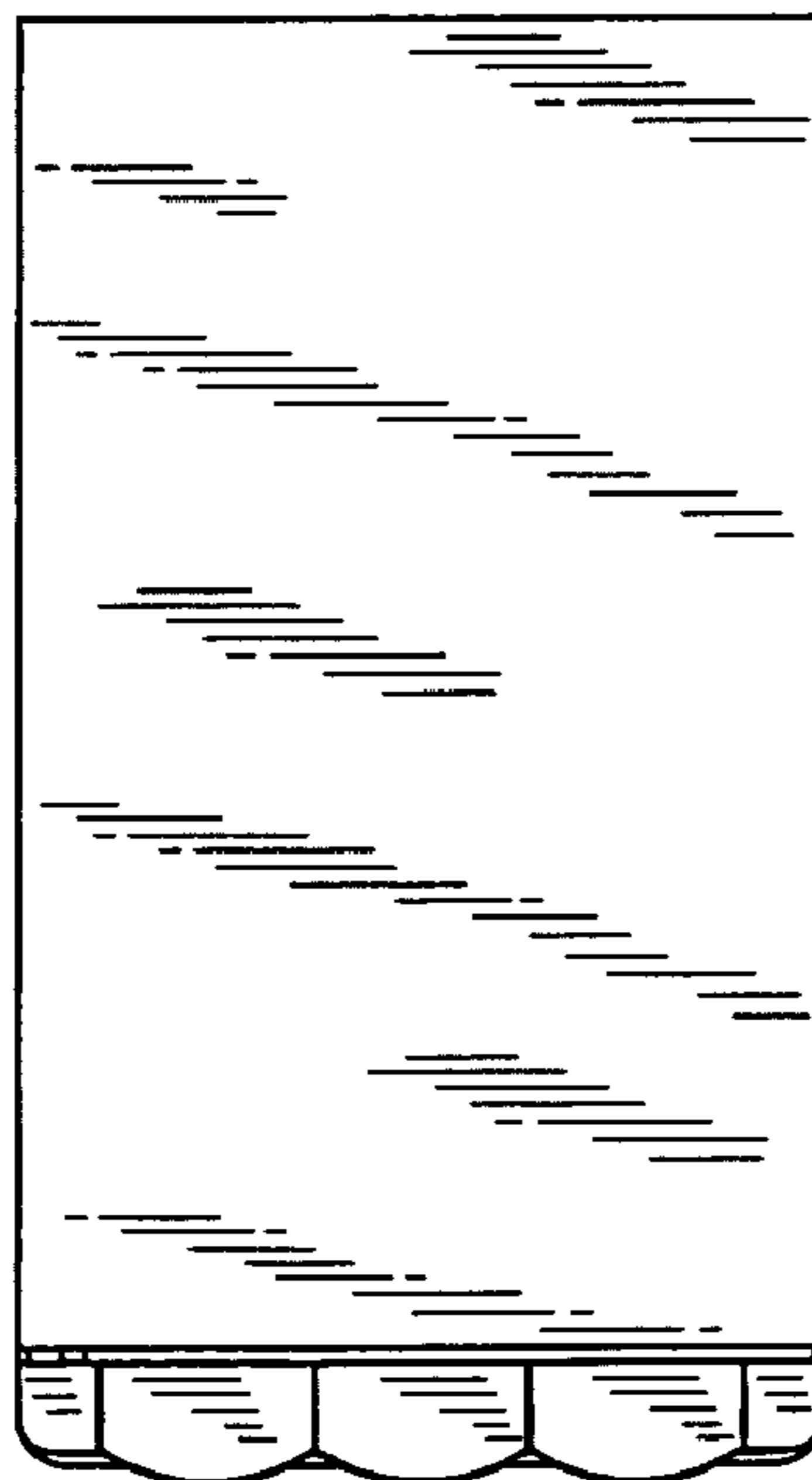

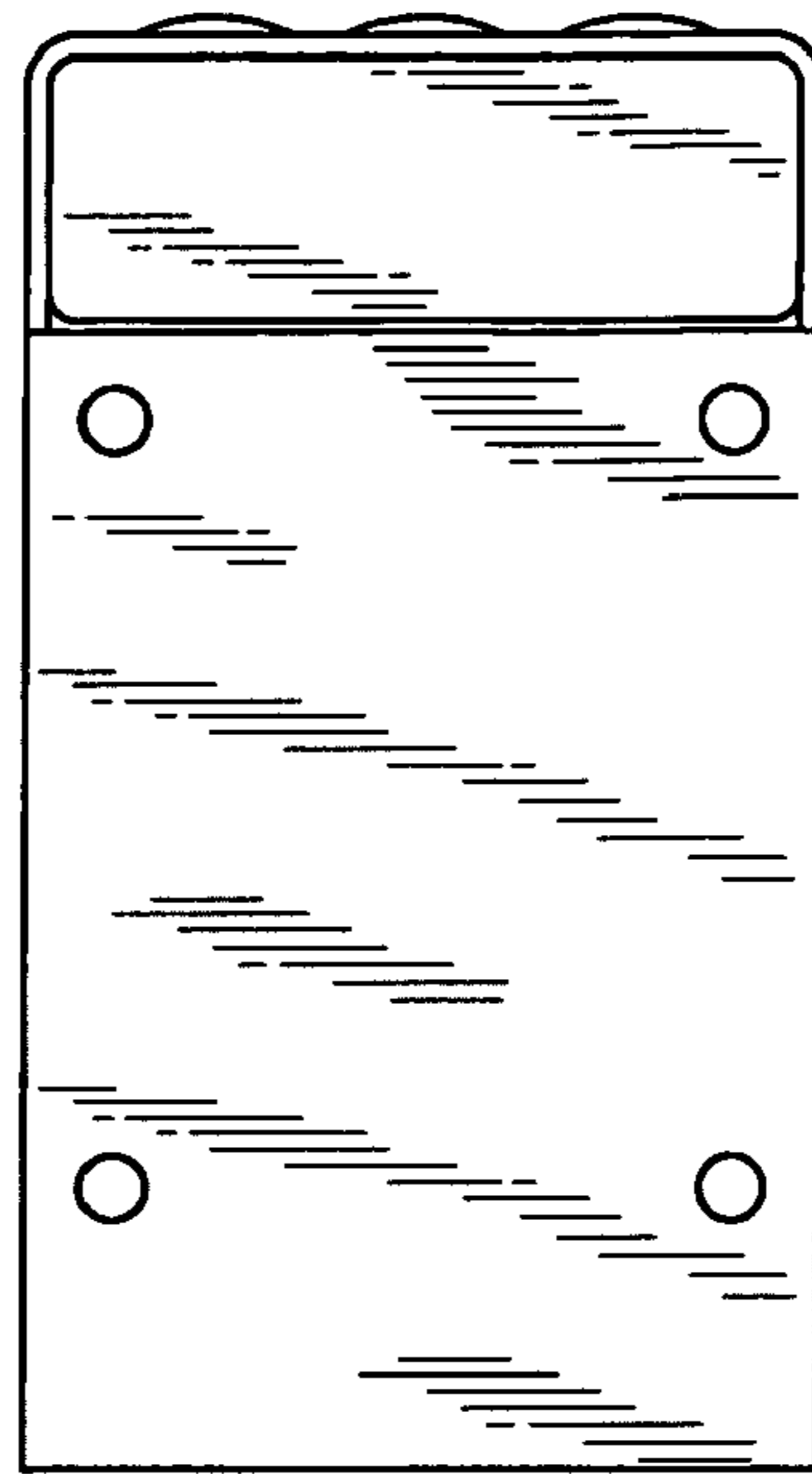

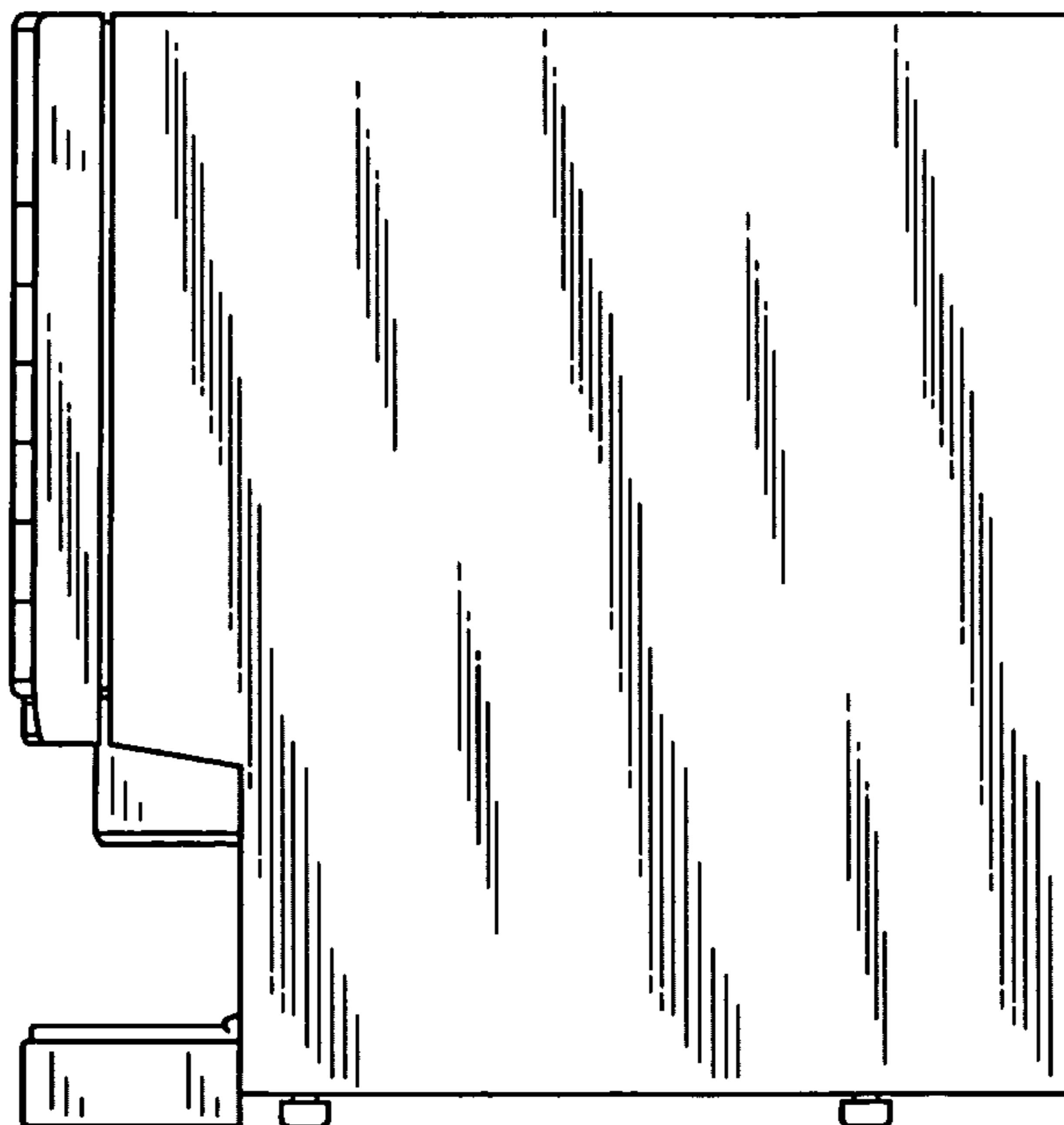
