FIG. 5 is a perspective view a second embodiment of my new design;

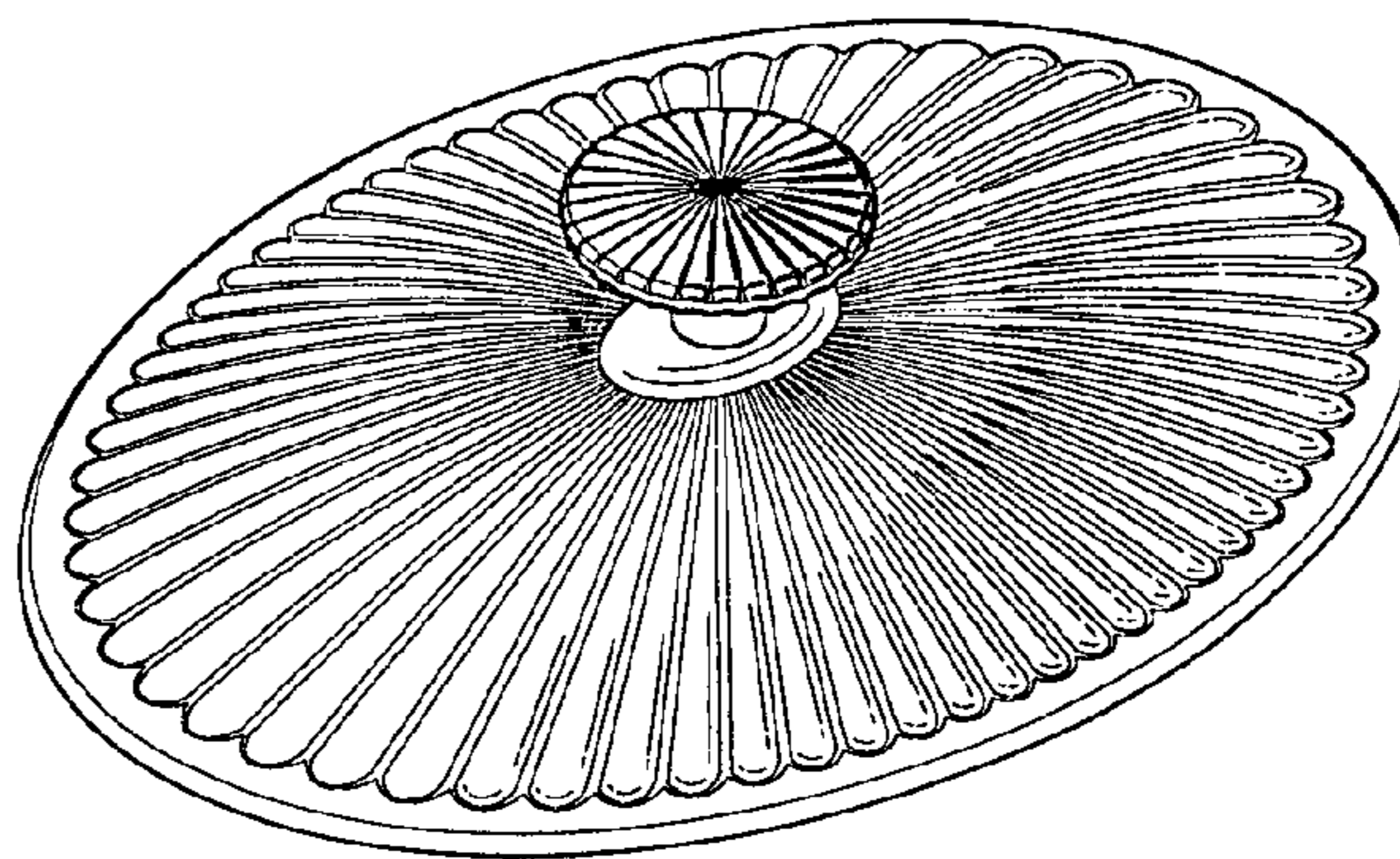
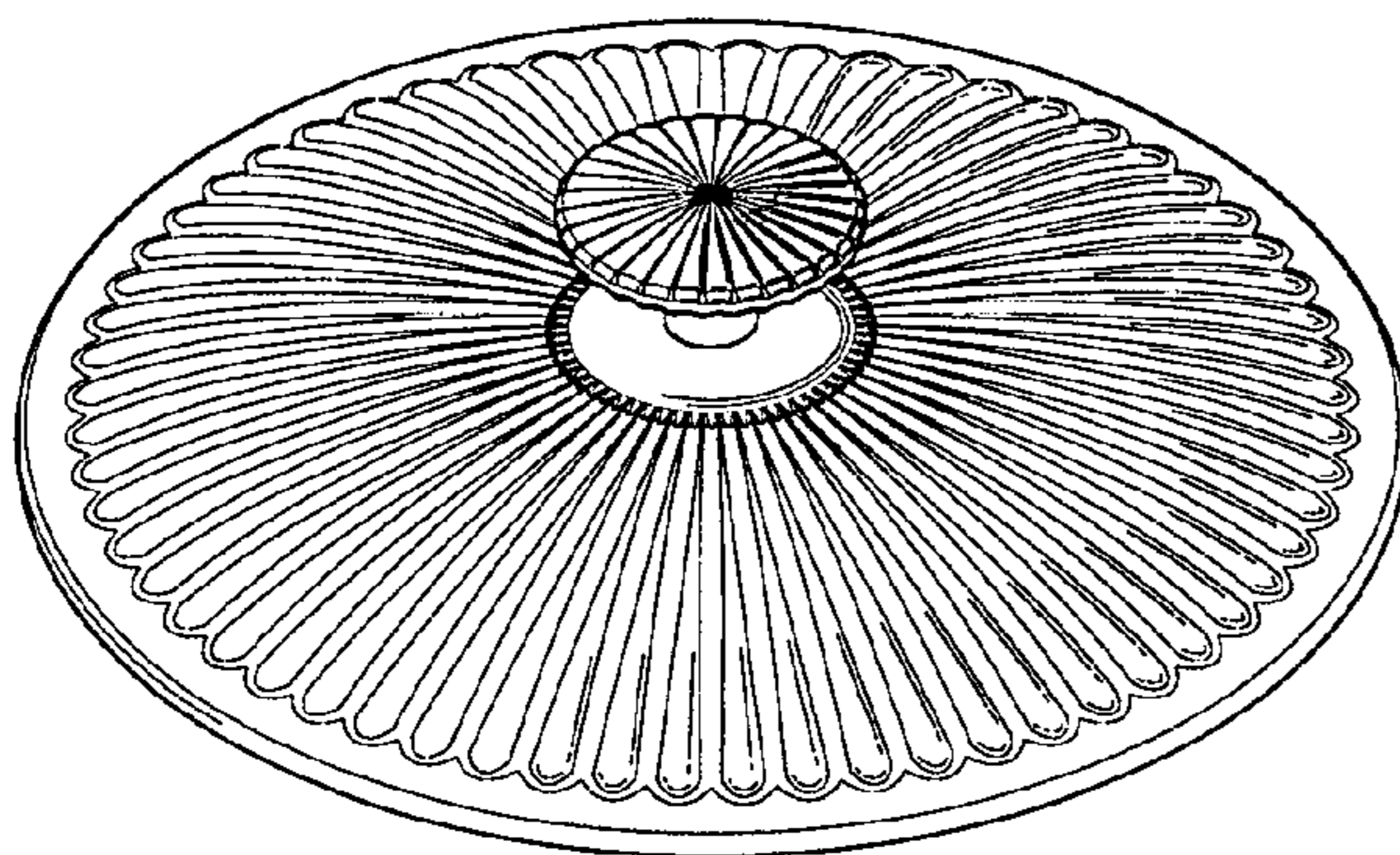
FIG. 6 is a top plan view of the second embodiment;

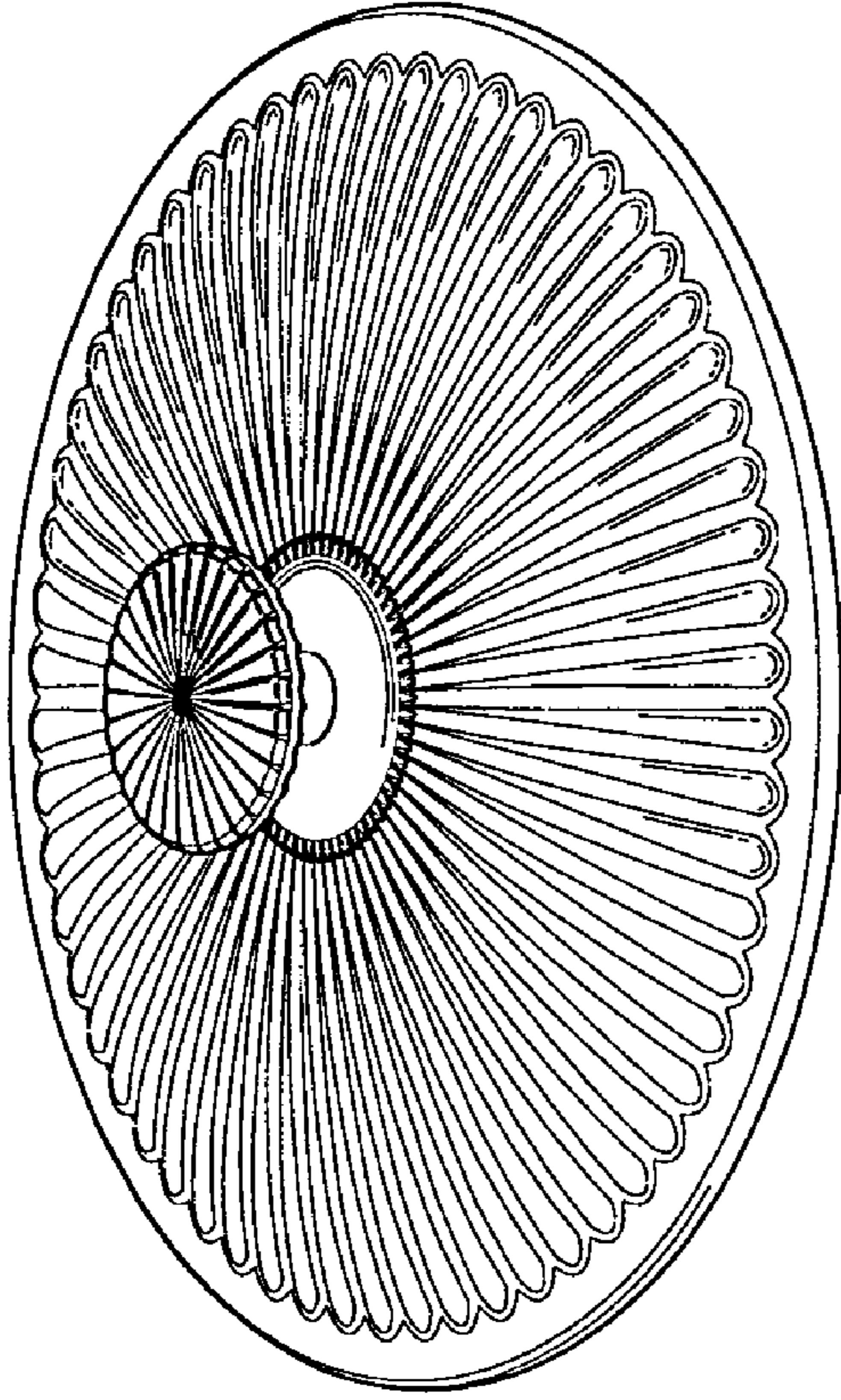

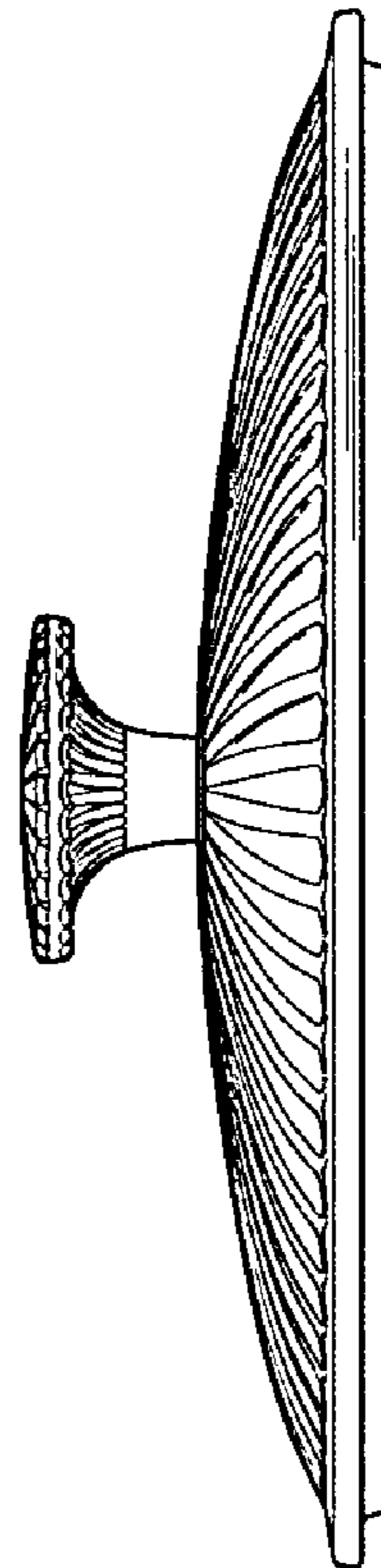

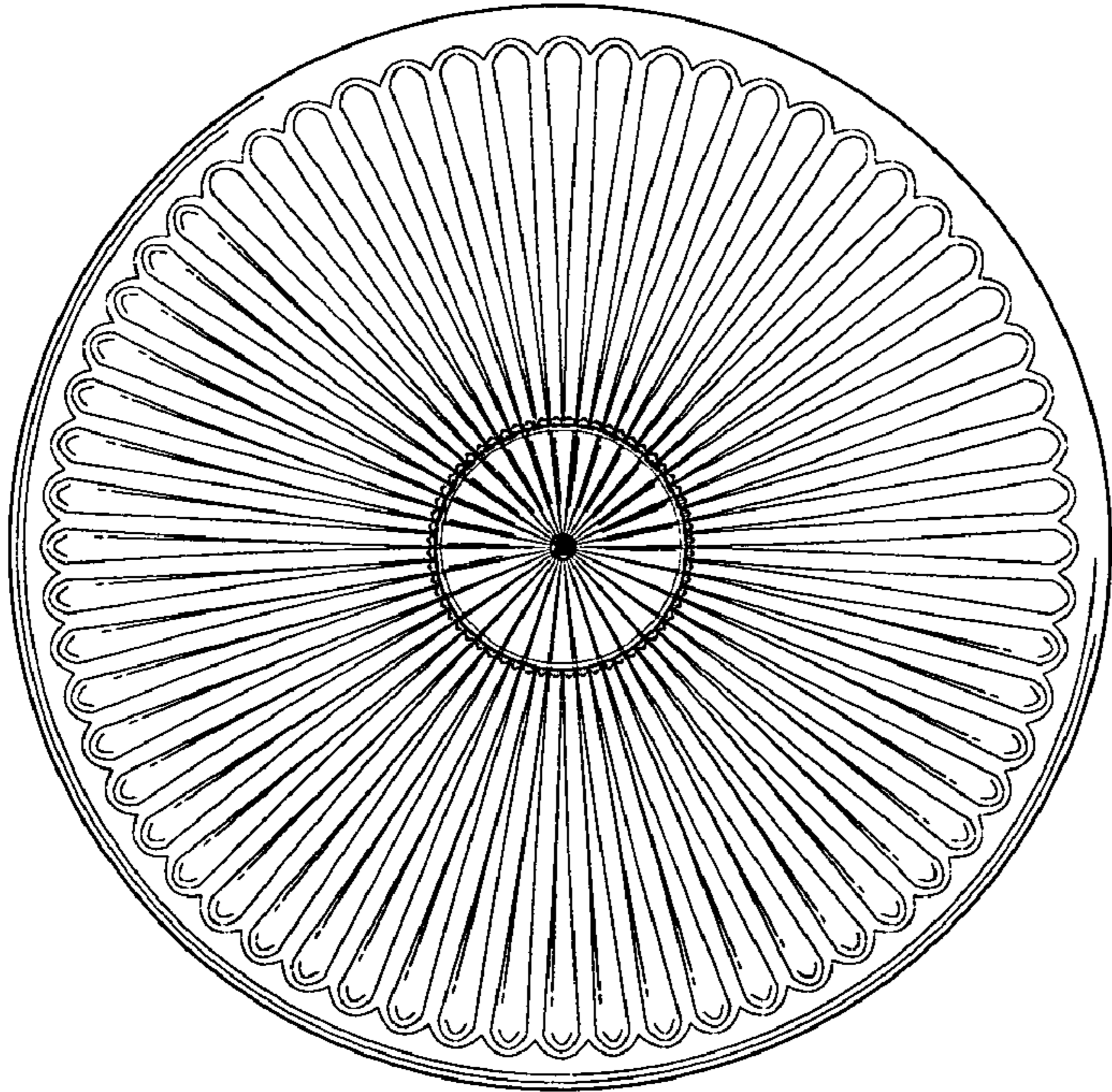

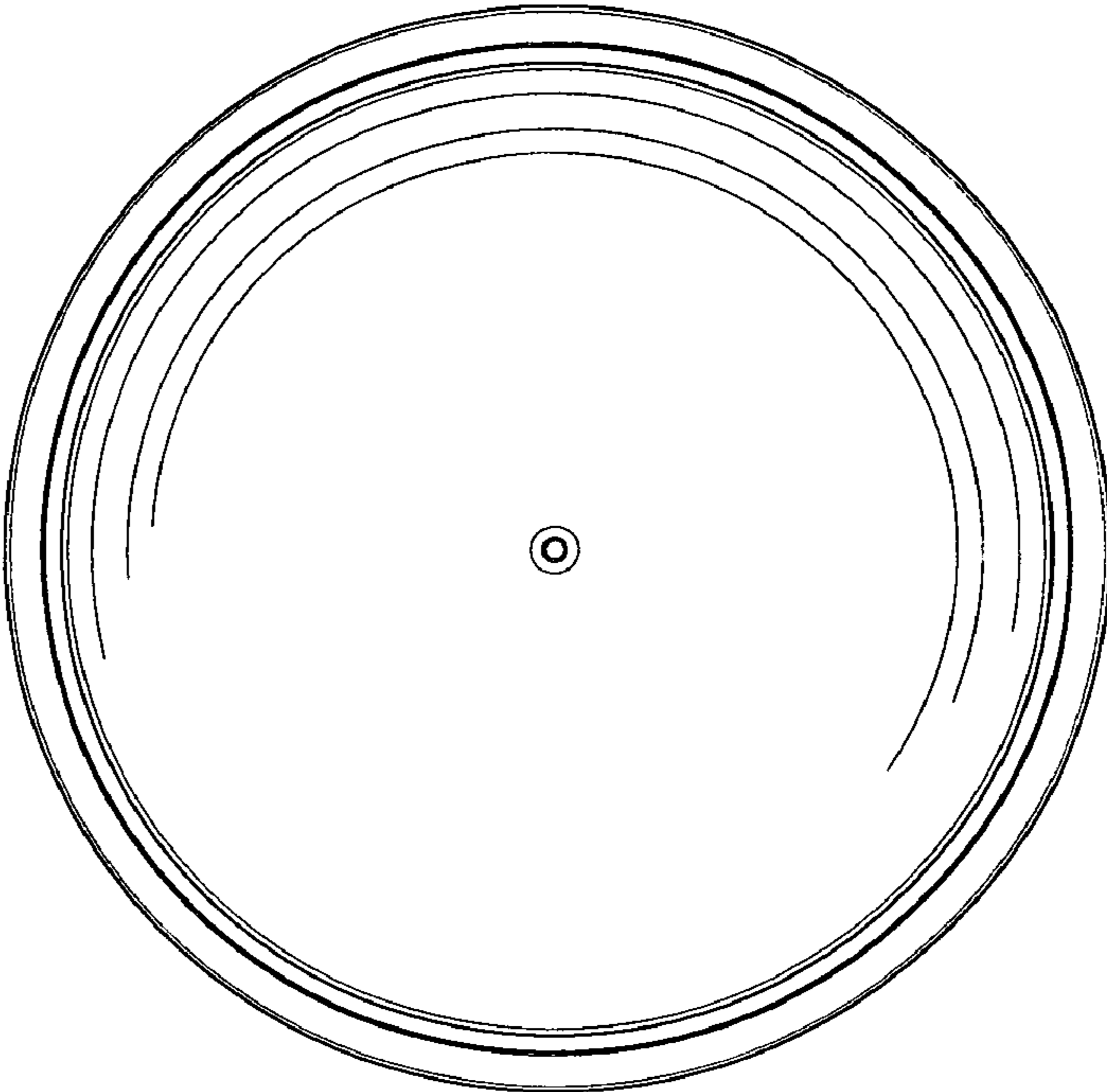

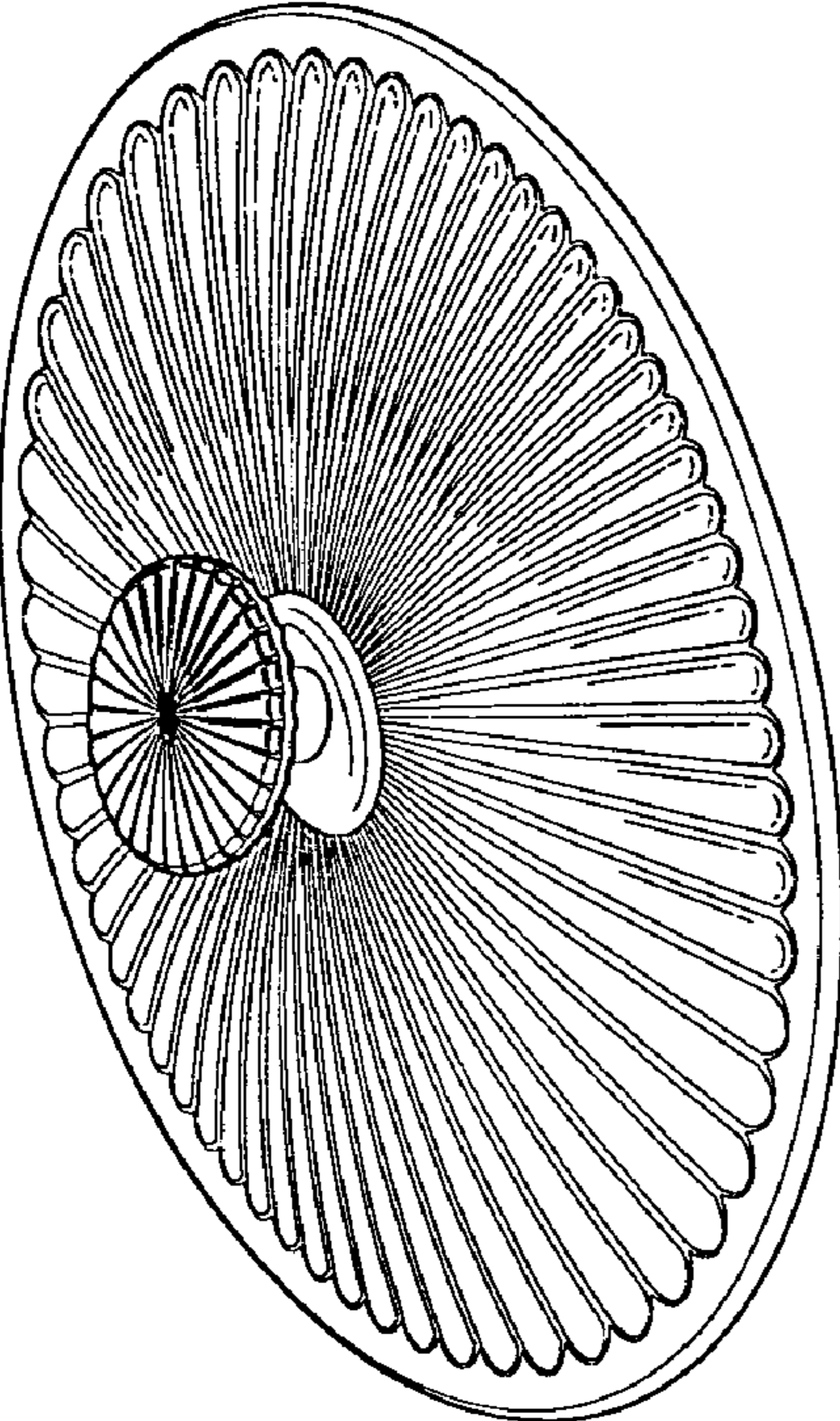

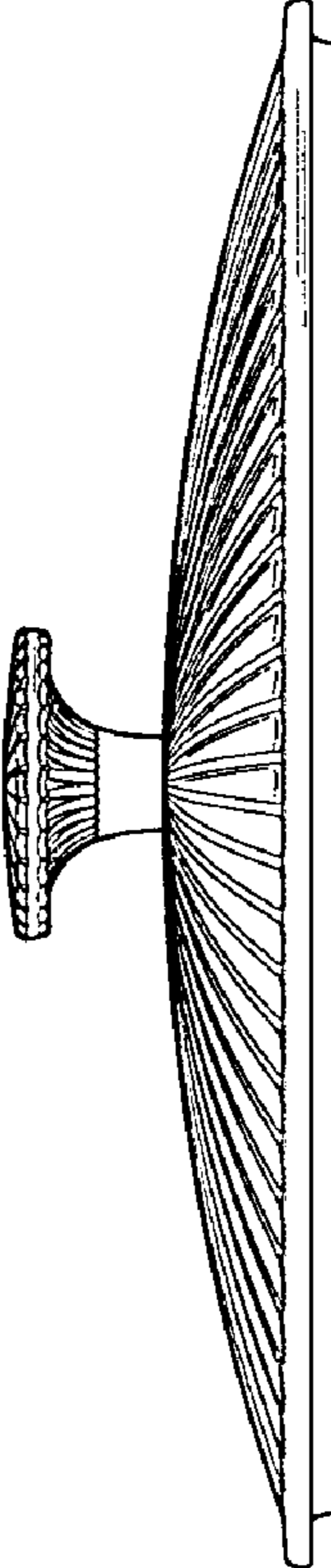

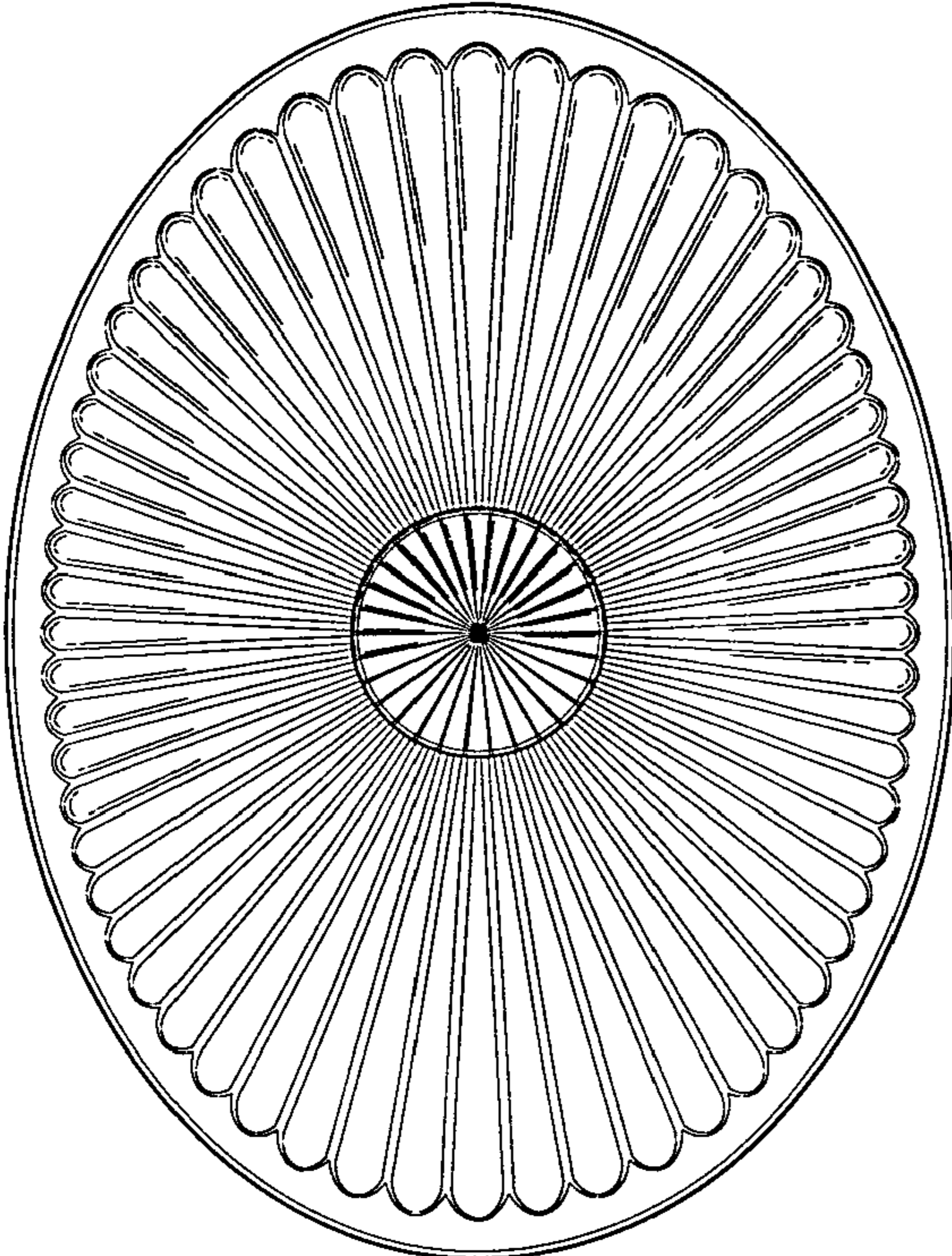
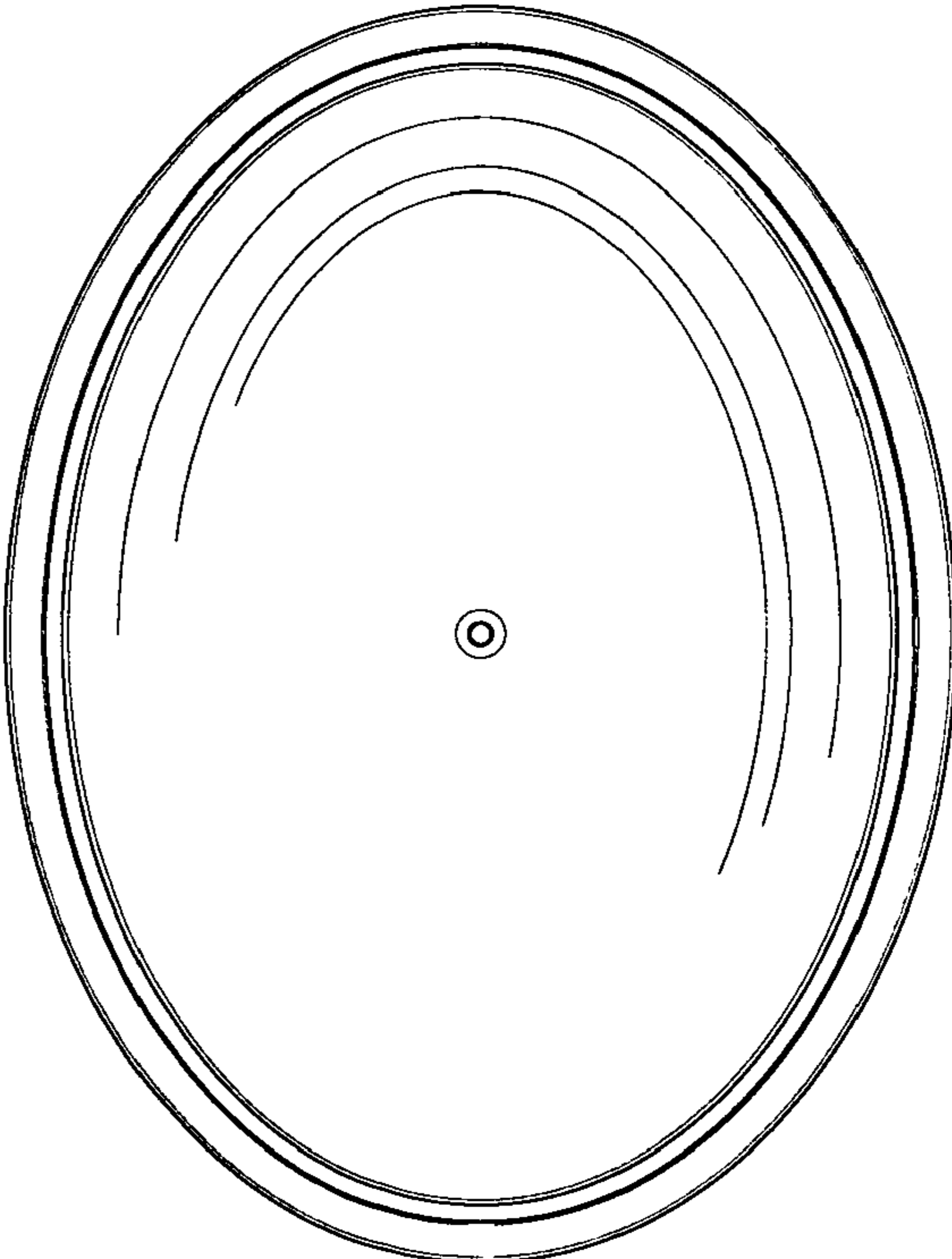

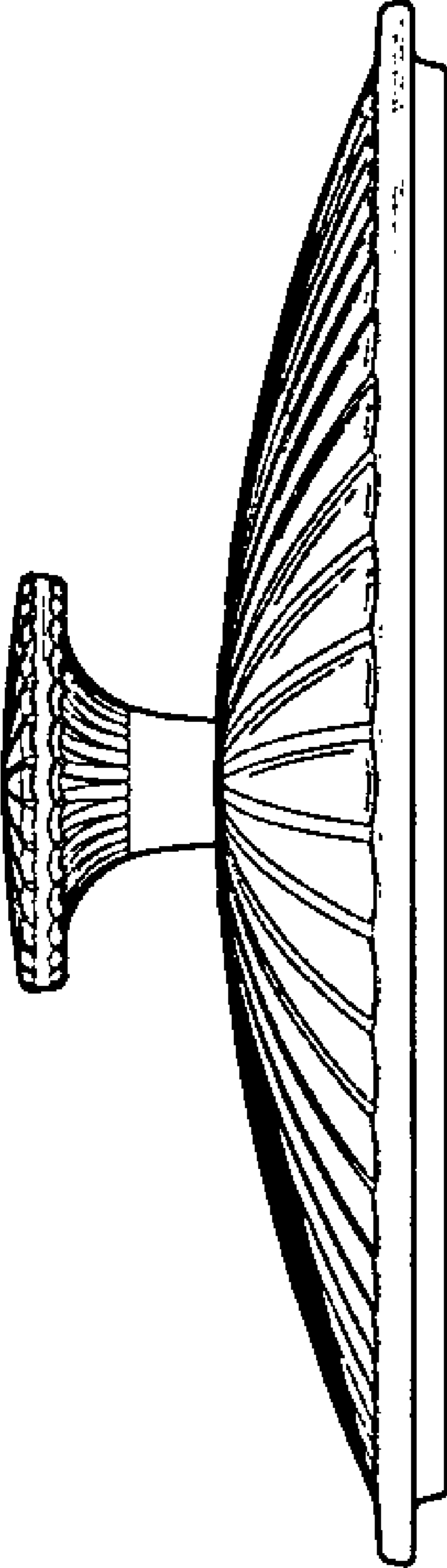
