The ornamental design for a sport beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sport beverage container showing my new design;

FIG. 2 is a side elevational view thereof with the handle to the left;

FIG. 3 is a side elevational view thereof with the handle to the front;

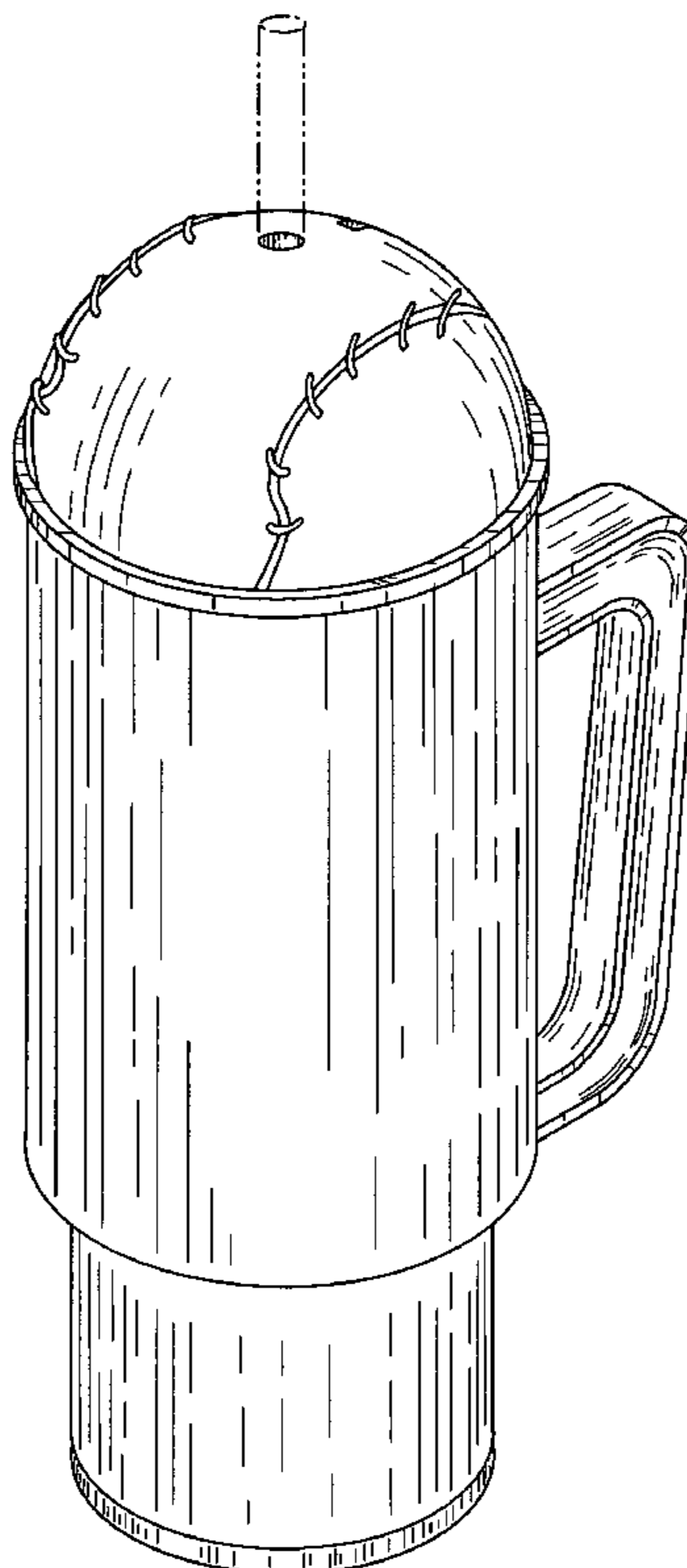
FIG. 4 is a side elevational view thereof with the handle to the rear;

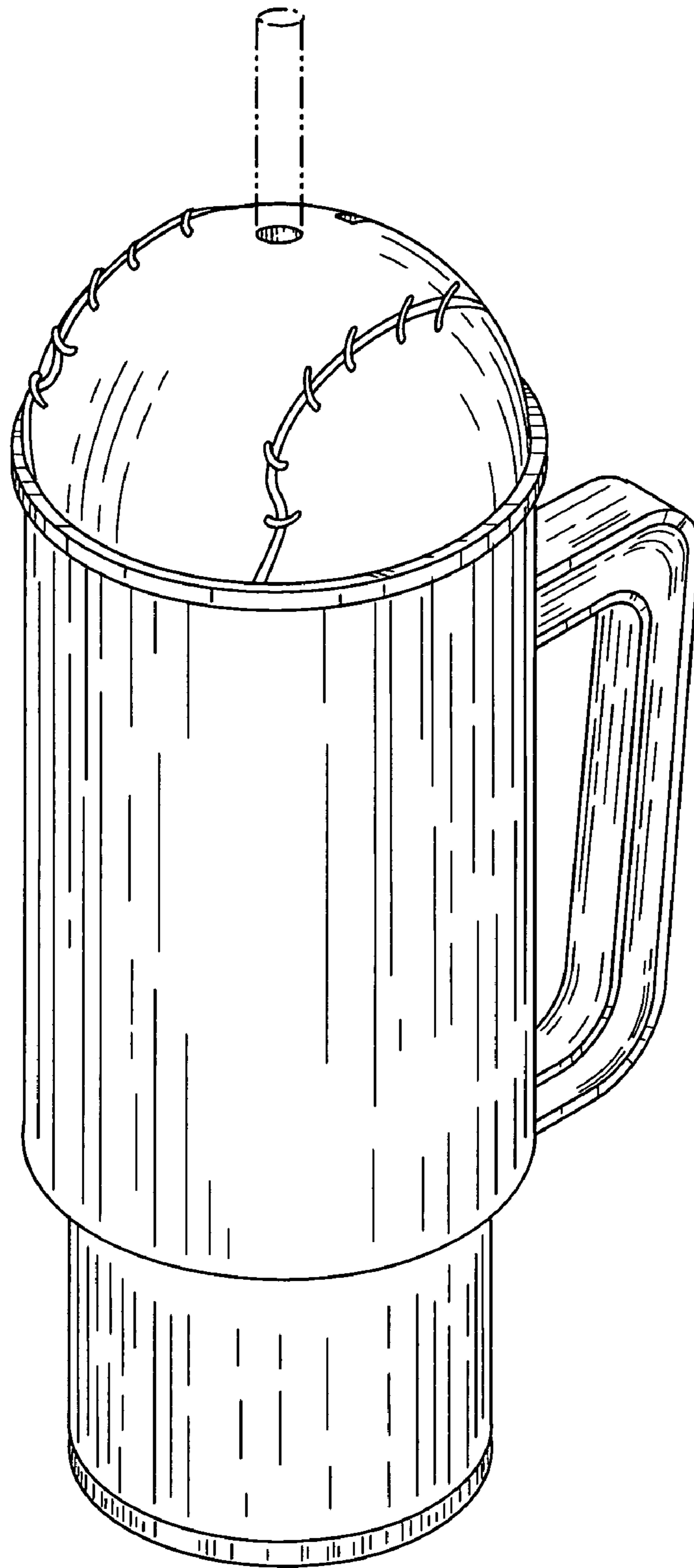

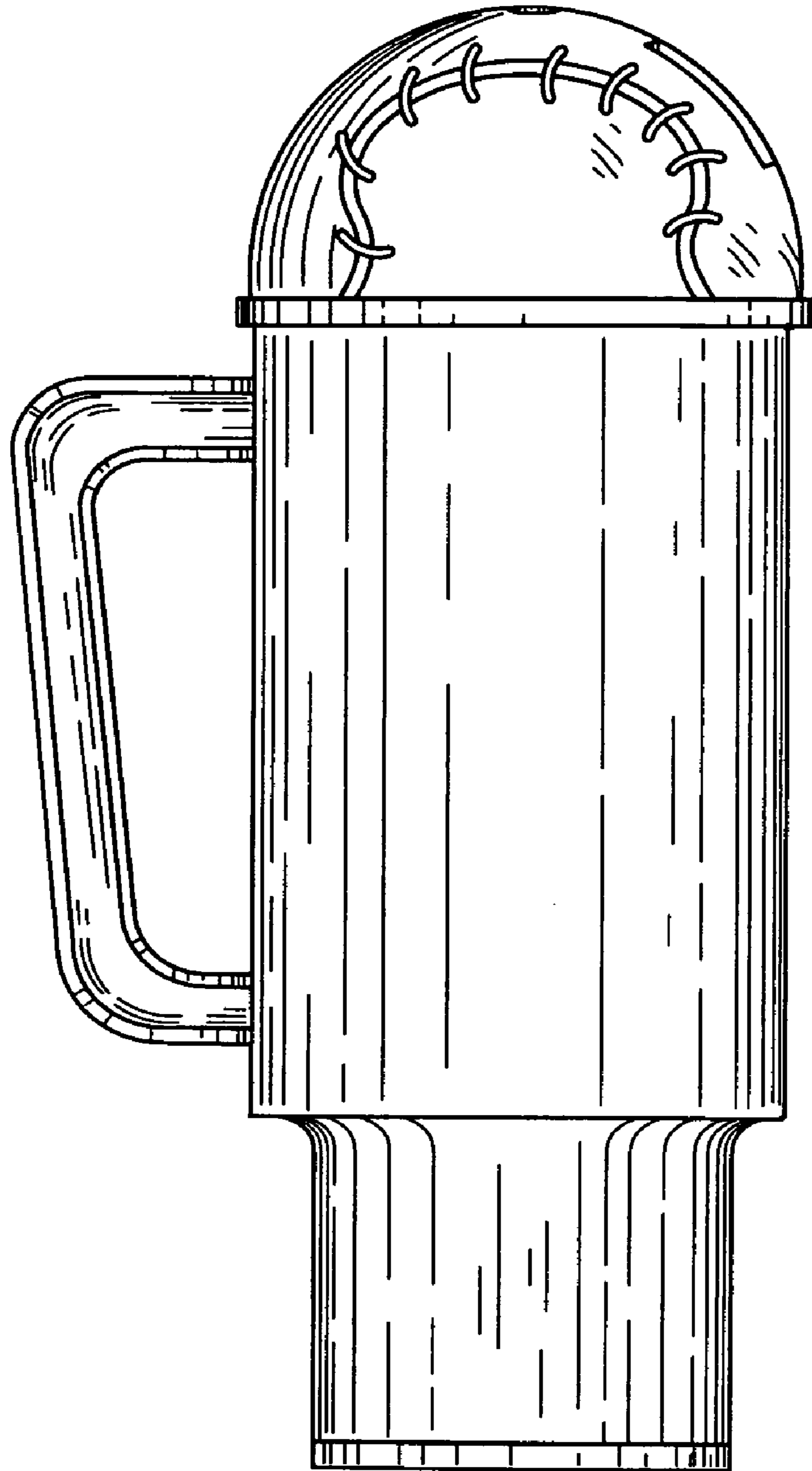

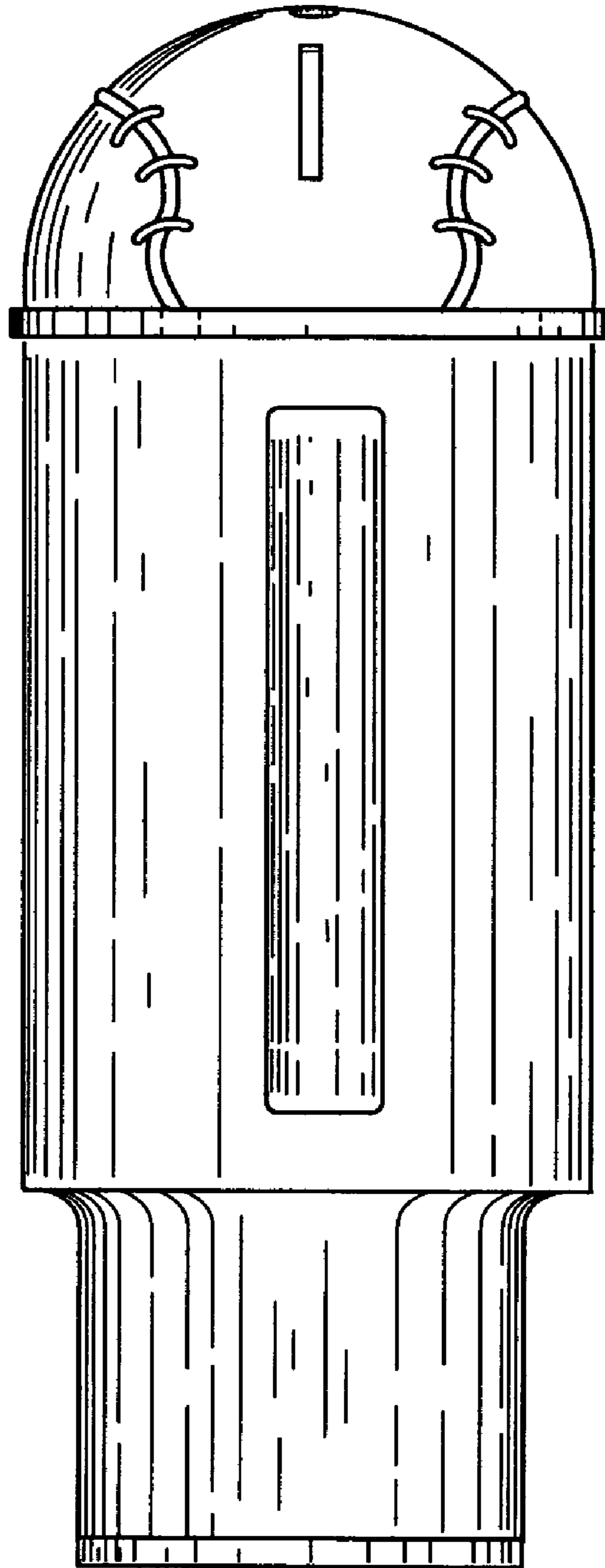

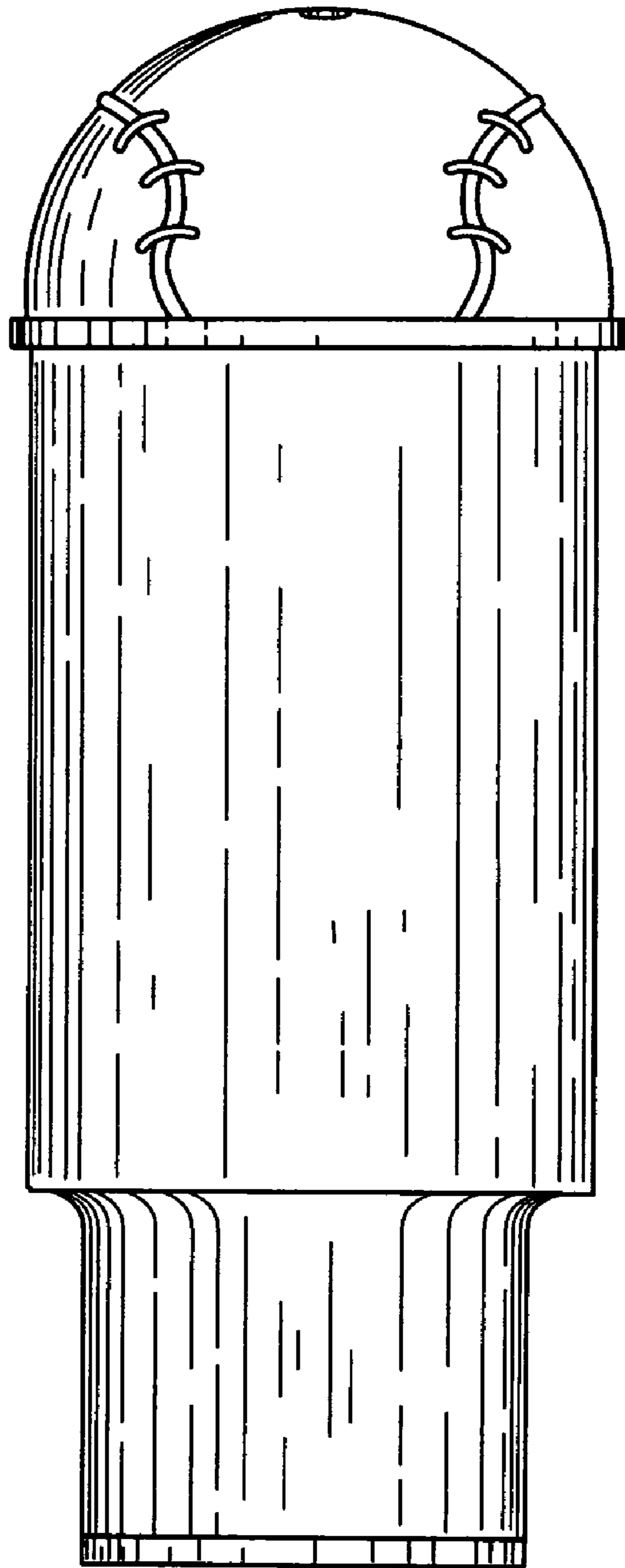

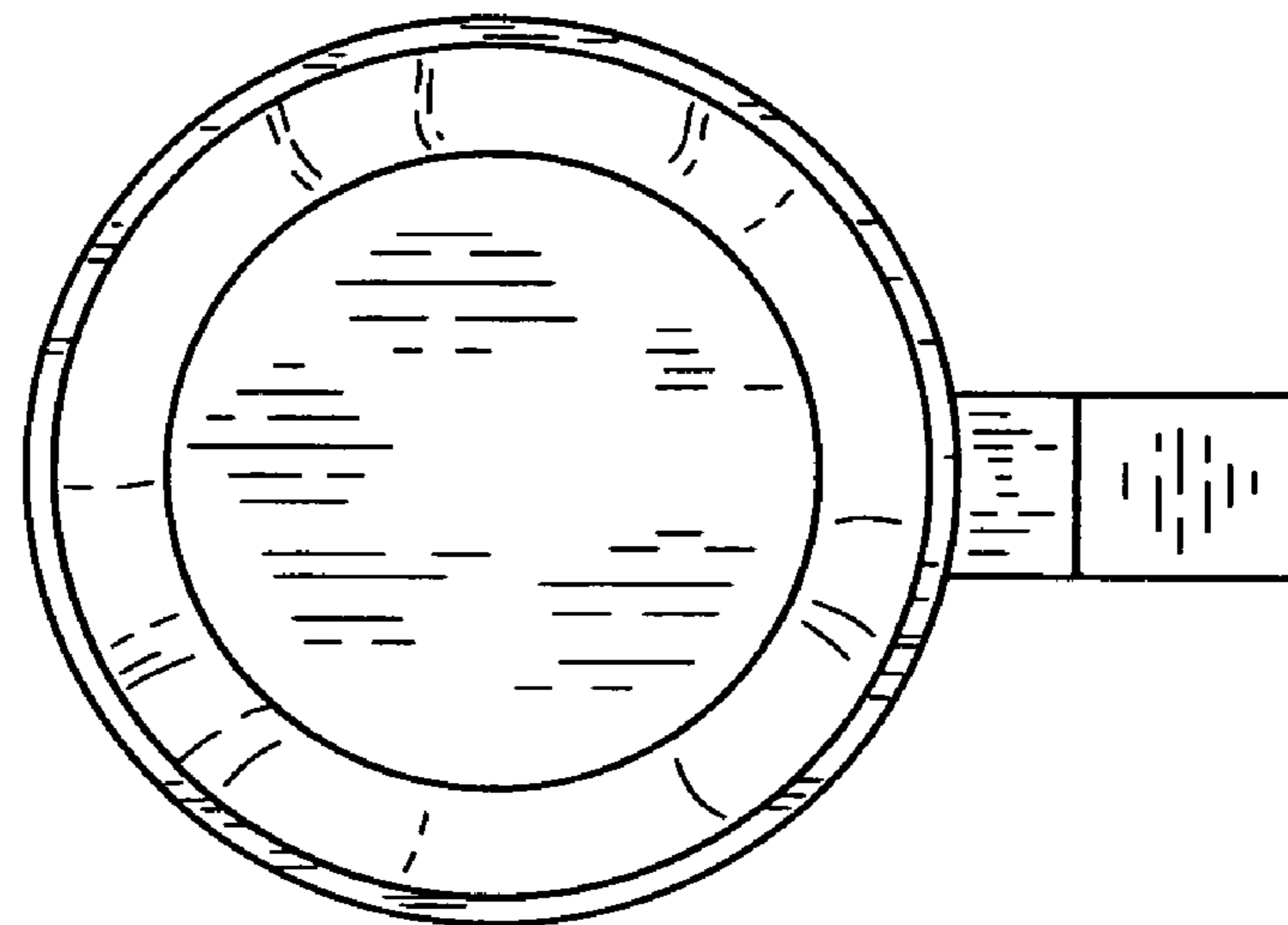
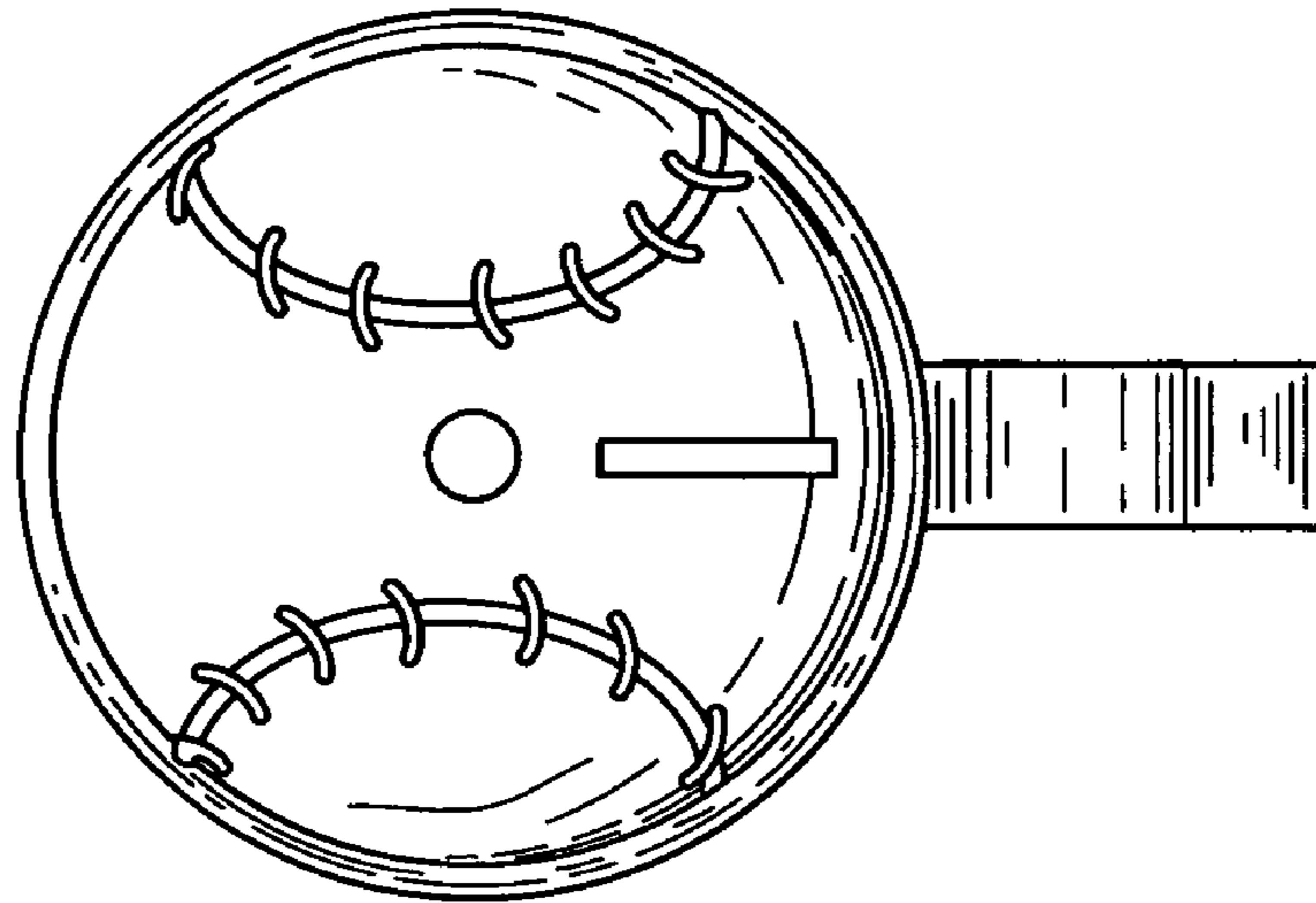
