FIG. 3 is a bottom view of the new design;

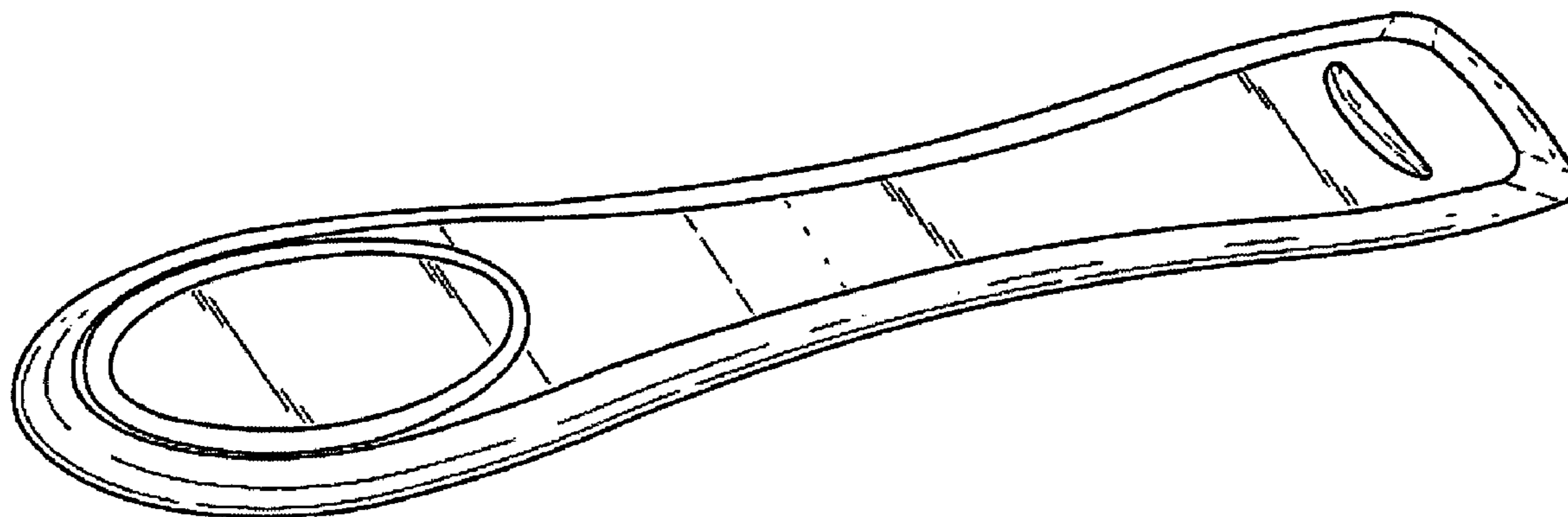
FIG. 4 is a front view of the new design;

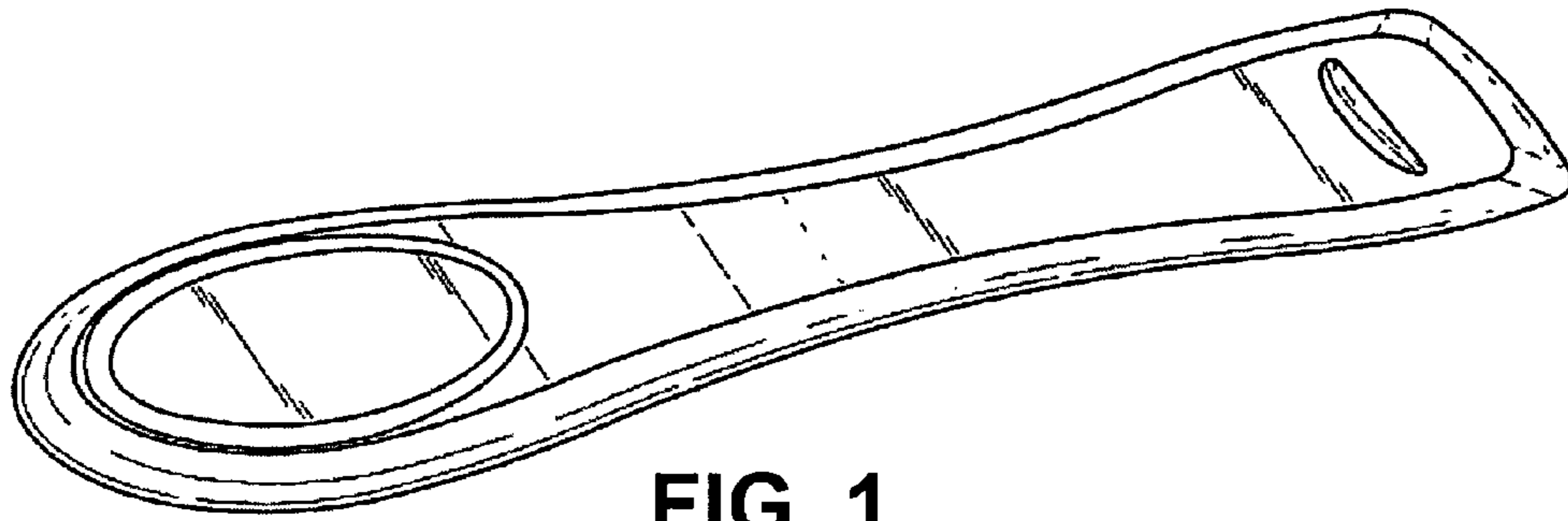

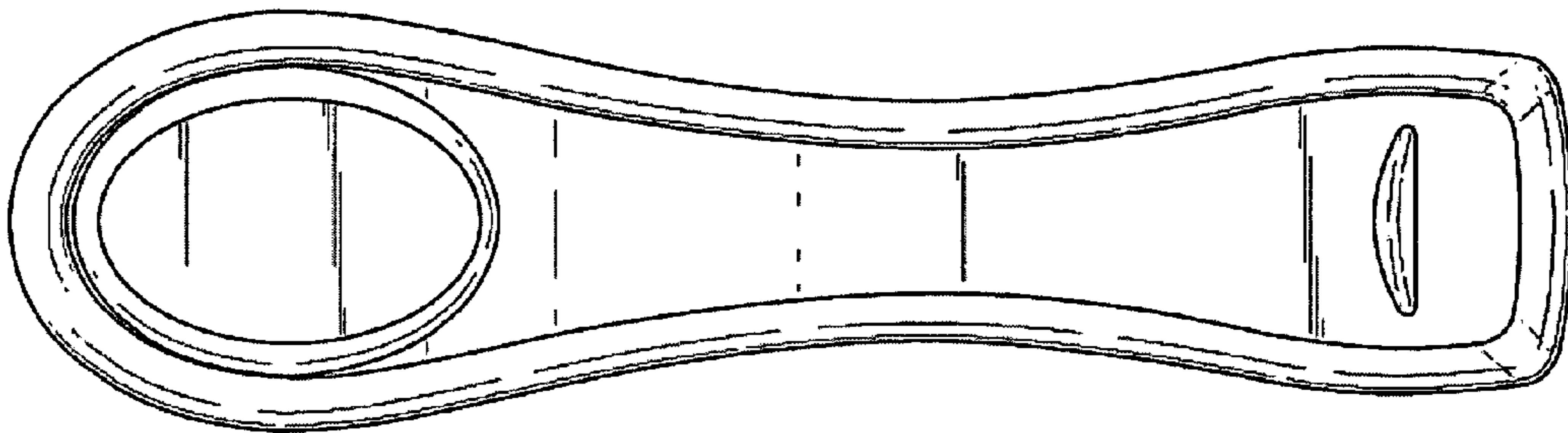

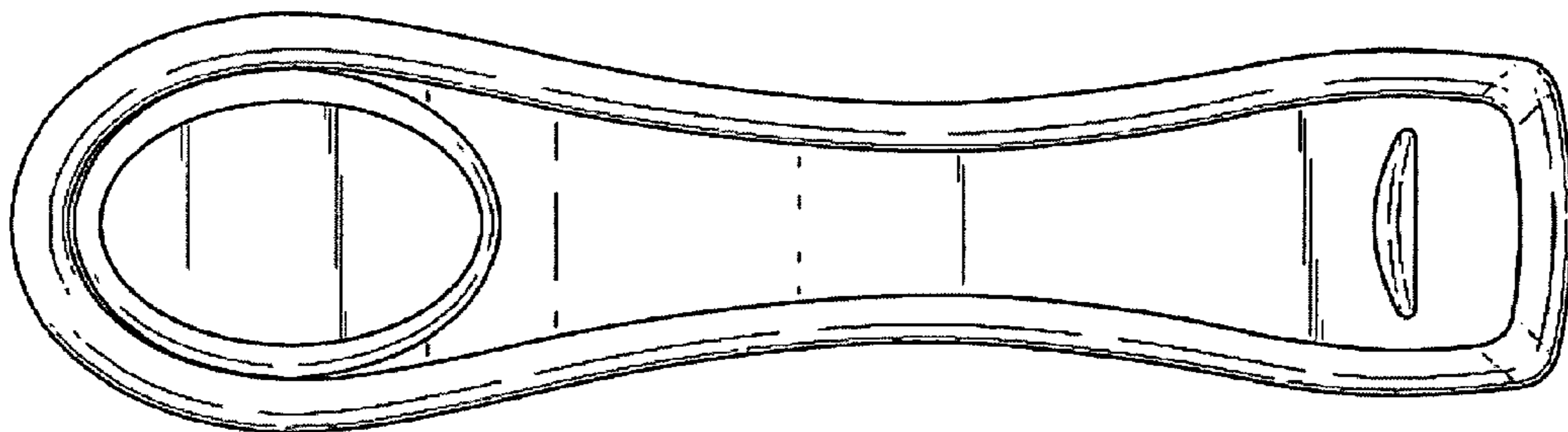

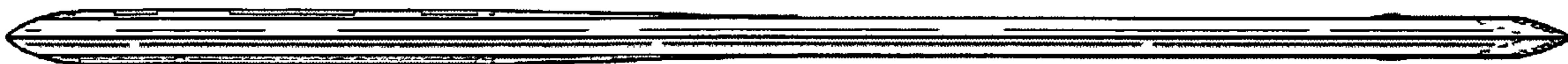

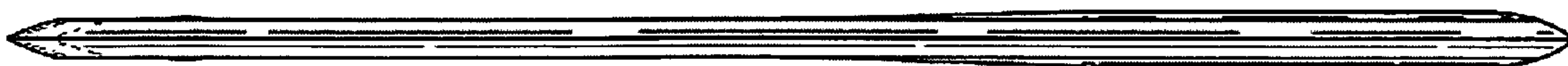

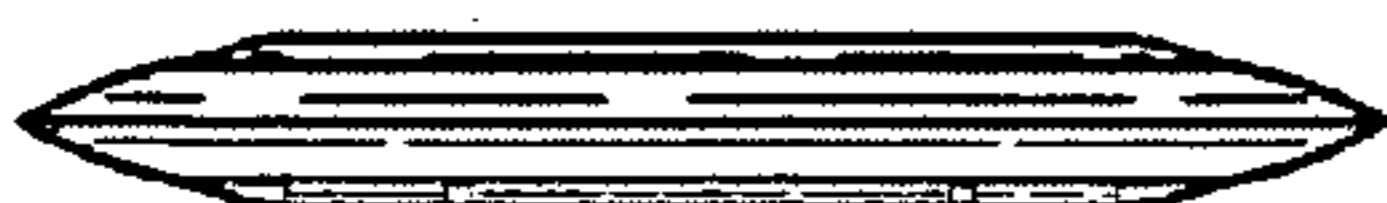
