FIG. 5 is a rear view thereof.

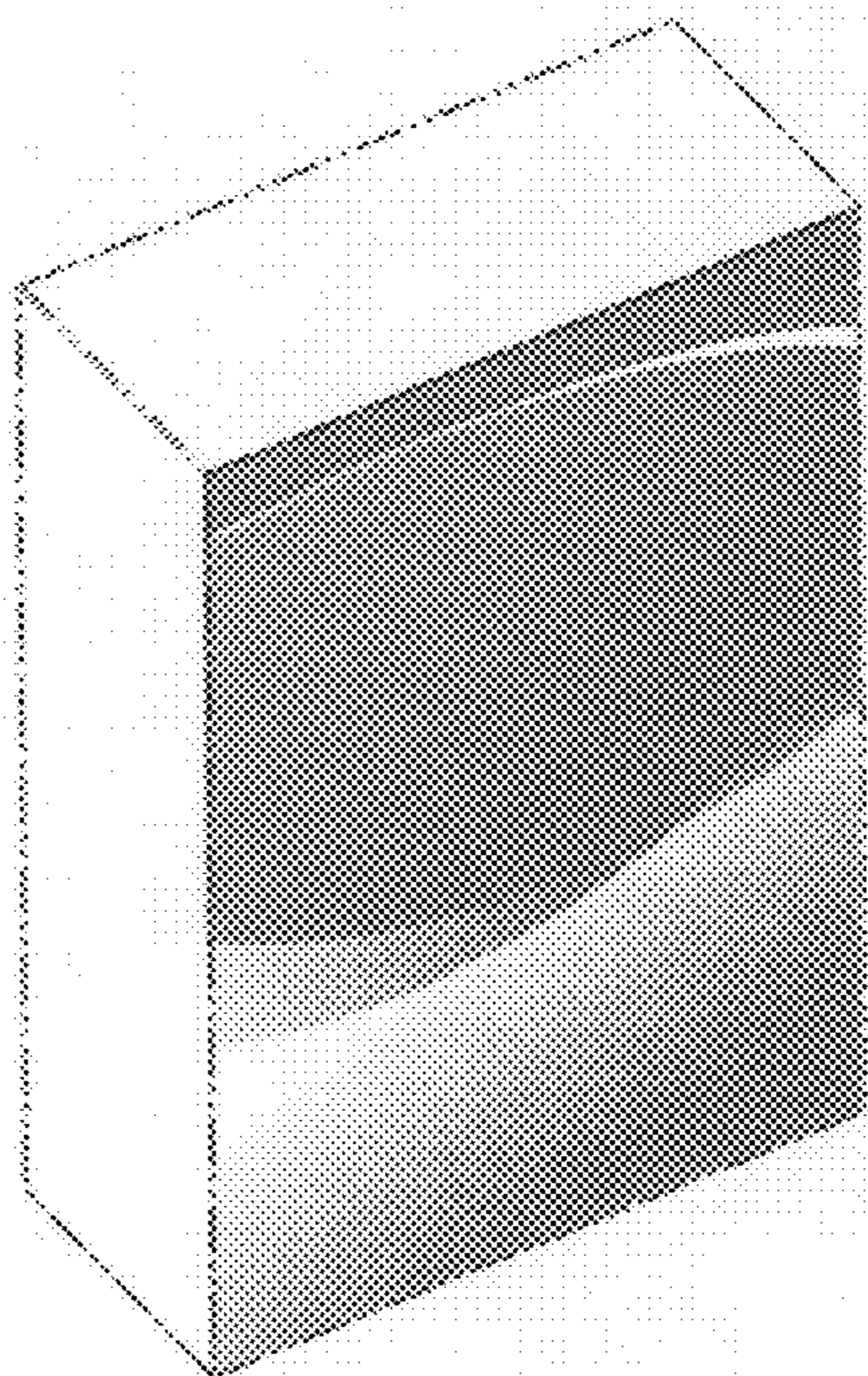
The broken lines in the drawing show structure illustrating the design in an environment of use. The broken lines form no part of the claimed design.

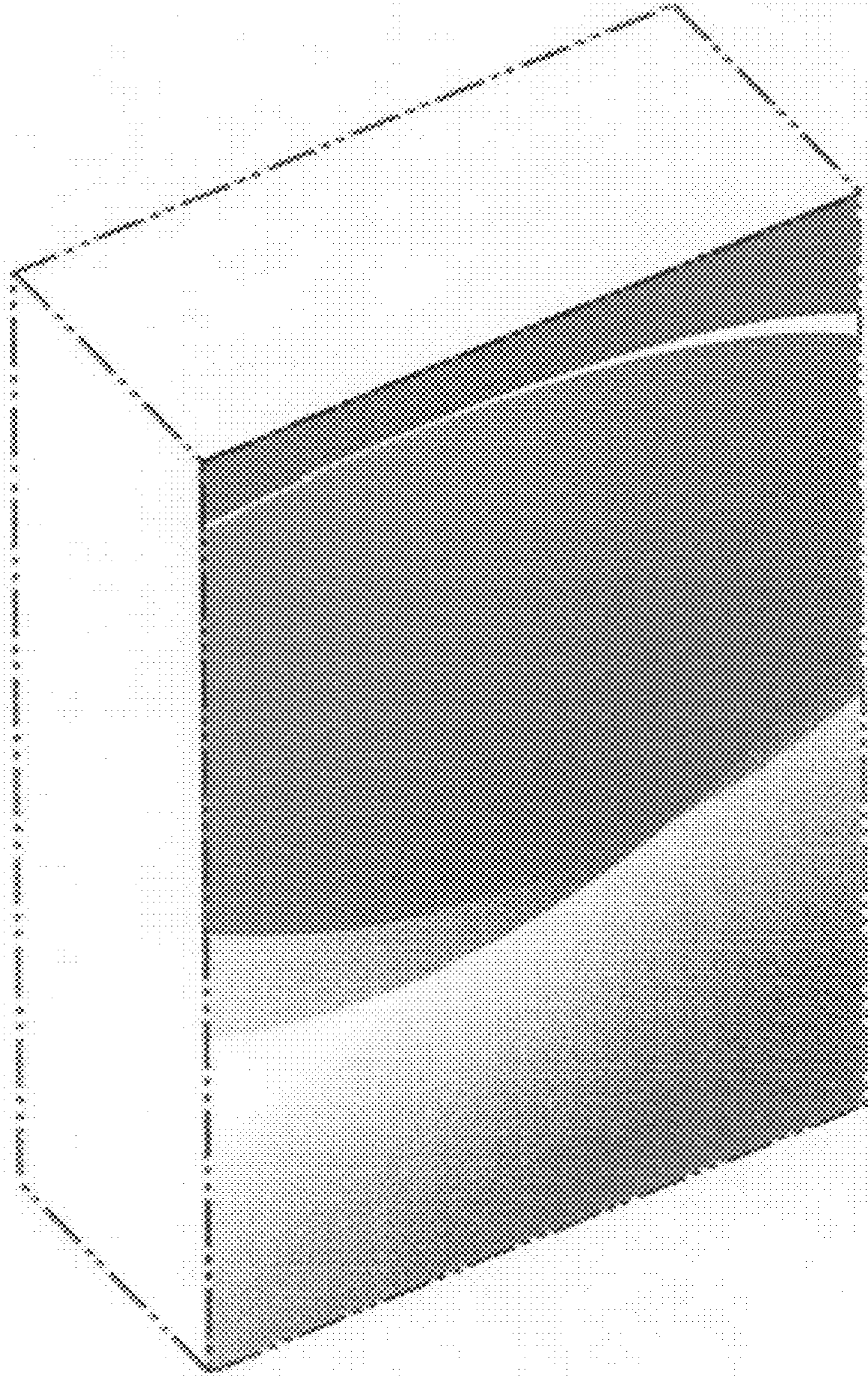

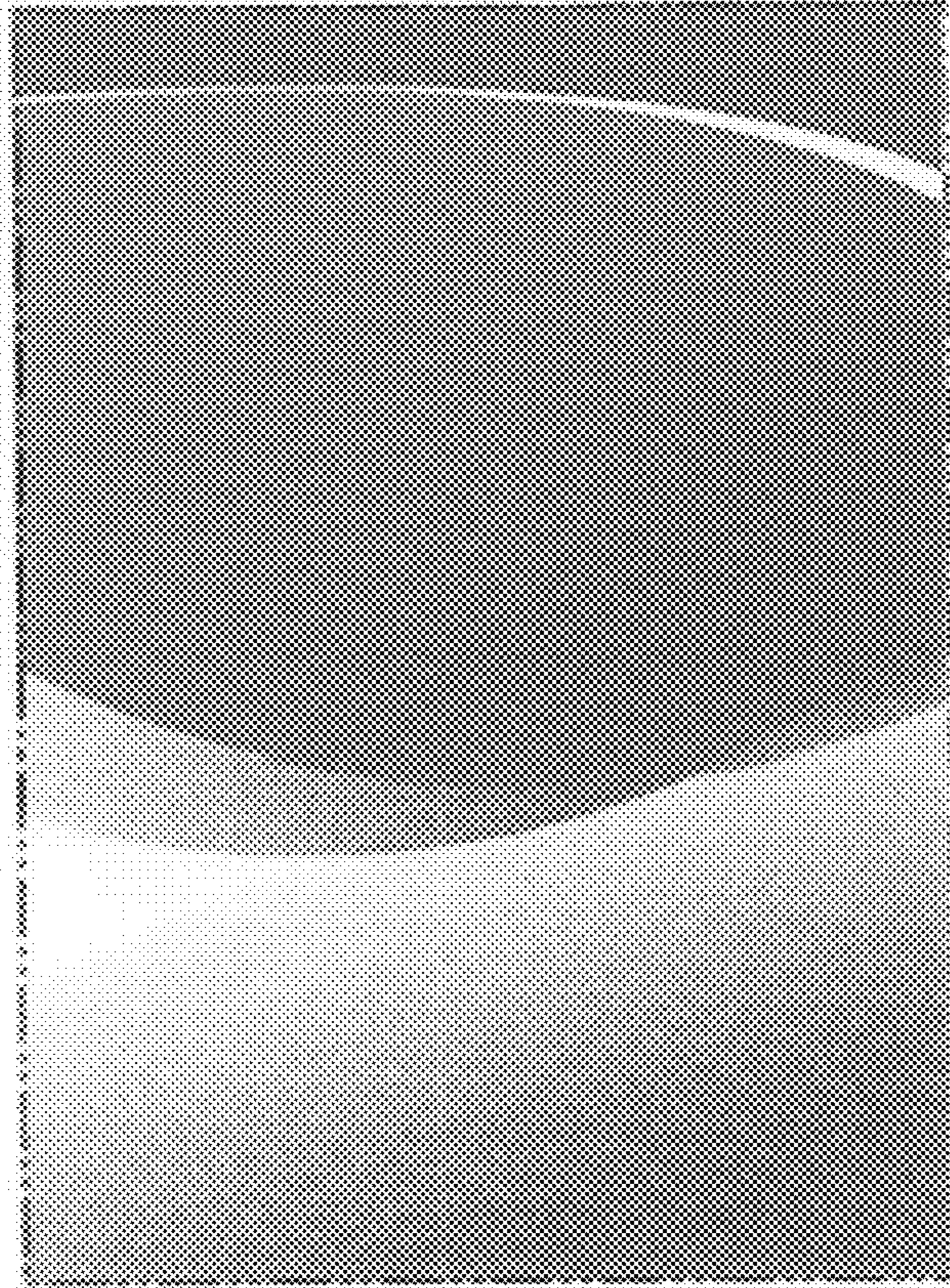

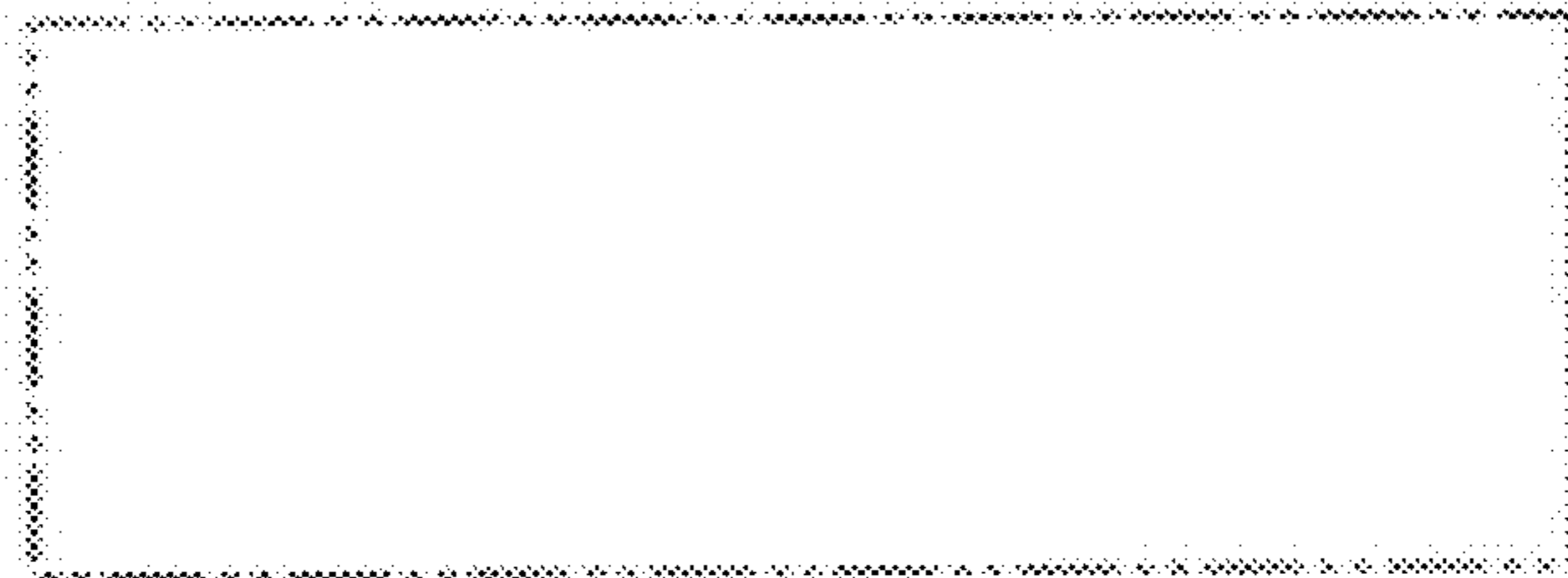

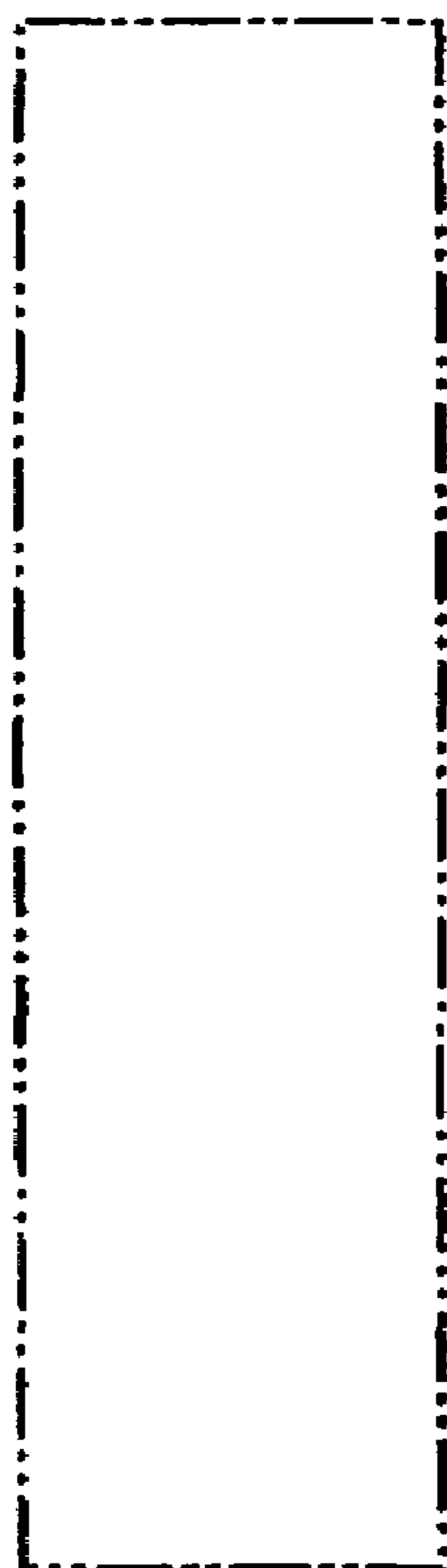
