The ornamental design for a mug cover, as shown.

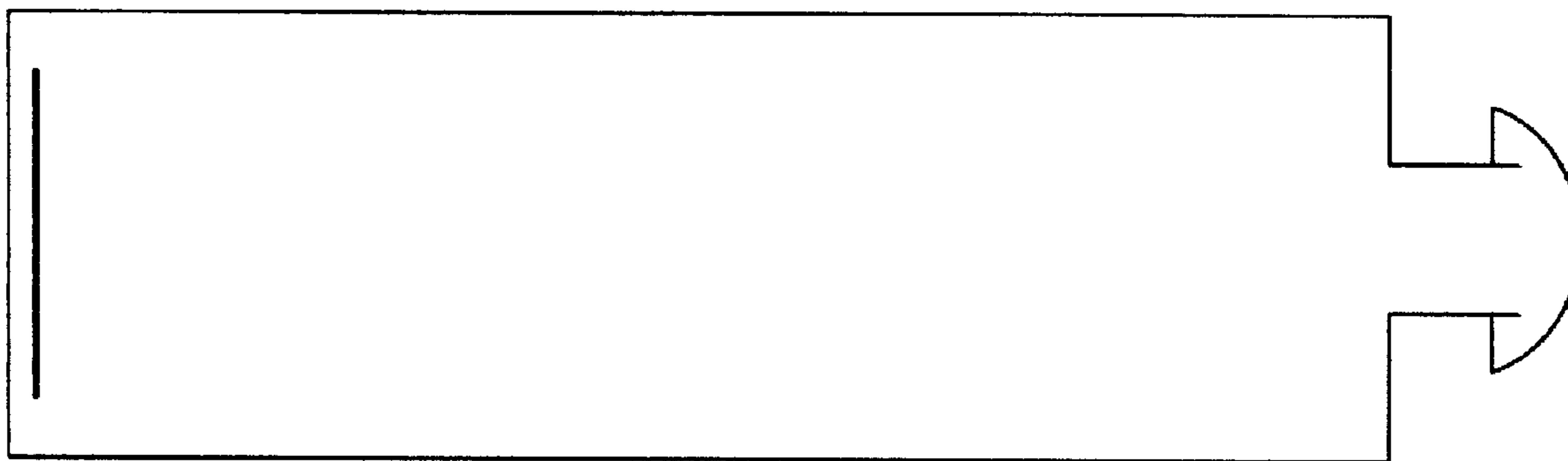
DESCRIPTION

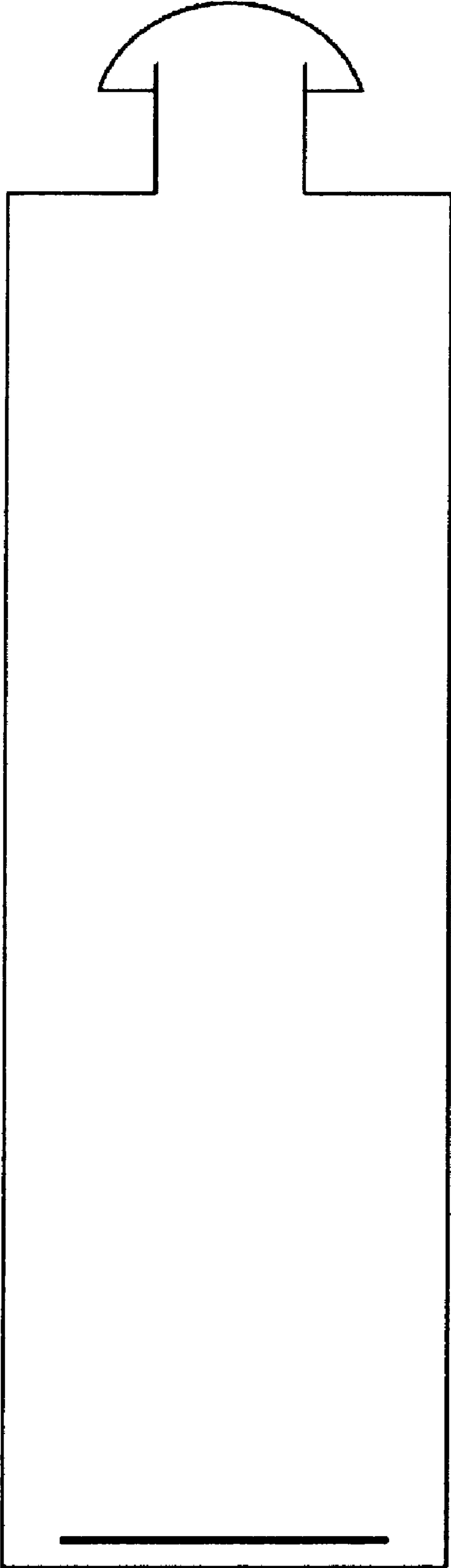
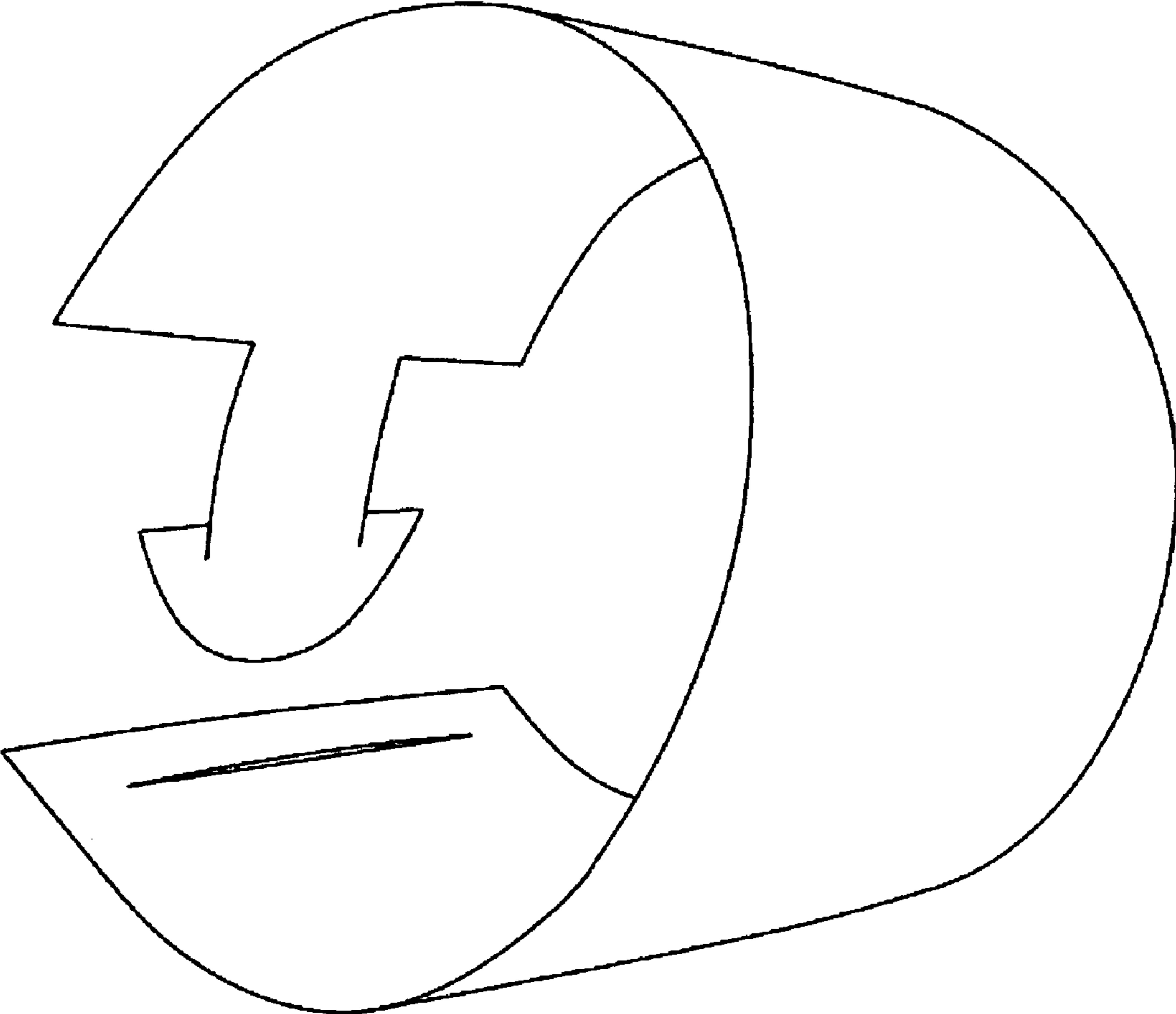

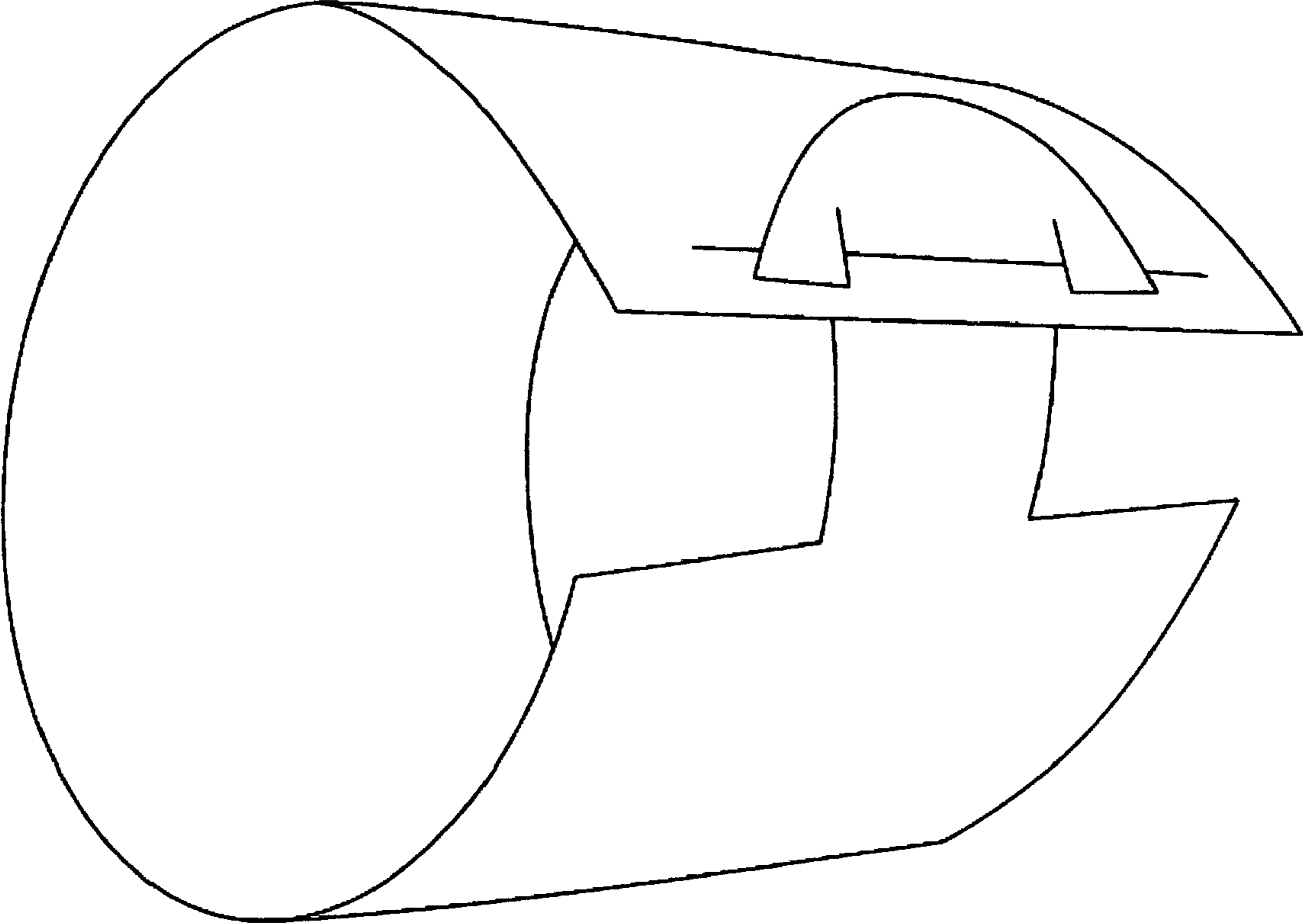
