FIG. 3 is a first side elevation view thereof;

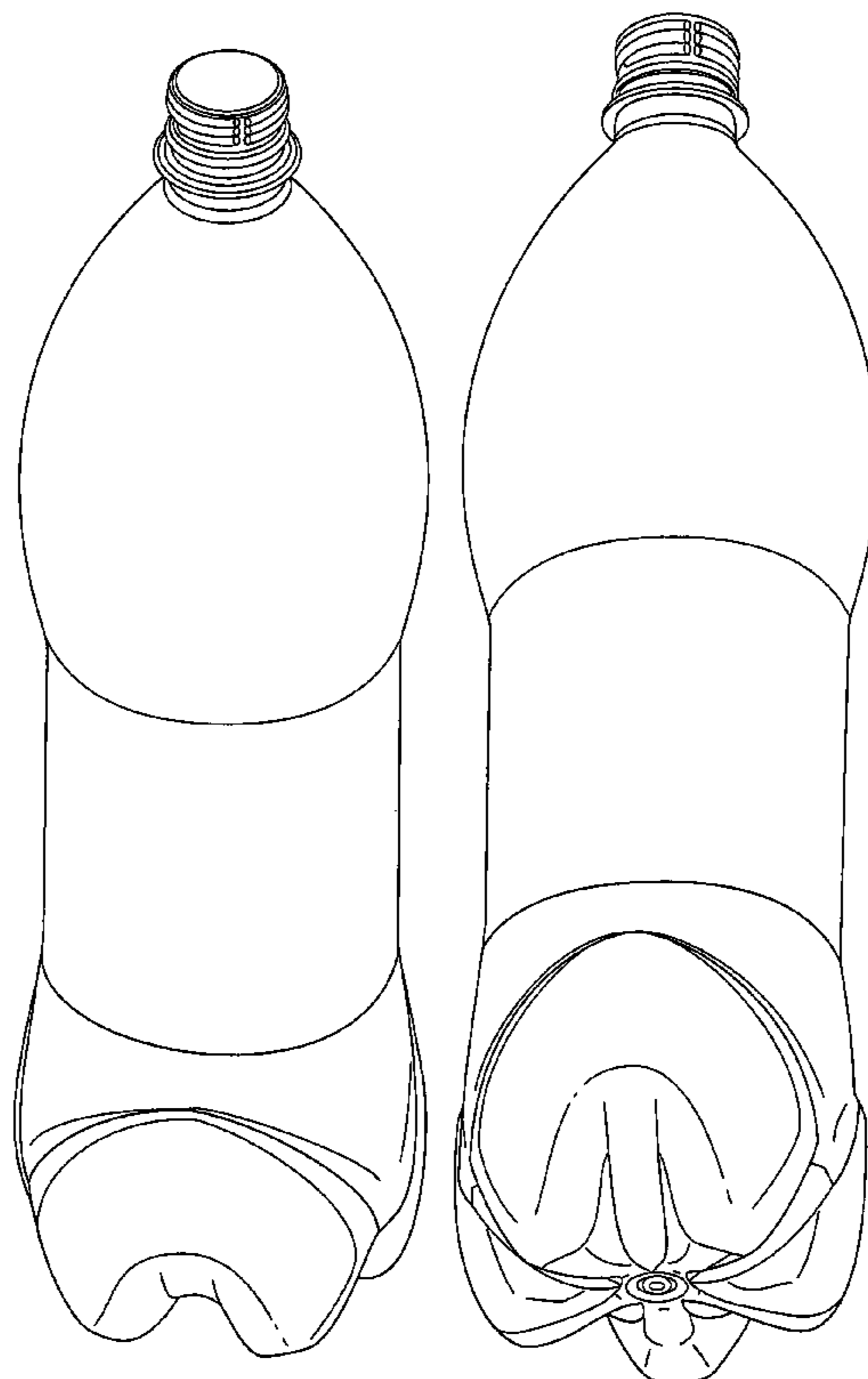
FIG. 4 is a second side elevation view thereof;

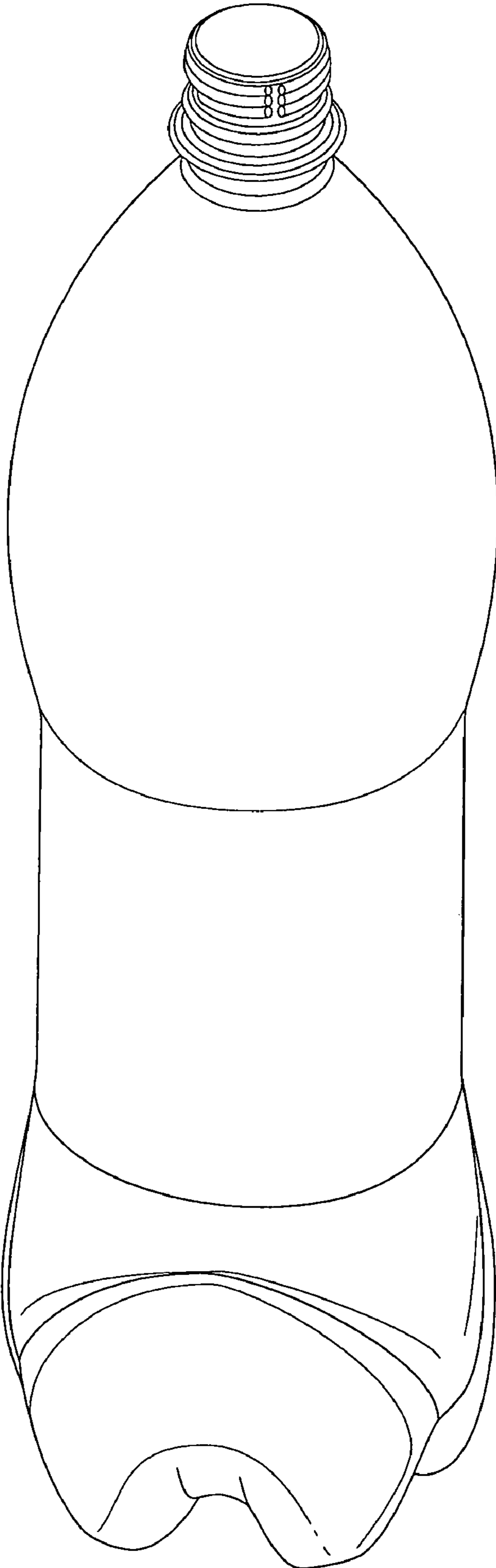

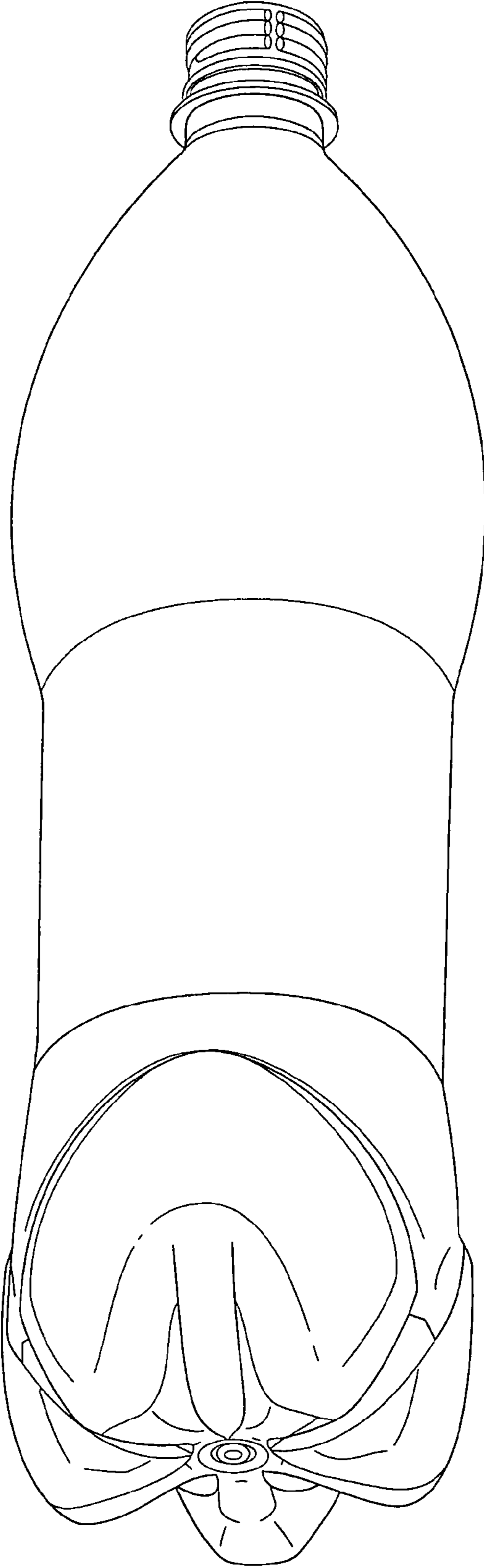

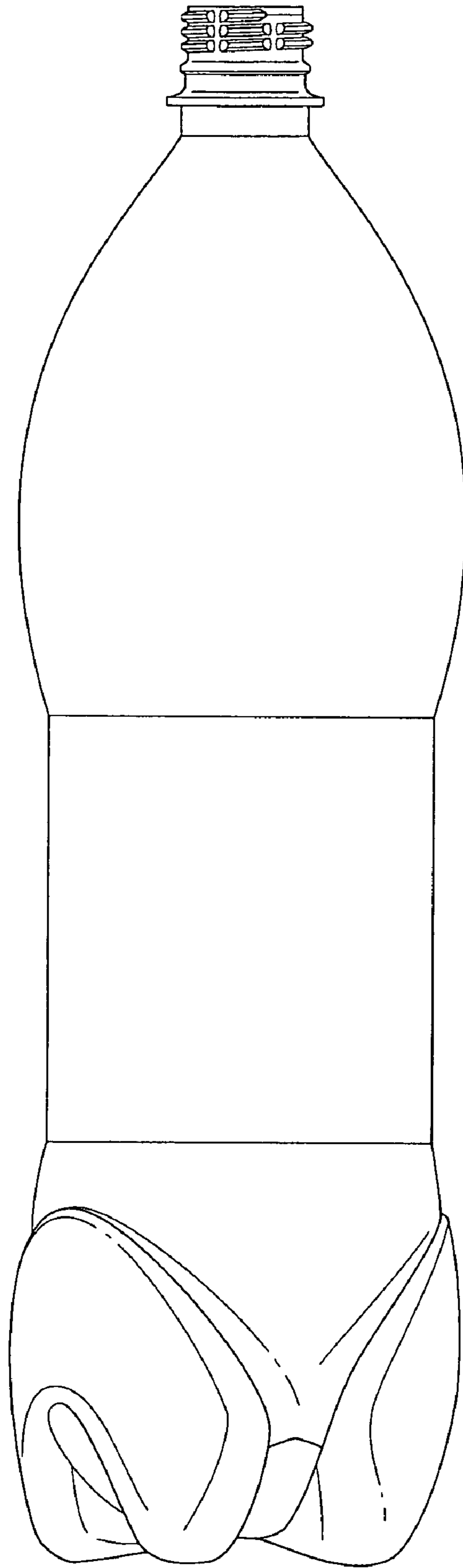

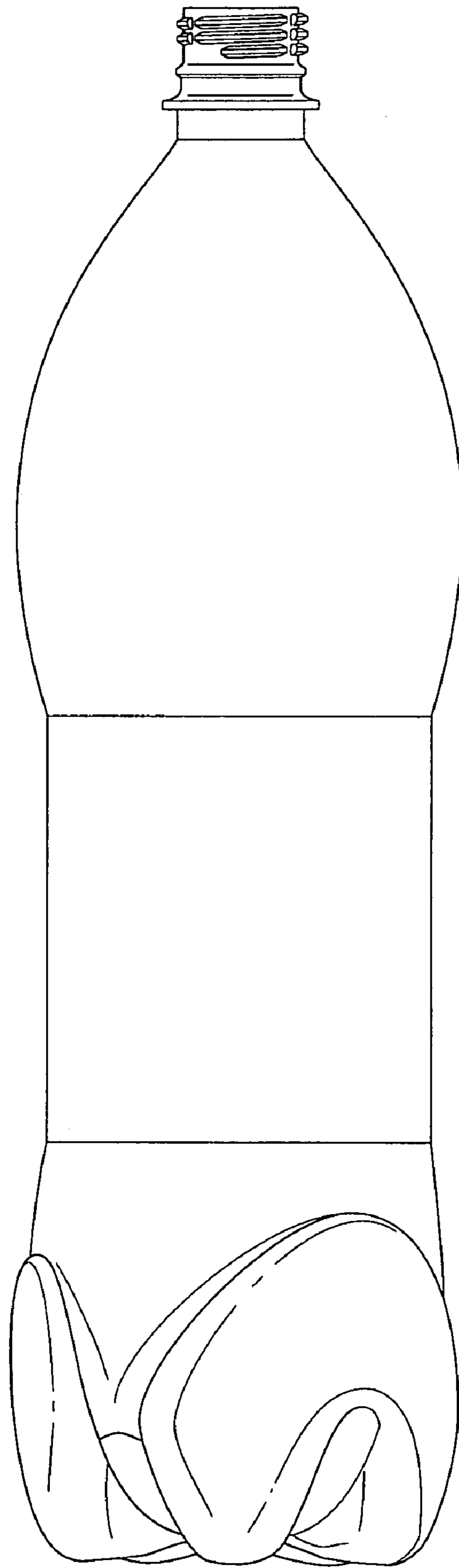

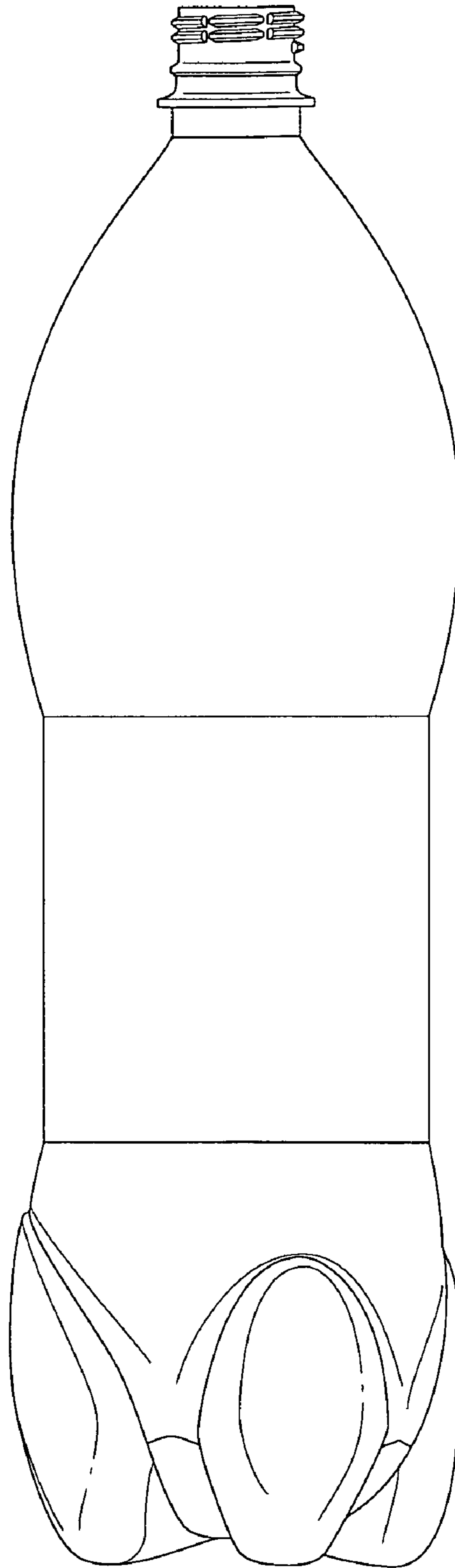

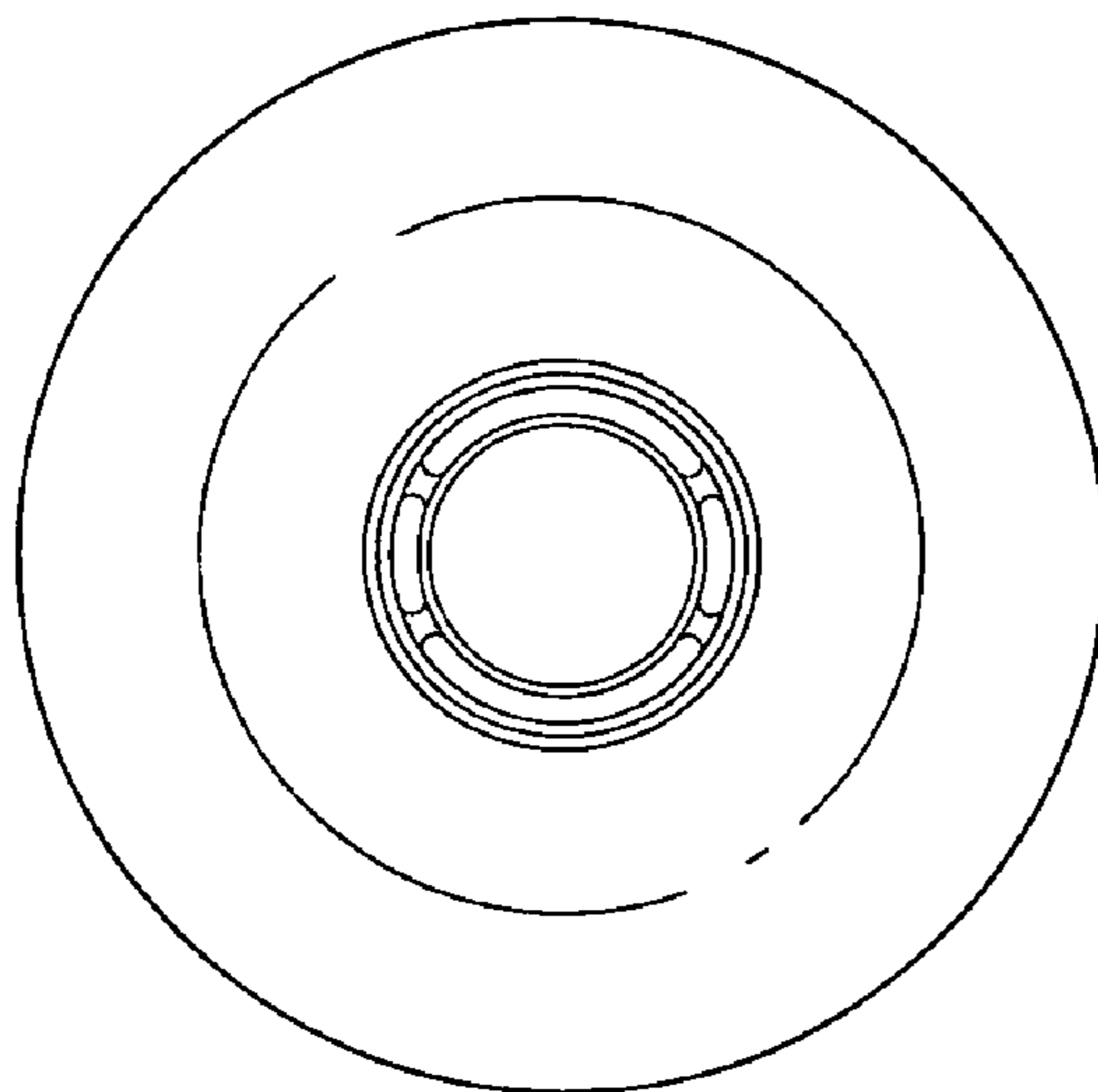

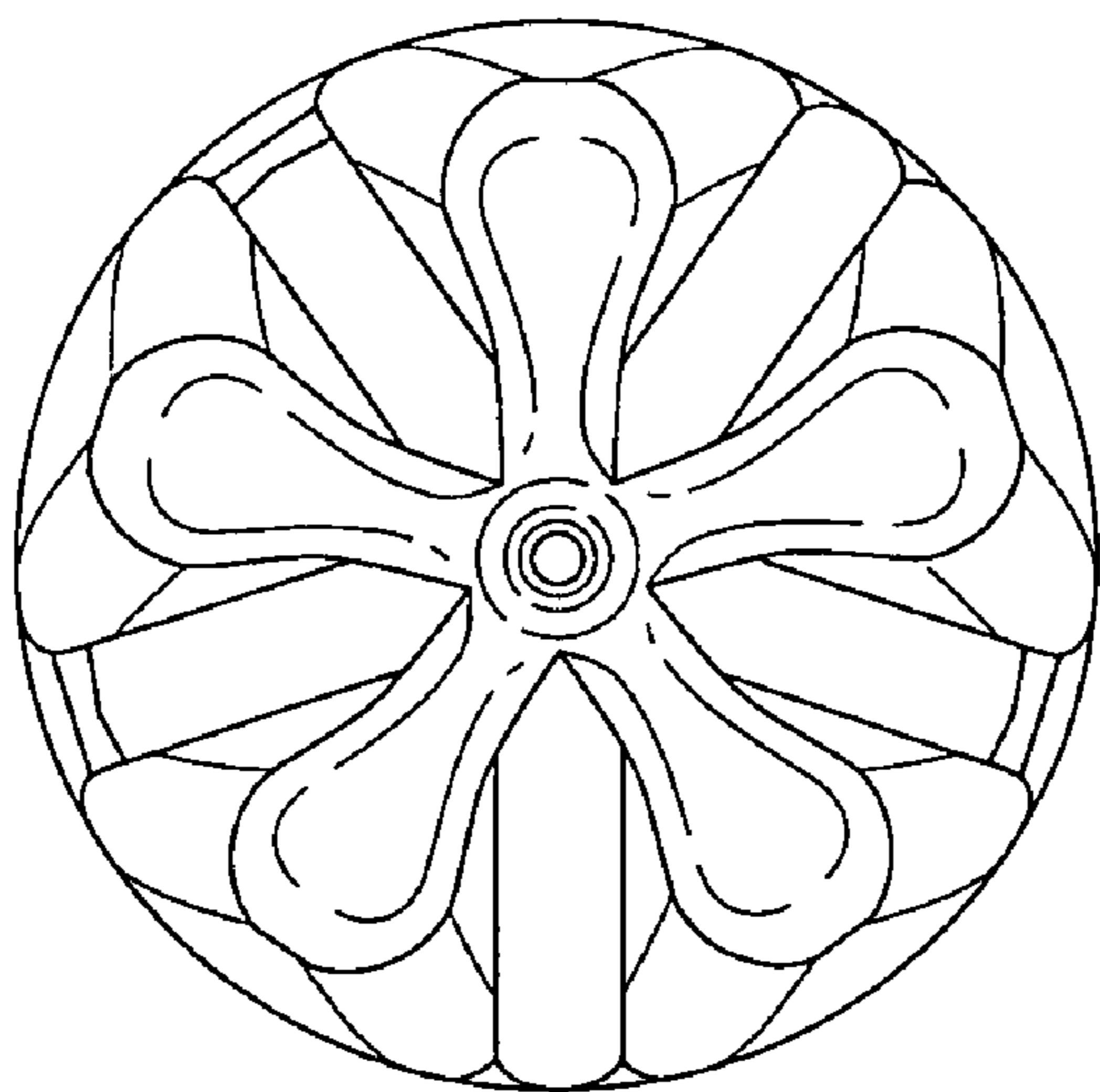
