The ornamental design for a Nativity scene decoration including Santa Claus and Rudolph, as shown and described.

**DESCRIPTION**

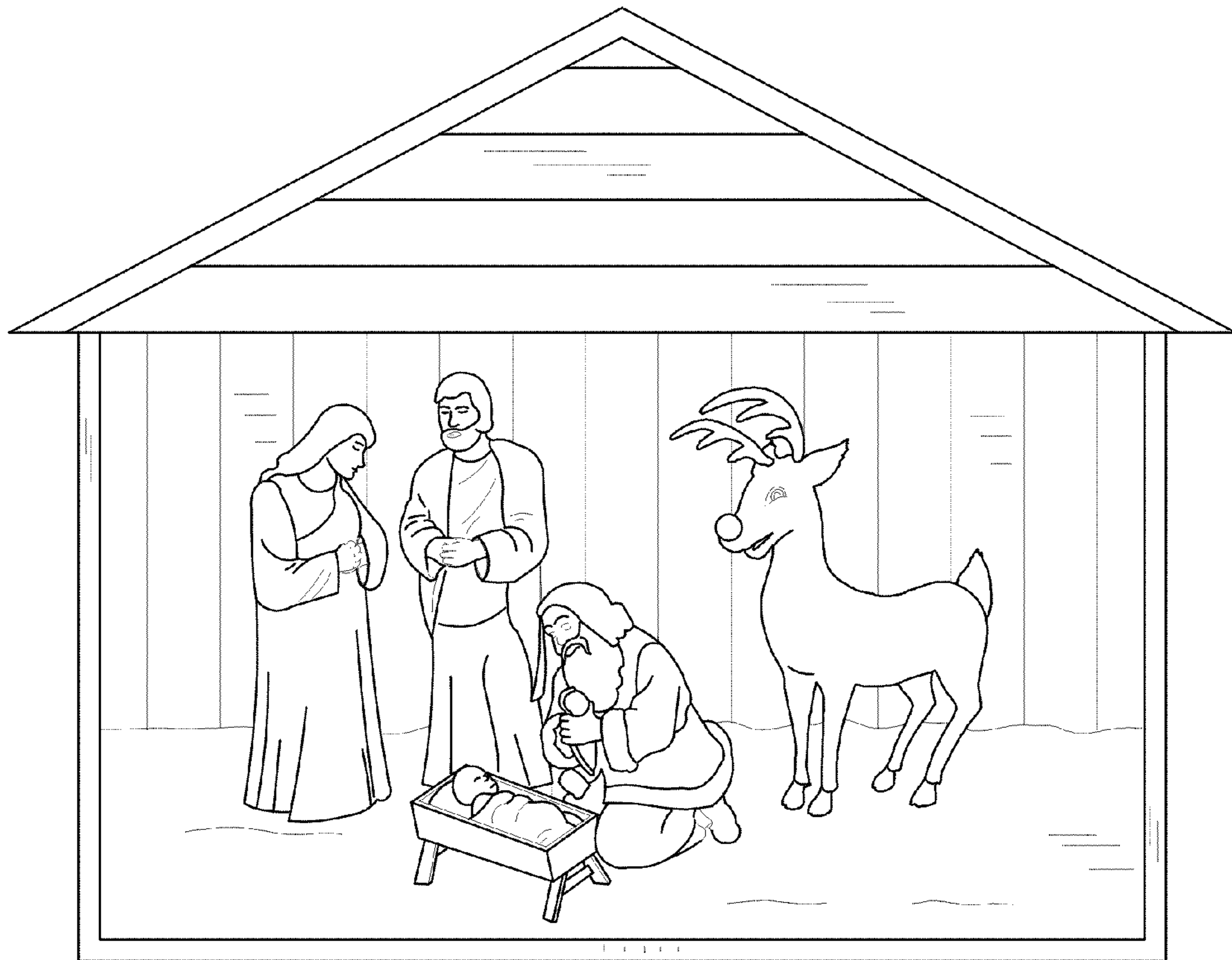

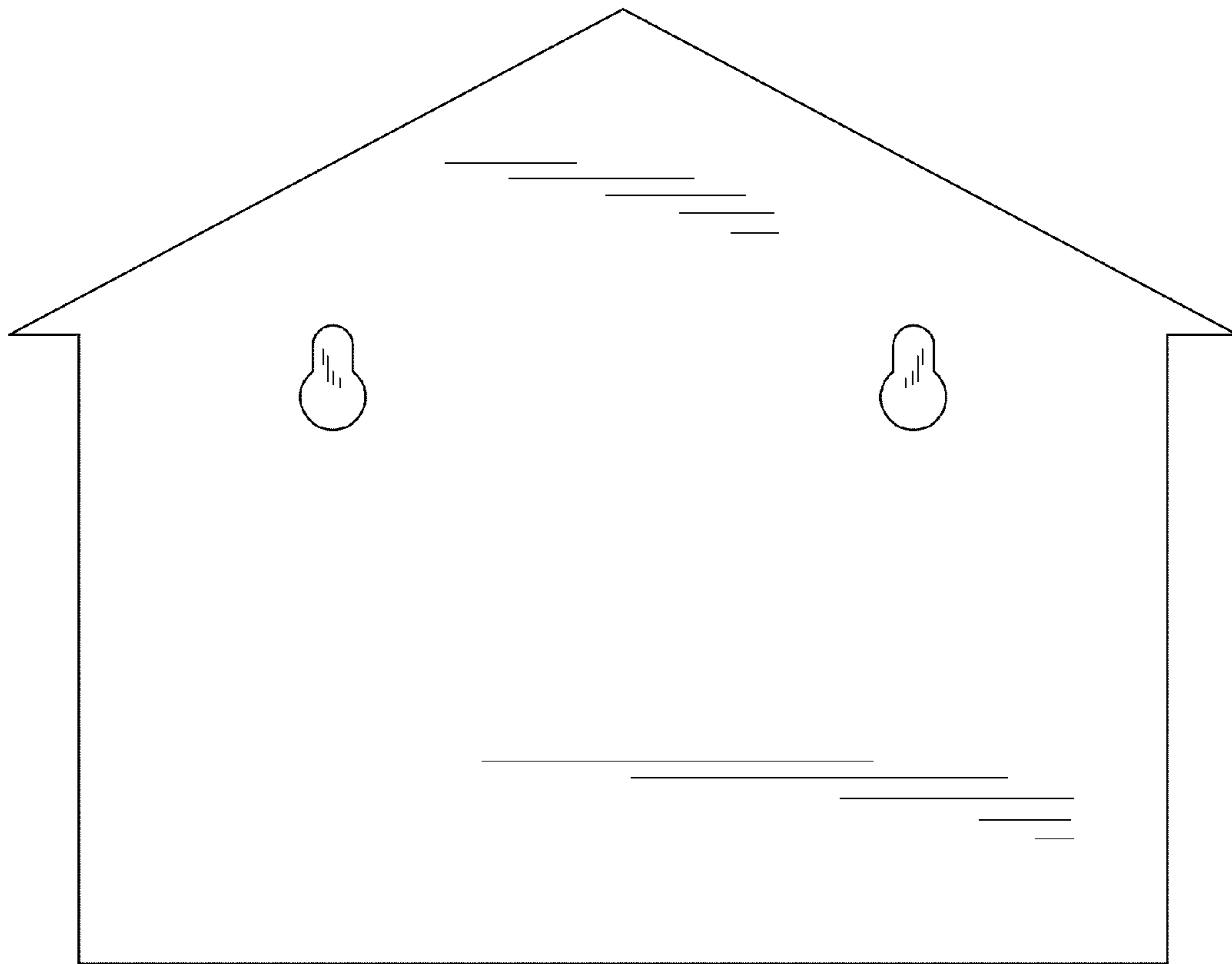

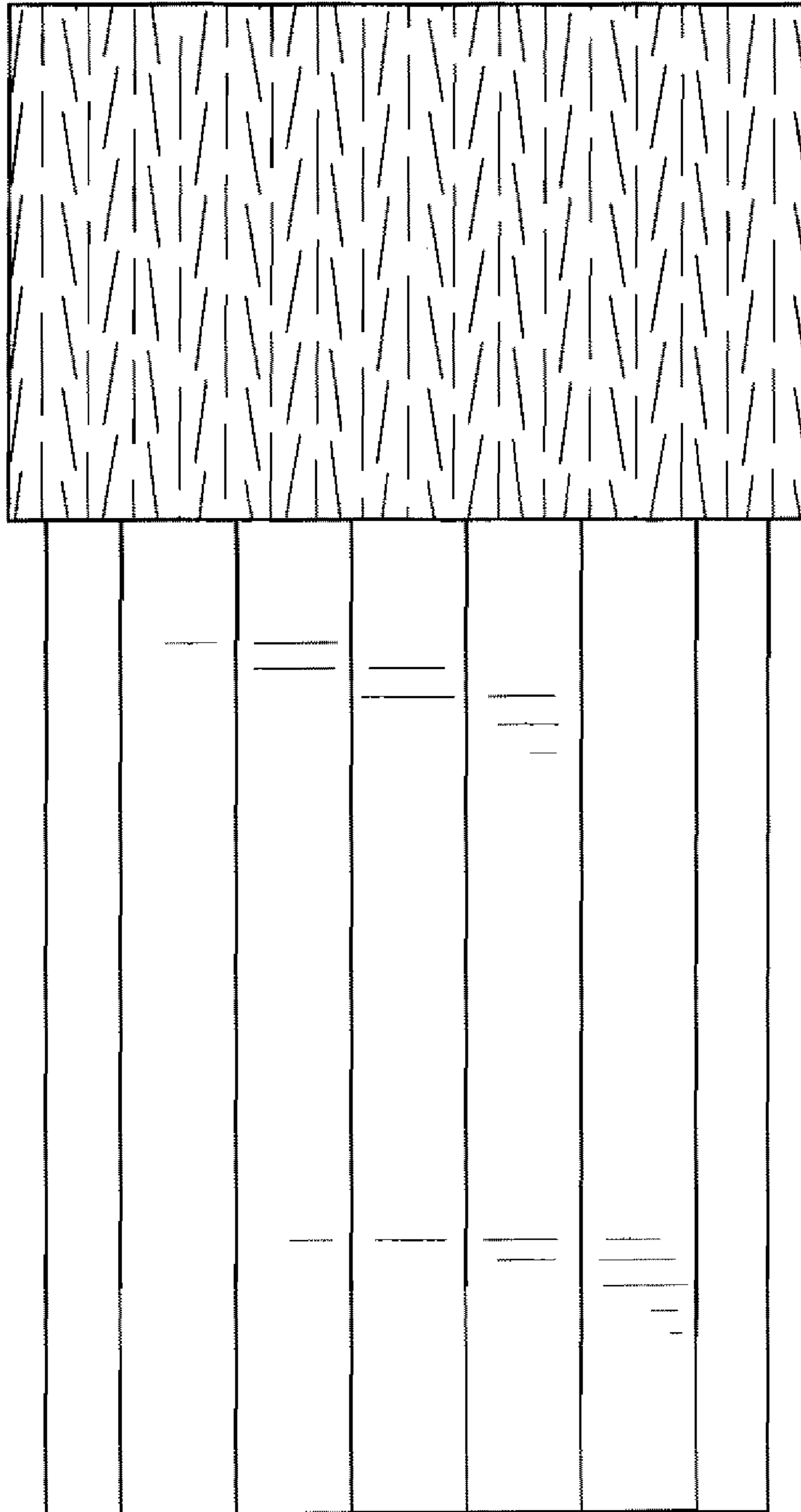

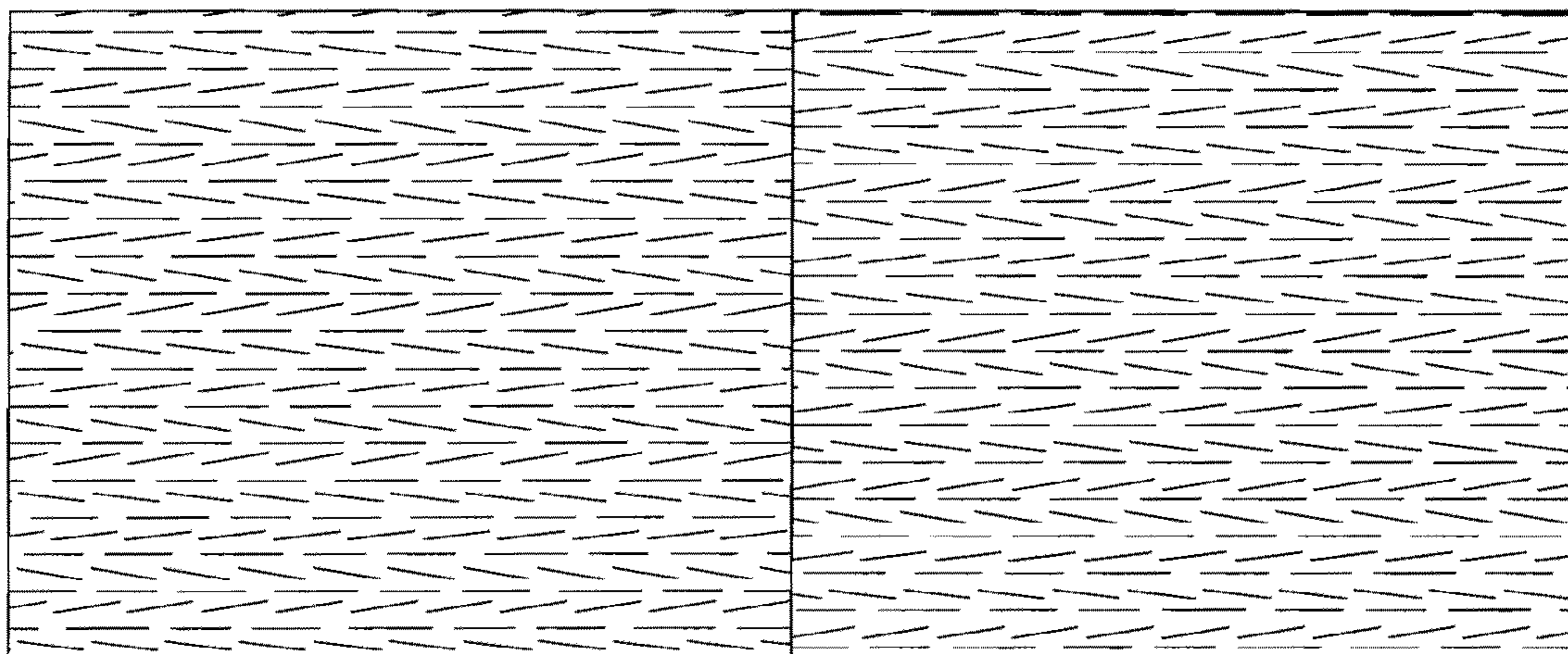

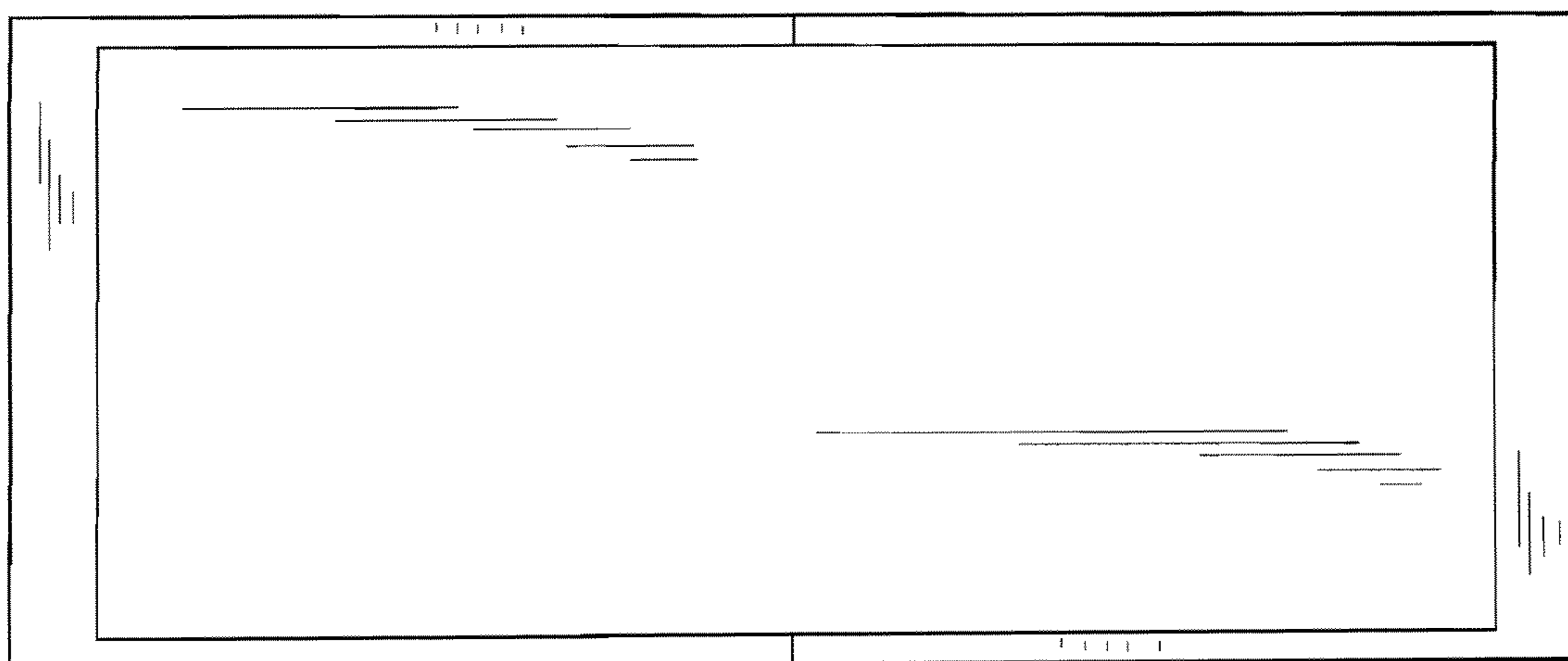
