FIG. 4 is a right side view of the charger of the design. A left side view is a mirror image of the right side view.

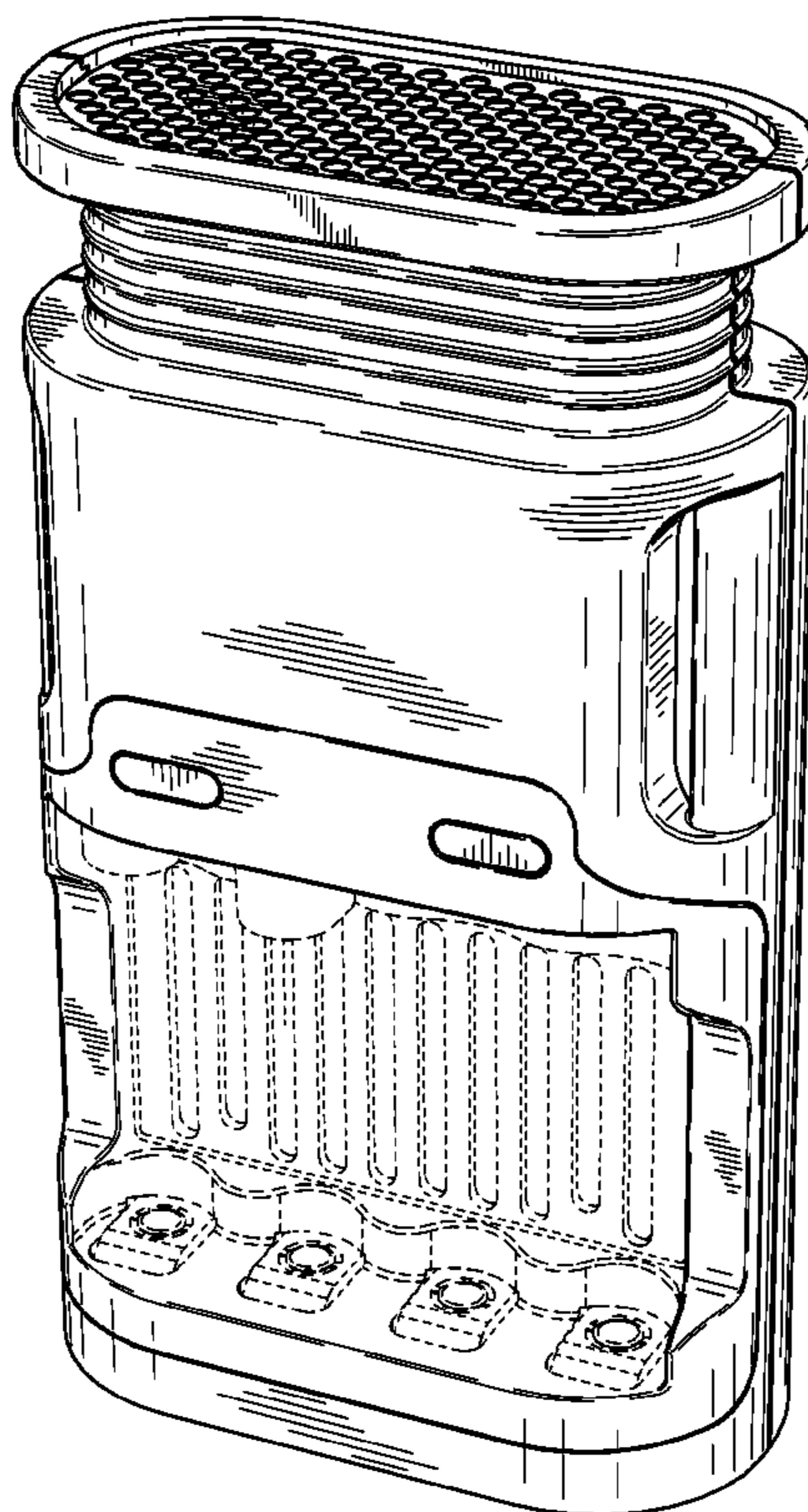
FIG. 5 is a front view of the charger of the design; and,

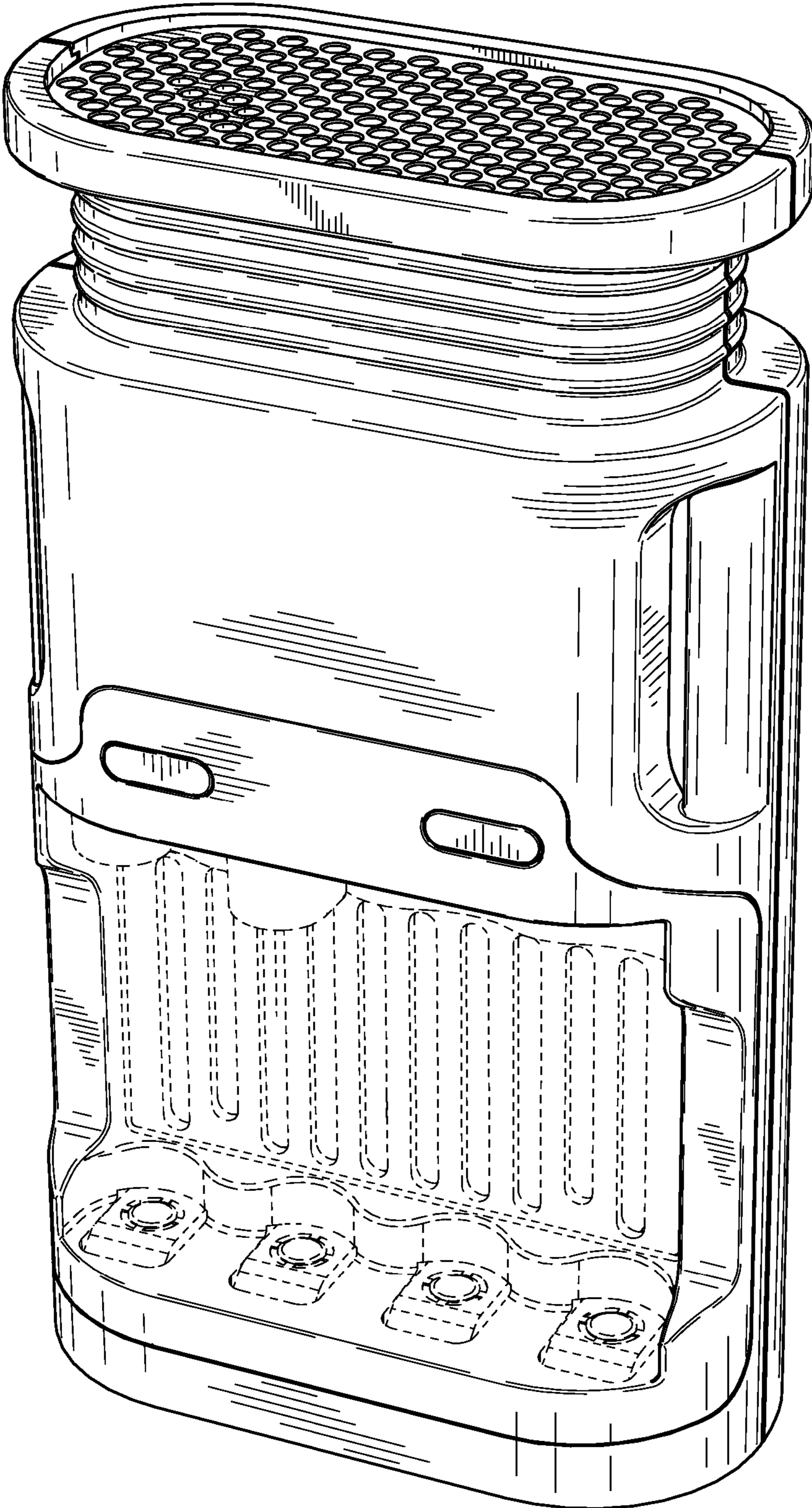

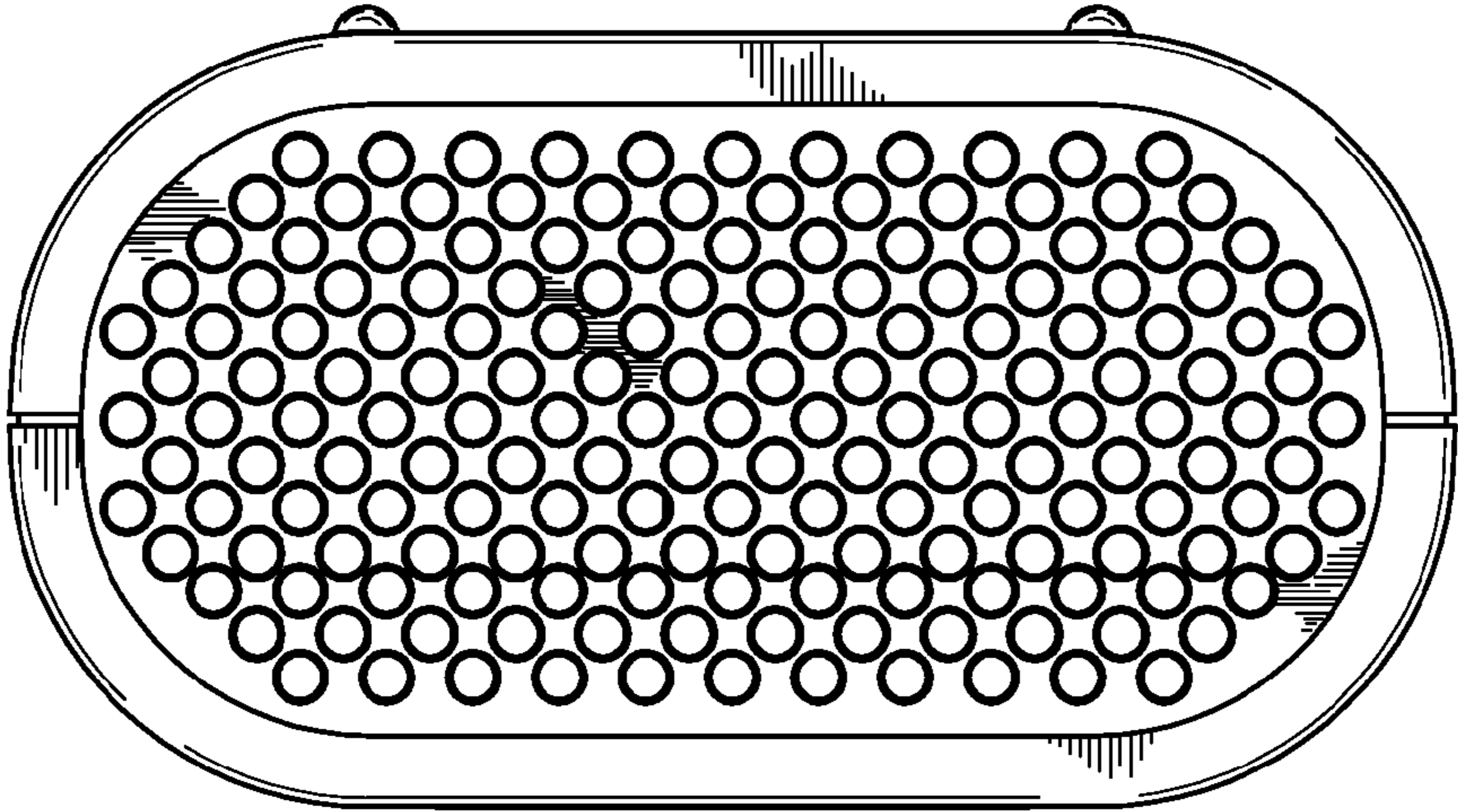

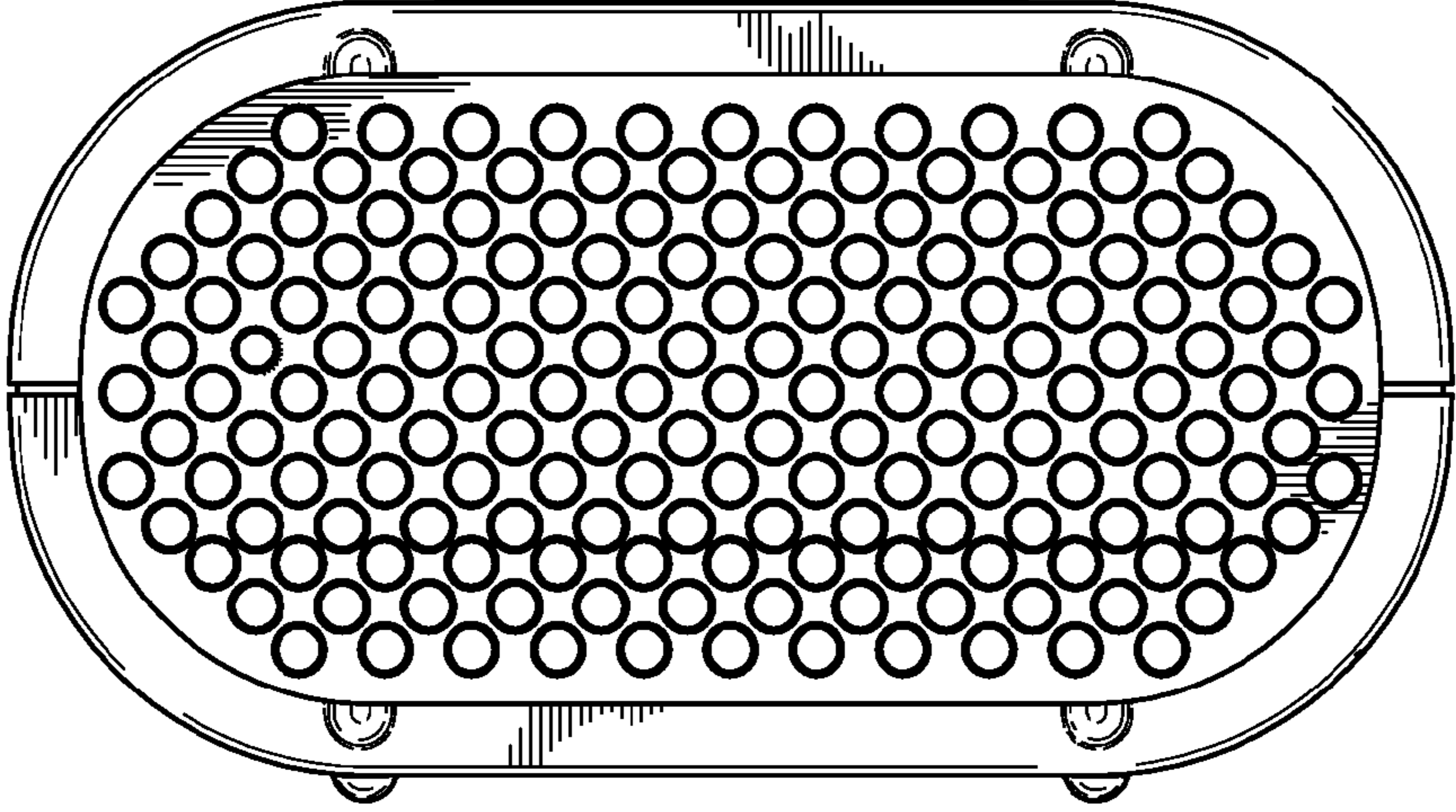

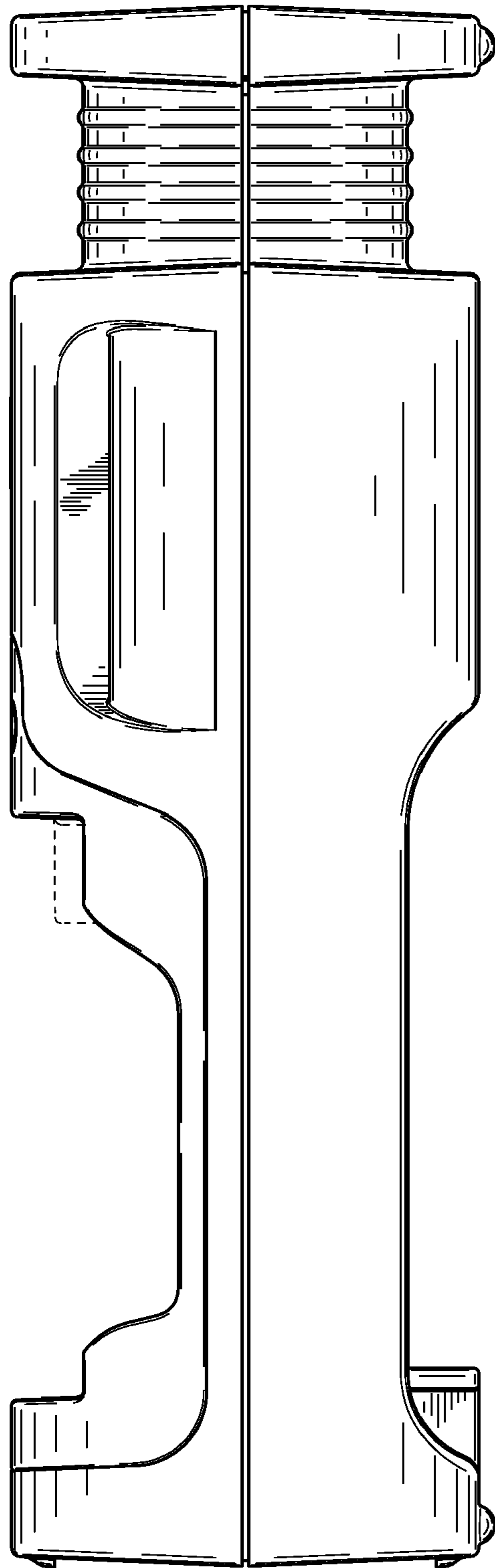

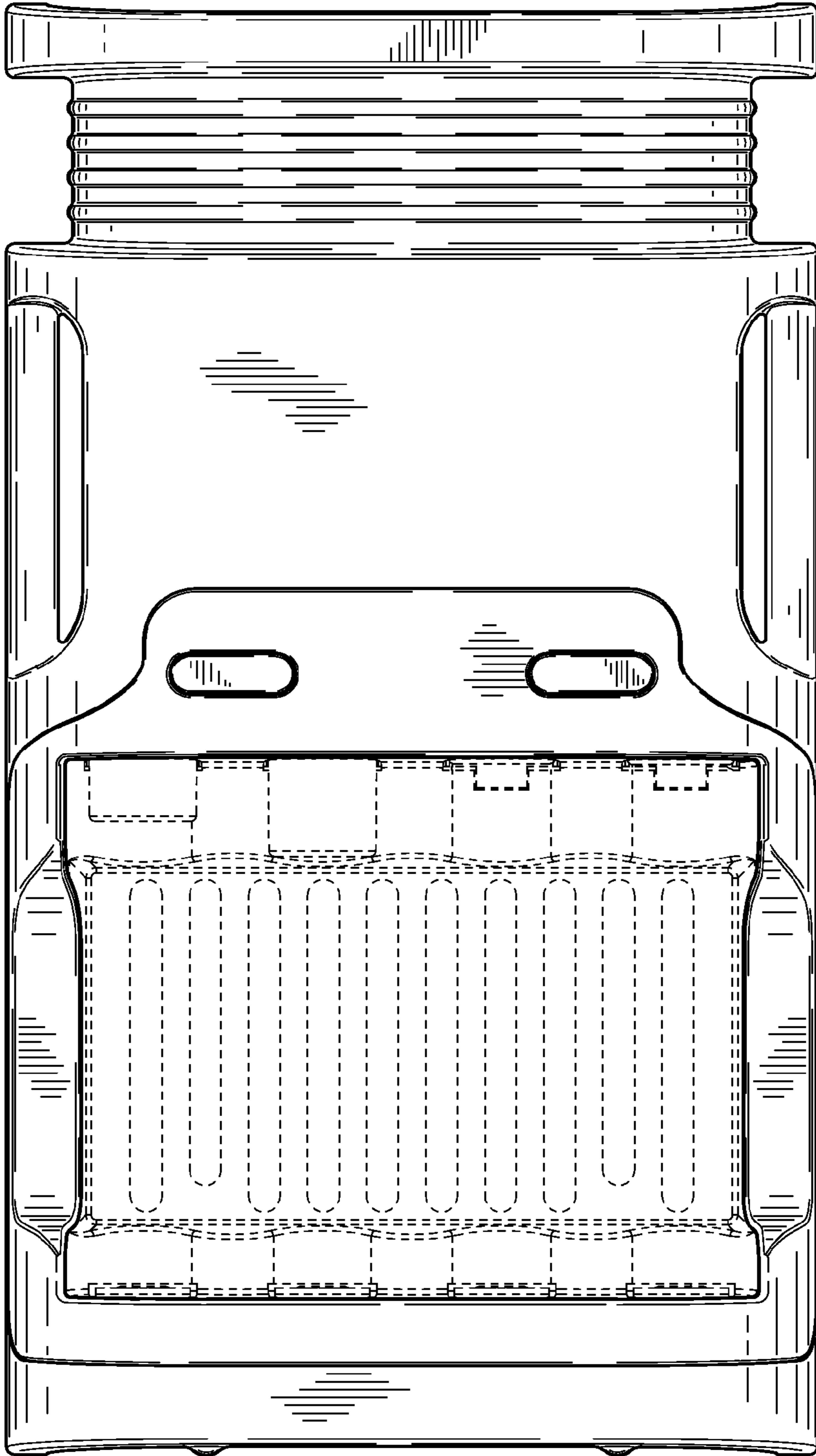

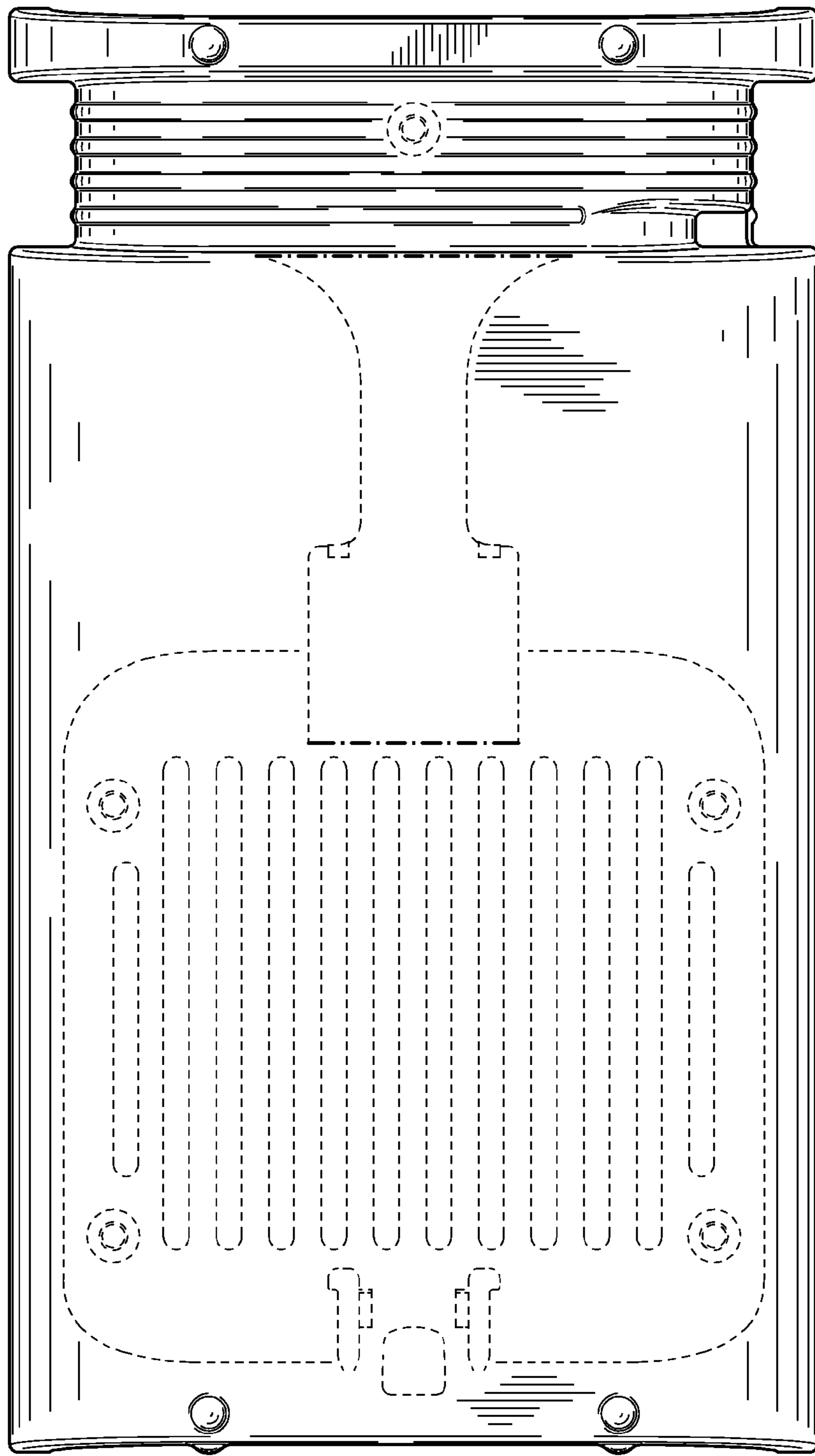
