The ornamental design for a storage device housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a storage device housing showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

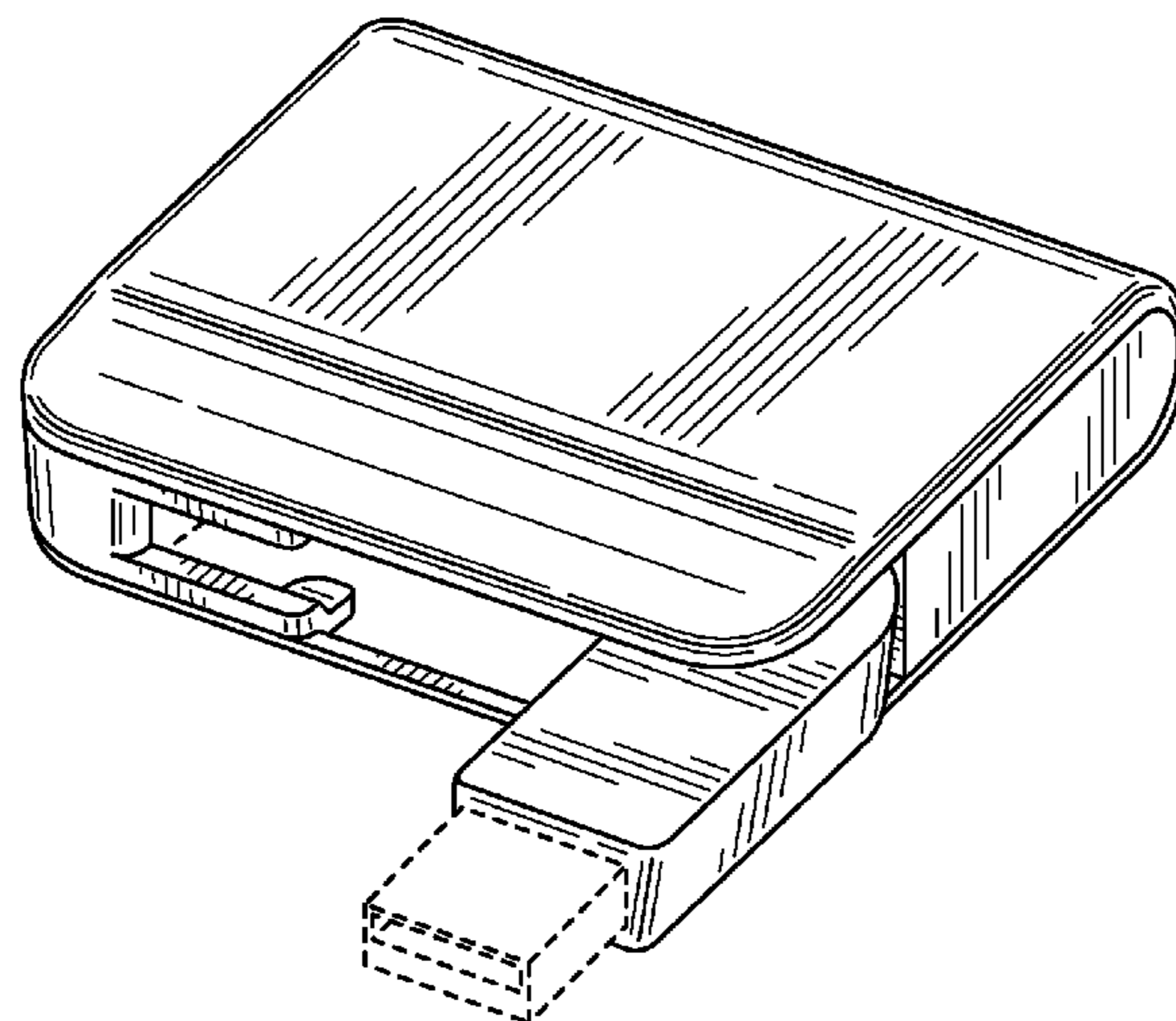
FIG. 6 is a left side elevational view thereof;

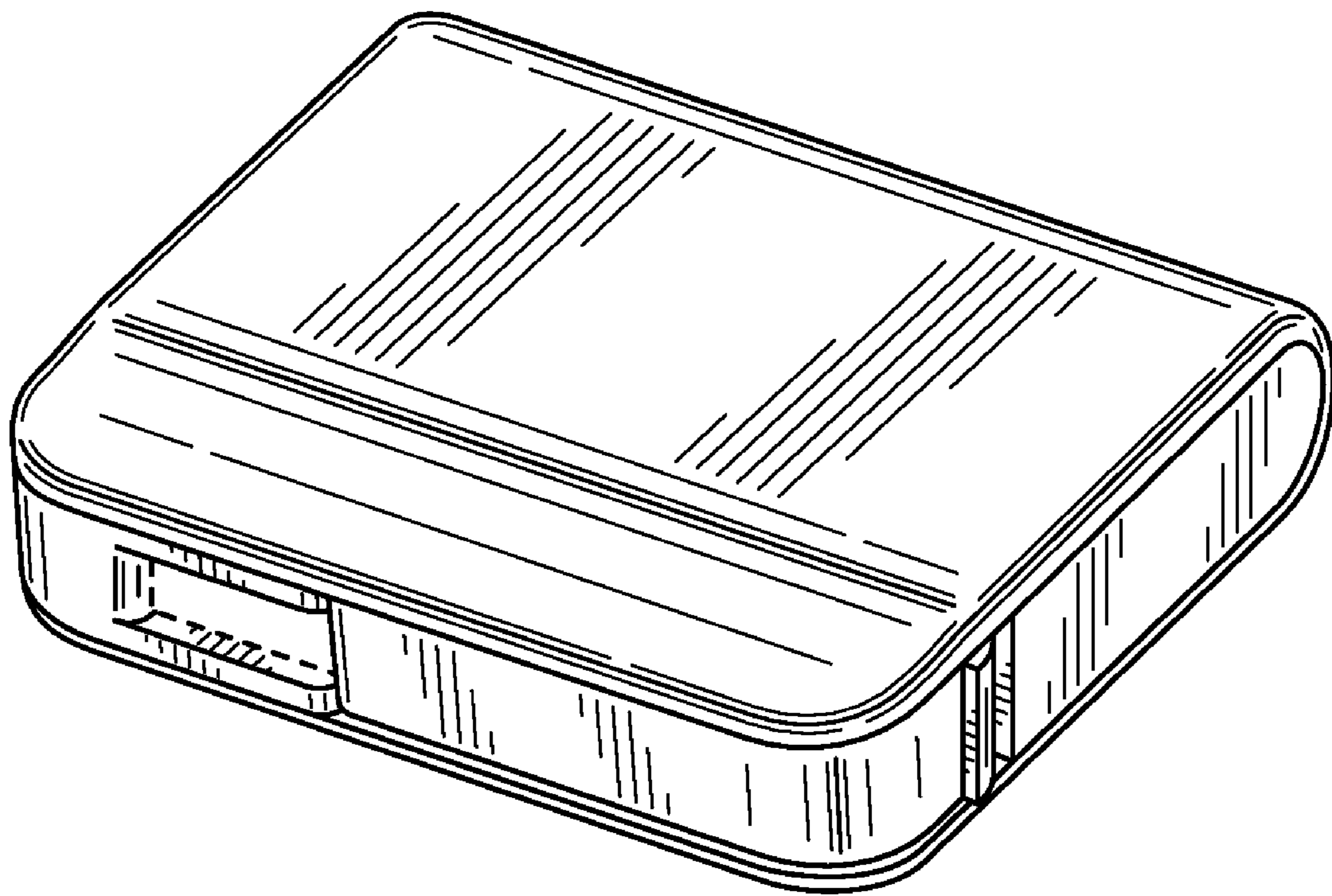

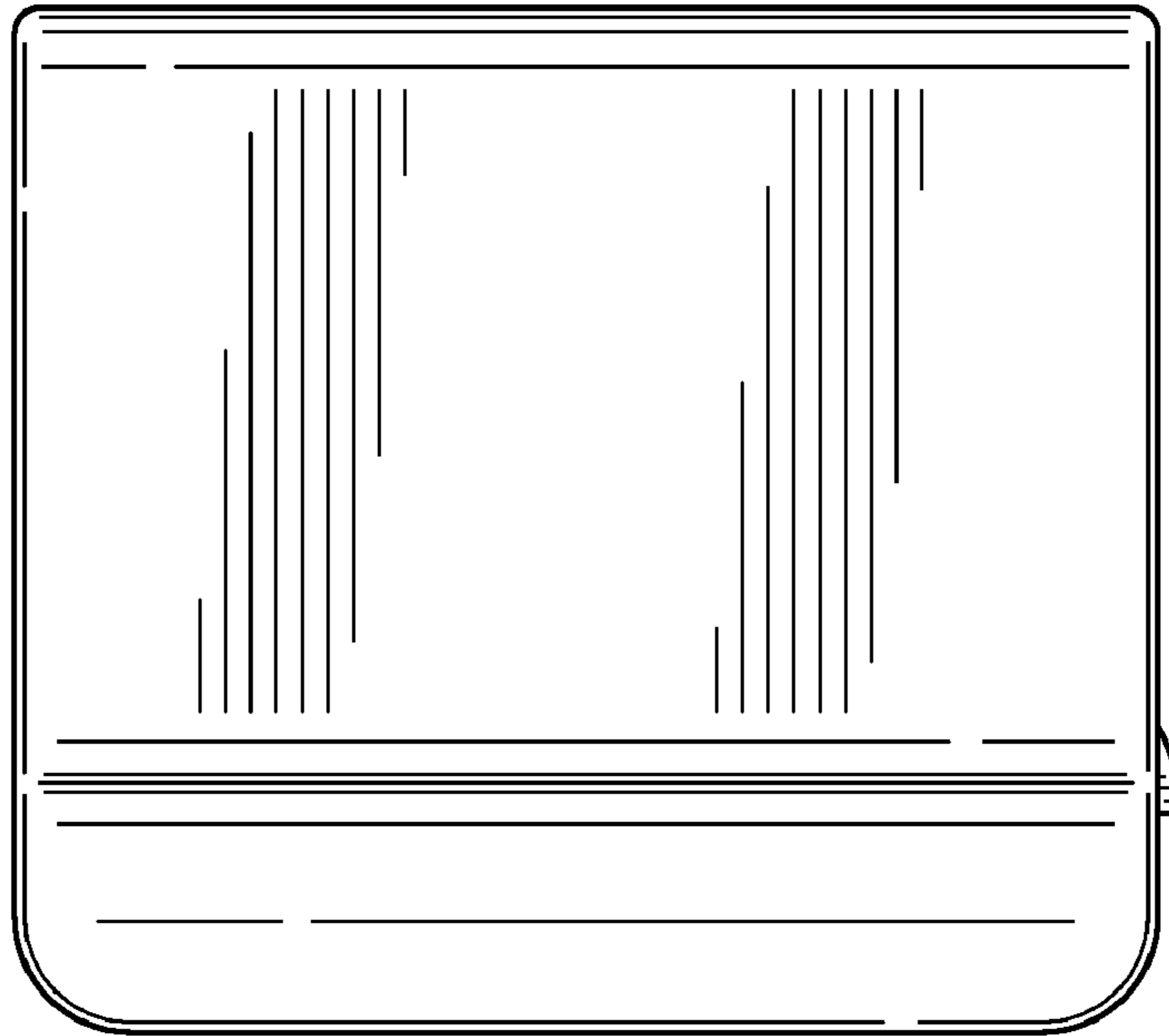

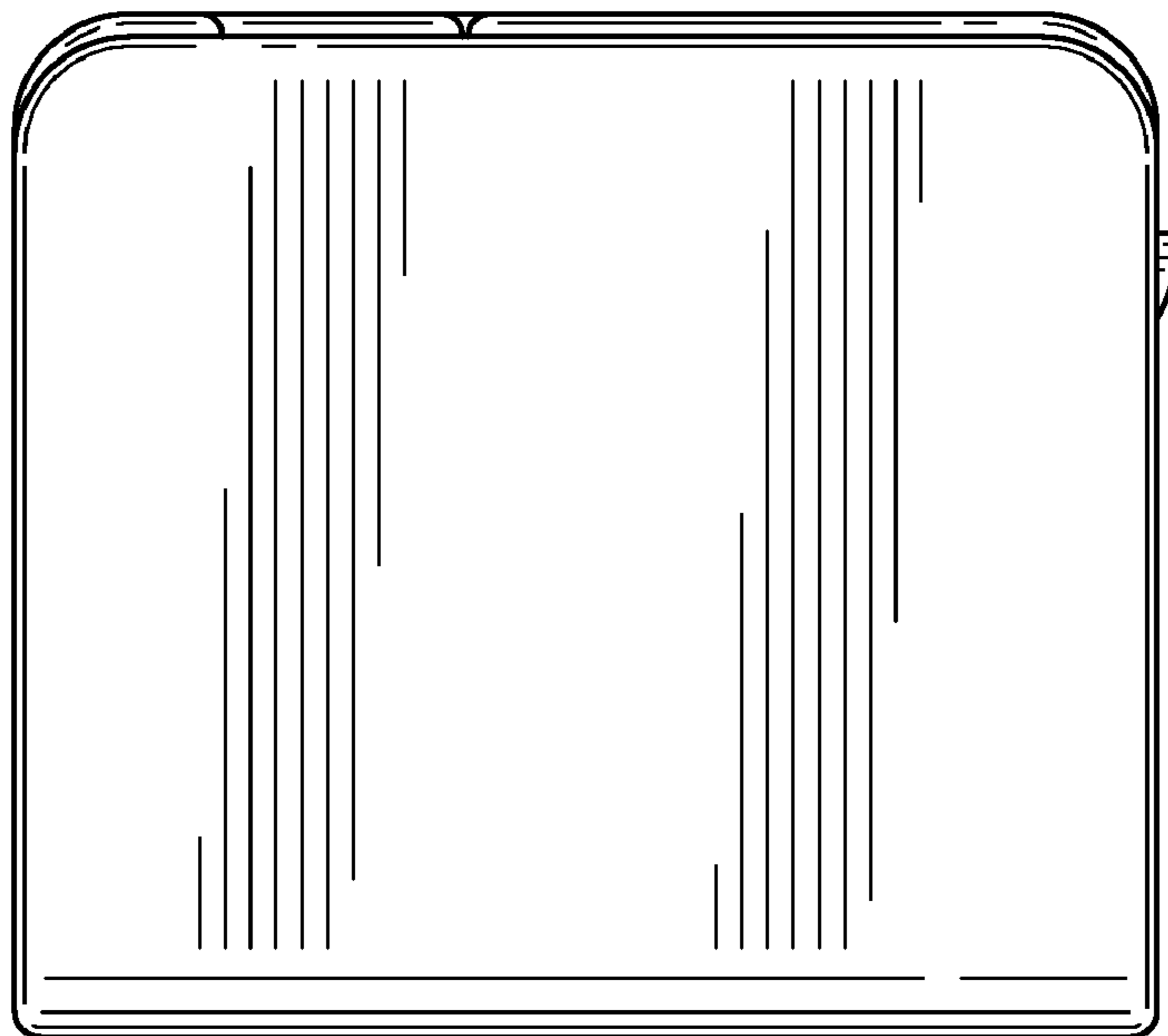

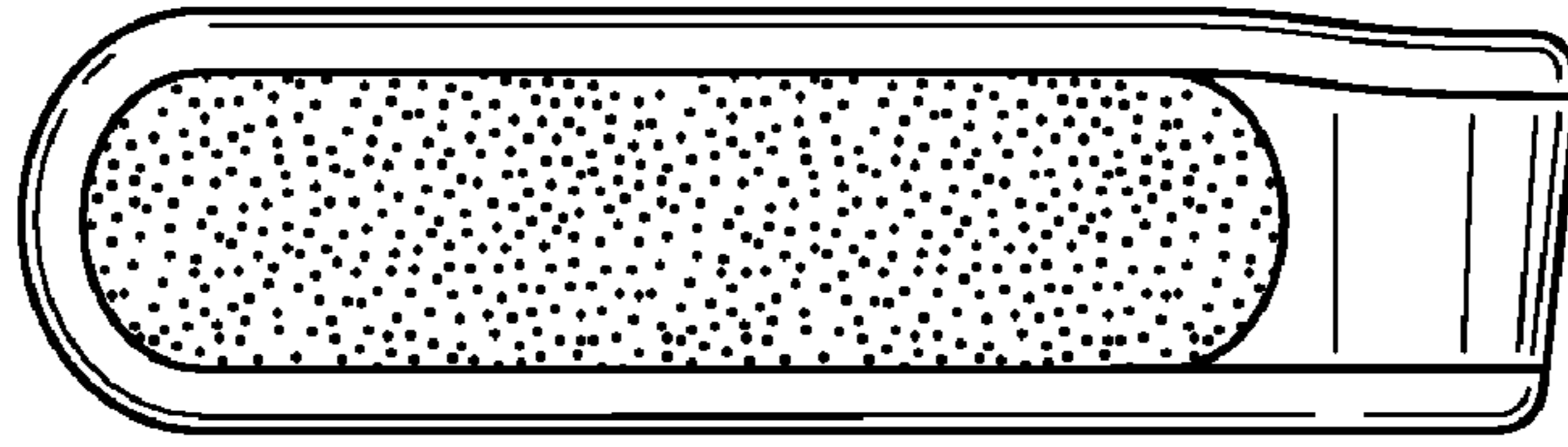

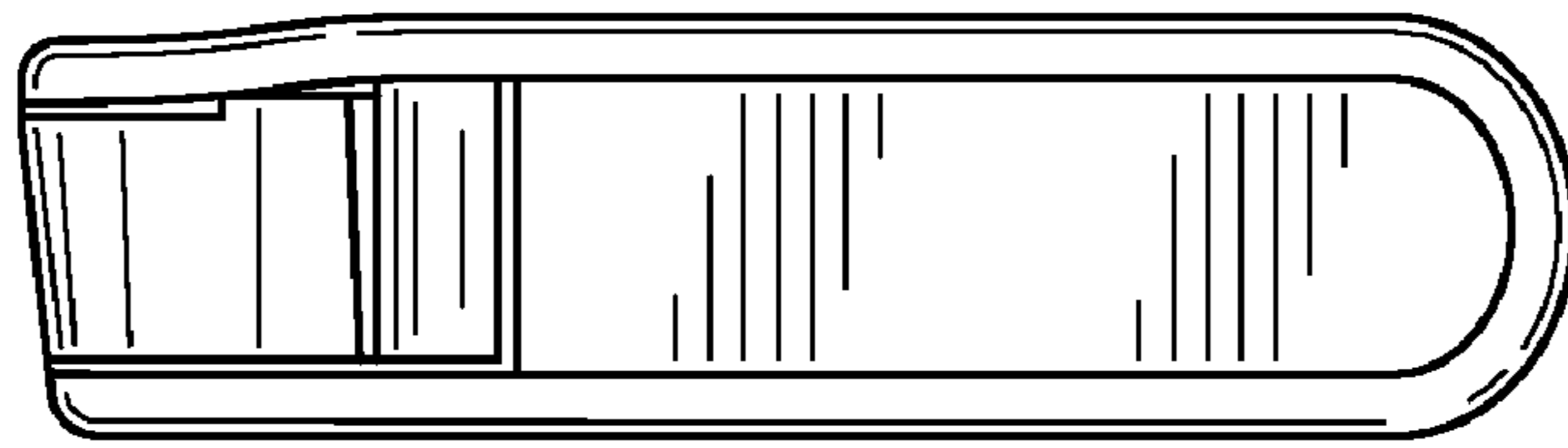

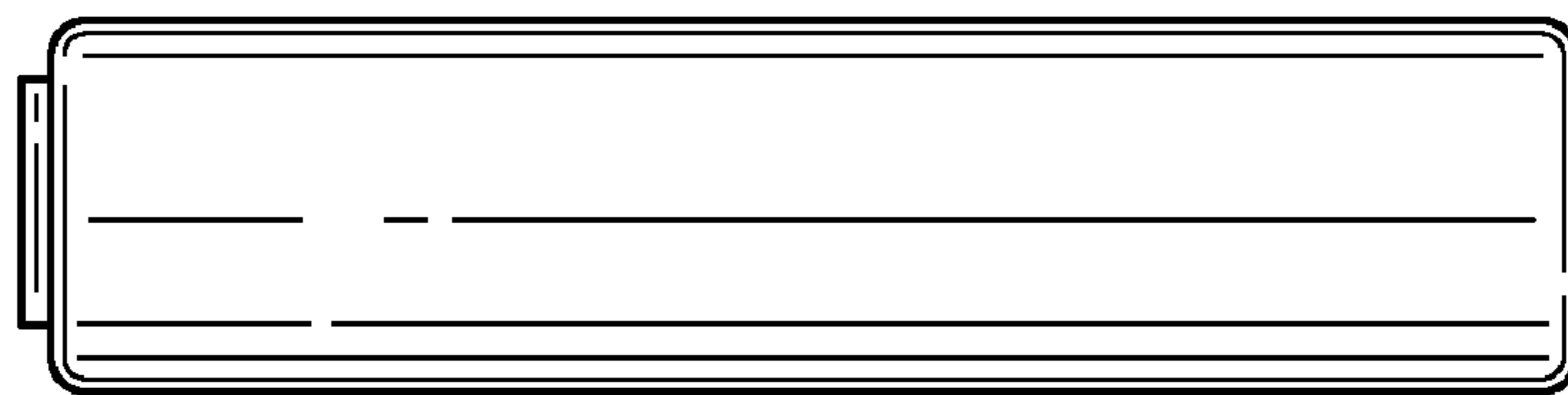

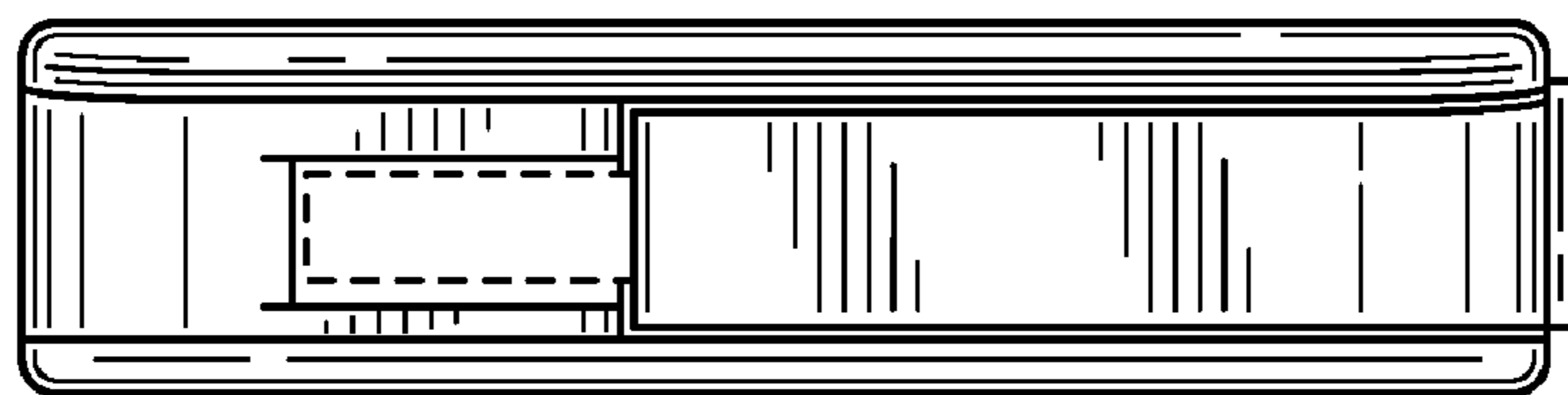

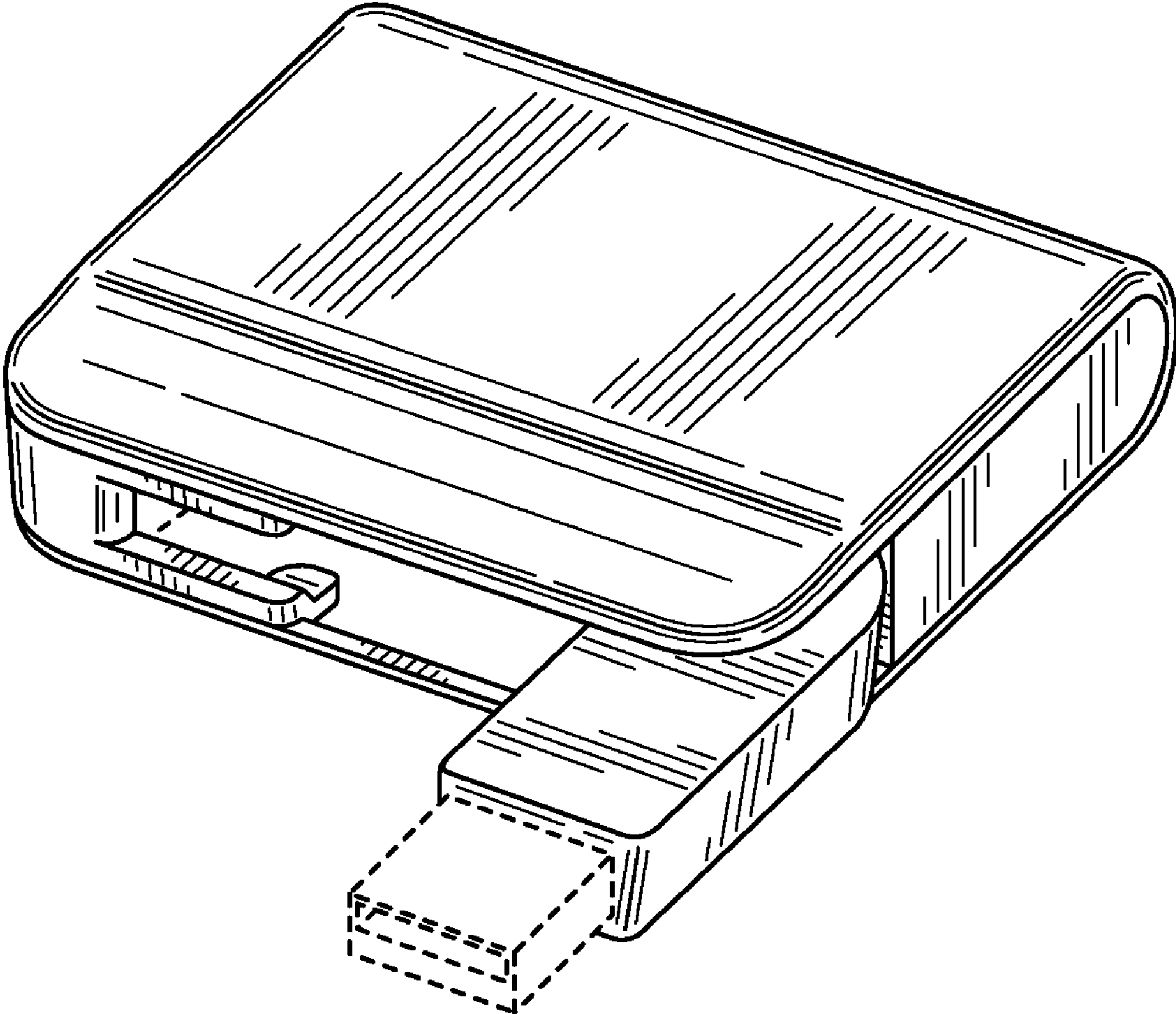
