(57) **CLAIM**

The ornamental design for a transitional video image display for portable phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first image of a transitional video image display for portable phone;

FIG. 2 is a front view of the first image of a transitional video image display for portable phone of FIG. 1;

FIG. 3 is an enlarged front view of the first image of a transitional video image display for portable phone of FIG. 1 shown without the portable phone in broken lines; and,

FIG. 4 is a front view of a second image of a transitional video image display for portable phone.

The broken line showing of portions of a mobile phone is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

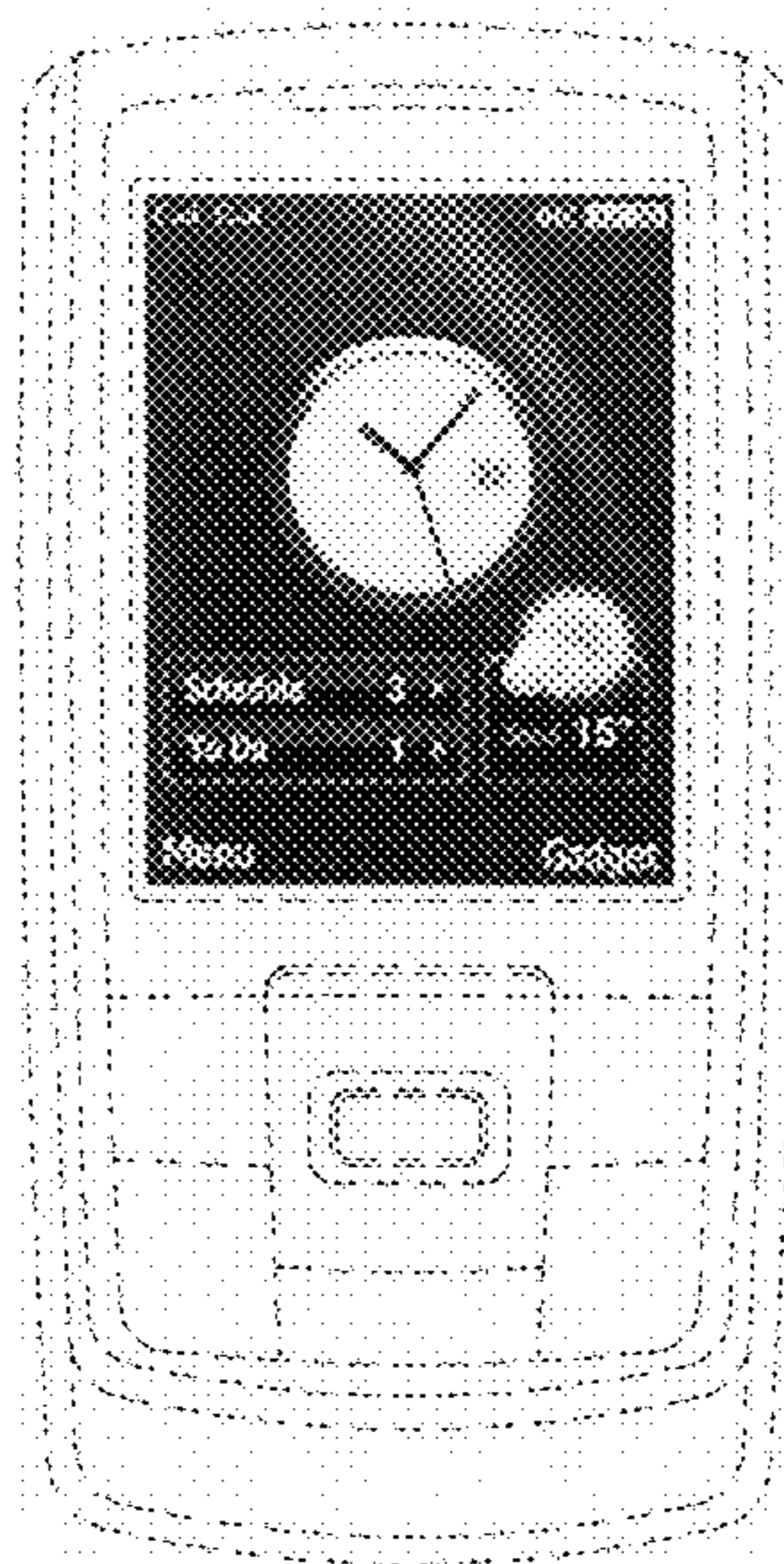

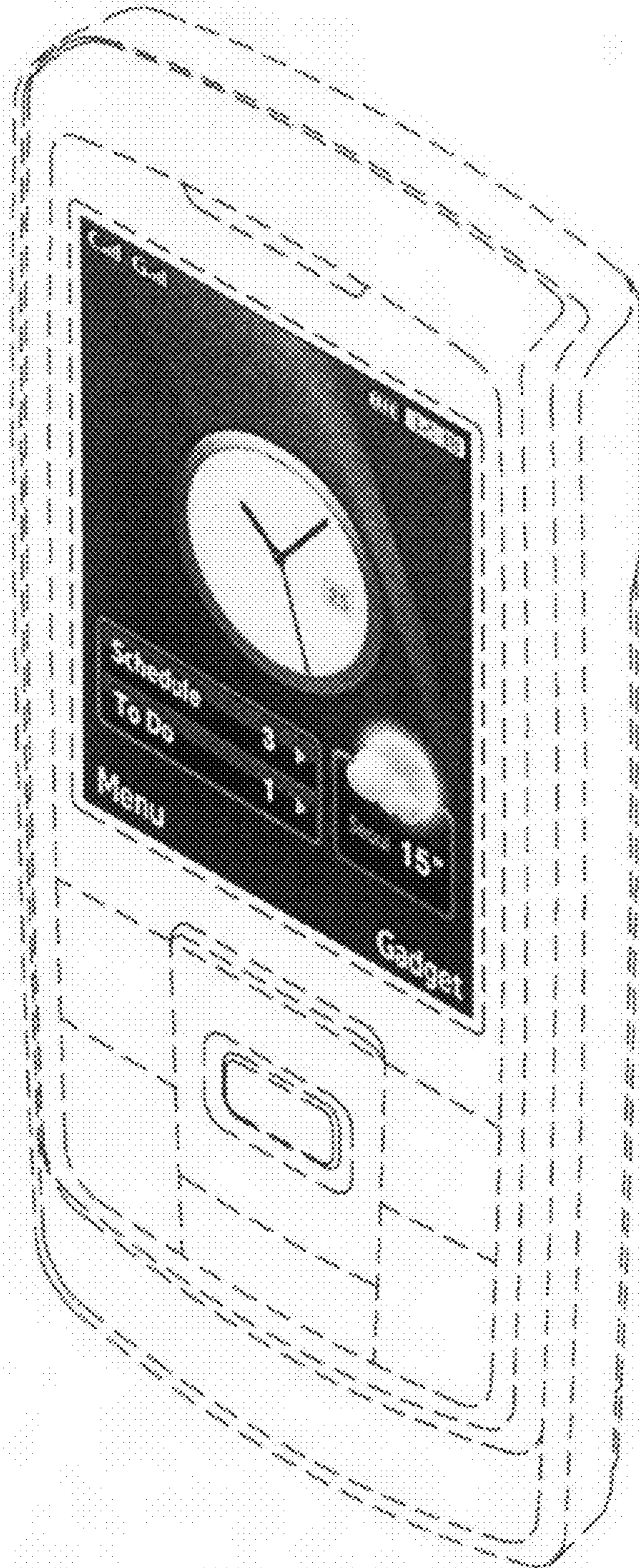

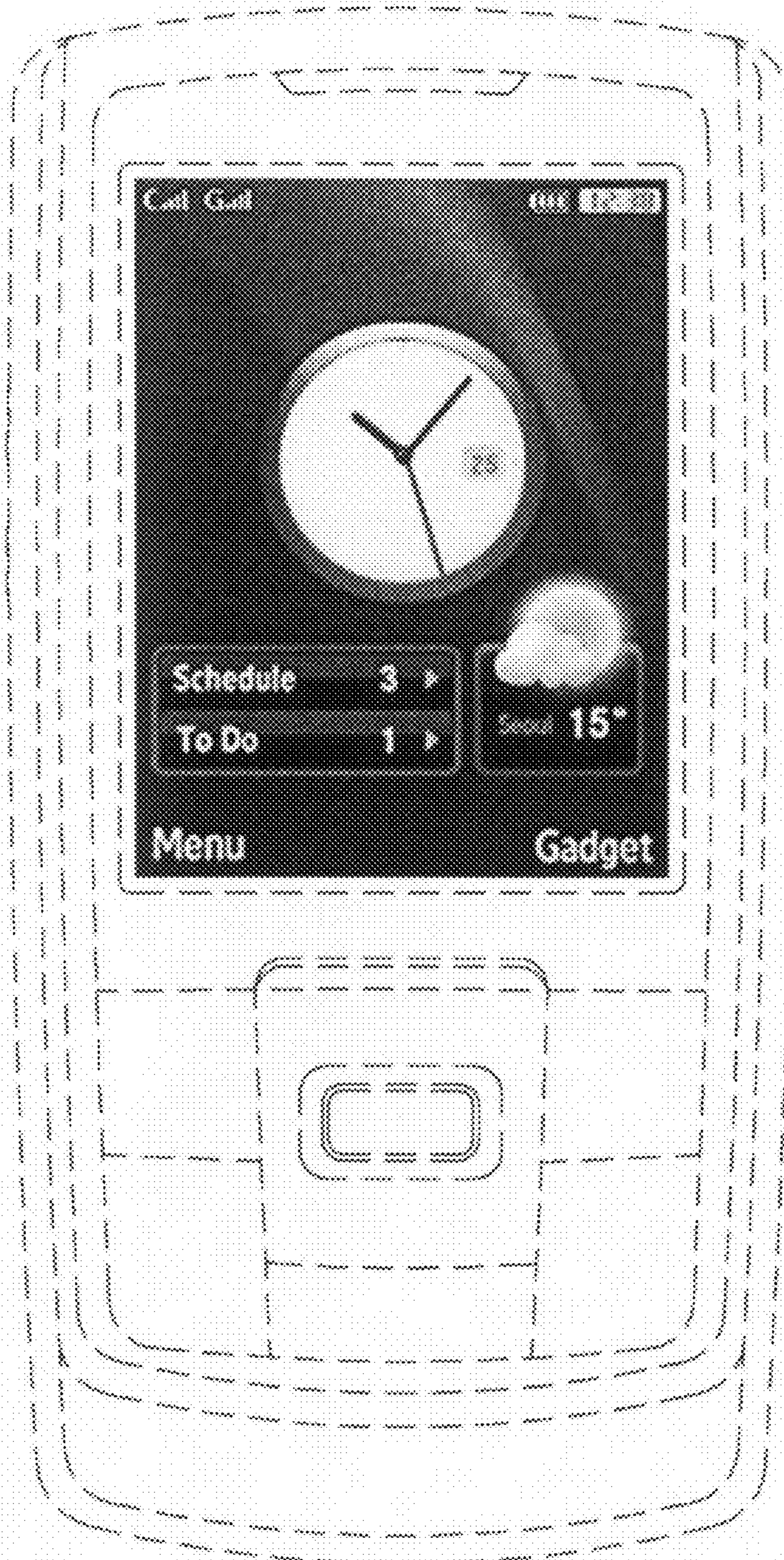
