(57) **CLAIM**

The ornamental design for a housing for a display panel of a road construction machine, as shown and described.

FIG. 1 is a top perspective view of a top cover of a housing for a display panel of a road construction machine showing my new design, the top cover shown removed for ease of illustration,

FIG. 17 is a bottom plan view of FIG. 15,

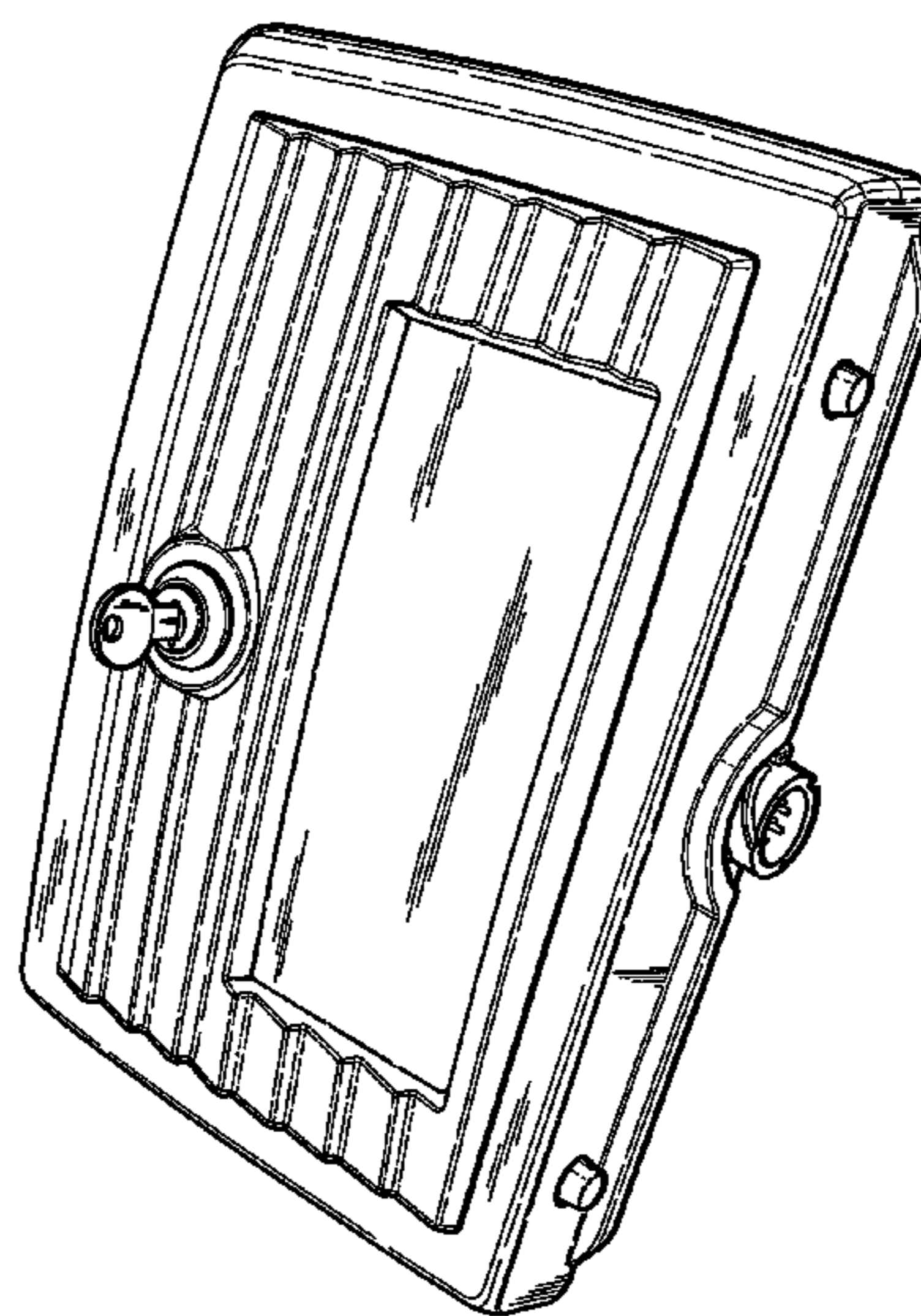
FIG. 18 is a bottom elevational view of FIG. 17,

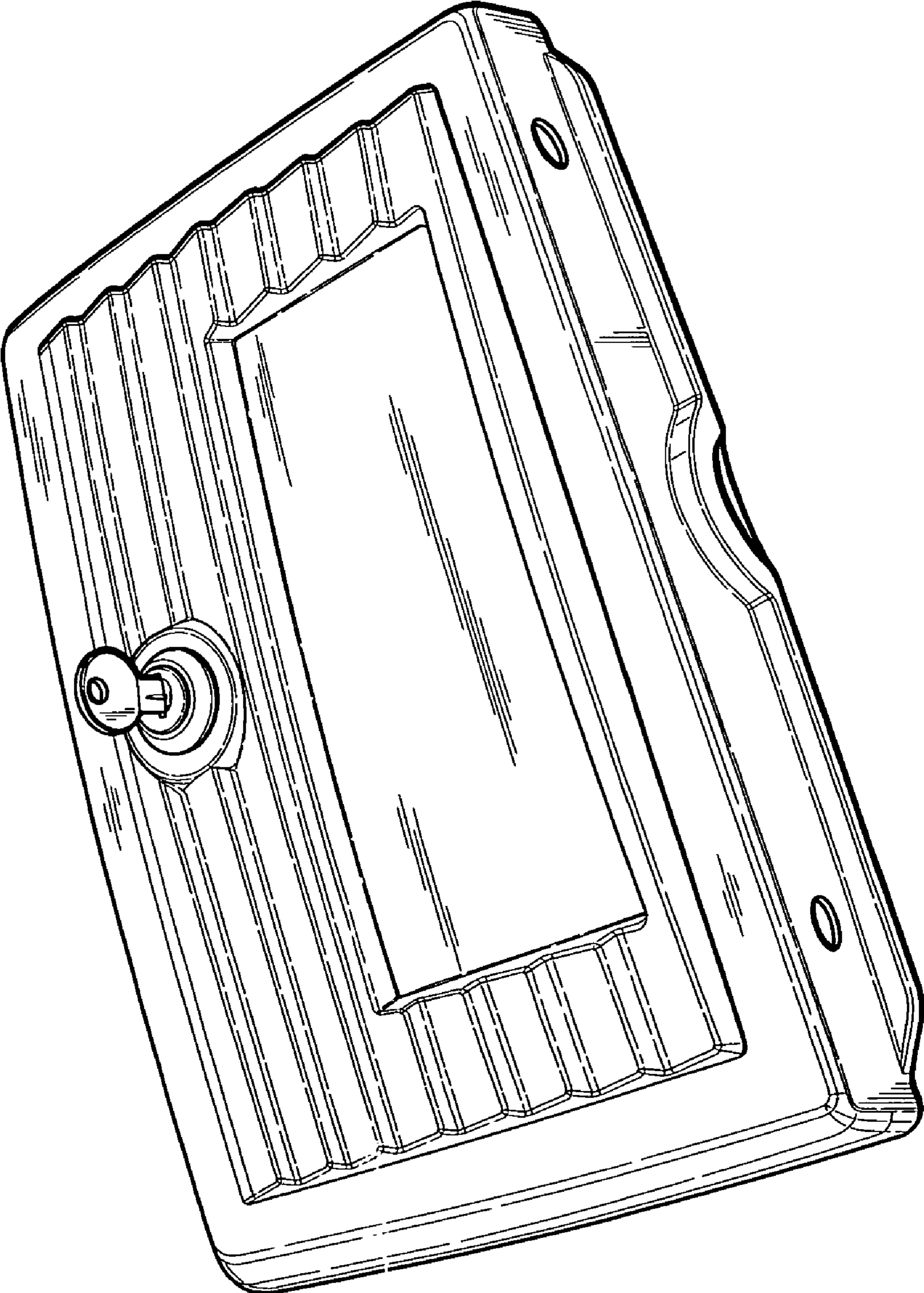

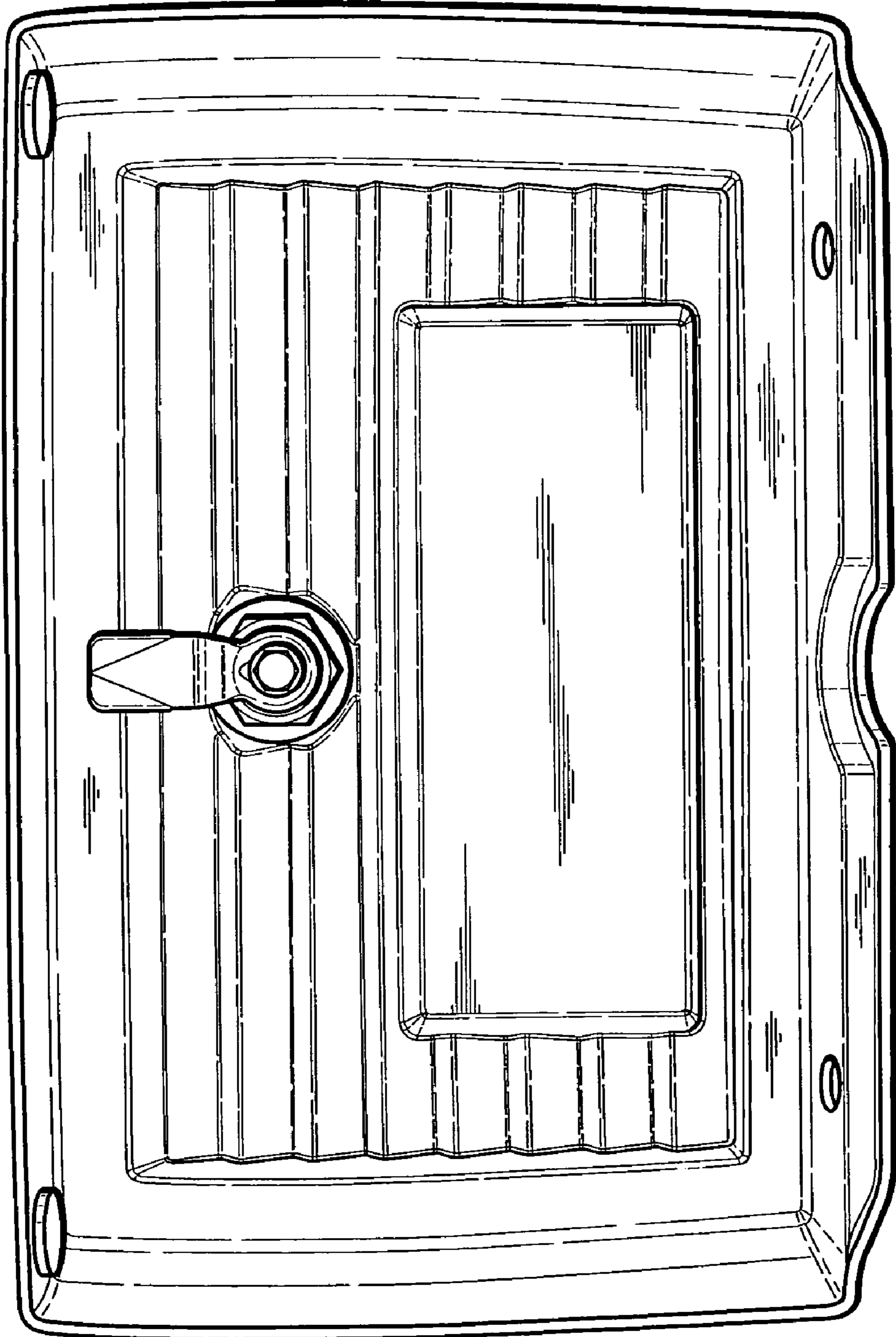

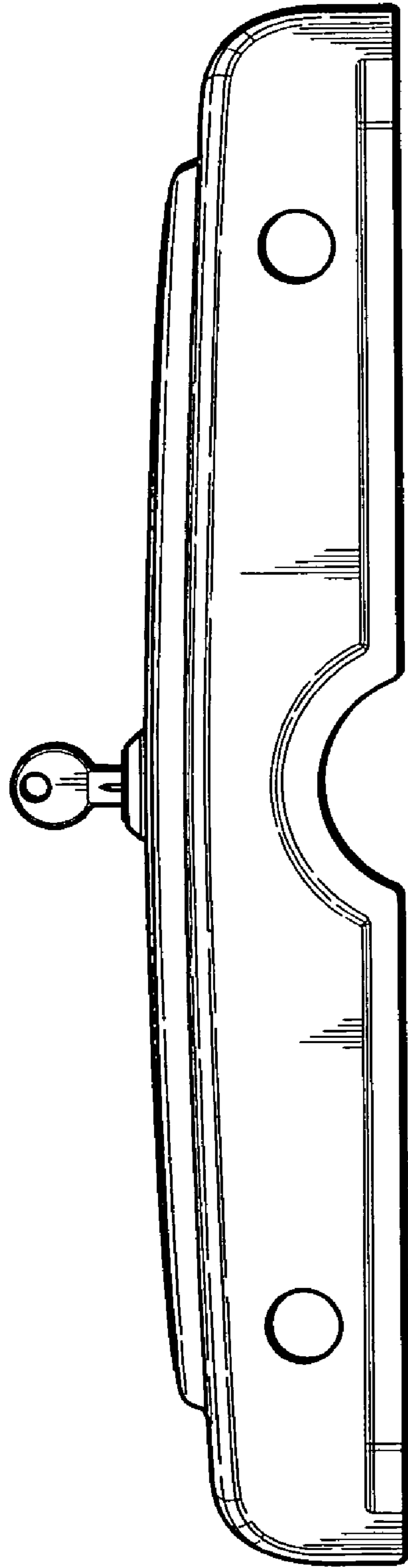

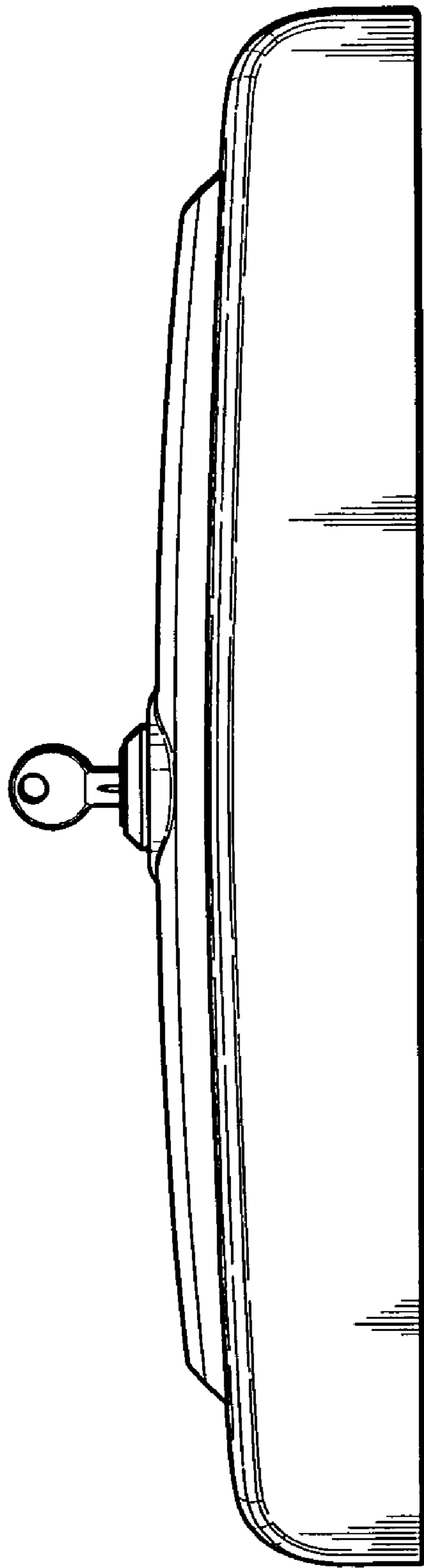

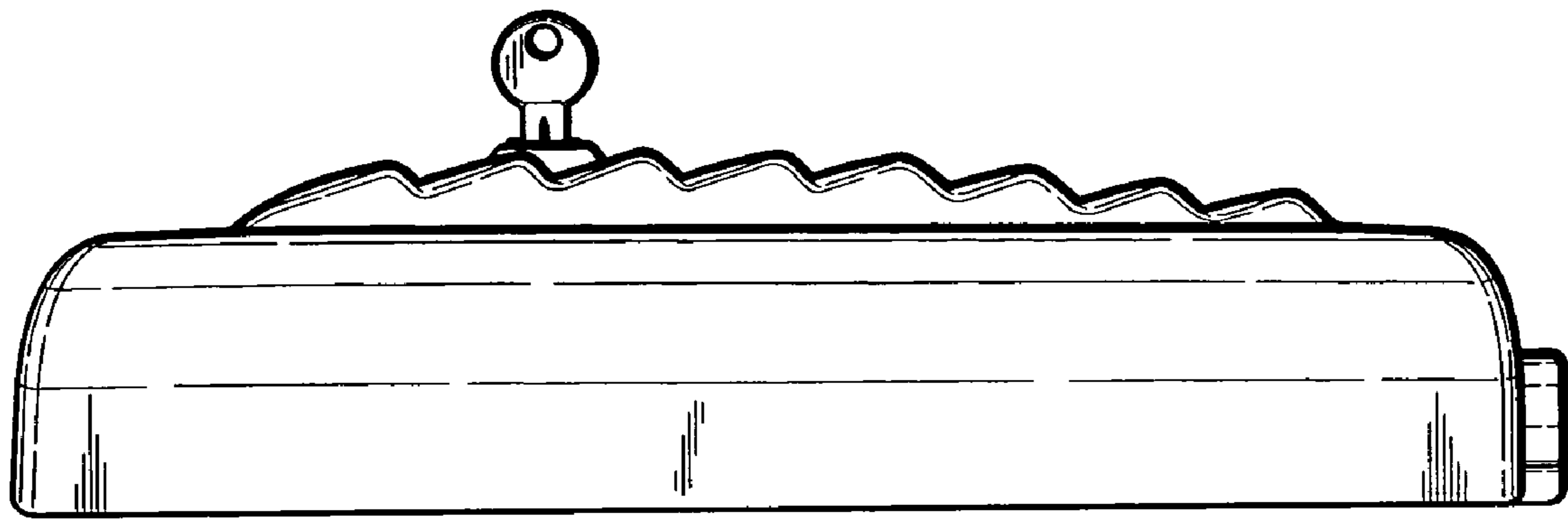

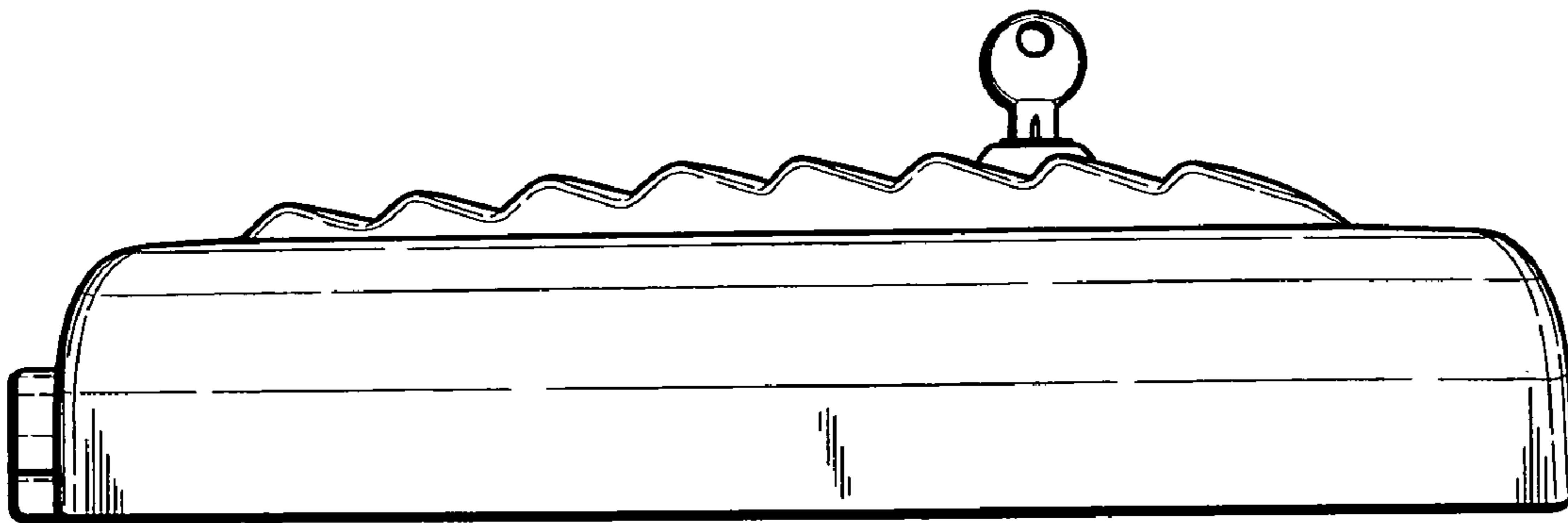

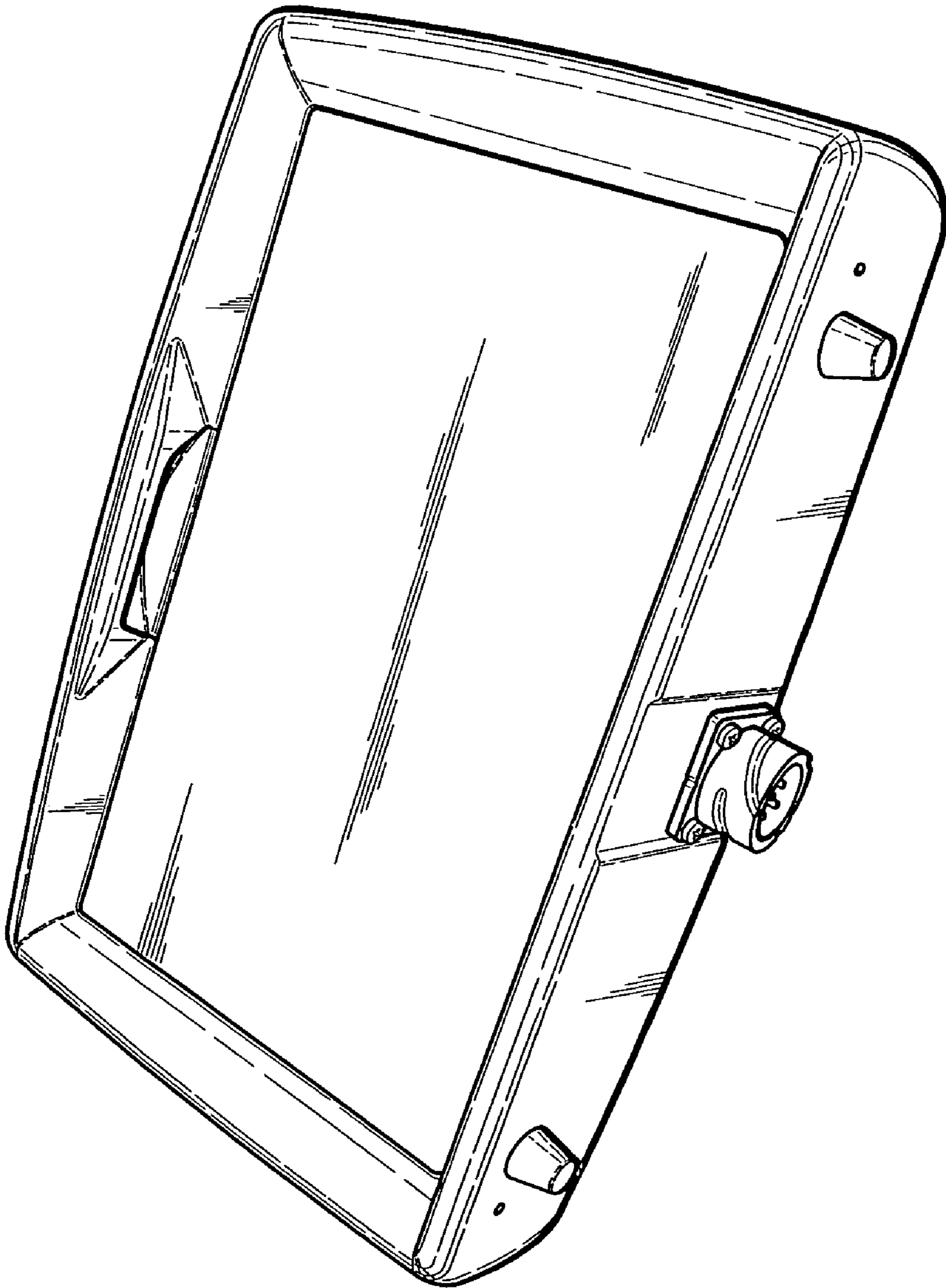

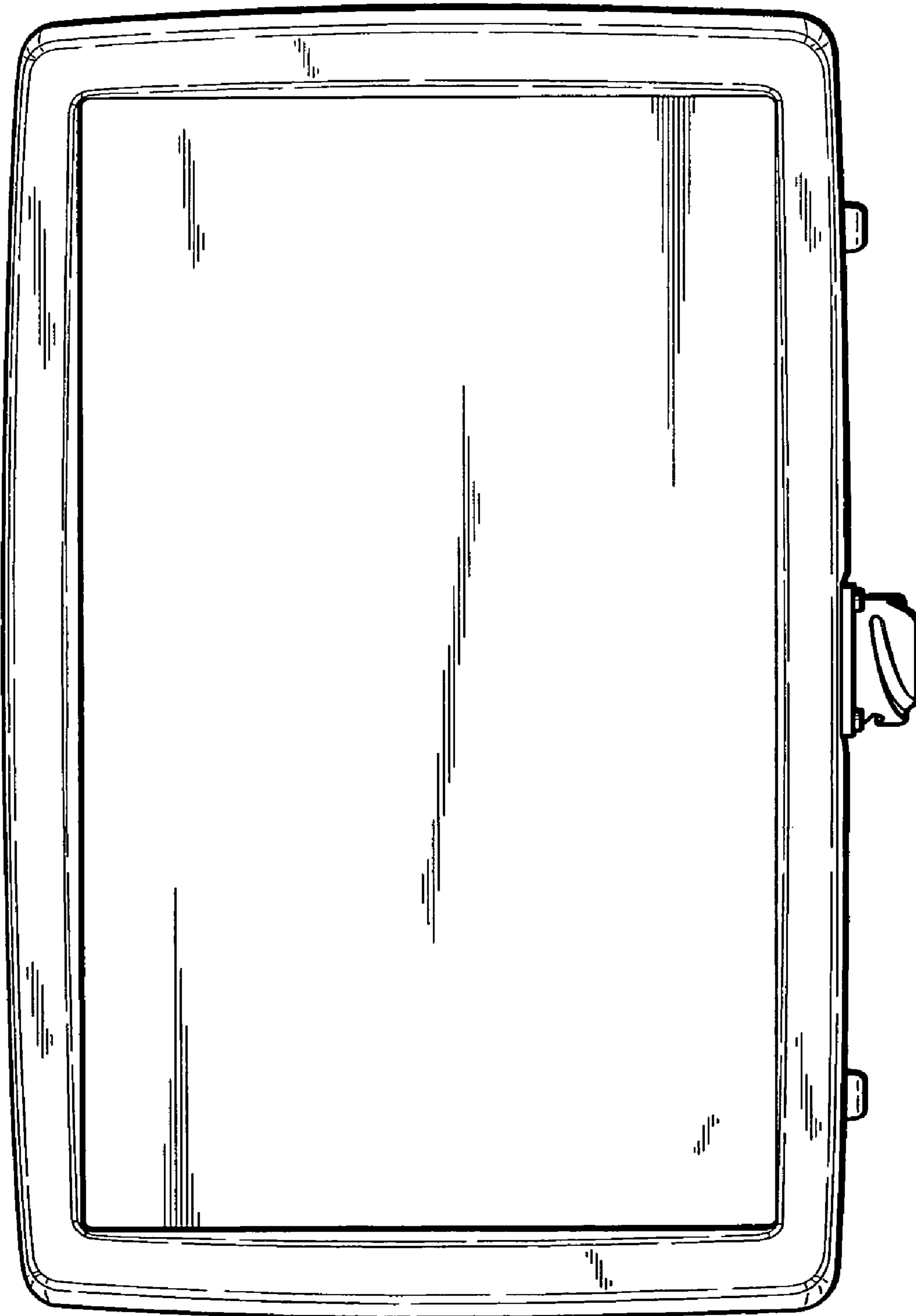

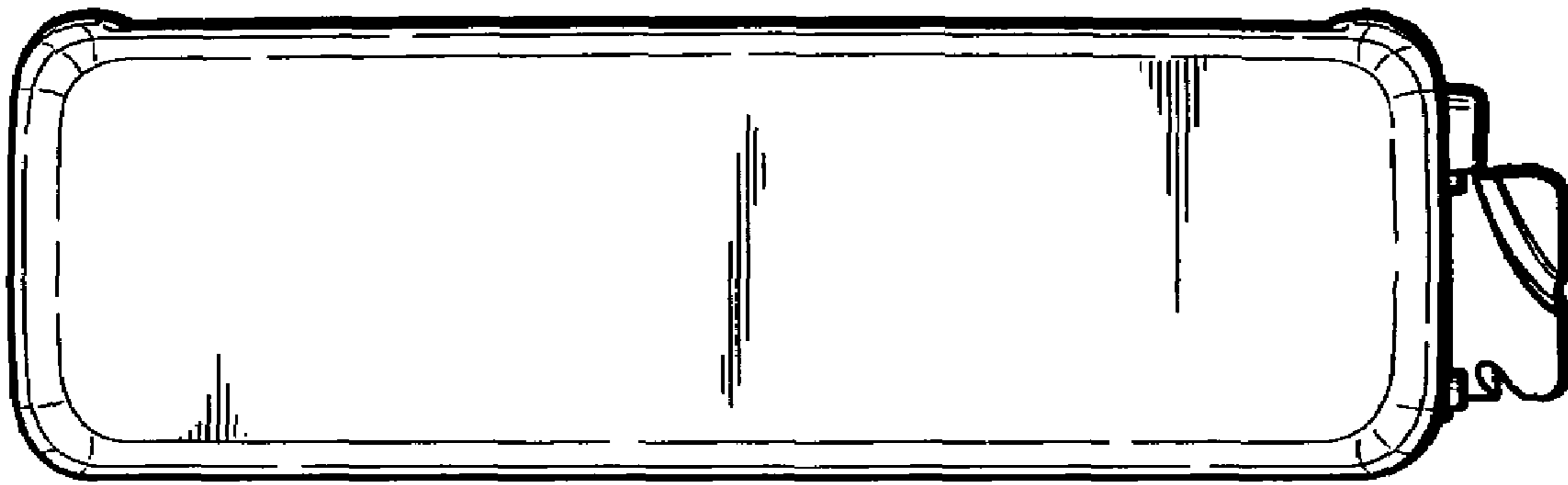

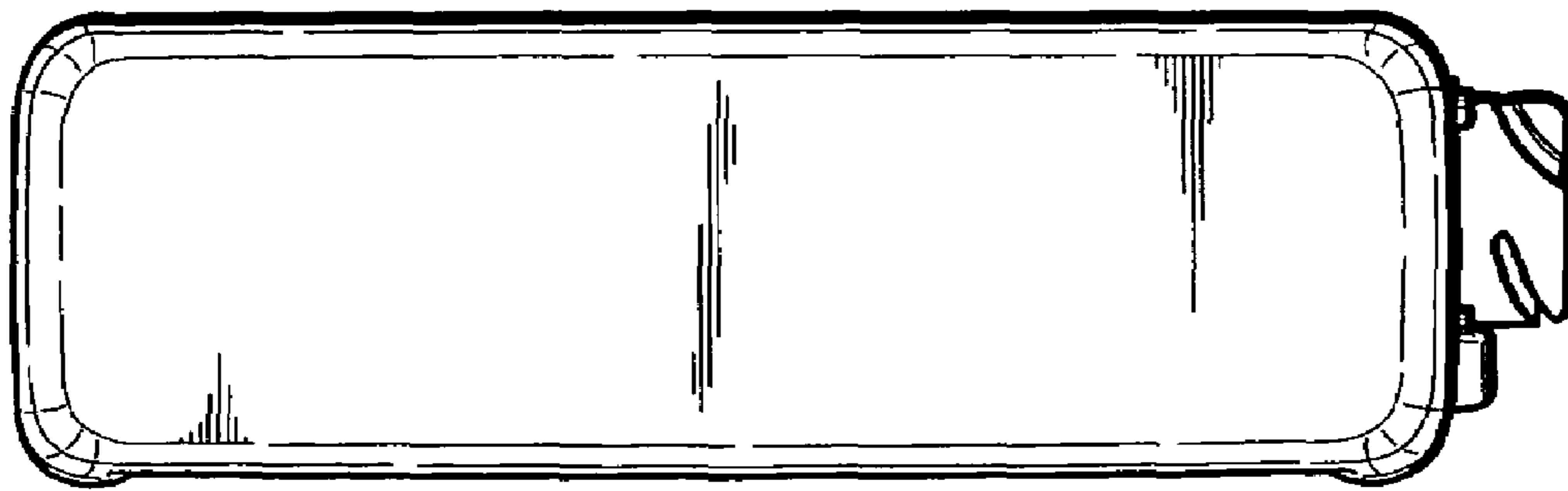

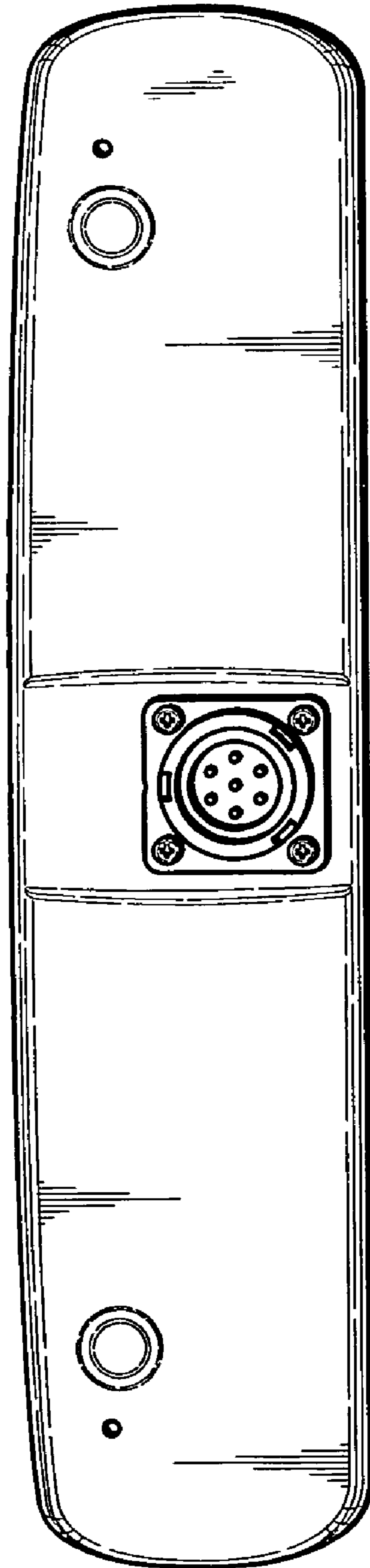

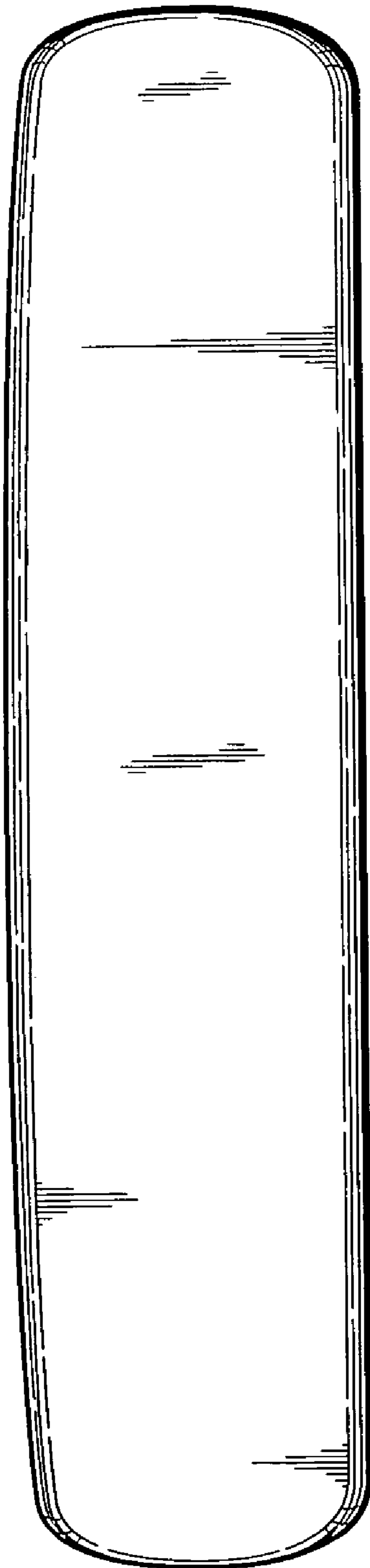

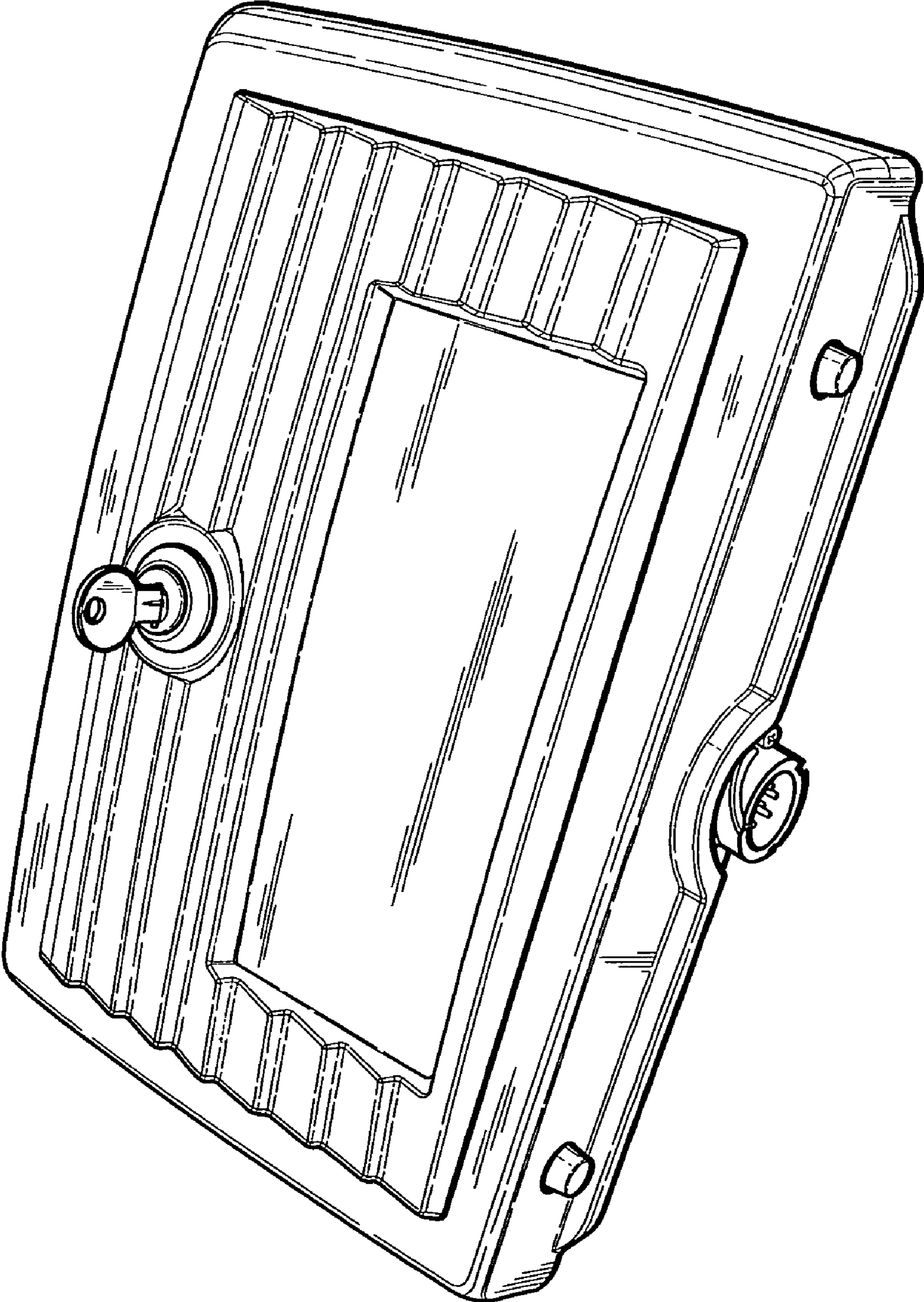

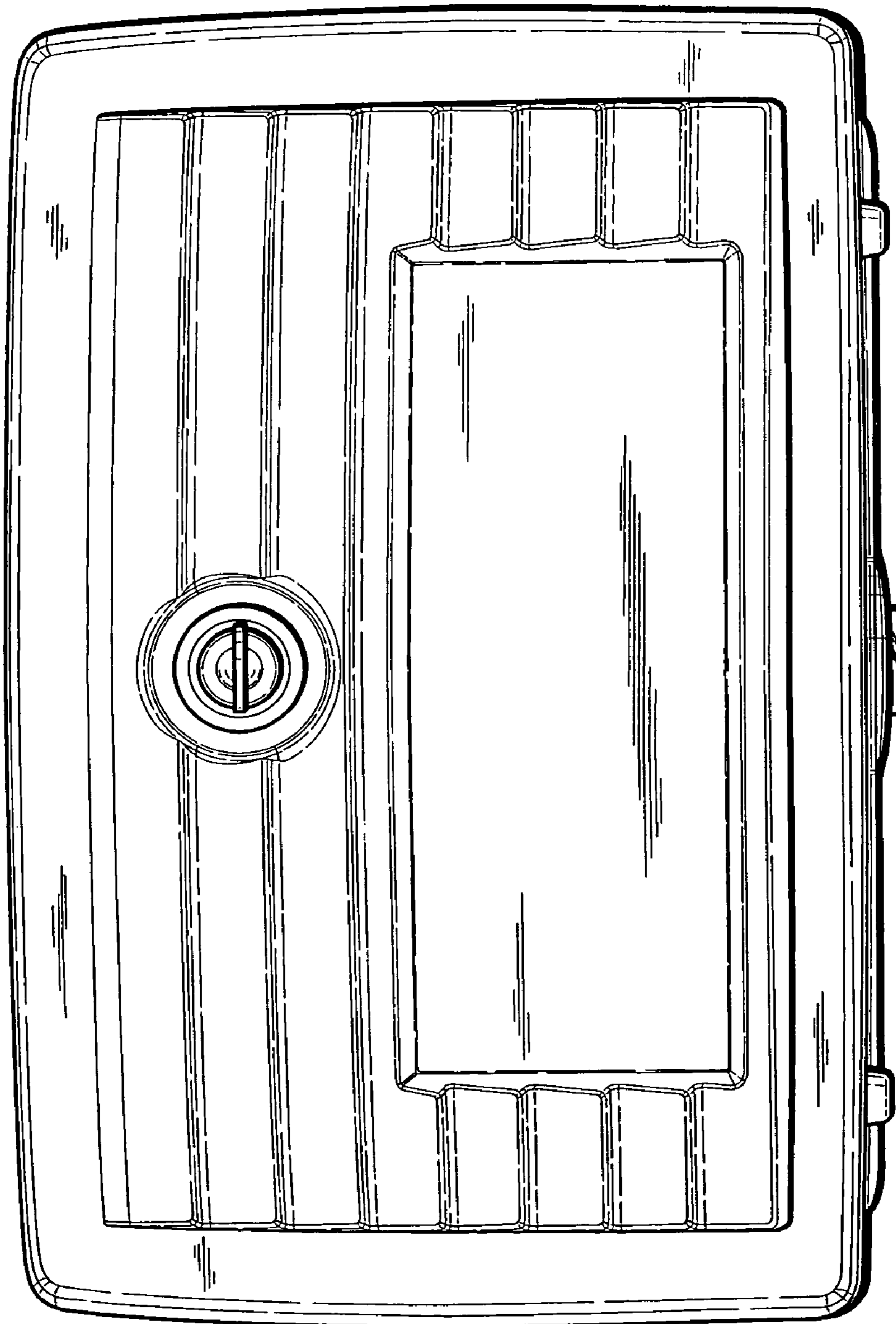

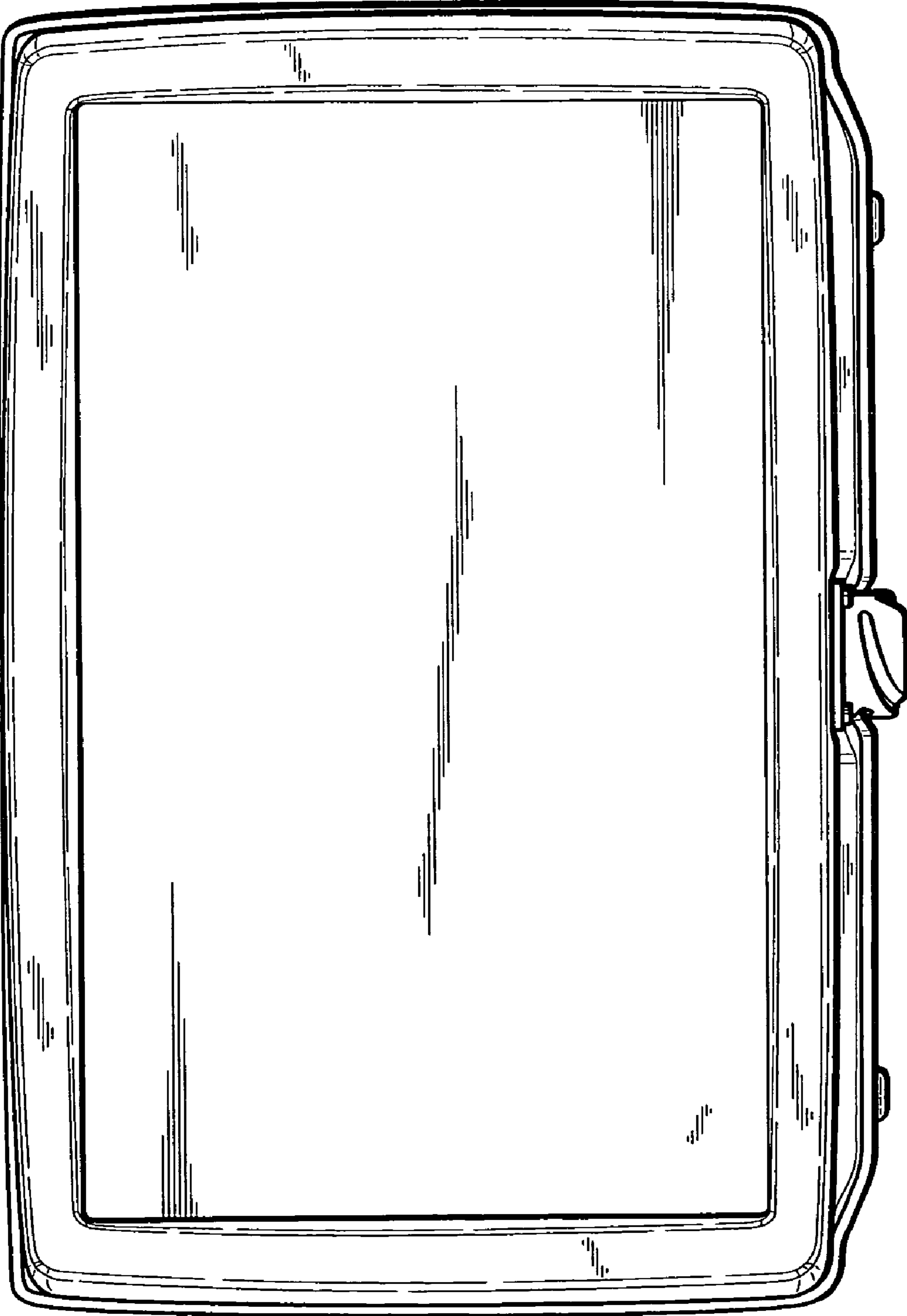

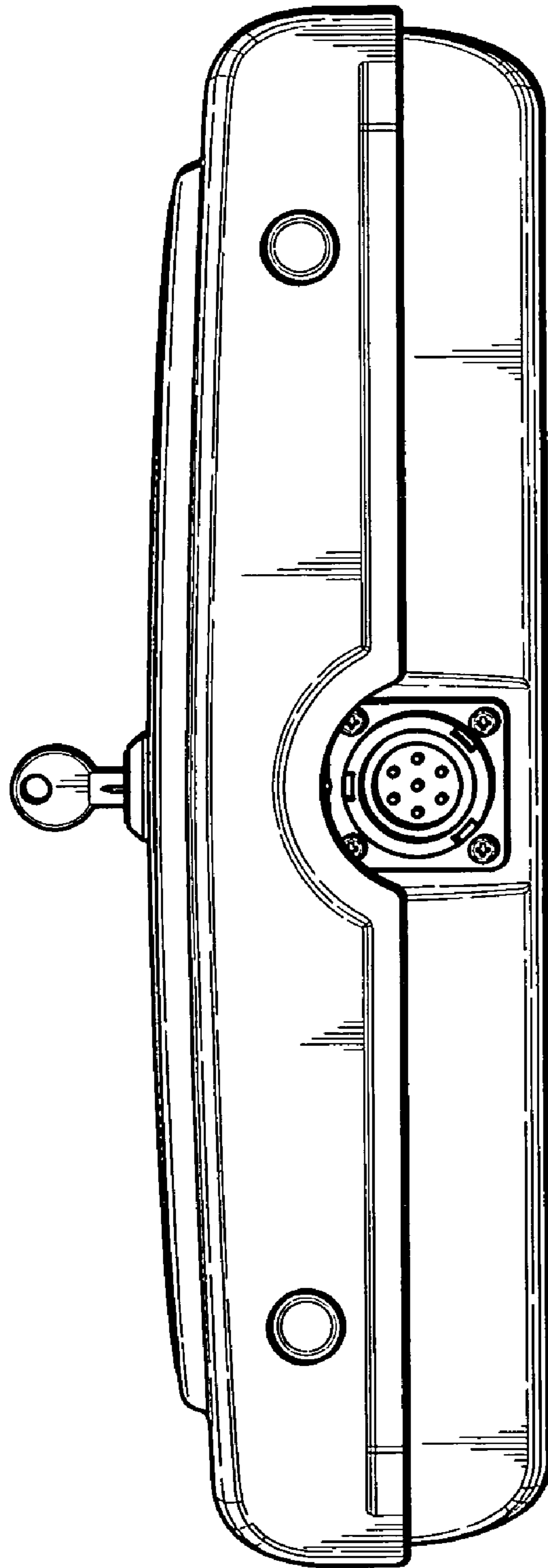

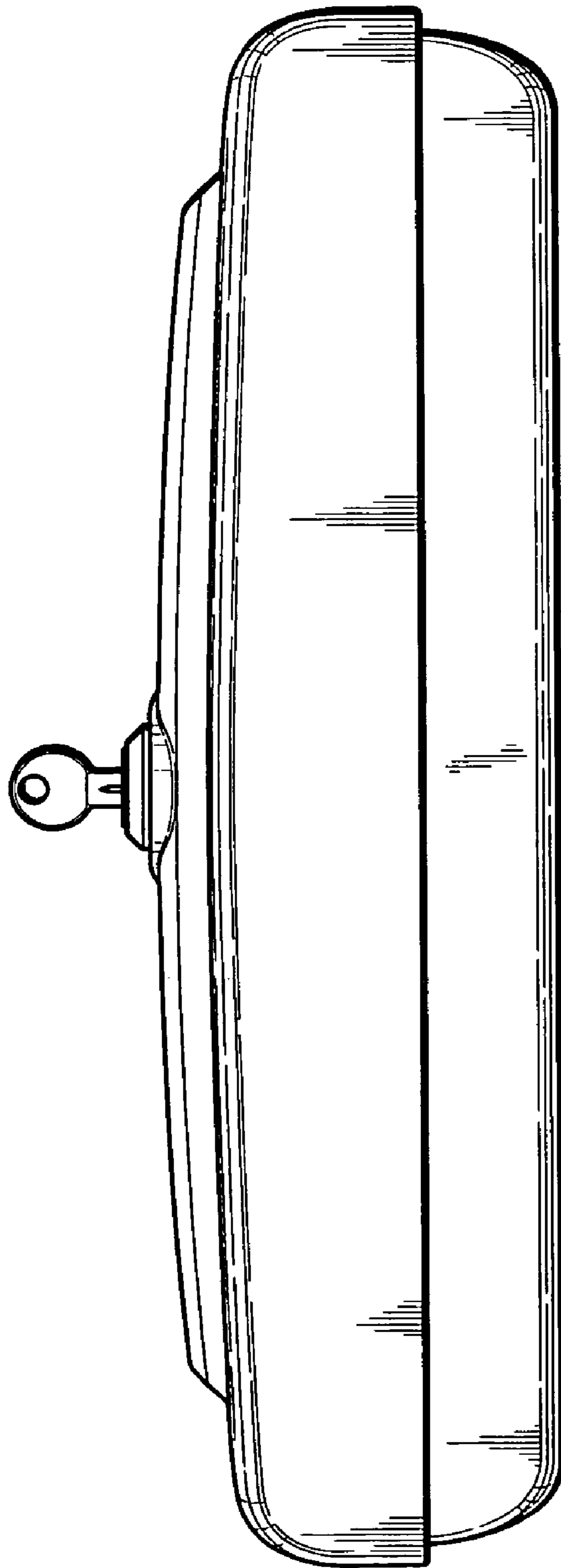

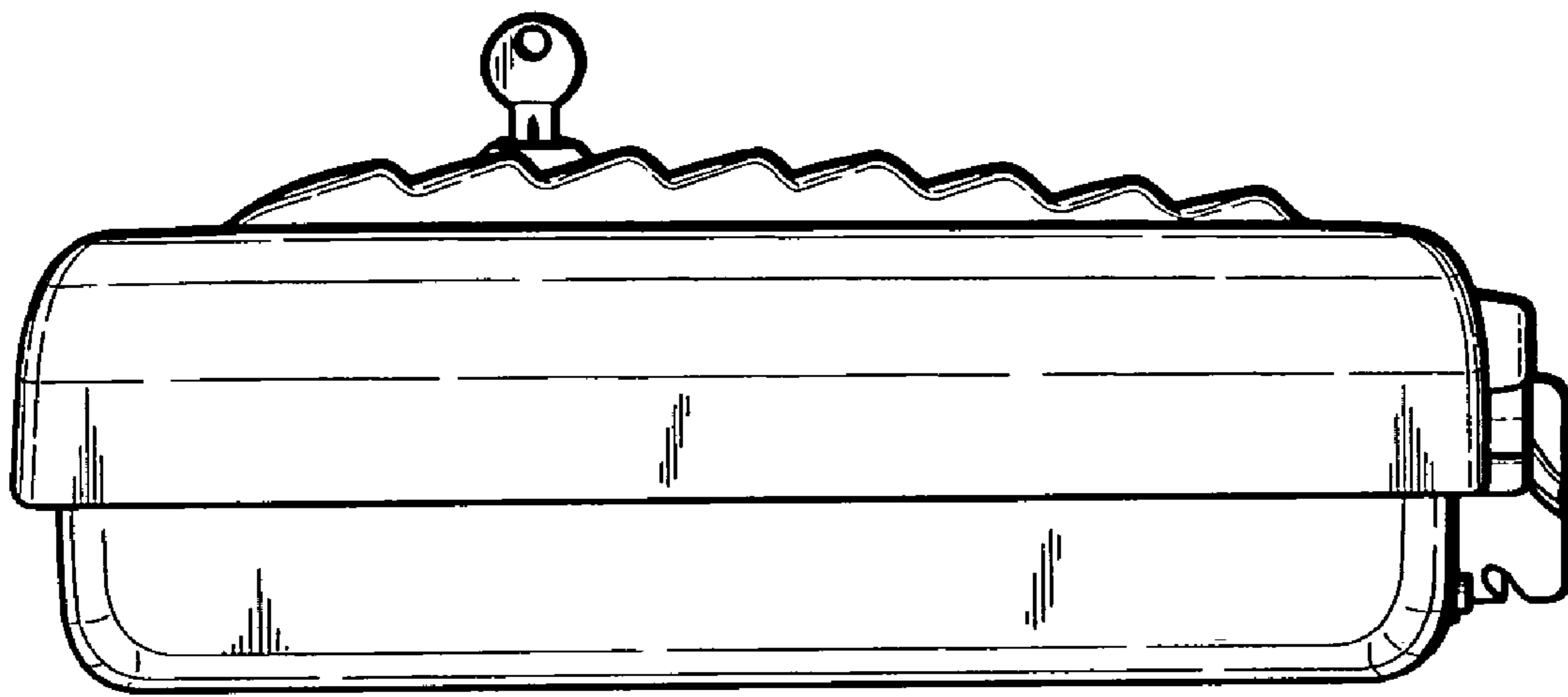

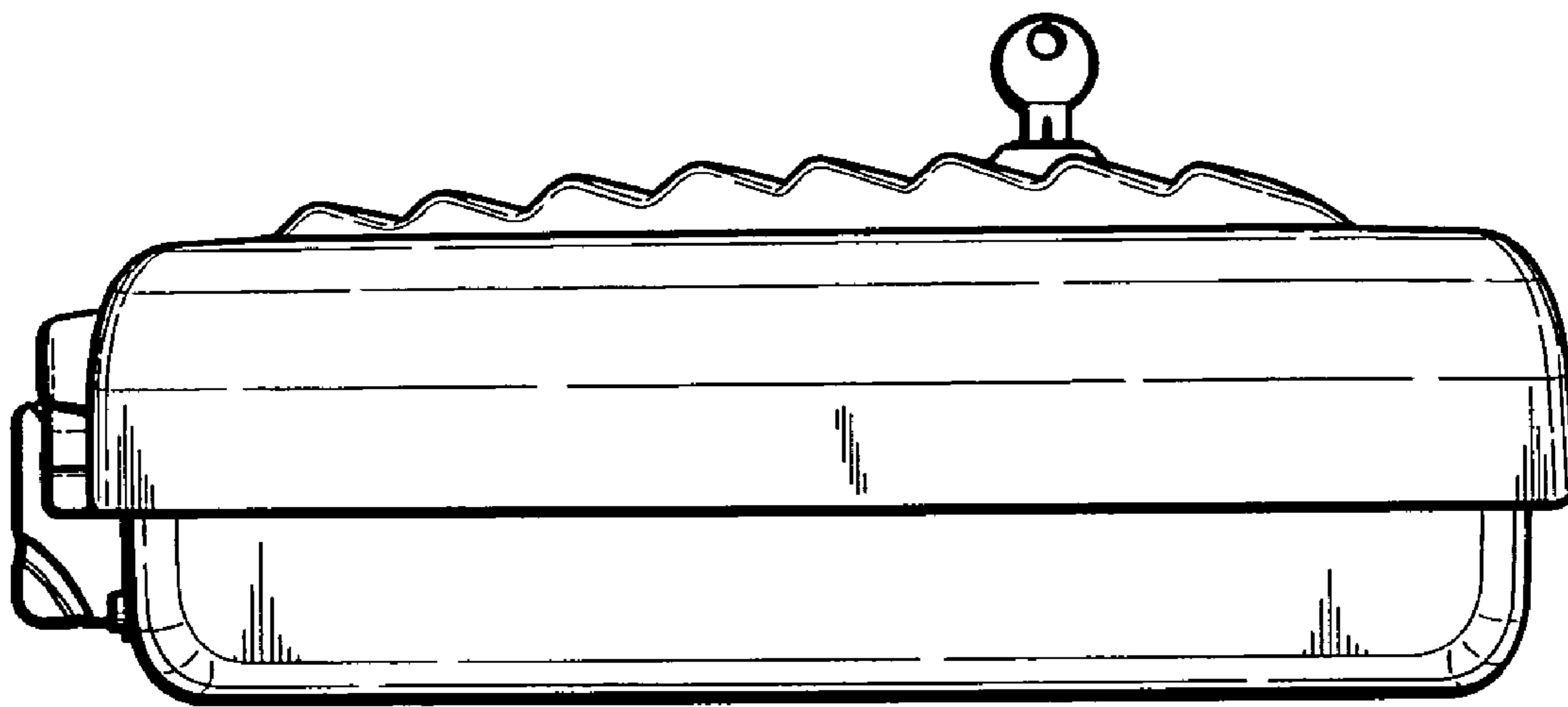
