The ornamental design for an “organizer,” as shown and described.

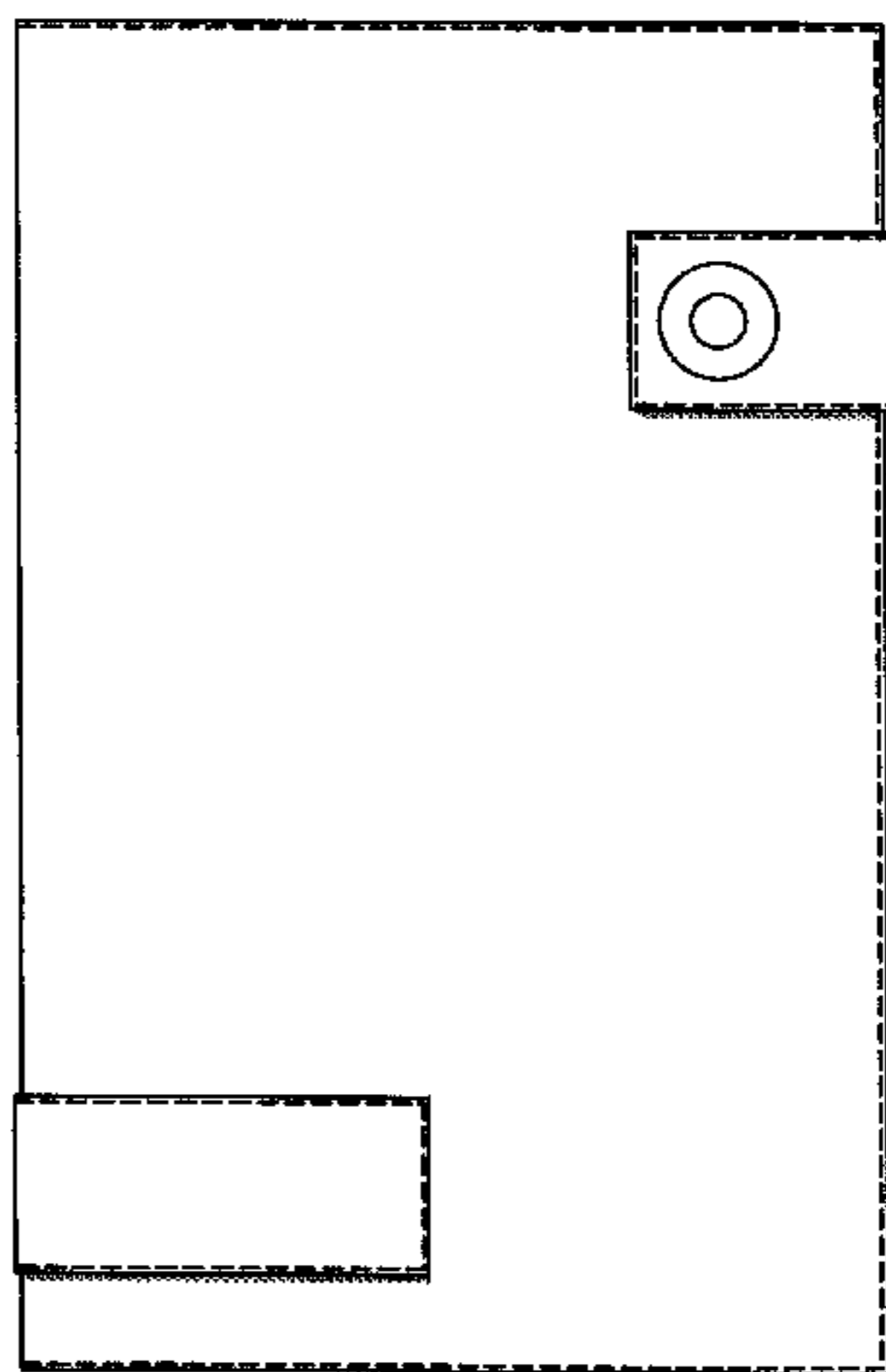
**DESCRIPTION**

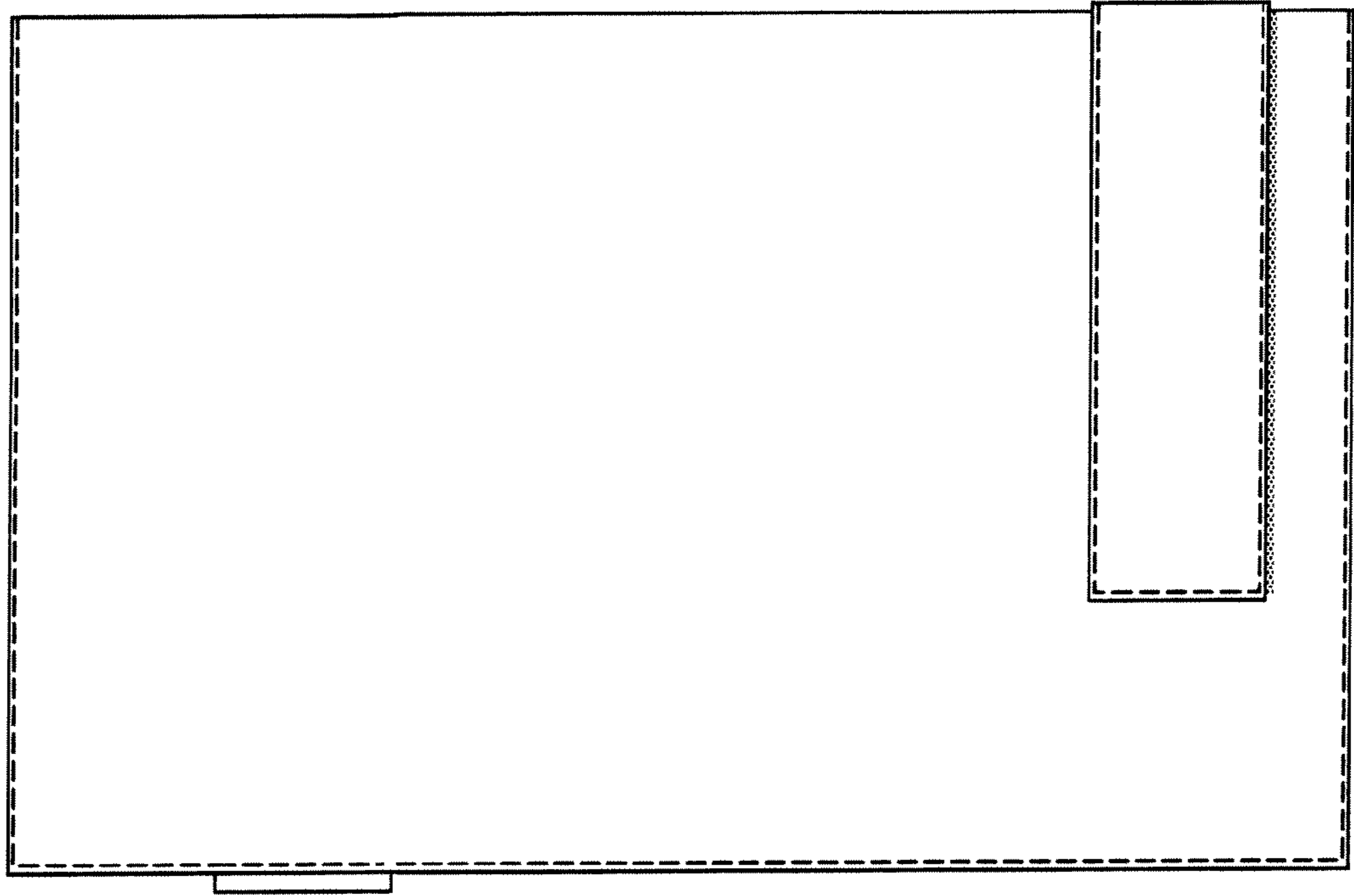

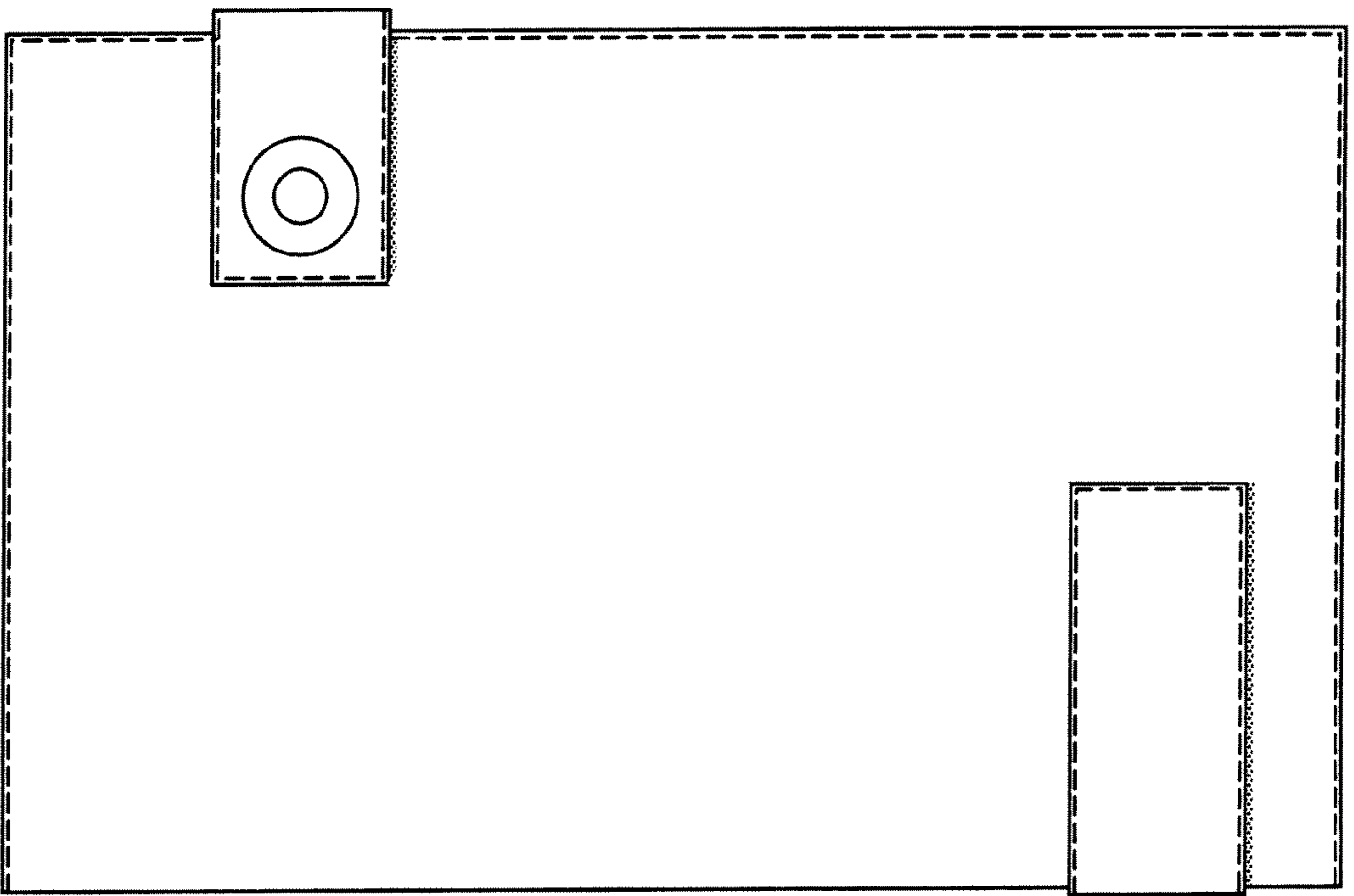
