FIG. 3 is a front view of the absorbent genital shield of the invention;

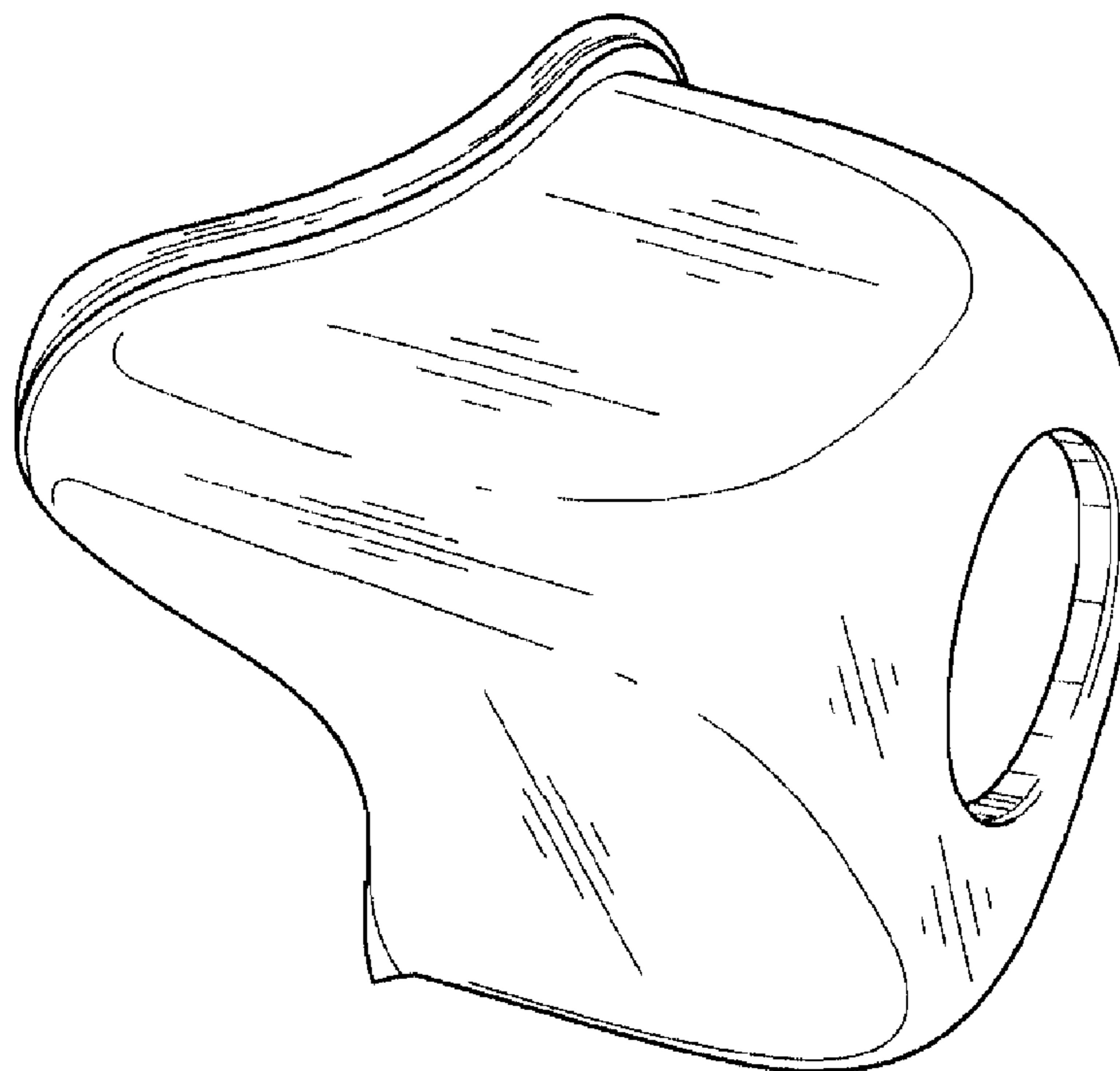
FIG. 4 is a top view of the absorbent genital shield of the invention;

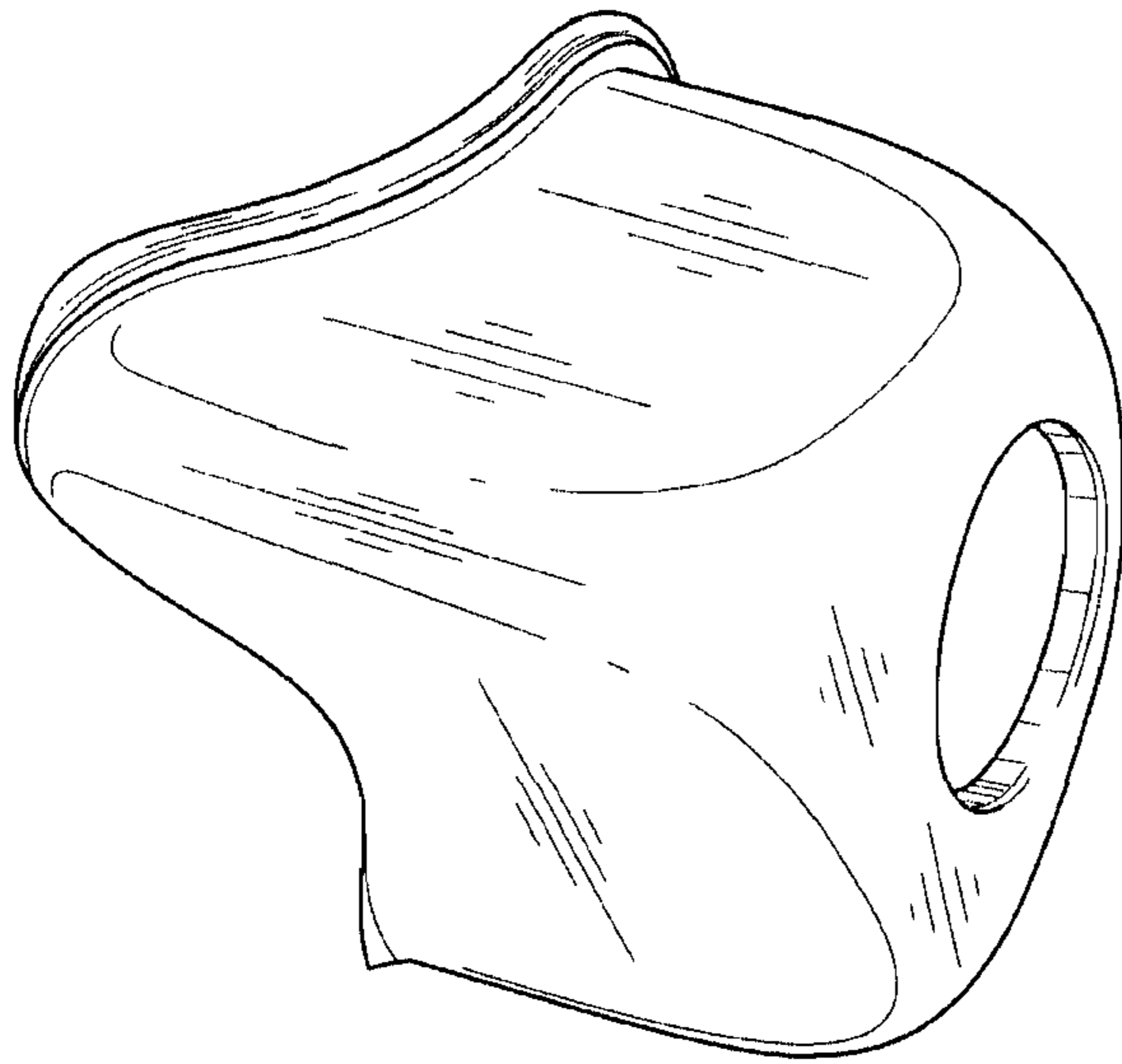

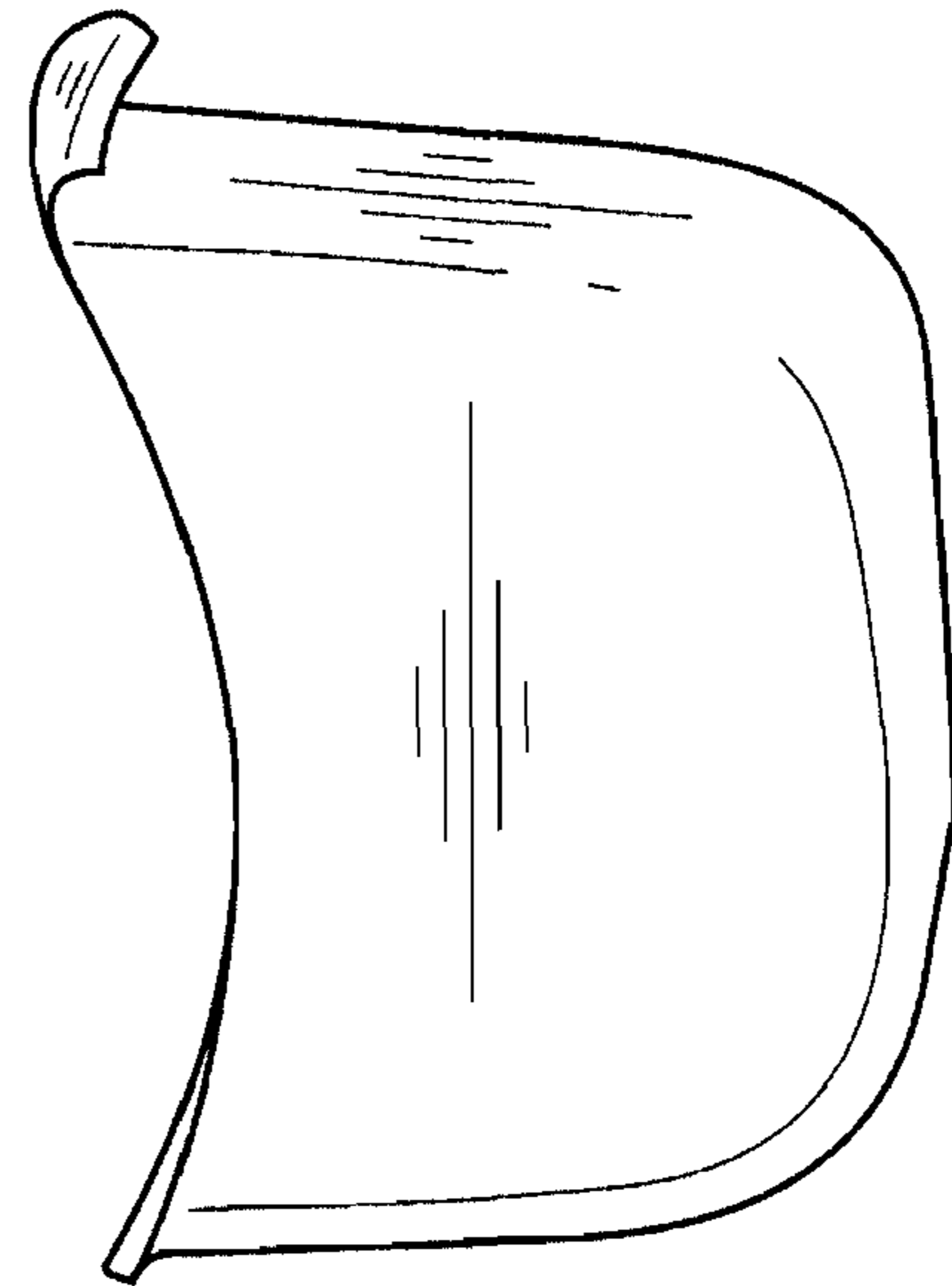

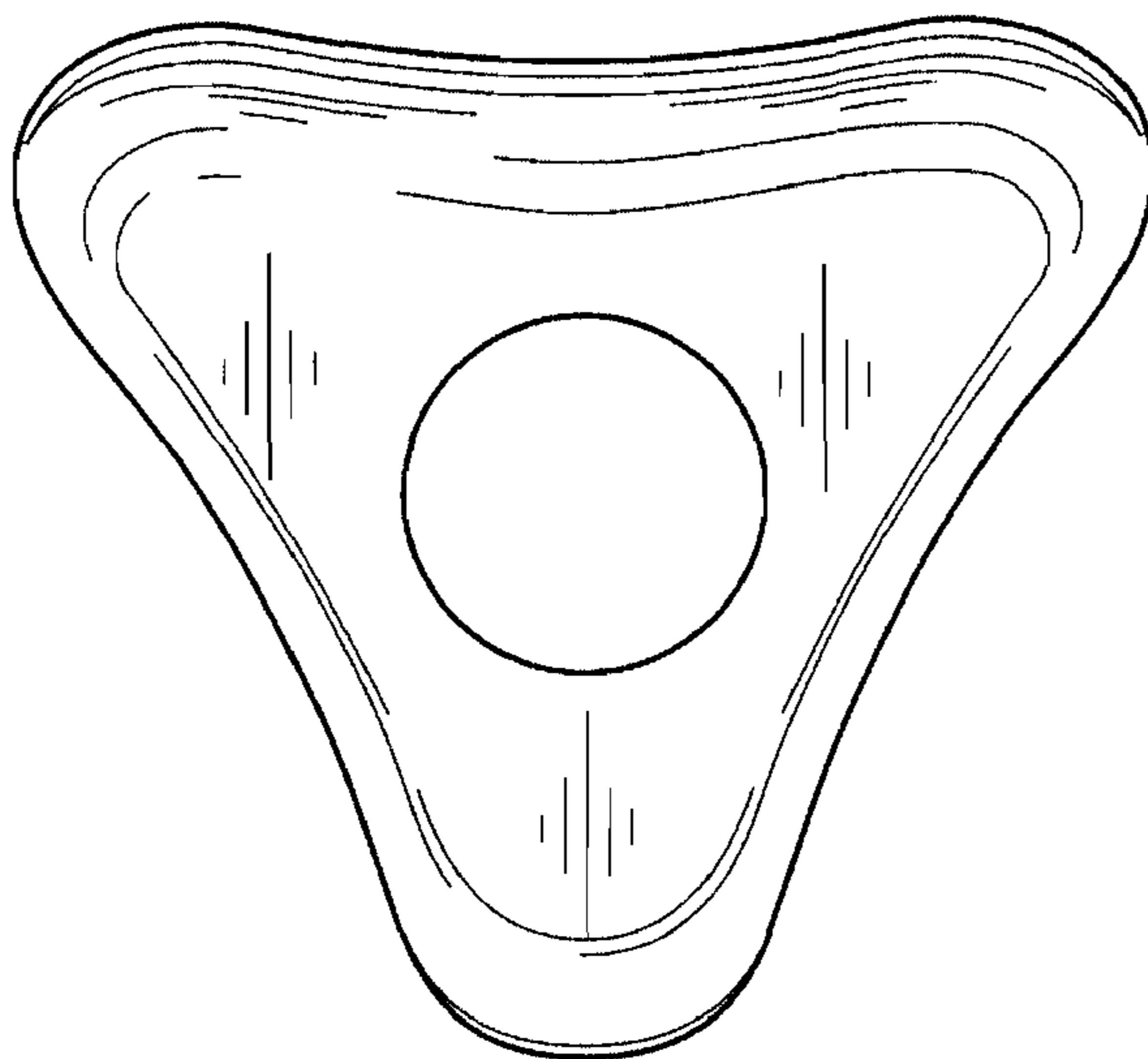

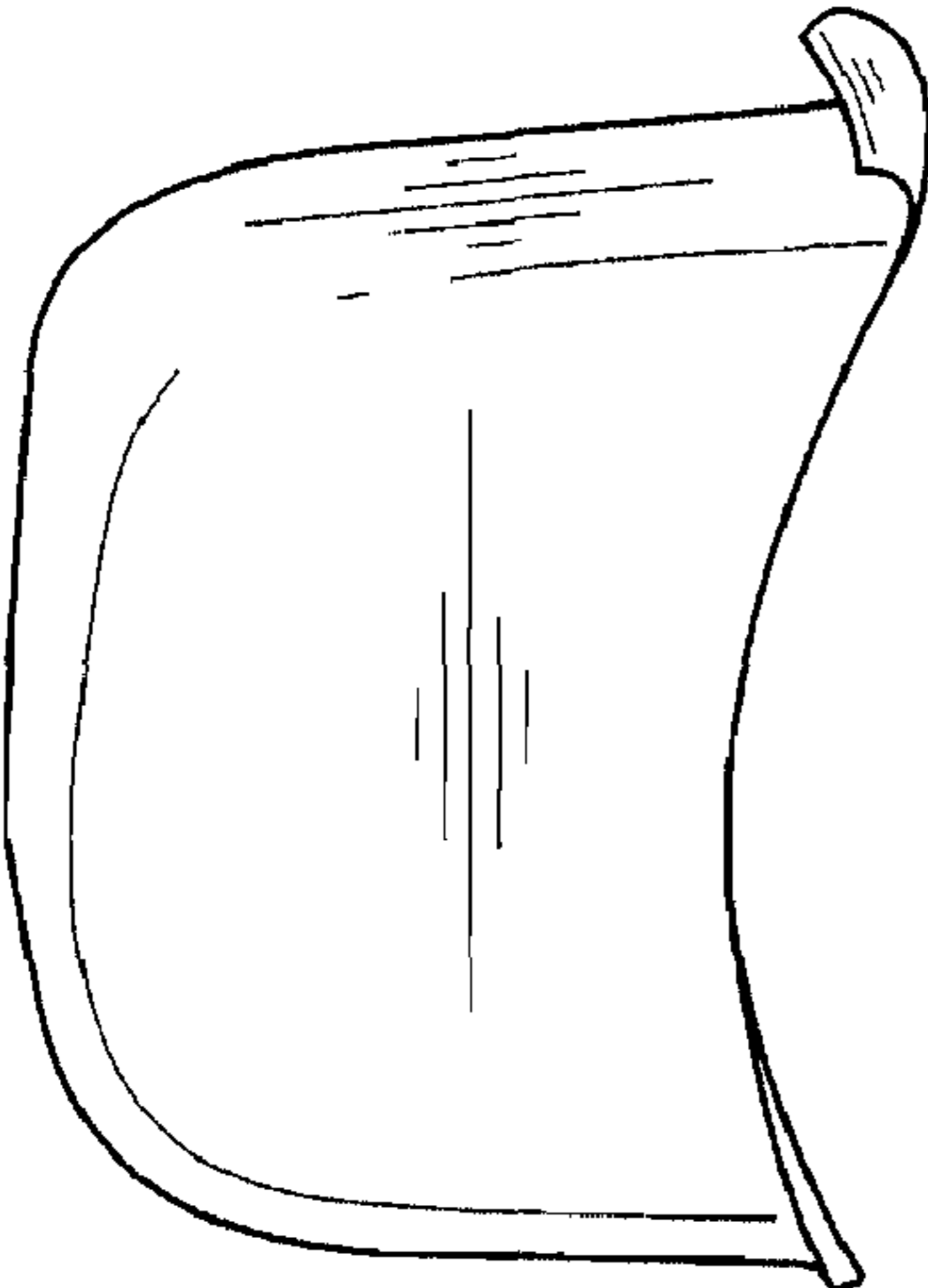
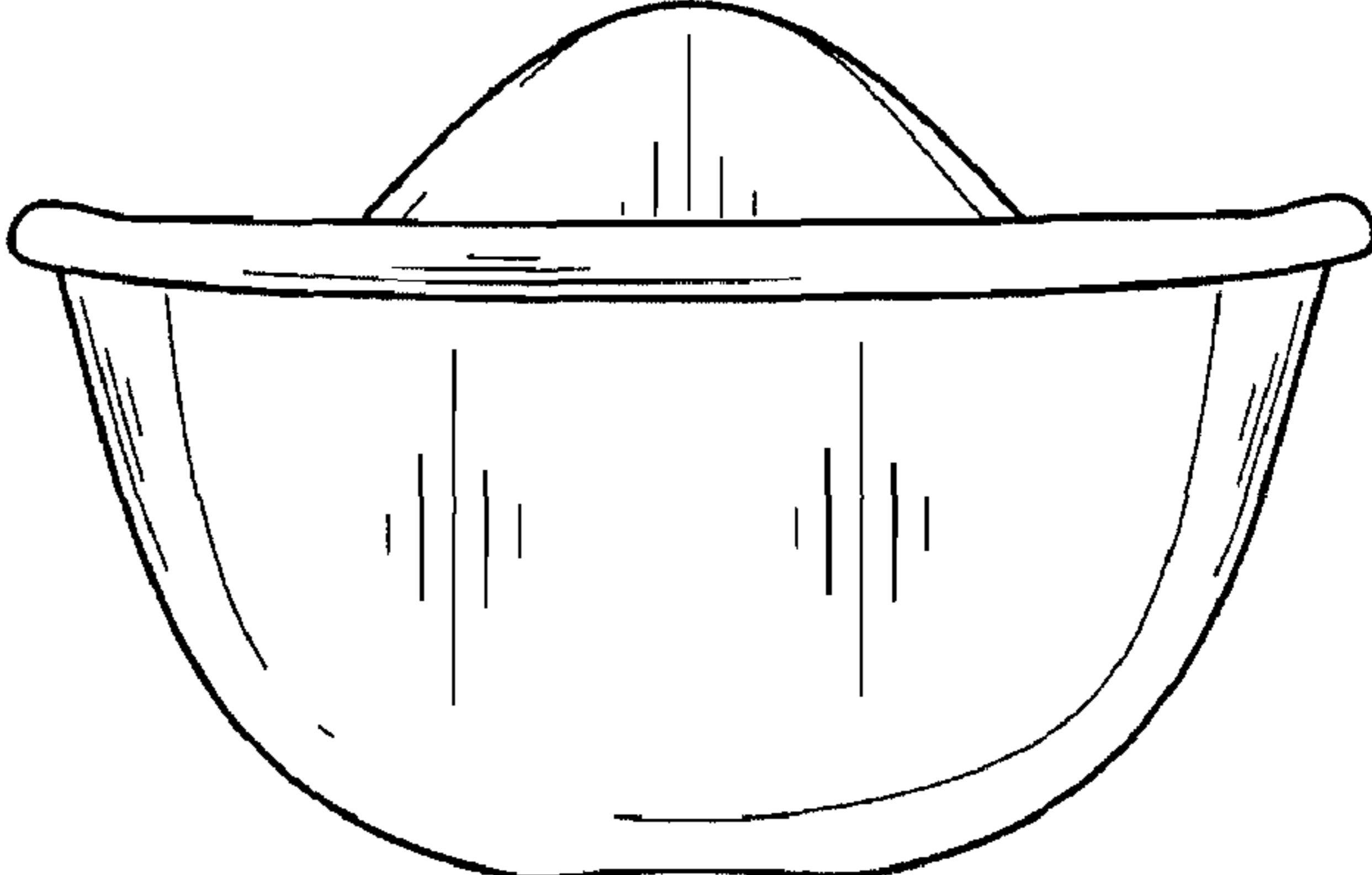

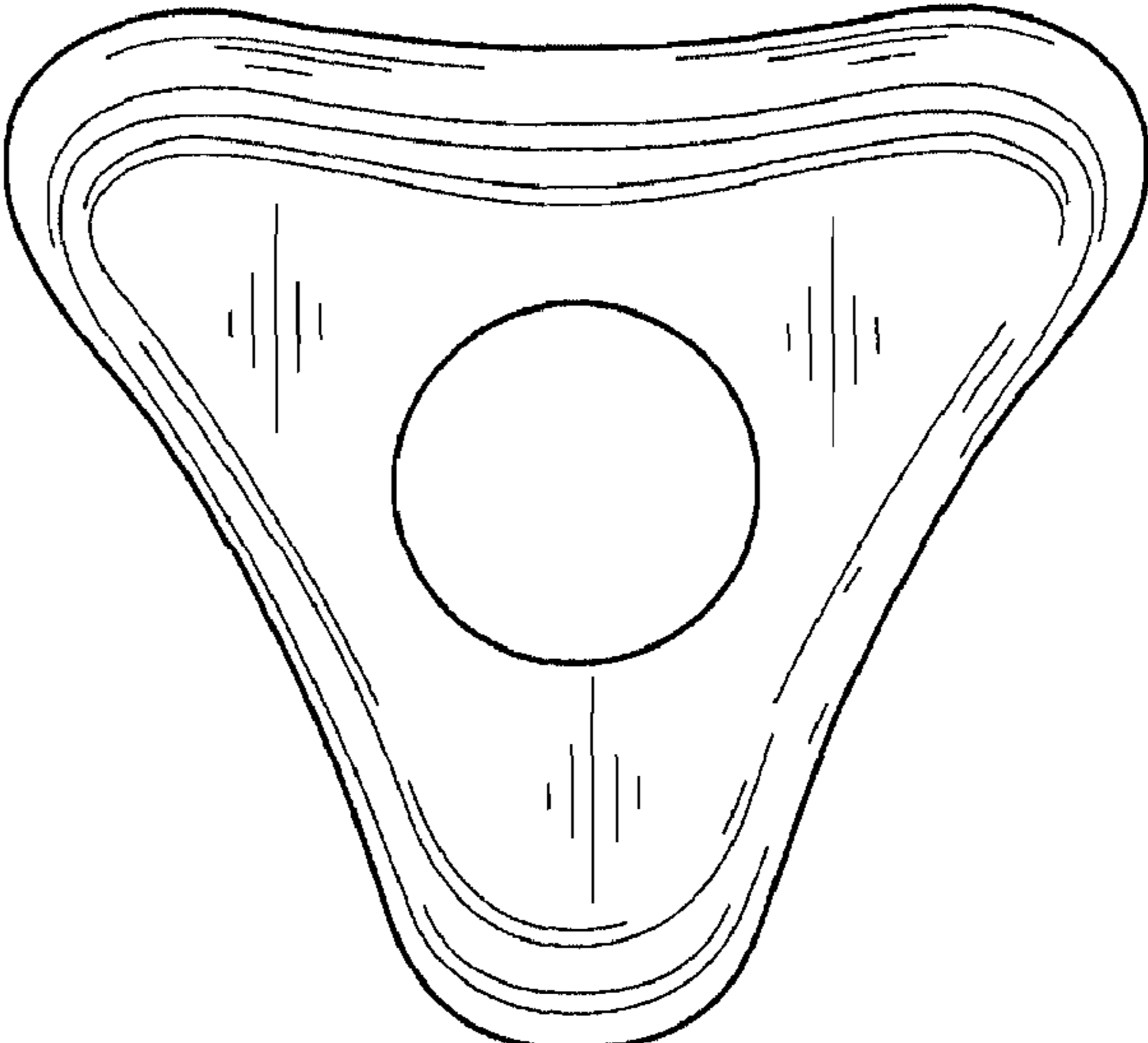
