(57) **CLAIM**

The ornamental design for a control device, as shown and described.

DESCRIPTION

The claimed control device comprises a transmitter and a receiver and is used for controlling the operation of massaging device.

FIG. 1 is a front elevational view of a control device showing my new design whereas a transmitter is on the left side and a receiver is on the right side;

FIG. 2 is a rear elevational view of the receiver of the control device as shown in FIG. 1 shown separately for completeness of illustration;

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 10 is a left side view thereof;

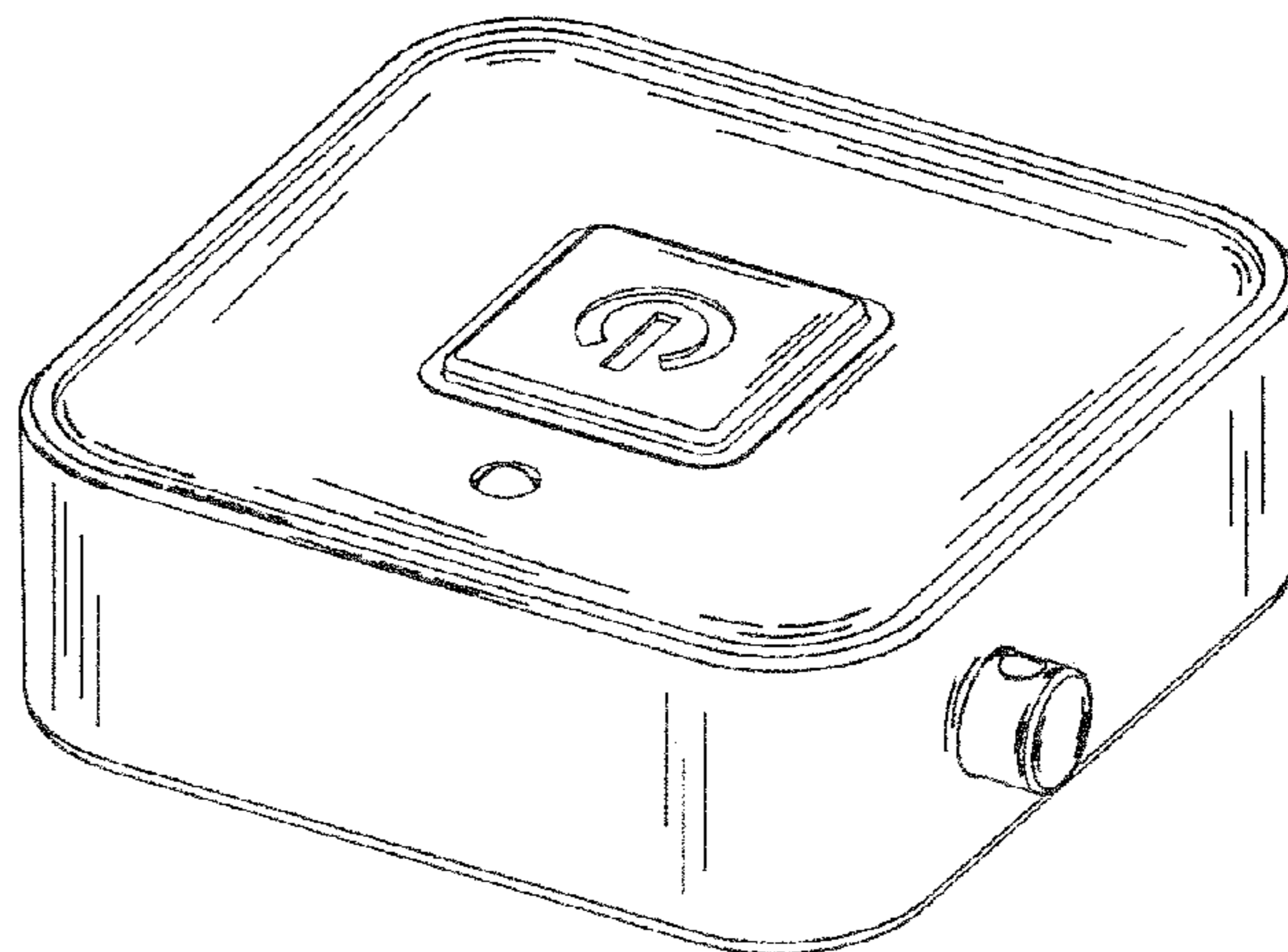
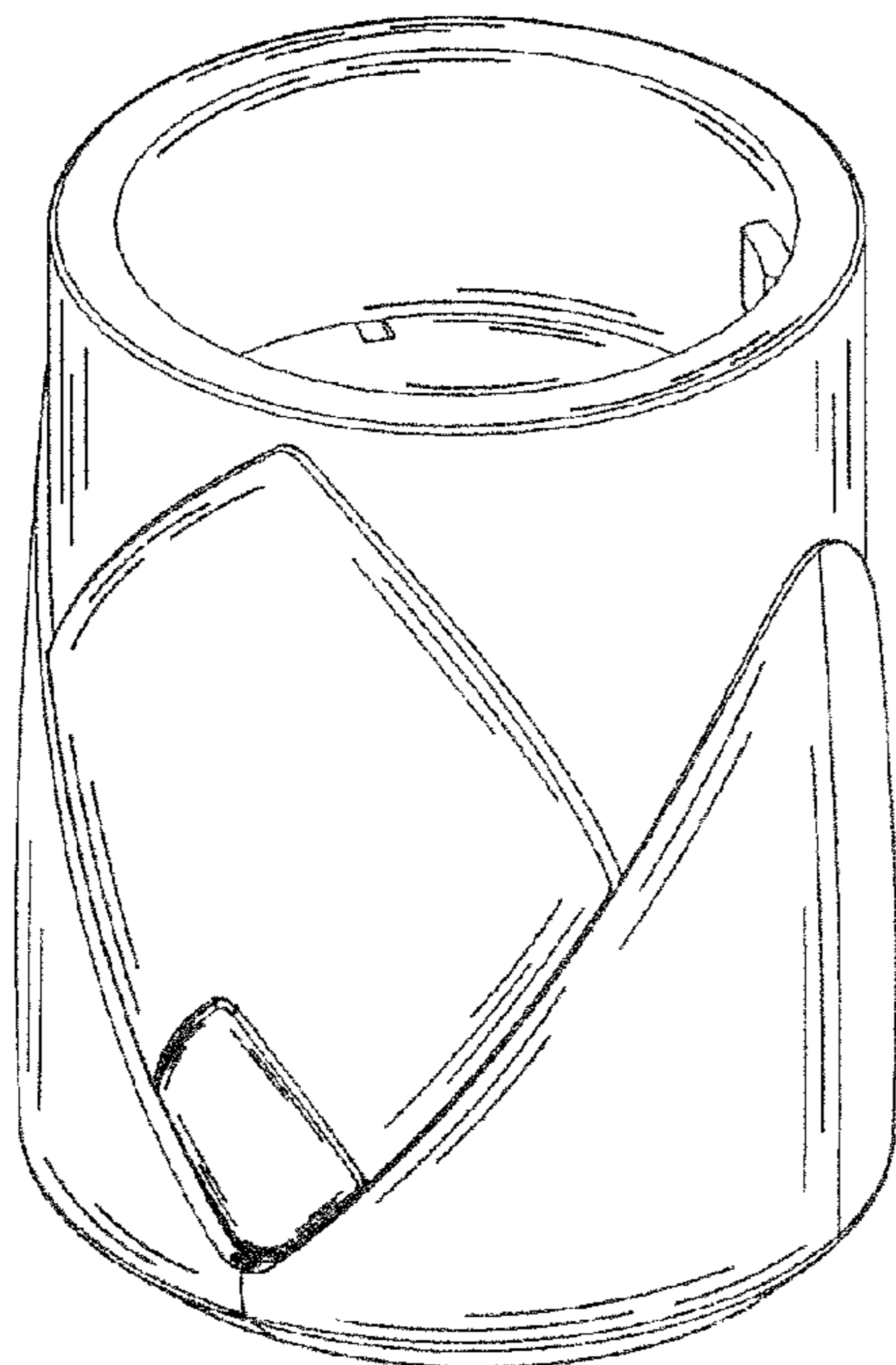
FIG. 11 is a top plan view thereof;

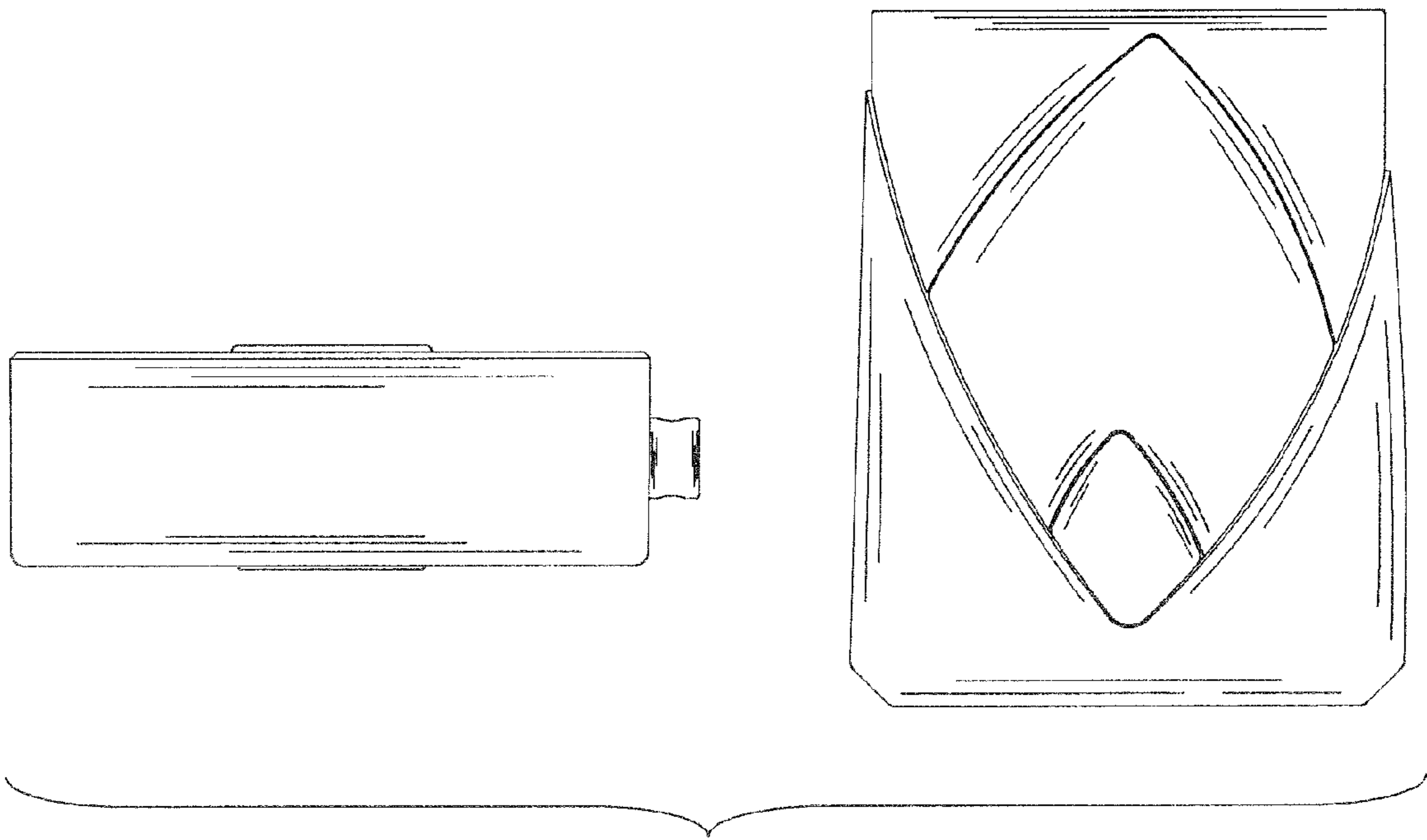

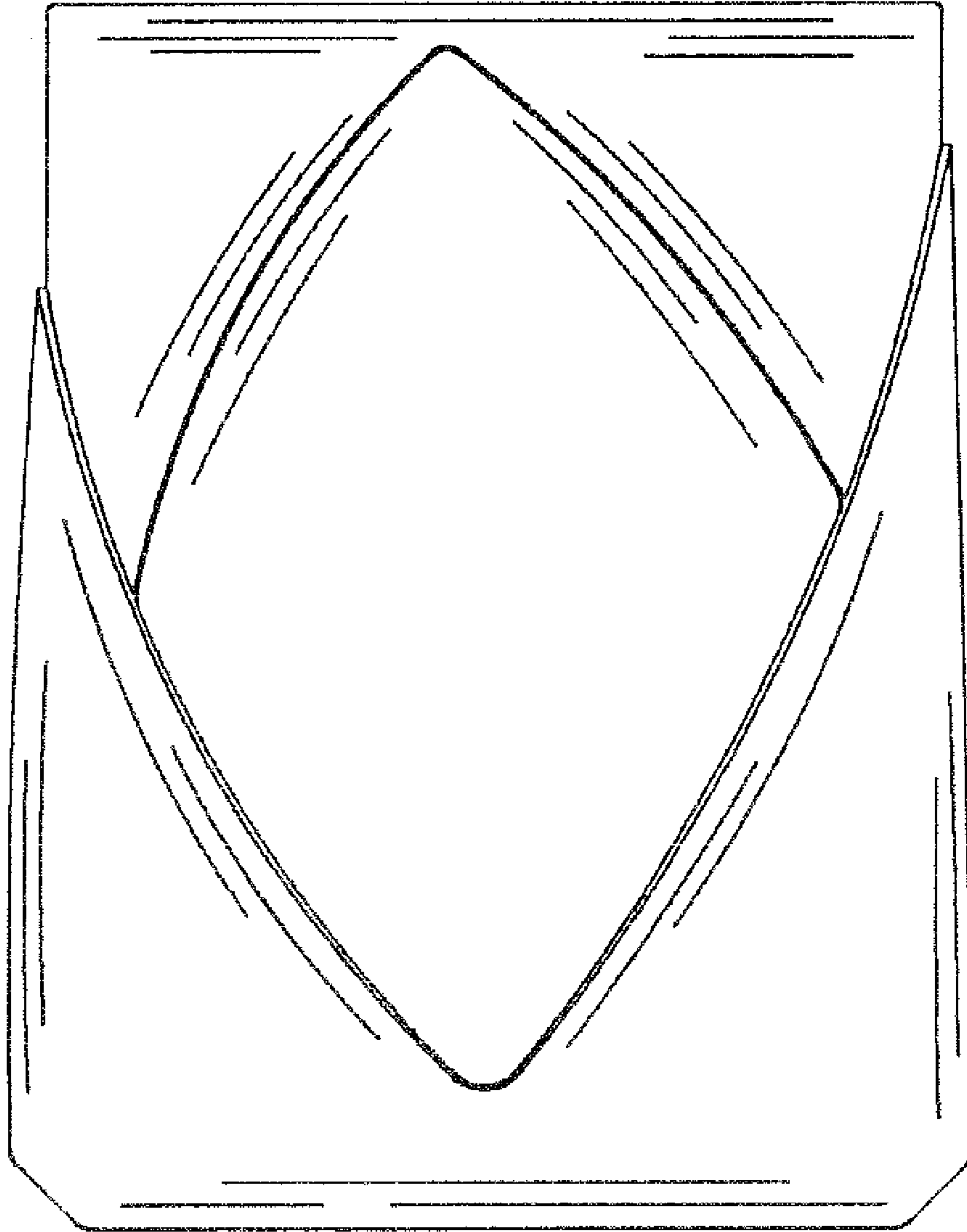

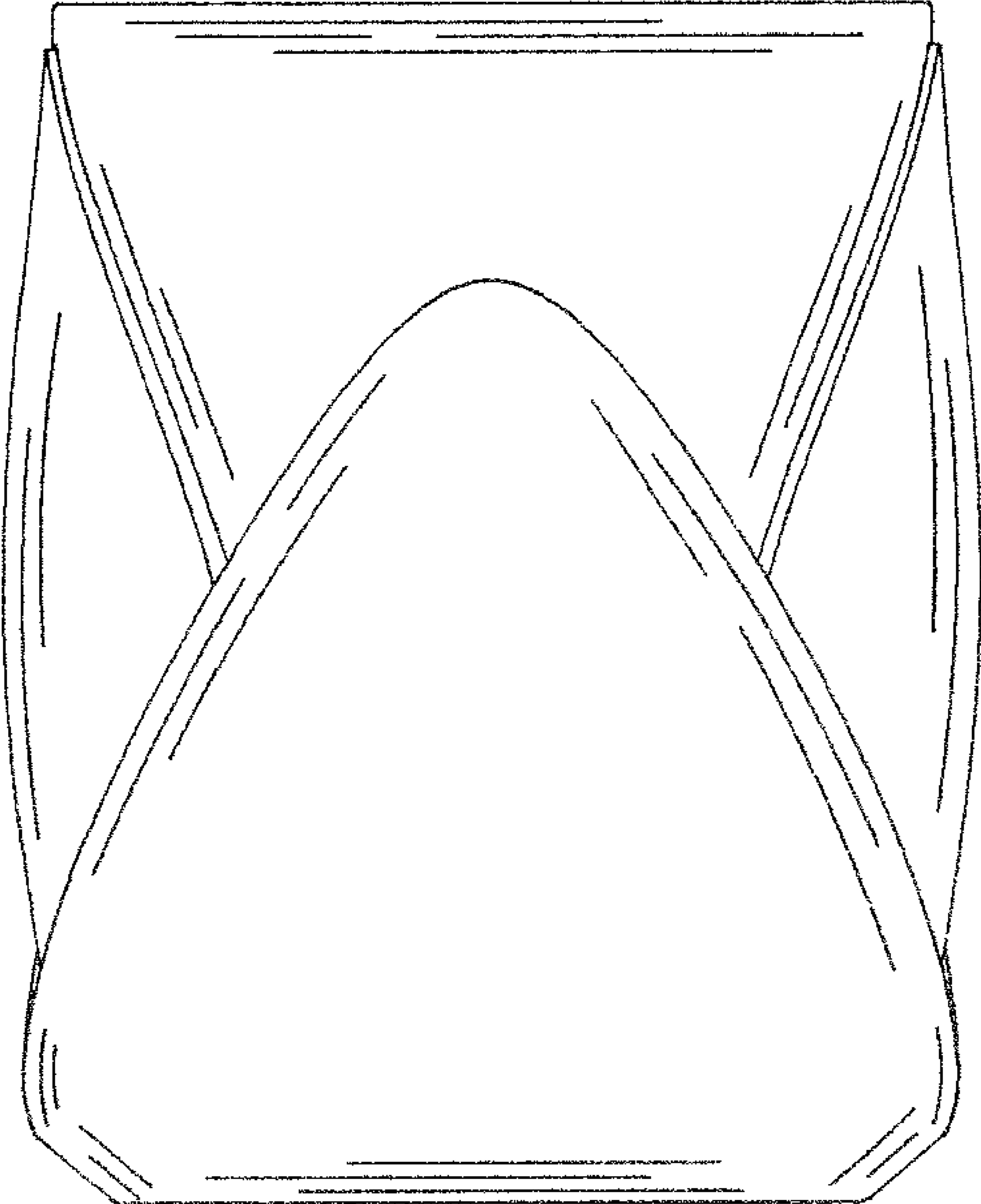

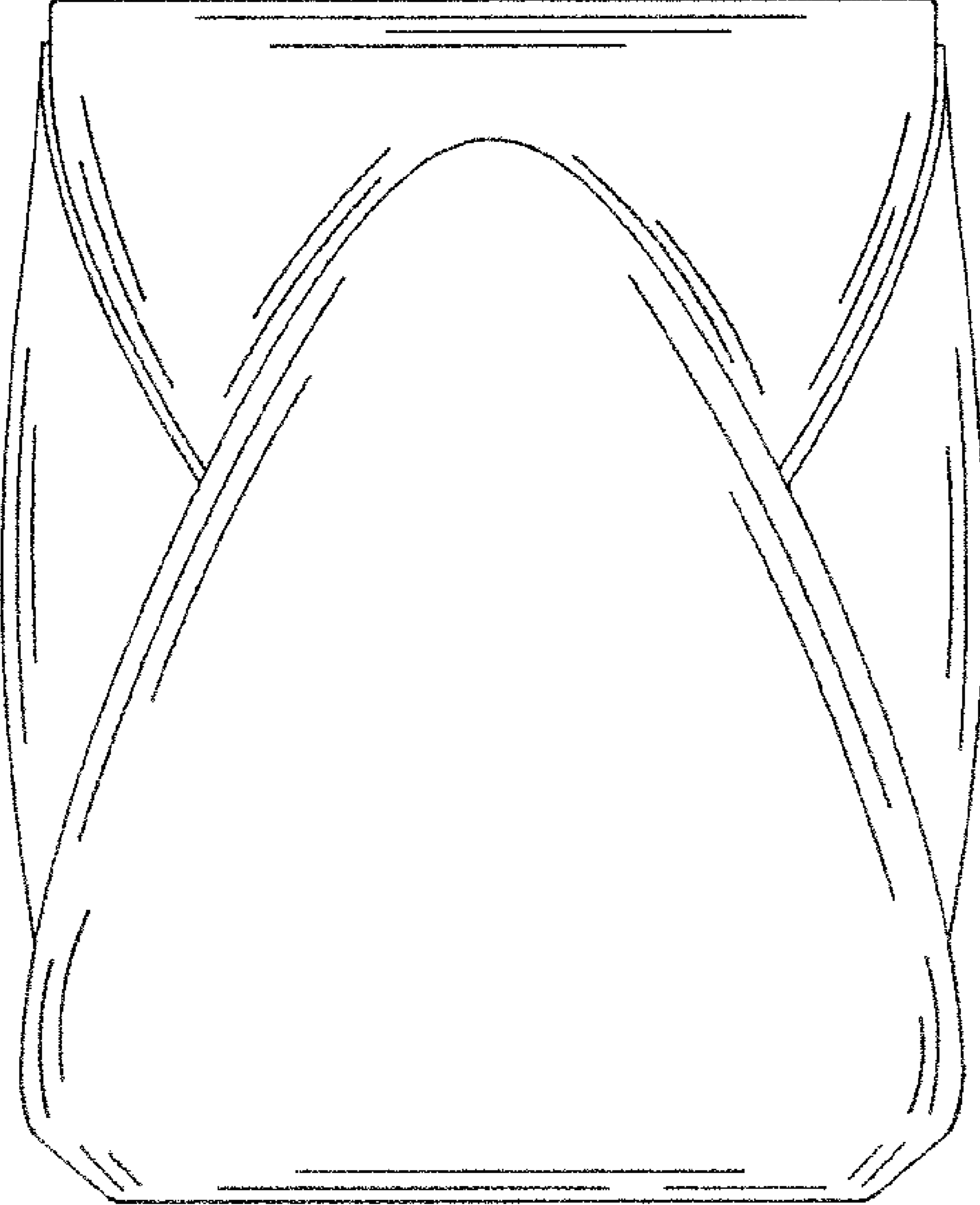

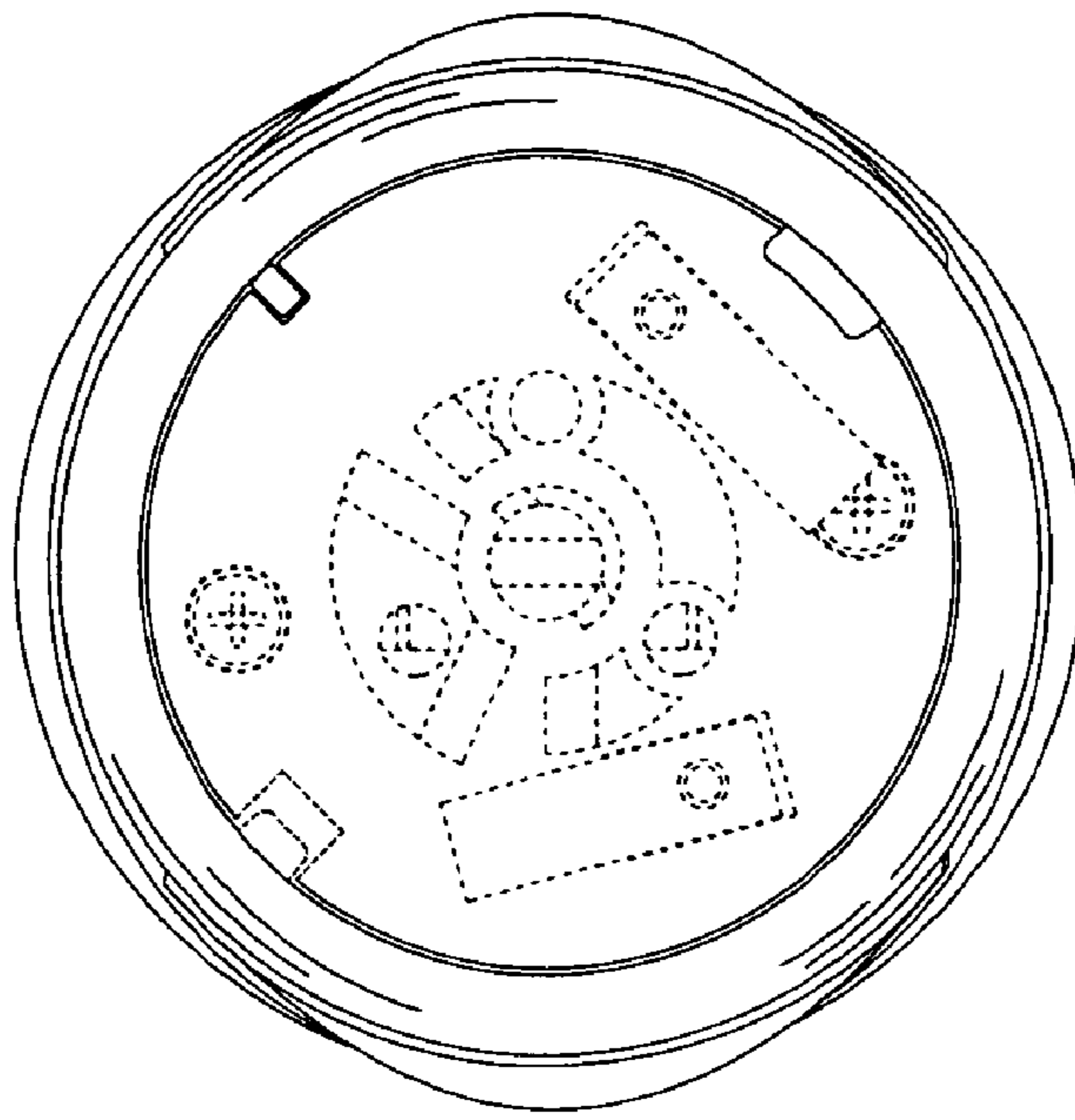

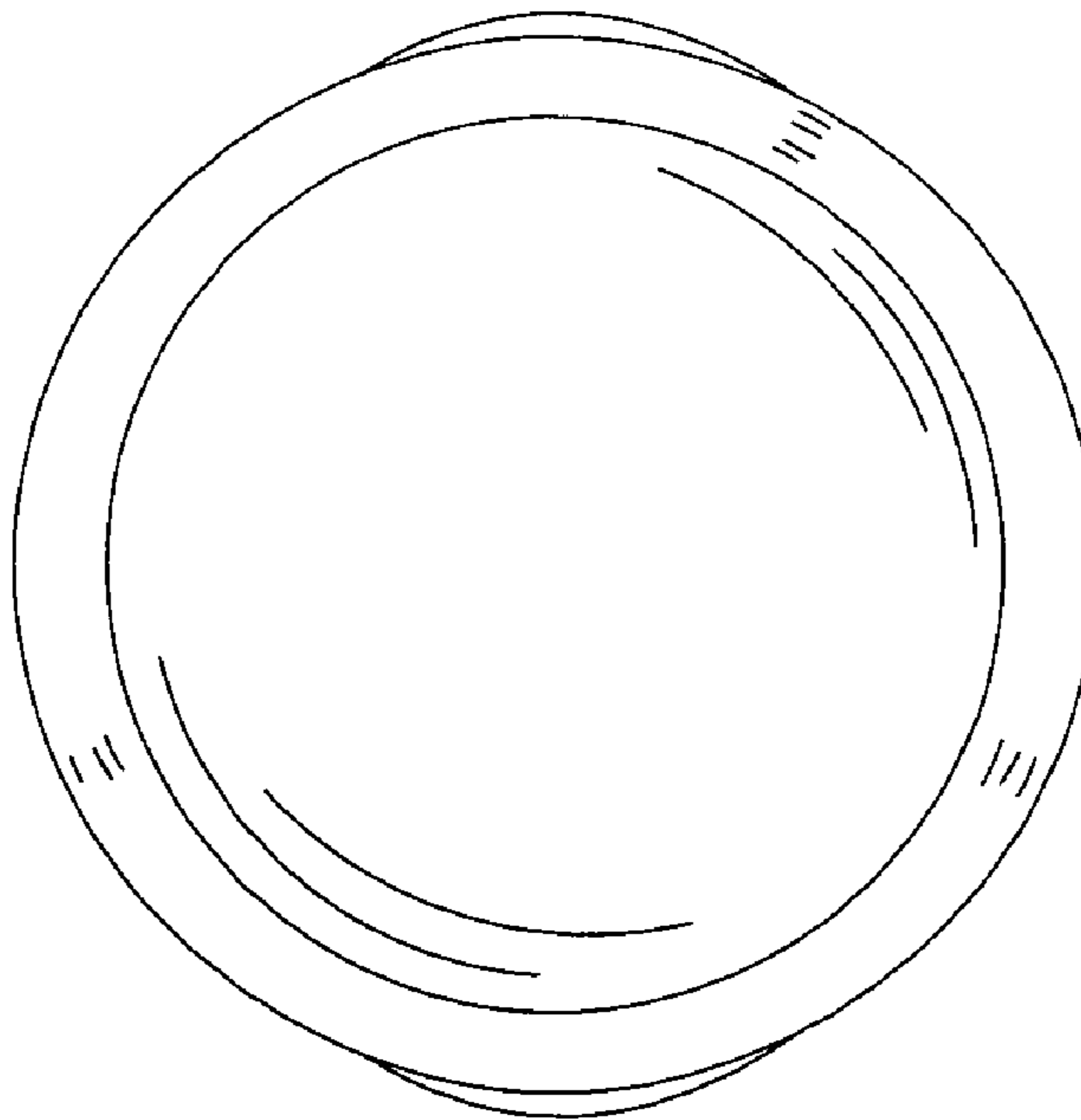

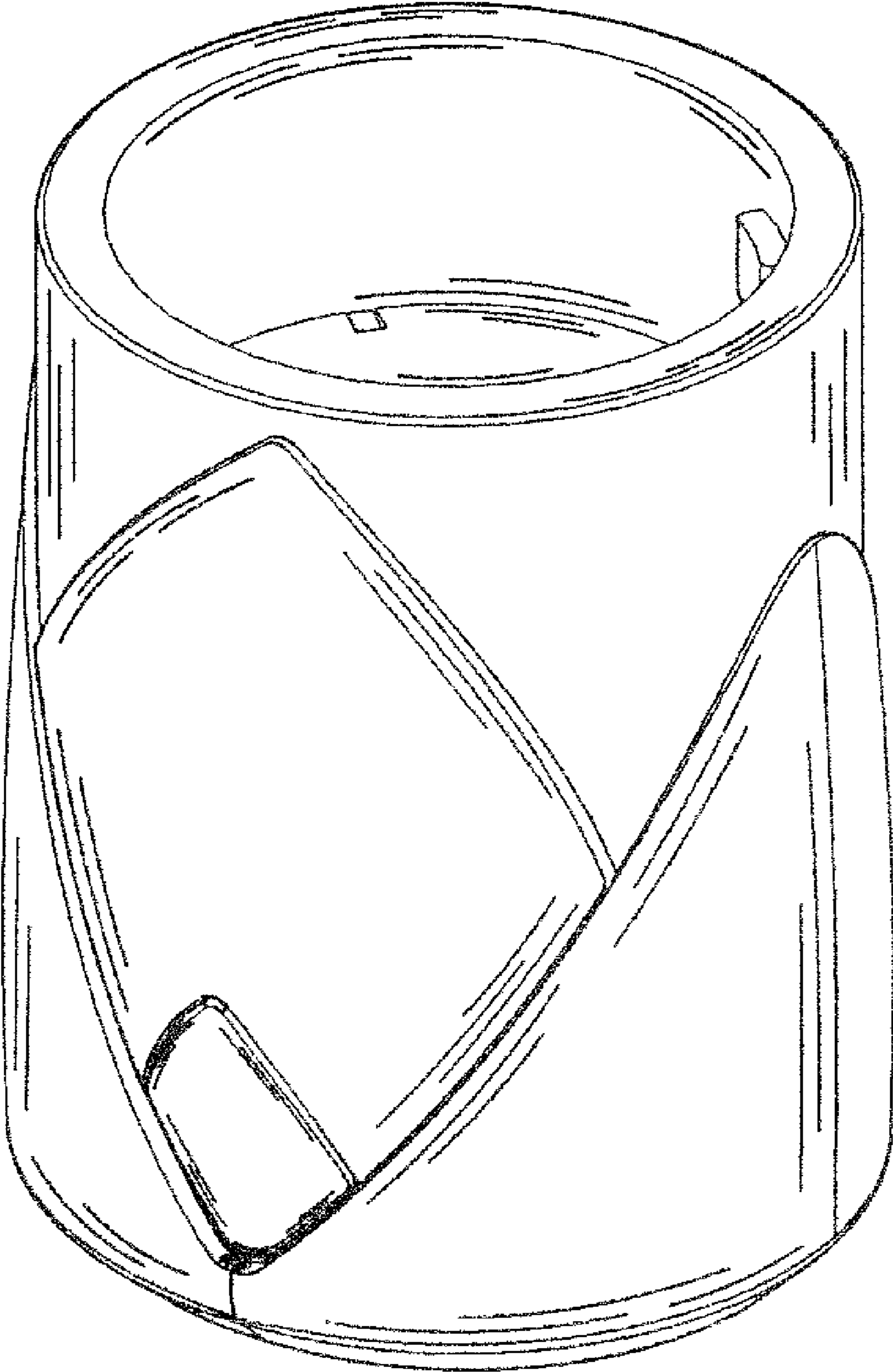

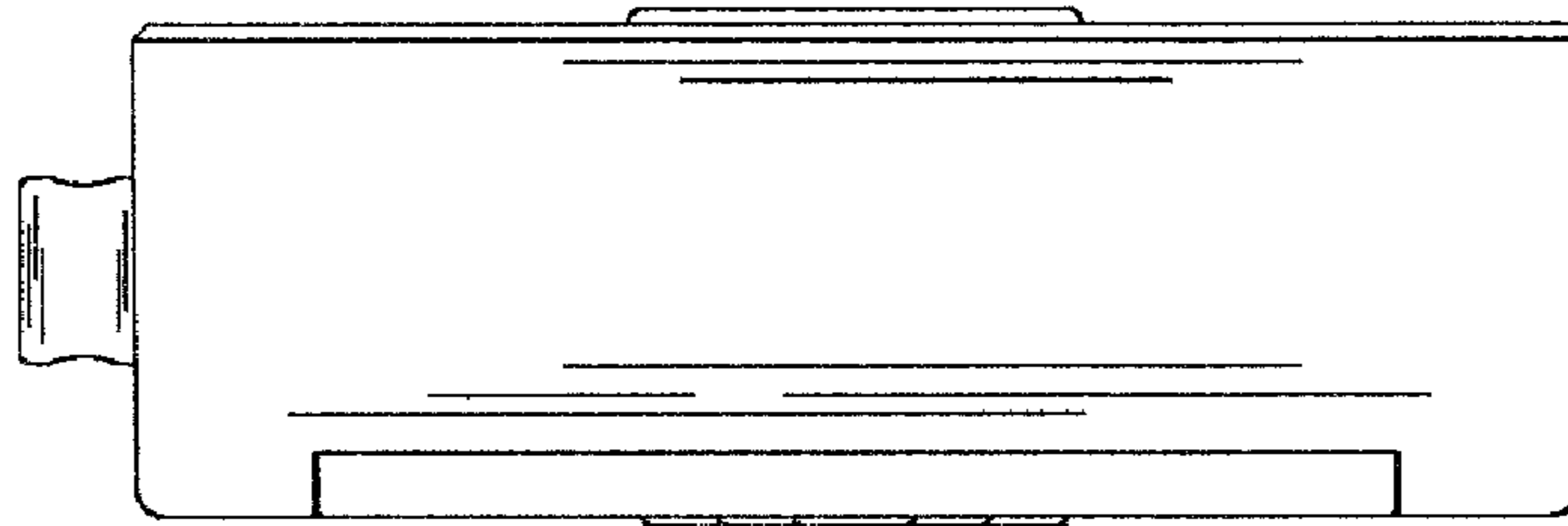

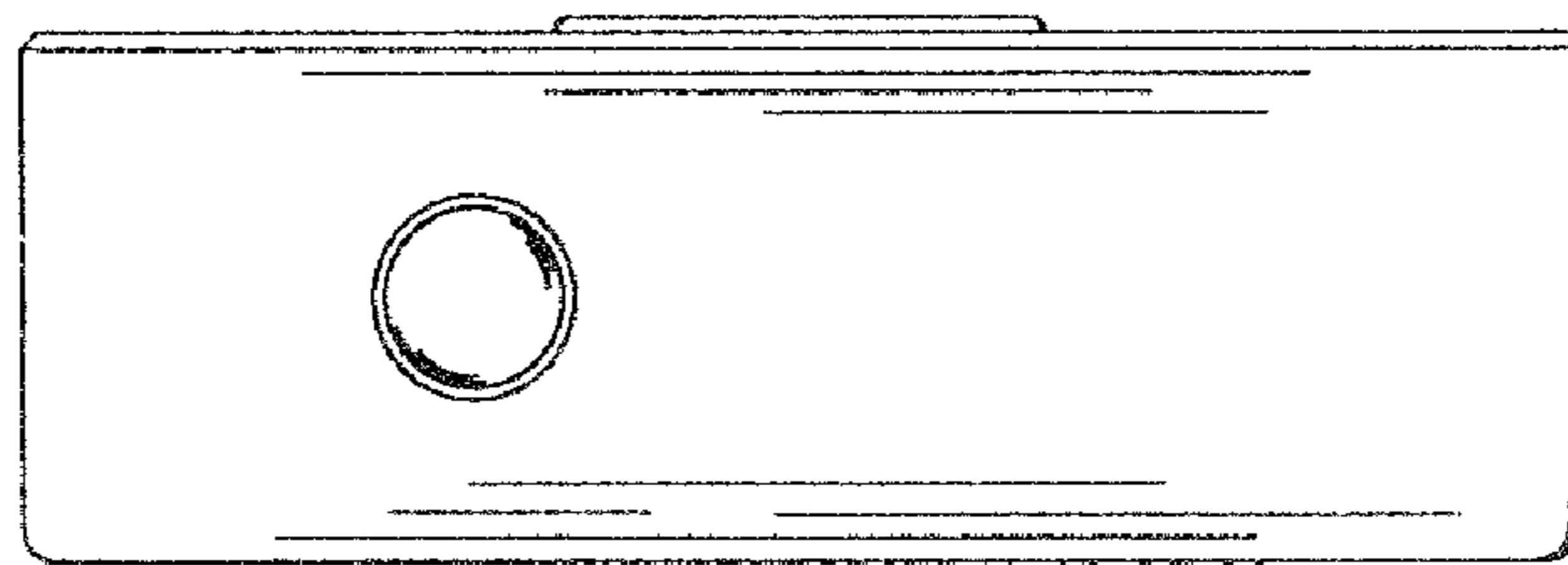

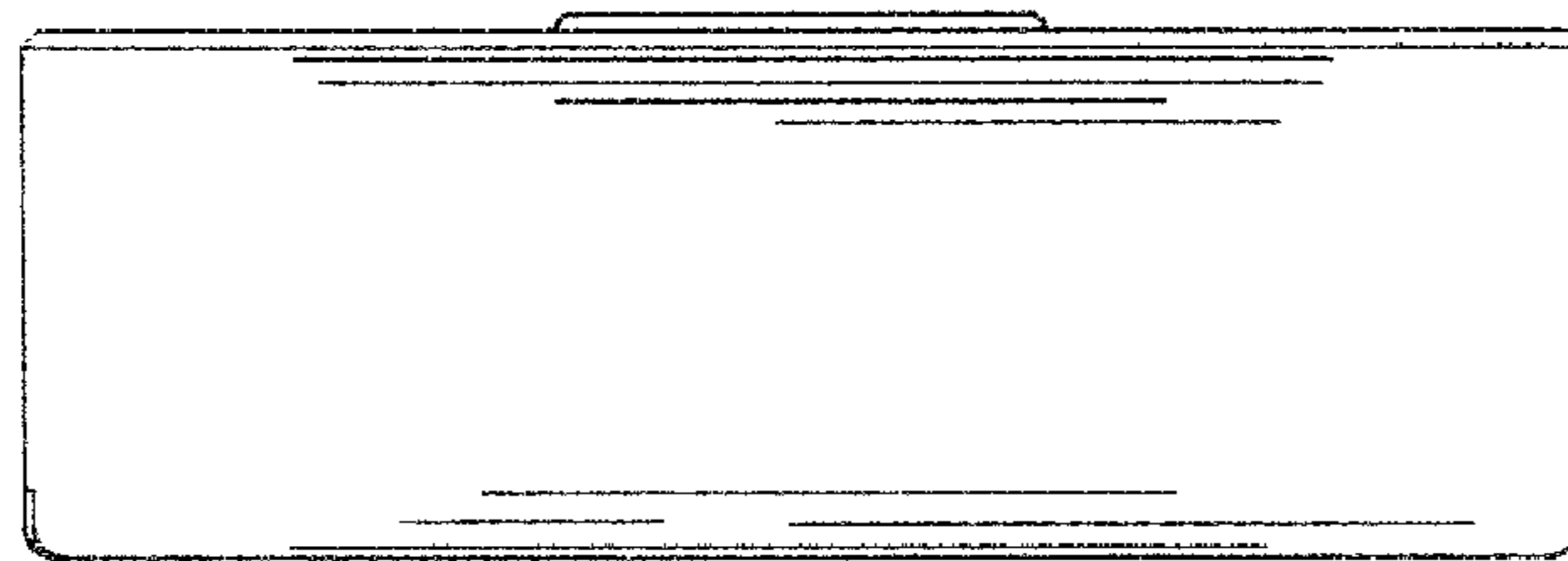

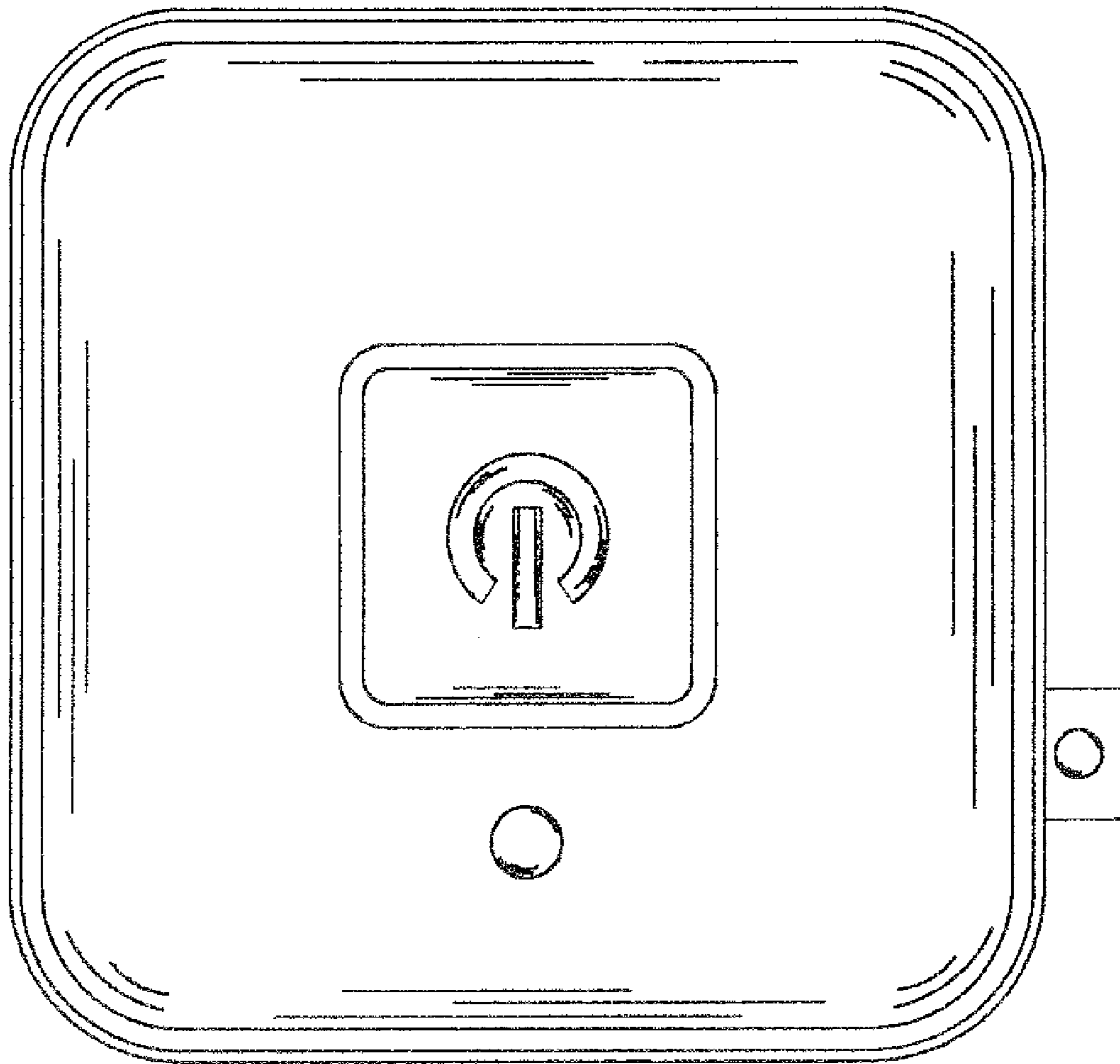

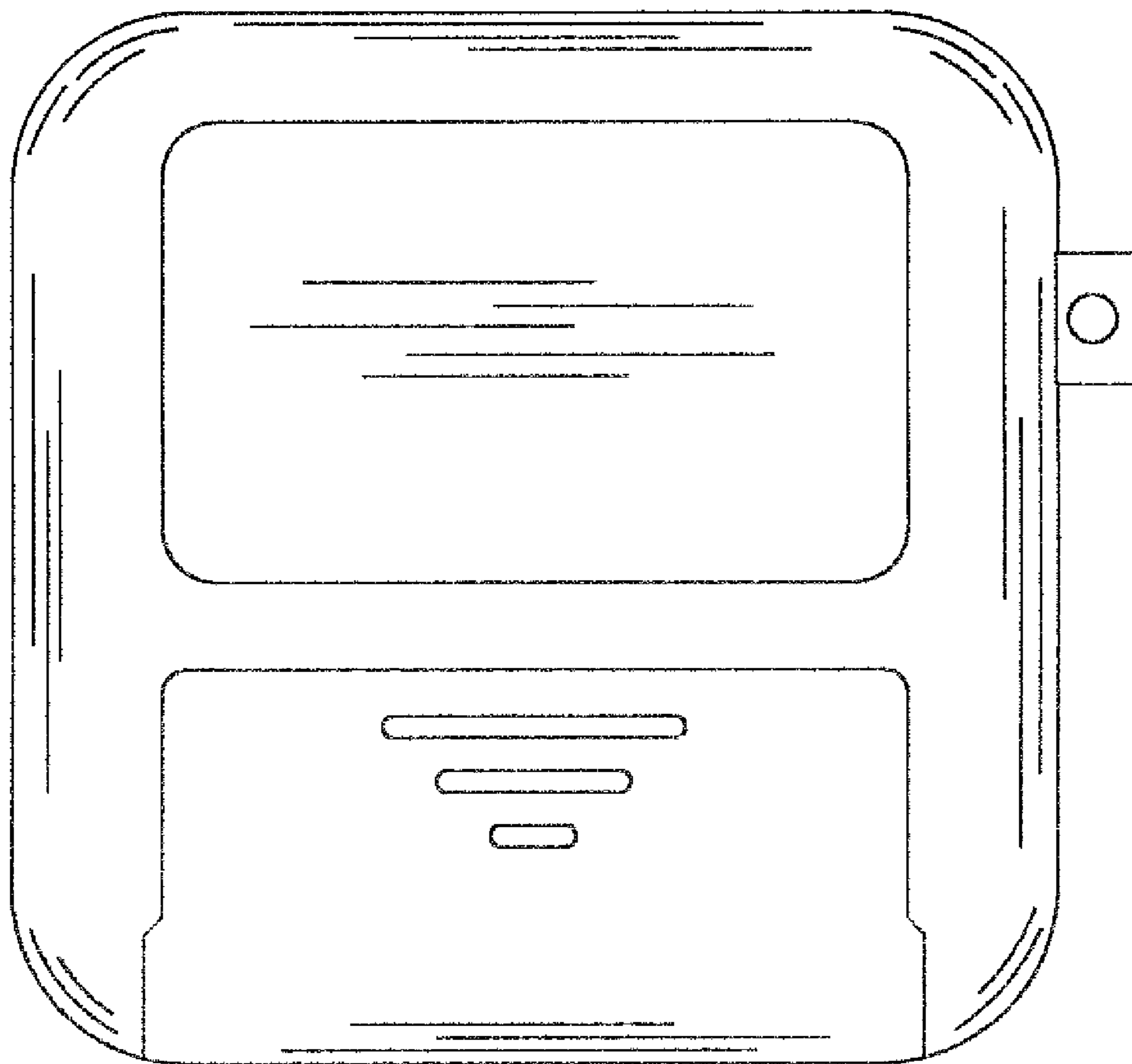

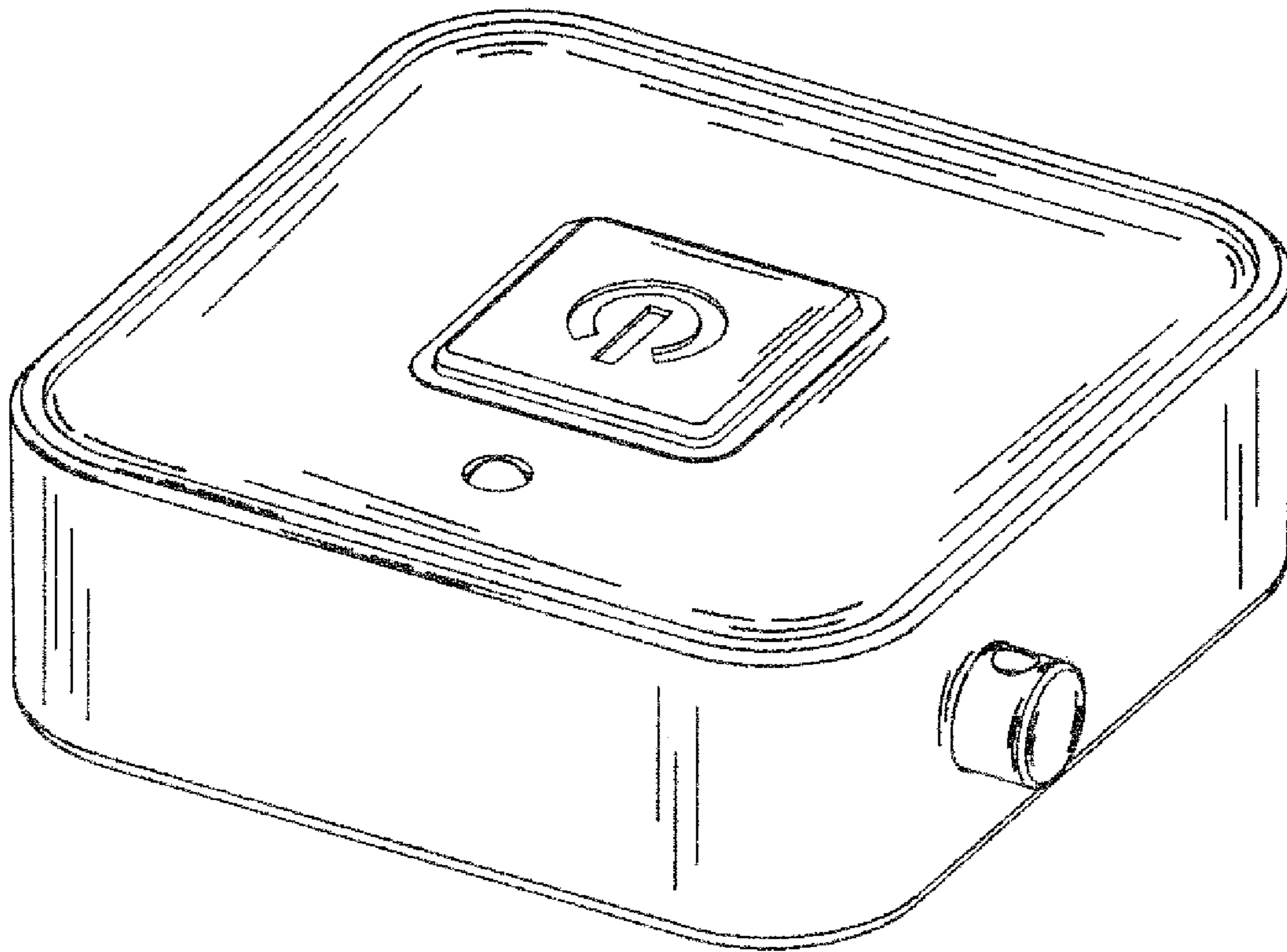
