(57) **CLAIM**

The ornamental design for a folding table and chair set, as shown and described.

DESCRIPTION

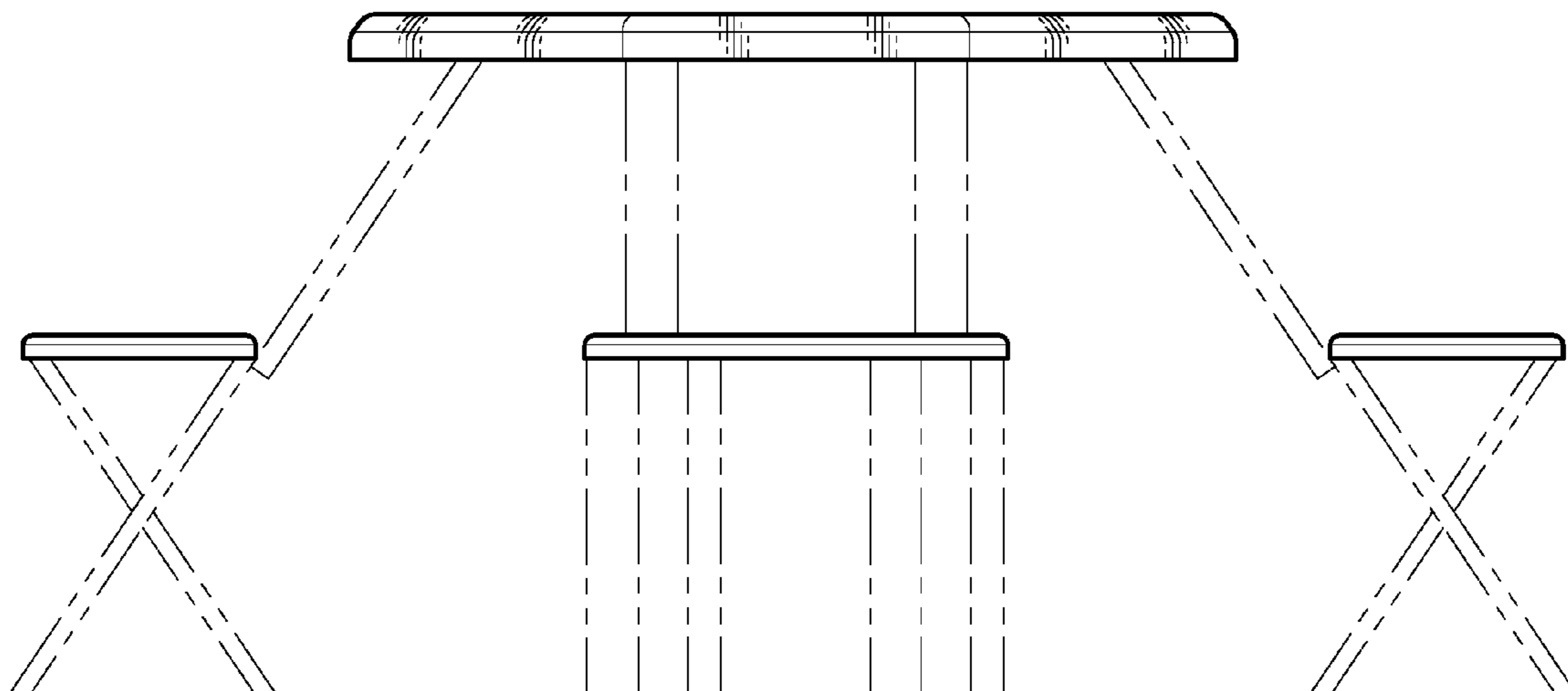

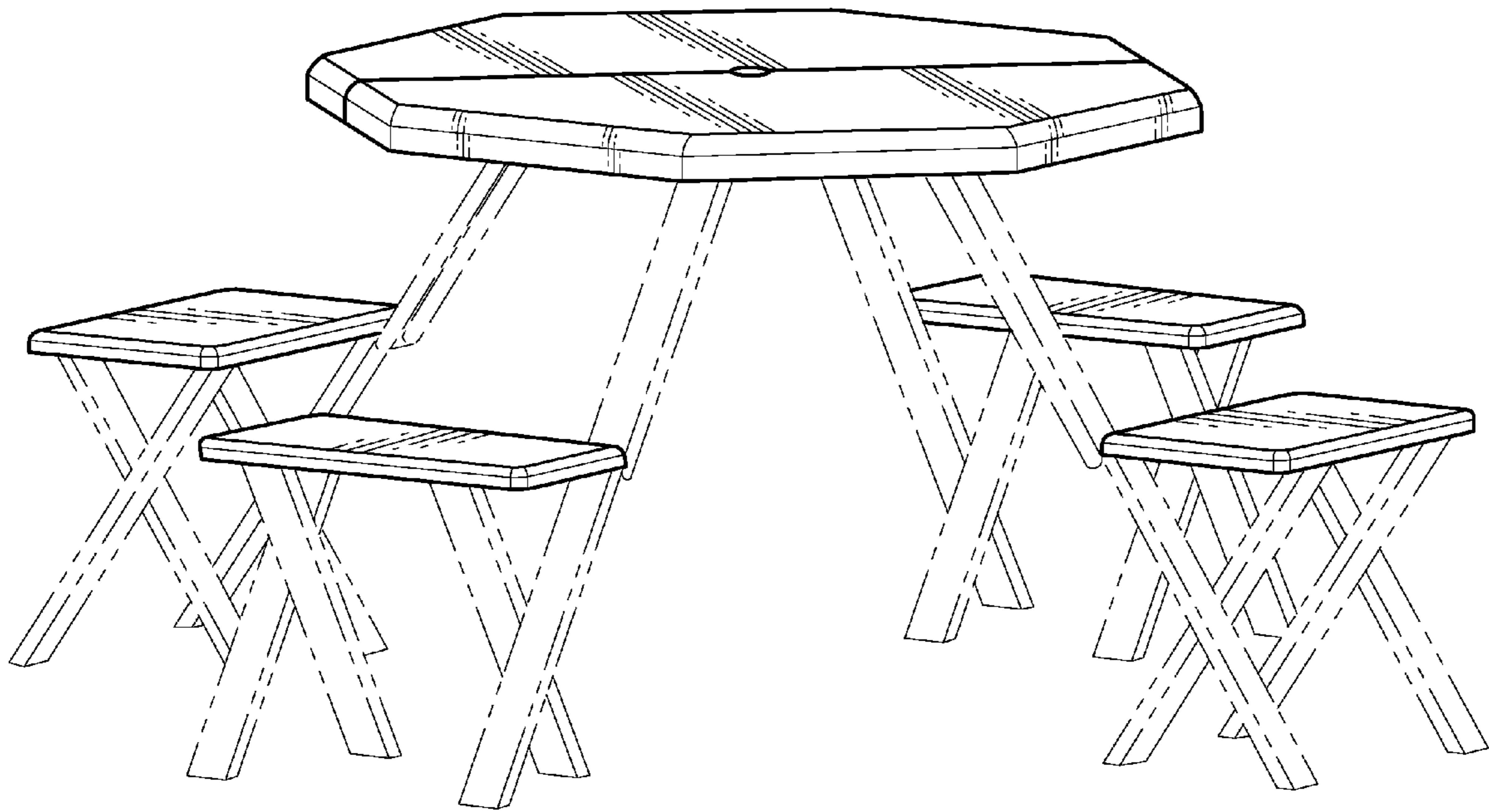

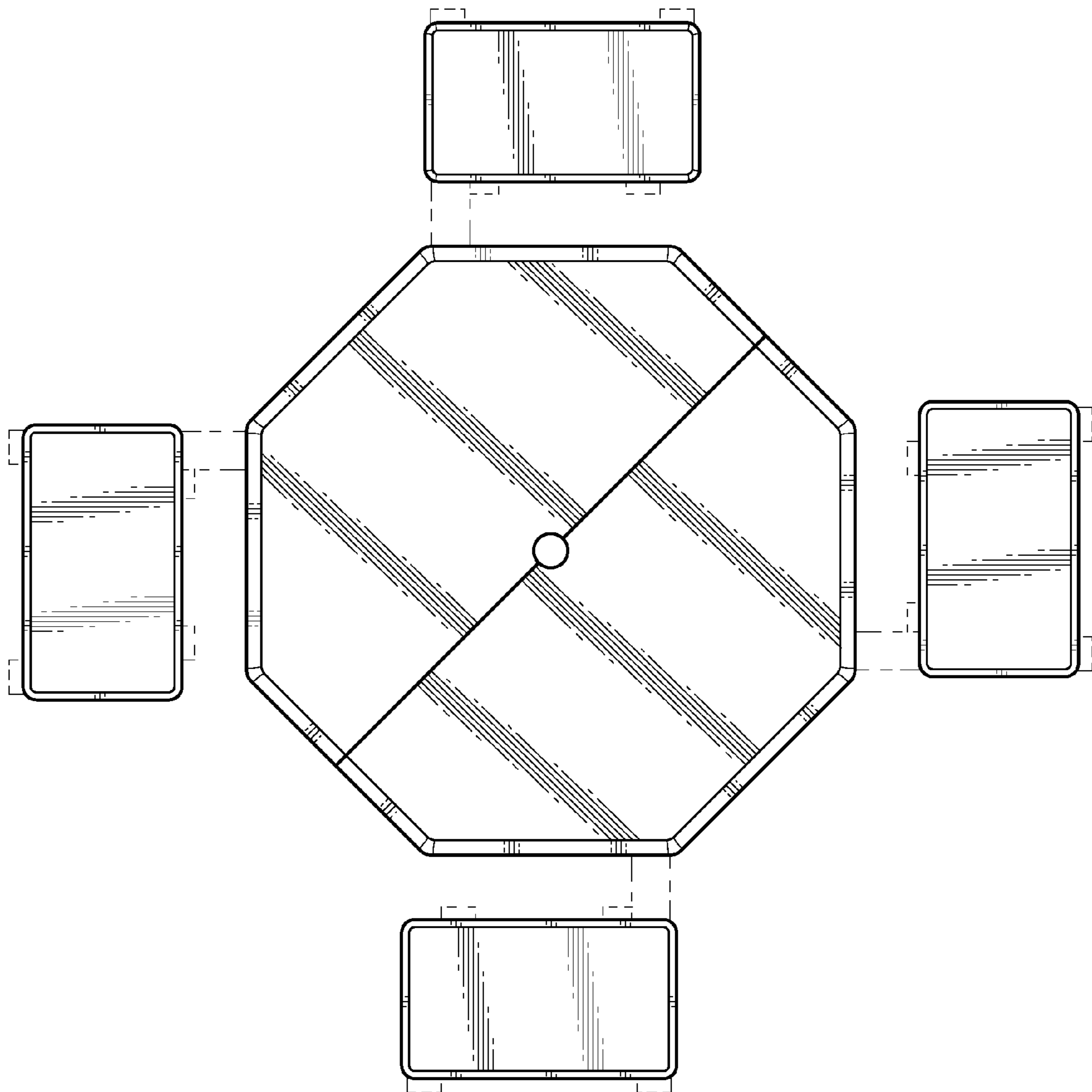
