FIG. 1 is a front perspective view of the sofa showing my design;

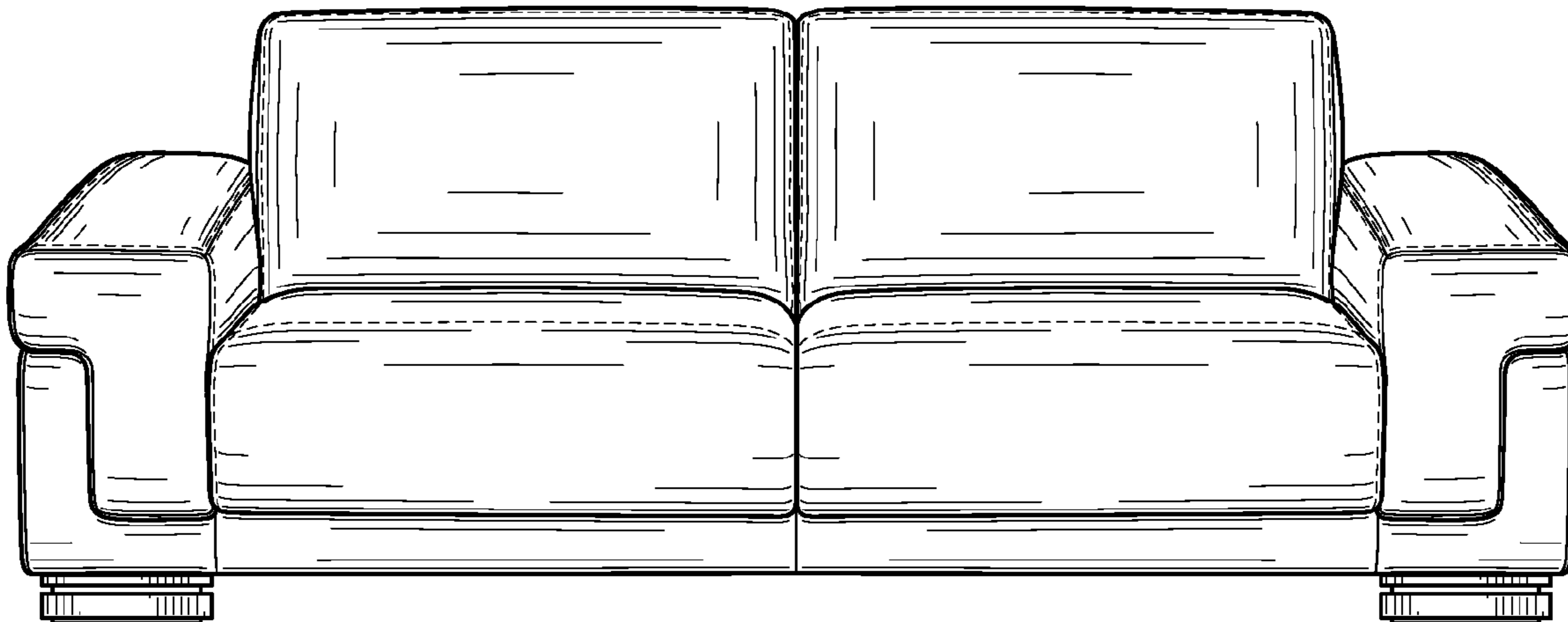
FIG. 2 is top plan view thereof;

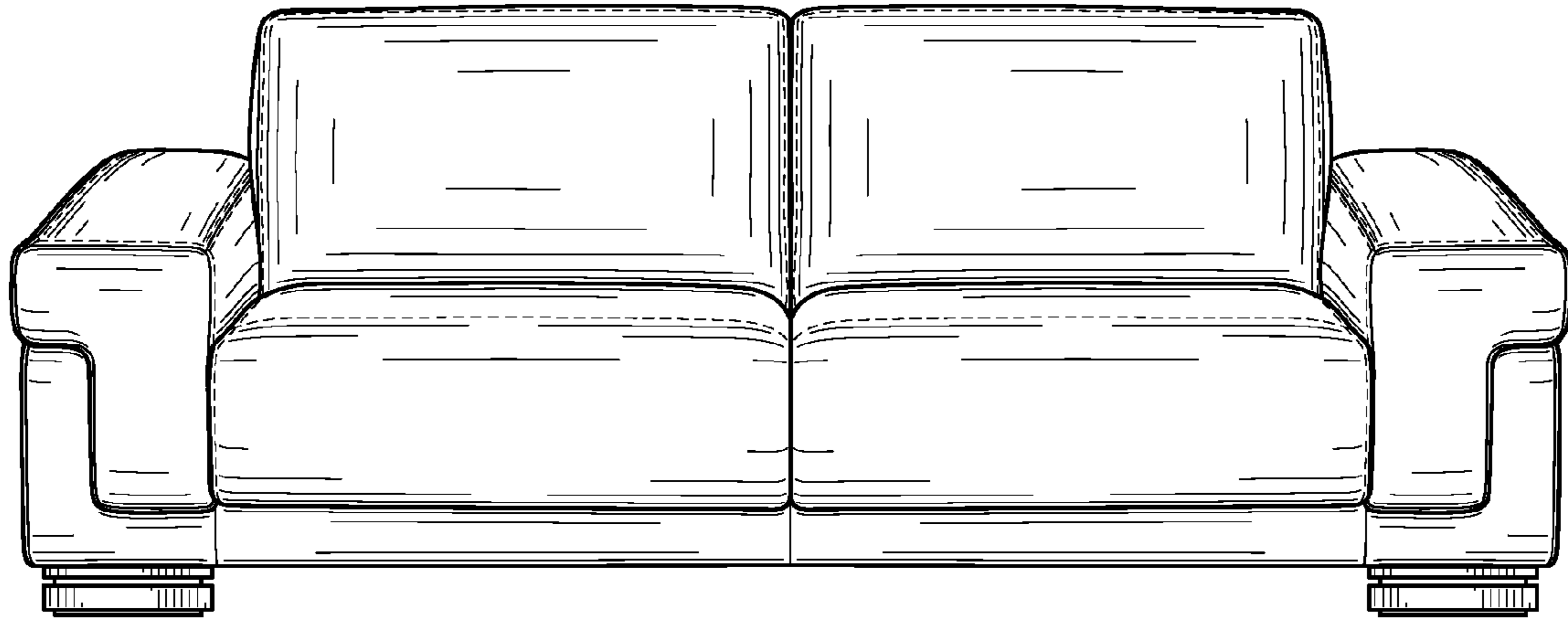

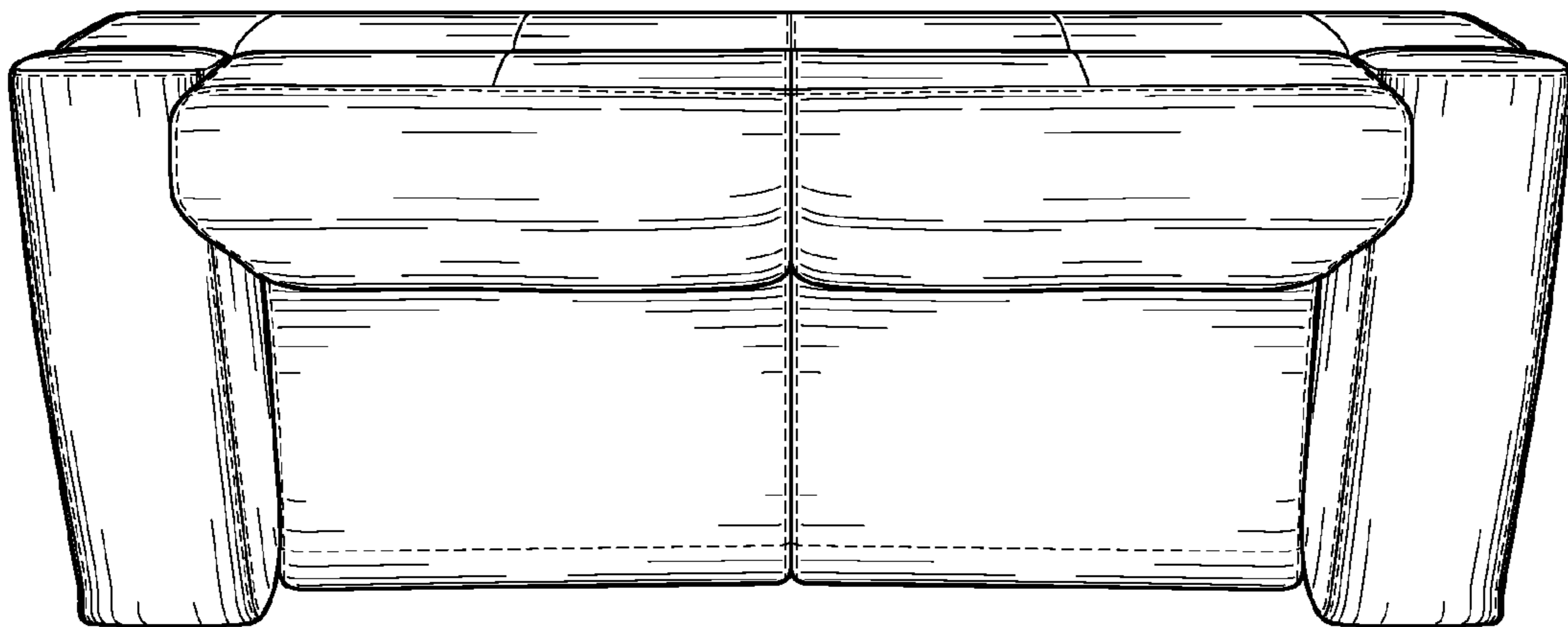

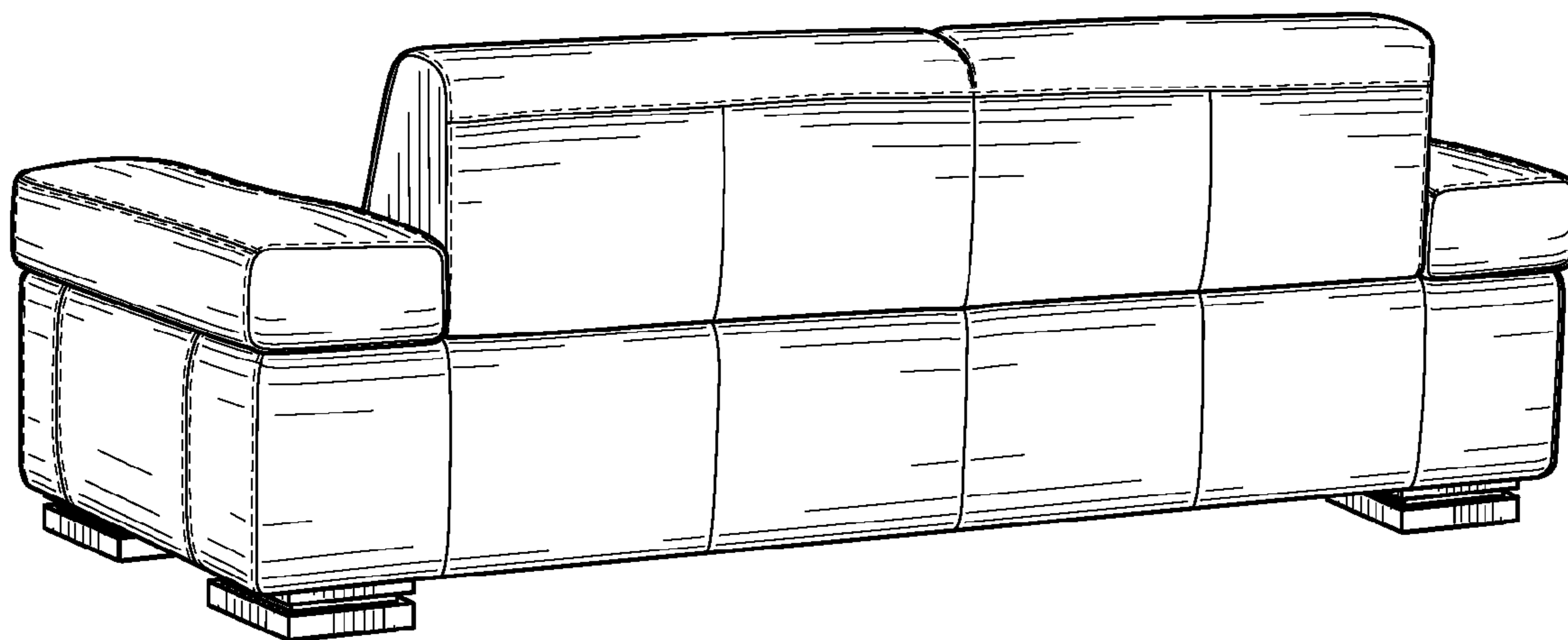

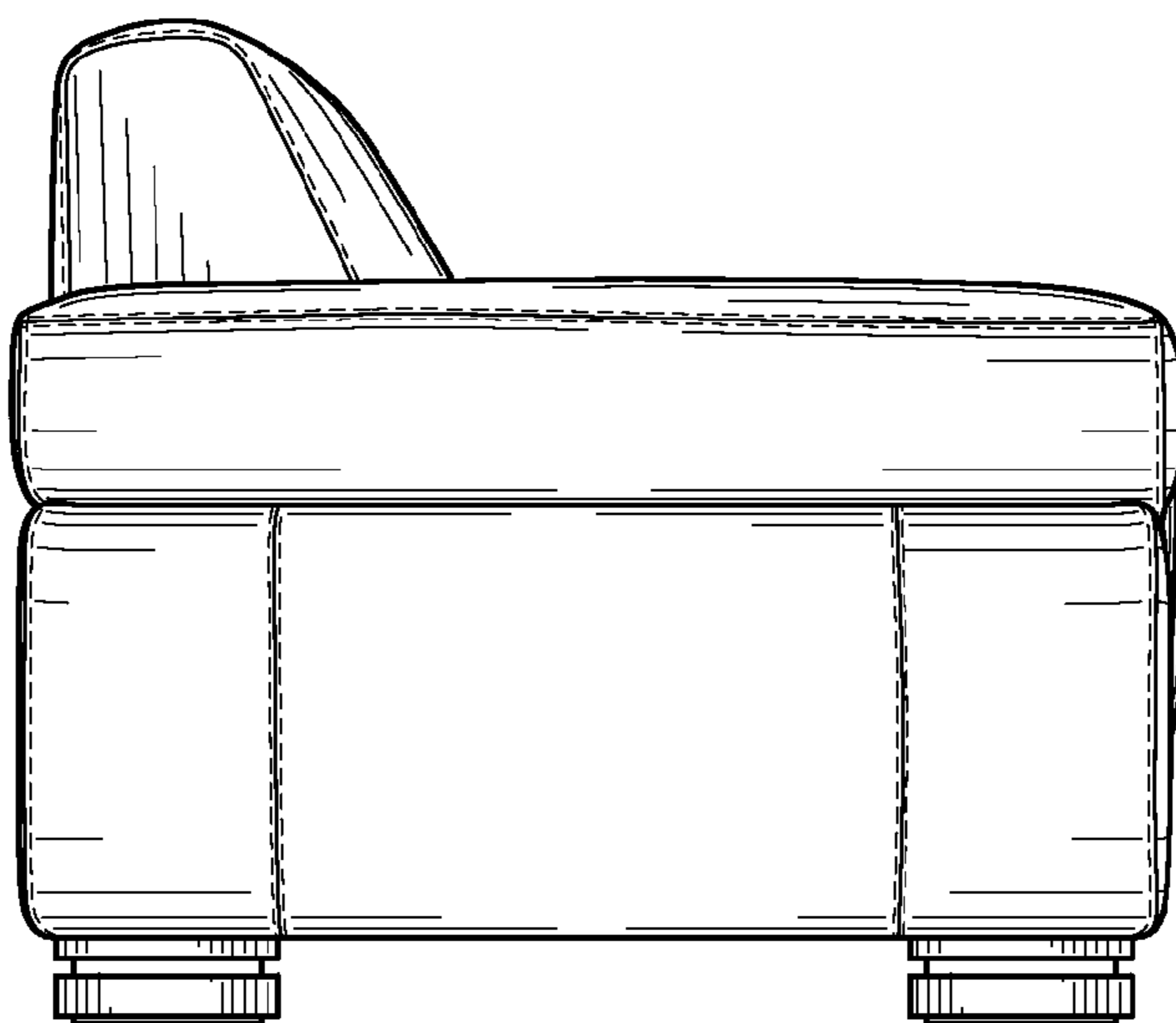
