image;

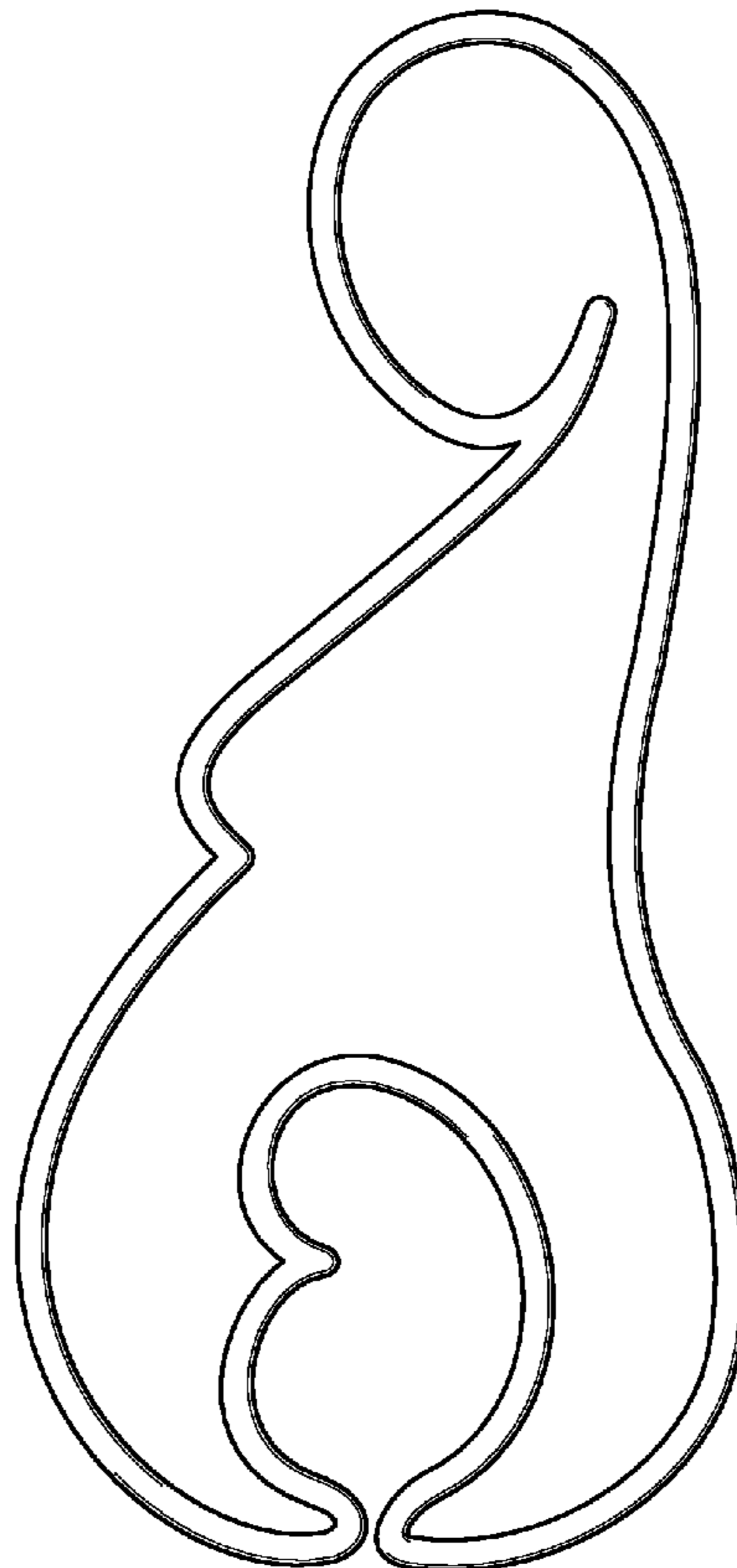
FIG. 2 is a left side elevation of the pregnancy symbol of FIG.

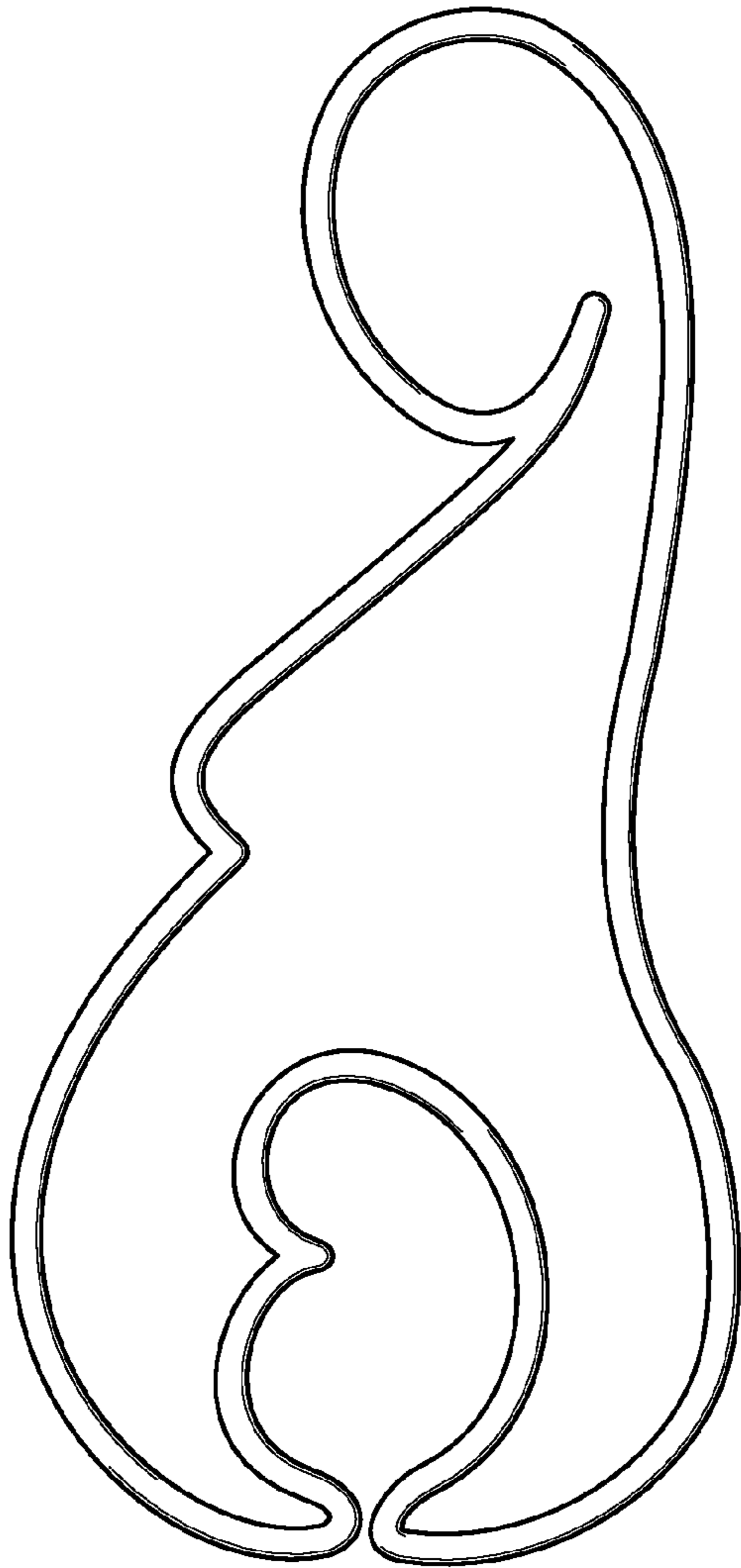

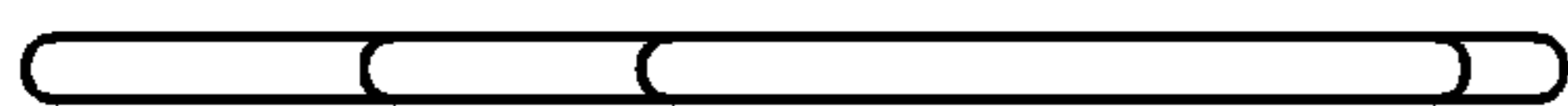
